Oh, Brother! A right royal welcome for little Louie

Official photographs released to mark christening of Prince Louis

THE Duke and Duchess of Cambridge have marked Prince Louis's christening by releasing a collection of official photographs that reveal the joy of the occasion.

One shows three-year-old Princess Charlotte gazing adoringly into her baby brother's eyes and clutching his tiny hand, while their older brother Prince George, who will be five on Sunday, gives a cheeky grin and joins the rest of the family group looking at the camera. It was one of several pictures released by Kensington Palace Wednesday night. They were taken by British photographer Matt Holyoak for the family album at Clarence House after the christening in the Chapel Royal at St James's Palace last Monday.

Elegant and colour-coordinated, the Royal Family were captured in the morning room and garden at Clarence House, the London home of Prince Charles and the Duchess of Cornwall. The house, built by John Nash in 1825-27 for George III's third son,

the Duke of Clarence, adjoins St James's Palace and was previously the Queen Mother's official residence for almost five decades. At the 40-minute service and a tea party afterwards, the women wore mainly pastel colours, each dressed head to toe in one colour, while the men wore blue suits, white shirts and light blue ties. George and Charlotte continued the blue and white theme.

William and Kate were also joined for the photoshoot by their children, along with Prince Harry and wife Meghan, Charles and Camilla. The Middleton family, including Kate's parents Michael and Carole, her sister Pippa and husband James Matthews and her brother James Middleton were also in attendance. Another picture shows Louis, who had been asleep when he arrived at the ceremony, looking up at his proud mother.

Mother and baby are captured in a similar pose in a group photo of the Cambridge branch of the family, which shows George, looking slightly tired after Camilla, Charles, Harry and Meghan join William, Kate and their three children a long summer term in his first year of school, and Charlotte, posing cheekily for the camera.

Holyoak, one of the world's leading celebrity portrait photographers, said: "I was truly honoured at being asked to take the

official photographs at the christening of Prince Louis. "Everyone was so relaxed and in such good spirits, it was an absolute pleasure.

"I only hope I have captured some of that joy in my photographs." Louis was sound asleep as he was carried into the Chapel Royal by Kate for the christening ceremony, but afterwards looked content and wiggled his fingers as his mother beamed at him as she held him in her arms. With Prince George and Princess Charlotte

joining their parents for Louis's big day, it was the first time the Cambriges have been seen together in public as a family of five.

Holyoak has worked with a host of celebrities and his photos have regularly been splashed on the covers of magazines such as Harper's Bazaar, Shortlist and Dazed And Confused. This was not his first royal commission as he photographed the Queen and the Duke of Edinburgh as part of a series of portraits released to

mark their 70th wedding anniversary. The picture is a throwback to the christenings of Prince George and Princess Charlotte. The Duchess of Cambridge sported her favourite designer Alexander McQueen at both occasions. She wore a creamy soft yellow ruffled look ensemble for Prince George's baptism in 2013 and a cream coat dress for Princess Charlotte's in 2015. She again wore McQueen for the christening of Prince Louis, this time around she chose a striking white dress.

Hosepipe ban comes into force for millions

Britain dries up in most severe heatwave since 1976

MILLIONS of Britons are facing the most widespread hosepipe ban in six years.

Amid the worst heatwave since 1976, a ban has already been imposed on nearly two million people in Northern Ireland. Now seven million residents in the north-west of England have been told by the UK's largest water company they face a hosepipe ban starting early next month. And with more sizzling temperatures forecast this month it is feared the rest of Britain could soon follow suit as reservoirs dry up. Keen gardeners who use sprinklers or motorists hosing clean their cars could be slapped with £1,000 fines. Water giant United Utilities said it had no choice but to clamp down on customers as parched reservoirs run dry.

Temperatures recently hit a peak of 91.4F (33C). The company has struggled to supply demand during the UK's longest heatwave in four decades. A hosepipe ban can reduce water usage by 5 to 10 per cent, which in the North-west

would amount to more than 100 million litres per day, the firm said. A hosepipe uses 540 litres an hour – as much as a family of four would use in one day. And a sprinkler left running overnight uses as much water as a family-of-four would use in one week, it claimed. The new ban is due to start on Sunday, August 5.

This week United Utilities water services director Martin Padley said: "Despite recent rainfall, reservoir levels are still lower than we would expect. "With forecasters predicting a return to hot dry weather for the rest of July, we need to impose temporary restrictions. It is not a decision we have taken lightly."

Customers can still wet their gardens with a watering can and wash vehicles using a bucket and sponge. Shocking images in recent days have shown northern England water reservoirs with parched and cracked beds. Northern Ireland Water put a hosepipe ban in place on June 29 – but the United Utilities move will be the first ban to

hit England since 2012. Six years ago restrictions were brought in by seven water companies, affecting 20 million customers. One water expert slammed the private water companies for failing to fix leaks while racking up huge profits. Privatised water firms typically lose between 20 per cent and 22 per cent of supply due to leakage, according to Ofwat, the water industry regulator.

Professor David Hall, a global water industry expert at London's University of Greenwich, said: "If the leakage levels were not so high, the daily volume of water delivered would be higher, therefore we would reach the point of hosepipe bans much later.

"Any restriction on water use is a restriction on people's quality of life." Household water bills rose by 40 per cent above inflation from privatisation in 1989 to 2015, according to the National Audit Office. Last night other water firms stressed they had no immediate plans for hosepipe bans but that may change. Severn

Trent Water, which serves more than 4.2 million homes in the Midlands and mid-Wales, said that so far reservoirs were "healthy". A company spokesman added: "We are just asking people to be waterwise."

South Staffs Water, which supplies over a million customers in the Midlands, and Anglian Water also said they had

no issues yet. That was echoed by Northumbrian Water, Bristol Water and Thames Water – who all denied any impending bans. Wessex Water said while there is "no prospect" of bringing in a ban it was vital customers still to do their bit to save water. Welsh Water said it was encouraging its three million customers to use

water wisely. While the sun has been unrelenting, there are more sizzling days ahead with the odd shower, according to forecasters. A Met Office spokesman said: "Less hot, is the best way to describe next week. "There will be some sunny spells but there will be a few showers around that could be heavy and thundery."

Departing Boris blasts May 'fog of self doubt'

Boris Johnson criticised Theresa May's "fog of self-doubt" and her government's "dithering" over Brexit in a sombre resignation speech on Wednesday.

The former foreign secretary, who stood down two weeks ago, earned cheers from allies as he told the Commons that it was "not too late to save Brexit". He urged Mrs May to return to Brexit plans set out in her Lancaster House speech in January 2017.

Cabinet members stayed away from the 12-minute address, during which Mr Johnson was surrounded by supporters in the half-full chamber. He denounced the plan agreed at Chequers this month and set out in last week's white paper as a "Brexit in name only" that would leave the UK in a state of "vassalage".

Julian Smith, the chief whip who attends cabinet but is not a full member, was the most senior Tory MP listening to the speech. He sat beside Mr Johnson's brother Jo, a transport minister, and Ben Wallace, the security minister.

Mrs May was giving evidence to the Commons liaison committee at the time of the speech, which was delayed by a series of government statements after prime minister's questions.

An ally of Mr Johnson said that he would probably never go for the leadership: "His friends are not the hard Brexiteers like Jacob Rees-Mogg. He knows he's possibly past it and hasn't made up his mind whether to go for it."

Mr Johnson appealed for Mrs May to rethink her plans. "It is not too late to save Brexit. We have time

in these negotiations. We have changed tack once and we can change again.

"The problem is not that we have failed to make the case for a free trade agreement of the kind spelt out at Lancaster House. We haven't even tried."

The MP for Uxbridge praised Mrs May's "courage and her resilience" and indicated that he thought she could lead the UK to a successful Brexit if she was willing to change her approach.

But he was scathing about the government's handling of negotiations so far, saying it had failed to turn the vision presented by the Lancaster House speech into a firm offer and had agreed to hand over £40 billion with no promise of a trade deal. He also criticised the Chequers plan because it accepted **cont. on page 3, col. 3**

My Meghan is 'terrified' insists estranged father

Pressures of royal life taking a heavy toll, claims Thomas Markle

THE Duchess of Sussex's father this week claimed she is hiding her unhappiness inside the Royal Family behind a pained smile and she is "under too much pressure".

Thomas Markle, 73, who has not spoken to Meghan, 36, since shortly after he pulled out of accompanying her down the aisle, said he thought his daughter was masking the stresses of her new life. Mr Markle fears that his daughter is struggling to cope with the transformation from US television actress to prim and proper royalty undertaking public duties.

He said: "My thing about my daughter right now is that I think she is terrified. I see it in her eyes, I see it in her face and I see it in her smile. I've seen her smile for years. I know her smile.

I don't like the one I'm seeing now.

"This one isn't even a stage smile. This is a pained smile. That might be just having a couple of bad days. I don't know. It really worries me. I think she's under too much pressure. There's a high price to pay to be married to that family."

He has also mocked the way she is dressing for royal duties. And Mr Markle, who has suffered with poor health, has urged his daughter to get

in touch before he dies. He begged Meghan to contact him claiming the pair had not spoken for two months and he had been "frozen out". He said: "I could actually die soon. My message would be, 'I love you, I miss you, I am sorry for anything that went wrong'."

"I just want to be her child's grandfather and I want to be near them. I am her father.

"The bottom line with that is, I deserve some

European Court of Justice jurisdiction over parts of the withdrawal agreement and allowed the issue of the Northern Irish border to dominate.

Actress Meghan, who gave up her starring role in US TV drama *Suits* to marry Prince Harry, looked relaxed and happy at Wimbledon on Saturday, watching the ladies' final alongside her sister-in-law the Duchess of Cambridge. But her dress style on official duties has changed, becoming noticeably more staid since she joined the Royal Family. Journalists covering her royal engagements have also noticed how aides have tried to keep the media at arms length, meaning they cannot hear what she says, and

there is little of interest to report on other than her wardrobe.

Mr Markle appeared bemused by his daughter's "ridiculous" dress code. "Meghan seems like something out of an old movie," he told a Sunday newspaper. "Why in 2018 are we dressing like the 1930s? Why do they have to cover their knees?"

He has still not met his new son-in-law and he says he has not spoken to Meghan and Harry since giving a controversial interview to ITV's *Good Morning Britain*. The Duchess and her advisers have refused to discuss

the rift but Mr Markle and other members of his family have repeatedly taken money for pictures and interviews with newspapers and television. He embarrassed the couple just before the wedding after it was revealed that he had colluded with a paparazzo photographer. But Mr Markle said: "I am being shunned because I made a profit on the staged pictures. Half of Great Britain seems to make a fortune selling pictures of my daughter and her husband. I have already apologised to the Royal Family."

Police 'identify suspects' in Novichok attack

Police believe they have identified the suspected perpetrators of the Novichok attack on a Russian ex-spy and his daughter in Salisbury in March.

Several Russians were involved in the attempted murder of Sergei and Yulia Skripal, according to the Press Association.

They have reportedly been identified through CCTV.

Earlier this month, Dawn Sturgess, 44, died after being poisoned by the same nerve agent, in Amesbury.

Her partner Charlie Rowley, 45, was also contaminated on 30 June and remains seriously ill in hospital.

Police believe the incidents are linked. The UK government has blamed Russia, but the country's authorities deny any involvement.

Mr Skripal, 66, and his

daughter, 33, who were discovered slumped on a bench in Salisbury on 4 March, have been discharged from hospital and moved to secure locations.

"Investigators believe they have identified the suspected perpetrators of the Novichok attack through CCTV and have cross-checked this with records of people who entered the country around that time," a source with knowledge of the investigation told the Press Association.

"They (the investigators) are sure they (the suspects) are Russian."

The Met Police, who are leading the investigation, have declined to comment.

An inquest into the death of Dawn Sturgess was due to open on Thursday.

Counter-terrorism detectives have revealed they found a small bottle

containing Novichok at Mr Rowley's home in Muggleton Road, Amesbury.

They are trying to establish where the container, thought to be a bottle of perfume, originated from, and how Mr Rowley and Ms Sturgess first encountered it.

On Wednesday, international chemical weapons experts completed their investigations in Amesbury, where they sought to identify whether the substance which poisoned the couple was from the same batch used against the Skripals.

The risk to the public remains low, according to Public Health England.

Mike Wade, deputy director for health protection in the South West, said: "The advice remains - if you didn't drop it, then don't pick it up."

Trump gushes over meeting with 'wonderful' Her Majesty

DONALD Trump described the Queen as a "fantastic woman" after their historic meeting at Windsor Castle, it emerged this week.

In an exclusive interview with Piers Morgan for Good Morning Britain, the US President lifted the lid on his private meeting with Her Majesty. Mr Trump, 72, and First Lady Melania were due to spend half an hour with the Queen on Thursday but stayed longer than expected after their afternoon tea overran by 20 minutes. Following the meeting, Mr Morgan boarded Air Force One at Stansted in Essex to question Mr Trump before he flew to his Turnberry golf

resort in Scotland for the weekend. And the presenter quizzed him on a range of issues, including the Queen, Vladimir Putin, Brexit and Kim Jong-un.

"so beautiful"

President Trump was quoted as having said: "The Queen is fantastic. She's a fantastic woman, so much energy and smart and sharp. She was amazing. Such a wonderful lady and so beautiful."

"It was such an honour to finally meet her. To have a Queen like that is great."

Mr Trump also said his mother Mary Anne Trump, who was born in Scotland and died in 2000 aged 88, was a "tremendous fan" of the

Queen. He said: "I was walking up and I was saying (to Melania) 'Can you imagine my mother seeing this scene? Windsor. Windsor Castle.'"

And it was beautiful, it was really beautiful but the Queen is terrific.

"She is so sharp, so wise, so beautiful. Up close, you see she's so beautiful. She's a very special person. And the way she's conducted herself for so many years."

Asked if he thought the Queen had liked him, the American President replied: "Well I don't want to speak for her but I can tell you I liked her."

"So usually that helps. But I liked her a lot."

And asked what the Queen's opening words

had been, he replied: "Um, 'Welcome'. 'Just 'Welcome'. Just very elegant. And very beautiful. It was really something special."

Mr Trump also revealed that he would run for a second term as President in 2020. He said: "Well I fully intend to. It seems like everybody wants me to."

'complex problem'

Speaking of his historic summit with North Korea dictator Kim Jong-un, he said: "I get along with him great, yeah. He's very smart, great personality, he's funny and tough, good negotiator."

The interview came before Mr Trump and his wife flew to Helsinki to

meet Mr Putin. The full interview was broadcast Thursday on ITV's Good Morning Britain. Mr Trump was asked if he had brought up the subject of Brexit with the Queen. He replied: "I did. She said it's a very - and she's right - it's a very complex problem. I think nobody had any idea how complex that was going to be."

"Everyone thought it was going to be 'Oh it's simple, we join or don't join, or let's see what happens.'"

Asked if the Queen had

indicated any personal view about what she thought about Brexit, the President was silent, before replying: "Well, I can't talk, you know I've heard very strongly from a lot of people, you just don't talk about that conversation with the Queen, right?"

"You don't want to do that...Let me tell you what I can talk about... she is an incredible woman, she is so sharp, she is so beautiful, when I say beautiful - inside and out. That is a beautiful woman."

Sir Cliff exults after winning privacy case against BBC

“What the BBC did was an abuse” says singer of coverage of police raid on home

SIR Cliff Richard was “choked up” on Wednesday after winning his privacy case against the BBC over its coverage of a police raid on his home.

The legendary singer, 77, was awarded £210,000 in damages by a High Court judge – and could get much more. Sir Cliff hugged friends after the ruling as fans outside clapped and sang his hit song Congratulations.

He said: “I’m choked up. I can’t believe it. It’s wonderful news.”

Sir Cliff fought back tears as he stood next to a lawyer who read out a statement on his behalf. The Summer Holiday star said it was “going to take

a little while” as he was too emotional to talk and added: “I hope you will forgive me.”

Close friend Gloria Hunniford, who was at the ruling, revealed: “Cliff said some really poignant things. He said to me, ‘I prayed every single night for four years that truth will out’. That was a really important statement. He was so excited.”

The TV host said of his ordeal: “I don’t think he will truly get over it. I don’t think you get over four years of turmoil like that. He is such a lovely man. He is a good, honest man. I think he took it so much to heart.”

Sir Cliff took legal action against BBC bosses over

broadcasts of a South Yorkshire Police raid on his home in Sunningdale, Berkshire, in August 2014, following a historic child sex assault allegation. He was never arrested or charged. The star was at his home in Portugal during the raid and was aghast as the events unfolded on TV. Mr Justice Mann said the BBC infringed the star’s privacy rights in a “serious and sensationalist way”. An emotional Sir Cliff said that if heads were to roll at the BBC “it would be deserved”. He said in a TV interview: “They [senior managers] have to carry the can. I don’t know how they are going to do it, but they’ll have to. If heads roll then maybe it’s because it was deserved. It’s too big a decision to be made badly. It was nonsense.”

He described the moment he saw police officers searching his home as “horrifying”

and said he would have “rather been burgled”. He added: “I will fight to the death against the abuse of the freedom of speech – what the BBC did was an abuse. Freedom without responsibility is anarchy. To me this was an anarchic thing to do.”

He also said the case had been distressing and that it was now difficult to be around children, adding he had resigned from one charity. He added: “In Wimbledon there is

a tunnel between Centre Court and Court One. I used to use it regularly to go and see the matches I was interested in on Court One and it went right past the ball boys’ dressing room. “I won’t go there now. I won’t go anywhere near children. Why? I’ve spent my whole life hugging people’s grandchildren. But because of this thing now... there’s aspects of my life now, even when I’m having photographs taken I try not to make

contact.”

Lawyer Gideon Benaim said the singer never expected, after 60 years in the public eye, to have his “privacy and reputation tarnished in such a way”. He said the BBC refused to apologise and insisted it had run a public interest story. He said: “The case clearly confirms that individuals, including high-profile ones, have a reasonable expectation of privacy in relation to police investigations.”

Boater rushing through locks drains part of canal

A boater accidentally drained a stretch of the Kennet and Avon Canal after leaving all the lock gates open this week.

A section of the waterway was left with hardly any water on Tuesday near the Barge Inn in Seend, Wiltshire.

A spokesperson for the Canal and River Trust confirmed what happened was not malicious but that the boater was “rushing and left the paddles up”.

The lock paddles “work like a plug on a bath in allowing water in and out of the locks,”

he explained.

He added that the trust had since restored the water levels.

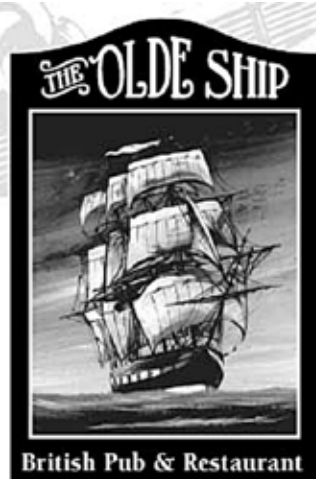
The Kennet and Avon Canal is an 87-mile (140km) waterway linking the River Thames at Reading to the River Avon in Bath.

It was originally opened in 1810, but gradually fell into decline after the Great Western Railway was built.

The waterway was completely restored by volunteers and officially reopened by the Queen on 8 August 1990.

James Forrest raced clear on the counter-attack to drill in a third.

Manchester United manager Jose Mourinho says he hopes World Cup winner Paul Pogba "understands why he was very good" during the tournament.

Red Devils midfielder Pogba scored as France beat Croatia 4-2 in the final to win the World Cup for the second time.

Mourinho said the 25-year-old was "absolutely brilliant" in Les Bleus' final three matches in Russia.

"It's about him understanding why he was so good, especially in the second part of the competition," he said.

"I think that's the point, about his performance level and his contribution to a winning team."

Pogba joined United for a then world record £89m in August 2016, but fell out of favour at times during the 2017-18

campaign.

He was left out of the starting line-up for both legs of United's Champions League last-16 defeat by Sevilla.

After France's victory on Sunday, former United defender Rio Ferdinand said it was "down to Jose to unlock this Pogba we saw at the World Cup because he was responsible, he stood up to a lot of hard tests in midfield, and was a talisman for this team."

While the Red Devils have travelled to the United States for their pre-season tour, Pogba is resting after his exploits in Russia.

Mourinho, speaking in Los Angeles, said: "I did with Paul what I did with all my players."

"I sent a nice message before the World Cup and during it I did not

disturb anyone. They needed to focus on the job for their national team.

"After the World Cup I sent a different message than to the other guys because he won the competition."

Meanwhile, Mourinho said goalkeeper David de Gea, midfielder Nemanja Matic and new signing Fred are due to link up with the squad next week.

Forward Alexis Sanchez has missed the start of the tour as he has been unable to get a visa.

"He's very sad. It's not good for him or me, not good for anyone," said Mourinho.

"There is no-one to blame - the club is making an effort. I have to respect the US authorities in their process of selection of visas."
