ANDREW: I NEED TRUST!

As FBI probe closes in, Prince claims he is being treated like a second class citizen by US Justice Department

PRINCE Andrew wants US investigators into a sex trafficking ring to "build a relationship of trust" with him, it emerged this week.

A source close to Andrew called for Geoffrey Berman, the US attorney leading the investigation into Andrew's late friend Jeffrey Epstein, a convicted sex offender, to stop criticising him publicly over his failure to so far give evidence.

"They need to do something to build a relationship of trust," a source said, playing down reports that the Queen's son believed Mr Berman's criticism had made it impossible for him to co-operate.

As the FBI closes in on the inner circle that helped his paedophile pal Epstein prey on underage girls, the two sides still cannot agree the terms under which Andrew, 60, can be interviewed as a witness.

Investigators want him to volunteer information about Epstein, who was found hanged at the age of 66 last August in a New York prison cell where he was awaiting trial on sex trafficking charges.

On Monday Andrew complained through his lawyers that he

was being treated as a second-class citizen by the US justice system. He insisted it was "entirely misleading" for Mr Berman to say he had offered "zero cooperation".

Tensions were sparked in January this year after the Duke's legal team contacted Mr Berman saying he was prepared to talk. His lawyers asked for 14 days in which to set the parameters in which he would co-operate. It did not discount the possibility of Andrew undergoing a face-to-face interview with US officials.

But a week later Mr Berman claimed there had been "a wall of silence" and "zero cooperation".

Several women, including American Teala Davies, are suing the late financier's alleged estate over sexual abuse. It has also emerged that the Prince is one of four British people the FBI wants to question over their relationship with Epstein.

Increasing interest is being paid to the US sex offender's relationship to the UK, following claims by two of his victims that girls were trafficked to and from this country. Other than the Duke of York, Epstein's alleged "madam" Ghislaine Maxwell, 58, and two cont. on page 2, col. 5

BoJo condemns violence after largely peaceful BLM rally sees Winnie statue defaced

The Prime Minister has condemned sporadic violence during a weekend of largely peaceful protests in support of the Black Lives Matter movement, which also saw the defacing of a statue of Winston Churchill and the toppling of a statue of a 17th-century slave trader.

"People have a right to protest peacefully and while observing social distancing but they have no right to attack the police. These demonstrations have been subverted by thuggery - and they are a betrayal of the cause they purport to serve," Johnson said in

a tweet, without directly addressing the vandalism of the statues.

Protesters defaced the statue of Churchill in central London, taping a Black Lives Matter sign around its midsection, and crossing out his last name and spray painting "was a racist" underneath.

The Metropolitan Police said a dozen people were arrested and eight officers injured after demonstrators clashed with law enforcement in central London.

Churchill was the subject of a 2014 biography written by Johnson, and although most Britons still consider him to be

among the greatest of the country's elected leaders, there has been a growing movement in recent years to address what his critics deem his racism, especially in his earlier years. As the product of a privileged Victorian upbringing, it is not surprising that among his less-than-impressive quotes is a description of Indian people as "the beastliest people in the world next to the Germans."

On another occasion, while deploring his own country's detainment of 'noble' Kikuyu tribesmen in Kenya during the Mau Mau rebellion, Churchill opined that he "did not

really think that black people were as capable or as efficient as white people."

After a meeting with Churchill in 1943, US Vice President Henry Wallace noted: "He (Churchill) said why be apologetic about Anglo-Saxon superiority, that we were superior, that we had the common heritage which had been worked out over the centuries in England and had been perfected by our constitution."

In addition to the defacement of the statue, a protester tried to set fire to a British flag at the Cenotaph, the London

memorial to the country's war dead.

Sunday's protests were mainly peaceful, but for the second day running there were some scuffles near the offices of Johnson. Objects were thrown at police, who sent reinforcements before calm was restored.

Two-metre rule to be eased after pubs start serving

The two-metre rule is to be relaxed once coronavirus infections fall sufficiently to open up the hospitality sector.

Pubs, restaurants and cafés are waiting for detailed guidance from the business department on how they can open securely from July 4, the date set in the "road map" after which elements of the sector can start to reopen as long as the virus remains under control.

Senior officials said

guidance that the could retain the twometre rule initially, but alternative guidance on smaller distances was being prepared for when the rule was relaxed. A cabinet minister said the government faced a choice of whether to delay publication of the guidance until the rule was relaxed or press on with the earliest possible reopening despite warnings that many businesses will unable to comply.

"On balance it's probably better to get as many businesses up and running as soon as possible rather than wait for when the rule drops to one or 1.5 metres," they said.

Chris Whitty, the chief medical officer for England, said last week that the two-metre minimum distance for face-to-face contact was among measures that would remain in place "for as long as this epidemic continues".

The UK is set to be the hardest hit by Covid-19 among major economies, according to the Organisation for Economic Co-operation and Development.

The group said that it expects Britain's economy to slump by 11.5% in 2020, outstripping declines in countries such as Germany, France and Spain. "The crisis will cast a long shadow over the world," said an OECD spokesperson.

other British women are believed to hold information that could be helpful to their investigation. The two other women, who both reside in the UK, are seen as witnesses. A source said new claims "include claims he [Epstein] was flying girls over from the UK

for him to abuse as well as Virginia Giuffre's allegation".

Ms Giuffre has claimed in a US court that she was flown around the world by Epstein, including on one occasion – in March 2001 – to London to have sex with Prince Andrew. The Prince has vehemently denied her allegation, saying he had never met Ms Giuffre, then aged 17.

Man jailed for running over stepmum

A man who repeatedly drove over his stepmother in a drunken rage at a wedding has been jailed for six years.

Ben Ashman, 37, went on a rampage in the car park at Bowburn Hall, near Durham, at the end of his stepbrother Connor Ashman's nuptials on 23 August.

His stepmother
Kathryn Ashman
suffered injuries
including a fractured
face and broken ribs
when she was run over
three times by his 4x4
Vauxhall.

He admitted five offences when he appeared at Newcastle Crown Court.

Judge Robert Adams said Mrs Ashman's injuries were "appalling" and the defendant, of Sunderland Street, Houghton-le-Spring, was "extremely lucky" she was not killed.

Prosecutor Jolyon Perks said trouble started just after midnight when Ashman's "intoxicated and upset" girlfriend complained of the way another man was looking at her.

A fight broke out and spilled into the car park, rousing Mrs Ashman.

Clad in her dressing gown, she shouted at Ashman's girlfriend, prompting him to hold his stepmother on the ground by her hair.

He shouted that he would kill her and "splat everyone here", the court heard.

The drunk couple a half years.

then got in their car, but guests tried to stop them driving away.

One woman, Jodie Young, had her arm shut in the door as she tried to grab the keys, while Ashman's brother, Kyle, threw a large rock at the windscreen, shattering it.

Ashman drove at speed around the car park aiming at people, including Kyle, with whom he made minimal contact as he braked.

He then smashed into Ms Young's Nissan Juke, the court heard, which his brother had attempted to hide behind.

Ashman then careered into his stepmother, then reversed over her.

He pulled her along, then drove forward over her again.

The court heard he had not intended to hit her and had limited visibility due to the shattered windscreen.

Ashman fled southbound along the A1(M), stopping after seven miles due to the amount of damage to his car.

Lewis Kerr, defending, said his client was suffering "mental health difficulties" at the time and is full of "remorse, sorrow and anguish".

Ashman admitted causing serious injury by dangerous driving, attempted grievous bodily harm, dangerous driving, common assault and criminal damage.

He was also banned from driving for five and a half years.

TV duo 'sorry' for blackface sketch

TV stars Ant and Dec have apologised for impersonating people of colour on thir show Saturday Night Takeaway. In a statement, the presenters said they were "sincerely sorry" for the sketches when they concealed their real identities with darker make-up and prosthetics. "We realise that this was wrong and want to say that we are sincerely sorry to everyone that we offended," they said.

Maddie killed 'soon after she was taken'

Madeleine McCann was killed soon after she was kidnapped, a German prosecutor said this week as it was reported that the prime suspect had boasted that he would "document" the abduction of a child.

Police have discovered that Christian Brückner discussed kidnapping, raping and killing a girl in a conversation with another paedophile online. He graphically described his wish to "catch something little and use it for days".

Asked about the risk of being caught, he said: "Meh, if the evidence is destroyed..."

He added: "Then I'll record maaaany videos/ clips. I'll document in detail how she's being tortured."

The conversation was discovered by German police investigating the disappearance of Inga Gehricke, five, on the eve of the eighth year since Madeleine disappeared in May 2007.

Hans Christian Wolters, the German prosecutor leading the investigation into Brückner, said he feared that Madeleine had been killed shortly after being abducted from her family's holiday flat in Praia da Luz, Portugal.

"My private opinion is that he relatively quickly killed the girl, possibly abused her and then killed her," he said. "We believe our suspect committed further crimes, especially sexual crimes, in Portugal possibly but also elsewhere like Germany."

"If we don't solve the McCann case perhaps we can prove he committed one or two other crimes, which might be enough to keep him in prison permanently in

preventive detention."

Mr Wolters declined to say whether he believed that Brückner had filmed his abuse of Madeleine, as he did with his other victims. He said investigators want to collect as much proof as possible before interrogating Brückner so that he would not be able to weaken the case against him by finding explanations for individual pieces of circumstantial evidence against him.

Brückner is appealing against his sentence for raping a 72-year-old American woman in 2005 at a villa close to where the McCanns later stayed.

A video at his nearby farmhouse showed him raping and torturing her, another woman and a teenage girl.

Hazel Behan, an Irish woman who was raped in 2004 by an intruder 12 miles from Praia da Luz, and who was also filmed by her attacker, has asked police to review her case.

The attack on her bore striking similarities to that on the American victim. The rapist, who spoke English and German and whose description matches Brückner, tortured her for five hours.

The father of Louise Kerton, a 24-year-old British student nurse who disappeared in Germany in 2001, urged police to investigate possible links with Brückner. Phil Kerton, 75, from Kent, said: "It just confirms that the family have been right to keep persisting, there was something to find out there."

Prosecutors are also looking for links to Peggy Knobloch, who disappeared in Lichtenberg, Bavaria, in May 2001, when she was nine.

Dutch detectives are investigating whether Brückner could be linked to Jaïr Soares, a seven-year-old boy who disappeared on a trip to a beach near the Hague in

Statue of slave trader torn down in Bristol - the first of many?

THE FALLOUT from the death of George Floyd continued this week in a most unlikely spot: the affluent coastal city of Bristol, where a statue of a slave trader which was torn down during an anti-racism protest – and it will likely just be the first of many.

Mayor Marvin Rees defended the actions of protesters, said he felt no "sense of loss" after the controversial bronze statue of Edward Colston was pulled down and thrown into the harbour by on Sunday.

But Prime Minister Boris Johnson described it as a "criminal act".

Avon and Somerset Police said a decision was taken not to intervene.

Mr Johnson's official spokesman said: "The PM's view is that in this country, where there is strong opinion, there is a democratic process which should be followed.

"People can campaign for the removal of a statue but what happened yesterday was a criminal act and when the criminal law is broken that is unacceptable and the police will want to hold to account those responsible.

"The PM absolutely understands the strength of feeling, but in this country we settle our differences democratically and if people wanted the removal of the statue there are democratic routes which can be followed."

Thousands of people attended largely peaceful demonstrations in cities across the UK at the weekend, including in Manchester, Wolverham, Glasgow and Edinburgh.

But unrest in London on Sunday resulted in eight police officers being injured and 12 arrests.

The statue of the prominent 17th Century slave trader has been a source of controversy in Bristol for years.

Ten thousand people descended on the city on Sunday for the protest which saw the Colston statue torn down and dragged through the streets to the harbour,

where it was thrown into the water.

Colston was a member of the Royal African Company, which transported about 80,000 men, women and children from Africa to the Americas.

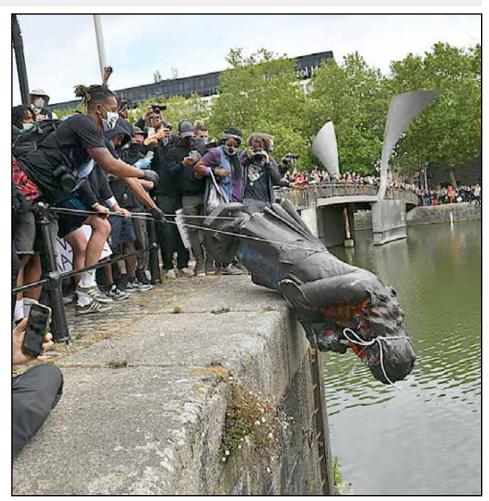
On his death in 1721, he bequeathed his wealth to charities and his legacy can still be seen on Bristol's streets, memorials and buildings.

After the statue was toppled, a protester was pictured with his knee on the figure's neck reminiscent of the video showing George Floyd, the black man who died while being restrained by a white Minnesota police officer.

Home Secretary Priti Patel said the incident was "utterly disgraceful" and "it's not for mobs to tear down statues".

Mr Rees said those comments showed an "absolute lack of understanding".

He added the statue would be retrieved from the harbour "at some point" and it was likely to end up in a city museum.

"I think circumstances came to a head and people felt the need to take the statue down," Mr Rees said.

"People in Bristol who don't want that statue in the middle of the city came together and it is my job to unite, hear those voices and hold those truths together for people for who that statue is a personal affront.

"Asanelected politician, obviously I cannot condone the damage and I am very concerned about the implications of a mass gathering on the possibility of a second Covid wave."

Liverpool University agreed this week to rename Gladstone Hall, which houses student accommodation. Bim Afolami, the Tory MP for Hitchin and Harpenden, tweeted in response to the news: "This is all going completely nuts. When will this stop??"

Farage loses radio gig after comparing BLM to Taliban

Nigel Farage is to leave his talk show on LBC radio with "immediate effect", the station confirmed on Thursday.

The station thanked the Brexit Party leader for his "enormous contribution".

The Nigel Farage Show aired five days a week. On Wednesday, he told listeners he would be back as usual on Thursday, but the schedule has now been changed.

"Nigel Farage's contract with LBC is up very shortly and, following discussions with him, Nigel is stepping down from LBC with immediate

effect," LBC said.

The station added: "We thank Nigel for the enormous contribution he has made to LBC and wish him well."

'Mr Brexit'

The Nigel Farage Show had been on air for three years, and offered callers the chance to sound off about political topics.

On Wednesday's show he signed off with the words: "I'm back tomorrow at six," suggesting his contract situation accelerated in the last 24 hours.

A p p a r e n t l y responding to the news,

fellow presenter James O'Brien tweeted: "We got our station back."

In 2018, he launched a podcast called Farage Against The Machine, which caused rock band Rage Against the Machine to send a cease and desist letter telling him to stop using the name. He refused, but LBC cancelled the series.

As former Ukip leader, Farage was influential in gathering momentum for the campaign to leave the EU.

This week the 56-yearold compared Black Lives Matters protestors to the Taliban, for demolishing statues of slaves traders.

His departure comes after the station's owners Global Radio were criticised by some presenters over its response to the protests, following the death of George Floyd.

A Global spokesperson said the company had

taken "several steps in recent days" to improve its inclusivity, "including the formation of a BAME committee".

They added: "This said, we recognize there is still a lot of work to do. Global is committed to recruiting the highest

level of expertise and experience, regardless of gender, race, sexual orientation or disability.

On the ground at the Hollywood protests

Cops, Protesters. Looters.

An eyewitness account by Erik Wolford.

I live on Hollywood Boulevard, right near La Brea.

I am in the more residential part so my experience is going to be different than someone several blocks away where the storefronts are. Events change block by block. But this is what I have personally experienced. I have seen the demonstrations from beginning to end walk past my house.

Here's the numbers and type of people I have seen:

First you hear the choppers. When the California state bird takes to the air and circles, you know something is up.

It starts in the late afternoon. Hollywood Boulevard is mostly empty. Suddenly sirens. Like all the sirens you have ever heard. cop cars. 40 motorcycle cops. Two flatbed trailers with cops hanging off it in riot gear with paint guns looking riot weapons. Then another wave of 20 cop cars. A single unmarked black Dodge Charger at the back of the pack with sirens blaring. They blow by at 50 miles an hour. Then they disappear. vanish into the bowels of Hollywood. I don't see them again the entire night.

Then a column of national guard in armored

Humvees and in full battle rattle (camo, plate carriers, rifles) drive by in trucks and Humvees. About 150 to 300 national guard. They vanish into the night, not to be seen again on my street.

An hour later, the noise is heard in the distance. Something big is headed our way. Faint cheers. Rhythmic car honking.

totally chill

Then the first cluster of marchers. Then the air gets electric, and you can feel the energy from the moment. A wave of humans, most wearing masks, most clustered in groups they are comfortable with Attempts to social distance are made. Other protests would be twice or three times more packed and dense. but here people are spreading out.

These are peaceful protesters. I would happily grab a drink and walk with them in flip flops with no fear.

Everyone is totally chill. Lots of cheering, lots of energy.

Then after about 30 minutes, the foot protesters thin out and now it's waves of cars with protestors hanging out taking up the tail end. They last for 10 minutes.

Then the road is clear.

No cops trailing them. No police presence at all, and it's a good thing. They don't need to be there. We are fine. I feel safe.

The last thing I have seen is near Fairfax and 3rd at 7:45pm. I'm getting some aerial shots with my drone of a building on fire. Two cars pull up 15 minutes before curfew. Eight men who look like hardened street criminals, complete with full face tattoos, pull up like you would pull up to rob a bank. Come in hot, slam into two spots on a side street, leap out in unison. I thought I was about to get jumped.

They are amped up. No protest signs, they are moving like predators about to kill. And they are so clearly heading in to rob a place, using the end of the protest at 8pm as cover to make it harder for cops to drive up to respond. It was so perfectly clear these were looters headed towards a local buisness.

They disappear around a corner. Then I see a cop car with fresh spray paint on its doors blast by at the other end of the street. I took it as my cue to head home. A little too close to the action. I felt like I was suddenly in the movie Purge. So I headed home.

But what was interesting was there was no grey area between the various groups. It was super clear who the peaceful protesters were. It's super clear who's heading in in packs to do damage.

So to tally it up:

I've seen 200-400 cops in packs

I've seen 200-300 national guards in columns on side streets

I've seen about 5000-6000 protestors

I've seen 8 looters.

I did not see one ANTIFA person. I did not see a single antifa sign in anyone's hands. It was a big long crowd. Maybe there was one or two in there, but I didn't see them. Certainly not

a group large enough to notice. Zero presence, in my view.

I've seen no property damage from my street but one building on fire at Fairfax and 3rd Street.

Judging by the hardened criminals using protests as cover to go into neighborhoods you would not normally see - I would say its very likely the buildings are torched as a distraction for the looters. They are organized, they are in groups, and they are a tiny tiny percent of what is going on, but they are having a huge impact on the perception of the protesters.

I work in Hollywood as a cinematographer and I've filmed a ton of these marches. I have hours and hours of footage of peaceful marching, and two minutes of a burning building. What I see the media showing is the 1% of the protest that is crazy and violent. As you watch the news,

know you're getting a "worst of" highlight reel. You are not getting the real story of a peaceful march. The coverage is understandably skewed to the exciting bits, but it doesn't give you a real picture of what's

happening.

I do know other parts of Hollywood are having different experiences. There do seem to be more problem areas- probably because that's where the stores are, and I am in a residential area.

Premier League clubs have agreed to replace the players' names on shirts with "Black Lives Matter" for the first round of games of football's return, subject to agreement from the players.

Fifa is understood to have said it would not object to the message being carried on the shirts, along with a badge thanking NHS workers for their efforts during the coronavirus crisis.

The plan was raised at a meeting of Premier League clubs today and was unanimously supported

The decision will be only confirmed if it receives unified support from the players, something that appears likely given that most clubs have already staged some demonstrations of support for the Black Lives Matter campaign which has taken off following the death of George Floyd at the hands of police in America.

The messages would only be carried for the first round of matches from June 17 to June 23. The clubs also approved the return to play protocols and a match-

day operations plan for when matches re-start on **June 17.**

Manchester City face Arsenal and Aston Villa entertain Sheffield United on that day, which will then mean all the clubs will have played 29 games. A full round of matches will then take place over the weekend of June 19-23 after which the Black Lives Matter message would then be

Fury and Joshua confirm two fight deal

he has agreed a twofight deal with Anthony Joshua.

In an Instagram post this week, the WBC heavyweight champion said: "The Gypsy King versus AJ is on for next year."

Fury said he had just got off the phone from Daniel Kinahan, the founder of his management group MTK. "He has just informed me that the biggest fight in British boxing history has been agreed," Fury said. "He got this over the line, a two-fight deal. One problem I just have to smash Deontay Wilder's face right in and then we go into the Joshua fight next year."

Despite his enthusiasm there are plenty of obstacles to overcome. A third fight with Wilder is one of them, while Joshua, the WBA, IBF and WBO champion, needs to get past Kubrat Pulev. Dates for those fights have not been agreed, with Fury potentially fighting in Australia on Boxing Day.

In addition, Frank Warren, who promotes

Tyson Fury says that Fury in the UK, had earlier suggested that the news was premature after Eddie Hearn, Joshua's promoter, told Sky that talks were progressing well.

> Hearn said: "We've been talking to MTK, giving them assurances from Joshua's side that all the details on the structure of the deal is approved from our side - and that is it from Fury's side as well.

> However, Warren said no dates or venue had been agreed and a 50-50 split was old news and had been "common sense" from the start. He added that a Joshua-Fury unification fight was likely to take place in the Middle East.

> Kinahan, who has no criminal record, is a controversial figure in Fury's camp. Earlier this year, the Special Criminal Court in Ireland was told that the Kinahan gang was a criminal organisation involved in drugs and trafficking weapons. It has also been alleged that his gang is involved in a bloody feud with another led by a known Dublin gang-leader.
