SUN'S OUT: ...and so is social distancing

■ Brits flock to beaches in shocking disregard for coronavirus threat

Lazy hazy BRITAIN basked in glorious sunshine as the nation enjoyed its hottest day of the year with temperatures topping 91F (33C) on Wednesday.

And the country's fondness for sunworshipping has clearly not lessened during the Covid-19 lockdown, with social distancing widely flouted as thousands headed to the seaside and packed on to beaches at Brighton and Bournemouth. Hordes also flocked to beauty spots such as Warleigh Weir on the River Avon near Bath.

Things go so bad on the Dorset coast that visitors were urged to stay away by the local council and a major incident was declared in Bournemouth.

Bournemouth Beach was "stretched to the absolute hilt" on the second day of the heatwave.

Dorset Police said there were reports of gridlocked roads, fights and overnight camping.

People were urged to "act responsibly" as temperatures hit the mid-20s.

Traffic built up early on coast-bound roads including Durdle Door - and people travelled to Bournemouth from as far as Birmingham.

By Thursday evening the Sandbanks peninsula was "heavily congested", the council said, repeating its warning for people to "please stay away".

'irresponsible behaviour'

The ferry service in Sandbanks tweeted: "Again we're struggling to get traffic off the ferry at Poole, for now we hope to carry half loads of vehicles from Studland, but depends

on the gridlock in Sandbanks tonight."

The council said declaring a major incident meant a "multiagency emergency response has now been activated to co-ordinate resources across the area to tackle the issues".

England's Chief
Medical Officer,
Professor Chris Whitty,
tweeted in response
to Thursday's beach
scenes with a warning
Covid-19 "will rise
again" unless people
followed social
distancing guidelines.

Council leader Vikki Slade said they were "absolutely appalled at the scenes witnessed on our beaches".

"The irresponsible behaviour and actions of so many people is just shocking and our services are stretched to

the absolute hilt trying to keep everyone safe. We have had no choice now but to declare a major incident and initiate an emergency response," she added.

The council said it issued a record 558 parking fines.

"White Lives Matter" stunt organizer sacked

"We stand against racism of any kind and absolutely do not condone the activity."

One of the Burnley FC fans behind the incident when a plane with a 'White Lives Matter' banner flew over the Etihad Stadium has been sacked by his employer.

Jake Hepple, 24, organised for the plane to fly over the stadium in Manchester just after the game kicked off, as players from Manchester City and Burnley had 'taken a knee' to protest against racism. Hepple, from Colne, has been sacked by Burnley

aerospace manufacturer Paradigm Precision. The company said it 'did not condone or tolerate racism in any form'.

A spokesperson told Lancashire Live: 'We have concluded our investigation into the conduct of one of our employees in relation to an incident at the Burnley v Manchester City match, as well as other related manners. 'We have concluded that there has been a break of the company's various

policies and procedures. The individual no longer works for the company.

'Paradigm Precision does not condone or tolerate racism in any form and is fully committed to diversity and inclusion.'

Police investigating the incident said that no crime was committed. Lancashire Police launched an investigation after the plane, believed to have been operated by the firm Air Ads, flew above the stadium on

Monday. In a statement, Chief Superintendent Russ Procter said: 'Today [Tuesday] Lancashire Constabulary has been in liaison with Greater Manchester Police, the Aviation Authority and the Crown Prosecution Service regards the 'White Lives Matter' banner that was flown over the Etihad Stadium last night.

'After assessing all the information available surrounding this incident

we have concluded that there are no criminal offences that have been disclosed at this time.

'We will continue to work with our partners at the football club and within the local authority.'

On Tuesday, Blackpool Airport, where Air Ads is based, announced that it was suspending bannertowing operations with immediate effect. Stephen Smith, manager of the Blackpool Councilowned airport, said: 'Blackpool Airport and Blackpool Council are outraged by this incident.

"We stand against racism of any kind and absolutely do not condone the activity. The message was offensive and the action reprehensible. "The decision to fly the banner was taken entirely by the banner-flying company without the knowledge or approval of the airport or Blackpool Council."

How the Isle of Man beat Covid-19

The tiny tax haven of the Isle of Man is the first place in the British Isles to scrap social distancing restrictions, after recording no new cases for 28 days. Pubs, restaurants, shops and gyms on the self-governing British dependency Crown all reopened last Monday, with schools welcoming back all children the next day.

The island has reported just 336 coronavirus infections and 24 related deaths, among a population of about 85,000.

Although some have pointed out the differences in controlling a virus on a small island with a limited population, tough decisions have been made, with the island's success in containing the Covid-19 outbreak largely attributed to how quickly

the authorities "pulled up the drawbridge".

The Isle of Man closed its border to non-residents less than a week after recording its first coronavirus case. Widespread testing for the virus quickly followed, along with a contact tracing push.

Residents also faced tougher punishments than Brits on the mainland for ignoring social distancing rules, with hefty fines and jail sentences, typically of around four weeks.

During the lockdown, 21 people were jailed, 108 were arrested and 27 were given on-the-spot fines for breaking the regulations. In addition, a mandatory 14-day quarantine for anyone travelling to the island remains in place, with police checks to ensure compliance.

Explaining how the authorities came up with their seemingly winning formula, Howard Quayle, chief minister for the Isle of Man, says that his team "looked at the best advice that was going around the world and 'Manxified' them".

]"We tested and tested and didn't stop," Quayle said, adding: "By getting it under control quickly, we knew we would be able to get out of people's lives quickly."

But residents still aren't taking any chances. In the island's 50-odd reopened pubs, "hand sanitiser everywhere and protective glass by the tills are a reminder that we are not quite living in normal times", according to the BBC's Isle of Man correspondent Sadhbh O'Shea.

Triple murder suspect 'known to security services'

■ Khairi Saadallah killed three, wounded three more in weekend knife attack in Reading

A MAN who stabbed three people to death in a Reading park on Saturday evening was twice assessed by security services but was deemed to pose no danger of staging an attack, it has emerged.

Khairi Saadallah, 25, was referred to Prevent, the government's antiradicalisation strategy, and then to MI5 in the past two years. He was arrested on Saturday following the stabbing to of three men and the wounding of two more in the Berkshire town.

Investigators are picking through his life as they search for evidence of the motivation for the stabbings.

mental health problems

Deputy Assistant Commissioner Dean Haydon, senior national co-ordinator for counterterrorism, determined it should be treated as a terrorist attack, but with investigators keeping an open mind as to motivation as the suspect has a long history of mental health problems. His three victims – James

Furlong, Joe Ritchie-Bennett and David Wails – were friends and members of the LGBT community.

In 2018, he is understood to have been assessed by Prevent and found to have no clear ideology. He was deemed to need additional mental health support. In the same year, the Libyan national was granted asylum in the UK.

In the middle of last year, MI5 had Saadallah under investigation as a person who might travel to Libya "for extremist reasons". That claim was found to lack credibility and he was assessed as being far from the legal threshold for investigation.

Detectives are also examining his mental health history. Saadallah had been diagnosed with post-traumatic stress disorder (PTSD), depression and an emotionally unstable personality disorder.

He had also volunteered to help at a Christian church and reportedly at one point converted to Christianity.

On Friday, the day before the attack, a check

on the Reading address where he was staying showed Saadallah was not present and a search found him in the street.

The chair of Reading Pride, Paul Britt, spoke of anxiety within the LGBT community and called for clarity from the police as soon as possible on motive. He said: "Because it's so close to home everyone's feeling anxious. I would say that some people are feeling a bit more anxious. The community is feeling grief, shock and sadness. All the emotions that come with such a terrible atrocity."

"There's a sense of incomprehension. People are trying to understand what happened and why. People won't get closure until there's understanding. I don't

want to prejudice the investigation but some clarity would be helpful."

Paying tribute to Mr Furlong, 36, head of history, government and politics at The Holt School in Wokingham, his parents Gary and Janet said: "He was beautiful, intelligent, honest and fun."

The attack happened at Reading's Forbury Gardens, which was were dotted with groups of friends relaxing in the early evening sunshine when the peace was shattered by a commotion and frantic shouts of "run".

"Everyone was just having fun and then suddenly a man shouted," said Lawrence Wort, who had been sitting nearby.

The 20-year-old said he could not make out the words or in what language they were spoken.

What he could see was a man with a "massive knife".

"He stabbed the first person - they were sat in a circle in a big group of about eight to ten people and he darted round anticlockwise, got one, went to another, stabbed the next one, went to another and stabbed them."

Saadallah was rapidly overpowered at the scene by unarmed officers who have been praised for their "incredible bravery".



Eden Valley Sally: the world's most expensive sheepdog

A border collie from Brecon has become the world's most expensive sheepdog after being sold for £19,451.

The 19-month-old working dog called Elan Valley Sally was bought by an unknown buyer at the Farmers' Mart online sale at Dolgellau, Gwynedd.

Sally was sold by top handler David Evans of Libanus, Brecon, to an unknown buyer in the UK.

The average price for a working dog is about £2,000.

The previous world record was reached at Skipton, North Yorkshire, in February, when shepherdess Emma Gray of Northumberland sold two-and-a-half-year-old Megan, who she described as a "special dog", for £18,900 to a ranch owner in Oklahoma, USA.

'Diversity is our greatest strength' — Charles' tribute to Windrush generation

PRINCE Charles honoured the contribution of black people in Britain this week and hailed diversity as the country's greatest strength.

On Sunday, the 72nd anniversary of the arrival of the Empire Windrush at Tilbury Docks in Essex - bringing the first in a post-war generation of Caribbean immigrants to help rebuild Britain - the heir to the throne spoke of the nation's debt of gratitude to them. Charles, 71, also paid tribute to people from African and Caribbean backgrounds working in the NHS and other frontline jobs during the Covid-19 pandemic and acknowledged that they had been hit particularly hard by the coronavirus.

In a video message marking Windrush Day, he said: "Today, as we honour the legacy of the Windrush generation, and the invaluable contribution of black people in Britain, I dearly hope that we can continue to listen to each other's stories and to learn from one another.

"The diversity of our society is its greatest strength and gives us so much to celebrate."

His remarks came after a wave of Black Lives Matter protests in Britain and a report, published in March, which found some of the Windrush generation and their children were wrongly detained, or even deported, and others were denied official documents, healthcare, work and benefits despite legally living in the UK. More than 500 Jamaicans and others from various parts of the Caribbean - applying to job adverts amid labour shortages in post-war Britain – were among the 1,027 passengers who disembarked at Tilbury on June 22, 1948 from the British troop ship.

Charles said: "The men and women who stepped off the Empire Windrush at Tilbury in June 1948, just a few months before I was born, had left behind all that was familiar to them in order to strive for opportunity in a land they barely knew.

"Many of them had served with distinction in the British Armed Forces during the Second World War, just as their fathers and grandfathers had in the First World War. "Now they came to lend their hard work and skill to a country rebuilding in peacetime, and to forge a better future for themselves and their families.

"They could hardly have imagined how they, and those that followed them, would make such a profound and permanent contribution to British life.

"Today offers an opportunity to express the debt of gratitude we owe to that first Windrush generation for



accepting the invitation to come to Britain and, above all, to recognise the immeasurable difference that they, their children and their grandchildren, have made to so many aspects of our public life, to our culture and to every sector of our economy."

The Prince also highlighted the impact of coronavirus, and expressed

his sympathy to those who had lost loved ones.

He said: "I know that the black community has been hit particularly hard by this pernicious virus.

"To those who have lost their loved ones in such heartbreaking circumstances, when it has been impossible for them to comfort their relatives in hospital, I can only

convey my most profound sympathy.

"And to everyone on the front line who has been put under such intense pressure over the last three months and risen heroically to the unprecedented challenge, I want to say, on behalf of all of us, how inordinately proud we are of them and the way they carry out their onerous duties."

Portugal police tried to quiz Maddie suspect 'but gave up because he was out'

P O R T U G U E S E detectives tried to quiz Christian Brueckner shortly after Madeleine McCann vanished – but he was not in when they visited and it is not known if they ever returned.

The astonishing revelation that police may have given up investigating the German – who is now the prime suspect in the case – came from Goncalo Amaral. The disgraced ex-chief led the much-criticised initial probe in 2007 and has been in a legal fight with Madeleine's parents Kate and Gerry for nine years.

Amaral, 60, said: "I have been told by colleagues, retired like me, that they had come knocking on the door. That person was not at home." He said he was not aware if any more inquiries were made after the initial visit, shortly after Madeleine vanished in May 2007 in Praia da Luz, aged three.

Amaral's comments, in an interview on Portugal's TVI, came after it emerged last week that Brueckner

told a judge he was a paedophile when he was in court in 2006, charged with petrol theft. However, Amaral also branded Brueckner, 43, a "scapegoat".

He told the TV interview: "He's an almost perfect suspect.

"All that's missing for him to become the perfect suspect is for him to be

Amaral also insinuated German authorities had altered photos of the VW camper van Brueckner was using around the time Madeleine disappeared. The former detective, who was removed as head of the Madeleine McCann inquiry in 2008, showed interviewer Jose Alberto Carvalho photos he said were taken in Portugal of the same vehicle. One showed a series of distinctive cartoon-style characters painted on the front and back of a camper van. But the vehicle had no markings on it in the picture put out by police, he said. He added: "It's the same vehicle flagged up in the police appeal. I think it's important to ask why the photo put out by the authorities of the van was altered."

The interview was his first since Brueckner's name was made public.

COLEEN Rooney has said she is "disappointed" fellow footballer's wife Rebekah Vardy is suing her, but has told lawyers to fight the case "all the way".

Rebekah, 38, is suing Coleen for accusing her of leaking stories about her private life in a dispute dubbed "Wagatha Christie".

Coleen, 34, the wife of former England captain Wayne Rooney, planted three fake stories on her personal social media page, including a supposed US car crash, to try to find out who was leaking information to the press. She later named Rebekah's Instagram account as the source of the leaks.

Rebekah denied any wrongdoing, saying third parties had access to her account and an expert was investigating. She also said the stress of the very public row had caused her to suffer severe anxiety attacks.

The Rise of Flexible Workspace

Over the last decade, for

progressive companies, the office has played a key role in the, "War for Talent" - on recruiting and retaining the best 'Flexibility' people. and 'agility' have been the main lexicon of workplace strategists, understanding that productive staff want a range of workspace, whether it is a large open plan meeting room for collaborative projects or a high-top in a quiet area to be alone and think. The Internet of Things (IoT) enabled companies to collect data on how space was being utilized and "PropTech" companies responded software to maximize the efficiency building and space use. Working From Home (WFH) policies were being woven into this fabric of flexibility and agility as demanded by millennial talent.

Concurrently, leveraging the above factors, a revolution took place in the "flexible workspace" sector. The dour private executive office suite became, contemporary "coworking" spaces for communities, with WeWork leading the charge. The emphasis was on, "Workspace as a Service" (WaaS) with

a plethora of amenities provided and pricing bundled into one monthly payment. Long term leases gave way to short term licenses, re-branded as more friendly, "Membership Agreements". It was effectively the convergence outsourcing and hospitality applied to the commercial real estate business.

The movement disrupted an industry which favored the traditional landlord who sought long term leases to secure cash flows to create value and leverage lending. While many established companies comfortable signing 10-15yr leases, many smaller ones and particularly the fast scaling tech startups, could not predict where they would be in six months time. Flexible office solutions were perfect for them. Traditional landlords sat up and took note. Everyone wanted a piece of it. Some landlords created their own products, What started as an upgrade from the coffee shop for entrepreneurs and small businesses would grow by 1000% by the end of the decade to be an office solution for large enterprise companies like Facebook, IBM and

ISBC.

The Impact of Shelter-in-Place

tensions

that

are rising within the industry are due to the "double pandemic's, whammy" – a recession and a realization that employees can work productively from home. In a recession companies look to reduce overhead and as workforce is reduced so is the need for square Likewise, feet. increase in WFH policies will further reduce the amount of office space a company requires. Everyone is therefore fighting for a piece of a smaller pie. Some would argue that with social distancing companies will require more space, but I expect, with the emphasis on capital preservation, that this will be offset in the short term by re-purposing existing space and having staff return in teams on alternate days.

Much has been written about the policies and procedures needed to welcome people back to the office and it does not paint a pretty picture for anyone, flexible or traditional. With summer now upon us, most LA folks are looking to post Labor Day, September 8th, as the natural return point - with the phased

reopening of LA starting today things could be quite different in 3 months.

The Challenges Ahead

I have seen several predictions that this is the end of flexible workspace. This would seem counterintuitive in a recession when uncertainty, unpredictability and preservation of capital would see companies push for shorter term leases requiring little to no capital.

The problem, as I see it, is the negative press puts flexible workspace in one bucket and tars it with the same brush as WeWork's highly publicized problems. It focuses on operators who provide the open plan coworking centers in the traditional flex office business model. Critics are correct, this is high-risk, long term liabilities with short term assets. It involves the operator taking a


long lease - albeit with favorable incentives like rent free periods and contributions to fit out. The operator then fills the space with companies on short term license contracts on a pricing model that incorporates all their costs plus a profit. Works well when there's high demand but right now, centers will have high vacancies and suffering from severe cash flow issues as entrepreneurs and smaller companies run for the hills. The open dense plan and "community" led models will be unpopular while social distancing protocols remain in place, so it is unclear when their target client will return. There will no doubt be those that do not make it through this. In their favor is that the centers are typically, "Single Purpose Entities", easier to wind up and so it will not necessarily create a domino effect and operators can focus on

those that work while closing those that do not.

However, landlords who have leased to operators on these arrangements are very exposed right now. I suspect they will recast leases as partnership agreements or bring in third parties to run the spaces. It is in no one's interest to see the space sitting there idle, it needs to be put to work. Interestingly, last week in Hong Kong, we saw the first time IWG took over a WeWork. Deals are there to be done!

in the 1970s and 1980s, including a run between the 1972-73 and 1990-91 seasons in which they only failed to finish first or second in the league once.

They have not been without silverware in the past 30 years, winning three FA Cups, four League Cups, a Uefa Cup, the Champions League twice - the latest coming last season under Klopp - as well as three Super Cups and one Club World Cup.

However, since Kenny Dalglish led them to the First Division championship, thev have had to endure three decades without league success, during which their record tally of titles was surpassed by rivals

Manchester United, who have 20 to their name.

It was during this period that United boss Sir Alex Ferguson revelled famously in having "knocked Liverpool off their perch".

The Reds have come close during that time to restoring themselves to the top of the English game, finishing second in the Premier League on four occasions.

Gerard Houllier (2001-02) and Rafael Benitez (2008-09) both took them close.

Famously, in the 2013-Brendan season,

Rodgers' side looked as though they were going to take the crown but a late-season slump synonymous with a Steven Gerrard slip that enabled Chelsea to score and win at Anfield - saw them fall agonisingly short.

Last season, they racked up a stunning 97 points, losing only one game all campaign, but had the misfortune of coming up against an even better Manchester City side, who beat them to the title by a point. No side had ever achieved so many points without winning the league.

Blues edge City to hand Reds title

Liverpool were crowned champions of England for the first time in 30 years after Manchester City lost to Chelsea.

Only a win for City at Stamford Bridge would have allowed them to hold on to the Premier League trophy for a little longer and their two-year reign is now officially over.

Bruyne's Kevin de brilliant second-half free-kick cancelled out Christian Pulisic's breakaway goal for the hosts but Liverpool's title was confirmed with 12 minutes left when Fernandinho was sent off for handball on the line and Willian dispatched the resulting penalty.

While City are still in the Champions League and continue their defence of the FA Cup at Newcastle on Sunday, their next act in the league will be as part of Liverpool's coronation when they welcome the Reds to Etihad Stadium next Thursday.

City's hopes of delaying them further ended in alltoo familiar fashion, with crisp passing and forward moves undermined by fragile defending and lapses in focus.

They had been the better side until they gifted Chelsea the lead courtesy of a terrible mistake by Bernard Mendy after Chelsea had cleared a first-half free-kick.

The France left-back had Ilkay Gundogan in support but was far too casual as he gave Pulisic possession near the halfway line, then compounded his error by diving in and allowing the American to sprint clear and slot home.

De Bruyne's brilliant dipping free-kick arrowed into the top corner to bring City level shortly after the break and they almost took the lead moments later when Raheem Sterling hit the post after a stunning counter-attack.

Chelsea went at the other end when Fernandinho let Pulisic in and he rounded Ederson, only to be denied by brilliant goal-line

clearance by Kyle Walker.

That was a huge let-off for City but they were not so lucky the next time Chelsea came forward.

Ederson denied substitute Tammy Abraham and then Fernandinho blocked Pulisic's follow-up but the video assistant referee confirmed what everyone watching on TV had already seen - that he had used his hand to clear.

Referee Stuart Attwell showed the Brazilian a red card after pointing to the spot, and Willian planted his spot-kick into the net to ensure the night belonged to Chelsea - and Liverpool of course.

While this was a momentous result at the summit of the table, it was also hugely significant in the race for the top four.

Chelsea have seen Manchester United and Wolves close the gap this week but this was a convincing response, and not just because of a result that moves the Blues five points clear of the teams immediately below them.

Klopp: 'more than I ever dreamed of'

Liverpool's 30-year wait for a top-flight title is over after Manchester City lost 2-1 at Chelsea on Thursday confirmed the Reds as Premier League champions.

Jurgen Klopp's side needed one victory to seal the league but City's failure to win means they cannot be caught.

It is Liverpool's 19th top-flight title and their first since 1989-90.

Despite being urged to "stay home" by the city's metro mayor because of coronavirus, thousands of fans gathered at Anfield to celebrate.

Many of the supporters who congregated at the club's ground wore face masks and some lit flares.

A number of Reds including players, goalkeeper Alisson, defender Virgil van Dijk and midfielder Alex Oxlade-Chamberlain celebrated together after watching the Chelsea-City game.

Klopp, wearing a Liverpool shirt and clearly emotional, told Sports: "It is unbelievable. It's much more than I ever thought would be possible.

"It's an incredible achievement by players and it's a huge joy for me to coach them.

"I haven't waited 30 years, I have been here for four-and-a-half years, but it is quite an achievement, especially with the threemonth break because nobody knew if we could go on.

"I know it is difficult for people in this moment but we could not hold back. We will enjoy this with our supporters when we can."

As the global pandemic disrupted life in England and led to the suspension of the Premier League for three months, Reds supporters endured a nervous wait to see how the season would be concluded, with some early suggestions it might have been declared null and void, thus wiping their remarkable efforts from the record books.

Thankfully for them, that did not come to pass, and the Premier League's return this month enabled them to cap their stunning success.

However, because of the measures put in place in response to the virus, the Reds will not be able to celebrate their long-awaited SUCCESS with their supporters immediately, at least not in the traditional sense.

closed doors

As with Wednesday's impressive 4-0 win over Crystal Palace, when they next play at Anfield - against Aston Villa on Sunday, 5 July, and for their two other remaining home games - it will be behind closed doors.

As things stand it also seems unlikely they will be able to partake in any of the usual public events in Liverpool, such as an

open-top bus parade around the city.

By quirk of fate, though, the next time they take to the field will be at the side they have beaten to this season's title and who pipped them so narrowly last campaign, Manchester City.

Following their defeat at Chelsea, City boss Pep Guardiola congratulated Liverpool on their title success.

Winning the title was always the main aim for a club which had endured such a long wait to be crowned champions of England again, having earned that honour 11 times between 1973 and

But having achieved that ambition things could get better yet, with City's 100-point total for a season one of numerous records Liverpool can still

Klopp's side have produced one of the most memorable campaigns in Premier League history, amassing 86 points already, with a record of 28 victories, two draws and a single defeat from their 31 games.

Such has been their dominance, at one stage they led the table by 25 points - a record gap between a side in first and second in English topflight history.

Also still a possibility are the most wins in a season (the record is 32), most home wins (18),



most away wins (16) and biggest winning margin (19 points).

Their title win this season is the earliest on record, at least with regard to games remaining, with

the Reds having seven still to play.

That it is not the earliest title win by date is only because of the halting of football in England between March and

May as a result of the coronavirus pandemic.

Liverpool's triumph represents a huge moment for their fans, who grew accustomed to success cont. on page 11, col. 4
