# Jidhadist bride can come back to UK, judges rule

■ Court of Appeal decides Shamima Begum has been denied a fair hearing by Home Office

Shamima Begum should be allowed to return to the UK to fight the decision to remove her British citizenship, the Court of Appeal has ruled.

Ms Begum, now 20, was one of three schoolgirls who left London to join the Islamic State group in Syria in 2015.

Her citizenship was revoked by the Home Office on security grounds after she was found in a refugee camp in 2019.

The Court of Appeal said she had been denied a fair hearing because she could not make her case from the Syrian camp.

The Home Office said the decision was "very disappointing" and it would "apply for permission to appeal".

The ruling means the government must now find a way to allow the 20-year-old, who is currently in Camp Roj in northern Syria, to appear in court in London despite repeatedly saying it would not assist removing her from Syria.

Lord Justice Flaux sitting with Lady Justice King and Lord Justice Singh - said: "Fairness and justice must, on the facts of this case, outweigh the national security concerns, so that the leave to enter appeals should be allowed."

The judge also said that the national security concerns about her "could be addressed and managed if she returns to the United Kingdom".

Former Home Secretary Sajid Javid, who made the decision to strip Ms Begum of her citizenship in February 2019, tweeted a statement saying he was "deeply concerned about the judgement".

### 'not afraid'

He said that regardless of the outcome of her case, if Ms Begum came to the UK "it will prove impossible to subsequently remove her".

Daniel Furner, Ms Begum's solicitor, said: "Ms Begum has never had a fair opportunity to give her side of the story.

"She is not afraid of facing British justice, she welcomes it. But the stripping of her citizenship without a chance to clear her name

is not justice, it is the opposite."

Her father Ahmed Ali told the BBC he was "delighted" by the ruling, adding that he hoped his daughter would get "justice".

The prime minister's official spokesman said that while the government "doesn't

routinely comment on individual cases", the decisions it made about Ms Begum had not been "taken lightly".

He said the government would "always ensure the safety and security of the UK and will not allow anything to jeopardise this".

Ms Begum's legal team

challenged the move on three grounds - that it was unlawful because it left her stateless; it exposed her to a real risk of death or inhuman and degrading treatment; and she could not effectively challenge the decision while she was barred from returning to the UK. Under international law, it is only legal to revoke someone's citizenship if an individual is entitled to citizenship of another country.

In February, a specialist tribunal - the Special Immigration Appeals Commission (SIAC) - ruled that the decision to remove Ms Begum's cont. on page 4, col. 1

# Coronavirus: Sturgeon ready to quarantine the English

sparked anger this week by refusing to rule out forcing visitors arriving in Scotland from England to go into quarantine.

In a BBC interview, Scottish the Minister claimed her government will "take a very close look" at further draconian measures to stop a fresh surge in coronavirus north of the border. Asked on the BBC's Andrew Marr Show about the possibility of self-isolation, the SNP leader said the UK nations needed to work together on outbreak management in a way that "mitigates against having to put any border restrictions in place".

She said she was "immediately planning" to implement a quarantine policy but would "take

decisions the best I can to protect the health of Scotland and to take that absolutely from a public health perspective."

She said: "This is not about saying to people in England 'You are not welcome in Scotland' of course people in England are welcome in Scotland," she said.

"This is not about politics, it's not about a constitutional agenda, it's just about taking decisions to protect people in Scotland as

much as possible from Covid."

Ms Sturgeon said she would like to see Boris Johnson's Government be more explicit that it is trying

to get to levels of coronavirus that are "virtually elimination

"We need to be sure that any outbreaks in England are being properly managed, just as England will want to be sure that any outbreaks in Scotland are properly managed," she said.

"It's when there isn't that confidence that the concerns about possible importation would grow."

attacked Opponents her quarantine threat. Scottish Tory leader Jackson Carlaw said: "In the same week

that Nicola Sturgeon approved unrestricted travel to and from 57 other countries, it is astonishing that she

persists with promoting the possibility of a quarantine for people entering Scotland from the rest of the UK."

### **Houses of Parliament** moving to York?

proposed moving both **Houses of Parliament to** York while the Palace Westminster is refurbished.

In a report from The Times the prime minister casts doubt on the £4 billion renovation project that was agreed in 2018 and would entail MPs moving out in the coming five years. The independent body overseeing the project has begun a review.

Mr Johnson wrote the letter, addressed to Sarah Johnson and Goldstone, David chief executives of the restoration and renewal programme. In it he welcomes the review and says that it should examine "the full range of options". He adds: 'Cost should be kept to a minimum (i.e. no 'gold plating'). We should also move as quickly as possible."

He says that the case for both Houses staying put should be kept on the table but if a decant is required "possible locations within London, Richmond including House, the QEII Centre and City Hall" should be examined. He adds: "However, the review should also consider possible location outside London. The government is considering establishing government hub in York and it would therefore make sense to consider this as a potential location."

Boris Johnson has Lords and parts of the civil service. Transferring both Houses to York would appear to resolve questions of how peers work at a distance from MPs. A temporary move could be approved with a motion in both Houses.

A spokesman for parliament's restoration programme said: "The Houses of Parliament are falling apart faster than they can be fixed. As the prime minister has made clear, the current situation is unsustainable given the serious risk of a major fire and the need to upgrade the services throughout the building.

"The restoration and renewal programme was set up in law to tackle this urgent work. We are currently reviewing how the programme is delivered before sharing findings with both Houses of Parliament. In line with best practice, we remain committed to developing a business case that will set out in detail the options for restoring Parliament including cost estimates and timescales."

But Labour MP Chris Bryant scoffed: "They've already wasted ten years and millions of pounds without much as mixing a bucket of cement. Now the government wants to send the whole project back to square one. This constant indecision is utterly irresponsible."

# Catching coronavirus was 'traumatic' says Luther star

LUTHER star Idris Elba says catching coronavirus was "traumatic" - and he feels lucky to be alive.

The 47-year-old actor and his wife Sabrina Dhowre Elba, 30, tested positive in March. He released a video on social media to reveal their diagnoses - and became one of the first highprofile people to say they had the deadly disease. The couple suffered just a mild strain of Covid-19 and are fully recovered but Idris told Radio Times he is "lucky to be alive and thankful for being able to kick" the virus.

He said: "I was asymptomatic so I didn't get the major symptoms.

"Mentally it hit me very bad, because a lot was unknown.

"I felt compelled to speak about it because it was such an unknown.

"So the mental impact of that on both myself and my wife was pretty traumatic."

Idris, who has two children from previous relationships, was selfisolating with Sabrina in New Mexico when he released the social media video. More recently he has signed an open letter to the UK Film and TV Industry which asks for better representation of BAME (black, Asian and minority ethnic) people in the creative industries. In total 4,300 people were including signatories, actress and screenwriter Michaela Coel. TVpresenter Sandi Toksvig and actor Bill Nighy. It was written in the wake of George Floyd's death, the 46-yearold African-American who died after a white police officer knelt on his neck during an arrest in Minneapolis, Minnesota, in May. The horrifying incident sparked an uprising of the Black Lives Matter

movement.

The letter to British TV and film chiefs says: "We require your active engagement to tackle structural and systemic racism in our industry, in the UK and around the world.

"After decades of enabling racism in your ranks and beyond, it is time to do more. If black lives really matter to you, our stories must as well."

Idris told Radio Times that more diversity on screen can't be achieved by money alone, and that real change needs a strategy and targets. However, he added he did not necessarily agree with

the recent censorship of historic comedies that may now be deemed offensive by modern audiences.

He said: "Diversity, by way of how many different types of human beings there are, is an ever-flowing tap. Any steps moving forward to amplify diversity is a good

necessarily mean money but money helps. It's a shift in attitude, perspective, tolerance. You can't put an amount on that."

Idris is now looking forward to the TV and movie industry getting back on track after most projects were paused or cancelled because of the pandemic. Before lockdown he hinted that a Luther film could be in the making, saying: "There isn't a real formal plan for Luther at the moment.

"I've made it very clear that I'd like to see Luther come back as a film. And I can tell you this, that we are this close to making a film of Luther."

DCI John Luther was last seen on television in January 2019, and fans are eagerly awaiting a comeback.

**Idris** is currently appearing on Sky One in In The Long Run, a comedy he created that is set in the 1980s.

### Russia 'tried to hack' vaccine research

Russian state of trying to hack into its vaccine research and claimed that "Russian actors" attempted to influence the general election last year.

The UK, United States and Canada declared in a joint statement on Wednesday that Russian agency intelligence hackers had mounted a campaign to steal intellectual property from western academic pharmaceutical and institutions researching Covid-19.

Cozv Bear. cybergroup also known as APT29 and The Dukes, was named as the culprit behind the persistent action against organisations in the three countries, which began at the start of the global coronavirus outbreak.

Scientists at Oxford University and Imperial College London are understood to have been targeted by the group, which Britain formally linked to the Russian state for the first time.

In March the National Cyber Security Centre, a branch of GCHQ, the communications headquarters, installed digital protection around British laboratories, which is how the Russian hacking attempts were detected. An assessment

Britain has accused the of Cozy Bear activities revealed attempts to steal information about vaccine research and related supply chains, rather than disrupt studies and trials or steal patient data.

> Dominic Raab. foreign secretary, condemned Russian cyberattacks 'completely' as unacceptable", adding: "While others pursue their selfish interests with reckless behaviour, the UK and its allies are getting on with the hard work of finding a vaccine and protecting global health." He said that Britain would continue to work with allies to hold cyberattackers to account.

Kirill Dmitriev, head of Russia's sovereign wealth fund, denied that his country was behind hacking attempts. He said that the allegation appeared to be "an attempt to tarnish the reputation of the Russian vaccine by some of the people who are scared of its success, because the Russian vaccine potentially could visit first to the market".

Mr Raab also disclosed that the government was "almost certain" that Russians tried to influence the outcome of the general election last December after documents on trade talks with the US were "illicitly acquired".

citizenship lawful because she was "a citizen of Bangladesh by descent".

She is understood to have a claim to Bangladeshi nationality through her mother.

SIAC, a semi-secret court which hears national security cases, also said that although there were concerns about how Ms Begum could take part in the proceedings in London, those difficulties did

not mean the home secretary's decision should be overturned.

In his ruling on Thursday, Lord Justice Flaux said: "It is difficult to conceive of any case where a court or tribunal has said we cannot hold a fair trial, but we are going to go on anyway."

Human rights organisation Liberty, which intervened in Ms Begum's appeal, welcomed the ruling, saying the right to a fair trial was "a fundamental part of our justice system and equal access to justice must apply to everyone."

# RIP Sir Jack; knighthood calls grow for 1966 hero

week paid tribute to World Cup winner Jack Charlton as calls grew for the football legend to be given a knighthood posthumously.

Jack, 85, is the latest member of England's 1966 World Cup-winning squad to die without being honoured. The former Leeds United defender and Republic of Ireland manager had been diagnosed with lymphoma in the last year and was also suffering from dementia. Tributes were paid to Charlton, fondly known as Big Jack, before Leeds United's match at the weekend, with both sets of players and staff applauding the former defender's contribution to football after a minute's silence had been held.

Pablo Hernandez. who scored the winner against Swansea in Sunday's game, said: "Jack helped us from the stars and this win is for him.

"I celebrated a lot because it is such an important goal. The three points are for everybody, the fans, the club, but especially for Jack Charlton."

Ray Houghton, who was a loyal servant for the Irish team under the much-beloved coach for years, winning 76 caps under his guidance, said: "He was a larger than life character.

"The word legend is used too much in football but not for Jack, for what he's done domestically with Leeds, winning the World Cup, which he should have been knighted for, I've still never understood that, I think that's an absolute disgrace.

"He changed everything about Irish



SOUTHAMPTON: ENGLAND suffered a historic four-wicket defeat at the weekend as West Indies celebrated the return of Test cricket in the most emphatic style.

Not since 2007 have the Windies gone 1-0 up in a series of at least three Tests away from home and, against the backdrop of the coronavirus pandemic as well as the Black Lives Matter movement, this was a win for the ages.

Either side could have triumphed on the last day as the tourists chased a target of 200 and there can be no doubting the efforts of Jofra Archer, Mark Wood and Ben Stokes to fire England

But, guided by a stunning 95 from Jermaine Blackwood, who took his team from 27-3 to 189-6 before he was eventually caught at mid-off, West Indies rolled back the years in emotional fashion.

Windies skipper Jason Holder said: "It was one of the best wins I've ever been involved in. Day four was probably the best day I've ever had in Test cricket.

"It was hard-fought cricket and everything I asked of the guys they gave me, it was a real team effort and I'm delighted.
"I missed the Barmy

Army. But it was a level playing field without the crowds. It's been a good start back to international cricket, it sets the series up quite nicely."

Stokes and his side will be cursing dropped catches and mistakes that let the Windies off the hook on the final day. Blackwood's three lives mattered in the end. Palace are comfortably safe in 14th place but there is no question the end to their season has been something of an anti-climax.

England probably did not feel too worried as the next chance arrived in minutes. Zak Crawley could have thrown to either end for a run out but failed to pick up the ball. Blackwood then edged Stokes to Rory Burns in the gully at catchable height, only for the fielder to grab at thin air. Three missed chances in half an hour.

The tourists' win set

things up nicely, and it was fitting that Holder was in the middle on 14 not out as John Campbell hit the winning run. Campbell had earlier retired hurt thanks to a thunderbolt from Archer that smashed into his right foot and may well have broken a toe. Archer was outstanding. Operating in the high 80s and using his probing accuracy and aggression,



he produced a spell at the start of the day that could haved turn the match into a procession. First he invalided Campbell before accounting for Kraigg Brathwaite, a previous hero of Headingley, with one that squeezed off the inside edge and between the pads to hit the stumps. Shamarh Brooks was the next to go for a duck, absolutely plumb lbw without any need for a review, and Archer was flying. He also got rid of Roston Chase with perhaps the most brutal ball of the match, short and fast, which the batsman gloved behind.

The Windies, though, were brave in the face of England's pace – as they have been from the moment they took the decision to travel to a Covid-19 hotspot. Holder held back his bowling in the warm-up game then saw them deliver in the Test, while man-of-thematch Shannon Gabriel took nine wickets and put his sore body on the line in the best way possible.

### Let's make history, Rodgers tell Foxes

Leicester boss Brendan Rodgers challenged his team to "make more history" after victory over Sheffield United secured European football for next season.

A first-half strike by Ayoze Perez and Demarai Gray's counter-attacking goal ensured the Foxes stay fourth, a point behind third-placed Chelsea with two games remaining.

Their win also means they qualified for next season's Europa League at least.

But Rodgers wants Leicester to secure Champions League football for a second time after becoming Premier League title-winners in 2016.

"The result gives us the second-highest Premier League finish in Leicester's history. We have two games to go to create some more history," he said.

"We all sat down at the start of season and said, it would be huge

challenge for Leicester to get into Europe, so do that in my first season here, to guarantee that is a phenomenal achievement."

The hosts, who dominated most of the game, went ahead when impressive 19-year-old debutant Luke Thomas crossed low to set up Perez after 29 minutes.

They should have extended their lead after the break when Harvey Barnes was twice denied by United goalkeeper Dean Henderson after clever through balls by Jamie Vardy.

The Foxes' top scorer also hit the post, and it looked as though Sheffield United might be fortunate enough to equalise when Jack O'Connell's shot was tipped wide by Kasper Schmeichel.

But, as the game hung in the balance, substitute Gray, on for Barnes, collected Vardy's pass and beat Henderson to finally seal the win after 79 minutes.

Leicester's victory was only their second in six games since the restart but it was a timely boost for Rodgers' team, who moved three points clear of fifth-placed Manchester United.

Blades boss Chris Wilder was fuming with his players afterwards as the result ended a four-game unbeaten run which included wins over Tottenham, Wolves and Chelsea.

# Pep's £150m win

Having dodged a possible £200m black hole with their successful appeal they are now ready to splash the cash. Guardiola is keen to secure the long-term future of young centrehalf Eric Garcia, while Bayern Munich's David Alaba and Napoli centrehalf Kalidou Koulibaly are on City's radar.

CAS cleared City of UEFA charges of breaching Financial Fair Play rules and overturned the ban from European club football. The Swiss court reduced a fine from £27m to £8.9m but said City failed to cooperate with UEFA's investigation.

A UEFA statement read: "The CAS panel found there was insufficient conclusive evidence to uphold all of the Club Financial Control Body's conclusions in this specific case and that many of the alleged breaches were time-barred due to the five-year time period foreseen in the UEFA regulations."

City, who firmly denied any wrongdoing, said: "The club welcomes the implications of today's ruling as a validation of the club's position."

Leicester City's earlier victory over Sheffield United and responded with a victory that keeps them in fifth place, level on points with the Foxes but with an inferior goal difference.

United were made to work for their victory, Marcus Rashford breaking the deadlock with a stylish finish in first-half stoppage time before playing his part in a sweet move involving Bruno Fernandes that was rounded off by Anthony Martial in the 78th minute.

It extended United's unbeaten run to 19 games in all competitions but Palace felt a real sense of injustice, furious that they were denied a penalty just before United took the lead when Wilfried Zaha tangled with Victor Lindelof, and then seeing a potential 55thminute equaliser from Jordan Ayew ruled out by VAR for a very marginal offside.

Roy meant Hodgson's side slumped

to their sixth consecutive league loss and their night was made worse by what looked like serious injury to Patrick van Aanholt, who was carried off on a stretcher after trying to prevent Martial scoring United's second.

United were not at their best and were grateful to goalkeeper David de Gea for some fine saves, particularly from Zaha, while he also did well to keep out Luka Milivojevic's freekick.

This, however, is a United team developing a ruthless streak, demonstrated by Rashford's calm finish for the opener, and then an artistic move constructed by Rashford and Fernandes that enabled Martial to complete the job in style.
