PM dismisses EU bid to hijack UK-made Covid jabs

BRITAIN has ordered desperate EU chiefs to wait in line after Brussels tried to hijack UK-made Covid vaccine doses.

The bloc said tens of millions of shots must be diverted from British patients to cover shortages caused by its delays in ordering the vaccine.

MP Peter Bone said the move by EU boss Ursula von der Leyen was selfish, adding: "They must wait their turn. I don't know whether they think they are all-powerful but it just goes to show how incompetent they are.

"It also goes to show why so many people want to leave the EU.

"Their bureaucracy and incompetence means they are miles behind on their vaccine rollout and are now scrambling to do anything they can to cover it up."

'very confident'

The Tory MP added: "I don't think there is anything legally or morally right about what the EU is doing to try and queue jump when they were so late in placing their order."

Johnson insisted he
was "very confident

AstraZeneca to supply
the UK.

He said Britain would

carry on with massproduction of the drug, which was developed jointly with Oxford scientists.

The slapdown to desperate EU chiefs came after Brussels' health boss ordered AstraZeneca to divert vaccine supplies from its two UK factories to the bloc – or face legal and financial penalties.

Stella Kyriakides accused the pharmaceutical giant of breaching its contract with the EU by trying to keep the UK's supply chain separate to that of the rest of Europe.

She said the EU's contract for up to 400million doses names UK factories and that not using them to supply it is "against the letter and the spirit" of the agreemet.

Ms Kyriakides said: "We reject the logic of first come first served. That may work at the neighbourhood butchers but not in contracts."

The outburst risks squeezing NHS supplies at a critical time in the UK's mass vaccination programme.

The vaccine is made at AstraZeneca's Wrexham and Oxfordshire factories as well as in European

plants.

But EU officials claim the bloc has been offered only a quarter of the 100 million doses it had been promised for the first quarter of the year – so they need 75 million jabs from the British factories.

teething problems

The firm has blamed production issues at its European plants. Crisis talks with EU chiefs broke up without a deal Tuesday night.

The UK has forged ahead with its vaccine rollout after moving swiftly and tying up a contract with AstraZeneca for the supply of its jabs three months earlier than Brussels.

Ms Kyriakides added:


"There is no hierarchy of the factories. In the contracts there are four factories listed but it does not differentiate between the UK and Europe.

"The UK factories are part of our advance purchase agreements and that is why they have to deliver.

"We expect the doses that are in an advance purchase agreement to be delivered to the European Union."

President von der Leyen is under mounting pressure due to big delays in the rollout of the bloc's vacination programmes.

AstraZeneca's boss Pascal Soriot said supply chain teething problems were sorted in the UK before the EU as Britain had signed a contract



three months ahead of the bloc.

He said: "We are basically two months behind" due to manufacturing problems in Belgium.

He added: "The contract with the UK was signed first and the UK, of course, said 'You supply us first" and this is fair enough."

AstraZeneca insisted

the Commission had been heavily involved in drawing up its plans.

A spokesman said: "As each supply chain has been set up to meet the needs of a specific agreement, the vaccine produced from any supply chain is dedicated to the relevant countries or regions and makes use of local manufacturing wherever."

Hancock: EU can't block our vaccine supplies

■ Matt Hancock is "confident" Britain's jab programme will not be disrupted by an EU clampdown on the export of vaccines.

The Health Secretary been assured pharmaceutical bv chiefs that a Brussels demand for firms to ask permission before moving vaccines out of the bloc will not hit UK supplies.

But he took a swipe European the Union for indulging in "protectionism".

He said: "We oppose protectionism in all its forms and I think protectionism is unfortunate, especially so in the midst of a pandemic, when we are working so closely together with countries around the world."

He was backed by Boris Johnson, who warned the EU not to impose restrictions.

Mr Johnson said at a Downing Street news conference: "I don't want to see restrictions on the supply of vaccines or their ingredients."

EU chiefs are reportedly furious that millions of Britons have been vaccinated while many European countries are struggling to roll out their own programmes.

Brussels diplomatic

sources have even claimed that jabs meant for the EU have gone to the UK

Restrictions from the EU could be applied to the Pfizer-BioNTech vaccine which is made in Belgium.

During an online event organised by a foreign policy think tank on Monday, Mr Hancock pledged to cooperate with Brussels.

He said: "I am sure that we can work with the EU to ensure that whilst transparency is welcome, there are no blockers put

Having spoken to the chief executives both of Pfizer and AstraZeneca, I am confident the supply of vaccine into the UK won't be disrupted."

PM's official The spokesman said: "AstraZeneca are committed to delivering two million doses a week to the UK and we are not expecting any changes to that."

Referring to the Pfizer vaccine, the spokesman added: "Supplies will be lower this month and next as it upgrades its factory, but it will then increase production in March.

Projection of volumes of delivery remain the same for that period."

But Ms von der Leyen warned that Brussels "means business" addressing the row.

She insisted pharmaceutical firms should supply the bloc in return for millions of euros invested "to help develop the world's first Covid-19 vaccines".

Mr Soriot added: "I can only tell you the facts, and the facts are that we basically signed an agreement with the UK three months before we did it with Europe."

Monday's UK vaccine figures showed of the 7.3 million jabs given so far, 6.8 million are first doses – an increase of 279,757 on the previous day.

Meanwhile, German MEP Gunnar Beck said Britain's successful vaccine scheme was a "nightmare" for Europe's bosses.

He said: "The [bloc's] dysfunctional approach has been a huge failure for the commission.

"It's a nightmare for the EU that Brexit Britain's vaccine scheme is working better than the EU's."

Now foreign breaks are outlawed

■ Quarantine on return from red-list countries

BRITONS returning from 30 "red-list" countries will have to quarantine in hotels for 10 days at their own expense to stop mutant variants of Covid from entering the UK.

Home Secretary Priti Patel announced the crackdown on Monday and also banned Britons from going on sky trips - unless they can show that their trip is essential. "Going on holiday is not a valid reason", Ms Patel said.

She told the Commons that Britain will continue to refuse entrv to non-UK residents travelling from the 30 countries that have already been hit with a travel ban. But Britons heading back will now be forced to isolate in a hotel "without exception".

Ms Patel said details of the plan would be set out next week but warned the public they should "simply not be travelling". Too many people were still not complying with the rules, she added, and there are plans to force travellers to sign a declaration explaining the need for their trip.

She said: "Border Force have given me examples where even at St Pancras [in London] people have been turning up with their skis. That is clearly not acceptable.

Britons and foreign nationals with UK residence will have to quarantine in approved hotels if they return from one of the 30 countries. These include Portugal, Brazil, Mauritius and South Africa.

The new measures are not as hardline as had first been predicted, with the Government holding off introducing a blanket hotel quarantine policy for all arrivals.

But Ms Patel said the Government will continue to "take all steps necessary" to prevent the spread of coronavirus.

She added: "Every layer of protection we have put in place will help to reduce the risk of transmission of this virus and any new potential variant from entering the UK.

"And as we have done throughout this global health emergency, we will continue to take all steps necessary to protect the public and help prevent the spread of this virus."

Albanian gangs flooding UK jails

ALBANIANS are now the largest group of foreign nationals in Britain's jails, with the country's gangsters said to have taken over the UK drug trade.

The number in our prisons has risen from 335 in 2014 to last year's tally of 1,203.

That means an average of 12 criminals from the former Iron Curtain state were locked up every month over six years.

The Ministry of Justice figures show there are more Albanians in jail in England and Wales than any other foreign group – despite the tiny nation having a population of just 2.8 million.

Experts have said the incarceration of Albanians is fuelled by their involvement in the drug trade and its associated violence.

David Spencer, research director at the Centre for Crime Prevention, said: "These figures show a massive increase in Albanian criminals being held in British jails and illustrates clearly how Albanians are at the heart of the UK's spiralling drugs problems.

"This is something that the police and the Home Office need to prioritize and ensure that these gangs are shut down once and for all.

"It is clear that the Home Office needs to work on ways to tighten border checks on Albanian nationals as well to stop these violent gang members from being able to enter this country so easily and wreak the havoc that they are."

The National Crime Agency had previously warned it was increasingly concerned violent Albanian criminal gangs were gaining control of the cocaine market.

Welsh star Grufudd splits from wife of 20 years - who claims she was 'mentally tortured'

HOLLYWOOD actor Ioan Gruffudd and wife Alice Evans have vowed to "remain committed to our children" after it emerged he was leaving her.

The Welsh star of Liar and Fantastic Four lives with his actress partner and their two daughters in Los Angeles.

But Alice, 49, stunned social media by announcing that her 47-year-old husband had "fallen out of love with her" and was "leaving the family".

She later reportedly claimed she was being "gaslit and mentally tortured", adding: "Hell yes, I will wash my linen in public." The comments were subsequently deleted.

Gaslighting is when someone is p s y c h o l o g i c a l l y manipulated into doubting their own sanity. Now the couple have

told fans they are having "an incredibly difficult time" but are committed to their girls Ella, 11, and Elsie, seven. The pair's statement said: "This is an incredibly difficult time for our family and we remain committed to our children. Thank you for respecting our privacy."

Ioan's father Peter, of Pentyrch near Cardiff, appeared to confirm the split on Wednesday, saying: "Marriages do end."

The retired headteacher, 72, added: "I have spoken to Ioan and we are of course incredibly sad, but I do not want to go into too much detail.

"We are very sad, particularly for our two granddaughters." The couple have been together for two decades, marrying 13 years ago.

They met on the set of the 2000 film 102 Dalmatians. Their children were conceived

through IVF, with Alice writing candidly about her fertility struggles.

But late on Monday she shocked Twitter followers by writing that Ioan had told her their marriage was over.

She said: "Sad news. My beloved husband/ soulmate of 20 years, Ioan Gruffudd, has announced he is to leave his family, starting next week.

"Me and our young daughters are very confused and sad. We haven't been given a reason except that he 'no longer loves me'. I'm so sorrv."

The post was later deleted, with Alice claiming Ioan removed the message using her account.

Also known for roles in Titanic and Hornblower, Ioan admitted work schedules had kept the pair apart, saying last year: "We've struggled the past four years, making time for each other, because physically we're apart."

Poppycock! British Legion slammed for spending £100k on new logo

VETERANS have branded the Royal British Legion's decision to spend £100,000 on a new logo an "unforgivable" misuse of cash.

Former servicemen are aghast at the cost of the Legion's rebranding project, which was launched this week.

They accuse the charity of losing touch with its ethos of supporting exsoldiers as needy veterans face red tape and long delays and four respite centres closed.

Andy Price, 42, who runs the Veterans Hub support group in Weymouth, Dorset, said: "I am dumbfounded.

"Spending £100,000 on a brand change is a gross misuse of their funds and unforgivable at all levels.


"Our logo and branding cost us a pint of beer. I have to beg borrow and steal to keep the hub open in order to help people."

The Afghanistan veteran added "We have just helped one guy who was £79 in arrears on his rent and about to be evicted. It would have taken two or three months for the RBL to have helped him.

"Another member who suffers from bad arthritis and can't use his bath has waited a year for the RBL to put in a wet room. Another was rehoused by them, yet it took three months for him to receive white goods and an oven.

"I think the RBL has lost touch with what they are supposed to be. When they were set up they supported veterans returning from the Great War, but they are more like a corporate organisation now."

There are thought to be 3,500-6,000 UK homeless veterans and the suicide rate among the ex-military has doubled in the past



decade.

The RBL, which has an annual income of around £150million and bank reserves of nearly £70million, is launching its new logo to coincide with the charity's centenary

vear.

for purpose". The new £100,752 design has its R and L initials in blue and a bright red poppy instead of the letter B.

War hero Trevor Coult, who suffers from PTSD and now campaigns to help veterans, claimed the charity's priorities were "all wrong".

He said: "The RBL shut down every one of their respite centres because they needed to save money, yet they are still willing to spend over £100,000 on a new logo.

"It is shocking and is a kick in the teeth when so many veterans are struggling."



CRICKET: As England stroll to victory in Sri Lanka, skipper Root lays down new challenge ahead of challenging India tour

JOE ROOT has told his team to stay hungry and demand even more of themselves despite making history in Sri Lanka.


No side had ever won six Tests in a row on the island, until England captured the Moose Cup with two out of two at the weekend, while Root has also overseen five consecutive wins away from home in the past 13 months.

When you add home series wins over the Windies and Pakistan, there is little doubt this team is making real progress.

Across a variety of conditions, and with the extra challenges of coronavirus and biosecure bubbles, a lack of preparation, first-choice players missing at various points and losing the toss in both matches in Galle, this is what a very strong set of results.

But with stiffer challenges ahead, such as four Tests in India starting a week on Friday, Root knows he cannot afford to get carried away.

"This is exactly what



we wanted," said the man of the series. "Now the challenge is to replicate that over and over again as a team.

"We have to look at this as a platform and a starting position and not be happy with what we've achieved. The guys know there is so much farther this group can go. We have just got to stay hungry.

"We've got four very important games against arguably the best team in the world in their own conditions.

"We'll have to play right at the top of our game to win there, but we couldn't be in a better place to challenge them."

Another brilliant series with the bat from Root will go a long way to meeting that challenge, but he needs support.

For those playing Test cricket in the subcontinent for the first time there were moments of encouragement for Dom Sibley and Dan Lawrence, while Zak Crawley has a better idea of what it takes.

But there was no surprise the best performers behind Root were Jos Buttler and Jonny Bairstow, who will play one Test between them of the next four.


Buttler's dismantling of yet another chase had the hallmarks of a man in fine form and who is ready to return the faith shown in him. England are choosing to accept it just once in India.

They could not have asked much more of their spinners, Dom Bess and Jack Leach, who picked up four wickets apiece in the second innings to keep England's target down to 164.

And on paper 22 wickets out of 40 for the series is a job well done, but they will know they are unlikely ever to see the same levels of generosity that the Sri Lankan batsmen offered.

Reds roar back to form

■ Klopp's men end goalless streak with impressive win at Spurs

Liverpool returned to form in impressive fashion as the Premier League champions secured a convincing 3-1 victory at Tottenham Hotspur Thursday night.

After a run of five league games without a win-four of those without a goal - Liverpool moved back into the top four as they discovered their cutting edge in style at the expense of an uninspiring Spurs.

Spurs, who lost striker Harry Kane to an ankle injury at half-time, had an early Son Heungmin strike ruled out for offside before Liverpool's threat was rewarded with their first league goal in 482 minutes in first-half stoppage time.

Brazil striker Roberto Firmino took advantage of hesitation between Eric Dier and Hugo Lloris to tap in Sadio Mane's low cross from close range.

France keeper Lloris

was at fault again two minutes after the break when he pushed Mane's shot into the path of rightback Trent Alexander-Arnold, who finished emphatically.

Pierre-Emile Hojbjerg's 20-yard strike gave Spurs hope almost immediately but Liverpool were always in control of an entertaining second period.

After Mohamed Salah saw a goal disallowed by VAR for handball by Firmino in the build-up, Mane stole in at the far post to pounce on an error by the otherwise impressive Joe Rodon to secure the win for Jurgen Klopp's side.

Liverpool are now four points behind leaders Manchester City having played a game more. This was an outstanding result and performance by Liverpool in the face of yet more central defensive injury problems.

Fabinho, who has excelled in an unfamiliar centre-back role in the absence of Virgil van Dijk and Joe Gomez, was ruled out with what was described as a "minor muscle issue" while the fragile Joel Matip lasted only 45 minutes on his return to the side.

It meant Liverpool's central defensive partnership in the second half was captain Jordan Henderson and the inexperienced Nathaniel Phillips.

While that unlikely centre-back pairing coped well, it was at the other end where Liverpool were right back to their brilliant best, with Mane a constant threat while Firmino and Salah were full of menace and creation.

Their disappointing recent form has seen Liverpool drop down the Premier League table and also exit the FA Cup at Manchester United - but

the manner of this display was an ominous warning to write off the champions at your peril.

Jose Mourinho spent much of the second half bellowing instructions at his Spurs players in an attempt to spark a reaction - but it was to no avail as they produced a lacklustre performance.

Liverpool always carried a greater threat once Son's early finish

was ruled out for VAR but it was a moment of indecision between Dier and Lloris that opened the door for Firmino right at the end of the first half.

Then, straight after the break and moments following a warning from Mourinho after Spurs let Salah in for a chance, Alexander-Arnold scored to give Liverpool a twogoal advantage.

Tottenham's Harry Kane could be out for a "few weeks" after injuring both ankles in the Premier League defeat by Liverpool, says his boss Jose Mourinho.
