THIRD WAVE IS ON THE WAY, WARNS BORIS

BORIS Johnson has warned that the UK must be ready to face a third coronavirus wave set to "wash up on our shores" from Europe.

With infections spiking across the Continent, the Prime Minister has vowed to press ahead with his vaccination rollout "as fast as we can" to ensure that Britain is fully prepared.

The Government paved the way for an extended foreign travel ban that could shatter hopes of European summer holidays this summer. Updated Covid regulations published this week – ahead of a crunch Commons vote on Thursday – included an outright ban on leaving the UK.

In another sign of the success of the vaccination campaign, the total of inoculations surged past 30 million on Tuesday.

Health Secretary Matt Hancock said: "The vaccine rollout is showing the best of Britain – thank you to the team involved."

Meanwhile the UK daily death toll from the virus fell to 17, the lowest figure since September 28.

The Prime Minister said that fellow government leaders in Europe had alerted him to the seriousness of the latest virus outbreaks there.

"I've talked to our friends repeatedly over the period – we're all facing the same pandemic, we all have the same problems. If there is one thing that is worth stressing, it's that on the Continent right now you can see sadly there is a third wave under way.

"People in this country should be under no illusions that previous experience has taught us that when a wave hits our friends, it washes up on our shores as well.

"I expect that we will feel those effects in due course. "That's why we're getting on with our vaccination programme as fast as we can.

But a vaccination campaign and developing vaccines, rolling them out – these are international projects and they require international cooperation," Mr Johnson added.

A Government health minister also fuelled speculation that European countries may be about to be put on the UK's

travel "red list" of Covid hotspots.

Health Minister Lord Bethell told peers: "I don't know how that will play out and it's certainly above my pay grade to speculate, but we are all aware that the possibility lies that will have to red list all of our European neighbours – but that would be done with huge regret."

A Government spokeswoman said: "There are currently no plans for any additions to the red list."

The ban on leaving the country without a reasonable excuse was included in Covid laws due to come into force next week.

The law says no one may "leave England to travel to a destination outside the United Kingdom, or travel to or be present at an embarkation point for the purpose of travelling from there to a destination" outside the UK without a reasonable excuse.

On Thursday voted to extend emergency coronavirus powers for another six months.

They backed the health secretary's call to renew "essential" emergency rules to deal with the pandemic as England moves out of lockdown.

But some Conservatives voted against the measures saying they were "out of step" with the roadmap for lifting restrictions.

Ministers say the powers


will stay in place "only as long as necessary".

The Coronavirus Act came in to force in March 2020 at the start of the pandemic with ministers pledging to use the measures "when strictly necessary".

The law gave the government wide-ranging powers unlike others seen

before - from shutting down pubs, through to detaining individuals deemed at risk as part of efforts to contain the spread of the virus.

MPs voted by 484 to 76 to extend it - 36 Conservative MPs rebelled, by opposing the legislation. Twentyone Labour MPs also voted against it.

844, 285 jabs in ONE day!

■ As Brussels ramps up vaccine threats, Britain's Covid deaths plunge to 33

BRITAIN has delivered a record number of jabs in one day, leaving the EU lagging far behind.

As the daily Covid death toll fell to 33 on Saturday, vaccinations in Spain were just 136,000 while Italy managed 163,000 shots. Both France and Germany inoculated 200,000 of their populations.

But Britain's rollout achievement saw 844,285 people receive doses – at a rate of 27 jabs every second.

The record-breaking total, which followed more than 700,000 vaccinations just 24 hours earlier, was applauded by Boris Johnson.

The Prime Minister – who had received his first jab on Friday – said: "A huge thank you to everyone involved." He added: "Please come forward to get your jab when you are invited to do so."

Meanwhile, Brussels chiefs stepped up their threats to seize UK-bound exports of the life-saving vaccines.

Ben Wallace, the Defence Secretary, attacked the EU's stance as "counterproductive" and urged the bloc to be "grown-up" as part of a global effort to beat the virus.

He added the EU was "under tremendous political pressure" because of its botched rollout and said "the rest of the world is looking at the Commission about how it conducts itself". His Cabinet colleague Matt Hancock called the UK jabs total the "best of Britain".

'team effort'

The Health Secretary added: "For the second day running... a new record number of vaccines administered in a single day. This mammoth team effort shows the best of Britain – thank you to the British public for coming forward."

Dr Emily Lawson, NHS England's senior responsible officer for vaccine rollout, said: "It is remarkable that because of the sustained hard work of NHS staff and all those involved in delivering jabs up and down the country, the vaccination programme has once again topped its own success with its busiest week.

"I could not be more proud of all those involved.

"We moved on to offering vaccines to those aged 50 and above. We urge anyone in this group to make use of the huge range of sites you can book in to across the country."

Sir Simon Stevens, NHS chief executive, said: "The speed and precision of the NHS vaccination campaign has been on full display this weekend.

"NHS staff across England administered a remarkable 27 jabs a second. In just one day we vaccinated the equivalent of the entire adult populations of Liverpool, Southampton and Oxford.

"We have a strong supply of vaccine for the coming week too, so if you are aged 50- plus, don't delay."

Ursula von der Leyen, president of the European Commission, has repeated a threat to use emergency powers to seize vaccines set for export. She said in an interview on Saturday: "This is a message to AstraZeneca – you fulfil your part of the deal toward Europe before you start to deliver to other countries."

EU commissioner Mairead McGuinness told the BBC: "European citizens are growing angry and upset at the fact that the vaccine rollout has not happened as rapidly as we had anticipated."

"Both the EU and the UK have contracts with

AstraZeneca and my understanding is the company is supplying the UK but not the European Union.

"We are supplying the UK with other vaccines, so I think this is just about openness and transparency."

In response, Mr Wallace warned the manufacture of the Pfizer dose depends on supplies from the UK.

He said: "The grownup thing would be for the European Commission and some of the European leaders to not indulge in rhetoric but to recognise the obligations that we all have.

"We will all hold each other to our contracts. Making a vaccine is like baking a cake. We all have different ingredients and the European Commission will know

No jab? No pint!

PUB landlords could be allowed to demand proof of Covid vaccination from customers before allowing them on to their premises, it was revealed this week.

Boris Johnson suggested the Government was preparing to leave the issue up to "individual publicans" as an alternative to a national certification scheme.

The Prime Minister revealed the latest measures being considered during a hearing of the Commons Liaison Committee of senior backbenchers at Westminster.

His remarks follow a long-running debate within Whitehall about whether so-called "vaccine passports" could help open up the hospitality sector.

During the hearing, Tory MP William Wragg, chairman of the Public Administration and Constitutional

Affairs Committee, asked if "Covid vaccine certification" could be required for pub-goers. Mr Johnson replied: "I think that that's the kind of thing. It may be up to individual publicans, it may be up to the landlord."

The PM also said that the "concept of vaccine certification should not be totally alien to us".

Cabinet Office Minister Michael Gove is currently leading a review of the use of vaccination certificates as part of the roadmap for releasing England's lockdown. But Tory MPs campaigning for a swift exit from restrictions criticized the idea that unvaccinated people could be blocked from using some businesses.

Steve Baker, deputy chairman of the Covid Recovery Group of Tory MPs, said: "The Prime Minister began to tread a dangerous path when he opened the door to domestic Covid certificates.

"First they said we'll need them to watch the football, and today that it may be papers for the pub.

"Whether the state legislates for it, recommends it or simply allows it, the result will be the same. A two-tier Britain that prevents pregnant women from taking part in society, given that the Government is telling them not to take the vaccine.

"We must not fall into this ghastly trap."

ONE YEAR ON: Britain stops to remember

■ Nation pauses to mark pandemic's grim toll

THE nation paused to remember all those who have died in the pandemic this week on the anniversary of the day the first lockdown began.

The Queen reflected on the "grief and loss felt by so many" in a poignant tribute and a minute's silence was held at noon.

The Duke and Duchess of Cambridge visited the vaccination centre at Westminster Cathedral and left floral tributes.

8pm, stepped outside to join a doorstep vigil with candles, lanterns and torches, showing solidarity with the bereaved.

Landmarks including London Eye, Blackpool Tower and Cardiff Castle were bathed in yellow light, creating a "beacon of remembrance" across the UK.

The National Day of Reflection, organised by the Marie Curie charity, honoured more than 600,000 who have

passed away in the past 12 months of all causes, including over 126,000 Covid-19 victims.

The Queen sent flowers to staff who cared for Prince Philip at St Bartholomew's Hospital in London, where the 99-year-old Duke of Edinburgh underwent heart surgery earlier this month.

And in her poignant message the monarch, 94, said: "As we look forward to a brighter future together, we pause to reflect on the grief and loss that continues to be felt by so many people and families, and pay tribute to the immeasurable service of those who have supported us all over the last year."

Chief executive Professor Charles Knight paid tribute to Barts' staff and said: "I am in awe of you."

Marie Curie nurse Clare Horgan, who provides end-of-life care, said: "I know how important today will be for those going through

bereavement.

"We hope it will provide evervone with time and space to reflect."

One family in grief were Rebecca Govier and daughters Audrey, seven, and Madison, four, of Dormansland, Surrey, who lost their father Dean to cancer.

Health Secretary Matt Hancock said it had been "probably the hardest year in a generation".

Boris Johnson offered condolences to those who had lost loved ones and praised the "great

Keir Starmer tweeted: "Our thoughts are with

Labour leader Sir families and loved ones. And we thank our heroic NHS staff.'

We have been through a trial but we will emerge stronger, says Charles

PRINCE Charles has called on the nation to "take a moment together to remember those who have been lost" during the pandemic and ensure they are never forgotten.

He said the country would emerge from the crisis with strengthened faith in our society". But that as we look forward to a brighter future, it is right that we think of those whose lives have been cut short.

More than 600,000 people have died in England and Wales since the first lockdown. That includes more than 126,000 virus victims who have passed away within 28 days of a positive test.

In a video message to mark the National Day of Reflection, Charles, pictured right, said: "Over the past year our country has been through a trial which has tested our resolve and our resilience in countless ways.

"We have all been inspired by the resourcefulness we have witnessed, humbled by the dedication shown



by so many, and moved, by beyond words, the sacrifices we have seen. Union Jack to fly on all government buildings

Ministers have ordered government departments to fly the Union Jack every day "as a proud reminder of our history and the ties that bind us".

Oliver Dowden, the culture secretary, said this would apply all year round except on days when another flag was being flown, such as the Saltire on St Andrew's Day or the Cornish flag on St Piran's Day.

At present the Union Jack flies from government buildings only on designated days. Dowden said that the public expected to see it and promised that the new guidance would ensure "that happens every day".

Regulations will be introduced to make it more difficult for public buildings to fly the European Union flag and rules will be relaxed to enable flags associated with the NHS to be flown more often. Labour indicated its support for the plan.

Robert Jenrick, the communities secretary, urged councils to display the Union Jack alongside county flags. nation's flag is a symbol of liberty, unity and freedom that creates a shared sense of civic pride," he said. "People rightly expect to see the Union flag flying high on civic and government buildings up and down the country as a sign of our local and national identity."

The intervention comes after two BBC Breakfast presenters appeared to mock Jenrick for the size of his Union Jack during a TV interview.

Charlie Stayt and Naga Munchetty were "reminded of their responsibilities" by their bosses. Munchetty also apologised for liking social media posts that insulted the flag.

Fortunately the midwife who was going to meet us at the hospital wasn't that far away. So she drove up just as we had assumed the position and the second midwife came just after the head had arrived."


Mike, who has longed for a son after having daughters Mia, seven and Lena, two, joked the baby would be his final child.

He said: "I literally was like 'Yep, snip, snip, snip. I've got a boy. I'm out. I'm out of here'."

A Buckingham Palace spokeswoman said: "The Queen and the Duke of Edinburgh are delighted with the news and look forward to meeting their 10th great grandchild when circumstances allow."

Lucas is 22nd in line to the throne and not an HRH. His mother was sixth but is now 19th.

Jamie's failed venture feeding off taxpayers

The collapse of Jamie Oliver's restaurant empire has cost the taxpayer a further £500,000.

The TV chef, 45, was forced to close his Jamie's Italian restaurants in 2019 after the chain racked up more than £80million in debts.

More than 1,000 people lost their jobs and councils were reportedly left £1.2million out of pocket thanks to unpaid business rates.

Taxpayers are now having to pay more after some 200 former employees won employment tribunal claims.

Oliver, who lives in

a £6million mansion and is reportedly worth £100million, declined to comment on the compensation payouts.

One former employee, who won her case, said the sudden collapse of the business left many staff struggling. She said: "We were angry because of the lack of notice "We were only told through email.

'I ran out of money'

We all worked hard and were loyal and passionate about the company so people felt let down.

"I knew a husband and wife who both worked there so they

were jobless and had no money."

Oliver called in administrator KPMG in May 2019. he later said: "I ran out of money, ran out of everything and it was really tough..."

The Trade Union Act means employers have to consult with workers prior to any closure. however, Oliver's employees received almost no notice.

Employment judges have now found in their favour and awarded eight weeks' pay each.

But because the companies have no money, the bill will be picked up by taxpayers.

Speeders fined £400k every day

MOTORISTS caught by speed cameras pay out £418.49p every minute.

It adds up to £600,000 every 24 hours and brings in more than £200million a year in fines.

In the last nine years, Britain's 3,224 speed cameras have earned the Treasury £1.9billion.

In 2011 1.8 million tickets were issued raking in £187million. Eight years later, 2.6 million tickets were issued producing fines of £262million.

Jack Cousens, the AA's head of roads policy, said: "Over the period of the research we have seen more and more speed cameras in Britain.

"Many motorists will look at these huge numbers and think they are just a cash cow for the Government."

Tributes to rock 'n' roll footballer Worthington

FOOTBALL paid tribute to flamboyant 1970s star Frank Worthington this week, after his death aged 72, following a battle with Alzheimer's.

Gary Lineker led praise for the gifted England striker whose record of 266 goals in 882 games was matched by his colourful lifestyle.

The Match Of The Day host said Worthington nicknamed Elvis by teammates after his idol looked after him when they were at Leicester City together. He tweeted: "Profoundly saddened to hear that Frank Worthington has died.

"He was my boyhood hero when he was at LCFC. A beautiful footballer, a maverick and a wonderful character who was so kind to this young apprentice when he joined the club. RIP

Frank (Elvis)."

Leicester described him as a "legend", while two of his other clubs, Huddersfield and Bolton, sent their prayers to family and friends.

Admiring

The national side saluted his eight games for England in 1974, tweeting they were "deeply saddened".

Wife Carol said he died peacefully in hospital in Huddersfield, adding: "He will be greatly missed by everyone who loved him. Frank brought joy to so many people throughout his career and in his private life."

The Halifax-born showman played for 20 clubs over 26 years, spending 14 seasons in the top flight and was the league's top scorer in 1979.

Ex-boss Ian Greaves

described him as the "working man's George Best" for his skill, pop star looks and lifestyle.



The rest of the 1970s weren't too kind for England, with them not qualifying for the 1974 and 1978 tournaments. However in the 1980s they were able to rebuild and bounce back. One of England's highlights this tournament was striker Gary Lineker, who bagged brace in the 3-0 win against Paraguay. England soon exited the tournament courtesy of the 'hand of God' but Lineker became the first Englishman to win the Golden Boot.

England vs Cameroon - 1990 World Cup

England returned at the 1990 World Cup, this time building of the momentum of the hit New Order song "World in Motion". Cameroon had emerged as a dark horse after beating defending champions Argentina and their game with England was looking to go either way. The game finished 3-2 after England went ahead, then were pegged back to trail 2-1, before Lineker and Paul Gascoigne turned on the style to ensure a thrilling late 3-2 win. It may be the most entertaining World Cup game England have played.

England vs Scotland - 1996 Euros

After failing to qualify for the 1994 World Cup, England bought football home by hosting the 1996 Euros. To add to this, the world got to watch the oldest rivalry in football history when England took on Scotland. The 2-0 England win remains controversial, with some UK tabloids claiming England were assisted by Uri Geller's psychic powers against a penalty. But who can forget Paul Gasoigne's wondergoal?

England vs Netherlands - 1996 Euros

While England's win over Scotland was a nostalgic one, it was their win over the Netherlands that made them look like title contenders. England dominated the game, beating the 1988 Euro champions 4-1. England would be unable to win the gold, but this tournament still remains England's best performance at the Euros.

England vs Germany - 2002 World Cup qualifier

Although England defeated West Germany in 1966 to win the trophy, the rivalry went south from there. West Germany eliminated England at the 1970 World Cup. Then the Germans crushed England's dreams in both the 1990 World Cup and 1996 Euros via a penalty shoot-out England was able to beat Germany in the group stage of Euros 2000, but it felt more like a consolation prize. Then England drew Germany in the qualifying group for the 2002 World Cup, and the situation felt grim. England lost at home to Germany, but shocked the world when they came from behind to beat Der Mannschaft 5-1 in Munich.

England vs Greece - 2002 World Cup qualifier

To top the qualification group and make it to the 2002 World Cup, England needed to at the least draw with Greece. With Greece leading 2-1 with five minutes to go English hopes hung by a thread. But cometh the hour, cometh the man, and David Beckham, who infamously got red carded against Argentina in 1998, put on the performance of



a lifetime to tie the match with a trademark free kick and cement his position as an England icon.

England vs Argentina - 2002 World Cup

Although England has faced Argentina in 1962 and 1966, the dynamic changed after the Falklands War in 1982. Tensions were still high in the 1986 World Cup, which saw Argentina win with two of football's most famous goals. Then in 1998, despite Michael Owen's wonder goal, Argentina advanced on penalties after the team's tied 2-2. The old

with England emerging victorious thanks to a David Beckham penalty.

England vs Colombia - 2018 World Cup

After a string of failures, including an embarrassing loss to Iceland the 2016 Euros, the Three Lions were rebooted with a younger team under Gareth Southgate. England reached the semi finals, something they had not done in the World Cup since 1990. The highlight was the round of 16 clash with Colombia. Harry Kane put England ahead

from the penalty spot, only for Yerry Mina to equalize in the 93rd minute. England finally broke their penalty hoodoo with a heart-stopping shootout win.

With the 2020 Euros coming this summer, England will host the final games for the first time since 1996. Gareth Southgate's miss from the penalty spot in the semifinal cost them dearly against Germany. 25 years later and now at the helm of the national team, Southgate has the chance make the Three Lions roar once again.



England swat aside the minnows

England's World Cup 2022 qualifying campaign started with a predictably routine stroll to victory against San Marino at Wembley on Thursday.

The side rooted to the bottom of the Fifa world rankings at 210 were never going to be anything other than an easy target for England, even with captain Harry Kane starting on the bench, and so it proved in this one-sided qualifier behind closed doors.

England were encamped in San Marino territory for the entire game and the only disappointment for manager Gareth Southgate will be the fact their finishing was very poor.

They should have inflicted a much heavier loss on their besieged opponents, the highlight being a late goal for Aston Villa striker Ollie Watkins on debut after he came on as a substitute.

James Ward-Prowse's first goal for England, swept in from Ben Chilwell's low cross, gave them the lead after 14 minutes before Everton's Dominic Calvert-Lewin doubled

the advantage seven minutes later with a header from a fine Reece James delivery.

Raheem Sterling, who looked desperate to score from the start, added the third before half-time when his shot was deflected in at the near post and Calvert-Lewin scored his second with a simple finish, laid on by Jesse Lingard, eight minutes after the break.

Southgate's side lost rhythm after four interval substitutions but Watkins got in on the act with a crisp low finish to mark his first cap with a goal seven minutes from time after he came on for two-goal Calvert-Lewin.

One San Marino player to emerge with huge credit was goalkeeper Elia Benedettini, who made a string of superb saves from Chilwell, Mason Mount, Lingard and Ward-Prowse as England made the expected winning start to their World Cup qualifying campaign.

England were presented with, statistically, the easiest game in international

football and while the points were secured in the expected fashion, the victory margin could and should have been far more emphatic.

They carved out openings at will, with 32 shots - 15 on target - but the likes of Sterling and Calvert-Lewin could have added to their goals, while Lingard will wonder how he did not

find the target.

Ward-Prowse will be delighted with his goal while James, who is a serious contender to start at right-back at the Euros,

was a constant threat and source of supply in his 45-minute appearance.

Calvert-Lewin's two goals, albeit among a couple of bad misses, will do his confidence good and step up his claims to be Kane's understudy, as he continued his smooth transition to England level.

Belgium douse early Welsh hopes

HARRY WILSON gave Belgium an early scare before the class of the world's No1 team shone through in Wednesday night's World Cup qualifier.

Wilson fired Wales in front after just 10 minutes as Gareth Bale masterminded a superb passing move.

It sparked dreams of another famous Welsh win over the Belgians after dumping them out of Euro 2016.

But Kevin De Bruyne lashed in a fine leveller from distance and the hosts, who top the FIFA rankings, were ahead by the break from Thorgan Hazard's header.

It then became a very tough task for Wales in Leuven without the injured duo of Ben Davies and Aaron Ramsey, plus Joe Allen who hobbled off early on here. They showed plenty of guts under caretaker Rob Page.

But Romelu Lukaku's second half penalty sealed the victory in both nations' opening World Cup qualifier.

Page even opted to withdraw skipper Bale six minutes from time after a quiet second half from their record scorer.

It always looked a stiff test for Wales, especially when veteran midfielder Allen went off with an apparent hamstring injury in just the eighth minute. Yet the visitors then took the lead after a brilliant move down the right.

Wilson found Bale before the skipper picked out Connor Roberts with the outside of his left foot. Bale received the ball back at the top of the box and played in the rampaging Wilson first time to score with a clinical left-footer. It was the on-loan Cardiff star's fifth goal in 23 internationals.

The superb passing goal stunned Belgium but they soon started to crank up the pressure as Youri cont. on page 15, col. 1
