BORIS Johnson called for "common sense" this week as he axed major Covid rules.

able to go further."

The Prime Minister said people would finally be free to hug, to drink inside pubs and stay overnight again, adding: "Your efforts have so visibly paid off." He called on the public to enjoy the hard-won freedoms responsibly, after zero virus deaths were recorded in most of the UK.

Mr Johnson said that the time had now come for people to make their own decisions about how to protect others.

But he urged them not to "throw caution to the wind" once the restrictions end on Monday.

He said yesterday at No 10: "This unlocking amounts to a very considerable step on the road back to normality and I am confident we will be The Prime Minister called on people to "protect the gains" made in driving down the infection rate.

The Covid alert level has been reduced from 4 to 3 following a fall in cases and deaths, on the advice of medical chiefs. Step 3 of the roadmap out of lockdown lets people in England meet indoors for the first time since New Year, in groups up to six and from two households.

The go-ahead for the biggest lifting of restrictions came after not one Covid death was notified in England, Scotland and Northern Ireland on Sunday – four fatalities were recorded in Wales, up from two the day before.

From this coming

Monday, people will be able to sit inside pubs and restaurants; table service and mask wearing for staff will still be enforced.

Cinemas, theatres, concert halls and conference centres will be allowed to reopen while overnight stays in homes, hotels, b&b accommodation and hostels can return.

Visitors

Pupils will no longer have to wear Covid masks in classrooms and face-to-face teaching can restart for all university students.

Care home residents can from then on have five regular visitors, rather than the current two, with more freedom to leave.

Outlining the sweeping changes, Mr Johnson said: "We are

announcing the single biggest step on our roadmap and it will allow us to do many of the things we've yearned to do for a long time.

"So let's protect these gains by continuing to exercise caution and common sense."

He continued: "We are taking a step towards that moment when we learn to live responsibly with Covid, when we cease eventually to rely on detailed Government edicts and make our own decisions – based on the best scientific advice – about how to protect our families and those around us."

'guidance'

People would have to make their own judgments about precautions to protect themselves and others from coronavirus infection, he said.

"We are updating the guidance on close contact between friends and family, setting out the risks for everyone to make their own choices. "This does not mean we can suddenly throw caution to the winds.

"In fact, more than a year into this pandemic, we all know that close contact, such as hugging, is a direct way of transmitting this disease.

"So I urge you to think about the vulnerability of your loved ones – whether they have had a vaccine, one or two doses, and whether there has been time for that vaccine to take effect."

It's working: 2m jobs saved as UK economy surges

AN extra two million it is beyond doubt people will keep their jobs as the economy rebounds from Covid.

Rishi Sunak announced: "Our plan is working."

The Chancellor said that the jobless rate will likely be half what was feared originally after the pandemic struck last year.

He told MPs that Treasury help for workers and firms as lockdown eases is helping the recovery.

"While our recovery will be long and difficult, now that our plan is working," Mr Sunak said in a Commons debate on the Queen's Speech.

Chancellor's The positive verdict came on the back of figures showing output (GDP) surging by 2.1 per cent in March. Overall during the first three months of the year the economy shrank by 1.5 per cent due to the winter lockdown.

But the contraction was much less than the 3.8 per cent dive forecast by the Office for Budget Responsibility.

But is it cricket? **Bamboo** is **'better than** willow' for bats

LEATHER on willow is the classic sound of cricket. but scientists said this week that replacing the wood with bamboo makes bats stronger, cheaper - and better for the environment.

The ball will travel faster as bamboo is 22 per cent stiffer and the blade's sweet spot is bigger.

Dr Darshil Shah, from Cambridge University's Centre for Natural Material Innovation, said: "This is a batsman's dream. It's exciting for all kinds of strokes."

Dr Shah, who played for Thailand under-19s, added: "We'd just need to adjust our technique to make the most of it.'

There is a lack of highquality willow, mainly from England, which takes up to 15 years to mature for use in bats.

Moso bamboo can be ready in five years and grows abundantly in China, Asia and South America SO switching could cut costs and increase participation there. Ben Tinkler-Davies. study co-author, said: "The sport can do a lot more for the environment by promoting sustainability. We've identified a golden opportunity to achieve that while also helping lower income countries produce bats."

He added the sound of a ball hitting bamboo is "very similar".

Cricket's rules say that the blade must be wood, and bamboo is a grass. But Dr Shah said: "We think playing with a bamboo bat would be within the spirit of the game."

The pair hope to involve bat makers in the research – published in the Journal of Sports Engineering and Technology.

■ Parents of missing girl post touching tribute on what would have been her 18th birthday

THE parents of Madeleine McCann have sent a heartfelt message to their missing daughter and vowed they will never give up their search.

Kate and Gerry McCann posted the touching tribute for their loved one's 18th birthday on Wednesday - an occasion they felt they could only mark quietly at home in her absence.

Her mum and dad wrote: "Happy 18th Birthdav Madeleine. We love you and we're waiting for you and we're never going to give up."

Their moving words were put up on the official Find Maddie Campaign Facebook page, along with a cherished last photograph of their little girl when she was three, wearing a sunhat and beaming.

Green and yellow ribbons adorn the new post to symbolise hope, strength and solidarity.

Well wishers sent messages festooned with cakes, balloons, flowers and hearts to the site, viewed by thousands across the world.

Carole Blackburn said: "Thinking of Madeleine on her 18th birthday. Hoping she will be found one day."

Cathy Reilly wrote: "Happy 18th birthday Madeleine, wherever you may be."

Dawn McDonald added: "Happy birthday sweet Madeleine, thinking of you and your family."

Kate and Gerry spent the day praying for Maddie, who vanished in 2007. They left gifts in her bedroom, which has remained untouched, and remembered her at home in Rothley, Leics, with their 16-year-old twins, Sean and Amelie.

Maddie's great-aunt and great-uncle, Janet and Brian Kennedy, who live in the same village, also prayed for her. Retired headteacher

Union official suspended after tweeting Home Secretary Patel 'should be deported'

Labour has suspended Unite's assistant general secretary from the party after he tweeted that Home Secretary Priti Patel "should be deported".

Howard Beckett tweeted the comment after two men were detained in an immigration van in Scotland.

The union official later apologised for the tweet, which has since been deleted, as well as to Ms Patel.

While suspended from the party Mr Beckett is not be allowed to take up his place on Labour's ruling body.

He sits as a union

representative Labour's National Executive Committee - a role that requires membership of the party. Mr Beckett's tweet came after the Home Office detained two Indian immigrants in Glasgow on Thursday "suspected over immigration offences".

He wrote: "Priti Patel should be deported, not refugees. She can go along with anyone else who supports institutional racism. She is disgusting.'

In a later apology posted on Twitter, he said: "My earlier tweet, deleted after half an hour, was never intended to be literal."

Abu Hamza set for return to UK?

■ Firebrand preacher seeks 'compassionate' release from high security Colorado facility

THE hate preacher Abu Hamza has moved a step closer to freedom in his bid for "compassionate" release to get back to Britain.

Warders at America's toughest "supermax" prison have supplied his lawyers with his medical records as part of his legal challenge.

If a court grants his freedom there would be nothing stopping the former imam of Finsbury Park Mosque in north London, from returning to the UK.

In 2015 hook-handed Hamza, now 63, was told he would die behind bars after being sentenced to life in a US prison.

New York Federal

Court Judge Katherine Forrest said he would never be freed after being found guilty of 11 terrorism and kidnapping charges. In sentencing, she said: "Any time he is released the world will not be a safe place. He has not shown any remorse."

Last month, the state's Bureau of Prisons asked New York judge, Analisa Torres, if it could provide the cleric's medical records to his defence team.

Dangerous

US attorney Audrey Strauss – who is also leading the sex abuse case against British socialite Ghislaine Maxwell – wrote to make the request.

She said: "The court's granting of such permission will obviate the need for defence counsel to obtain a waiver from the defendant for the release of his medical records to his attorneys."

To seek compassionate release, inmates must file a petition with their prison governor.

It is however only granted "when there are particularly extraordinary or compelling circumstances".

Hamza has no hands and one eye, and is housed in a maximum security jail in Colorado, nicknamed the Alcatraz of the Rockies, along

with some of the world's most dangerous men, like British shoe bomber Richard Reid and Mexican drug lord El Chapo. Last year he began suing the US authorities over the "cruel" conditions he claims to be kept in. He says the removal of his hooks has left him having to tear open food packages with his rotting teeth.

Bent copper jailed for role in drug money heists

■ London PC colluded with Dubai crime kingpin to steal hundreds of thousands from drug dealers

A Metropolitan Police officer who pretended to stop and search drug dealers so he could steal their money has been jailed for eight years.

In an audacious scheme that could be lifted straight out of the UK's wildly popular TV cop drama Line of Duty, Kashif Mahmood seized hundreds of thousands of pounds for an organised crime gang controlled from Dubai.

The gang received information about when money was on the move so that Mahmood could intercept it - in uniform using police cars.

Four other men and a woman received sentences of up to 16 years.

The sentences follow an investigation which benefited from the penetration of the Encrochat mobile phone network in 2020.

Passing sentence, His Honour Judge Tomlinson said Kashif Mahmood had abused his position of "power, trust and responsibility".

'Betrayal'

Metropolitan Police Commissioner Dame Cressida Dick called the case "shocking" but said she was "delighted" the Met's anti corruption officers "were able to mount this operation and to catch those people and to actually have a big impact on an organised criminal network".

Of corrupt officers, Dame Cressida added: "They betray the rest of us and we deplore this form of corruption or any corruption."

The defendants pleaded guilty to

offences including acquiring criminal property, money laundering and drug supply.

It was a sophisticated criminal operation based on tip-offs from a shadowy figure in Dubai, named in court as Mutjaba Neazmand.

Using the code name "SSNew" on the Encrochat network, the court heard he was involved in large-scale drug dealing, but also directing gang members to "steal back" the proceeds.

UK 'jobs'

Neazmand would contact the gang's leader in the UK, Mohsin Khan, with information about "jobs" - large amounts of money being carried by drug couriers.

Khan, whose Encrochat nickname

Mahmood would book out police cars from Stoke Newington Police station, and pick up an accomplice, Ioan Gherghel, to pose as his

partner.

Backed up by Khan and his two brothers, they would then try to stop the couriers and "seize" their money.

Often the couriers had been given the cash by the Khan gang as part of a drug deal.

When it was stolen back by the Khans and

Mahmood, they were left out of pocket, and at risk of reprisals from their criminal associates.

The scam was so successful the gang seized more than a million pounds, prosecutors believe.

By March 2020 "SSNew" or Neazmand, the mastermind in Dubai, was boasting in Encrochat messages that: "We can do 1500m and I still say to u bro we do more."

"This system is in our hand. We can do it unlimited."

Police say Encrochat was almost exclusively used by criminals who communicated freely, believing their conversations were encrypted.

It was penetrated by French police and intelligence agency cyber security experts in early 2020, and, as a result, more than 1,500 suspects have been arrested so far.



Santa Barbara: a Californian gem, still shining very brightly

"Los Angeles is 72 suburbs in search of a city."

At least that's what famed wit Dorothy Parker once wrote of our adopted hometown, and although it can be accurately described as a vast wasteland with uniquely bizarre barrage of cross-cultures, to my mind that's what makes it so special. In other words, anything goes.

But for a more retro and homogenous (and some say, more authentic) California experience, you can't do better than take a trip up the 101 to Santa Barbara. Nestled between the coast and the mountains just 90 minutes north, the place remains as enchanting and seductive as it was to the wealthy elite to flocked to the town in the 1930s.

I've been filming in this compact gem of a town recently and last week we happened to be shooting a trapeze artist in an empty parking lot right by the freeway. Before driving on to San Jose the crew and I got to enjoy a well needed day at the beach.

The city is pleasingly located on the longest section of south-facing coastline on the West Coast, bracketed by the Santa Ynez Mountains to the north and the Pacific Ocean to the south. The climate is classically Mediterraneananditwas pitched to vacationers as the 'American Riviera' during its initial heyday before Word War II. In recent months it has come back into the spotlight as the adopted home of The Duke and Duchess of Sussex, or rather it's tony suburb of Montecito, where the royals' neighbors include Oprah Winfrey and Michael Douglas.

We working stiffs enjoyed a delicious brunch at Chad's, conveniently located right by the sea, where we quaffed a flight of mimosas, dived into some incredible Eggs Benedict and enjoyed watching the sail boats glide by. It's a little slice of heaven. (chadscafe. com).

There are plenty of options in terms of places to stay. We opted for the Inn By The Harbor, a quaint little place with a cute courtyard which ran us \$159 a night but if you are feeling lavish you can always stay at the Bacara for around \$1500 a night. And if you want to splash out on a sumptuous Sunday brunch there is always the legendary Biltmore Four Seasons, where well-heeled locals and vistors alike have been downing Bloody Marys since the 1920s.

If you're craving gourmet food at modest prices, don't miss La Super-Rica on Milpas Street, which has long been a must-eat destination for visiting foodies. The place itself looks like not much more than up upmarket taco stand but the food is quite superb.

There are tons of young folk milling around the old town district on weekend nights, particularly on State Street, thanks to its proximity to the nearby University of California, Santa Barbara. Covid



Defeat for Manchester United against Leicester on Tuesday night finally delivered a third title of his hugely successful fiveyear Etihad reign.

But the City boss maintained this has been the toughest of all campaigns, with a gruelling schedule, no fans and battling restrictions throughout.

"This has been a season and a Premier League title like no other - this was the hardest one," said Guardiola, whose side are 10 points clear of United with three games remaining.

will "We always remember this season for the way that we won. I am so proud to be the manager here and of this group of players.

"They are so special. To come through this season - with all the restrictions and difficulties we've faced - and show the consistency we have is remarkable.

"It is relentless.

Every single day, they are there, fighting for success, trying always to be better. They have been so, so resilient."

City can still land treble this season, having already won the Carabao Cup and with a Champions League final to come against Chelsea on May 29. But Guardiola, who has landed eight domestic trophies since arriving in Manchester in 2016, said the league title is always the most important piece of silverware on offer.

Reds st a shout

Jurgen Klopp celebrated his first win at Old Trafford Thursday night as Liverpool came from behind to beat Manchester United 4-2 and boost their chances of a Champions League place.

In a thrilling game played against the backdrop of noisy protests against the United ownership outside the ground, United struck first through Bruno Fernandes' deflected opener.

But Liverpool, who had seen one of their buses prevented from picking team members up before the game after being blocked in the street, hit back through Diogo Jota's instinctive effort.

Roberto Firmino, who had only scored once since his two-goal haul at Crystal Palace in December, then put his side on top with a well-taken double either side of half-time.

Rashford Marcus pulled one back for United midway through the second half but Mohamed Salah wrapped up the points with a late

breakaway strike for his 21st Premier League goal of the season. That moved him level

with Harry Kane in the Golden Boot standings and condemned Ole Gunnar Solskiaer's side to a sixth home defeat of the season.

The result takes Liverpool fifth in the Premier League. If they win at West Brom on Sunday they will close to within one and three points respectively of FA Cup finalists Chelsea and Leicester, who still have to play each other at Stamford Bridge on 18 May.

Brendan Rodgers was in charge in March 2014, the last time Liverpool beat United in an away game. Jordan Henderson's groin injury meant there was no-one left from that night in the visitors' ranks, and Klopp celebrated his debut United away win with a double fist-pump as Salah scored.

Salah might have had the chance to get on the scoresheet much earlier in the game had referee Taylor Anthony not

consulted the pitch side monitor and changed his decision to give a penalty for Eric Bailly's tackle on Nat Phillips.

Knowing victory was needed to maintain a realistic top-four chance, Klopp appeared distinctly unimpressed by the incident. The Ivorian defender certainly played the ball first but the force behind the challenge sent the Liverpool defender flying.

In a game that started to the sound of a police whirring helicopter overhead, Liverpool did not have to wait long, Jota's finish was excellent but United's defence stood off Phillips after a corner, allowing him to run and turn before his shot spun to the feet of his Portuguese team-mate.

Trent Alexander-Arnold's superb free-kick delivery to the far post in first-half stoppage time invited Firmino's header to put Liverpool ahead and was a timely reminder of his ability with England boss Gareth Southgate watching from the stands.
