# CUMMINGS CLAIMS ARE 'PURE REVENGE', SAY TORIES

# ■ Allies of PM brand 7-hour tirade by his former aide 'vengeful and embittered'

TORY MPs closed ranks this week following an explosive series of claims by former Boris Johnson adviser Dominic Cummings.

The controversial spin doctor – who masterminded the successful Leave campaign ahead of the Brexit vote - has been branded "vengeful and embittered" after an extraordinary seven-hour public attack on the Prime Minister, his ministers and officials.

Allies of the PM savaged the ex-chief Downing Street adviser over his allegations that the Government's response to Covid was chaotic and "a complete disaster".

During a marathon testimony at a Commons committee hearing, the Tory strategist claimed "tens of thousands of people died who did not need to die." Mr Cummings accused the Prime Minister of repeatedly dismissing coronavirus as a "scare story" and declared him "unfit for the job" of

running the country.

He also said Health Secretary Matt Hancock should be sacked for "lying". But one senior Tory said on Tuesday: "Cummings has no credibility at all. He behaved at the committee as he always has done, claiming he is eternally right and everyone should listen to him."

The Tory grandee also dismissed Cummings, who was sacked from Downing Street last November, as "vengeful and embittered".

Speaking at Prime Minister's Questions, he said: "I think what the people of this country want us all to do is to get on with the delicate business of trying to reopen our economy,

restore people's freedoms and get back to our way of life by rolling out the vaccine.

"To go into lockdown is a traumatic thing for a country. To deal with a pandemic on this scale has been appallingly difficult.

"We have at every stage tried to minimise loss of life – to save lives and to protect the NHS – and we have followed the best scientific advice that we can."

Mr Cummings, dressed in a white opennecked shirt, gushed out allegations by the dozen during the televised question-and-answer session held jointly by the Commons Health and Science and Technology Committees.

He began his epic

evidence session with an apology for the Government's handling of the pandemic.

He said: "The truth is that senior ministers, senior officials, senior advisers like me fell disastrously short of the standards that the public has a right to expect of its Government in a crisis like this.

# UK vaccine totals close in on 60m

#### ■ Health Secretary hails 'another great British success story'

BRITAIN is blazing its way towards freedom with the country's vaccination blitz hitting 60 million doses.

Boris Johnson said its success meant people would soon be able to do "the things we love" with just three weeks to go until the June 21 'Freedom Day'.

Cheering the landmark, the Prime Minister said: "Jab by jab this life-saving programme, unparalleled in our history, is getting us back to the things we love. Thank you to everyone who has made this happen.

"Please get both your vaccines when it's your turn."

The stunning achievement means that 72 per cent of UK adults have received a first dose of a Covid-19 vaccine.

Overall, 37.9 million people have had one jab with 22.6 million having both doses.

Health Secretary, Matt Hancock added: "Our trailblazing vaccination programme – the biggest and most successful in NHS history – is another great British success story and a testament to what can be achieved when all four corners of the country comes together to defeat this virus."

He is "increasingly confident" England is on track for the Government's coronavirus roadmap.

Mr Hancock said Saturday was a "huge day" with 762,361 first or second jabs, the second highest daily total since the rollout started.

The welcome news comes after the latest daily data showed there were 2,235 coronavirus cases and five associated deaths.

And a study which found the Pfizer and AstraZeneca vaccines are highly effective after

two doses against the variant identified in India.

Both ministers and senior health officials say the latest vaccine data means the possibility of all coronavirus restrictions being lifted next month is "looking good".

Under the Government's roadmap, the final stage of the unlocking is due to take place on June 21 at the earliest.

Dr Jenny Harries, the chief executive of the UK Health Security Agency, said: "It's looking good if people are continuing to observe all of the safety signals, so we should not stop doing what we're

doing

Home Secretary Priti Patel said the rollout is "gradually enabling us all to live our lives".

She told Sky News: "We

should absolutely just reflect upon the success of the vaccine and how that is giving people, individuals, society, businesses confidence to be back out there again at what is a very critical time, a year after lockdown and very tough decisions that have been made by the Government."

## HOUSE ABOUT THAT? Property market smashes records

BRITAIN'S property market will break records this summer as a pent-up demand drives prices ever higher, experts claimed this week.

Competition between buyers determined to bag their dream home saw one in three properties sold for more than the asking price last month, smashing the alltime record.

And this year's housing market is on course to be the busiest since 2007, with around 16 buyers competing for every property up for sale.

Around 1.5 million UK house sales are expected across 2021, up by 45 per cent compared with last year, property website Zoopla said.

The value of homes sold in 2021 is projected to reach £461billion – up by 46 per cent.

Statistics from estate agents show 32 per cent of homes sold above their original price tag last month – beating the previous all-time high of 19 per cent from 2014.

The average number of house hunters registered per estate agency branch was 427 last month, an increase from 409 in March and the highest April figure since 2004.

Mark Hayward, the National Association of Estate Agents Propertymark's chief policy adviser, said: "It's phenomenal to see demand for housing breaking records, as house buyers continue to fuel the post-Covid economy."

**Cummings:** 

paint an extraordinary picture of chaos at Downing Street as the pandemic spread last year.

"In February, the Prime Minister regarded this as just a scare story, he described it as the new swine flu," Mr Cummings told MPs. He likened the heart of Government in mid-

March to the disaster film Independence Day "with Jeff Goldblum saying the aliens are here and your whole plan is broken and you need a new plan".

And delays over the second lockdown last autumn led to thousands of needless deaths, the former aide claimed. "I said to [Boris] ...'surely you have got to learn the lessons from the past'. And the Prime Minister decided no and said

basically we are just going to hit and hope."

Mr Cummings, 49, also said Mr Johnson's fiancee Carrie Symonds wanted him out. "By October 31 our relations were essentially already finished. The heart of the problem was fundamentally I regarded him as unfit for the job...

He compared the Prime Minister to a "shopping trolley" that was difficult to control.

### ■ Royal couple enjoy traditional ceremony to end week long Scotland visit

Kate Middleton and Prince William were treated to a traditional Beating the Retreat ceremony complete with bagpipers and a troupe of Highland dancers on the final evening of their week-long tour of Scotland on Thursday.

The Duchess of Cambridge, 39, looked dazzling in her baby blue Catherine Walker coat dress, joining her husband at the Closing Ceremony of the General Assembly of the Church of Scotland.

Kate looked a picture of elegance in the chic belted wool coat which cut at the knee. Having let her locks loose throughout the day, the mother-of-three swept her chestnut waves into a more refined half-updo.

The couple, both wearing blue, arrived at the General Assembly Buildings after a busy day of engagements.

William was supposed Lord High to be Commissioner at the General Assembly May last year, but the event was cancelled. The Duke was appointed by the Queen as her personal representative. Commissioners and other attendees joined the event remotely from across Scotland and around the world, with only a small number of people present in the assembly hall.

Kate teamed her coat with her £425 Emmy London 'Rebecca' Riviera Suede blue stiletto heels and a Strathberry clutch bag in a navy blue croc leather, designed in Scotland. She also wore the Queen's Floral Bouquet Brooch with its matching stud earrings, which she previously borrowed for the Commonwealth Day service at Westminster Abbey in 2018, as well as

# Look who's zooming! United star scores 'surreal' chat with Obama

#### ■ The pair spoke about some of their shared experiences

Footballer Marcus Rashford has spoken with President Barack Obama to discuss the power young people can have to make change in society.

Rashford, 23, the Manchester United and England striker, met virtually with the 44th United States president for a 'surreal' Zoom conversation (pictured, right) on topics important to them both.

Thursday's discussion focused on giving back to your local community and the positive impact of reading, as well as other themes from the president's memoir, A Promised Land.

The pair also spoke about some of their shared experiences, including being raised by single mothers.
Rashford last year spearheaded a prominent campaign to tackle child food poverty in the UK during the coronavirus pandemic.

It led to 1.7 million vulnerable children being supported by a £520 million Government scheme and other projects have helped deliver 130 million meals.

He has also launched a food education and cooking project for children, 'Full Time Meals'.

President Obama said: 'A lot of the young people I meet - including Marcus - they're ahead of where I was when I was 23. They're already making changes and being positive forces in

their communities.'

The conversation, which was organised by Penguin Books and moderated by broadcaster and author June Sarpong, was released in full on Penguin UK's YouTube channel on Friday.

Rashford said: 'It's quite surreal isn't it? I'm sitting in my kitchen in Manchester, speaking to President Obama. But, immediately, he made me feel at ease.

'It wasn't long before I realised just how aligned our experiences as children were in shaping the men you see today – adversity, obstacles and all. I genuinely enjoyed every minute of it. When President Obama speaks, all you want to do is listen.'

# Priti: BBC needs to learn lessons or face tough reform legislation

PRITI Patel has threatened the BBC with sweeping reforms in the wake of the Princess Diana interview scandal.

The Home Secretary said the corporation's governance and funding will be looked at "very closely" when its royal charter is reviewed next year.

In a blistering attack, she said the findings of an inquiry into the 1995 Panorama interview had "highly damaged" the BBC's reputation.

The Dyson Inquiry found that journalist Martin Bashir used "deceitful behaviour" to land his world exclusive interview and that an internal investigation had covered it up. Ms Patel said the broadcaster now needed to rebuild "trust and confidence".

She told The Andrew Marr show on BBC One this week that it had been "utterly heart- breaking" to hear Diana's sons Prince William and Prince Harry speaking "in very personal terms" about their mother, following the publication of the report last week. She said: "There is no doubt this world-class institution, its reputation has been highly damaged. Lessons will have to be learned – there is no question about that."

Asked whether the broadcaster would survive, she said it would need to "reflect and learn lessons". Citing the Government's upcoming review of the BBC's Royal Charter, the Home Secretary added: "If there is subsequent action that needs to be taken, then clearly alongside the publication of this report and lessons being learned and changes to the institution, structure, governance, accountability - that will follow.

"This is going to be a very significant and serious moment, at a time when the reputation of the BBC has been compromised."

Ms Patel also said the BBC would have to reflect on where it stands in a multimedia world – an apparent reference to whether parts of the corporation would survive.

The Conservatives have regularly threatened the BBC with funding cuts and reform since coming to power in 2010.

The Dyson report found Bashir had seriously breached rules by commissioning faked documents, which he showed to Diana's brother Earl Spencer to obtain the interview.

Lord Dyson criticised the internal BBC investigation in 1996 that cleared the journalist and BBC News of wrongdoing as "woefully ineffective".

Former director general Lord Hall, who led the original probe when head of BBC News, resigned as National Gallery

chairman on Saturday. Royal biographer Andrew Morton said Diana's interview with Bashir was not a case of self-indulgence, but "self-preservation" as she had been put into a state of fear and trepidation.

Asked if Bashir could have landed the interview without lying, Mr Morton said: "He wouldn't have got it – he scared her half to death."

He told Sky's Trevor Phillips On Sunday programme: "He had her thinking he had contacts inside MI5, he was very plausible, he arranged meetings in underground car parks, scary places at the best of times, but when you think your life is in danger it was very potent."

Mr Morton added that Diana had been keen to speak her mind and would have granted an interview to another journalist.

Bashir left the BBC in 1999. He returned as religious affairs correspondent in 2016 and was later promoted to religion editor before resigning earlier this month

### F1 boss who sued over 'Nazi orgy' claims, dies of cancer, 81

FORMER Formula One chief Max Mosley, son of fascist leader Sir Oswald Mosley, has died aged 81 after a long battle with cancer.

A one-time barrister and amateur racing driver, Mr Mosley was president of motorsport's ruling body FIA for 16 years and one of its most influential figures.

He later campaigned for tighter press controls after the nowdefunct News of the World reported on his sadomasochistic orgy with five prostitutes in 2008.

Mr Mosley's family revealed he died on

Sunday night at his Chelsea home in London. They said: "The family of Max Mosley can confirm that he died after a long battle with cancer. They ask to be allowed to grieve in private."

#### scandal

Mr Mosley is survived by wife Jean – who he married in 1960 and who stood by him through the sex scandal that saw him win a landmark privacy case against Rupert Murdoch's media empire – and his son Patrick.

He was a huge name in sport after helping to build F1 into a global brand with Bernie Ecclestone.

Mr Ecclestone, 90, said that he felt like he had lost a brother.

He said: "It's like losing a family member, he was like a brother to me. We understood each other.

"It meant that one of us could criticise the other if we didn't like a particular idea.

"I'd always kept in touch with him and we spoke often. "I am sorry Max has died but it is also a merciful release. "He had been in a bad way for weeks and I am just glad he didn't suffer for too long.

"Max did a lot of good



#### What was your first impression of LA and has it changed since?



It may sound a little typical but if you really want it you will make it happen in LA as long as you are willing to work hard and do whatever it takes to make whatever your


