Queen gives 'gracious' welcome to Joe and Jill

■ President praises 'generous' monarch as she hosts Bidens at Windsor Castle

US PRESIDENT Joe Biden praised the Queen as "generous and gracious" after visiting her at Windsor Castle this week.

Mr Biden and wife Jill looked delighted as they were shown around the royal residence, and were thrilled to be treated to afternoon tea with the monarch.

The Queen, 95, had rolled out the red carpet for her American visitors.

And she was in a sunny mood to match the sweltering heat as she chatted easily with the President and First Lady.

Wearing dark sun glasses and holding his wife's hand, Mr Biden arrived a few minutes earlier than scheduled. He spent almost 45 minutes, slightly longer than anticipated, having tea with the Queen after inspecting a guard of honour in the castle quadrangle and witnessing a military march past.

He is the 13th US president to meet the Queen while in office.

Mr Biden, 78, said they had spoken about Russian president Vladimir Putin and China's leader Xi Jinping during afternoon tea, which followed a display of pomp and pageantry from the Grenadier Guards in the castle grounds.

He said: "We had a long talk. She was very generous.

I don't think she'd be insulted, but she reminded me of my mother. In terms of the look of her and just the generosity. She was very gracious."

Mr Biden, speaking at Heathrow before flying out of Britain, said he had invited the Queen to the White House after she asked about it.

He added: "She said, 'What's it like in the White House?' I said, 'Well it's magnificent but it's a lot of people.'"

The Queen may have been wondering how it had changed after several previous visits. She first went to Washington DC as Princess Elizabeth in 1951 with Prince Philip and stayed with President Harry S. Truman and his family.

The Bidens joined the monarch at Windsor after attending the G7 summit in Cornwall.

They were driven into the quadrangle in a relatively humble Range Rover – rather than the armoured limousine known as The Beast.

They had already met the Queen on Friday when she attended a reception for G7 leaders at the Eden Project in Cornwall.

The Queen was wearing driven a Stewart Parvin dress in a floral print jacquard in shades of pink, olive and russet, and she teamed it with a hat by Rachel st. Trevor-Morgan and the

diamond Jardine Star brooch. Mrs Biden wore a powder blue skirt suit.

The carefully choreographed welcome echoed the one given to Donald Trump in 2018, when the controversial then-US President travelled to Windsor to meet the monarch. After a guard of honour formed

of The Queen's Company First Battalion Grenadier Guards gave a royal salute, the US national anthem was played beneath blue skies and blistering sun.

The Queen then left Mr Biden to view the guardsmen.

Covid surge delays lockdown easing

■ Delta variant brings worrying spike in numbers; PM postpones lifting all lockdown restrictions to July 19

Britain's latest surge in coronavirus infections gathered pace Thursday with new confirmed cases rising above 10,000 for the first time in nearly four months as a result of the spread of the more contagious delta variant.

Government figures showed another 11,007 cases were reported. That's the highest daily number since Feb. 19, when 12,027 cases were recorded, and cements talk that the country with Europe's highest virus-related death toll is in the midst of a third wave of the pandemic.

The government's chief medical adviser, Professor Chris Whitty, said the height of the current surge is "still uncertain" but that it "will definitely translate into further hospitalizations and, unfortunately, it will undoubtedly translate into further deaths."

Daily cases have risen fairly sharply over the past few weeks after fluctuating around the 2,000 mark earlier. The delta variant, which was first identified in India and is considered by government scientists to be between 40 percent to 80 percent more transmissible than the previous dominant strain, accounts for around 95 percent of all new cases in the U.K.

Most of the new confirmed cases are among younger age groups which have not yet gotten Covid-19 vaccines. The U.K.'s widely praised rollout of vaccines is being extended to all adults over the age of 18 starting Friday, Health Secretary Matt Hancock confirmed.

The spread of the variant upended government plans to lift all remaining restrictions on social contact in England starting next week. On Monday, Prime Minister Boris Johnson delayed the move until July 19, saying now was the "time to ease off the accelerator" so more people could get vaccinated and prevent thousands of more deaths.


Johnson laid out his hope that by July 19, two-thirds of the U.K.'s adult population will have been offered two vaccine shots, including everyone over 50.

The government's figures Thursday showed that another 19 people died after testing positive for the virus, the highest daily death toll reported since May 11. It takes the U.K.'s total deaths in the pandemic to 127,945, the most in Europe.

Health Minister Edward Argar said there was a "concerning increase" in cases of the Delta variant and numbers in hospital were "beginning to creep up".

Most severe cases were among unvaccinated people or those who had only one dose, he said, adding that at current rates nearly 10 million second doses could be administered over four weeks to increase protection.

All areas of Scotland are due to move to Level Zero Covid restrictions on 28 June - meaning bigger groups can gather in cafés, pubs and restaurants, although they will still



have to observe social distancing.

gatherings in Northern Ireland are scheduled to be relaxed on 21

June and the current rules in Wales will be reviewed on 25 June.

All change... Britons now use cash for just 17% of payments

MORE than one in every four payments last year were contactless, as cash use fell by 35 per cent, figures show.

Coins and banknotes were used for just 17 per cent of payments, says UK Finance.

But only 11 per cent of over-65s are registered for mobile and contactless payments, compared with more than half of 16 to 34-year-olds.

The Government has already said it will legislate to protect future access to cash to ensure older people and those without contactless bank cards are not penalised.

The trade association said 13.7 million people used cash only once a month or not at all last year, nearly doubling

from 7.4 million in 2019. Trends With the contactless transaction limit increased from £30 to £45 in April last year, there were 15.8 billion

debit card payments.

David Postings, chief executive of UK Finance, said: "The pandemic resulted in some marked changes in payments behaviour. While it's too early to say whether they are permanent changes, we did see an acceleration

in some existing trends. The banking and finance industry is committed to helping customers make payments in a variety of different ways."

With fewer chances to spend in the lockdowns and large parts of the economy shut, the total number of payments fell for the first time in six years to 35.6 billion – down 11 per cent – with cash accounting for 6.1 billion.

the guard of honour, Major James Taylor, and Major General Christopher Ghika, to inspect the troops, before returning to the dais to watch the military march-past with the Queen and the First Lady Major General Ghika, who commands the Household Division, was the top UK commander in the US-led international anti-Isis coalition until two years ago.

After the visit, the Bidens were seen hugging after a job well done on their first trip to the UK.

Mr Biden is the first overseas head of state welcomed by the Queen since the death of the Duke of Edinburgh in April.

His remark that the Queen reminded him of his late mother is another nod to a figure he has frequently cited since taking office. His mother Jean, who died aged 92 in 2010, has had a profound influence on his life and politics.

Begum: I was a dumb kid, let me come home

■ Former jihadi bride, now wearing skinny jeans and a baseball cap at a Syrian camp, says she needs no rehabilitation

JIHADI bride Shamima Begum this week insisted: "I don't think I was a terrorist, I think I was just a dumb kid."

Begum, 21, with painted finger nails, a Nike cap and skinny jeans has begged to come home.

And she said she does not need to be rehabilitated.

The schoolgirl from Bethnal Green, east London, claimed she was brainwashed by extremists when she left the UK aged 15 and travelled to Syria in 2015.

Asked what she would say to those back in Britain, Begum replied: "Can I come home please, pretty please?"

In February, Begum lost a Supreme Court appeal to return to the UK.

It came after former Home Secretary Sajid Javid stripped her of British citizenship in 2019 on national security grounds. Mr Javid made the ruling shortly after she was found nine months pregnant in the al-Hawl refugee camp in Syria. Her newborn child later died there.

Begum's two other children, with the Dutch jihadist she married while living under the rule of terror group IS, also died young of disease or malnutrition.

But in an interview for a new documentary from the al-Roj prison camp in Syria, where she is now being held, Begum said: "I don't think I was a terrorist. I think I was just a dumb kid who made one mistake

"I personally don't think that I need to be rehabilitated, but I would want to help other people be rehabilitated.

I would love to help." She was speaking to filmmaker Andrew Drury for his TV show, Danger Zone.

Explaining why she now wears trendy Western clothes, Begum told him: "I wear these clothes, and I don't wear a hijab, because it makes me happy. And anything in this camp that makes me happy is like a lifesaver."

On Friday a London court was told that there is "overwhelming evidence" that Begum was a victim of trafficking when she left the UK.

Ms Begum's lawyers told the Special Immigration Appeals Commission (SIAC) at a hearing on Friday that the Home Office had a legal duty to investigate whether Ms Begum was a victim of trafficking when her citizenship was revoked.

said "the counter-terrorism unit had suspicions of coercion and control" at the time Ms Begum left the UK, which she argued "gives rise to the need to investigate the issue of trafficking".

In written submissions, Ms Begum's legal team said the Home Office failed to consider whether she was "a child trafficked to, and remaining in, Syria for the purposes of sexual exploitation and forced marriage".

Ms Begum also wants to challenge the removal of her British citizenship on the grounds that it made her "de facto stateless" and that the decision was procedurally unfair.

'HELPING LONDON'S ECONOMY' Scottish fans in Leicester Square

Swarms of England and Scotland fans descended on parts of central London in the pouring rain on Friday ahead of the teams' clash at Wembley in Euro

Hundreds of supporters wearing their country's shirts, flags and kilts were chanting, singing and playing bagpipes at Leicester Square, Kings Cross and Hyde Park.

The much-anticipated match, the 115th in international football's oldest rivalry, is the first time the two sides have met in a major tournament since Euro 96, when Paul Gascoigne's famous goal

sealed a 2-0 win.

Scotland fan Rab Foulis said supporters were "bringing a party atmosphere" to the city and "helping London's economy".

Speaking near Kings Cross, Mr Foulis said he had been waiting 23 years since wanting to go to the economy."

Speaking in the pouring rain, Charlotte Gammie, 27, from Dundee said: "I think we'd literally come out in the rain, snow, sleet, anything.

"I think it actually proves how much we obviously all want this and hopefully we go out and win it today."

Another fan Mark Graham said: "It's a pity but it looks like Scotland will make their own fan zones. "We've booked a pub for last night and a pub for tonight so we're well prepared."

Scotland supporter Gordon Mackey, from Dunblane, said: "I'm a big fan and it's been a long time actually, I think the last time I enjoyed this was 1990 and watched Scotland lose to Costa Rica and there was just as much excitement."

The match itself proved less exciting, finishing in a goalless draw.

Met boss faces calls to quit over axe murder cover-up

BRITAIN'S top police officer is facing calls to resign after her force was branded "institutionally corrupt" over the unsolved 1987 axe murder of private eye Daniel Morgan.

Metropolitan Police commissioner Cressida Dick accused of "lack of candour" and obstructing an independent panel.

Panel chairwoman Baroness Nuala O'Loan said a catalogue of failings in the case had been denied or covered up and the force's prime objective had been to "protect itself".

Her blistering verdict came as Home Secretary Priti Patel called the Morgan case "one of the most devastating" in the Met's history.

She has demanded a response from Dame Cressida to the panel's recommendations and wider issues in its 1,200page report.

Mr Morgan's brother said Dame Alastair Cressida, should "absolutely" considering her position, but Prime Minister Boris Johnson was quick to say she retained his confidence.

crooked officers

Father-of-two Morgan, 37, was killed in the car park of the Golden Lion pub in Sydenham, south London, in 1987.

Despite five police costing at inquiries least £30million and an inquest, no one was brought to justice.

Scotland Yard has admitted crooked officers hampered the initial murder inquiry.

Dame Cressida apologised to Mr Morgan's family, but

insisted the panel was given full co-operation.

Ms Patel said the report found the Met was guilty of a "litany" of mistakes "irreparably damaged" the chances of a successful prosecution.

She said: "This is one of the most devastating episodes in the history of the Metropolitan Police."

Mr Morgan's family said: "We welcome the recognition that we and the public at large - have been failed over the decades by a culture of corruption and coverup in the Metropolitan Police."

The panel said: "The family of Daniel Morgan suffered grievously as a consequence of the failure to bring his killers to justice, the unwarranted assurances which they were given, misinformation which was put into the public domain, and the denial of failings in investigation.

"Concealing denying failings, for the sake of the organisation's public image...constitutes a form of institutional corruption."

A£50,000 reward is still on offer for information leading to the successful prosecution of those Morgan's murder.



■ Deaf border collie learns sign language so she can keep herding sheep

WHEN sheepdog Peggy went deaf it looked like her shepherding days were over - until she learned sign language.

The border was signed over to the RSPCA when her owners could no longer communicate with her.

But RSPCA animal welfare manager Chloe Shorten fell in love with the farm dog. And she vowed to help nineyear-old Peggy get back to the job she loved.

Sheepdogs traditionally trained to obey whistles or voice commands, with short, simple instructions such as Away, Come-by, and

But now, Peggy is back in the field after learning to read hand signals and body language from Chloe and her husband Jason, 34 – who is a shepherd. Chloe, 28, who works at the charity's Mid Norfolk and North Suffolk branch, said:

"We completely fell in love with Peggy.

"We knew she wanted to be working so we started the long process of teaching her how to herd and work with a shepherd without relying on voice commands. We started by teaching her to look at us for hand signals.

"We used repetitive and positive reinforcement and instead of pairing a

verbal command with an action, we'd use a physical hand gesture.

"Now she reads our hand signals and body language as a way of telling what we're asking for."

A thumbs up means "good girl", a flat, outstretched palm means stop and patting their knees brings her to them.

Chloe said: "It can be

difficult with a deaf dog, because you have to wave at them to get their attention, and sometimes she doesn't realise straight away."

Now Peggy helps with the couple's other two working sheepdogs, Sid and Nora.

Chloe added: "It's amazing to see her with this new lease of life and enjoying her life with us."

After 12 years of marriage the couple, (pictured, right) who have two daughters Savannah, nine, and Isla, seven, – announced in February that they were separating.

A statement said: "Whilst this is a sad day for Peter and Autumn, they continue to put the wellbeing and upbringing of their wonderful daughters first and foremost.

"Both Peter and Autumn are pleased to have resolved matters amicably with the children firmly at the forefront of those thoughts."

Peter, 43, is the son of Princess Anne. Said to be the Queen's favourite grandchild, he is the first to divorce.

The couple met at the 2003 Canadian Grand Prix, where at the time Autumn was working for the Canadian Security Intelligence Service.



PM hails Aussie trade deal

BRITAIN celebrated a "fantastic" Brexit boost after securing a trade deal with Australia this week.

Boris Johnson sealed an agreement in principle for zero-tariff, zeroquota commerce with Australian premier Scott Morrison in talks at Downing Street. It will be the first trade deal negotiated from scratch since the UK regained control of trade policy by leaving the EU.

And the deal, set to boost UK firms by £1billion a year, will unleash the full power of global Britain, the PM insisted.

MrJohnsonsaid:"Today

marks a new dawn in the UK's relationship with Australia, underpinned by our shared history and common values.

"Our new freetrade agreement opens fantastic opportunities for British businesses and consumers, as well as young people wanting the chance to work and live on the other side of the world. This is global Britain at its best—looking outwards and striking deals that deepen our alliances and help ensure every part of the country builds back better from the pandemic.

"By seizing the vast opportunities of Brexit to drive our economic recovery with a tariff-free deal that will boost industries that employ 3.5

million across the country.

"Today's deal will create incredible opportunities for British businesses and consumers.

"This is just the start of the world of opportunities we are grasping as an independent trading nation.

"We are already making excellent progress towards striking more tailored trade deals with like-minded allies across the globe.

"And today's deal paves the way for us to join the Trans-Pacific Partnership, a £9trillion free trade area of some of the world's largest and most dynamic economies.

"It will be good news for British car manufacturers, for British services, for British financial services.

"And it will be good news for the agricultural sector on both sides."




Many of us were disappointed to hear that the UK is not opening up quite just yet. Whilst it is frustrating I do respect their current position, as at the time of writing



Stone was removed with the first ball of day four to leave New Zealand only 38 to secure a 1-0 series victory - their first series win in England since 1999.

New Zealand, the topranked Test side in the world, face India in the inaugural World Test Championship final at the Ageas Bowl from Friday,

but had made six changes from the drawn first Test at Lord's.

England were without all-rounder Ben Stokes and fast bowler Jofra Archer because of injury, while wicketkeeper Jos Buttler and all-rounder Chris Woakes were rested.

■ Well drilled Scots impress to leave England frustrated at Wembley

England and Scotland played out a goalless draw at Wembley to leave both countries with their hopes of reaching Euro 2020's knockout stage very much alive.

The first meeting between the men's teams in a major tournament since Euro 96 was played out in a typically raucous atmosphere despite only 22,500 fans in attendance - and both sides had big opportunities to win.

But England struggled while Scotland shone as they drew 0-0 for the first time ever at Wembley in the 115th meeting between the two nations.

The England captain Harry Kane again failed to have an impact and was subbed with 16 minutes to go, while Steve Clarke's Scotland impressed, particularly in midfield where 20-year-old Billy Gilmour held his own on his first international start.

Most of the honours must go to the visitors, who bounced back from their opening defeat to the Czech Republic at Hampden Park with real resilience and character to fully deserve this important point. It was The Tartan Army who were elated at the final whistle while England's players heard the sound of loud jeering from their supporters.

England, who were sluggish and disappointing, should have taken the lead early on when John Stones headed Mason Mount's corner against the woodwork.

As Scotland settled and improved, England were grateful to Jordan Pickford's superb save from Stephen O'Donnell and a goal-line clearance from Reece James to divert Lyndon Dykes' goal-bound shot after the break.

Gareth Southgate's side, with a win over Croatia in the bag, now have a chance to overtake the Czech Republic and win Group D in their final game while Scotland will chase victory against Croatia at Hampden Park.

Scotland's players punched the air with delight when the final whistle sounded and they had secured a point that keeps them in the mix going into their final game.

Manager Steve Clarke had his team well-drilled and, once they had survived an uncertain start, they gave as good as they got. The heroes' welcome they received when they went to thank the rain-sodden Tartan Army at the final whistle was thoroughly deserved.

England had plenty of possession in the second half but this must never be portrayed as a Scottish rearguard action. It was anything but.

bright start

Yes, they were forced back for periods but were always positive, on the lookout to attack and it needed that crucial intervention from James to deny Dykes a winner.

And in 20-year-old Billy Gilmour, on his first Scotland start, they had the game's outstanding performer, the Chelsea's midfielder showing his class on the ball and a real fighting spirit in the physical challenges. It was an outstanding, mature display

Arsenal's Kieran Tierney also showed how much he was missed in that Czech defeat with a powerhouse performance that must give Scotland real hope against Croatia.

Clarke got it right tactically but England counterpart Southgate has questions to ponder. There is no doubt who will be the happier manager. England were efficient rather than spectacular in victory against Croatia on Sunday but it was very much a case of job done to set the platform to face the old enemy in a repeat of that Euro 96 encounter.

Instead, England faded badly after a bright start although Raheem Sterling was furious when Spanish referee Antonio Mateu Lahoz ignored his pleas for a second-half penalty when he tangled with Andrew Robertson.

England did not deserve victory but they are still in a very healthy position going into their final game.

Kane sluggish

That does not mean Southgate can be satisfied after what was a very disappointing night - especially as he faces a dilemma he could not have been contemplating before this tournament started.

Captain Harry Kane was poor before his substitution against Croatia on Sunday and was equally anonymous here. He looked sluggish, off the pace and short on threat. It was no surprise
