Charles: I DID support Harry after Megxit

■ Prince of Wales spells out truth on cash gifts to Harry

PRINCE HARRY'S claim that his father provided no financial support following his decision to quit royal duties was cast into doubt this week – by none other than Prince Charles.

In his explosive recent interview with Oprah Winfrey, Harry claimed that his family "cut me off financially."

But Clarence House accounts, published on Wednesday, show that the Prince of Wales provided the Duke and Duchess of Sussex with a "substantial sum".

Prince Harry, 36, the sixth in line to the throne, and his American wife Meghan, 39, were supported by his father in the financial year to March 2021.

The accounts lump together funding for both of Charles's sons William and Harry and their families, with other expenditure.

They show a £1.15million drop from £5.6million to £4.5million compared with the previous year.

But confirmation that Charles did continue to support the Sussexes may cast fresh doubt on the reliability of the couple's testimony, following a series of controversial claims that have not always stood up to scrutiny.

The exact amount offered by Charles to help Harry and Meghan is not detailed but some reports put it at as much as £3million.

A senior spokesman for Clarence House – London residence for the Prince of Wales and the Duchess of Cornwall – said: "As we'll all remember in January 2020 when the Duke and Duchess announced that they were going to move away from the working Royal Family, the Duke said that they would work towards becoming financially independent.

"The Prince of Wales allocated a substantial sum to support them with this transition. That funding ceased in the summer of last year. The couple are now financially independent."

His remarks are in sharp contrast to ones Harry made when questioned by US chat show host Oprah and shown in March this year.

The prince claimed he and Meghan had to move from Canada to the Los Angeles home of billionaire film producer Tyler Perry in March 2020 as Charles had ended their funding and they struggled to afford their personal security costs.

Harry told Oprah: "My family literally cut me off financially.

"I've got what my mum left me and without that, we would not have been able to do this. I think she saw it coming. I certainly felt her presence throughout this whole process."

Questioned about the apparent discrepancy in the remarks the Clarence House spokesman said: "I wouldn't acknowledge

that they are dramatically different.

"All I can tell you are the facts." He described the couple's stepping away from senior royal duties as "a matter of enormous sadness to the family.

"But the prince [Charles]wanted to help make this work, (and) allocated a substantial sum to the Duke and Duchess of Sussex, to help them with that transition."

The spokesman added: "I betray no confidence

when I say they've been very successful in becoming financially independent."

His comments came as it emerged that Harry and Meghan have signed a license to stay at Frogmore Cottage, their base on the royal estate at Windsor, only until March next year.

They have previously insisted that the five-bedroom house – currently occupied by Harry's cousin Princess Eugenie, her husband

Jack Brooksbank and their four-month-old son August – will remain their long-term home for UK visits.

There has been speculation that the Sussexes might look elsewhere for a property.

The accounts also showed that when Harry and Meghan agreed to repay the taxpayer the £2.4million it cost to refurbish Frogmore Cottage, that sum also represented several tranches of rent.

2020 deaths higher than births for only second time in more than a century

Last year more deaths than births were registered in the UK for the first time since 1976.

In total, just over 683,000 births were registered compared with nearly 690,000 deaths.

This was only the second time deaths have outnumbered births since the late 1890s.

The coronavirus epidemic led to a sharp rise in deaths last year but birth rates have also been falling for the last decade.

The number of deaths in the UK has been rising in recent years, but part of that increase is due to the UK population increasing and getting older.

birth rates down

Last year's 13% rise in that figure is attributed by statisticians to the coronavirus pandemic.

It was the largest jump in a single year seen since World War Two, bringing death rates, the chances of any single person dying, back to levels seen in 2008.

Figures published on Monday by the Office for National Statistics suggest the first lockdown had not led to a baby boom.

Birth rates in December and January, nine months after lockdown started, were sharply down on the same months one year before.

But the pandemic has affected register offices, leading to problems with birth registrations, so the ONS "urges caution" when reading meaning into these figures.

Part of the reason that deaths have outstripped births is that births have been falling steadily in every nation of the UK since at least 2015.

The Office for National Statistics says this is because we are having children later in life and fewer of them.

This trend has been happening for decades but it wasn't apparent in the noughties as another trend was masking it.

Back then, younger migrants tended to have more children than UK-born mothers and so they propped up British birth rates.

But this is no longer the case and birth rates have been falling since 2011, feeding through into a

lower total number of births by the middle of the decade.

The last time deaths outnumbered births was in 1976.

In that year, there were just under 681,000 deaths and about 5,000 fewer births.

sharp change

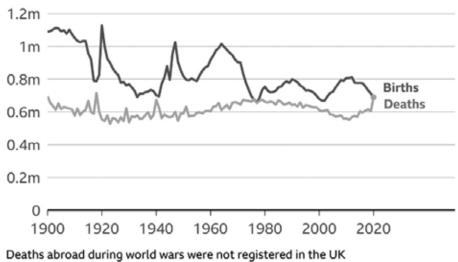
The main driver was falling birth rates: the late 1960s and 1970s saw sharp falls in the number of live births in the UK.

There has been some relationship between the state of the economy and the number of births and the low levels in the 70s coincided with a faltering economy.

But the biggest reason for the sharp change was the widespread availability of contraception and the legalisation of abortion in the UK in the late 60s.

It is likely that more Britons died than were born during some years of the World Wars, with the smallest gap between the two in 1940, the year of the Blitz.

But deaths of military personnel who died abroad are not included in the UK death registration figures. More deaths than births rarely happens

'July 19 is looking good'

The Prime Minister said the Government's scientific data showed vaccines are working against all coronavirus variants to raise hopes that the so-called "Freedom Day" will go ahead on July 19.

But he also cast fresh doubt over summer holidays abroad by warning that travel will remain "difficult" this year.

Mr Johnson gave his latest assessment of the national effort against the pandemic during a visit to the MHRA laboratory in South Mimms, Herts, on Monday.

He said: "You can never exclude that there will be some new disease, some new horror that we simply haven't budgeted for, or accounted for.

"But looking at where we are, looking at the efficacy of the vaccines against all variants that we can currently see – so Alpha, Delta, the lot of them, Kappa – I think it's looking good for July 19 to be that terminus point.

Priority

"I think what the scientists are saying is that things like flu will come back this winter. We may have a rough winter

for all sorts of reasons, and obviously there are big pressures on the NHS.

"All the more reason to reduce the number of Covid cases now. Give the NHS the breathing space it needs to get on with dealing with all those other pressures – and we are certainly going to be putting in the investment to make sure that they can."

Despite his optimistic remarks about easing restrictions next month, the PM played down suggestions that restrictions on foreign travel could be lifted as more people receive the vaccine.

He said: "I want to stress that this is going to be – whatever happens – a difficult year for travel. "There will be hassle, there will be delays, I am afraid, because the priority has got to be to keep the country safe and stop the virus coming back in."

Health Secretary Matt Hancock said a new system using daily Covid tests instead of isolation was being trialled by 40,000 people and could soon be rolled out once clinicians have studied the data.

Under the plan to revise quarantine restrictions, the 10-day isolation period could be axed in favour of daily lateral flow tests [fast home kits].

Mr Hancock said the approach is being piloted "to check that it will be effective".

He added: "We're not ready to be able to take that step yet. But it's something that I want to see and we will introduce, subject to clinical advice, as soon as it's reasonable to do so."

Asked whether the remaining restrictions are likely to be lifted before England's freedom day, Mr Hancock said experts will examine the figures shortly.

Careful

He said: "We are looking at the data. And we've said that we'll take a specific look two weeks into the four-week delay that we had to put in place to get more people vaccinated, so we'll do that. But I have every confidence that the more people get vaccinated, the easier it is and the safer it is to lift restrictions.

"We had to have the delay in order to get more people vaccinated, especially those second vaccines to protect people.

"We're being careful, we're being cautious. But I have a high degree of confidence that this vaccine is going to get us out of this, and the more people who come forward, the easier that will be."

Noting the real value of Turing

THE new £50 banknote featuring codebreaker Alan Turing has entered circulation in Britain.

Turing worked at Bletchley Park, Bucks, during the Second World War and played a pivotal role in breaking the Nazi's enigma code, a breakthrough which some historians claim shortened the war by several years and saved millions of lives.

Andrew Bailey, Bank of England Governor, said of Turing: "He went on to pioneer work on early computers, as well as making some groundbreaking discoveries in the field of developmental biology.

"He was also gay and was treated appallingly as a result."

Despite these accomplishments, he was never fully recognized in his Britain during his lifetime because much of his work was covered by the Official Secrets Act.

Turing was prosecuted in 1952 for homosexual acts; the Labouchere Amendment of 1885 had mandated that "gross indecency" was a criminal offence in the UK. He accepted chemical treatment castration as an alternative to prison. Turing died in 1954, 16 days before his 42nd birthday, from cyanide poisoning. An inquest determined his death as a suicide, but it has been noted that the known evidence is also consistent with accidental poisoning.

In 2009, following an internet campaign, British Prime Minister Gordon Brown made an official public apology on behalf of the British government.

Young people answer the call...one million jabs booked in two days

MORE than one million vaccinations were booked in just two days this week after the Covid-19 inoculations were opened up to the 18-20 age group in England.

On average over 21,000 jabs were reserved each hour – six per second – on Friday and Saturday, and thousands more queued at walk-in centres at the weekend.

At Tottenham Hotspur Stadium in north London, hundreds of young people joined the queue as jabs were dished out from 10am to 6pm on Monday.

Tottenham stars of the past including Ossie Ardiles and Ledley King joined in to help. Stadiums in Bristol and Merseyside were also among those brought into action after a social media blitz.

Health chiefs thanked those who had come forward to do their bit.

'playing their part'

Sir Simon Stevens, NHS chief executive, told reporters: "We need everyone's help to protect the country and we are so grateful to the many young people who have come forward so far, to either get their jab or to book in. By playing their part and getting protected, they are helping our country to save lives.

"If you have not been vaccinated yet please do take up the offer and if you know someone who has not yet done so please urge them to book a jab.

"The more of us who are vaccinated the safer we all are."

Health Secretary Matt Hancock tweeted: "It's great to see young people stepping up and playing their part in the national effort."

Latest data showed more than 42.9 million people had received a first dose in the UK, accounting for 81.6 per cent of adults. Some 31.3 million had received a second dose – almost three in five adults.

The vaccine booking figures for Friday and Saturday do not include appointments made through GP-led vaccination services or those jabbed at walk-in centres, meaning the true figure will be even higher.

Sir Simon added that the programme "continues in full swing as the finishing line comes into sight".

He said: "It is fantastic to see so many young people coming forward to play their part, protecting themselves, their friends and their family – nearly nine million people in their 20s and 30s have now had their first dose.

"NHS staff are pulling out all the stops to get jabs in arms with pop-up sites in shopping centres and mass events at football stadiums all adding to the huge network of services that have now delivered more than 62 million lifesaving jabs."

In a bid to reach as many young people as possible, the Government has joined forces with social media giants offering extra features such as stickers and photo filters in support of the vaccine programme.

Mr Hancock said: "I am delighted that Snapchat, Reddit, TikTok and YouTube are coming together to support the most successful vaccine effort in NHS history.

"The vaccine programme has put us on the road to recovery and I urge everyone to come forward for the offer, roll up their sleeves and join the millions that already have the fullest possible protection from two doses"

a series of Q&A sessions with medical experts on the Prime Minister's account to build confidence and tackle misinformation.

Reddit is hosting live "ask me anything" events with experts on its coronavirus forum. TikTok is offering "I've had my Covid vaccine" stickers for users to share and is supporting scientists and doctors to share information through videos.

And in collaboration with the NHS, YouTube has rolled out a campaign

with the tagline "Let's Not Go Back" to remind its core 18-34 year old audience of the importance of getting the jab.

Digital Secretary Oliver Dowden said: "Our vaccine rollout has been a great success and is now available to all adults.

"We have worked closely with social media platforms throughout the pandemic to promote life-saving vaccine information, and this new initiative with popular platforms will help drive take-up even higher.

"We are also tackling

misinformation online through our Online Safety Bill to make sure people are not bombarded by harmful content."

Vaccines Minister Nadhim Zahawi said: "The vaccine is our way out of this pandemic and we have made incredible progress so far with more than four in five adults receiving at least one dose and all adults being

"I encourage everyone to get the jab. It could stop you becoming seriously ill and protect your loved ones."

Cop convicted in death of former footballer

■ Court told Dalian Atkinson was tasered for 33 seconds and kicked twice in the head shortly before his death

A police officer has been found guilty of the manslaughter of ex-footballer Dalian Atkinson.

The former Aston Villa striker died after a standoff with West Mercia police officers outside his father's home in Telford, Shropshire in 2016.

PC Benjamin Monk, 43, was cleared at Birmingham Crown Court of an alternative charge of murder.

Mr Atkinson's family said justice had been done and hoped he would be remembered for his life, not his death.

Monk was granted bail until his sentencing hearing at the same court on Monday, after being told a custodial sentence in his case was inevitable.

His trial had heard he tasered Mr Atkinson for

33 seconds and kicked him twice in the head.

He denied any wrongdoing and said he believed there was a danger to life for him and his colleague.

Mr Atkinson began his career at Ipswich Town before moving to Sheffield Wednesday, Real Sociedad and Aston Villa.

'much missed'

Following a six-weektrial, jurors took 18 hours and 48 minutes to reach unanimous verdicts on Monk, who has 14 years' service.

In a statement, Mr Atkinson's family said he was "much missed" by his family and friends and the footballing communities of the clubs he played for.

"The past five years

have been an ordeal for Dalian's family," they said.

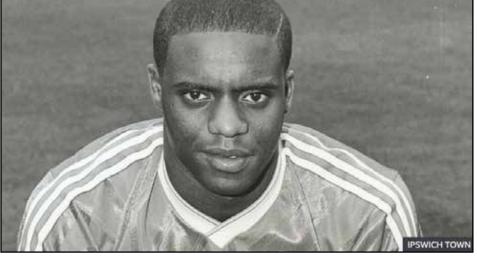
"We are hugely relieved that the whole country now knows the truth about how Dalian died.

"While it has been hard for us not to be able to talk about the details of Dalian's death, it has been even harder to sit through this trial and to hear PC Monk try to justify the force he used."

They said his footballing talent "led him to achieve great things in his life".

"Our sincere hope is that now that the truth about his death is known, and justice has been done, we can start to remember him not for the manner in which he died, but for the way in which he lived," the statement added.

Following the verdict,

Mercia Police Assistant Chief Constable Rachel Jones, said: "Words alone cannot express the deep regret and shock I feel that I must stand here today because a West Mercia officer has been found to be criminally responsible for Dalian's death.

"I am sincerely sorry and extend my apologies and deep condolences to Dalian's family and friends."

Mr Atkinson's death, she said, has "sent shock

and sadness" through the police service.

Police officers come to work to serve their communities and keep the public safe," ACC Jones added.

"Our uniform should represent justice, public safety and the observance of the law.

"Those who wear it, as individuals, are also subject to those laws and should be held to the very highest standards of conduct and behaviour."

She said the force does

not "underestimate the impact of the case" and will "work hard to build and maintain the trust and confidence" of the communities it serves.

A "fast-track misconduct process" will be carried out following Monk's conviction, ACC Jones said.

The Independent Office for Police Conduct, she said, had made a number of recommendations following Mr Atkinson's death, which have have been implemented.

Next time we bomb you, say Russians after Black Sea incident

■ HMS Defender shadowed by fighter jets following incursion into disputed waters off Crimea

LONDON: Russia warned Britain on Thursday that it would bomb British naval vessels in the Black Sea if there were any further 'provocative actions' by the British navy off the coast of Russia-annexed Crimea.

Russia summoned the British ambassador in Moscow for a formal diplomatic scolding after HMS Defender breached what the Kremlin says are its territorial waters but which Britain and most of the world say belong to Ukraine.

Britain said Russia was giving an inaccurate account of the incident. No warning shots had been fired and no bombs had been dropped in the path of the Royal Navy

destroyer, it said.

In Moscow, Russia summoned Ambassador Deborah Bronnert for a reprimand over what it said were Britain's "dangerous" action in the Black Sea - while foreign ministry spokeswoman Maria Zakharova accused London of "barefaced lies"

"We can appeal to common sense, demand respect for international law, and if that doesn't work, we can bomb," Deputy Foreign Minister Sergei Ryabkov told Russian news agencies.

Ryabkov, referring to Moscow's version of events in which a Russian aircraft bombed the path of the British destroyer, said that in future bombs would be sent "not only in its path, but also on target."

The Black Sea, which Russia uses to project its power in the Mediterranean, has for centuries flashpoint been a between Russia and its competitors such as Turkey, France, Britain and the United States. Russia seized

annexed the Crimea peninsula from Ukraine in 2014 and considers areas around its coast to be Russian waters. Western countries deem the Crimea to be part of Ukraine and reject Russia's claim to the seas around it.

Prime Minister Boris Johnson said the British warship, which was

travelling from the Ukrainian port of Odessa to the Georgian port of Batumi, was acting in accordance with the law and had been in international waters.

"These are Ukrainian waters and it was entirely right to use them to go from A to B," Johnson said.

British Defence

Minister Ben Wallace accused Russian pilots of conducting unsafe aircraft manoeuvres 500 feet (152 m) above the warship.

"The Royal Navy will always uphold international law and will not accept unlawful interference with innocent passage," Wallace said.

Under international law of the sea, innocent passage permits a vessel to pass through another state's territorial waters so long as this does not affect its security.

Britain disputed the Russian version of events, with Foreign Secretary Dominic Raab calling it "predictably inaccurate".

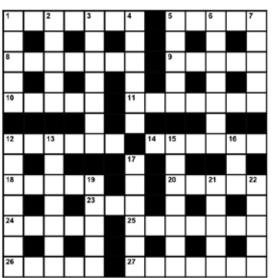

between the Germans and the English.

"If we have to go to a penalty shootout I think Germany is the favourite because then you start to think about what's happened in the last 30, 40 years, Euro 96 and other penalty shootouts.

"This is a lot of pressure for the English players - they read the newspapers and they know the stories about penalties. England have the chance to win the game in 90

minutes or 120 minutes but when you go to a penalty shootout I think Germany is the favourite."

As well as the two penalty shootout defeats, England also lost the last time they played Germany in the knockout stages of a major tournament, a 4-1 last-16 defeat at the 2010 World Cup.

Matthaus, though, denies Germany have a mental grip over the Three Lions.

"Come on, you don't have to be so negative and pessimistic. You have to be optimistic for the future," he added. "When you see the England team, they were in the semi-finals of the World Cup three years ago, they have fantastic players who play in the Premier League and the best clubs all around the world. They have won titles with their club teams. They have to be full of confidence and this is what they have to show.

"I respect this team very much, I see these players all year and what they are doing for their clubs. I think they can perform - like the German team - better than they have in the first three games."

Scots bow to magic Modric

STEVE CLARKE'S Tartan Army will have to think again.

The dream of progressing out of the group stages of a tournament for the first time in 67 years was ended by the genius of Luka Modric on Tuesday.

With the outside of his right boot, he brilliantly caressed a 25-yard curler into the top corner of the net to give Zlatko Dalic's side the lead after an hour and extinguish any real hope of a Scotland victory.

For now, being at their first finals for 23 years will have to be the first stepping stone of progress for a young and improving squad.

At least Scotland broke their Euro goal duck. Callum McGregor's first-half strike did the trick. But after a Group D campaign that was lethargic, Modric stepped forward to rekindle the swagger that took the Croats to the World Cup final three years ago.

Patriotism, revved-up players and a smattering of star men from the Premier League could only take the Scots so far. But it was fun while it lasted.

Appropriately it was the anniversary of the last time Scotland were

knocked out of a major tournament, when they were defeated 3-0 by Morocco in France '98.

Boss Clarke admitted losing creative force Billy Gilmour to Covid was "shock" but Stuart Armstrong slotted in. Croatian boss Dalic moaned about Scotland having an advantage with their home crowd. And the atmosphere generated by 12,000 Tartan Army fans was fierce as befitting a game in which both nations needed to win to get out of the group.

Quick out of the blocks, John McGinn had a curler tipped wide with Che Adams close to

getting a touch. But it turned flat after 17 minutes. Ivan Perisic nodded down a cross from Josep Juranovic into the path of ex-Everton midfielder Nikola Vlasic.

The 23-year-old smashed home left-footed on the half volley from 12 yards, hooking it around Scott McTominay's attempted block.

After disappointing against England, Croatia were clearly up for this one.

Clarke's men did not lie down – and when Juranovic scuffed his clearance to the edge of the box in the 42nd minute McGregor snapped up the loose ball, drilling home from 22 yards.

It set up an all-ornothing second-half tussle but Croatia dominated. Perisic scored a third with a glancing header from Modric's corner after 77 minutes. Wales defender Connor Roberts says "99% of the world" will be supporting Denmark for their Euro 2020 last-16 tie in Amsterdam on Saturday.

Denmark have provided the uplifting story of the tournament, inspired by midfielder Christian Eriksen and his recovery from a cardiac arrest.

Although Wales are marginal underdogs for the game, Swansea full-back Roberts expects neutrals to back the Danes.

"It's going to be really tough but hopefully we can [win]," he said.

"I think 99% of the world are going to be supporting Denmark.

"It's going to be tough but we're a good team, we've got good players



and we've got a little bit of momentum with good performances under our belts.

"They're a really good team and they're going to have a lot of support but, when we cross that white line, we just have to give everything."

Denmark have earned much admiration for their compassion and resilience after their opening fixture against Finland was overshadowed when Eriksen collapsed on the pitch.

Eriksen has since been discharged from hospital and, in his absence but with the Inter Milan player very much in their thoughts, Denmark beat Russia 4-1 in an emotional encounter on Monday to reach the second round as runners-up in Group B.

Wales, meanwhile, qualified for the knockout stages after finishing second in Group A, drawing with Switzerland and beating Turkey before losing to group winners Italy.

"We weren't expected to get out of the group and we managed to do that," said Roberts.

"We're always underestimated I think. You look at our squad, we've got really good players all over the field.

"We were in a group with three really good teams. It was almost a 50-50 group apart from Italy.

"We were underestimated."

Old rivals to meet again

■ England face Germany in Euro 2020 last 16

ENGLAND will face old enemy Germany in a huge Euro 2020 encounter at Wembley on Tuesday.

The Three Lions will take on their great rivals after the Germans finished as runners-up in Group F following their 2-2 draw with Hungary.

The last-16 clash for Gareth Southgate's Group D winners will kick-off at 5pm and will draw tens of millions of viewers at home and in pubs and bars up and down the nation.

ITV this week said its coverage of England's final group game against the Czech Republic and Scotland's loss to Croatia, across ITV and STV, drew a peak audience of 17.7 million as England went through and Scotland bowed out.

And on Monday

the Government said Uefa officials could face fines if they breach coronavirus rules while visiting England for the closing stages of Euro 2020.

Final details are still being worked out to decide what measures will be in place for VIPs such as officials, politicians, sponsors and broadcasters to come into the UK without having to quarantine for the climax of the tournament.

Downing Street said fixed penalty notices could be issued for breaches of the rules.

Uefa, European football's ruling body, is thought to be pushing for 2,500 guests to attend the competition's final on July 11 without having to comply with the usual restrictions

Wembley is hosting both semifinals and the final.

The Prime Minister's spokesman said discussions were still under way with Uefa and Public Health England over the "final detail", but said the Government would not do anything that "compromises the safety of the public".

He said: "Those who are eligible to come will be subject to a strict code of conduct."

The Government said more than 60,000 fans will be allowed to attend both semi-finals and the final at Wembley if they have a negative test or are double-vaccinated.

England have nothing to fear 'unless it goes to penalties'

England have nothing to fear from Germany in their Euro 2020 last-16 tie - unless it goes to penalties, says Germany legend Lothar Matthaus.

Matthaus was captain of West Germany when they beat England on penalties in the 1990 World Cup semi-final, with the Three Lions again losing on spotkicks to Germany in the last four of Euro 96.

England host the three-time European champions again at Wembley on Tuesday.

"England have a chance to win, but not with penalties," Matthaus said.

England seek rapid reunion with Mount and Chilwell following self-isolation

ENGLAND medical staff are seeking permission for Mason Mount and Ben Chilwell to take part in socially-distanced training with their team-mates.

Three Lions manager Gareth Southgate has not given up on the Chelsea pair playing some part in next Tuesday's last-16 tie at Wembley, despite being under orders to selfisolate.

Chilwell and Mount have remained at St George's Park despite coming into contact with Chelsea team-mate Billy Gilmour, who tested positive for coronavirus after Scotland's draw at Wembley last Friday.

Public Health England initially told the FA the pair must train alone away from the rest of the group in accordance with social distancing rules.

But the FA are exploring a precedent set by the Premier League last year when players were permitted to train in small groups under strict supervision.

They would not be allowed any contact or to be involved in drills but, with regular testing, the hope is they can play some part.

Mount is seen as being particularly important for his set pieces and the hope in the England camp is that with some fitness work and involvement, they may be able to be on the bench for next Tuesday's clash.
