■ Nation left delirious as England book final date with Italy



ENGLAND made history Wednesday night with a thrilling extra-time victory over Denmark sending them into the Euros final.

But Gareth Southgate's men, who face Italy in Sunday's final, had to hit back from behind to finally see off the brave Danes.

Mikkel Damsgaard's free-kick had the Three Lions on the rack before an own goal from Simon Kjaer levelled the semi-final before the break.

And then skipper Harry Kane scored the winner in the 105th minute after he slammed in the rebound – from his own saved penalty, earned by Raheem Sterling. Kane's 37th goal for the country sent a 60,000 Wembley crowd wild, along with the millions watching at home, as England reached their first major final in 55 years. - REPORT: BACK PAGE

## George Cross for NHS heroes

#### ■ Queen awards top honor for courage and compassion during Covid pandemic

THE Queen has awarded the George Cross to the whole of the NHS.

The service was honoured on Monday, its 73rd anniversary, with Britain's highest civilian medal. But the news triggered calls for new Health Secretary Sajid Javid to reward the UK's Covid heroes with a fair pay rise of "at least five per cent".

In a handwritten tribute, the monarch praised NHS employees for their pandemic response.

#### 'highest standards'

The Queen wrote: "It is with great pleasure, on behalf of a grateful nation, that I award the George Cross to the National Health Services of the United Kingdom.

"This award recognises all NHS staff, past and present, across all disciplines and all four nations.

"Over more than seven decades, and especially in recent times, you have supported the people of our country with courage, compassion and dedication, demonstrating the highest standards of public service.

"You have our enduring thanks and heartfelt appreciation."

Welcoming the "unprecedented" George Cross, Sir Simon Stevens – chief executive of NHS England – said the demands of the pandemic had brought out "the best" in care staff.

#### 'not enough'

But there were also demands for the Government to follow the joint medal with a wage rise larger than the suggested one per cent.

Sara Gorton, head of health at the Unison union, said: "The NHS truly deserves this prestigious award. The health service and its staff have gone to extraordinary lengths over the last 73 years – no more so than in the past 16 months.

"But this is not enough. Ministers must now honour staff by giving the NHS the resources to tackle the Covid backlog, starting with a decent pay rise for everyone."

Dr John Puntis, cochairman of campaign group Keep Our NHS Public, said: "Recognition of the 'conspicuous courage' shown by NHS staff during the coronavirus pandemic is welcome, but does not detract from the need to show appreciation in a much more concrete way.

"After a decade of austerity the average spending power of NHS workers has fallen by eight per cent.

"The one per cent pay offer is frankly an insult and does not even come close to what is needed. NHS staff deserve so much more."

He added: "Claps don't pay the bills and neither do honours, however well-intentioned."

The George Cross is the highest civilian honour for gallantry.

It was instituted on September 24 1940 by the Queen's father, George VI, and is given for bravery not in the presence of an enemy.

Today's award is only the third time it has gone to an organisation, collective body or to a country rather than to an individual.

In 1942, it was conferred on the island of Malta by George VI, recognising the population's bravery during attacks in the

Second World War.

In 1999 the Queen awarded the George Cross to the Royal Ulster Constabulary for the heroic service of staff and families.

The most recent recipient is Dominic Troulan, a retired British Army officer and former Royal Marine. He was given the medal on June 16 2017 for his courage during a 2013 terrorist

attack at a shopping centre in Nairobi, Kenya. The virus outbreak has

left around 151,000 dead in the UK, including at least 230 frontline health staff. The honour came just a day after the country's first national Thank You Day which included the NHS.

The idea came from a grassroots campaign to hold the biggest-ever party in communities to thank each other and build on the community spirit that so many felt during lockdown.

The campaign won support from hundreds of groups, such as the NHS and the Scouts, and from high-profile individuals including TV presenter Gary Lineker, actors Michael Sheen and Dame Judi Dench and footballer Raheem Sterling.

### Reckless? We're being cautious

■ PM hits back at Labour leader's jibe over 'Freedom Day"

BORIS Johnson stuck to his guns this week over the proposed July 19 freedom day when most Covid rules are due to be scrapped – as he blasted Labour claims of recklessness.

The Prime Minister said his target date should mark the conclusion of the roadmap out of lockdown, insisting the plan was cautious. Mr Johnson is due to announce his final decision on Monday.

Speaking to the Commons Liaison Committee, the PM said he expected to be able to give pubs, restaurants and other hospitality venues the go-ahead to abandon social distancing

measures from that date.

He also hit back at
Labour criticism saying
the Government's
approach was "balanced
and reasonable".

Mr Johnson said: "Now it looks as though – we will take the final decision on July 12 – but it looks as though we will get through to step four, which will allow them [hospitality venues] to open up fully without the need for the one-metre rule."

Mr Johnson said projections of the numbers of hospitalisations and deaths from easing lockdown made by his scientific advisers were at the "middle to the low".

"The crucial thing is to

remember that currently we need to contain the pandemic, but double vaccination is clearly the way forward."

"This country has rolled out the fastest vaccination programme anywhere in Europe.

That is an extraordinary achievement, and that is allowing us to go ahead."

Sir Keir had blamed tborder policy for the spread of the Delta variant and joked it should be renamed the "Johnson variant".

The Labour leader said: "Let us be clear why infection rates are so high. It is because the PM let the Delta, or we can call it the Johnson, variant into the country."

## 24m tune in as England lay the ghost

Almost 24m viewers watched England's historic Euro 2020 victory against Denmark on Wednesday on ITV and ITV+1.

According to overnight figures, the semi-final at Wembley Stadium brought an average audience of 23.86m.

The last five minutes of the match drew a peak audience of 25.71m - almost 5m more than the peak audience recorded during Sunday's match against Ukraine.

The game was the most watched non-news event since Croatia knocked England out of the 2018 World Cup.

That match was watched by 24.3m on 11 June 2018, with a peak of 26.5m tuning into ITV's coverage.

England's 4-0 win over Ukraine on Sunday attracted a peak TV audience of 20.9m, making it the mostwatched live TV event of the year up to that point.

The most watched event of recent years

remains the Prime Minister's May 2020 coronavirus announcement, which was seen by 27.49m viewers across six different channels.

Sunday's Euros final will be shown on both BBC One and ITV and could break the viewing record set by the 32.3m who watched England win the World Cup Final in 1966.

The official audience for Wednesday's match may rise when those who saw it via ITV's

School renames itself after Harry Kane

An EAST Anglia school which has had thousands of views for its England-supporting social media has renamed itself Harry Kane Junior School for the day.

Pupils at what was known as Howard

Junior School, in King's Lynn, Norfolk, donned masks of the England captain to celebrate Wednesday's semifinal win.

Earlier in Euro 2020, a video of the children singing Three Lions was viewed more than 100,000 times.

Head teacher Greg Hill said: "We truly believe football is coming home."

England ended a 55-year wait to reach a major men's final after victory against Denmark, with Kane scoring the winning goal in extra-time.

England's players sent the nation into delirium on Wednesday after beating Denmark by two goals to one after extra time. Striker Harry Kane scored the decisive goal after England were awarded a penalty. Kane's initial strike was blocked by Danish goalkeeper Kasper Schmeichel but he was

able to tuck away the rebound.

Governing body Uefa has since charged England after a laser pointer was directed at Schmeichel as Kane prepared to shoot.

#### UEFA charge England over Schmeichel laser

Uefa has charged England after a laser pointer was directed at Denmark keeper Kasper Schmeichel during Wednesday's Euro 2020 semi-final at Wembley.

Television pictures showed a green light on Schmeichel's face just before Harry Kane took an extra-time penalty.

Schmeichel saved the spot-kick but Kane scored the rebound as England won 2-1 to reach Sunday's final against Italy.

England are also charged with causing a "disturbance" during Denmark's national anthem and setting off fireworks.

"The case will be dealt with by the Uefa Control, Ethics and Disciplinary Body (CEDB) in due course," said a statement from European football's governing body.

There was some booing heard during the Danish national anthem and that has been criticised by Prime Minister Boris Johnson's official spokesman.

"We don't want fans to be booing teams," said the spokesman. "We want fans to be showing support and being respectful.

"Uefa are looking into that, that's a matter for them but it's not something we would want to see."

The Football Association and Uefa officials searched for the source of the laser pointer when they were first made aware of it being used during the first half of extra time.

However, they were unable to find those responsible.

Following the game the Danish FA representatives were asked if they wanted to make an official complaint, but said they did not wish to take the matter any further.

# Euro 2020: How Sweet Caroline became an accidental football anthem

Neil Diamond's Sweet Caroline, a song written more than 50 years ago about the daughter of a former US president, has become the unofficial anthem of the England team at Euro 2020. And it's not the only pop song to have been adopted by England fans.

"I've never seen anything like it!" cried former England footballer Micah Richards on BBC Radio 5 Live on Wednesday.

Over on ITV, another former England player-turned-pundit, Gary Neville, soaked up the joyful atmosphere in Wembley Stadium and declared: "This is one of the best experiences I think I've had in football."

They weren't speaking after England's men qualified for their first major final since 1966.

They were talking before the semifinal, when 60,000 people were belting out Sweet Caroline as the teams prepared to take to the pitch.

A couple of hours later, the song blasted out of the speakers again, and this time the whole squad linked arms and jumped up and down as they joined in the euphoric chorus

Somehow, a song first released by an American soft rock star in 1969 has suddenly been adopted as England's new sporting anthem.

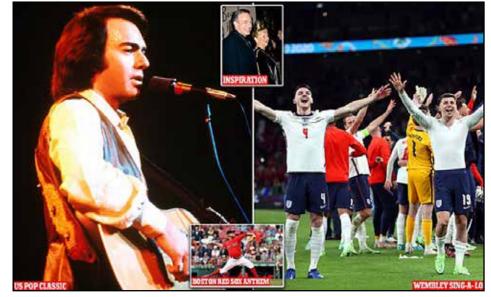
"There are certain songs that you go, 'I completely get why this is being sung en masse,'" says actor Steve Furst, who performs a Neil Diamond tribute act.

"And a song like Sweet Caroline is in no way a surprise because the Diamond appeal is that he doesn't overcomplicate anything. That very simple sing-along chorus just makes it perfect, and everyone knows it."

Paul Carr, professor in popular music analysis at the University of South Wales, who wrote a recent article about what makes a great tournament anthem, adds: "It's a song that's got a lot of nostalgic resonance for many of the people who sing it.

"The big thing is simplicity of the melody, and there's something in the lyrics."

Simple but emotive phrases like "Good times never felt so good" and "Reaching out, touching me, touching you" are coupled with the anticipatory build-

up, leading to a rousing chorus. That all makes it a feelgood communal sing-along - especially after more than a year of lockdowns and social distancing.

has Diamond said he actually wrote the love song about his wife Marcia, but her name didn't fit the tune. However, he had remembered a magazine photo he had seen of Caroline Kennedy, the daughter of John F Kennedy and Jacqueline Kennedy.

His song reached number four in the US chart and number eight in the UK, and became a staple of Diamond's live shows. But the first hint of its potential as a sporting crowd-pleaser came in the late 1990s when it was played during a Boston Red Sox baseball game for an employee who had named her newborn Caroline.

The Red Sox decided it was good luck, and started playing it every week from 2003. In 2013, the singer pledged all future royalties from the tune to a charity supporting victims of the Boston Marathon bombing.

Other teams on both sides of the Atlantic began to adopt it, from the NFL's Carolina Panthers to the Northern Irish football side.

After England's Euro 2020 quarter-final win over Germany, Wembley DJ Tony Parry said he went with his instinct to play Sweet Caroline instead of Fat Les's 1998 World Cup anthem Vindaloo.

He told TalkSport: "I was going to play Vindaloo, but went with my gut. Even the German fans were belting it out in the end. It's a song that all fans can enjoy.

"The match director said in my in-ear, 'The world's been closed for 18 months... let 'em have it'."

## Warring Wags score a win each in libel feud

REBEKAH Vardy and Coleen Rooney could both claim a victory this week in their High Court War of the Wags libel battle.

Coleen, 35 (far right), was dubbed "Wagatha Christie" when she accused Rebekah of leaking false stories about her private life in 2019, following an online "sting" operation.

Rebekah, 39, who is married to Leicester City striker Jamie Vardy, is suing Coleen for libel. On Monday Mrs Justice Steyn denied Rebekah's bid for summary judgment – in which that part of the case would be resolved without a trial. But she also threw out parts of Coleen's defence.

A claim by Mrs Rooney, the wife ex-England captain Wayne, that Mrs Vardy was leaking information to The Sun newspaper about the libel case itself, was dismissed.

But the judge ruled that accusations about



Rebekah's alleged close relationship with the paper and its journalists were relevant to the case. She also refused to dismiss a defence that Rebekah wrote a gossip column called The Secret



Wag – which Mrs Vardy denies.

The libel dispute continues.

## Murder of young **Spaniard highlights** enduring scourge of homophobia

I remember walking the streets of London as a young teen, getting the **Bakerloo line to Queens** Park.

In order to get to my flat, I'd have to walk through a cluster of council flats. On occasion I'd hear rumblings of gangs of youths chatting, laughing and cussing. One night I heard a "Oi! you f\*\*\*ing bender, come

I turned as I thought they were talking to someone else, but then saw four lads start to run towards me. Luckily then, I was fast, I heard them yell: "F\*\*\*ing get him... smash his f\*\*\*ing head in."

My heart was beating so fast, I remember I was carrying a shopping bag, that I had to dump as it was slowing me down. I contemplated running all the way home I, but decided to run into the local pub. I was out of breath and tried to ask the bar man to call the police and if he could hide me. He started asking questions."what's wrong? Who's after you? I didn't have time to talk about the urgency as just as I looked at the front door, one of the lads entered. It was autumn and it had been raining, the lad wearing a Kappa tracksuit with his dark brown hair slightly wet, plastered down on his head. I remember he was six foot tall, acne on his forehead. He smiled showing his crooked teeth. He started to grab at me, pretending to be be my friend, and said "come on, mate, let's go outside" I retorted with a much deeper slightly threatening cockney accent" "Look mate, I don't know who you think I am but you obviously got the wrong bloke."

I looked at the barman and a few of the other punters, who all looked away. I decided to try to ignore the bully and order a pint, as I turned away, suddenly I felt a slight gust of wind and then a cold sting to my cheek as the lad scarpered out of the door and said "Don't ever fucking look at my mate like that again, you f\*\*\*ing gay bastard."

After I paid for my pint, I took it to a corner and kept thinking be strong, don't cry, don't let the bastards win. I went to the toilets and sobbed out of fear thinking what if they are waiting outside the pub for me, I still have a distance to go home, what did I do to deserve

Samuel Luiz. On Saturday, the 24-yearold man was beaten to death in northwestern Spain. Luiz's friends said he was targeted for being gay and that the attackers shouted a homophobic slur. The

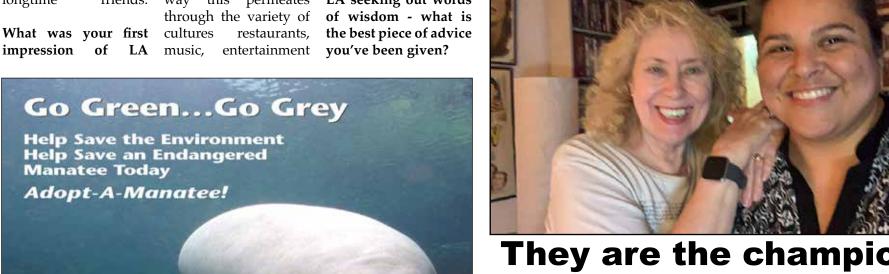

### Federer left at crossroads

#### ■ SW19 may not see him again after Wimbledon exit

ROGER FEDERER suffered his worst ever Wimbledon defeat this week-and then admitted he does not know if he will ever return to play again.

The Swiss superstar, who turns 40 next month, would not even commit to competing in the Olympics later this month.

The 20-time Grand Slam champion was blown away on a blustery day by world No.18 Hubert Hurkacz, beaten 6-3 7-6 6-0 in under two hours It was the first time he has been bagelled at Wimbledon on perhaps his last appearance at the All England Club.

His emotional turn and wave to the adoring Centre Court crowd as he left the scene of his greatest triumphs certainly suggested it was a farewell performance.

Asked if this humbling defeat was his last in SW19, Federer said: "I don't know. I really don't know. I have got to regroup. My goal was always for the last year and more to always try to play another Wimbledon.

"I was able to make it this year, which I'm really happy about. With everything that comes after Wimbledon, we were always going to sit down and talk about it because clearly now Wimbledon is

"I have got to take a few days. You can't think of the entire mountain to climb at once. You've got to go in steps. Wimbledon was the initial first super step, if you like.

"I just think I need to speak to the team, get it all out, hear what they have to say, tell them how I felt, and then we go from there. I've got to take my time, take the right decision."

If his 119th match at his 22nd consecutive Wimbledon was his last, it was a sad way to go.

Federer, who had been seeking to equal Martina Navratilova's singles record of nine Wimbledon titles, had been the oldest man to ever reach the quarter-finals in the Open era.

And he looked like a 39-year-old who had two knee operations and was playing only his 13th match since January 2020. Lacking any timing or rhythm, he made 31 unforced errors and was broken five times by the 24-year-old Pole, who had hero-worshipped him

growing up.

Federer had not lost in straight sets at The Championships since winning only 12 games against Mario Ancic in 2002. "It was tough," he admitted.

"Clearly, there's still a lot of things missing in my game that maybe 10,

15, 20 years ago were very simple and very normal for me to do."

Hurkacz, who had knocked out world No.2 Daniil Medvedev in the last round, said: "It's super special for me – it's a dream come true."

In 429 Grand Slam matches, this was just the

third time Roger Federer has lost a set 6-0.

The others came in his very first Grand Slam match, against Pat Rafter at the French Open in 1999 – he lost 5-7 6-3 6-0 6-2 – and then nine years later in the 2008 Roland Garros final against Rafa Nadal, losing 6-1 6-3 6-0.

Ahead of the match, Mr Johnson tweeted: "We're behind you England." An accompanying image showed the Prime Minister from behind, with his arms in the air, wearing an England shirt bearing the name "Boris" and the number 10.

## Grealish 'understood' reason he was hooked, says Southgate

England manager Gareth Southgate has explained the reason he withdrew substitute Jack Grealish in his side's Euro 2020 semi-final on Wednesday and claimed the forward 'understood' the decision.

Despite having starred in England's two warm-up games prior to this summer's tournament, the 25-year-old hasn't been given the game time many Three Lions fans have been crying out for him to be afforded.

Grealish has been included in the starting XI just once so far at Euro 2020 - as England faced the Czech Republic having

already qualified from Group D - with the rest of his appearances coming via cameo roles as a substitute.

The Villa man was brought off the bench yet again in England's semi-final win over Denmark on Wednesday night, yet he suffered the embarrassment of being hauled off in extra-time after the Three Lions had taken a 2-1 lead.

When asked how Grealish reacted to being substituted just 35 minutes after coming on, Southgate claimed he was fine with the decision and that it was done purely to shore up the defence as

Denmark went in search of a late equaliser.

"But we know when they've [Denmark] gone behind in games they've thrown four men up front so we needed to get an extra defender on just to make sure we were more solid and I wanted to keep Raheem's [Sterling] speed on so it meant taking one of the two boys off who had just come on." Southgate hasn't been afraid to chop and change his starting XI throughout the tournament, with Bukayo Saka emerging as a surprise favourite of the England boss.

Forward Raheem Sterling said after the final whistle: "We had to dig in deep. I think we regrouped well and showed we had a good team spirit.

"It's another step in the right direction. But we have got to focus on the weekend now.

"What football means to this country, you can see by the numbers that came out here this evening, the atmosphere, the cheering, people with shirts off."
