Boris vows football ban for web racists

BORIS Johnson has vowed that anyone who sends racist abuse to footballers will be banned from attending matches.

The PM said the Government is changing football banning orders to cover online racism.

It follows a wave of vile abuse aimed at England stars Marcus Rashford, Jadon Sancho and Bukayo Saka following the national team's defeat to Italy in the Euro 2020 final on Sunday.

Mr Johnson made the announcement at Prime Minister's Questions on Wednesday. Condemning racist abuse directed at England stars, he said: "I repeat that I utterly condemn and abhor the racist outpourings that we saw on Sunday night.

"What we're doing today is taking practical steps to ensure that the football banning order regime is changed, so that if you are guilty of racist abuse online of footballers, then you will not be going to the match. No ifs, no buts, no exemptions and no excuses."

The Premier League

said it supported the extended crackdown.

Banning orders allow magistrates to stop individuals from attending regulated matches in the UK if they are convicted of relevant offences.

They may also be required to surrender their passport before overseas matches and tournaments.

The orders can last between three and 10 years and are mainly handed out for violent and public disorder offences.

The league is working with Rashford, Sancho and Saka to review the accounts that posted abusive messages and provide all findings to the relevant authorities.

During a fiery PMQs, Labour leader Sir Keir Starmer criticised Mr Johnson and Home Secretary Priti Patel's failure to condemn the booing of England players taking the knee. He said: "Far from

giving racism the red

card, the Prime Minister gave it the green light."

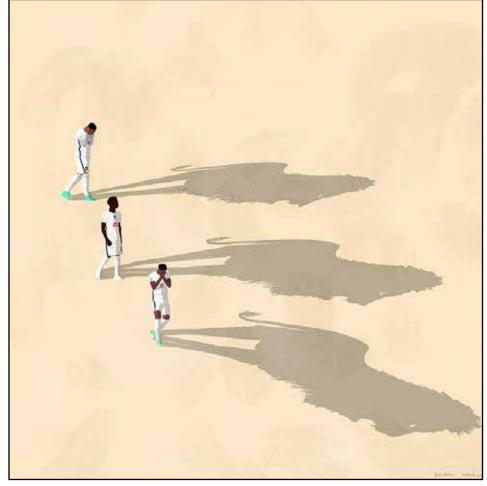
Mr Johnson replied: "The Home Secretary has faced racism and prejudice all her career of a kind he can never imagine."

The PM also urged social media giants to take tougher action over racism. He told Facebook, Instagram, TikTok and Twitter to "up their game" in showdown talks at No 10.

The Prime Minister's official spokesman said: "We expect social media firms to do everything they can to identify these people.

"There is no question this kind of abuse is extremely upsetting, unfair and needs to be stamped out."

The talks, which also included representatives from Snapchat, Microsoft and Amazon Kids UK, come ahead of tougher laws being brought into force with the Government's Online Harms Bill.

Five arrested over England online abuse

Five people have been arrested after England footballers were racially abused online following their Euro 2020 final defeat.

Marcus Rashford, Bukayo Saka and Jadon Sancho were targeted after they missed penalties in the Euro 2020 final.

Chief Constable Mark Roberts said the abuse was "utterly vile".

"If we identify that you are behind this crime, we will track you down and you will face the serious consequences of your shameful actions," he said.

Police said "a torrent of racist comments aimed at some of the team's black players" appeared on social media platforms on Sunday, after England lost on penalties to Italy in the final at Wembley.

The UK Football Policing Unit said its working team was through "a significant number of reports of racist abuse".

The latest arrest was made by Cheshire Police, who have arrested a 42-year-old man from Runcorn on suspicion of displaying threatening, abusive or insulting written material that is likely to stir up racial hatred.

The force said he was arrested as part of an investigation into a racist social media message, which was posted after the Euro 2020 final.

The man has been released under investigation pending further inquiries.

Professor Anthony Harnden, deputy chairman of the Joint **Committee on Vaccination** and Immunisation (JCVI) - which advises No10 on the roll-out — claimed there would be no 'gain' from cutting the gap.

He said data shows a four-week interval causes a much lower immune response, meaning people who get the jabs after a shorter time-frame get less protection against the virus.

Other JCVI advisers have also called for No10 not to change tack in its fight against the third wave, echoing Professor Harnden's concerns.

Harnden Professor told Times Radio: 'We've looked at this data very carefully over the last few days and it is quite clear, from the AstraZeneca vaccine, there is absolutely no doubt the longer interval gives you much better protection.

'But we concentrated on the Pfizer vaccine because of course that's one that's being given to younger people at the moment.

Policing Unit said, as of 13 July, 897 football-related incidents and 264 arrests had been recorded across the country in the 24hour period surrounding the final.

'And it's quite clear from antibody T cells studies that you get much lower response, and poorer quality memory response, with the shorter interval — that's a fourweek interval compared to an eight- to 12-week interval.

'And the actual real data vaccine effectiveness studies show that there is a lower vaccine efficacy against symptomatic with shorter disease intervals compared to longer intervals.'

He added: 'Then we got the modellers to look at this and, actually, the number of infections will rise if we reduce the dose.

'We just don't think there's any good short, or longer term gain by shortening the interval.' Scientists say spacing out doses leads to a better priming of the immune system to fight off the virus.

Originally, both AstraZeneca and Pfizer's vaccines were approved to be dished out in threeweek intervals because that was the gap tested in the research trials.

But No10's scientists pushed the regimen back to 12 weeks to get wider protection in winter, when the second wave started to take off.

H E A R T B R O K E N England fans this week told of their pride in how the Three Lions united a nation – and came so close.

And they believe it is only a matter of time before England end the long wait for a major trophy.

Ås Sunday dawned, anticipation and excitement reached fever pitch – with supporters meeting friends and family early to share the fizzing tension.

Wembley Way was packed hours before kick-off, with fans many without a ticket to the match – creating a full-on party atmosphere.

After the party, comes the clean-up

STREET cleaners on Monday faced the mammoth task of tackling mountains of rubbish left by revellers following England's defeat to Italy in the Euro 2020 final.

Crowds gathered in fan zones and outdoor venues across the country for the big game at Wembley – and left masses of filthy debris in their wake.

Nearly 30 tons of waste was collected from around central London and Wembley stadium in the 24 hours after the final.

Expertssaybeleagueredlocalauthorities also face billsof millions of pounds tosweep up piles of bottles,flags and plastic cups.

Central London, Manchester, Liverpool, Leeds, Brighton and Birmingham were among the worst affected.

Street cleaners in London worked by hand to ferry tons of rubbish from Trafalgar Square and sweep debris from the steps of the historic National Gallery that overlooks it.

One clean-up worker said: "We know everyone was geared up for a huge party, but the revellers here really have made an astonishing mess.

"You'd think people would have learned by now to take their rubbish home with them or put it in bins."

It took Veolia, the waste management company clearing the debris from Leicester Square and Wembley Way, 20 hours to collect the trail of litter. Research estimates the Euros final celebrations generated over one million extra empty beer bottles for waste

collections. Local councils are expected to struggle with the excess generated by fans. Mark Hall, communications director at businesswaste. co.uk, which carried out the research, said: "As a nation, we were all looking forward to watching England play in the final.

"However, it wasn't just fans waking up with a hangover – companies, waste collection teams and local councils also have a costly environmental hangover to deal with."

Bars and pubs were struggling with the big clean-up, too.

Some pubs reported as much as four times their usual weekly waste, with an extra 150,000 plastic pint glasses, 200,000 takeaway trays, 100,000 pizza boxes, 150,000 English flags and one million glass bottles.

In London, a deep layer of broken glass and crushed cans littered Leicester Square after thousands of rowdy fans occupied it for hours, uprooting trees, launching cones and smashing a Burger King shop front.

The fallout from audiences watching the game on big screens in Trafalgar Square was grim. And council workers were busily binning mountains of waste left in Piccadilly Circus. Similar scenes played out in cities across the nation, including Bristol, with extra staff drafted in for yesterday's clean-up.

The researchers reckon the final going to extra time and penalties meant an additional £10,000 alone was added to each local council's street cleaning bill.

Mr Hall added: "It's understandable that people wanted to have a few drinks, but the cost of cleaning these areas can really stretch waste management budgets and has a real knock-on effect for local authorities."

Branson has lift off!

■ British tycoon wins the billionaires' race to space

SIR Richard Branson boldly went where no tycoon had gone to win the billionaire space race – and returned to Earth in time to watch England play in Sunday's Euro 2020 final.

The Virgin entrepreneur, 70, beat the world's richest man, Amazon founder Jeff Bezos, by nine days.

In doing so he turned his childhood dream into reality and opened up the final frontier to tourism.

After he and his crew reached an altitude of 53.3 miles in Virgin Galactic rocket plane VSS Unity, Sir Richard said: "We want to turn the next generation of dreamers into the astronauts of today and tomorrow.

"If you ever had a dream, now is the time to make it come true. Welcome to the dawn of a new space age."

Father-of-three Sir Richard, who had cycled to Virgin Galactic's Spaceport America carrying family photos, said he loved his wife of 45 years, Joan, and his family "lots and lots and lots". Known as Astronaut

001, Sir Richard was accompanied by pilots Dave Mackay, from Sutherland, Helmsdale, and Michael Masucci, and three other crew members. CI Sturckow and Kelly Latimer piloted mothership VMS Eve. It launched Unity at 50,000 feet and flying at 2,600mph about three-and-a-half times the speed of sound - Unity entered suborbital space, reaching 282,000ft above the Earth.

At the top of the flight path, the passengers briefly experienced weightlessness. For re- entry, Unity raised its wings as it began to fall back to Earth, then lowered them to glide to a

runway landing. Sir Richard travelled with chief astronaut Beth Moses, lead operations engineer Colin Bennett and Sirisha Bandla, the second Indianborn woman to go to space.

Sir Richard also carried his mission statement for the £1billion project, which "is to turn the dream of space travel into a reality – for my grandchildren, for your grandchildren, for everyone".

Before the 8.39am flight from New Mexico, he was joined by fellow billionaire and space pioneer Elon Musk, 50. Sir Richard posted a picture of the pair on Twitter, saying: "Great to start the morning with

a friend." And Mr Bezos, 57, posted a picture of Sir Richard on Instagram, saying: "Wishing you and the whole team a successful and safe flight. Best of luck!"

Pilot Mr Mackay said he wanted to make space flights accessible.

"We are confident that the vast majority of the population of the Earth are capable of going on this space flight," he told BBC Scotland.

But for now, at a cost of £180,000 each, thrillseekers must dig deep.

Tom Hanks, Justin Bieber and Lady Gaga are among more than 700 to have signed up for future trips.

Both sides condemn plan to end Ulster prosecutions

Relatives of people killed during the Northern Ireland Troubles have condemned the government's plan to end all criminal prosecutions as a death knell to their hopes for justice and accountability.

Families from all sides of the conflict expressed anger and hurt on Wednesday at what they said was an effective amnesty for perpetrators.

"We're seeing de facto impunity," said Mark Thompson, whose brother Peter was shot dead by British soldiers in Belfast in 1990. "This is a government that doesn't care a jot for human rights and the rule of law.""

Relatives who lost family members to republican and loyalist paramilitaries said Boris Johnson's government was extinguishing any slender hopes of one day seeing terrorist killers behind bars.

"Tell me, prime minister, if one of your loved ones was blown up beyond recognition, where you were only able to identify your son or daughter by their fingernails because their face had been burned so severely from the blast and little of their remains were left intact, would you be so quick to agree to such obscene legislation being implemented?" said Julie Hambleton, whose sister Maxine was one of 21 people killed when the IRA bombed pubs in Birmingham in 1974.

The Northern Ireland secretary, Brandon Lewis, unveiled the plan to deal with so-called legacy cases to the Commons. It proposes a statute of limitations that would end all prosecutions in Troubles-related cases pre-dating the 1998 Good Friday agreement.

Earlier this month, prosecutors halted the trial of Soldier F, who is accused of two murders during the Bloody shootings in Sunday Derry, saying the test for prosecution was no longer met. A legal challenge to that decision is likely to be overtaken by the government's plan. The decision to proceed with the plan is largely driven by strong opposition in Britain to the prosecution of former soldiers.

From hope to despair...again

I think I have been out socially more in the last fortnight than I did in the 18 months prior! And it was all because the England football team kept on winning their matches during the Euros. Unprecedented (in my lifetime at least!) Once they made it to the final (first time in a major tournament in 55 years!), it dawned on me that the crowded bars I had been frequenting would be completely packed to the rafters. So I opted to play it safe and watch the final match with a small(ish) group, in a friend's back garden. It was a very last minute (but sensible) decision, all of the guests were asked to bring something along to help create a bit of atmosphere. I naively volunteered to get St George's Cross bunting. Sounds easy right? I called around to a few of the British stores and had a bit of a Google but couldn't find

anywhere that would deliver before August! However, I did learn that many people think the England flag is the Union Jack though, so do take heed.

I love a bit of DIY so decided that spray painting white 'pennant banners' (American for bunting!) was a good idea. Turns out I am NOT a dab hand with spray paint, but fortunately my boyfriend is. I managed to persuade him to decorate 50 feet of it for our gathering. It was a lovely afternoon, except for the result of course! I was feeling very nostalgic for England and my home town of London in particular, wishing I could be there to celebrate and commiserate with everyone. Sadly my romantic vision was immediately shattered the following morning when I read about the mayhem that fans had caused post match, and on top of that all of

the vile stories of racist abuse that was directed towards some of the England players. It is truly despicable and I will never be able to understand why some people think that way.

Thankfully, a few of the offenders have since been arrested and the social media platforms are supposedly taking action. Boris Johnson announced earlier this week that online racists will be banned from football matches for life. I have no idea how he thinks he can enforce that, especially when most of them are too cowardly to reveal who they actually are. It doesn't really solve the problem either. Racists will be racist with or without social media. The only way to combat this is with education, and that needs to be started at a young age.

Whilst disheartening, please don't forget that this is just a very small section of the population, they just have very loud voices and a large platform. To put it in to perspective I looked up some of the statistics. Over 30 million people in the UK tuned in to the football and from what I can gather 0.1% of that 30 million decided that posting racial abuse was a good idea. If you can't visualize that, it translates in to 1 person in 1000, considering

there were at least 60,000 fans at Wembley stadium that would mean 60 of the attendees would be racist. Still too many for my liking, but I don't think that number would surprise any of us?

Which dilutes this number even more, but also shows this is a global issue, which living in the USA is something I think we are well aware of. I take some solace in knowing that they are a minority but it is still not acceptable. If you want to learn more on how you can help eliminate this problem the charity Kick It Out is a great place to start. Everton have made an opening bid for Napoli and Senegal centre-back **Kalidou Koulibaly**, 30, who is said to be one of new manager Rafa Benitez's top targets.

Liverpool are reportedly preparing a £60m bid for Inter Milan and Italy's Euro 2020 winning-midfielder Nicolo Barella, 24. The Reds may include one of Divock Origi or Xherdan Shaqiri in a deal to bring Atletico Madrid's Saul Niguez to Anfield. But Niguez is also wanted by Barcelona, who have offered Atleti their former striker Antoine Griezmann in exchange.

Chelsea want to offer English forward **Tammy Abraham**, 23, to Borussia Dortmund as part of the deal to sign 20-year-old Norway striker **Erling Braut Haaland**.

West Ham are close to agreeing a loan deal, with an option to buy, for French Paris St-Germian goalie Alphonse Areola, 28.

Arsenal defender Hector Bellerin has yet to agree personal terms with Inter Milan but the Italian side are considered favourites to sign the 26-year-old Spaniard.

Tottenham could make a move to sign Roma midfielder Lorenzo Pellegrini, 25, but will have to meet his £26m release clause to get the Italy international.

Chelsea are reportedly tired of waiting for big money signing Timo Warner to come good in the Premier League, and are preparing bids for either Spurs' England striker Harry Kane, 27 or Inter's Belgium forward Romelu Lukaku, 28. RORY McILROY has vowed to go all out at Royal St George's to end his seven-year Major drought.

McIlroy was hoping to be one of the leading contenders for The Open when it started in Kent on Thursday, although the Northern Ireland star has not won one of golf's biggest prizes since August 2014.

Asked about that barren run, the four-time Major winner said: "I'm fed up with it too. I'm trying my nuts off. I've had my chances and I haven't taken them.

"There's been times where I have been playing good enough golf. "The more you knock on the door, it is the law of averages."

McIlroy needs only The Masters to complete a career Grand Slam.

But his prospects of more glory have been hit by a series of poor starts in the first rounds of Majors.

Compatriot Darren Clarke, the 2011 Open champion from when the tournament was last held at Royal St George's, feels McIlroy's game is close after the pair practised together on Wednesday.

Clarke said: "Any time you get a chance to play with Rory, I really enjoy it.

"I think he's one of the most, if not the most, naturally gifted players in the world, so it's only a matter of time before he starts winning again.

"There's no questioning his talent. He's working really hard.

"I spoke to Rory many times when we were playing and his desire is incredible. He wants to win Major tournaments. He wants to perform well.

"You've just got to

believe in your own ability and believe in your own talent and trust that it's going to

NEW Everton boss Rafa Benitez has signaled that star players like James Rodriguez and Fabian Delph could be on the chopping block as he seeks to rebuild the Merseysiders into a titlechasing outfit.

And he indicated that he although he is confident of his abilities to do just that, he doesn't expect patience from the club's owners.

Asked if there had been any promises of patience to plot a route towards the trophies that could win over the fans, his answer was succinct.

To be fair, in modern football that's quite difficult to get," he said.

Owner Farhad Moshiri and his chief sponsor Alisher Usmanov emphasized only the need for silverware, he said, and he was confident he could do just that.

"The question was, is it possible?" he said. "I would say, yes.

"You can see that you can compete in the Premier League against the best players and managers in the world and that is what I'm looking for. I like this challenge. I'm not afraid of anyone," he said. "I hope that our team is not afraid of anyone. That is the way to create this winning mentality we are talking about.

"My job is to give them confidence, give them the tools so we can win any game and it doesn't matter the name of the opponent."

There will be signings, the manager in particular looking to strengthen the wide areas to deliver more to Everton dangerman Dominic Calvert-Lewin.

That could mean the end for both Richarlison and James.

"Everyone knows this club has spent a lot of money in the last few years so it means you must respect Financial Fair Play," he said.

KANE TO RACISTS: WE DON'T WANT YOU

Skipper hits out as Southgate says penalties were his call

HARRY KANE has blasted racist England fans telling them: "We don't want you."

Three Lions skipper Kane was left seething after Marcus Rashford, Jadon Sancho and Bukayo Saka were all bombarded with vile racial abuse following defeat in Sunday's Euro 2020 final.

All three missed penalties in England's heartbreaking shoot-out loss to Italy at Wembley and they have since been singled out for abuse on social media.

Kane hit back Tuesday night, telling those responsible to stop following Gareth Southgate's men because they were no longer wanted by the national team. Kane took to Twitter to say: "If you abuse anyone on social media you're not an England fan - and we don't want you.

"They [Rashford, Sancho and Saka] deserve support and backing, not the vile racist abuse they've had since. Three lads who were brilliant all summer had the courage to step up and take a penalty when the stakes were high."

As well as the abuse, Rashford also saw his mural in the Manchester defaced - before it was covered in supportive notes.

In a moving message on Twitter, the United star wrote: "I can take critique of my performance all day long, my penalty was not good enough, it should have gone in, but I will never apologise for who I am and where I came from.

"The messages I've received today have been positively overwhelming and the response in Withington had me on the verge of tears. The communities that always wrapped their arms around me continue to hold me up."

He also apologised for his miss, writing: "It's been playing in my head over and over since I struck the ball and there's probably not a word to quite describe how it feels. Final. 55 years. 1 penalty. History. All I can say is sorry. I wish it had gone differently."

Southgate labelled the abuse "unforgivable".

The manager reiterated that it was entirely his decision who should take the kicks and that the three who missed would "heal together" with the rest of the group "as a team". "We have got to make sure we're looking after those suburb of Withington boys - that's been at the

top of my thinking all night really," Southgate said. "It was my choice, nobody else's, it was my decision to give the penalties to the guys that took them.

"It's not a case of players not volunteering or more experienced players backing out, as they didn't have a chance. And Bukayo has been an absolute star in this tournament. He has shown incredible maturity in the way he has played.

"He's brought smiles to people's faces and is such a popular member

of the group. I know he has everyone's support." Saka's club Arsenal their released own statement in support,

saying: "Our message to Bukayo is hold your head high, we are very proud of you and we can't wait to welcome you back."
