



# Clown prince (and pals) make Meghan's birthday

## ■ Duchess of Sussex marks 40th birthday with scheme to mentor women returning to work

**SENDING** out a serious birthday message proved a bit of a juggling act for the Duchess of Sussex on Wednesday – thanks to the antics of husband Prince Harry.

Drinking a cup of tea to toast her 40th, she launched a scheme to encourage people to devote 40 minutes of their time to help and mentor women returning to work.

But in a short film about the 40x40 initiative, she gets the giggles when she is interrupted by the clown prince juggling balls outside her window.

Meghan – filmed at a desk with her pet beagle Guy close by – also has a laugh with comedy actress Melissa McCarthy, who suggests they get tattoos of each other's faces and holds up a design.

The Duchess tells the *Bridesmaids* star: "But you know I already have something really similar across my back."

A host of other

celebrities and activists will set aside 40 minutes to support the 40x40 project, including singer-songwriter Adele, fashion designer Stella McCartney and Sophie Gregoire Trudeau, wife of Canadian PM Justin Trudeau.

Meghan said: "Because I'm turning 40 I'm asking 40 friends to donate 40 minutes of their time to help mentor a woman who is mobilising back into the workforce."

"Over two million in the US alone and tens of millions around the world have lost their jobs due to Covid and I think, if we all do it and all commit 40 minutes to some sort of act of service, we can create a ripple effect."

In a written statement the Duchess, who worked for 72 days as a

royal before announcing her decision to quit, said "time" is "among our greatest and most essential gifts", especially "time spent in service to others".

Meghan and Harry are believed to have planned a low-key 40th

celebration at their home in Montecito, California.

The rest of the couple's royal patronages are expected to be handed to other royals. And the Duchess of Cambridge is set to take Harry's Rugby Football Union role.

### Iran warned over 'big mistake'

**THE** head of the British military has warned Iran that it made a "big mistake" by launching a bomb attack on a tanker which killed two crewmen – including a Briton.

General Sir Nick Carter said Tehran had taken tensions in the Gulf to a dangerous level with its "reckless" drone strike on MV Mercer Street.

General Carter spoke as Adrian Underwood was named as the British victim. The other man was a Romanian. They were in the tanker's living quarters when an explosives-packed drone hit the tanker off the coast of Oman last Thursday.

Family and friends of Mr Underwood paid tribute as they raised funds to pay for his funeral. They said he was born in Fiji to a distinguished military family, then moved to the UK and served in the Army until about 20 years ago.

Mark Wilson wrote

on the JustGiving web page: "A humble gentleman, funny and loved by so many.

"Our love, thoughts and blessings go to his wife Kiasia, young son Zac and his family and friends."

Meanwhile, tension escalated after another vessel was boarded in the Gulf by gunmen identified as Iranian nationals.

General Carter told the BBC: "What we need to be doing, fundamentally, is calling out Iran for its very reckless behaviour. They made a big mistake on the attack against the Mercer Street last week because, of course, that has very much internationalised the state of play in the Gulf.

"Ultimately, we have

got to restore deterrence because it is behaviour like that which leads to escalation.

"That could very easily lead to miscalculation and that would be very disastrous for all the peoples of the Gulf and the international community."

Mercer Street – Liberian-flagged and Japanese-owned but operated by Israeli company Zodiac Maritime – was escorted to safety by two US Navy warships.

Although Iran denied involvement, the incident came as its relations with Israel and Western powers were at a low. Boris Johnson warned Iran it would "face consequences" for its warmongering.

## Fury as NHS lets trans sex offenders on female wards

**HOSPITALS are facing an outcry by allowing sex offenders born male but identifying as female to be placed on women-only wards.**

NHS Trusts in Devon, Oxford and Nottinghamshire have told staff a criminal history should be part of a risk assessment when deciding to put a person born male on a female-only ward.

But they do not say that it prevents transgender men from being admitted. The news has sparked anger and concerns for the safety of women patients.

It comes as NHS Trusts across the country also issued guidance on allowing people who are transgender to choose which ward, lavatory and shower facilities they use.

The policies have been

put in place even though a Department of Health order says hospitals have to provide single-sex wards.

Medical staff have warned that the guidance could leave the most vulnerable at risk.

Baroness Nicholson of Winterbourne, the chair of Parliamentary campaign group Children and Women First, said that by "manipulating and distorting" equality laws, the NHS is denying women the right to "dignity and privacy" in their treatment.

She said: "The NHS is the best in the world. We can't afford to have the NHS go off track like this. It will be the laughing stock of the world."

The Oxford Health NHS Foundation Trust said: "If the service user

has a sex-offending history, risk should be managed in the same way as it would be with any other client, irrespective of gender."

Devon Partnership NHS Trust guidance states: "Transgender people must be able to use the facilities of their preferred gender while admitted."

Nottinghamshire Healthcare NHS Foundation Trust guidance says that when deciding on a treatment setting "previous history of sexual offending should be taken into account".

An NHS spokesman said: "Hospitals must safeguard the safety, privacy and dignity of all patients, including following the legal requirements established by Parliament."

## Fitness fanatic, 42, who refused jab dies of Covid

**A SUPER-FIT and healthy 42-year-old father with a "belief in his own immortality" has died of Covid-19 after rejecting the vaccine.**

John Eyers had been climbing mountains and wild camping just before he tested positive.

His twin sister Jenny McCann, of London, said he was the "fittest, healthiest person I know" and had thought he would only have a "mild illness" if he got coronavirus.

She added that before going on to a ventilator in hospital he told his consultant that he wished he had been vaccinated.

Mr Eyers, of Southport, Merseyside, died last week after suffering from an infection and organ failure.

He also leaves behind parents and a daughter aged 19.

Writing on Twitter, Ms McCann, a mother of two, said: "He died exactly four weeks after testing positive. The only pre-existing health condition he had was the belief in his own immortality."

"He thought if he contracted Covid he'd be OK."

She added: "My mum wants people to know about John. For his story to save someone's life... to drive people to get a vaccine."



# Peaty declares GB gold standard

## Swim hero: We swim to win, not to make finals

ADAM PEATY sent a warning to the world as Britain's swimmers completed their greatest ever Olympic campaign.

An eighth medal on Sunday gave them their biggest haul in 113 years and banished the embarrassment of just three in the home Games of London 2012.

Peaty, the spiritual leader of a rejuvenated team, said: "Ten years ago we were happy making finals. We aren't happy making finals any more.

"The culture has

totally changed. We are aiming for gold, we are aiming to be the best in the world – and to dominate the world."

You could see it this week in the body language of Peaty, Luke Greenbank, James Guy and Duncan Scott after being edged out by the USA for 4x100m medley relay gold. It took a world record to beat them by a swimming superpower never defeated in the event.

Yet Scott looked like he had swallowed a wasp rather than become the

first British Olympian to win four medals at a single Games. And Peaty, taking his own Tokyo tally to three, admitted: "It's painful, I don't like coming second at all."

### breaking point

They had just lost to an American quartet spearheaded by the peerless Caeleb Dressel, capping one of the greatest ever individual Olympic performances with his fifth gold of these Games.

Yet Britain pushed them almost to breaking

## Kenny surpasses Hoy for greatest medal haul

JASON KENNY became Britain's most decorated Olympian on a day Team GB roared to a further eight medals on Tuesday.

Kenny aimed a playful dig at former teammate Sir Chris Hoy after passing his record, with silver in the men's team sprint bringing his eighth Olympic gong. "The main thing is I beat Chris because I know it will annoy him," said Kenny, whose wife Laura (pictured, above) won silver in the women's team pursuit. There were also two GB gold medals in the sailing, a diving bronze and a silver each in sailing, boxing and athletics.

Jason became Britain's most-decorated Olympian by adding a second silver medal to his six golds, and defeat was no shame against three flying Dutchmen in the men's team sprint final.

In many ways, it did not just feel as if the curtain was falling on Team GB's cyclists at the Izu velodrome. In the chaos of records tumbling, crashes, protests and an unexpected farewell, it seemed like the roof was caving in.

Ed Clancy's retirement ushered in the end of Britain's reign as team pursuit kings, then Laura Kenny's 100 percent Olympic record

was finally punctured by Germany's quartet posting a mind-blowing world record of 4mins 4.242secs.

And when his alliance with Ryan Owens and Jack Carlin was torpedoed by the Netherlands, in an Olympic record 41.369, Jason Kenny's unbeaten record in Olympic team sprint duels going back to Beijing was finally broken.

But there is no need to take down the bunting, no need for inquests, no need for recrimination.

The Britons dished it out to the rest of the world in Beijing, London and Rio. Now they have to be humble enough to take it.

point with Peaty posting the fastest breaststroke relay split of 56.53secs en route to a European record 3mins 27.51secs.

"A lot of teams are going to look at us and how we do things," said the Staffordshire pool terrier.

"Because we are now always looking for gold, always looking for world records. I'm incredibly proud to be part of this team. It's history making."

As Britain's fab four collected their medals, performance director Chris Spice hailed "phenomenal performances across the board" and lifted the lid on the transformation within British Swimming.

"It's a significant shift in where we've gone," he said. "To be talking about the colours of the medals rather than the numbers. One of the reasons I took the job was that I could see that we could swim fast but we couldn't swim fast when it matters. I thought that's something we can fix.

### bellyflop

"There was a whole programme [created] around how do we swim fast in the arena – how do we get our athletes to step up and not be nervous."

Spice, who took charge following swimming's London 2012 bellyflop, found that only 20 percent of the team posted personal bests in

that Olympic year.

"I've always believed that you can't give someone self-confidence but what you can do is create an environment where they build their own," he said.

They invested in talent identification, coaches and sports science, streamlined national centres of excellence from five down to two and devised a plan everyone could buy into.

Tom Dean, little known but full of potential, was persuaded to stay in the UK rather than take up a US scholarship. The same Tom Dean who last week became the first British male swimmer since 1908 to win more than one gold at a single Games.

## Laura: from coma to Olympic gold

OLYMPIC eventing champion Laura Collett had already won her biggest battles before taking team gold in Tokyo on Tuesday.

She helped Great Britain top the podium in the discipline for the first time in 49 years alongside Oliver Townend and Tom McEwen.

Victory sealed a remarkable comeback for the 31-year-old who nearly died in a fall eight years ago and spent six days in a coma.

Laura suffered a punctured lung, fractures to her spine, shoulder and ribs and lost most of her vision in one eye.

But this week Laura put those tough times behind her.

She said: "I know I am lucky just to be alive, let alone doing the job I love and to be winning a gold Olympic medal.

"Just to be here was more than a dream come true."

"I am super grateful to be on a team with these two guys. It has been an unbelievable week, and roll on the celebrations."

Laura's cross-country fall at an event in Hampshire left her unconscious for a week and she counts herself "very, very lucky" that it was not worse.

Elsewhere, Tom McEwen won silver in the individual eventing category and Emily Campbell became the first British woman to win an Olympic weightlifting medal with a stunning silver.

The eventers, led by world No 1 Oliver, claimed Britain's first gold since Munich in 1972, when they were inspired by Richard Meade who also won the individual title.

Oliver said: "It still has not sunk in. There will be a big celebration and I don't think it'll be with a cup of tea and a biscuit."

## Gymnast Max 'owes repeat victory to his little girl'

BRITAIN'S golden boy Max Whitlock was crowned Olympic champion again this week – and said he was inspired by his little girl back home.

The gymnastics star, 28, mounted a successful defence of his pommel horse title at Tokyo 2020 after receiving a good luck message from his two-year-old daughter Willow.

Max said he managed to FaceTime her every day, despite the eight-hour time difference in Japan.

And Willow inspired him to his second successive Olympic title.

He said: "Willow loves my medals from Rio in 2016. She is definitely my motivation.

"I feel absolutely lost for words. I can't even describe the feeling. I feel completely overwhelmed and it feels very surreal.

"Team GB have been doing absolutely

incredibly. The gold medals have been flowing in and I just wanted to do the same thing.

Coming out here and getting my own, I feel very proud."

Willow had posted a video before the competition, wishing her father good luck – saying "duck" by mistake.

She watched the action from home with Max's wife, Leah.

The gymnast, from Hemel Hempstead, Herts, had married his childhood sweetheart after the last Olympics.

First up in the eight-man pommel horse field, Max posted a score which could not be beaten.

As his title was confirmed, he held his hands to his face and then raised the Union Flag aloft. He has now won six medals in three Games. Max, a double Olympic champion in 2016, said: "This

is probably the most pressured environment I've ever been in.

"This morning I felt that, and I've always said that chasing is 10 times easier than retaining. I've

learnt that throughout my journey.

"I've been fortunate to have learnt that, being in this position, going into this competition."

His mother Madeleine

said: "He's my champion. You cannot put into words how I feel about him and I just want to give him a hug and just tell him that we're so proud of him."

## GB on the crest of a wave....

### ■ Giles surge caps golden hour for country's jubilant sailors

AS HE clutched his gold medal, Giles Scott said he had never known pressure like it.

Along the boardwalk he was being hailed as "the king" of Britain's sailing team. Sir Ben Ainslie paid tribute to how cool he had been.

He had just retained his title in the Finn class to complete an Olympic golden hour without equal for Britain's yachtsmen and women.

He had watched Stuart Bithell and Dylan Fletcher deliver the nation's historic first win in the 49ers class – then went out and matched it.

Soon after, John Gimson and Anna Burnet followed him back into Enoshima harbour with a silver medal in the mixed Nacra 17 class. Britannia

ruling the waves? You bet. Yet what made Monday so incredible was the manner of the achievement.

With 20 metres remaining, Scott was in silver medal position. With 10 to go in theirs, the 49er boys were too. Scott, 34, a double Olympic champion with experience of the America's Cup, said: "No doubt that's the greatest pressure I've felt in my career.

"That was mine to lose. I got there, but only just. I've never been involved in any form of boat race as close as that."

The reigning champion had won six of the previous seven races, putting him in the position he dreamed of as a kid wanting to be

Ainslie. He would have had to false start and finish out of the top five in the medal race to blow it.

Yet, when the hooter sounded in Sagami Bay, he twitched on the start line so doubled back and started again to avoid the possibility of a penalty.

"That left him at the

back of the fleet, playing catch-up. With 50m to go, he was sixth, behind big rival Zsombor Berecz, of Hungary. Britain's gold monopoly since 2000 seemed to be ending.

Bithell and Fletcher had powered from nowhere to pip the Germans in the previous race, and Scott somehow found a way

past Turkey on the line in a heart-stopping finish.

Ainslie tweeted: "How cool under pressure. Seriously, well done."

Scott said: "To follow legends like Iain Percy and Ben Ainslie, my heroes growing up, yeah, so proud. That's six in a row for Britain in the Finn. We own it."



# Penny: Rod is so proud police job has boosted my confidence

**PENNY Lancaster** clocks on for a late shift with the police – knowing every beat of her husband's heart will race a little faster until she is back safe.

The former model (pictured, right), who works as a special constable one night a week, has revealed Sir Rod Stewart is jumpy about her job.

But Penny, 50, said: "He's got over the initial nerves of, 'I'm not going to be able to sleep until you come home'.

"I can't really message him on the job.

But I always text him when I get back to the station to reassure him before he puts his head

down.

"He sees the joy I get out of it. But now he also sees my confidence.

"And he's proud I'm raising the positive profile of the police and helping support police charities."

Penny, who stands 6ft 1in in her City of London Police plod-hopper boots, spent her Friday shift until 4am on foot patrol with divisional commander Ian Miller.

### Grappling

Her hastily-grabbed Tesco meal-deal dinner was a far cry from the Michelin-starred dishes she often shares with Sir Rod, 76.

Penny said: "Sometimes

I have to pinch myself. I'm in all these glamorous outfits and then I've got to get to the police station on time.

"It's not a fashion show, but the trousers are the worst fit and super-thick like cardboard – because they expect you might be rolling around and grappling on the floor. One of the girls advised that maybe I should try the men's trousers as they fit better."

But Penny does love one part of her uniform.

She admitted: "I like to wear open-toed shoes like my Jimmy Choos for photoshoots as I'm uncomfortable in pointy sandals... but even they are not as comfy as my

police boots."

Penny, mum to Alastair, 15, and Aiden, 10, joined the police after appearing on Channel 4's Famous And Fighting Crime reality show in 2019. She qualified as an officer in April.

Penny told a magazine the TV show did not reveal her first agony on the job – when she tried to resuscitate a heart attack victim who didn't make it.

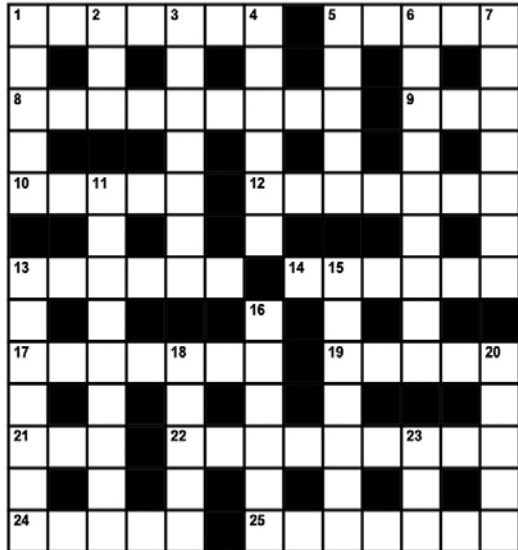
She said: "I'm quite good at following instructions and taking all the emotion out of it. Afterwards I cried. But the police are really good because they help you deal with your emotions after any trauma."

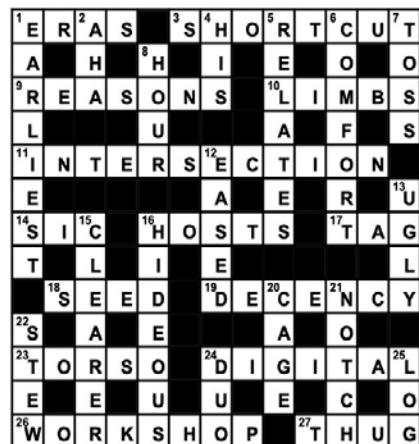

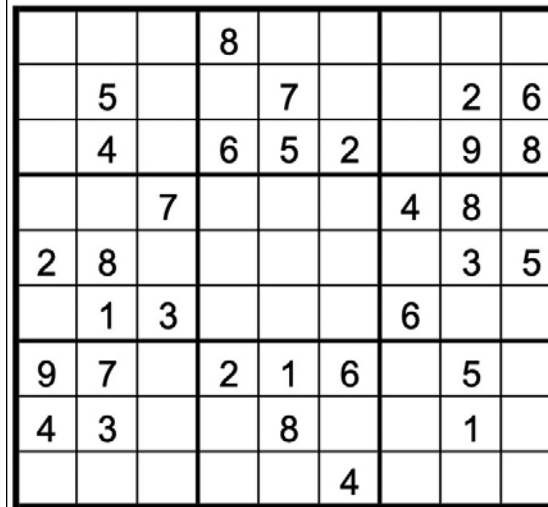

# From Sicily to Sardinia: not all smooth sailing

■ Nick Stark continues his boozy and cruise-y voyage through Italy's Mediterranean coast

After two delicious days in Palermo I taxied out to the small town of Cefalu where my friend Franz was waiting aboard his sailboat See Dream. Although Franz hails from Utah, he's had the boat in the Med for 25 years and takes two months off to sail every summer because he's a firm believer in a healthy work/life balance...

We weighed anchor about 3am Saturday, July 31st for a long journey to the small island of Ustica, the only habitable spot en route to Sardinia, which lay another 200

miles over the horizon. It was an uneventful motor sail to Ustica, which has just one small marina and one main town, a collection of restaurants, trinket shops and B&Bs clustered onto the small hillside overlooking the port. The place was charming enough in Italian/Mediterranean way, and we stayed for a couple of days, enjoying the local seafood but sweltering in the 95-degree heat, from which there seemed no escape. The complete lack of wind meant there was no point in continuing

to sail, and our boat's fuel supply was too low to motor all the way to Sardinia. There is a fuel dock in Ustica, but it was too shallow and narrow for our boat to maneuver alongside. So, like all good sailors, we waited out the weather.

### Lido shuffle

To escape the heat we took plenty of dips in the sea and chatted to other sailors, including a charming couple from the Isle of Wight who were docked alongside us. But the highlight was renting scooters to travel round the island, which is the remnant of a volcano. The most interesting aspect of this was seeing the half dozen chintzy 'lidos' where concrete had been poured into the lava rock bay and chairs and sunshades laid out, to entice visitors to swim. There were no beaches to be seen anywhere, just a couple of very pebbly but sheltered coves set into the rock where we could lounge for an hour or two to beat the heat.

Come Monday we set off for Sardinia, a 200 mile, two-day journey with no land in

sight. The first day was uneventful with decent wind, but overnight the weather turned stormy and we were treated to a lightning show (every sailor's nightmare, in fact, because of the danger of the mast getting struck and the electrics getting fried), followed by sharp squalls, hard rain and large swells. The wind really turned up shortly after 4am, when I was on watch alone, but none of us got much sleep before conditions eased. Dawn

came dreary, wet and lumpy, before giving way to tentative sunshine and soft breezes come lunchtime. We took the opportunity to make a tasty onboard lunch of salad and white wine and take a dip overboard in the middle of the ocean. Having nothing but miles of sea in every direction and countless hundreds of feet below

By the time we reached Butoni Bay on Sardinia's east coast

about 10.30pm, we were all ready for a very long snooze. Fortunately there was not a breath of wind and we enjoyed a comfortable night in a deserted anchorage with nothing but the distant lap of water on ivory colored sand and the view of pine dotted hillsides to keep us company.

On Wednesday we made the short hop up to the Gulf of Aranci, where we needed to stay another two nights due

But if the forecast is right this will ease overnight, allowing us tomorrow to set sail for the northern tip of Sardinia, and from there across to Minorca, another two-day passage with no land in sight. Let's hope the weather and wind gods will smile upon us.

## ■ Aston Villa star Grealish set to be England's first £100m footballer

ENGLAND star Jack Grealish is on the brink of scoring a record transfer deal with Manchester City that will net him more than £230,000 a week.

He will also become the country's first striker worth £100million – the price Premier League champions City are poised to pay for the Aston Villa captain, who shone at this summer's Euros 2020.

The British record fee stands at £89.3million, paid by Manchester United to Juventus in 2016, when the club signed France ace Paul Pogba.

But that looks set to be smashed by the contract Grealish is now expected to sign at City's Etihad Stadium.

The move will be a blow to Aston Villa supporters. Grealish, 25, a Villa academy graduate, is adored by fans and has scored 32 goals in more than 200 appearances for his boyhood West Midlands club.

But Tottenham Hotspur fans will be praying the deal will spell the end of City's attempts to sign their captain, Harry Kane.

Grealish had returned to training with Villa on Monday after his holidays in Mykonos and Dubrovnik.

Meanwhile England team-mate Kane, 28, failed to report for training at Tottenham in what is believed to be a bid to force a move.

Grealish, who set

up Kane's first goal in the Euros in England's thrilling 2-0 win against Germany, is seen as one of the country's most talented midfielders.

But his career has been dogged by controversy. In 2015 images emerged of him appearing to inhale "hippy crack" from a balloon and that summer he was snapped sprawled out, apparently drunk, in a Tenerife street.

He was hit by scandal again in 2016 when he was accused of inhaling the drug at a Birmingham hotel party.

In December, the footballer was banned from driving for nine months and fined £82,499 after he admitted two counts of careless driving during the first lockdown

in March last year.

Birmingham magistrates heard police had spotted him driving at more than 90mph on the M42 before he went

on to crash his £80,000 Range Rover.

And it emerged 200 death threats sent to Grealish's girlfriend Sasha Attwood during

the Euros were mainly from teenage girls.

Model Sasha, 25, said: "I'd go on these girls' accounts and they're 13 or 14. It's so sad."



## Danny goes from Saint to Villain

ASTON VILLA have signed striker Danny Ings from Southampton for an undisclosed fee.

The 29-year-old (above) has agreed a three-year contract and arrived on the same day Villa announced the signing of forward Leon Bailey on a deal running until 2025.

"He is also a top professional with a great character who will be a leader in our squad and a role model for our rapidly developing

young academy players who are now in and around the first team.

Ings, who scored 13 goals for Saints last season, joins fellow summer recruits Bailey, Emi Buendia and Ashley Young at Villa Park.
