# ALL OVER FOR ANDY?

## ■ U.S. lawsuit likely to scupper Prince's hopes for return to full Royal status

**PRINCE Andrew's hopes of returning to his official royal duties were shattered this week – as it was revealed he is being sued for allegedly sexually assaulting a teenager.**

Andrew, 61, had been hoping to resolve his legal problems by the end of the year in a bid to have his status in the Royal Family restored, despite the opposition of some palace officials.

But friends admitted this week that he had been dealt a hammer blow – as Virginia Giuffre filed a lawsuit in New York accusing him of sexually abusing her while she was under the age of 18 and a victim of trafficking.

His legal problems look likely to continue well into next year, when the Queen is due to celebrate her Platinum Jubilee.

### Connections

The Duke of York could also be hit with a second lawsuit as attorneys for another alleged victim, hairstylist and former PA Johanna Sjoberg, consider possible action under an Adult Survivors Act set to come into force in New York state.

Andrew's biographer Nigel Cawthorne said: "It is very difficult to see how Prince Andrew can return to the frontline of the monarchy while a suit is pending, or with a verdict against him passed in

absentia."

The prince stood down "temporarily" from official duties in November 2019, following a disastrous television interview he gave about his friendship with the convicted paedophile Jeffrey Epstein.

Epstein, who hanged himself in prison two years ago, was accused with British socialite Ghislaine Maxwell of "lending out Ms Giuffre for sexual purposes".

Friends of Ms Maxwell, who is currently in prison awaiting trial in November on sex trafficking charges, said she was prepared to give evidence on behalf of the Duke.

They told a newspaper: "By the time the case against the Duke gets to court, Ghislaine will either be convicted and serving up to 85 years in jail [or if] cleared of course she would help Prince Andrew.

"They have been friends for a very long time."

Maxwell, 59, would need to be cleared of wrongdoing at her own trial if her evidence is to be considered credible in a New York courtroom.

Andrew and his lawyers maintained a stony silence this week, having not responded publicly to a 15-page civil lawsuit filed by Ms Giuffre in which she sought unspecified damages from him in a federal court under New York state's Child Victims Act.

She says Epstein and Ms Maxwell forced her to sleep with Andrew 20 years ago, when she was 17 and still a minor under some US states' laws.

Ms Giuffre, now 38, claimed she feared for her life if she did not have sex with the prince.

"Prince Andrew's wealth, power, position and connections enabled him to abuse a frightened, vulnerable child with no one there to protect her," she said.

"It is long past the time for him to be held to account."

New York's Southern District Court gave Andrew 21 days to respond once he had been served with the paperwork.

Legal experts think it likely that the papers will be handed to British representatives in the US

rather than Ms Giuffre's representatives trying to access Andrew at Balmoral Castle.

Andrew strenuously denies sleeping with Ms Giuffre or any other

wrongdoing and insists he has no recollection of ever meeting her.

He promised to help an FBI inquiry into allegations against Epstein and associate Ms Maxwell

but he has declined to cooperate with the FBI in practice and consistently ignored the threat of civil action for damages.

# Briton suspected of spying for Russia arrested in Berlin

German police have arrested a British man who worked at the British embassy in Berlin on suspicion of spying for Russian intelligence in exchange for cash bribes, according to prosecutors.

Germany's highest public prosecutor said the man, identified only as David S, was arrested at his Potsdam apartment at 2.20pm on Tuesday, and his home and embassy workplace were searched.

The 57-year-old Briton is understood not to be a diplomat but a private contractor working as a security guard at the Berlin embassy and therefore does not hold diplomatic immunity.

He is suspected of having worked for a Russian intelligence agency at least since November 2020, at least once passing on documents he had acquired through his work to a handler.

He is alleged to have been paid a cash bribe to pass information to Russian intelligence.

He is a British national and was

under surveillance by British and German investigators, believed to have included MI5, but officials reluctant to discuss when that started.

## cash payments

The operation that led to David S being suspected was "intelligence-led".

He is alleged to have received cash payments of an as yet unspecified sum in exchange for information. Citing prosecutors' circles, the German news magazine Focus reported on Wednesday that the information passed on related to counter-terrorism issues.

Germany's public prosecutor said the arrest was the result of a joint investigation by German and British authorities. The Metropolitan police said the investigation into David S had involved Scotland Yard's counter-terrorism officers.

"The man was arrested in the Berlin area on suspicion of committing offences relating to being engaged in 'intelligence agent activity' (under

German law)," the Metropolitan police said.

"Primacy for the investigation remains with German authorities. Officers from the counter-terrorism command continue to liaise with German counterparts as the investigation continues."

The Met's counter-terrorism command is responsible for investigating alleged breaches of the Official Secrets Act.

A spokesperson for the British Home Office said: "An individual who was contracted to work for the government was arrested yesterday by the German authorities. It would not be appropriate to comment further as there is an ongoing police investigation."

Nick Thomas-Symonds, the shadow home secretary, said the allegations potentially amounted to a "serious breach of UK national security".

"All measures must now be taken – urgently – to establish exactly what information has been passed to Russian intelligence and the

impact this has on the UK, as well as that of our allies," he said.

"This is yet another example of the real

threat posed by Russia, so it is unacceptable that

## Time to decriminalize drugs, says former Tory leader Hague

FORMER Tory leader William Hague has called for drugs to be decriminalised and treated as a health problem.

The life peer (pictured, right) believes Britain's war on drugs has failed and thinks Portugal's approach to the issue is far better.

Last week's official figures show deaths from MDMA, cocaine and sleeping pills such as Xanax have multiplied 10-fold in a decade.

### 'worth a try'

Drug fatalities have surged to their highest level since 1993, with 4,561 deaths in England and Wales registered last year – the ninth successive year they have risen.

Mr Hague admitted that, like many fellow Conservatives, he was



initially reluctant to abandon a "tough" law and order approach.

Offenders But he said: "We will never suppress the supply of drugs while the demand goes on."

Lord Hague said: "Portugal has not legalised drugs and still punishes drug trafficking.

"But after decriminalisation [in 2001], all major indicators...improved, including an 18 per cent

fall in the total costs to society after 11 years.

"By 2010, the number of drug offenders sent to criminal courts had halved.

"Less law enforcement work will have helped to pay for better treatments. "Might this not be worth a try?"

Ministers are now proposing to make naloxone – a medicine that can reverse the effects of an opioid overdose – more widely available.

# Team GB left aglow by historic Olympic success

**TEAM GB were left basking in the warm glow of historic Olympic glory this week.**

In one of the country's greatest-ever displays, the nation's athletes electrified the county with their golden performances, generating renewed national pride and a host of inspirational memories.

The team finished fourth in the medal table, just behind Japan and the global giants of the USA and China, but by one measure, Britain was the most successful team of all, taking medals in a wider range of sports than any other country. Our 65 medals covered 23 different disciplines, whereas China's 88 were garnered in 19.

What is certain is that this was Britain's second most successful overseas Olympiad after the Rio games in 2016, where

we won 67 medals and finished second in the table.

Team GB's total this time was exactly the same as in London nine years ago, but it could be argued that Tokyo was even more impressive. Not only because there was no home advantage but also because Team GB was significantly smaller with 375 athletes compared with 500 in 2012, partly because of the pandemic.

New heroes were created, like boxer Lauren Price, BMX rider Beth Shriever and modern pentathletes Joe Choong and Kate French.

Great names had their stature reinforced, such as cyclist Laura Kenny, the only woman to have won a gold medal at three successive games, and her husband Jason, the most successful British Olympian of all time with seven golds.

Superhuman Adam Peaty became the first Briton to successfully defend a swimming title, while the brilliant Tom Daley, who first captured

the nation's heart in Beijing in 2008, finally won the diving gold his ability had always merited.

But this was no collection of prima donnas or lavishly rewarded superstars. Many of the medallists had to show supreme devotion to their craft in the face of tough obstacles. The 200 metres freestyle gold medallist Matt Richards had to train during lockdown in a makeshift pool in his parents' back garden. BMX rider Charlotte Worthington worked in a Mexican restaurant to subsidize her training, while boxer Galal Yafai was a Midlands car factory employee six years

ago. The fortitude and steadfastness required are almost beyond comprehension.

As Jessica Ennis-Hill, one of the true greats of British athletics, put it this week: "To be the best in the world, you have to push yourself to unthinkable levels. You have to be able to get to the point in training where you are on the floor and you cannot walk, but you pick yourself up."

That spirit of endeavour characterised Team GB. Their magnificent record in Tokyo was a world away from some of Britain's past humiliations, like the 1952 Helsinki games when we won a single gold in our

lowest ever medal haul.

There was just one gold in Atlanta in 1996, when Britain finished in 36th place – and that embarrassment prompted the use of the National Lottery to support promising athletes.

The £2.8 billion of Lottery funding for British Olympic and Paralympic sport, including £342 million for Team GB at Tokyo, shows it was money wisely spent.

After all the misery inflicted by Covid, Team GB gave the country another patriotic saga to savour, just like Gareth Southgate's England squad in its advance to the European Championship Final.

## Scots hailed for 'sensational' medal return in Tokyo

**SCOTTISH athletes have been hailed for a "sensational" Olympics display after returning with a record 14 medals.**

The Scots haul for Team GB included three gold and eight silver medals.

Stewart Harris, chief executive of sportscotland, said: "The performances of the Scots on Team GB have been sensational.

"Duncan Scott has confirmed himself as one of Team GB's greatest ever Olympians.

"But this success did not happen overnight. It is down to years of hard work and commitment."

In swimming, Scott became the first British athlete to win four medals at a single Olympics, winning gold and three silvers, while Kathleen Dawson also won a relay gold.

national coach Alan Lynn said: "Duncan's contribution to this team success must be celebrated."

In cycling, Jack Carlin and Katie Archibald each scooped two medals, the latter claiming a gold, while Neah Evans won a silver alongside her

cycling team-mate.

There were two medallists on the track, both in the 1500m, with Laura Muir claiming silver and Josh Kerr bronze.

Rowers Angus Groom and Harry Leask both returned with silver medals.

# Una Stubbs, actor in Sherlock and Till Death Us Do Part, dies aged 84

Una Stubbs, the actor whose long career took in *Summer Holiday*, *Worzel Gummidge*, *Till Death Us Do Part* and most recently *Steven Moffat's Sherlock*, has died aged 84.

In a statement her family said: "Mum passed away quietly today with her family around her, in Edinburgh. We ask for privacy and understanding at this most difficult and sad of times."

Her agent, Rebecca Blond, said Stubbs' career "was so extraordinarily varied" and she was desperately sad "to have lost not only a wonderful actress ... but also a wickedly funny, elegant, stylish, graceful, gracious, kind and constant friend."

## chorus girl

"She was also a highly respected and exhibited artist. We will miss her enormously and remember her always."

Stubbs grew up in the home counties and was a chorus girl and dancer before landing a role in the wholesome 1963 Cliff Richard film *Summer*

*Holiday*, which saw four lads caper through Europe on a London Routemaster bus. She played Sandy, one of three stranded singers.

It was her first major screen role, but her big breakthrough came in 1965 when she was cast as Rita, the married and even-tempered daughter of bigot Alf Garnett in the Johnny Speight sitcom *Till Death Us Do Part*. She played the part for a decade.

From 1979 to 1981 she starred as Aunt Sally, opposite Jon Pertwee, in the teatime ITV show *Worzel Gummidge*. Stubbs once reflected: "Aunt Sally was like Hitler, really. Horrible woman."

She became a perky team captain in the ITV charades show *Give Us A Clue*, battling a team led by the equally perky Lionel Blair on a weekly basis.

## varied career

Stubbs appeared never to be out of work and was a regular face on television, always popping up in dramas including *Heartbeat*,

*Midsomer Murders*, Agatha Christie's *Marple* and *Casualty*. In 2006 she was cast in *EastEnders* as Honey Mitchell's aunt Caroline.

Stubbs was an immensely likable figure

and had a long and strikingly varied career over more than 50 years. Her portrayal of Mrs Hudson in *Sherlock*, to Benedict Cumberbatch's Holmes and Martin Freeman's Watson, was

regarded as a triumph.

*Sherlock's* co-creator Mark Gatiss was among those to pay tribute: "It was one of the great joys of my life to work so closely with and to adore Una Stubbs. She was a

wonderful, wonderful woman and a great and serenely graceful actor. Mischief was in her blood. We were so blessed that she became our imperishable Mrs Hudson. Goodbye, darling."

Andrew said there was "no comment" when asked to respond to the civil suit.

Meanwhile, Dame Cressida Dick, the Metropolitan police commissioner and Britain's most senior police officer, said "no one is above the law" when questioned about the allegations of sexual assault.

Speaking on LBC radio on Thursday, Dick said: "I'm not going to talk about individuals, but what I can say is that I think what you're referring to is associated with Jeffrey Epstein, who I will talk about since he is deceased. And the position there is that we have had more than one allegation that

is connected with Mr Epstein and we have reviewed those, assessed those, and we have not opened an investigation."

She added that police had previously considered "is there evidence of a crime, is this the right jurisdiction for this to be dealt with, and is the

person against whom the crime is alleged still alive? We have concluded that there is no investigation for us to open and we haven't [opened one]."

Dick added that she believed it was the "right decision" after advice from the Crown Prosecution Service and

two reviews.

But, she said: "I'm aware that currently there is a lot more commentary in the media and an apparent civil court case going on in America and we will, of course, again review our position ... But, at the moment, there is no investigation."

## Suspect in Harry bike death 'was on phone'

HARRY DUNN's alleged killer could have been "distracted by her mobile phone" moments before the teenager's road-crash death, his family's lawyers claim.

They say relevant data from her phone is now missing and could have been deleted.

Harry, 19, was killed when a car crashed into his motorbike outside a US military base in Northamptonshire two years ago. The lawyers say Anne Sacoolas, 43, has been "evasive" about

her phone usage at the time of the collision.

They say no calls or texts were found on her Sim card on the day of the crash. But they allege call records were found on the days before and after.

The lawyers state: "Discovery thus far raises the possibility that Ms Sacoolas was distracted by her mobile telephone."

The claim is in court documents submitted as part of a damages case brought against Anne Sacoolas in the US.

## Jail for guard who freed prison lover

A FORMER prison officer has been jailed after falling in love with an inmate and helping him escape.

Erica Whittingham, 33, drove prisoner Michael Seddon away from HMP Sudbury, in Ashbourne, Derbyshire, after he left a dummy in his cell to fool guards. For the next six months, she remained in contact with her lover, meeting him in hotels and buying him gifts while he was on the run.

Whittingham, a former England badminton international, said she had fallen in love with the violent robber, who had been part of a gang that tied up and battered an elderly farmer.

She will now return to prison as an inmate rather than an officer having been jailed for three years at Derby Crown Court.

Seddon, from Bootle, Merseyside, was 22 when he was jailed in 2011 for his part in a

robbery. He escaped from HMP Sudbury in 2019. But he was arrested in Bournemouth in March 2020 having formed a new relationship with a different woman.

Seddon was previously handed an extra six months for escaping lawful custody.

Whittingham, of Uttoxeter, Staffordshire, pleaded guilty to harbouring an escaped prisoner and misconduct in public office.

# No ifs, no butties

## ■ Bacon butty tops poll of nation's most loved sandwiches

THE bacon butty has been voted the greatest thing since sliced bread – topping a poll to find the nation's favourite sandwich.

The filling of rashers, with a dollop of mustard, ketchup, brown sauce, or a combination of all three, was streaks ahead of the competition.

Traditional cheese, still a great favourite, came second in the poll. Egg mayonnaise was third.

It's not known how long the nation's favourite filling has been around, but the earliest literary reference to a "bacon sandwich" was made by Animal Farm author George Orwell in 1931.

And the Daily Express was first to refer to a "bacon sarnie" on August 21, 1986.

Although not exactly a health food, the bacon butty is considered an excellent hangover cure.

Despite bacon being the nation's top dog, the survey revealed Britons DO try to think about their diets when eating

our sandwiches.

A third of the country prefers brown bread, compared to 25 per cent who always opt for white.

As a nation Britons eat 12 billion sarnies year at a cost of £8 billion-plus. On average they eat four a week. A fifth of workers have one every day for lunch. A quarter of those are home-made.

But despite being sarnie experts, 46 per cent do not realize the dish was invented in Britain.

In 1762, John Montagu, 4th Earl of Sandwich, asked his chefs to put together his two favourite foods, roast beef and sliced bread, so he could eat while playing cards through the night.

The poll was for Travelodge to celebrate its 593rd hotel opening in Sandwich, Kent.

Spokeswoman Shakila Ahmed said: "We thought it would be fitting to celebrate the town's most famous resident."

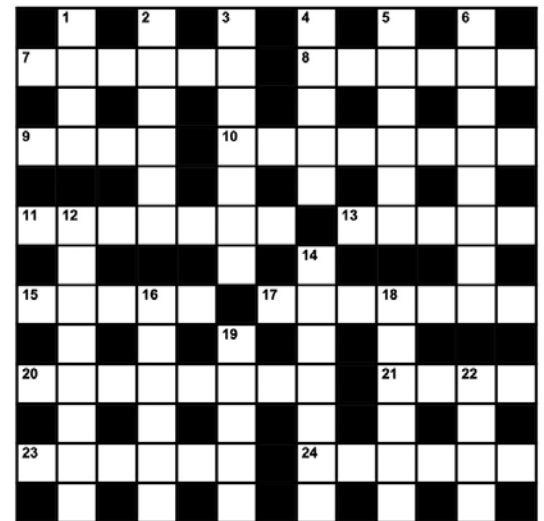

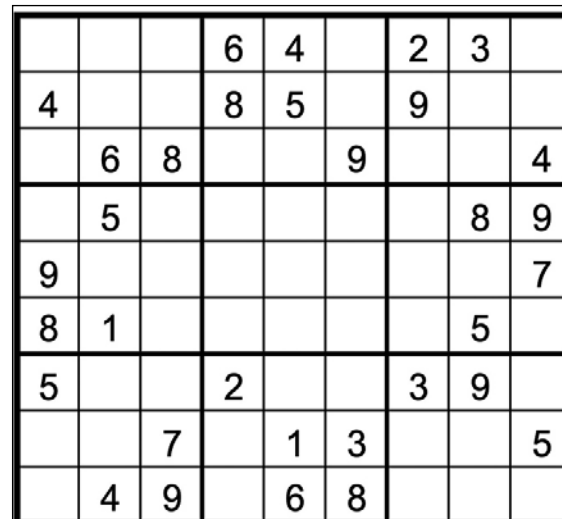

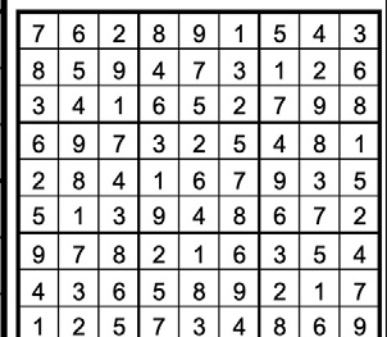

# Port Mahon: where the British influence lingers (apart from the food...)

■ Nick Stark takes a delicious detour into an historic former Royal Navy stronghold

IF, LIKE ME, you are a fan of Patrick O'Brien's/Master and Commander series, that superb 20-novel saga chronicling the life and adventures of Jack Aubrey and Steven Maturin in the service of the Royal Navy during the Napoleonic Wars, then the port of Mahon in Menorca needs no introduction.

I arrived here on Wednesday after a 32-hour sail from the west coast of Sardinia aboard my friend's 28 foot Bristol Channel Cutter. We had been in Sardinia a week, experiencing everything from the modest Italian family resort of Porto Aranci to the ultra-chic, megayacht (and megabucks) harbor of Porto Cervo. We had spent a couple of nights anchoring in deserted coves, enjoying morning swims in warm, crystal clear water with nary another boat in sight, en route to Alghero, a charming fortified town from where we set off across the Mediterranean to Mahon, our port of entry to Spain.

The passage itself was uneventful, we saw barely another boat and had hardly any wind, forcing us to motor until we pulled into Mahon around 4am and dropped anchor in a wonderfully sheltered cove just across from the main inlet which forms Port Mahon.

## tapas and pinchos

This is one of the longest natural harbors in the world and home to the British Mediterranean fleet for more than a century. Allegedly the birthplace of an oil, egg and vinegar/lemon juice-based condiment then known as Mahon-aise, but now known the world over as Mayonnaise. Food for thought...

Mahon itself is all about the old town, full of charming alleyways and plazas in the shadow of the ramparts and fortifications which the British, French and Spanish built over the years to maintain control of this vital strategic spot. These days the

vibe is less royal navy and more tapas and pinchos. But the houses, mostly built in a genteel Mediterranean style replete with carving arches and wrought iron balconies, set in narrow streets and cobblestoned alleys make it easy to close your eyes and imagine British navy men taking an evening stroll in their frock coats and waistcoats.

I enjoyed my three days here immensely, thanks mainly to the astonishing local food scene. The language, like the culture, is a mix of Spanish and Catalan, and the food is similar to what you'll find in Barcelona. Although the harbor front is jammed with enticing restaurants serving tapas, local seafood, paella and the like, if you venture up the hill into the old town your curiosity – and your appetite – will be richly rewarded. I began my evening at the Mercado de Pescados, a food court boasting one eye popping and mouthwatering dish after another. Traditional

delights like bocarones (fried anchovies) croquettas (croquettes stuffed bechamel sauce and, among other things, camembert cheese or jamon iberico) and abondigas con tomate (meatballs in a tomato sauce) rested cheek-by-jowl with razor clams, whitebait with olive and green peppers, small bowls of seafood paella, shot-sized glasses of

ice cold gazpacho, and anchovy, and brie doused with salsa pedro Ximenez resting invitingly atop a slice of fresh local bread. The price for these delights? Between 2 and 3 euros each.

## lively and chatty

Interspersed with the food stalls were vendors selling dozens of local and regional wines, few

of which I'd ever heard of, by the cup, glass or bottle, and of course a couple of local cerveza suppliers, selling a glass of caña (draft) for two euros or a bottle of the delicious Estrella Damn for 50 cents more.

Reluctantly leaving this cornucopia of delights, I wandered the nearby plazas and alleys, stopping here

During the day most of the places were empty save for a British or German family or two, but come nighttime, around 8.30pm, the place comes alive with local and vacationing Spaniards, filling the bars, cafes and restaurant in a lively and chatty scene that keeps going till the wee small hours.

I had other destinations in store so I left reluctantly Mahon (this time by plane) en route to Estapona in Andalusia...where hopefully more memories, and good food, lay in store.

## Magnificent Seventh....

■ Kenny launches great escape to establish a golden record

**CYCLIST JASON KENNY underlined his status as Britain's greatest Olympian of all time this week, sprinting clear of the field in the men's keirin pursuit to land a magnificent seventh gold medal.**

Kenny's seventh Olympic title was also his greatest – because earlier in the week it looked as if his time was up as a force of nature in the velodrome. And he unfurled his tactical masterpiece after the trauma of seeing his wife, Laura, crash heavily in the women's omnium scratch race as he warmed up on the rollers.

Like all true champions, he dug deep enough to dredge one more track for the greatest hits compilation.

Kenny said: "Before today I had all but given up.

"I was counting my career in days and races as opposed to years, but maybe I have bought myself more time now.

"This is special because it has been a really tough week and I've been really disappointed with my speed.

"For whatever reason, we have trained hard and tapered well but it hasn't

popped out the peak speed I was hoping for, so it is special to get a gold medal – just for turning up and racing hard."

Japan is the birthplace of the keirin, where riders follow a pacemaker on a derny – a motorised bicycle.

Just a few miles from where the race was developed more than 70 years ago for betting purposes, Kenny's own gamble paid the richest of dividends.

He jumped the field with the cleanest getaway on a bike since Chris Froome's 50-mile solo to win the Giro d'Italia three years ago, leaving Malaysia's Azizulhasni Awang and flying Dutchman Harrie Lavreysen gave chase to take silver and bronze, but they were half a street behind.

In a classy gesture at the medal ceremony, Awang and Lavreysen, whose bronze added to his pair of gold medals in the sprint competitions, lifted Kenny on their shoulders.

It was a nod to greatness, an acknowledgement that King Kenny is cycling royalty – seven gold medals, plus two silvers, spread over four Olympic Games.

IN THE past 13 months, Manchester City have played in four Wembley showpieces and the Champions League final.

And the only time they scored was when Harry Kane was on the pitch. Of course, for last season's Carabao Cup final the England captain was in a Tottenham team stunned by the sacking of Jose Mourinho - and even then Aymeric Laporte's late winner was the only goal City could manage in a series of tepid failures on the biggest stages.

Saturday's Community Shield defeat was no different to the two FA Cup semi-final exits and the 1-0 defeat in Portugal in the final game of last season.

Manchester City looked lost up front without a

top-class striker. This time it was Ferran Torres' turn to be the false nine but instead of playing in the hole he must have disappeared into it, so anonymous was his performance. Alongside him youngster Sam Edozie was rewarded for a strong pre-season.

After the game, Guardiola was adamant that there was nothing to suggest City could not go without a striker again this season.

But Leicester goalkeeper Kasper Schmeichel barely had a save to make. It also meant that when Nathan Ake bundled over Kelechi Iheanacho late in the game, the converted spot-kick was enough to earn Leicester their second trophy in three months.

JACK GREALISH is determined to prove he is worth his record £100 million fee - by helping Manchester City win the Champions League.

Grealish's self-belief matches his talent and he sees City's willingness to smash the British record as a compliment.

# Kepa shows a magic touch

## ■ Inspired late gamble works as keeper is shoot-out hero

**KEPA ARRIZABALAGA came out of the cold at Chelsea to win his team the UEFA Super Cup with his penalty shoot-out heroics against Villarreal on Wednesday night.**

The £71.6million keeper had been relegated to the No.2 spot at Stamford Bridge with Edouard Mendy manager Thomas Tuchel's first choice.

But as this final slipped towards a shoot-out after an extra-time stalemate, Tuchel threw on Kepa – and the Spaniard brilliantly saved from Aissa Mandi and then Raul Albiol to earn his side victory.

Hakim Ziyech had given Chelsea the lead in the first half, but Gerard Moreno had levelled for Unai Emery's side in a lively second half.

Tuchel, though, thanks to Kepa, had his second trophy of his Chelsea reign.

Chelsea had lost their three previous Super Cup finals, their only win in four attempts was in 1998 when they surprised Real Madrid in Monaco.

The Blues' Champions League triumph against Manchester City in Porto in May was against the odds.

But on Wednesday Tuchel's men were overwhelming favourites.

Villarreal – the "Yellow Submarine" – performed their own upset by beating Manchester United in a dramatic shoot-out to lift the Europa League in Gdansk.

Emery's side had frustrated United with a cagey game in May – but Chelsea were at them from the off. Ziyech's corner found Timo Werner at the far post, and his volley had to be turned away by Sergio Asenjo, and then skipper N'Golo Kante

fizzed a drive just wide.

The pressure paid off, as Marcos Alonso played in Kai Havertz, and his low cross was swept in by Ziyech for his third pre-season goal.

Villarreal were

sporadically lively on the break and Mendy had to be sharp to stop Boulaye Dia's low shot.

It got feisty, as Antonio Rudiger was booked for a thunderous tackle on Yeremi Pino – and then

Tuchel was cautioned for protesting.

Chelsea's assurance had disappeared – Mendy kicked the ball straight to Dia who played in Gerard Moreno – but the goalkeeper redeemed

himself, tipping the shot on to the post.

The goal arrived, as Rudiger sloppily gave the ball away, Gerard Moreno exchanged passes with Dia and slammed the ball home.



## Lukaku in; Abraham out....

**ROMELU LUKAKU'S club record move to Chelsea will clear the way for Tammy Abraham to quit the club.**

But the Chelsea striker's move to Arsenal is in doubt because the Blues would rather sell him abroad, with Roma leading the chase for the

young star.

Lukaku underwent the first part of his medical in Italy this week ahead of a £97.5million transfer from Inter Milan. He is expected in London to sign a five-year deal worth £200,000 a week and complete the rest of his checks.

The Belgium star could

play in his new club's Premier League opener at home to Crystal Palace on Saturday.

Inter wanted a replacement signed before giving Lukaku's transfer the green light, and they have now agreed terms with Roma's Edin Dzeko, formerly of Manchester City.
