BORIS VOWS TO KEEP 'EM COMING

THE Prime Minister has vowed to "get thousands more out" of Afghanistan as the military evacuation neared its deadline.

Boris Johnson said that troops will continue the Kabul airlift "right up to the last moment".

It comes after the final hopes of extending the evacuation deadline of August 31 were extinguished.

President Joe Biden this week rejected calls for US troops to stay any later to allow the multinational evacuation effort to continue.

The President refused to alter his deadline following menacing warnings from the Taliban that further evacuations "will not be allowed" after Tuesday. And, according to reports late this week, US troops have already started leaving.

Militants yesterday demanded an immediate end to Afghans being evacuated. But Mr Johnson and other world leaders urged the Taliban to allow "safe passage" for anyone wanting to leave Afghanistan after the deadline.

A virtual summit of the G7 group of nations, chaired by the Prime Minister, agreed a "road map" for dealing with the Taliban.

Following the meeting, the PM insisted the UK's airlift had been "extraordinary" around 9,226 people rescued in 57 flights amid "harrowing scenes" at Kabul Airport. Evacuated Afghan passengers were arriving at RAF Brize Norton, Oxfordshire. throughout the week and unaccompanied children were escorted by officials there.

'public order issues'

Mr Johnson said: "We will go on right up until the last moment that we can. But you have heard what the President of the United States has had to say, you have heard what the Taliban have said."

"You have got to understand the context in

which we're doing this.

"We're confident we can get thousands more out. But the situation at the airport is not getting any better. There are public order issues, it's harrowing scenes for those who are trying to get out, and it's tough for our military as well."

Along with French

President Emmanuel Macron and German Chancellor Angela Merkel, the PM had used the summit as a final attempt to try to persuade Mr Biden to allow the evacuation to be extended into September. But their call was rejected by the US President.

Despite the rebuff,

Mr Johnson said the summit had agreed a "joint approach" by the West for engaging with the expected new Taliban government in Kabul. The PM added: "What we have done today at the G7 is we have got together the leading Western powers and agreed not just a joint approach to dealing with

the evacuation, but also a road map for the way in which we're going to engage with the Taliban, as it probably will be a Taliban government in Kabul.

"The number one condition we're setting as G7 is that they have got to guarantee, right the way cont. on page 2, col. 4

Clock ticking in race to flee Taliban wrath

■ US and UK forces poised to pull out of Kabul within days

BRITISH SOLDIERS were locked into a desperate, chaotic scramble to get out thousands out of Kabul this week with time running out and renewed warnings from Taliban chiefs.

The deadline means UK and US troops now only have until next Tuesday to evacuate thousands attempting to flee Afghanistan's hardline rulers.

Some 2,000 were airlifted to the UK on Tuesday – a total of 9,226 since August 13. A flight carrying hundreds of evacuees arrived at RAF Brize Norton, Oxfordshire, in the early hours of Wednesday morning.

One of those Captain Abdul Muraal, 26, who served in the Afghan National Army for eight years, but had to cross several Taliban checkpoints to reach British troops at Kabul's airport.

The officer, who trained at the Defence Academy in Shrivenham, Swindon, and studied for a masters degree in military and security studies at King's College London, said: "We made

it through because of the British military. We are safe here at the air base and we will be safer still in the UK.

Resettle

"The route to safety was harsh, a humanitarian disaster. People waited many nights as the Taliban controlled the first gate. There was a lot of suffering."

Capt Muraal's immediate family have also been evacuated from Kabul because of the danger they face from the Taliban.

But with US and UK forces poised to pull out of Kabul in days, efforts to resettle those seeking to escape were gathering pace this week.

US and UK forces were said to be "doubling down" on efforts to get people away from an increasingly febrile atmosphere at the capital's Hamid Karzai Airport.

Washington rescued 10,400 people using 28 military jets, between Tuesday and Wednesday, bringing the US total to nearly 48,000 taken out of Kabul since the military withdrawal began on August 14.

With flights now leaving every 45 minutes, America's removal of evacuees is being stepped up by the day, the Pentagon said.

But on the ground outside the airport terminal, the terrified and anxious still trying to flee desperately sought information from news crews as they held on to dwindling hope.

Both the British Government and US forces warned they may simply not be able to evacuate all fleeing Afghans by August 31. Defence Secretary Ben Wallace said: "We have taken out 2,000 people in the last 24 hours and 10,000 since April.

supplies dwindling

"Our focus is to get as many people [as possible] out. But the scale of the challenge means that not everyone will get out. We are ruthlessly prioritising people.

"We want to stay longer if it is possible to do so. The two people with the biggest vote in the room are the US and the Taliban.

"[The Taliban] could

make life incredibly difficult. It will be a discussion between the US government and the Taliban. If America makes a decision that it doesn't want to extend, then we will be out by 31 August."

As Covid infections rose and medical supplies dwindled, the World Health Organisation expressed fears over those trying to escape – and the ability of bodies such as itself to ship in aid to an already

chaotic situation on the ground.

A senior WHO official said it now had only enough supplies in Afghanistan to last for a week after medical deliveries from abroad were blocked by restrictions at Kabul airport.

WHO regional director Ahmed Al-Mandhari said: "We rapidly distributed lifesaving supplies to health facilities and partners in Kabul, Kandahar and Kunduz, but WHO now only has enough supplies in country to last one week.

"Yesterday 70 per cent of these supplies were released to health facilities."

Meanwhile, rebel fighters from the National Resistance Front of Afghanistan, based in the Panjshir Valley, north of Kabul, have appealed for world support to fight the Taliban if peace moves fail.

through, through August 31 and beyond, safe passage for those who want to come out.

"Some will say that they don't accept that and some, I hope, will see the sense of that, because the G7 has very considerable leverage – economic, diplomatic and political.

"I am totally realistic about the Taliban and I don't think that anybody is going to pretend that this is anything other than a very difficult situation.

"But that doesn't mean that we should ignore the leverage that we have. But when it comes to engaging with the Taliban, and engaging with the government in Afghanistan, whatever its exact composition, the G7 has huge leverage."

The US President's press secretary Jen

Psaki said: "The President conveyed that our mission in Kabul will end based on the achievement of our objectives. He confirmed we are currently on pace to finish by August 31.

"He also made clear that with each day of operations on the ground, we have added risk to our troops with increasing threats from Isis-K, and that completion of the mission by August 31 depends on continued co-ordination the Taliban, including continued access for evacuees to the airport. President asked the Pentagon and State Department for contingency plans to adjust the timeline should that become necessary."

Earlier, the Taliban had said it would not accept foreign troops remaining in Afghanistan past the end of the month. Spokesman Zabihullah Mujahid said: "August 31 is the time given and after that it's something that is against the agreement. All people should be removed prior to that date. After that we do not allow them... We'll take a different stance."

Foreign Secretary Dominic Raab told an MPs briefing that the UK would like to see a functioning airport in Kabul after the troops' departure. This could allow Afghans to leave the country on commercial flights if they wanted.

He said: "If we want to do this in a more managed way, what we really could do with is the Taliban being able to run a functional airport in Kabul. I'm sure there will be various neighbouring countries that will want to see if they can help them keep that airport open."

Dead at eighty, Charlie Watts, Rolling Stones legend who laid down the beat of a generation

"Charlie was a cherished husband, father and grandfather and also, as a member of the Rolling Stones, one of the greatest drummers of his generation."

ROLLING Stone Charlie regarded many as rock's greatest drummer, has died, aged

music legend passed away just weeks after pulling out of the band's scheduled US tour following an emergency heart operation. The surgery was said to have been "completely successful" and Charlie was prescribed rest and recuperation.

His spokesman announced vesterday: "It is with immense sadness that we announce the death of our beloved Charlie Watts. He passed away peacefully at a London hospital earlier today surrounded by his family.

"Charlie was cherished husband, father grandfather and also, as a member of the

Rolling Stones, one of the greatest drummers of his generation."

He leaves his wife of 56 years Shirley, their daughter Seraphina, 53, and his granddaughter Charlotte.

Beatles drummer Ringo Starr posted a tribute on Twitter, along with a photo of the two together. He wrote: "God bless Charlie Watts, we're going to miss you man, peace and love to the family, Ringo."

In a social media video, Sir Paul McCartney sent love to the star's family and condolences to his bandmates.

"It'll be a huge blow to them because Charlie was a rock, and a fantastic drummer, steady as a rock," he added "Love you Charlie, I've always you, beautiful loved

Sir Elton John added:

Watts was the ultimate drummer. The most stylish of men, and such brilliant company. My deepest condolences to Shirley, Seraphina and Charlotte. And, of course, The Rolling Stones." After pulling out of the 13-date No Filter tour earlier this month, Watts

He did not want his recovery to delay the tour, which was set to visit Dallas, Atlanta, Los Angeles and Las Vegas.

"I am working hard to get fully fit but I have today accepted, on the advice of the experts, that this will take a while," he said.

"After all the fans' suffering caused by Covid I really do not want the many fans who have been holding tickets for this tour to be disappointed by another postponement or cancellation. I have therefore asked great friend Steve Jordan to stand in."

Watts was one of only three Stones - with Mick Jagger and Keith Richards - to have been with the band throughout their nearly 60-year history, and to have featured on all of their studio albums.

His recent illness meant it was the first time he had missed a tour since he first joined Jagger, Richards and Brian Jones to form a new band in 1963.

Watts was treated for throat cancer at London's Royal Marsden Hospital in 2004 and given the allclear after a four-month battle with the disease, including six weeks of intensive radiotherapy. Following his recovery,

the band began work on their 22nd studio album A Bigger Bang.

But this time, there was no way back for the man famous for never missing a beat.

'mid-life crisis'

Having left art college to start a career as a graphic designer, Watts was integral to the Rolling Stones from the earliest days, not only as drummer but designing their record sleeves and their tour stages.

while But bandmates hit headlines for their "sex, drugs and rock 'n' roll" lifestyle during decades of performing, Charlie was more noted for his devotion to his family and his stylish sense of dress.

Remaining faithful to wife Shirley, who he had met before the band found fame, on one occasion when the band was invited to the Playboy Mansion during a 1972 American Tour he reportedly ignored the Bunny Girls and headed to Hugh Hefner's games

He once admitted: "I've never filled the stereotype of the rock star. Back in the 70s, Bill Wyman and I decided to grow beards and the effort left us exhausted."

Watts admitted to a short-lived alcohol and drug problem in the early 1980s. He said: "I think it was a mid-life crisis. All I know is that I became totally another person around 1983 and came out of it about 1986. I nearly lost my wife over my behaviour.

"It got so bad that even Keith Richards, bless him, told me to get it together."

Famously, in the mid-1980s, while on tour, he got a phone call in his hotel room in the middle of the night from a worsefor-wear Mick Jagger who demanded: "Where's my drummer?"

Watts reportedly got up, shaved, dressed in a suit, put on a tie and freshly shined shoes, went downstairs and punched Jagger in the face, telling him: "Don't ever call me your drummer again. You're my ****ing singer."

Jonathan Pryce takes over the reins as Prince Philip in the Crown – and looks every inch the royal patriarch in this sneak peek.

The Game of thrones star, 74, is seen trying one of the late Duke of Edinburgh's greatest passions, carriage driving.

Jonathan will play Philip for the next two seasons of the hit Netflix drama about the Royal Family. He takes on the role for the fifth and sixth series, following in the footsteps of Matt Smith, 38, and Tobias Menzies, 47, who played Philip in the earlier seasons.

Drama

These first pictures from the set of the fifth season also show James Murray as Prince Andrew and Claudia Harrison portraying Princess Anne.

James is best known

Royals feared Meghan might 'create spectacle' during Philip's funeral

ROYALS were fearful the Duchess of Sussex would create a "spectacle" at Prince Philip's funeral and later were "quietly pleased" she did not attend, it was claimed this week.

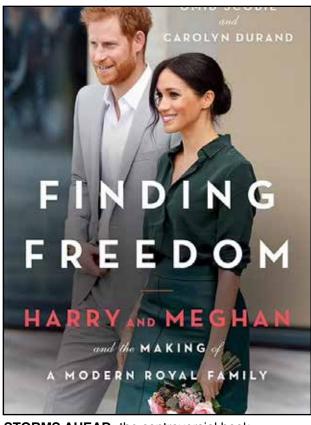
An updated version of Meghan and Harry's biography Finding Freedom says some Royals feared her presence would foster a "circus" at April's funeral.

However Meghan, 40, did not travel with Prince Harry, 36, from their £11million Californian home to the funeral at Windsor Castle.

Finding Freedom authors Carolyn Durand and Omid Scobie say Meghan, heavily pregnant with her second child Lilibet, made "every effort" to pay her respects to Philip in person, but was under doctor's orders.

They also claim several royals were "understood to have been quietly pleased", as they "didn't want a circus" or "the duchess creating a spectacle".

The book also claims Prince William was "furious" about Harry and Meghan's allegation of racism "being discussed in the public domain" after the couple spoke to Oprah Winfrey. The Sussexes told the chat show host there were

"several conversations" in the Royal Family about how dark their son Archie would be.

They would not reveal who said it but ruled out the Queen and Philip.

A friend of Meghan's said the interview was "cathartic" and the authors say: "All the things she had kept to herself or been too afraid to say she felt safe to finally share. It was liberating."

Mr Scobie and Ms Durand understand the Queen and other royals knew nothing about the Oprah interview until it was announced publicly.

A friend of the Sussexes is said to have revealed: "It felt like certain individuals at the Palace were doing their very best to undermine and discredit anything they worried the couple may or may not say during the interview."

The authors also say Harry was refused permission to have poppies laid on Remembrance Sunday last year because he was no longer a "frontline royal".

Rotten luck... Johnny loses TV duel over Pistols songs

JOHNNY Rotten has lost his High Court fight with two other Sex Pistols over the use of their songs in a Disney TV miniseries about

The punk band's ex drummer Paul Cook and guitarist Steve Jones sued him after he tried to halt the use of their back catalogue in Danny Boyle-directed Pistol.

During a weeklong hearing, former frontman Rotten - who used to get spat upon on stage - branded the biopic: "The most disrespectful s*** I've ever had to endure."

But this week he lost the case after Judge Sir Anthony Mann ruled

Cook and Jones could invoke "majority voting rules" under the terms of a 1998 Band Member Agreement (BMA).

Rotten, real name John Lydon, had branded that "some kind of slave labour...like a total trap or prison".

'unreasonable'

Jones, in turn, told the court he considered Rotten to be a "total

Former band member Glen Matlock and relatives of the late Sid Vicious backed Cook and Jones. Sir Anthony "had noted Rotten actually signed away his power to control the use of music rights" to publishing and music firms.

The 65-year-old had limited approval rights "which could be overridden if he was being unreasonable".

After the judge's ruling, Jones and Cook, also both 65, said: "It has not been a pleasant experience, but we believe it was necessary to allow us to move forward and hopefully work together in future with better relations.'

Six-parter Pistol, due on screens next year, is based on a best-selling 2016 memoir by Jones called Lonely Boy.

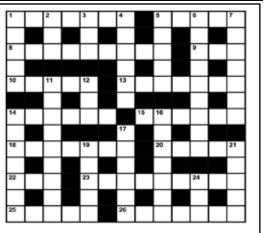

European Travel: still a patchwork of regulations

Nick Stark takes stock after a one-month, four country trip to Europe

ALTHOUGH global travel in the age of Covid has become far easier since widespread the availability of vaccines, patchwork national laws and requirements still make a multi-country trip a challenge.

Having just returned from a four-country jaunt to Europe it seems useful to give a placeby-place guide to some of the most popular destinations: the UK, Italy, Spain and France.

I started my trip in late July flying from LAX to Rome. I was booked onto American Airlines who have outsourced paperwork requirements to an app company called Verifly. The company blurb claims their product is the industry's 'most widely adopted health passport', although all that really seems to mean is that you can use it on American and their partner airlines, Aer Lingus, Alaska Airlines, British Airways, Iberia, Japan Air Lines, and Qantas. To be fair their interface

simple was and required a copy of my vaccination certificate, a negative Covid test taken not more than 24 hours before arrival in Rome, and a completed passenger digital locator form, the EUwide standard which gave the authorities a way to find you if it discovered you been exposed. had system worked well in that at check in I simply had to show the app with its completed 'ready for travel' section bearing a photo of myself. My only gripe is that the description of me was a generic 'confident traveler'. Seems like that was written by a nine year old.

Arriving at Rome was simply a matter of going through passport control. Since the flight was a 'Covid flight', the Italian authorities trusted the airline to do all the appropriate screening. The airline, in turn, had delegated it to the app. All in all, a reasonable public private partnership.

Going from Italy to

Spain was a different matter. I was arriving by a private sailboat, sailing on a 30-odd hour passage from Sardinia to Menorca. I was required by the Spanish government to complete declaration being symptomatic, upload a copy of my vaccine certificate and provide my location within Spain. This I had to do within 48 hours before arrival. Simple, right? Not really, because the Spaniards have introduced these requirements without the infrastructure to enforce it. Arriving at Menorca harbor in good time to 'check in' with the local customs we found no sign of where the customs building was. When we did find it, we were brusquely informed that we couldn't tie our boat, even briefly, to the harbor wall in front of the building where we must, by law, present ourselves. We called all the local marinas in the harbor and none of them could accommodate us, not

even for an hour or two in a so-called 'transient berth', something almost every other harbor I have ever been has at least a few of. So we were forced to drop anchor in the main channel of the harbor and dinghy over to the office. Of course we couldn't leave our dinghy in front of the office either, we had to tie up half a mile away and walk in 100 degree heat to the office.... which was closed. At 2.15pm. A sign outside notified us that their reduced hours were 9am to noon each day. Trouble is, if we returned the following day, we'd be past the 48-hour window for the notification we had completed.

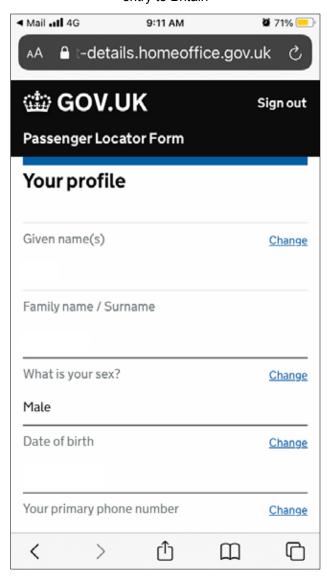
A longtime friend I later visited, who has lived in Spain for 30 years, has a standard response to this kind of everyday frustration; he shrugs his shoulders and mutters 'that's Spain'. So that's what I did. Since my next flight was an internal Spanish one I saw no bad outcome to simply staying in the country until my next departure to Marseilles, in five days.

The French were far more efficient, both in their requirements and their infrastructure. I needed to complete a form online showing my full vaccination status and a passenger locator form so I could contacted. Into France with no problem for four glorious days staying at a friend's two hundred year-old stone farmhouse in Provence.

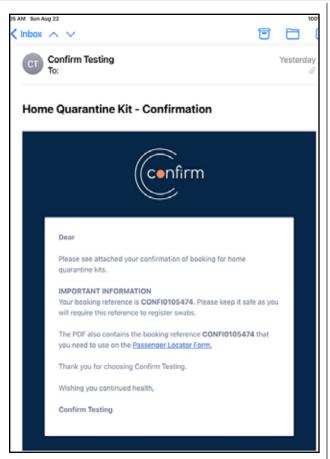

So I booked a test I would never take, for the not-cheap price of £59, which was to be sent to my hotel to self-administered.

England captain Harry Kane says he will be "staying at Tottenham this summer" and is "100% focused on helping the team achieve success".

Manchester City were keen to sign Kane, who believed he had a gentleman's agreement with chairman Daniel Levy to leave Spurs this summer.

But Levy has refused to enter into negotiations for the striker, 28.

Kane played his first game of the season on Sunday, coming on as a substitute in the 1-0 win over Wolves.

from the Spurs fans on Sunday and to read some of the messages of support I've had in the last few weeks," he wrote in a social media post on Wednesday.

"I will be staying at Tottenham this summer and will be 100% focused on helping the team achieve success."

Spurs boss Nuno Espirito Santo said it was "fantastic news" to see Kane's immediate future resolved.

"I think since Harry joined us he has been working so this is what we value. His attitude in training has been excellent," said the Portuguese.

"It's finished, Harry is going to be with us."

Asked whether he was concerned about the word "summer" in Kane's statement, and if the issue was likely to arise again in the January transfer window, Nuno replied: "I'm not worried at all. It's day by day.

"We are all very happy. [He is] one of the best players in the world. Delighted to have one more option for the season ahead of us."

Kane, whose contract at Spurs runs to 2024, has reaffirmed his commitment to the club just six days before the

Pep announces he will step down from City job in 2023

Pep Guardiola has said that he will leave Manchester City when his contract runs out in 2023 - and hopes to manage a national team.

The 50-year-old, who joined City in 2016, plans to "have a break" after seven years at the helm of the Premier League club.

"I think I'm going to have a stop. I'm going to have to take a break, see what we've done," Guardiola said. "Next step will be a national team, if there is a possibility."

Speaking at an online event organized by Brazilian financial services company XP Investimentos, and quoted by ESPN Brasil, he added: "I would like to train a South American (team), European, playing a Copa America, I want to have that experience."

The news will come as a blow to City on the

same day their chances of signing Tottenham striker Harry Kane came to an end, with the England captain confirming he will be staying put this summer.

Guardiola, who has won three Premier League titles, one FA Cup and four successive League Cups with City, took a 12-month break from management after leaving Barcelona in 2012 before joining Bayern Munich.
