## ■ PM tells families of fallen heroes: Your suffering was not in vain

**BRITAIN'S 20-year mission in Afghanistan ended this week as the last of the troops who served in the war on terror arrived safely home.**

The RAF's final flights out of Kabul landed in the UK on Monday, bringing to a close the long campaign which cost the lives of 457 brave soldiers.

In a video message, Boris Johnson said that their sacrifice had kept Britain safe.

The Prime Minister told their families: "Your suffering and your hardship were not in vain."

"It was no accident that there has been no terrorist attack launched against Britain or any other western country from Afghanistan in the last 20 years."

Mr Johnson's heart-felt words came as the last British troops involved in the biggest evacuation since the Second World War arrived back home.

All throughout the day, exhausted soldiers, diplomats and officials were touching down in the UK after a frantic two-week mission that airlifted 15,000 people to safety.

In all, more than 100 RAF flights took place,

carrying 5,000 Britons and their families, and more than 8,000 Afghan former UK staff and families.

About 2,200 children were taken to safety, with the youngest just one day old.

The arrivals came amid heightened security fears in Kabul. The US ordered the evacuation of people surrounding Kabul airport because of a "credible" threat from ISIS-K.

### 'colossal exertions'

US forces left Afghanistan the next day after the Taliban refused to extend the deadline for withdrawal.

Up to 150 Britons and as many as 1,100 eligible Afghans were stranded in the UK's hasty evacuation mission.

Mr Johnson admitted he would not have wished to leave Afghanistan this way, but pledged not to abandon those left behind.

The PM hailed British troops for their "colossal exertions" as the operation drew to a close.

Mr Johnson said it was at the "darkest and most difficult moments" that the UK's Armed Forces "have always performed their greatest feats".

Military planes landed back at RAF Brize Norton in Oxfordshire on Monday with a small number of military personnel on other aircraft arriving 24 hours later.

Ambassador to Afghanistan Sir Laurie Bristow was greeted by Sir Philip Barton, the Permanent Under-Secretary of the Foreign Office, as he exited a plane at the air station.

Mr Johnson said: "It is the culmination of a mission unlike anything we have seen in our lifetimes. UK troops and officials have worked round the clock to a remorseless deadline."

"In harrowing conditions, they have expended all the patience and care and thought they possess to help people in fear for their lives."

"They have seen at first hand barbaric terrorist

attacks on the queues of people they were trying to comfort as well as on our American friends.

"They did not flinch. They kept calm. They got on with the job."

"It is thanks to their colossal exertions that this country has now processed, checked, vetted and airlifted more than 15,000 people to safety in less than two weeks." Mr Johnson said the Afghans who have arrived in the UK "have proved their loyalty to this country beyond doubt".

He added: "Interpreting, guiding, helping to keep our people safe for two decades in a series of

Afghan operations.

"That has seen 150,000 serving men and women do a tour of duty and which has cost the lives of 457 troops and injured thousands more."

### 'global terror'

The PM said he wanted to "speak directly" to troops and the families of those killed and injured.

He added: "Thanks to the devotion of British troops and aid workers and diplomats, we have helped to educate 3.6 million girls."

"And whatever the future may hold for Afghanistan, they will have that gift for the rest of their lives, a gift they will pass on to their

daughters as well as their sons."

The PM said the Taliban must ensure safe passage for those who wish to leave the country, respect the rights of women and girls and prevent Afghanistan from "becoming an incubator for global terror" if it wants diplomatic recognition.

He said: "We will use every lever we have – political, economic, diplomatic – to help the people of Afghanistan and to protect our own country from harm."

Vice Admiral Ben Key, the Chief of Joint Operations who commanded the

# COVID: rising concern as latest Covid variant arrives

SCIENTISTS are closely monitoring what is thought to be the most mutated Covid-19 variant yet.

Already in the UK, the variant – called C.1.2 – carries some mutations seen in other variants which have been linked to increased transmissibility.

A study found the new variant “has between 44-59 mutations away from the original” form of the virus identified in Wuhan, China.

It also has an unusually high rate of around 42 mutations per year – almost double the average for others.

C.1.2 was first picked up in South Africa in May and around 100 cases have been detected globally, including at least one in the UK.

## isolated cases

Dr Richard Lessells, an infectious diseases specialist in South Africa, said his team had flagged it to the World Health Organisation.

He said: “This new variant is just something that we’re keeping a very close watch on and we’re doing some work in the laboratory to understand how this new variant behaves and what properties it might have.”

The new strain is descended from the C.1 variant, which was

circulating in the country during its first wave of infections.

Dr Lessells said the C.1.2 type did not appear to be taking hold and was being monitored, rather than having the more serious classifications of a variant “of concern” or “under investigation”.

The Delta variant is dominant in South Africa, accounting for more than 90 per cent of Covid cases.

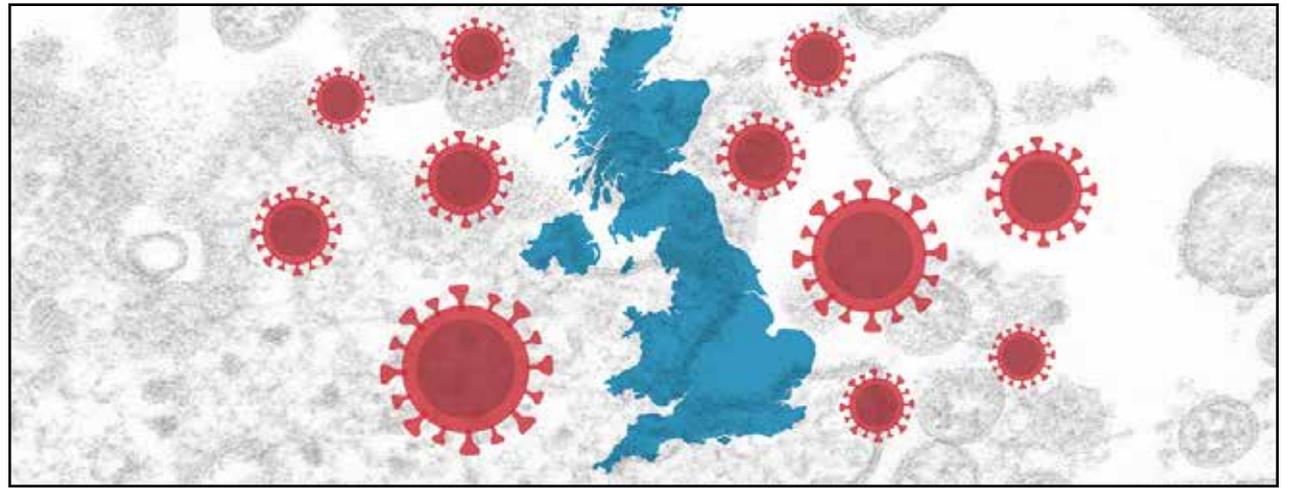
Asked about the risk of C.1.2 escaping vaccine immunity, he said the jabs should still prevent severe disease. He said: “Looking at the pattern of mutations in this new variant, it doesn’t look different enough from what we’ve seen already that that’s likely to change.”

Dr Lessells also revealed that isolated cases have been found in countries including the UK, Switzerland and China.

Public Health England added the variant to a list of those it was monitoring in early July.

PHE declined to comment and did not confirm how many cases of C.1.2 had been found here.

The study was published on the preprint server medRxiv. Preprints are preliminary reports of work that have not been



certified by peer review. Meanwhile, 26,476

cases of Covid-19 were confirmed in the UK and

48 deaths. Due to the bank holiday, the figures

did not include data for Wales.

## PANIC IN THE SKIES: BA to ditch traditional drinks trolley

BRITISH Airways is ditching its traditional drinks trolley in favor of a “buy before you fly” system.

It means passengers on short-haul economy routes must select what they want to drink – and how much – at least 12 hours earlier.

While staff will still wheel a trolley down the aisle, it will only contain complimentary water and snacks.

BA said the changes were made as it is trying to cut down on aircraft weight.

But travellers have criticised the move.

Passenger Hellen Madden tweeted: “BA, can you explain why there is no onboard trolley service on this three-hour flight to Greece?”

Another wrote: “In the 1960s, the air stewards used to carve roast beef for you. Now you can’t even get a glass of wine without a kerfuffle.”

One traveller said: “BA’s boast of being the world’s favorite airline now seems pretty hollow.”

Only passengers on longer flights are currently able to order extra drinks via a smartphone app.

Former BA stewardess Amanda Epe, who wrote

a book on her experiences, said: “You can never replace people with apps. That’s why we call it service – because of the human touch. With all the profit in the airline industry, it’s not right to do this. They seem to be ditching tradition for no good reason.”

A BA spokesman said the airline expects to roll out the in-seat ordering option to more of its other routes.

He said: “The suggestion we have taken away service is not true. We have added more complimentary products on board.”

**A Conservative MSP has apologised after suggesting that Scottish First Minister Nicola Sturgeon was anti-English.**

North East Scotland MSP Tess White heckled the first minister while she was answering a question at Holyrood about anti-Irish prejudice.

Amid an angry response from SNP MSPs, Ms Sturgeon complained to the presiding officer that she was “deeply offended” by the remark by Ms White.

Ms White later apologised and said her comments were “over the line”.

## City types ditch the smoke for the sea

RECORD numbers of Londoners are leaving the city for the country and coast, figures show.

In the first six months of this year, 61,830 London dwellers moved out.

This has led to some villages waking up to a London invasion, with up to two-thirds of property sales going to buyers from the capital.

First-time buyers are not moving far, averaging just 22 miles from the capital according to the data by estate agents Hamptons.

But others, particularly buy-to-let landlords, are snapping up properties an average of 109 miles away, where prices are more affordable and demand for rental property is rising.

It is the biggest migration from inside to outside the capital since Hamptons started monitoring it in 2006.

And it follows predictions that London's population is about to fall for the first time in 30 years.

The average spent on out-of-town homes is £313,300. This includes first-time buyers and existing owners moving out, who make up 49,470 of the total.

The rest is buy-to-let investors and second home and holiday home buyers, with Margate, Great Yarmouth and Whitstable in Kent among the top choices.

Surrey, Hertfordshire and Kent are the most popular locations for Londoners.

Only eight per cent of movers have gone outside the South-east and East of England and are usually buy-to-let or other investors, said Hamptons.

In Tandridge, Surrey, which includes Caterham and Oxted, 67 per cent of buyers in the first half of this year came from London.

## Coining it: Fleabag creator raking in £250k a week

■ Brilliance rewarded as Phoebe Waller-Bridge finds fortune to go along with her fame

PHOEBE Waller-Bridge is laughing all the way to the bank as she rakes in more than £253,000 a week, her company accounts show.

TV's *Fleabag* creator, 36, who also wrote *Killing Eve*, ended up with a turnover of £22,040,744 in less than two years.

Her PMWB company earned £10,692,453 from April to November last year and £11,348,291 in 12 months to March 31, 2020.

The profit before tax was £7.34million, compared with £8.3million in the previous accounting period.

Two years ago, PMWB had a respectable bottom line of £515,864, but now it has £6.9million of cash reserves and nearly £2million in investments. Accounts filed to Companies House this week show Phoebe paid herself a dividend of £1.4million

from her firm.

Phoebe was head writer and executive producer for worldwide TV hit *Killing Eve*, which stars Jodie Comer.

She has also appeared in the film *Solo: A Star Wars Story* and helped pen the screenplay of the upcoming James Bond film *No Time To Die*, which is due to be released on September 30.

### 'razor-sharp instincts'

Tragic-comic *Fleabag* won Phoebe a best female comedy performance British Academy Television Award, three Primetime Emmys and two Golden Globes. Last year *Time* magazine named her one of the 100 most influential people in the world.

After Phoebe picked up her Emmys in the US, she was photographed smoking a cigarette and surrounded by her gongs in a lounge chair.

## Brexit: food and drink exports to EU suffer 'disastrous' decline

■ First-half sales fall £2bn, says industry body, as barriers are compounded by staff shortages

Exports of food and drink to the EU have suffered a "disastrous" decline in the first half of the year because of Brexit trade barriers, with sales of beef and cheese hit hardest.

Food and Drink Federation (FDF) producers lost £2bn in sales, a dent in revenue that could not be compensated for by the increased sales in the same period to non-EU countries including China and Australia.

Dominic Goudie, head

of international trade at the FDF, said: "The return to growth in exports to non-EU markets is welcome news, but it doesn't make up for the disastrous loss of £2bn in sales to the EU. It clearly demonstrates the serious difficulties manufacturers in our industry continue to face and the urgent need for additional specialist support."

He said the difficulties now facing British food and

# Set in stone: Avebury named as Britain's best place to live

A QUIANT village in Wiltshire has been voted the best place to live in the UK.

Avebury, which has the largest stone circle in the world, came top in the Which? survey of Britain's best towns and villages.

Avebury also boasts a 16th century manor house and garden managed by the National Trust, the Alexander Keiller Museum displaying local archaeological finds and a picturesque pub with a thatched roof.

It was given five stars for its scenery and tourist attractions and four for peace and quiet, attractiveness and value for money.

It pipped Castle Combe, also in Wiltshire, and Wells, in Somerset, which were joint second in the poll.

## Moated

Castle Combe, with its pretty houses and babbling brook, has appeared in several films, including *Downton*

Abbey and *Warhorse*.

Wells, which is the UK's smallest city, thanks to its cathedral, is known for its moated Bishop's Palace and Vicars' Close, a medieval street inhabited by clergy. It received five stars for its tourist attractions and four stars in every other category.

The Victorian model village of Saltaire, West Yorks, came fourth. The Unesco World Heritage Site was given four stars for tourist attractions, shopping, peace and quiet and value for money. It was built for the workers of the mill in the 19th century.

The mill now houses a diner, galleries and bookshop.

Castleton in Derbyshire and Ironbridge in Shropshire were joint fifth. Both got four stars for attractiveness.

Castleton was given five stars for scenery while Ironbridge got the top rating for tourist attractions. The best scoring pace in

Scotland was Aberfeldy in Perthshire, with a destination score of 82 per cent.

The small market town was first made famous by Robert Burns. Today though, it is better known for being Scotland's first Fairtrade town, and for its many attractions including The Watermill, containing a book shop, gallery and café, and Dewar's Aberfeldy Distillery. The town received five stars for scenery and four stars for peace and quiet.

The results were based on responses from 2,710 online panellists.

Rory Boland, Which? travel editor said: "The UK is full of towns and villages bursting with character and history, many of which are relatively quiet and unspoilt, making them perfect for a day trip or holiday."

"There are a wealth of brilliant towns and villages to explore across the country."

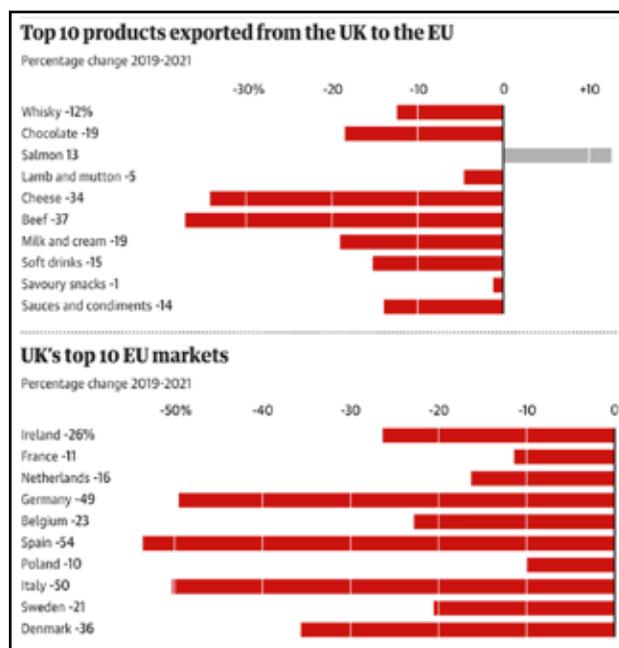

drinks manufacturers and farmers were compounded by the lorry driver and warehouse workers shortages, which were choking the supply chain.

"At the same time, we are seeing labour shortages across the UK's farm-to-fork food and drink supply chain, resulting in empty spaces on UK shop shelves, disruptions to deliveries and decreased production," Goudie said. "Unless steps are taken to address these issues, the ability of businesses to fulfil vital



export orders will be impacted."

The biggest falls in sales to the EU have been in dairy and meat: beef

exports were down 37%, cheese down 34% and milk and cream down 19% in the first half of 2021 compared with the

equivalent six months in 2019.

Exports to nearly all EU member states fell

significantly, including a loss of more than £500m in sales to Ireland, while sales to Germany, Spain

and Italy were each down around a half since the first half of 2019.

But year-on-year exports of salmon and whisky, two of Scotland's flagship products, were up 27% and 20%.

Exporters have struggled with the extra paperwork and administrative costs that came into force on 1 January 2021, with companies required to document their products for trading standards, customs and health reasons before entry to the EU.

Food exporters are particularly exposed because of the physical sanitary and phytosanitary (SPS) checks that were not necessary before Brexit, with lorries facing partial or full unloads in Calais and other ports if any of the paperwork is missing.

Industry leaders said predictions that some companies would simply move their export production operations to an EU country are being realized.

evacuation mission, admitted there was a "sense of sadness" that not all could be saved.

He said: "We recognise and pay testament to the achievement of everything that has been

achieved by coalition forces, but particularly the British contingent, over the last two weeks.

"In the end, we know that there are some really sad stories of people who have desperately tried to leave that we have, no matter how hard our efforts, been unsuccessful in evacuating."

## Novel sentence: Uproar as judge tells extremist to read Jane Austen

The Attorney General has been asked to review a sentence given to a right-wing extremist for a terrorism offence.

Ben John was handed the 24-month sentence, suspended for two years, at Leicester Crown Court on Tuesday.

According to media reports, the 21-year-old was also ordered by a judge to read classic novels such as *Pride and Prejudice* and to return to court in January.

In a letter, campaign group Hope Not Hate asked for a review of the case.

John, of Addison Drive, Lincoln, was found guilty of possessing a record of information likely to be useful to a person committing or preparing an act of terrorism on 12 August.

During the sentencing hearing, Judge Timothy Spencer QC is reported to have asked John: "Have you read Dickens? Austen?"

"Start with *Pride and Prejudice* and Dickens's *A Tale Of Two Cities*. Shakespeare's *Twelfth Night*. Think about Hardy. Think about Trollope."

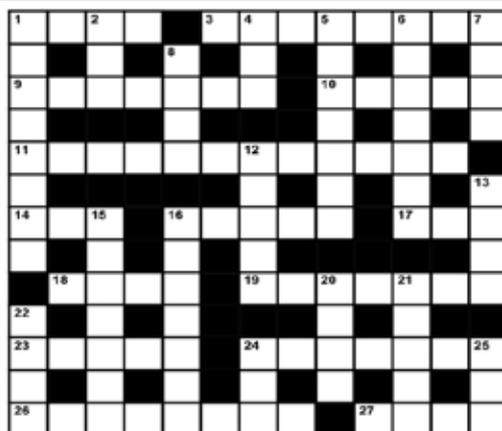

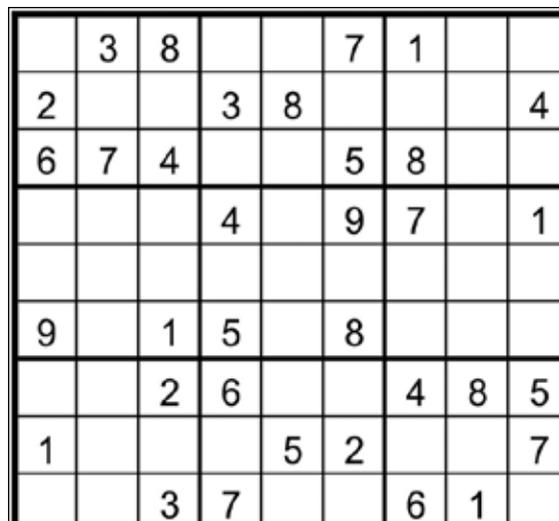

broke the deadlock before setting up the second for Kane.

Southgate will have been delighted with the manner in which England carved out their first goal, Rice winning possession before a slick link between Grealish and Mount set up Sterling for a composed finish. It was exactly what he wants from those players.

England now face Andorra at home on Sunday before travelling to Poland for what is likely to be the toughest game on the road to Qatar in Warsaw next Wednesday - but it is already hard to see who can stop Southgate's side taking their place at next winter's World Cup.

# England skipper wants to remain on top of the world

**CRICKET: JOE ROOT says reaching the top of the world rankings will not deflect his focus from the job in hand - beating India this summer.**

Six centuries this year and three in a row against India proved enough to lift the England captain above Kane Williamson in the latest ICC Test rankings for batsmen.

But Root insisted that while reaching the summit for the first time since 2015 was "nice", it would mean little if England were defeated by India.

"It's a nice thing to hear but my main focus is to try to keep scoring runs in this series and get us across the line in this

series," Root said.

"As nice as it is, though, there is still so much hard work to do and my focus doesn't change.

"It is all about continuing getting better, scoring runs and to keep setting up games to try and win Test matches."

Root has reached No.1 for the third time in his career but he said he hopes even better form is to come, starting at The Oval this week, where England and India both aim to strike a crucial blow in a series that is perfectly poised at 1-1 with two Tests remaining.

"Hopefully the form of my life is still to come," said Root. "However, I

certainly feel very good at the minute.

"I know that I have to remain focused and diligent in the preparation that I am doing around and behind the games. I also have to try to keep giving myself the very best chance to keep dragging out some big scores."

Root confirmed that Moeen Ali will be his vice-captain at The Oval in the absence of Jos Buttler, who is taking time out to be present at the birth of his second child.

"Moeen is a natural

leader," said Root. "He possesses a brilliant cricketing brain and has done wonderfully well when he has done the role in domestic cricket and in short formats.

"It will be a proud moment for him but it is thoroughly deserved because of how he goes about the game and everything that he offers to the team."

At close of play on Thursday as the BW went to press, England were 53-3 in their first innings, replying to India's 191 all out.

# England cruise to Hungary win

England consolidated their position of power in pursuit of a place at next year's World Cup in Qatar with a hugely impressive victory against Hungary on Thursday in a hostile and often unsavoury atmosphere in Budapest.

Gareth Southgate's side made it four wins from four qualifying games to open up a five-point lead over Poland, who England face in Warsaw after Sunday's meeting with Andorra at Wembley, at the top of Group I.

In a match which contained several flashpoints in the crowd, including loud jeering when England's players took the knee before kick-off, objects being thrown and racist chanting, they came through a mediocre first half to take total control after the break and run out easy winners.

England captain Harry Kane missed a great chance to give them the

lead shortly after the break but it did not prove costly as Raheem Sterling crowned a smooth move involving Declan Rice, Jack Grealish and Mason Mount to slide home his 16th goal in his past 24 international appearance after 55 minutes.

Sterling then turned provider eight minutes later as his deflected cross sat up perfectly for Kane to head home, Harry Maguire adding a third as his header from Luke Shaw's corner slipped through the grasp of Hungary keeper Peter Gulacsi.

In one of many incidents, Shaw was showered with plastic cups before taking the corner, as were England's celebrating players after Maguire scored. Sterling suffered a similar fate after putting England ahead when he took off his shirt to display a message in tribute to a close friend who died a few days ago.

England's night was rounded off three minutes from time when Gulacsi's second serious error gifted them a fourth as he

allowed Rice's routing shot under his body.

England's path to Qatar now looks smooth - and this was a performance that cemented their status as firm favourites to come through their qualifying group with ease.

Southgate's side kept their nerve and discipline in the unsettling, intimidating

surroundings of Budapest, with the behaviour of Hungary's fans leaving much to be desired, to turn up the heat and punish their opponents ruthlessly once they had gone ahead.

England's defence was untroubled and the only disappointment for Southgate was that the victory margin could have been even more convincing, with Kane and Sterling missing clear

chances to heap even further misery on the fading Hungarians.

Sterling was once again England's key figure, as he was in the Euros, scoring the goal that

■ **Ronaldo hails father figure who inspired his return**

**CRISTIANO RONALDO** dedicated his emotional Manchester United return this week to father figure and former manager Sir Alex Ferguson.

Ronaldo's stunning move back to United, 12 years after he left for Real Madrid, was confirmed this week - with the forward signing a two-year deal including an option for a third.

And five-time Ballon d'Or winner Ronaldo revealed that he only made up his mind to return to Old Trafford because of the unique

bond he has with old mentor Fergie.

"I'm right here!" said Ronaldo, in a message posted to his 336million Instagram followers. "I'm back where I belong! Let's make it happen once again."

"PS - Sir Alex, this one is for you."

In 2005, Ferguson broke the news to Ronaldo of the death of the forward's father Dinis, and the pair have remained particularly close ever since.

Ferguson sought out Ronaldo at the Stade de France after Portugal won Euro 2016, the pair embracing following

the presentation of the trophy.

Ronaldo is expected to make the first appearance of his United Second Coming at Old Trafford against Newcastle in the Premier League a week on Saturday. But his return will not push Jesse Lingard or Anthony Martial out of the club in the short term, according to United sources, despite the altered pecking order up front.

West Ham had wanted to sign former loan star Lingard - but their £25.7million capture of Nikola Vlasic from CSKA Moscow has effectively ended their interest.
