Life sentence for 'warped, selfish and brutal' killer

■ Former policeman Wayne Couzens found guilty of rape and murder of Sarah Everard

A FORMER POLICEMAN has been given a life sentence after kidnapping, raping and murdering a London woman, as police investigate whether he is responsible for any further crimes.

Wayne Couzens, at the Old Bailey on Thursday by Lord Justice Fulford, who said his "warped, selfish and brutal" offences had eroded confidence in the

The judge said he had been planning for at least a month before abducting Ms Everard, 33, as she walked home from a friend's house in Clapham, south London, on the evening of March 3.

Police Metropolitan firearms officer Couzens.

who had been "hunting" was handed the sentence for a victim, used his warrant card and handcuffs to snatch the marketing executive off the street using Covid lockdown rules to make a false arrest.

'sexual pornography'

Lord Justice Fulford said the case in which a serving officer abused his position was so exceptional it warranted a whole life order, meaning Couzens will never be freed.

It is the first time sentence has been

imposed for a single murder of an adult not committed in the course of a terror attack.

"The misuse of a police officer's role such as occurred in this case in order to kidnap, rape and murder a lone victim is of equal seriousness as a murder for the purpose of advancing a political, religious or ideological cause," said the judge.

Couzens was said in court to have been "attracted to brutal sexual pornography" as far back

Miserable winter ahead as Britain stumbles into severe fuel crisis

■ Covid and Brexit combine to wreak havoc on supplies as petrol stations see lines reminiscent of 1970s

A DOUBLE WHAMMY of Brexit and the Covid pandemic has produced the worst fuel shortages in Britain since the oil crisis of the early 1970s.

A shortage of truck drivers has led to empty fuel pumps around the country, creating long lines at gas stations and panic buying.

And households are facing "desperate choices" this winter, with energy bills rising by £30 a month for those who have had to switch supplier owing to a wave of energy company failures, as three more collapsed on Wednesday.

Many consumers in the UK are on long term contracts at fixed prices with their local supplies, meaning that as wholesale prices have risen, the companies are unable to pass those costs onto their customers. As a result 12 regional energy companies have collapsed in the past three months, under this year, forcing the regulator, Ofgem, to transfer 2m customer accounts to surviving suppliers. This week's collapse of a further three will force the regulator

to move 233,000 more customer accounts, with bills expected to increase as a result.

Ofgem said Igloo Energy, Symbio Energy and Enstroga had become the latest companies to succumb to a gathering crisis that shows no sign of abating, with gas prices remaining stubbornly high amid international shortages as winter approaches.

The regulator emphasised that customers would not have any disruption to the supply of energy to their homes, adding that anyone with credit in their accounts with those companies would not lose their money.

But it will have to find a

new provider for nearly a quarter of a million people through its "supplier of last resort" scheme, under which financially healthy companies take on customers from collapsed rivals.

Those that were on cheaper fixed-rate tariffs, often used by smaller, start-up energy companies to woo new customers, will see their bills increase to the government's energy cap, which is £1,277 for a household with average usage.

The crisis stems both from Britain's withdrawal from the European Union, which caused about 20,000 drivers to leave Britain, and the pandemic, which has severely disrupted

training of new drivers.

The Road Haulage Association, a trade association of road transport operators, estimates that Britain is facing a shortfall of 100,000 drivers. About 20 percent of those are drivers who left Britain after it voted to leave the European Union.

panic buying

To make matters worse, truck drivers tend to be older, and they are retiring. And new driver trainees are facing delays in getting licensed. Transport companies have reported raising

wages for truck drivers by 25 percent or more this year to retain them.

The shortage has also caused problems for restaurants, which are struggling to obtain food, and grocery stores, which have been unable to replenish shelves.

Drivers, concerned about reports of empty gas stations, have also been panic buying fuel in recent days, which has exacerbated the shortages.

But some government critics say that may not be enough to address the long-running shortage of drivers. About 200,000 E.U. citizens left Britain during the pandemic, on top of the thousands who have left since the Brexit vote in 2016, when Britain signaled it would impose limits on immigration from the bloc. That has made it harder for companies — including those in the haulage, hospitality and food supply sectors — to fill empty positions with overseas hires.

The scarcity of fuel has reduced the number of vehicles on the road. Figures showed traffic volume down by six percentage points on Monday compared with the previous week.

Labour leader Starmer faces down Corbynite rump at party conference

SIR KEIR Starmer faced jeers and heckles from Labour activists this week as he sought to steer his party back to the election-winning ways of Tony Blair.

In his first conference speech in person, which was frequently interrupted by protesters, the party leader promised to replace hard-Left policies rejected by millions of voters with "a sensible plan for Government".

He vowed to be tough on crime, to prioritise education and to back enterprise.

And, distancing himself from the extremism of his double election-losing predecessor Jeremy

Corbyn, he insisted: "We are the patriots."

His 90-minute address to the annual conference in Brighton infuriated the Left-wing supporters of Mr Corbyn and his allies.

In what appeared to be a co-ordinated attempt to disrupt the speech, several delegates repeatedly heckled the Labour leader and shook red sheets of paper at him.

Diehard

Sir Keir faced down the protests, saying the party needed to "get our own house in order" and insisting that the heckling "doesn't bother me".

He claimed the

protesters were "shouting slogans rather than changing lives".

The Tories branded the conference "chaotic" following clashes between the leadership and Left-wing grassroots throughout the week.

Party officials blamed a "small number" of diehard opponents of the leadership for the disruption and insisted the protests had not been a distraction from the message.

Sir Keir, 59, used the speech, the longest for many years at a Labour conference, to set out his vision for the country and his pitch to be the next prime minister.

Tributes flow to 'Sir Roger', Reds legend and World Cup winner

■ Liverpool FC said Roger "passed away peacefully at home following a long illness"

WORLD Cup star Sir Geoff Hurst has described his sadness after his "absolutely lovely" friend and fellow 1966 hero Roger Hunt died following a long illness aged 83.

Roger played as a striker alongside Sir Geoff in Sir Alf Ramsey's glorious England side that beat West Germany 4-2 to lift the Jules Rimet trophy at Wembley. He remains Liverpool's record league scorer with 244 goals and was known as "Sir Roger" to Anfield supporters.

Sir Geoff, 79, is now one of just three surviving members of the World Cup final starting XI with Sir Bobby Charlton and George Cohen.

He tweeted a picture celebrating with Roger and Alan Ball after scoring against Argentina in the 1966 quarter-final.

He said: "Great memories. Very sad day. Roger was an absolutely lovely man."

A dazzling forward, Roger won 34 England caps and scored 18 international goals after making his debut in 1962 when Bill Shankly's Liverpool side were still in English football's second tier

He played in every game of the 1966 World Cup and scored three times to help England out of their group. Liverpool players wore black armbands Tuesday night in their Champions League group game against Porto in Portugal.

Manager Jurgen Klopp said: "Roger Hunt comes second to no one in his importance in the history of Liverpool FC.

"I am told the Kop christened him 'Sir Roger' for all his achievements. A goalscorer who never stopped working to help his team-mates. He would have fitted well within our current team."

Liverpool FC said Roger "passed away peacefully at home following a long illness", adding: "The thoughts of everybody at Liverpool Football Club are with Roger's family and friends at this sad and difficult time."

'treasured'

Football Association chief executive Mark Bullingham revealed England would pay tribute when they play Hungary in a World Cup qualifier at Wembley on October 12. He said: "Hunt will always be treasured by fans across the country as one of our World Cup winners of 1966."

Liverpool legend Sir Kenny Dalglish said he had been lucky to follow Roger.

The former Kop striker and manager said: "RIP Sir Roger Hunt. Those of us who followed you and Shanks's men were fortunate to stand on the shoulders of giants.

"Thank you for everything you have done."

Ex-Liverpool defender and Sky pundit Jamie Carragher said: "RIP Sir Roger Hunt, one of the greatest goalscorers our club has seen. Sir Roger along with the other legends from the 60s made LFC the club it is."

Roger's death comes six months after that of his long-time Liverpool strike partner Ian St John at 82.

And it follows the passing two weeks ago of Jimmy Greaves, who he played alongside up front for England in the 1966 group games before the latter was injured.

Former Liverpool defender and Match of the Day pundit Mark Lawrenson tweeted: "Hopefully Roger & the Saint are renewing their Brilliant Partnership wherever they may be. Love to the Hunt family. We feel your pain."

'great striker'

Arch rivals Everton paid tribute, momentarily bridging the Merseyside divide, tweeting: "Our thoughts are with Roger Hunt's loved ones and everyone at @LFC at this sad time. RIP."

Former Three Lions forward and Match of the Day presenter Gary Lineker said: "Saddened to hear that another of the heroes of '66 has left us. Roger Hunt was a truly great striker for both @ LFC and his country. "He may be gone but his achievements will always be remembered."

Born in Golborne, Cheshire, on July 20, 1938, Roger signed for Liverpool in 1958 and made his 492nd and final appearance for the club in 1969.


Under legendary Kop boss Shankly he helped lift the club out of the Second Division in 1962, scoring 41 goals in as many games.

Liverpool then won the First Division in 1964 and 1966 either side of a first FA Cup win in 1965.


With 285 goals from 492 appearances, his league scoring record of 244 is unlikely to be broken.

After leaving Anfield in 1969 he had three successful seasons with Bolton Wanderers.

He also enjoyed the distinction of scoring the first goal on the BBC's Match of the Day – a looping volley in a 3-2 win

over Arsenal on August 22, 1964.

Like Jimmy Greaves, Roger was overlooked for a knighthood but received an MBE in 2000. After retiring as a player, he

joined his brother Peter as the third family generation running the Hunt Brothers haulage business.

He married Patricia O'Brien in 1959 and they had two children, David and Julie.

of scathing attacks on Boris Johnson, seeking to contrast himself as a "serious" politician with the "trivial" premier.

He also dragged up a past joke by Mr Johnson describing himself as a "blithering idiot".

Sir Keir said: "I don't think Boris Johnson is a bad man. I think he is a trivial man. He's a showman with nothing left to show. He's a trickster who has performed his one trick.

"Once he had said the words 'Get Brexit Done' his plan ran out. He has no plan."

In a striking switch Corbyn from Mr rubbishing Labour's past, Sir Keir repeatedly

praised the last Labour government of Mr Blair and then Gordon Brown. And making a deliberate nod to the Blairite slogan promising "education, education, education", Labour leader said: "Education is so important I am tempted to say it three times."

He also sought to bring back the patriotic language of the New Labour era and spoke of being "proud" of the Armed Forces.

Sir Keir kept specific policy announcements to a minimum. But he did promise that a Labour government under his leadership would launch "the most ambitious school improvement plan in a generation" and increase investment in support for mental health.

Having been denied a full conference speech last autumn due to the Covid crisis, Sir Keir used Wednesday's address to try to fully introduce himself to Labour members and the electorate.

MICK Jagger has led the Rolling Stones in an emotional tribute to Charlie Watts in their first concert without their beloved drummer.

The show opened with an empty stage and only a drumbeat, as pictures and videos of Charlie, who died aged 80 last month, were projected on to four giant screens.

And after performing their first two songs, including the rousing It's Only Rock 'N' Roll (But I Like It), Sir Mick, Keith Richards and Ronnie Wood came to the front of the stage.

Prospects turn dark for Andrew as witness emerges claiming she saw him with alleged victim

WOMAN claims she saw Prince Andrew dancing with his sex abuse accuser the night he says he was at a Pizza Express has allegedly agreed to testify against him in the United States.

Shukri Walker is prepared to reveal details of an encounter she said she had with the Duke of York at Tramp's nightclub in London in 2001.

The prince is being sued in New York by Virginia Giuffre who alleges he sexually assaulted her three times, once on the night after she visited the club with him when she was aged 17.

The Duke vehemently denies the allegations against him.

Ms Walker, of London, has given a statement to the FBI saying she vividly remembers seeing Andrew with Ms Giuffre, then called Roberts, and apologised after standing on his foot.

Her evidence, if believed, may blow

defence.

He said he had "no recollection" of meeting Ms Giuffre, despite a photo that seems to show him holding her waist at the home of his friend Ghislaine Maxwell.



"He was with this young girl who was close to my own age, perhaps even a bit younger. The young woman wasn't smiling, it was the opposite of smiles. They were with the woman who [had] just been arrested, Maxwell, Ghislaine and Epstein. I will never forget the night because I was told this is a real prince."

Andrew wiped the back of his hand across his face several times, she claimed. A source with knowledge of the development said: "Shukri is totally convinced she saw Andrew that night and is prepared to stand up in court to say so.

Critics hail 'magnificent' new Bond film

■ British critics hail Daniel Craig, in his final turn as 007 as 'a 'towering charismatic presence' in 'an epic barnstormer' of a movie

Daniel Craig's fifth and final James Bond film, No Time To Die, has received rave reviews from critics.

The movie premiered at the Royal Albert Hall on Tuesday, following several delays prompted by the Covid pandemic.

In his five-star review of the film, Kevin Maher of *The Times* said: "It's better than good. It's magnificent.

"Craig is a towering charismatic presence from opening frame to closing shot, and he bows out in terrific, soulful, style."

But while most critics were positive, some suggested the film did not quite justify its 163-minute running time.

In his own five-star review, *The Guardian*'s Peter Bradshaw described the film as an "epic barnstormer" which delivers "pathos, action, drama, camp comedy, heartbreak, macabre horror, and outrageously silly old-fashioned action".

"It is of course a festival of absurdity and complication, a head-spinning world of giant plot mechanisms," he said, but concluded the film as a whole is "very enjoyable and gleefully spectacular".

Stephanie Zacharek of *Time* was broadly positive about the film,

but suggested Craig's swansong didn't warrant its length.

"At two hours and 43 minutes, it's too long and too overstuffed with plot - more isn't always better," she said. "And it features one of the dullest villains in the series' history, played by Rami Malek in mottled skin and dumb silky PJs.

"But forget all that. No Time To Die, its flaws notwithstanding, is perfectly tailored to the actor who is, to me, the best Bond of all."

No Time To Die marks the culmination of an over-arching storyline that began with Craig's first Bond film Casino Royale, released in 2006. In another fivestar review, Robbie Collin of *The Telegraph* said: "[Director] Cary Joji Fukunaga's extravagantly satisfying, bulgingly proportioned last chapter to the Craig era, throws almost everything there is left to throw at 007 the series can come up with.

"We've been expecting you, Mr Bond, for quite some time," he added, "and what a joy and relief it is to have you back."

The Independent's
Clarisse Loughrey
was less
enthusiastic, awarding
the film three stars and
describing the premise as
"generic spy nonsense".

"Cary Joji Fukunaga has made a smashing piece of action cinema with No Time To Die-it's just a shame it had to be a Bond film," she said. "What's most disappointing is how strangely anti-climatic the whole thing feels."

She added: "Despite Phoebe Waller-Bridge's much-publicised contributions to the film's script, No Time to Die hardly feels like the radical feminist rewrite we were promised."

There was a similarly lukewarm response from *Screen Daily*'s Jonathan Romney, who said: "It's certainly a film that breaks many of the canonical rules of the series, though not entirely to dazzling effect.

"There's plenty to gawk at, and to argue over, in this episode," he added, "yet No Time To Die is oddly lacking in pleasure or real wit."

Empire's John Nugent agreed that the film was too long, writing that the middle third is "bogged down by plotting and exposition doesn't justify that heaving runtime".

However, he noted: "This film does things that no Bond film has ever done, and despite relying heavily on tropes

that feel not only familiar but comforting, it is the unfamiliar things it does that make this such an exciting entry."



Danjuma came close again three minutes later, cutting inside onto his right foot, but De Gea produced a superb save to his left to turn away the goal-bound effort.

De Gea came to United's rescue again in the 17th minute, tipping a fine glancing header over from Paco Alcacer, after Danjuma had beaten Diogo Dalot all ends up to send in the delivery.


Another chance came the way of the Europa League champions moments later, ex-Liverpool defender Alberto Moreno shooting over after United were slow to react to a cleverly-worked corner.

Danjuma continued to torment Dalot, who had no answer to his opponent's pace and trickery. United's lack of a replacement right-back on the bench meant there would be no respite for Dalot.

De Gea was called into action again before the break, diving low to his right to keep out a shot from Yeremi Pino, as United's defence was once again exposed.

Villarreal deservedly went ahead in the 53rd minute, Danjuma again getting the better of Dalot and crossing for Alcacer, who turned the ball in with a first-time finish.

United levelled on the hour, Alex Telles executing an unstoppable volley from a cleverly worked free-kick from Bruno Fernandes – then came Ronaldo's goal after good work by substitute Jesse Lingard.
