DUCHESS TELLS COURT SHE DID BRIEF AIDE OVER BIOGRAPHY

EXPLOSIVE NE EVIDENCE: MEGHAN SAYS SHE 'FORGOT'

The Duchess of Sussex has apologised to a court for making a misleading statement in her privacy case against the Mail on Sunday's publishers.

Court heard she had asked an aide to pass on information to the authors of a biography - despite having earlier said she "did not contribute".

Meghan said she had forgotten the events and had not intended to mislead.

Associated Newspapers is trying to overturn a ruling after it published a letter from the duchess to her father.

Meghan, 40, won her privacy case against the publisher of the Mail on Sunday earlier this year, when the High Court found its publication of the letter was unlawful.

This week the Appeal Newspapers' legal team are now seeking to overturn this judgement at the Court of Appeal, disputing that this was simply a private and personal letter - and have argued that it was crafted with the "possibility of public consumption" in

'discussed directly'

A spokesman for the Sussexes had previously said the couple "did not contribute" to the Finding Freedom biography, written by Omid Scobie and Carolyn Durand.

But in new evidence heard on Wednesday, Jason Knauf, the couple's former communications secretary, said the book

"discussed was a routine basis" and "discussed directly with the duchess multiple times in person and over email".

He also discussed planning a meeting with the authors to provide background information and said Meghan had given him briefing points to share with them, including information on how she had "very minimal contact" with her half-siblings during her childhood.

In the second day of the appeal hearing, lawyers Associated Newspapers had also challenged the extent to which the letter from Meghan to her father - at

the centre of the case it is trying to overturn - was "private".

They quoted exchange of text messages between the duchess and Mr Knauf in which Meghan said: "Obviously everything I have drafted is with the understanding

that it could be leaked, so I have been meticulous in my word choice."

Mr Knauf's evidence to the court also included emails with the Duke of Sussex, discussing the proposed meeting

with the authors and the need to conceal any involvement by Prince Harry and Meghan.

NHS crisis: 'tens of thousands' could quit over jab mandate

■ Fears for mass exodus of personnel as Sajid Javid confirms NHS England workers must be fully jabbed by April

Thirty-two thousand staff and care home of thousands tens NHS of personnel could quit over the government's insistence that both workforces get vaccinated against Covid, the government was warned this week.

The warning came as Sajid Javid confirmed that health service workers in England will have to be fully jabbed by next April or risk being sacked. The move will bring the NHS into line with the care home sector, in which staff have until Thursday to prove that they have had two doses.

The health secretary appeared to disclose to MPs when making the announcement about the NHS that, with Thursday's deadline for care home staff imminent, as many as 32,000 of them have still not yet been jabbed.

The Conservative MP Mark Harper, a former government chief whip, told Javid that 32,000 was "a very significant number". He also asked government publish "a plan to deal with what sounds like will be something like tens of thousands of NHS staff who, if the care home workforce is any precedent, are going to end up leaving the national

health service".

The minister replied that the number of care home staff was accurate: "The 32,000 number he's referred to, I would just point out that was the latest number that we had - it's a published number – at the end of last month." But it might include potentially thousands of people who are medically exempt, he

Javid said staff such as doctors and nurses "carry a unique responsibility" to keep patients safe. Workers who deliver personal care services in people's homes will also have to be vaccinated.

"I have concluded that all those working in the NHS and social care will have to be vaccinated. We must avoid preventable harm, and protect patients in the NHS, protect colleagues in the NHS and of course protect the NHS itself," he told MPs.

opposition

The only exceptions among the NHS workforce will be for those who are medically exempt from being vaccinated and those who have no face-toface contact with patients.

Javid decided to press ahead with making jabs mandatory despite health unions and some organisations representing

doctors voicing strong opposition. He had been warned that compulsion would lead to an exodus of NHS staff who have chosen not to get immunised.


"Concerns [were raised] that some people may choose to leave their posts if we went ahead with this. [But] I have carefully considered the responses and the evidence and I've concluded that the scales clearly tip on one side," he told the Commons on Tuesday.

Javid said that while 90% of NHS staff had already had both jabs, about 103,000 have not, and in some trusts only 80% have been double-vaccinated. Many are younger women who are or hope to become pregnant, or those from a minority ethnic background.

He considered imposing the new legal duty of vaccination on NHS personnel before this winter. But he opted to delay it until April 2022 after warnings hospital groups NHS Providers and the NHS Confederation that doing that sooner would exacerbate understaffing by triggering an exodus of staff at the time when the health service is under its greatest pressure.


Covid-19 in the UK

chief executive of NHS Providers, said: "Had the policy been introduced any sooner, we would have risked worsening the NHS's current workforce shortages at a time when the health service is already under huge operational pressure. This could have posed a risk to the quality of care we were able to provide."

Javid said that a statement about the impact of the move to mandatory jabs would be published later on Tuesday but that a full impact assessment would be made public "later".

'persuasion'

Other countries including France, Italy and the US have already made vaccination compulsory, he added. Some hospitals in the US have recently fired small numbers of employees after they refused to get immunised.

The union Unison, which represents both NHS and care home staff, said there would be

"dire consequences" for care homes from Javid's "draconian approach".

"The staffing crisis will become a catastrophe for a sector already on its knees. Some homes may have to close if care staff are barred from their jobs. Forcing the vaccine on care staff is an own goal by the government," said Christina McAnea, Unison's general secretary. Take-up rates would only increase with "persuasion, not punishment", she added.

UK KNIFE HORROR: 15 year old schoolboy stabbed friend 70 TIMES in frenzied attack

A 15 YEAR OLD BOY has been jailed for at least 16 years for murdering a schoolfriend by stabbing him more than 70 times.

Lincoln Crown Court heard that Marcel Grzeszcz, 15, also tried to behead Roberts Buncis, 12, before leaving his body in local woodland.

The murder took place on 12 December last year, two days before the victim's 13th birthday.

It has since emerged Grzeszcz expelled after he had taken a knife into St Nicholas Primary School in Boston, Lincolnshire, and threatened a girl with

decapitate

A mother who used to take Roberts to school with her children told The Sun: "It's not his first incident with a knife. When he was at primary school, he took one into class to threaten other kids. He threatened a girl with it and was excluded."

The court heard that Grzeszcz, who was 14 at the time of the attack, lured Roberts to meeting him in a residential street near where they both

lived by offering him £50 to sell cannabis.

He then stabbed him "in excess of 70 times", the court heard.

A pathologist said that wounds to the neck and arm indicated that he was trying to decapitate Roberts, as well as cut off his hands. Roberts was also stabbed in the chest and abdomen.

Grzeszcz, who had been expelled from secondary school and sent to a pupil referral unit for dealing drugs, has claimed that he "lost control" after Roberts allegedly pulled the knife on him.

The victim, who came to live in the UK with his father from Latvia when he was seven, was found the day after the attack. Grzeszcz was charged with murder the following

On Monday Grzeszcz was jailed for a minimum of 16 years and his identity - which had not been publicised due to his age - was revealed after the judge lifted reporting restrictions.

'utterly senseless'

Mr Iustice Ieremy Baker warned the boy that he may never be released as he had shown no remorse.

He added that the crime was further aggravated to destroy the clothes he wore on the day of the murder and hide the blade with a collection of other knives he owned in his bedroom. Grzeszcz often carried a

knife at secondary school, a pupil told the court.

Prosecuting lawyer Mary Loram QC said Grzeszcz intended to rob a shop at knife-point to get cash to set himself up as a cannabis dealer, and was believed to have feared that Roberts would "snitch" on him.

He messaged another boy saying "Rob's a liability", to which he received a message saying "if he snitch, smack time".

In court after Grzeszcz was sentenced, Roberts' father Edgars Buncis's statement was read out.

He said: "How do I put into words how I feel? This is all wrong. No father should ever have to bury his son.

"I have lost my destination, my purpose. My life is in the cemetery. I feel empty, nothing will change this."

Detective Chief Richard Inspector Myszczyszyn, of the East Midlands Special Operations Unit, said: "This is an utterly tragic case."

He also said: "The act was utterly senseless and the consequences, devastating. It will be remembered by officers and staff as one of the worst and saddest cases we have ever dealt with. "The level of violence, and that it involved children, makes it almost incomprehensible."

"Equally, you giving the right context and background to them would help get some truths out there."

In a witness statement to the court the duchess said she accepted that her aide did provide information to the authors of the book with her knowledge but she said the "extent of the information he shared is unknown to me".

"When I approved the passage... I did not have the benefit of seeing these emails and I apologise to the court for the fact that I had not remembered these exchanges at the time," she said.

"I had absolutely no wish or intention to mislead the defendant or the court."

The duchess added that she would have been "more than happy" to refer to the exchanges with Mr Knauf if she had been aware of them at the time, but said they were "a far cry from the very detailed personal information that the defendant alleges that I wanted or permitted to put into the public domain".

Another reason the duchess gave for not

discovering the emails between her and Mr Knauf sooner was that the disclosure stage of the litigation had not yet been reached, and in October last year her lawyers applied to adjourn the trial date as she was pregnant.

She said she was advised to avoid stress after a recent miscarriage, which came shortly after Associated Newspapers Limited indicated it wished to reveal the identities of her five friends who gave an interview to the US magazine People, which they referred to her relationship with her

Wife's tribute to 'wonderful father', 57, killed by shark



"Rest in peace, Paul. He died (doing) what he enjoyed doing the most, which was exercising," said the victim's wife.

A HEARTBROKEN wife has paid tribute to her husband, believed killed by a shark off Australia's west coast.

Paul Millachip, 57, who emigrated to Australia several years ago, was attacked while swimming at Port Beach near Perth on Saturday.

His wife, who did not wish to be named, described the father-of-two as "a wonderful man" who loved exercise.

Speaking to Australian

broadcasters, she paid tribute to the teenagers who helped raise the alarm.

"I also just wanted to say thank you to all of our friends here in Perth for all the support and love that you've shown us," she added.

The couple are believed to have settled in Perth years ago; both their families are currently overseas.

Mr Millachip was a regular at the beach and a pair of goggles believed to belong to him have now been recovered.

"Rest in peace, Paul. He died (doing) what he enjoyed doing the most, which was exercising," his wife said.

She thanked eyewitnesses and praised the police and emergency services.

"It came out of the blue. But it did happen, you just have to deal with it," she added.

Acting inspector Troy Douglas said: "Enquiries will continue based on anything that is washed up or anything that's found in the future, but at this point the marine search is suspended."

At press time authorities had not determined whether the attack was by one shark or two. Several eyewitnesses spoke of seeing two dorsal fins in the water immediately prior to the attack, with at least one eyewitness saying he saw both a Great White and a tiger shark circling the victim

Gerald Sinstadt, former BBC and ITV football commentator, dies aged 91

■ Broadcaster was best known for work within football

Gerald Sinstadt, one of the most instantly recognizable television sports voices as a commentator for BBC and ITV for more than 40 years, has died at the age of 91.

The versatile broadcaster, who covered golf as well as the Olympics, will be chiefly remembered for his football commentaries, first for Granada TV in the north-west in the 1970s and also with the BBC where in 1989 he was famously its pitchside reporter on the day of the Hillsborough disaster.

Sinstadt was one of the first commentators to criticise the racist abuse black players suffered, including during a West Bromwich Albion 5-3 victory over Manchester United at Old Trafford in 1978 when Cyrille Regis and Laurie Cunningham scored the crucial goals.

His path to broadcasting might not have happened but for a cruel twist of fate involving his parents.

"I can do this"

Sinstadt, born in 1930, was the only child of shopkeepers in Folkestone was evacuated and during the second world war. Later, reflecting on the tragic death of the pair in a German air raid, he said: "I can still remember my teacher taking me out of class to tell me the news. I have wondered what might have been if my parents had survived. Who knows, I may have followed my dad and become a shopkeeper."

The young Sinstadt made his first live commentary in 1949

for forces radio after his conscription into national service and was rewarded with a 7-6 cup game between an English and Scottish regiment.

"The game made my job easy and I thought: 'Hang on, I can do this,'" recalled Sinstadt.

"Unfortunately, I soon realised you couldn't just turn up on the day and hope for the best. If you don't do your proper research the listener will soon catch you out."

cultured man

After time on BBC radio and Anglia Television, Sinstadt's informed but distinctively dry style became a feature of Granada TV's Kick Off preview and of highlights shows on ITV from 1969 to 1981 when he became the station's full-time

football commentator. Sinstadt described the iconic moment Denis Law scored a cheeky backheel goal for Manchester City as his former club Manchester United were relegated to the then second division, telling viewers: "Dennis has

done it!"

A cultured man with a passion for opera, he worked on programmes covering that art form as well as branching out to commentate on golf for Channel 4 when he left Granada TV before returning to the BBC in the mid-1980s to become a regular on Match of the Day, Football Focus and Final Score until his retirement.

Sinstadt settled in the Potteries after his retirement and wrote a weekly column for the Stoke Sentinel until 2019.

new album in 15 years, Thank You. She was first announced in October 2019, saying then: "To all my fans across the world, this is my tribute to you. Every concert feels like a private party, I can see your eyes and feel your hearts. I'm coming to Glastonbury, with love."

Festival organiser Emily Eavis said she was "thrilled to be able to let you know that the magnificent Diana Ross is coming to play at Glastonbury next summer".

Ross will be 78 years old when she takes the Pyramid stage, whose crowds often top 100,000 people, making her one of the oldest to perform cont. on page 5, col. 1



FLY TO BLIGHTY IN BUSINESS FOR FREE I'm Owen Beiny - a fellow Brit in LA. I've lived here since 2005.

For the last 16 years I've been flying around the world on a flat bed using credit card points and air miles, and I have now made it my mission to help others do the same by teaching them how to maximize their credit card benefits.

As expats, we all feel

that constant pull of being torn between LA and our loved ones back home. But as we all know, jetting back and forth to the UK ain't cheap and it's not as simple as jumping on an EasyJet flight for fifty quid.

Long Haul flights are expensive - even more now as airlines desperately try to recuperate the huge losses they incurred from the pandemic.

Imagine waking up one day and having the freedom to just pop home for a long weekend knowing it's not only going to cost you nothing, but you get to do it in comfort and in style.

That's exactly what I did! During a weekly Facetime call with my mum, she moaned, "It's all very well and good you live in LA but you can't pop over for a cup of tea."

Twelve hours later, I knocked on her door and said, 'I thought I'd pop over for a cuppa." Let's just say it was worth the crippling jet lag and swapping the LA sunshine for the pouring rain.

I've ensured that living 6,000 miles away from my loved ones is that much easier - as well as being able to travel the rest of the world too.

It sounds good to be true I know, but it's not and I can show you how. You don't have to have a six-figure salary or have an extravagant lifestyle. It's about spending smarter and maximizing those points and air miles.

England loss and transfer saga took a toll, admits Kane

England captain Harry Kane says defeat in the European Championships final and summer speculation over his Tottenham future took its toll on him mentally.

The Three Lions were beaten by Italy on penalties at Wembley, while Kane was linked with a move to Manchester City.

Kane also defended brother and agent Charlie's role in the transfer saga.

"You go through the highs and lows of a major tournament, coming so close to a dream and it being taken away from you in such a quick moment," he said.

"Then it was my first summer of transfer speculation and having to deal with those situations. So of course it takes a toll mentally on yourself but from my point of view, I've always had good friends and good family around me.

"Being able to talk to them in those situations. Being able to talk to people you trust. When things are difficult, it's important that you do talk about it and not just hide it in and suck it up.

"But it is important that you have people around you that you can trust to do that. That's what I've done."

But the 28-year-old says the siblings will always stick together and any outside interferences were just "noise".

"Whatever the circumstance, whenever there is stuff being written about your family, it's always maybe a little bit difficult to take, especially when it's stuff that's negative," he said.

"But I think that's when families really come together during those moments. Obviously I'm very close to my brother and my parents, my wife, her family, so there's plenty of people that I know and trust and am able to talk to.

"It's never easy when there is any negative story about yourself or someone you know, or your friends, or team-mates. That's where we stick together. I know what he does for me as an agent, I know what he does for me as a brother and that's all that matters."

The striker has scored just once in 10 Premier League games this season but does not believe the summer transfer speculation is to blame.

"Well I think from my point of view it's easy for people to try and look for an excuse when maybe you're not on form or you're not scoring as many as you usually do," he said

New Zealand ended England's hopes at the Men's T20 World Cup with a dramatic semifinal victory in Abu Dhabi on Wednesday.

England looked on course for Sunday's final until an assault from Jimmy Neesham swung the game in New Zealand's favour in a thrilling finale.

Neesham smashed three sixes, each a body blow to England's hopes, as the Black Caps' pursuit of 167 was given life.

The all-rounder was caught for 27 from 11 balls in the 18th over but, with 20 needed from 12 balls, opener Daryl Mitchell took on the attack.

He hit Chris Woakes for two sixes, finishing 72 not out from 47 balls as New Zealand won by five wickets with an over to spare.

England cantered through the group stage with four comprehensive wins but their quest to become the first team to hold both the men's 50-overs and T20 World Cups is now over.

New Zealand, beaten in incredible fashion when the sides met in the 2019 World Cup final, will face Australia in Dubai on Sunday. The Aussies beat Pakistan by five wickets in another thrilling semi final on Thursday.

Spain win sends Wales into playoffs

Wales are officially guaranteed at least a place in the World Cup play-offs after Spain beat Greece 1-0 on Thursday.

Wales started their qualifying campaign knowing they had all but secured a play-off spot having won their Nations League group.

Spain's win in Athens formally seals it, even if Wales finish outside the top two in their qualifying group.

Wales must finish second to have any chance of being seeded for March's play-offs.

Teams who reach the play-offs via the Nations League are unseeded and will be away in their semi-final to a seeded nation.

Wales can guarantee a top-two finish with four points from their final two qualifiers at home to Belarus on Saturday and Belgium on Tuesday.

Wales could theoretically qualify automatically - they are five points behind Group E leaders Belgium with two games to go - but they would need the world's number one ranked side to lose to Estonia as well as to Rob Page's men in Cardiff.

If Wales beat Belarus and lose to Belgium and the Czech Republic beat Estonia in their only remaining game - the playoff spot would go down to goal difference. The Czechs are currently two ahead on that metric.


Even if Wales do finish outside the top two, they now have a play-off place guaranteed.

Spain's victory, secured by Pablo Sarabia's goal,

means they need a point from their showdown with Sweden at the weekend to secure a place at next year's World Cup finals.

Sweden had led Group B going into the final two games but a shock 2-0 loss in Georgia earlier has handed Spain the advantage.

Wales are the fifth best ranked Nations League side, with two play-off places given to the highest ranked sides who do not finish in the top two of their qualifying group.

Kane shines as England cruise

England require only a point from their final qualifier in San Marino to confirm their place at the 2022 World Cup in Oatar after thrashing Albania 5-0 at Wembley on Friday.

Harry Kane led the romp with a first-half hat-trick as England made light work of an Albania side expected to provide stiff opposition after a very respectable qualifying campaign.

England were five goals ahead and out of sight by half-time, Harry Maguire setting them on their way with a ninth-minute header from Reece James' free-kick, Kane quickly adding a second at the far post from Jordan Henderson's cross.

Henderson scored the third himself after a slick exchange with Kane before England's captain added two more before

an angle and a stunning scissors kick from Phil Foden's corner.

Kane is now level with Jimmy Greaves on 44 England goals and has scored 39 competitive goals for his country, breaking Wayne Rooney's record of 37. Gareth Southgate's decision to use two holding midfielders in Henderson and Kalvin Phillips raised some eyebrows but the system was the same one used when they beat Germany in Euro 2020, as well as in the losing final against Italy, and worked positively and efficiently.

Southgate was determined get to England on the front foot, using James and Ben Chilwell as attacking wing-backs with Henderson showing a particular willingness to get forward.

After a combative

Pickford saved brilliantly from Myrto Uzuni after Kyle Walker played the ball into his path at 1-0, England overwhelmed Albania with wave after wave of attacks.

Once that moment of anxiety passed it was oneway traffic with England in complete control and the Albanians being run ragged at the back.

Kane was back to his brilliant best as he scored three and could easily have doubled that tally while Raheem Sterling also looked sharp as England did all their goalscoring in the first 45

Maguire celebrated his goal with a fingers in the ears celebration which may have been directed at critics of his recent performances for Manchester United - although it will take the break with a shot from opening and a scare more than a goal against

Albania to erase the memories of those humbling Old Trafford defeats against Liverpool and Manchester City.

England's supremacy enabled Southgate to give a debut to Arsenal's talented Emile Smith Rowe as the game was played out to a low-key conclusion.

This was a comfortable night for England against mediocre opposition but Albania have performed well in this group so Southgate and his players deserve credit for their positive approach and the ruthless manner in which they got this job done, and indeed the way they have negotiated the qualifying campaign.

It is a group which always looked favourable and now all England have to do is complete the formalities against San Marino on Monday before they can begin the serious preparations for Qatar next year.

Stevie G takes Villa hot seat

Aston appointed Steven Gerrard as manager on a three-and-a-half-year deal, ending his threeyear reign at Rangers.

The former Liverpool captain, 41, leaves the Scottish champions having guided them to a first league title in 10 years last season.

Gerrard (pictured, right) replaces Dean Smith, who was sacked on Sunday after a run of five successive defeats.

Villa are 16th in the Premier League, two points above the relegation zone.

"Aston Villa is a club with a rich history and tradition in English football and I am immensely proud to become its new head coach," said Gerrard.

"In my conversations with [co-owners] Nassef [Sawiris], Wes [Edens] and the rest of the board, it was apparent how



ambitious their plans are for the club and I am looking forward to helping them achieve their aims."

Gerrard took his first steps in senior management with Scottish Premiership side Rangers in 2018, and leaves with them four points clear of rivals Celtic at the top of the table.

According to reports Villa have paid Rangers £4.5m in compensation.

"Steven and backroom staff have ensured that the club is undoubtedly in a better place today than it was three-and-a-half years ago," said Rangers sporting director Ross Wilson.

"We have shared a desire to move Rangers forward, to modernize our infrastructure and to make the club win again.

"There have been so many areas that we have moved forward, and there is still so much to be done, but I can't stress enough how important it has been to have with us a first-team manager who shared a drive and desire to set standards and move the whole football operation forward."

Scots clinch play-off spot

Scotland clinched a World Cup play-off place with a game to spare thanks to a composed 2-0 victory in Moldova.

Nathan Patterson calmed the nerves with his first Scotland goal then teed up Che Adams to double the lead.

Craig Gordon's vital penalty save denied the hosts a late lifeline.

A fifth straight victory for Steve Clarke's men opens a seven-point gap - Israel are level with Austria after a 4-2 defeat in Klagenfurt with Denmark already qualified as Group F winners.

Scotland complete the campaign against the Danes at Hampden

on Monday when the hosts are likely to need a point to earn a home semi-final in the play-

Northern Ireland moved back up into third in their World Cup qualifying table with a comfortable and muchneeded 1-0 home win over Lithuania.

Benas Satkus headed a Paddy McNair corner into his own net to hand the hosts a victory that they thoroughly deserved for a dominant display.

It was a second Group C win in seven games for Ian Baraclough's side, their first also coming against Lithuania.

Striker Dale Taylor, 17, came off the bench late on to make his NI debut.

Northern Ireland, who go above Bulgaria on goal difference in third, finish their campaign back at Windsor Park against Italy on Monday night.

The European champions will arrive in Belfast still top of the table after drawing with Switzerland on Friday, but needing a win to be sure of topping the group.

For Northern Ireland, though, it will be an opportunity to finish the World Cup campaign on a high after defeat in Switzerland and Bulgaria last month ended their hopes of qualifying for the finals.
