'Cancel Christmas' Andy orders as net closes in

■ Prince "totally consumed" with legal battle, claim Royal sources

Prince Andrew has ordered his US legal team to "cancel Christmas" and prepare for a key court date in his sexual assault case.

The Duke of York has instructed his legal team to "leave no stone unturned" in the lead up to the January 4 hearing, described as his "last ditch attempt" to get allegations he abused a teenage girl thrown out.

Royal sources say he is "totally consumed" with the legal battle and has been staying up into the night to keep in constant conversation with his California-based lawyers. Next Monday they are set to deliver their final submissions to the New York court before a decision is taken in the new year as to whether the Duke will face a full trial.

Giuffre is Virginia pursuing Andrew through the civil courts. He is accused of "rape in the first degree" amid claims he forced Ms Giuffre, also known as Virginia Roberts, to have sex with him three times in 2001 while she was trafficked around the world by the royal's late paedophile pal Jeffrey Epstein.

In August she sued the Queen's son for unspecified damages which could run into millions of pounds if she is successful. Sources close to the Duke say he has become "incredibly stressed" in recent weeks after fearing his team's strategy of not publicly responding to the claims is failing.

'tension'

Insiders also suggest he is extremely worried over the financial burden he has placed on the Queen, who agreed to personally meet his spiralling court costs, which could run into millions. Prince Andrew has denied the claims.

One source close to Andrew said: "The tension in the camp is palpable. No one is really sure what Andrew's involvement is other than asking a lot of questions, but he spends his days and nights poring over documents.

"He is totally consumed by it, keeping most irregular working hours so he can be in contact with his team.

"He was particularly stressed a few days ago and was heard remonstrating with one of the team. The feeling was he was telling them to effectively cancel Christmas and get totally across all the eventualities of what could happen in the case so there are, as he put it, 'no more surprises'.

"It's very much a last ditch attempt to get the case thrown out and if that doesn't succeed he knows they are all potentially in it for the long haul."

The Duke's team want the "baseless lawsuit" thrown out, claiming Virginia Giuffre "achieve looking to another payday his expense". Court documents filed on behalf of her lawyers condemned Andrew, 61, for launching a "baseless, defamatory" attack on her credibility, character and motives.

Christmas parties leave enduring hangover for Boris

■ Inquiry launched as claims grow that Tories flouted lockdown rules in several parties in 2020

JOHNSON's **BORIS** political recent difficulties look likely to blossom into a winter of discontent as concern grows over allegations that Christmas parties at **Downing Street last year** flouted Covid lockdown rules.

Although the Prime Minister initially attempted to brush aside the allegations, they story will not go away, and now an official investigation into government staff parties is set to focus on three events that took place in 2020, Downing Street parties on 27 November and 18 December, and one at the education department on 10 December.

Pavmaster General Michael Ellis said any potential criminality uncovered would be reported to the police.

Labour called for the prime minister to resign if he is found to have misled MPs about the parties.

Shadow Cabinet Office minister Fleur Anderson questioned whether the investigation was "serious" and whether more parties needed to be included in it.

Boris announced Wednesday that inquiry would be carried out by top civil servant Simon Case, after a video from last year emerged of government staff joking about a party that took place on 18 December - a day on which more than 400 Covid deaths were

Government spokeswoman Allegra Stratton resigned later on Wednesday over the video, obtained by ITV News, in which she appeared.

'absence of evidence'

And Labour has called for Commons Leader Jacob Rees-Mogg to apologise after joking at an event on Monday that those attending would not be "investigated by the police in a year's time".

The Metropolitan Police has ruled out an investigation for the time being into the 18 December Downing Street gathering, citing an "absence of evidence" of any criminal wrongdoing.

On Wednesday, Mr Johnson said he had been "repeatedly assured" that "there was no party and that no Covid rules were broken" on that date at which time London was under Covid rules banning people from meeting indoors.

But he said he had asked Mr Case to "establish all the facts" and that if rules had been broken those responsible would face disciplinary action.

The 10 December gathering took place during the same period of restrictions, while on 27 November England was in full lockdown.

Mr Ellis told the House of Commons on Thursday: "The primary purpose of the cabinet secretary's investigation will be to establish swiftly a general understanding of the nature of the gatherings, including attendance, the setting and the purpose, with reference to adherence to the guidance in place at the time."

He added: "As with all internal investigations if, during the course of the work any evidence emerges of behaviour that is potentially a criminal offence, the matter will be referred to the police and the Cabinet Office's work may be paused."

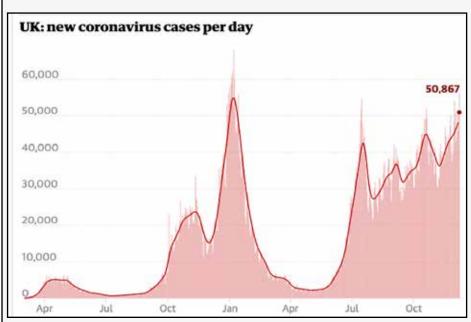

Government faces Tory backbench revolt over plan B Covid measures



Street **Downing** facing a damaging revolt over planned Covid restrictions after dozens of Tory backbenchers threatened to rebel or abstain in fury over the proposed new rules and Boris Johnson's handling of the Christmas party scandal.

With at least 30 Conservative MPs expected to vote against regulations on masks, home working and vaccine passports, and many more now vowing to stay away from Tuesday's vote, the prime minister could be left relying on Labour support to win.

Johnson is battling the fallout from days of revelations about a festive gathering inside No 10 amid tough Covid rules last December. An inquiry into the reports has been expanded to examine other alleged events, including one Johnson is believed to have attended.

In further blow for the prime minister, a Survation survey for the Daily Mirror put Labour six percentage points ahead the Conservatives, at 40% to 34%. A YouGov poll for the Times had Labour four points ahead on 37%

Shortly after unveiling

review, Johnson announced introducing tougher "plan Covid restrictions for England because of the rapid spread of the Omicron variant - a move which Tory MPs say has instead magnified their annoyance and frustration.

The likely collision point will be next Tuesday, when MPs will vote on the restrictions. covering an extension to mandatory maskwearing, advice to work from home and, most controversially, introduction of Covid status certificates as a condition of entry to venues.

Scotland marks end to coal power as Longannet chimney is blown up

■ Nicola Sturgeon pushes button on controlled explosion at what was Scotland's largest freestanding structure

Scotland has marked the end of its coal-powered history by demolishing the huge chimney at its last remaining coal plant at Longannet in Fife.

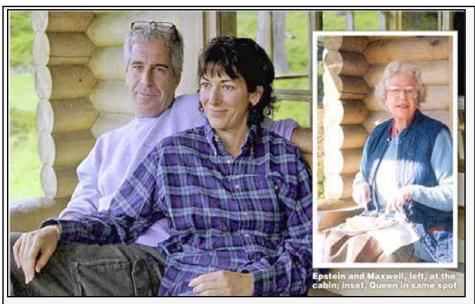
The chimney, which was Scotland's largest freestanding structure, dominated the skyline for more than half a century before it was destroyed on Thursday morning with 1600lbs of explosives.

Scotland's first minister. Nicola Sturgeon, who pushed the ignition button on the controlled implosion, described the demolition as "a symbolic reminder that we have ended coalfired power generation in Scotland, as we work in a fair and just way towards becoming a net zero nation by 2045".

The Longannet coal plant, which is owned by Scottish Power, was the largest of its kind in Europe when it began enough generating power electricity to a quarter of Scottish homes in 1970.

'tranformative'

Almost half a century of power generation at the plant came to an end in 2016 when the energy company shut the site beside the Firth of Forth, drawing a line under the coal age that

The Duke York stepped back from public life in 2019, which was when he first spoke publicly about friendship with Epstein and allegations that he was involved in Epstein's child sex-trafficking scheme.

Virginia Roberts Giuffre claims she was trafficked by Maxwell, and forced to have sex with Prince Andrew three separate times when she was

17-years-old.

Giuffre is not testifying in Maxwell's trial, though other witnesses have recalled meeting her at Epstein's Palm Beach mansion, as well as aboard Epstein's private

She has also filed a separate civil case against the Duke, who denies any involvement with her.

Epstein died by suicide in a Manhattan jail cell before he could stand trial on sex abuse charges.

had powered Scotland's Industrial Revolution.

Sturgeon said Scotland aims to generate half of its overall energy consumption from renewable sources by 2030 by investing in renewables, hydrogen and energy storage to help tackle the climate crisis "in a way that leaves no one behind".

She said growth in these sectors over the next decade would be "transformative Scotland, delivering further good, green jobs, strengthened energy security, and benefits for local communities".

Scottish Power, which is owned by the Spanish energy giant Iberdrola, ended its generation of fossil fuels in 2018 after selling off its last gas plants to Drax to focus on running wind and solar farms.

Keith Anderson, Scottish Power's chief said the executive, company had "bade farewell" to a landmark; "However, this is a landmark day Scotland, too."

He said: "Watching the chimney of Scotland's last coal-fired station fall today represents a real milestone, as the UK moves away from the large polluting power stations of the past and accelerates down the road to net zero emissions."

The UK still has a handful of coal plants that generate electricity ahead of the government's 2024 ban on coal power. Drax continues to burn coal at two of its six generating units in North Yorkshire. There are also active coal plants at West Burton A in Lincolnshire, at Ratcliffe-on-Soar Nottinghamshire, and at Kilroot in Northern Ireland.

Elton John backing protest against Qatar World **Cup being promoted by pal David Beckham**

■ Music legend and his husband David Furnish protest World Cup in Qatar, which his close friend Becks is reportedly being paid £10million to help promote.

Sir Elton John is backing a high-profile protest over the World Cup being held in Qatar next year.

Activist Peter Tatchell says the Middle Eastern country's record on human rights and LGBT issues should preclude it as host of football's top competition.

And he has revealed that football fan Sir Elton, 74, and husband David Furnish, 59, are supporting his fight.

Peter, 69, said: "Elton and David have been fantastic. We are hoping to work together over the Oatar World Cup.

"Elton is supporting my mission. I know he is concerned about the World Cup being held in

"I will be liaising with him to ensure something significant happens to profile the abuse of human rights in that country. He is a good guy, Elton."

Peter said he was keeping details of the protest under wraps for now. He revealed: "Let's just say I will be doing something to raise awareness... but I will do what I do best.

'very unhappy'

"I mooted my idea with Elton and David sometime ago and I spoke to David and they are being supportive.

"Elton is a big football supporter and that is how he feels. I don't know if he will pay for the trip but it is in the early stages. He said he would be willing to help and support around Qatar."

The involvement of Sir Elton, who is the Honorary Life-President of Watford football club, could potentially put him at loggerheads with David Beckham.

The former England star is reportedly being paid £10million to help promote the competition.

Elton is godfather to Beckham's eldest two boys, Brooklyn Romeo. Peter said: "I am very unhappy with David's decision to act as an ambassador for Qatar. He claims presumably he will be able to influence things from the inside but nobody previously has succeeded in doing that.

"I hope he will think again and perhaps start

putting some pressure on Qatar to deliver some reform."

Record number of children in Britain arrested over terror offences

■ Home Office figures show 25 under-18s arrested in year to September, mostly in relation to far-right ideology

children were arrested on suspicion of terror offences in Great Britain in the last year, development that investigators have linked to the shutdown of schools during the early stages of the pandemic.

Figures released by the Home Office show there were 25 such arrests of under-18s in the 12 months to September, the majority in relation to far-right ideology.

This was an increase from 17 arrests the previous year. Under-18s accounted for 13% of all terror arrests last year, up from 8%.

"We are very concerned that children

A record number of increasing proportion of our arrests," said the deputy assistant commissioner Dean Havdon. the senior national coordinator for counter-terrorism policing.

pandemic-related

In February a 13-yearold neo-Nazi from Cornwall was found guilty of possessing bomb-making manuals and disseminating farright materials online.

Last week a 17-yearold from Derbyshire appeared before Westminster magistrates charged with possessing and sharing a terrorist publication. A trial is expected next year.

Învestigators highlighted the impact

pandemic-related school closures, arguing educational settings help normalize behaviour, while schools regularly report cases of concern to Prevent, government's deradicalization programme.

Loneliness during lockdowns and the ease with which young people with time on their hands can seek out extremist material online when not being supervised are also factors driving the rise in numbers, police believe. Some extremists are using Covid conspiracy theories and online gaming channels as a means of recruitment.

"Our research tells us that parents, family members and friends are the first to see the changes in behaviour which might indicate that a loved one is being radicalised," Haydon said. "But currently just 3% of people we help through Prevent come to the programme because of concerns raised by those same people who

know them best."

He advised parents to seek advice from the Act Early scheme.

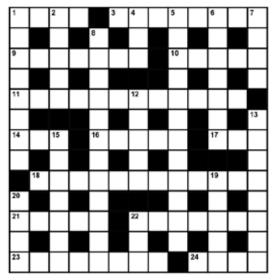

BRISBANE: ENGLAND face an uphill battle to avoid going 1-0 down in the Ashes series as Australia took a commanding hold on the First Test.

At press time at lunch on the third day, Joe Root's men were 23-0, still 255 behind Australia's first innings total of 425. England had been skittled out for a paltry 147 on the first day.

England's dismal start to the Ashes series was compounded by Travis Head's blistering 152 on day two of the first Test at the Gabba.

With temperatures in the high 90s, lefthander Head tucked into a weary attack to reach three figures from targeted for some brutal only 85 balls, the thirdfastest hundred in Ashes history.

Missed chances and the ineffectiveness of Leach aside, England could do little more on a second day that exposed the inadequacy of their performance and decisions on day one.

Robinson was the pick of the English bowlers with 3-58, and Wood bowled with extreme pace and Chris Woakes often beat the bat. However, the sight of Stokes limping is a huge concern and his nine overs cost 50 runs.

When Robinson had Warner caught at midoff and followed up by bowling Cameron Green, who offered no shot, the game was in the balance.

Then came Head's stunning assault, which surely extend England's 35-vear winless run at the Gabba.

Rodgers left fuming as sloppy **Foxes slip into Europa Conference**

"There is a lot of naivety in our team, with a lot of young players and it has been a big demand for them this season," he added.

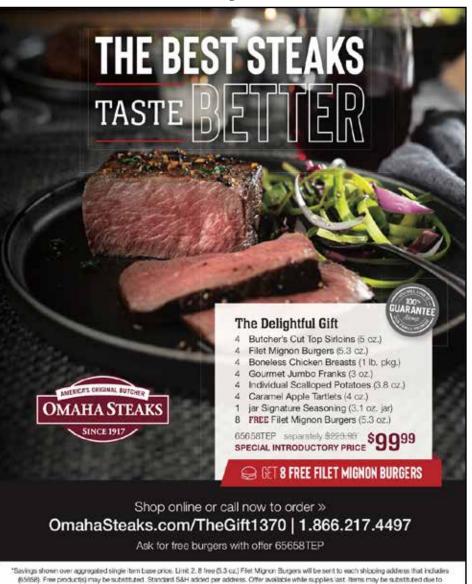
"We have played a number of systems but individually it comes down to having that mentality to track a runner or stop a cross. We were good offensively but it was nowhere near good enough."
