Andrew loses military titles AND use of HRH

"Whether he's guilty or not, he has brought things into disrepute... He's not fit to serve in an honorary rank"

The Duke of York's military titles and royal patronages have been returned to the Queen, Buckingham Palace has said.

Prince Andrew, 61, will also stop using the style His Royal Highness in an official capacity, a royal source said.

It comes as he faces a US civil action over sexual assault allegations - claims he has consistently denied.

A source close to the duke said he would "continue to defend himself" against the case brought in New York by Virginia Giuffre.

But the source insisted a judge's ruling on Wednesday that the civil action could proceed was "not a judgement on the merits of Ms Giuffre's allegations".

Buckingham Palace said in a statement: "With the Queen's approval and agreement, the Duke of York's military affiliations and Royal patronages have been returned to the Queen.

"The Duke of York will continue not to undertake any public duties and is defending this case as a private citizen."

All Prince Andrew's roles have been returned to the Queen with immediate effect, and will be redistributed to other members of the Royal Family, a source said.

The issue had been widely discussed with the Royal Family, the source said.

'unsavory business'

Like Harry and Meghan, Prince Andrew retains his title HRH but will not use it in any official capacity.

A spokesperson for the Ministry of Defence said it had no comment about the duke's military titles being handed back to the Queen, and that it was a

matter for the Palace. On Thursday, a letter - released by antimonarchy pressure group Republic - was signed by more than 150 Royal Navy, RAF and Army veterans asking the Queen to strip Prince Andrew of his eight British military titles.

Lt Hunt, Stuart who served in The 1st Royal Tank Regiment and signed the letter, welcomed the prince losing his military titles but suggested the matter should have been resolved sooner.

The 52-year-old told the PA News Agency: "It's an unsavoury business... I'm just glad he's not associated with the military now.

The duke had a 22year career in the Royal Navy, and served as a helicopter pilot during the Falklands War.

The latest Palace announcement means he has lost military titles including Colonel of the Grenadier Guards one of the most senior infantry regiments in the British army.

The duke will also lose several overseas honorary roles including colonelin-chief of The Royal

by getting into this sort Highland Fusiliers Of 2015. Canada, colonel-inchief of the Royal New Zealand Army Logistic Regiment, colonel-inchief of the Princess Louise Fusiliers of Canada and colonelin-chief of the Queen's York Rangers (1st American Regiment).

But he will retain his service rank of Vice-Admiral, the Palace has confirmed.

As an ex-member of the armed forces, he was promoted in line with his still-serving peers and made Vice-Admiral by the Navy on his 55th birthday in

The duke was due to be promoted to Admiral on his 60th birthday in 2020, but asked to defer this after stepping back from public duties in 2019.

At the time, the Palace said his other military appointments had been suspended.

Several other charities and organisations had cut their ties with the duke, but he continued to hold dozens of royal patronages - including being a patron or member of prestigious golf clubs, schools and cultural trusts.

Boris says sorry for 'Partygate' scandal as (most) Tories rally behind embattled leader

PM apologizes to the House for Downing Street drinks party; opposition parties continue to demand his resignation

CABINET ministers have rallied round Boris Johnson after he apologized for attending a Downing Street drinks party during lockdown.

The embattled Prime Minister was urged to carry on leading the country out of the pandemic and deliver on the people's priorities – in the face of calls for his resignation from both opposition and his fellow Tory MPs over alleged rule-breaking in the No 10 garden.

Leading the plea for unity, Home Secretary Priti Patel urged the Tories to "put our shoulders to the wheel and back Boris to deliver".

And Housing Secretary Michael Gove urged the party's MPs to rally behind the Prime Minister. He said: "Boris gets the big calls right. Now is not the time to go wobbly."

The show of support followed a dramatic statement on the scandal by Mr Johnson at Prime Minister's Questions on Wednesday.

In it, he said: "I offer my heartfelt apologies."

Mr Johnson acknowledged the "rage" felt by many at reports of a "bring your own booze" party for staff in the Downing Street garden.

He said: "I want to apologise. I know that millions of people across this country have made extraordinary sacrifices over the last 18 months."

After days of pressure to explain whether he attended the event, the PM confirmed he spent 25 minutes chatting to staff in the garden to thank them for their efforts in the Government's pandemic response.

Ĥe added: "I believed implicitly that this was a work event. But, with hindsight, I should have sent everyone back inside.

"I regret the way that the event I have described was handled. I bitterly regret it and wish that we could have done things differently."

The PM claimed the event may have "technically" been within the rules but accepted millions did not see it that way while appealing for MPs to await the report of an inquiry by senior civil servant Sue Gray.


He promised the Cabinet Office inquiry will establish the "full facts" about what happened at the Downing Street gathering on May 20, 2020. In angry Commons attacks in response to his remarks, the Labour, Lib Dem and SNP leaders all demanded the PM's resignation.

And several senior Tories, including the party's Scottish leader, also urged him to quit.

But Cabinet ministers rejected the calls and urged the PM to carry on leading the country out of the pandemic.

In a text message to colleagues, Ms Patel said: "The Prime Minister has given his heartfelt apologies and taken responsibility for what has happened.

"Now is the time to put our shoulders to the wheel and back Boris to deliver on the people's priorities." It was claimed 20 out of 28 ministers had publicly backed the Prime Minister. Chancellor Rishi Sunak

to apologize and I support his request for patience while Sue Gray carries out her inquiry."

Deputy Prime Minister Dominic Raab said Mr Johnson had given a "very clear account" of the staff gathering in the Downing Street garden. Mr Raab said: "He has been clear that he believed he was acting in accordance with the rules at the time but, of course, understands the perception that those in power are not following the rules that many others are required to. Particularly those who have been through

hardship or lost loved ones, that's why he has apologised."

Mr Raab described a question about whether he would run for the Tory leadership as "daft".

Health Secretary Sajid Javid said: "I completely understand why people feel let down. The PM did the right thing by apologizing.

"Now we need to let the investigation complete its work.

But Opposition MPs mocked Mr Johnson's claims and called for his resignation. Starmer said: "The Prime Minister is a man without shame."

He accused Mr Johnson of "lying through his teeth". He added: "The party is over, Prime Minister. The only question is, will the British public kick him out, will his party kick him out, or he will he do the decent thing and resign?"

Ian Blackford, the SNP's Westminster leader, said: "If the Prime Minister has no sense of shame, the Tory backbenchers must act to remove him.

"They know that the damage is done."

PM faces an anxious wait

Boris Johnson faces an anxious wait for the findings of an investigation into the Downing Street party claims by a civil servant who holds his fate "in her hands".

Whitehall mandarin Sue Gray, who previously ended the careers of two Cabinet ministers, is probing a string of claims about gatherings.

Ms Gray could wrap up her inquiry as early as next week, although no timetable has been set. Cabinet Office permanent secretary Ms Gray is a former ethics chief. She probed Tories Andrew Mitchell over "Plebgate" in 2012 and Damian Green in 2017, when pornography was found on his Commons computer.

Former senior civil servant Sir David Normington said Ms Gray, 65, was the "best person" to look into the allegations.

He said yesterday: "She has the confidence both

of people who worked in previous governments, Labour and Conservative governments, so we are where we are."

Sir David said it was "fairly unprecedented" for a civil servant to be investigating the behaviour of the Prime Minister and seniorofficials in No 10.

He said: "She will be very aware that she has the reputation and possibly the careers of senior civil servants and possibly of **cont. on page 3, col. 1**

the Prime Minister in her hands.

"That is a very difficult position to be in, however fair and fearless and rigorous you are."

Mr Johnson vowed to make a Commons the statement once inquiry concluded.

During a stormy session of Prime Minister's Questions, Mr Johnson offered "heartfelt apologies" for the "things that we simply did notget right".

He said: "All I ask is that Sue Gray be allowed to complete her inquiry into that day and several others, so that the full facts canbe established.

"I will of course come back to this House and make a statement."

Environment Secretary George Eustice said circumstances were different in No10 in May 2020 than for other workplaces.

He said: "At that particular point obviously, most of us were working from home and even doing interviews from home.

"But it was different in No10 in the sense that the Prime Minister lives there and works there and there was a team dealing with Covid who were working there and had to work from there."

Mr Eustice admitted it was a "very difficult, uncomfortable time for the Prime Minister".

But he said it was for Ms Gray to investigate the reported events. Asked if the Prime Minister would resign if Ms Gray's report exposed wrongdoing, Mr Eustice said: "I don't think we should get ahead of ourselves here. We should take this a step at a time."

Ms Gray will look into seven gatherings, including claims that a No 10 event was held on December 18 2020 – the first allegation of rulebreaking parties.

Omicron leaves overstretched NHS facing some of the most difficult weeks in its history

Rising admissions and staff shortages leave health system on a knife edge

THE embattled NHS is facing some of the most critical weeks in its 73history, vear experts warned this week.

Health bosses said the situation is now so precarious that the quality of patient care is in danger as pressure intensifies.

At least 24 NHS trusts have declared critical incidents because of staff shortages and rising Covid admissions.

It comes as more older people are being admitted to hospital and the uptake of booster jabs is slowing in every age group.

That, coupled with traditional winter pressures, has created a perfect storm - leaving services from emergency care to routine surgery on a knife-edge.

Matthew Taylor, chief executive of the NHS Confederation, the voice of the UK healthcare system, said:

"The weeks ahead will be some of the toughest in the history of the National Health Service.

grim milestone

"Health leaders are battling an unprecedented staffing crisis. The quality of care is at risk of being compromised at a time of rocketing patient demand. NHS organisations do not declare critical incidents lightly but over two dozen have done so far."

Mounting concern over the ability of the NHS to withstand a third successive winter wave comes as the UK reached another grim milestone.

More than 150,000 people have died from Covid within 28 days of a positive test since the pandemic erupted in March 2020. The UK is the first country in Europe to pass the figure. Mr Taylor is demanding an urgent action plan to address

the lack of "resilience" that has seen the NHS stretched to breaking point in the crisis.

He said: "The public inquiry into the pandemic will pose fundamental questions. It is crucial we learn the lessons.

"The NHS did not enter the pandemic in a resilient state following a decade of the lowest real terms funding increases in NHS history. That left us with 100,000 staff vacancies, run-down buildings, a lack of key equipment and without the effective testing capacity."

Pressures are set to increase with a slowdown in the booster jab programme.

shortage

Data show fewer than half of all adults in some of the UK's biggest cities - including Liverpool, Birmingham, Manchester and Nottingham - have had their third jab.

The UK also faces a shortage of fully-qualified surgeons as more than one million elective or operations, non-urgent which in trainees would have gained key experience, have been "lost" to the pandemic.

The monthly number is down 50 per cent on pre-Covid levels in some specialities.

The Royal College of Surgeons warned around half of surgeons in their final two years of training are not meeting "the requirement on numbers experience and to graduate from the training programme".

It prompted college president Prof Neil Mortensen to demand a recovery plan to support higher levels of planned surgery.

According to figures compiled by the Joint Committee on Surgical

Training, some 1,142,967 elective operations that involve trainees assisting or being supervised by a consultant have gone by the wayside.

of non-urgent medical care.

A snap survey showed one in five GPs has had to self-isolate in the past fortnight. Nine in 10 said clinical colleagues had to take sick leave or selfisolate within the same period, but less than half said they could always access lateral flow tests.

Dr Chaand Nagpaul, BMA council chair, said: "Omicron is battering our health service, forcing staff off sick, resulting in untold suffering for patients as a result.

"We currently have a record-breaking waiting list stretching to almost six million.

"These are people in distress, 312,000 of whom have already been waiting more than 12 months. As doctors, it is our job to provide the care they need and it's incredibly distressing when we can't do that."

To add to the crisis, from April all frontline NHS staff in England will need to have the Covid jab - or be redeployed. The boss of one of London's busiest hospitals is worried about losing medics as a result. King's College Hospital chief Clive Kay said his job was to encourage

workers to get jabbed - but 10 per cent of his 14,000 staff remain unvaccinated.

A similar policy is in place in social care in England – with care homes saying it has compounded staffing issues. The NHS is short of about 93,000 workers.

Hospitals are also under pressure from bed blocking, where patients healthy enough to leave wards are unable to do so because councils do not have space in care homes or staff to care for them at home.

One NHS trust recently turned a hotel into a care facility. Staff from Spain and Greece were flown in and at least 30 patients were discharged to stay with live-in carers at the Plymouth Hotel, Devon.

Andrew 'a dead man walking' after legal setback

Outlook for Prince looks bleak as his legal team's latest bid to have sex assault case thrown out fails

PRINCE Andrew was this week described as a "dead man walking" after his legal team's latest bid to have the sex assault case against him thrown out failed.

Prominent British lawyer Mark Stephens also urged the Duke of York to "fall on his sword" for the sake of the Royal Family after US Judge Lewis Kaplan ruled against four attempts to stop a civil trial going ahead in New York.

And an American lawyer claimed Ms Giuffre's lawyers may even try to gather evidence from the Queen, Andrew's wife Sarah or their two daughters, Princesses Beatrice and Eugenie.

Andrew, 61, now faces months of legal wrangling before a possible trial later this year that will leave an indelible black mark on the Queen's Platinum Jubilee.

"nowhere to go"

He will have to endure up to seven hours of questioning by lawyers for his accuser Virginia Giuffre as part of pre-trial evidencegathering – and is even likely to be asked intimate questions about his sex life, relationships and body.

English solicitor Mr Stephens said: "Prince Andrew has nowhere to go. He's effectively a dead man walking as far as the Royal Family is concerned.

"But the one thing he can do is accept the responsibility, accept the blame, accept that he has to fall on his sword for the sake of the wider Royal Family."

Mr Stephens – who specialises in media law, intellectual property rights and human rights with legal firm Howard Kennedy LLP – represented James Hewitt when he revealed his affair with Diana, Princess of Wales. Ms Giuffre, 38, alleges

she was forced to sleep with Andrew when she was 17 – a minor under US law – in London and New York, and again when she was 18 on Little St James in the US Virgin Islands.

Andrew vehemently denies sleeping with her while she was controlled by his friends, the late paedophile Jeffrey Epstein and Ghislaine Maxwell, convicted of sex trafficking late last month.

private parts

The Duke has said he has no recollection of meeting Ms Giuffre, despite a now infamous photo that appears to show him with his arm around the then 17-yearold at Maxwell's house in London.

US lawyer Spencer Kuvin, who has represented victims of Epstein, said "nothing" and "no one" was "offlimits" after the Duke's car crash telly interview in 2019.

He told the Daily Express: "Andrew's disastrous BBC Newsnight interview will haunt him. He mentioned his wife as well as his daughters. They can now all legally be deposed.

"The lawyers could even try for the Queen. I don't doubt they will, but as a sovereign, it will be almost impossible to do." He added: "It is without question the Duke will be asked about his private parts.

"Because if she [Giuffre] can describe them accurately, how would that be if they had not had a relationship?"

Mr Kuvin – who famously asked Epstein to describe his private parts when he was sued by three of his young victims in 2009 – also estimated that Andrew's accuser could win at least £14million in damages.

settlement

Unless the Prince finds further grounds to dismiss the lawsuit, a trial date could be set for between September and December this year. Ms Giuffre's case will now proceed to the "discovery phase", when both sets of lawyers exchange information about the witnesses and evidence they will present at trial.

Andrew could offer to make an out-of-court settlement, but sources close to him say that "is not an option at present".

Meanwhile sources close to Ms Giuffre have cast doubt over whether she would accept a settlement unless the Duke

admitted wrongdoing. Andrew will not need to travel to the US to make his deposition under questioning from Ms Giuffre's lawyer, David Boies.

In his ruling on Wednesday, Judge Kaplan said a 2009 agreement between Ms Giuffre and Epstein protecting "potential defendants" from prosecution was unclear and therefore insufficient to have the lawsuit dismissed. The judge also found her claims against the Duke "legally sufficient" and the New York law she was suing under constitutional.

He also dismissed Andrew's argument that he deserved the allegations against him to be told in much more detail at this stage.

But he gave the Prince aglimmer of hope by suggesting he would get another chance to have the case dismissed after the discovery stage.

If the trial goes ahead, a panel will decide if Ms Giuffre's claims are true on "the preponderanceof the evidence" – not beyondreasonable doubt, as in a criminal trial.

As the swimsuitwearing ex-Playboy model, Lily wore prosthetics to mimic the pin-up's famous bust. And she has told fashion website Porter how playing the Baywatch star was "liberating" but she's "never worked so hard".

Lily said: "I read the books Pamela has written, I read her poetry, I can parrot along to all her interviews.

"I love that about acting; you fit into a




Do you think you could ever see yourself moving back to LA, if not tell us what keeps you in Ohio?

10-man Gunners shut down free-scoring Reds

Carabao Cup: honors even as Arsenal hold Liverpool in semi-final first leg

Arsenal manager Mikel Arteta praised 'fight, his side's determination and brotherhood" after the 10-man Gunners frustrated Liverpool in the first leg of their Carabao Cup semifinal at Anfield on Thursday.

Granit Xhaka was dismissed after 24 minutes for denying a goalscoring opportunity - the Swiss midfielder catching Diogo Jota with a high challenge on the edge of his penalty area as he attempted to cut out Andrew Robertson's pass.

Trent Alexander-Arnold could not punish Arsenal further from the resulting freekick, however, and the visitors produced a resolute defensive display to leave on level terms.

Despite coming under intense pressure it was Arsenal who registered the first shot on target 71 minutes into the contest, but a poor first touch by Bukayo Saka allowed Alisson to smother the England international's shot at close range.

Takumi Minamino blazed over the crossbar when faced with an open goal with Liverpool's best chance of the match in the closing stages.

Root demands 'one last push' from his battered and bruised team

JOE ROOT has urged his England team to make one last push after they secured a dramatic draw in Sydney in the Fourth Test and sign off with victory in Hobart.

But at the end of a miserable Ashes series, during which England have been found to be way off the pace in every department, the skipper's request seems somewhat fanciful to say the least.

Just because the ledger says 'draw' it would be foolish to ignore the fact that it took every last ounce of effort from a broken, bruised and battered team to survive with only their final wicket intact in the fourth Test.

These are not the conditions in which a side is set to turn things around and suddenly find another level at which to operate, especially with potentially two players, Ben Stokes and Jonny Bairstow, carrying injuries into the final game in Tasmania.

ahead and needs to find a way to transfer that confidence to his players, with the help of returning head coach Chris Silverwood.

Silverwood has been given Root's support ahead of the match.

However, for both men it is the support of the players – in the shape of their performances – that really matters most.

And if England collapse in a heap this week having shown a glimpse of something more, it will be a pretty damning statement without the need for words.

Root said: "We need to win this week to instil a bit of pride back in from the way the first three games unfolded.

"We made a small step forward last week in the way we went about things and now we have to shift that into an actual performance. We have to show the desire, character and what this group is about.

"But ultimately you have to put that into wins. We have to take the next step as a team.

"In many ways it is one last push. You can have some time to reflect and relax at the end of it."

There has been plenty of emphasis on player health and well-being in recent months.

Root, though, was also keen to point out the basics of fitness and athleticism when it comes to playing Test cricket.

"They never gave up even though it's extremely difficult against this opponent," said Arteta.

"I said to the players before the game that you have to have a certain attitude and in difficult moments you have to react - I think the boys did that very well," he added.

"We played the game we had to play. I'm expecting now our fans will create an even better atmosphere [in the second leg] than today."

The second leg takes place at Emirates

Stadium next Thursday at 19:45 GMT.

The winner will face Chelsea in the final at Wembley at the end of February, after Thomas Tuchel's side completed a 3-0 aggregate victory over Tottenham on Wednesday.
