Boris 'sorry' as Tory rebels plot ouster

PM apologizes to voters and Queen over Downing Street drinks parties One Tory defects to Labour as rebel group seeks leadership challenge

BORIS JOHNSON faced the most difficult week of his tenure at No. 10 this week, as he was forced to apologize for the 'Partygate' scandal while battling a growing revolt from within his own party.

The embattled Prime repeatedly Minister apologized to both the Queen and voters over drinking parties at Downing St during Covid restrictions, Mr Johnson addressed the issue on Tuesday as a gang of around 20 backbenchers who won seats in his 2019 election triumph met to discuss forcing a vote of no-confidence in him.

Speculation about Mr Johnson's future grew as a seventh MP was revealed to have sent a letter urging a leadership contest to heads of the Tories' influential 1922 Committee

Christian Wakeford, MP for Bury South, was named as having contacted chairman Sir Graham Brady - several more MPs from the latest Commons intake are thought to be on the brink

of sending in letters. The scheming to dethrone the Prime Minister was tagged the "pork pie plot" at Westminster after Tory whips identified Alicia Kearns - MP for Rutland and Melton, home of the pastry meat treat – as one of the ringleaders.

Gary Sambrook, Birmingham Northfield MP, and Chris Loder (West Dorset) – both 2019 arrivals - were named as plotters. Under Tory rules, 54 signatures would trigger a vote. At press time reports suggested that number was around 30. But one unnamed Senior Conservative backbencher hinted they are confident of getting to 54.

Speaking to the BBC, the MP said: "I think we've done it, difficult to tell though. Lots of

The PM's allies were infuriated by the plotters, with one saying: "It's pretty sickening. They were only elected because of him. Most of them are a load of nobodies."

Mr Johnson, in his first official visit in a week, expressed regret over the leaving bash for civil servants at No10 the night before Prince Philip's funeral.

His head bowed in sorrow, he said he took "full responsibility" and apologised to the country.

A Savanta ComRes opinion poll showed nearly two thirds (65 per cent) of voters say the party scandal has made them think worse of the Tories.

including half of those who voted for them in 2019.

But the PM denied he ignored warnings on the garden gathering: "I can tell you categorically, categorically, that nobody told me and nobody said that this was something that was against the rules or was a breach of the Covid rules or we were doing something that wasn't a work event because, frankly, I don't think, I can't imagine why on

earth it would have gone ahead."

On a visit to Finchley Memorial Hospital in north London, he faced press questions on Mr Cummings' claim he lied over rule breaking at No10. Apologising for two sessions hours before the Duke of Edinburgh's funeral, the Prime Minister said: "I deeply and bitterly regret that that happened."

■ Christian Wakeford says whips told him to back Boris or lose school funds

The former Conservative MP Christian Wakeford has alleged that party whips told him he would lose funding for a new high school in his constituency if he did not vote with the government.

The claim came as the senior Conservative William Wragg urged MPs to report government ministers, whips and advisers to the Speaker - and even the police for what he claimed was blackmail attempted of some colleagues suspected of possibly opposing Boris Johnson. Speaking at a Labour

event on Thursday, Wakeford backed up the claims by Wragg that threats involving public money were made by the whips.

"I was threatened that I would not get a school for Radcliffe if I did not vote in one particular way," he said. "This is a town that has not had a high school for the best part of 10 years.

"How would you feel when they hold back the

regeneration of a town for a vote. It didn't sit comfortably. That was the start of me questioning my place, where I was and ultimately to where I am now."

Wragg, who chairs the administration public and constitutional affairs committee (PACAC), which looks into the work of government and the civil service, said whips had threatened to withdraw funding from the constituencies of MPs

In England, one in 15 people were thought to have had the Covid variant during the


week to January 15, the equivalent to around three million people nationally, according to the Office for National Statistics (ONS).

Mr Johnson, wearing a mask, continued: "I can only renew my apologies both to Her Majesty and to the country for

Prince's Twitter account deleted

PRINCE Andrew's Twitter account has been deleted – days after the Queen forced him to step down permanently from his royal roles.

His @TheDukeofYork handle, which he used to promote his work, now brings up a blank page, apart from the message: "This account doesn't exist."

Separately, Andrew's YouTube account is no longer accessible and his Instagram account is now private.

His reduced status is also evident on the British monarchy's official website, where all his honorary positions and charity been links have removed.

Andrew is still listed under "Members of the Royal Family" but the website includes a passage explaining his "military affiliations and royal patronages have been returned to the Queen, and the Duke will continue to not carry out public duties".

It also uses the past tense to describe his royal jobs, saying: "An important part of the Duke of York's role was to support the Queen's work."

Andrew, 61, is still deciding whether to file a new motion to have his

sexual assault civil trial in New York dismissed on the grounds his accuser, Virginia Giuffre, 38, lives in Australia and is not a US resident.

He has also not ruled out asking ex-wife Sarah and daughter Princess Beatrice for witness statements.

Ms Giuffre claims she was forced to have sex with Andrew by his friends, convicted paedophile Jeffrey Epstein and socialite Ghislaine Maxwell.

Denying the allegations, Andrew says he was at Woking Pizza Express with Beatrice and then looking after his daughters at home while Sarah went out on the night in 2001 when Ms Giuffre claims she was assaulted by him at Maxwell's London home.

At a public appearance this week Prince William ignored journalists when asked: "Do you support Prince Andrew?"

But Armed Forces Minister James Heappey branded the Duke's friendship with Epstein as "horrifically illadvised".

Canada's Prince Andrew High School announces plan to change name

■ Nova Scotia school attempts to distance itself from the growing controversy surrounding the Duke of York

A Canadian high school named after the Duke of York has announced plans to rename itself, in an attempt to distance itself from the growing controversy surrounding the Oueen's second son.

The principal of Prince Andrew high school in the province of Nova Scotia told families on Wednesday to expect the change as the school looks for a name that "upholds our values as a safe and inclusive" space.

"The name of a school should be reflective of our school community ... Our hope is to continue to build our identity as a positive, supportive and respectful community, with a name to match," principal Craig Campbell wrote in an email.

The high school of nearly 800 students was named in 1960 to commemorate the birth of Prince Andrew While most students call the school "PA", the recent accusations against the Duke of York mean the name is no longer tenable, the school said.

Community members initially raised concerns over the name in 2019, but efforts to rename the school faced opposition alumni from and residents concerned over the loss of a historical connection.

BBC license fee to be axed, says Culture Secretary

CULTURE Secretary Nadine Dorries says the BBC licence fee will be axed, with the broadcaster funded in some other way.

She has also given hope to over-75s who were forced to fork out to watch.

In a reference to the controversial decision to end free licences for older viewers, Ms Dorries said: "The days of the elderly being threatened with prison sentences and bailiffs knocking on doors are over".

She revealed her plans via Twitter this week, declaring: "This licence fee announcement will be the last."

This came after it emerged the licence fee will be frozen for two years from April.

It is worth £3.2billion annually to the BBC after rising from £157.50 to £159 last year, having tracked inflation since 2017.

Under the BBC's Royal

Charter, the moneyspinner is guaranteed until at least December 31, 2027. After that the way the national broadcaster is paid for will be decided by the Government.

A BBC source said of the fee freeze: "Anything less than inflation would put unacceptable pressure on the BBC finances after years of cuts."

The source added there were "very good reasons for investing in what the BBC can do for the British public and the creative industries and the UK around the world".

An ally of Ms Dorries said: "There will be a lot of anguished noises about how [a fee freeze] will hit popular programmes but they can learn to cut waste like any other business. This will be the last BBC licence fee negotiation ever.

"Work will start next week on a mid-term review to replace the charter with a new funding formula.

"It's over for the BBC as they know it."

The Corporation has been arguing for licence fee rises sufficient at least to cover inflation in the next five years.

That is expected to hit 4.4 per cent next year and the broadcaster says it will struggle to meet the increasing cost of programming if the cash it gets from households does not go up at a similar rate. It pays for BBC shows and services - including TV, radio, the BBC website, podcasts, iPlayer and apps.

But Tory MPs have been arguing that the money people pay could be reduced owing to the success of paid-for streaming services such as Netflix – which costs from just £5.99 a month - and Amazon.

There is also Freeview and YouTube which are free to watch and paid for by advertising.

have already taken place between BBC bosses and the Government over a future funding settlement. Ms Dorries tweeted: "Time now to discuss and debate new ways of funding, supporting and selling great British content."

The BBC will have to negotiate with the Government over an entirely new funding model when the final licence fee funding deal expires in 2027 - with potential options including a subscription service,

part-privatisation, or direct government funding.

A Government source said that "the days of state-run TV are over" and praised the growth of US-run private sector companies such as Netflix and YouTube.

80s Star Hazel out of coma

A MAN shot dead after taking four people hostage in a Texas synagogue was a Briton trying to win freedom for a terrorist dubbed "Lady Al Qaeda".

Malik Faisal Akram, 44, was killed after a 10-hour stand-off with American intelligence officers at Congregation Beth Israel temple in Colleyville, Texas, at the weekend.

Akram, who reportedly backpacks had of explosives and a gun, demanded the US release Pakistani terrorist Aafia Siddiqui – "Lady Al Qaeda" - who police say he called his "sister".

Akram, from Blackburn, stormed into the temple which was live streaming a service on its Facebook page at 11am on Saturday.

His English accent could be heard as he shouted instructions and demanded the release of Siddiqui, who was jailed for 86 years in 2010 after

opening fire on Americans following her arrest in Afghanistan.

He could be heard saying: "You get my sister on the phone" and "I am gonna die". Akram also said: "There's something wrong with America." The feed was later taken down. During "constant contact" between negotiators and hostagetaker, one man was released uninjured shortly after 5pm. Dramatic footage later revealed the moment two other hostages escaped from the temple.

Akram could be seen running out of the door as he chased after them with a gun, but he quickly retreated inside, closing the door after spotting the SWAT team. At 9pm, officers stormed the building and opened fire.

Foreign Secretary Liz Truss condemned Akram's "act of terrorism and antiSemitism". She said: "My thoughts are with the Jewish community and all those affected by the appalling act.

"We stand with the US in defending the rights and freedoms of our citizens against those who spread hate."

In Blackburn, Akram's brother Gulbar issued a statement apologising to the victims and saying Akram had been suffering "mental health from issues".

Gulbar said he had liaised "with Faisal, the negotiators, FBI etc" during the siege but "there was nothing we could have said to him or done that would have convinced him to surrender".

He added: "We do not condone his actions. Any attack on any human being, be it a Jew, Christian or Muslim etc, is wrong and should be condemned."

Stranded dog saved from rising tide after rescuers attach sausage to drone

As the tide rose, it began to look perilous for Millie the jack russellwhippet cross, who had defied the efforts of police, firefighters and coastguards to pluck her from treacherous mudflats.

So the rescuers had to think imaginatively, and came up with the idea of attaching a sausage to a drone and hoping the scent of the treat would tempt Millie to safety. It worked gloriously and Millie has been reunited with her grateful owner after following the dangling sausage to higher, safer ground.

Millie disappeared after slipping her lead in Havant, Hampshire, and after frantic public appeals was spotted on the mudflats, in danger

of being engulfed by the tide. She resisted efforts to encourage her to a safer spot until a drone pilot suggested attaching food to one of the unmanned aerial vehicles that had been used to track the dog.

"It was a crazy idea," said Chris Taylor, the chair of the Denmead Drone Search and Rescue team. But they pressed

ahead and after checking Civil Aviation Authority regulations, and the MTOW [maximum takeoff weight] of their machines, the rescuers calculated they could attach a single sausage to a drone.

Taylor said: "One of the local residents on the beach where we were flying from supplied us with the sausages – I think

they were from Aldi. The woman cooked them up for us and we attached them with string."

To the joy of the rescuers, Millie took the bait.

"If we hadn't had got her away from that area the tide would have come in and she would have

been at risk of drowning," said Taylor. "It was something we had never tried before – the sausages were the last resort, as we couldn't reach her by kayak or any other means. "Because Millie was

hungry it worked at luring her away from the danger to higher ground,

which wouldn't go underwater. We certainly would consider using sausages again: every dog and search operation is always going to be different, but if we were ever in a similar situation again we would employ the same methods to lure the dog."

Happy Silver anniversary, Golden State

This week I reached quite a milestone. 25 years since I first set foot in Los Angeles.

At the time I had no idea that a quarter of a century later I would still be here, and a bona fide American to boot!

My first impression of LA was how damp it smelt; since then whenever I land at LAX that same smell hits me and transports me back to January 16th, 1997.

My visions of warm sunshine and walks on palm tree-lined beaches didn't quite match up to the LA I was greeted with. I was informed it was because it was rainy season; so nothing much has changed there then, has it?

To be honest not a lot else has changed since I made California my home. Being here for so long has actually highlighted the cyclical nature of the city, which is kind of comforting, as when times are tough you know that if you stick around to ride it out it will get better again.

It does feel like crime has definitely increased since I first arrived; although I do recall that the neighborhood Ι currently reside in was a definite 'avoid after dark' back in 1997. Which made me wonder if we are just more aware of it now? Not only do we have constant access to the world wide web via our smartphones but we also have Apps like Citizen and Nextdoor that alert us to everything and

anything that might 'possibly, maybe' be a crime and they even manage to make Pasadena sound like a war zone.

So, of course, my curiosity got the better of me and after a bit more searching on the internet I managed to find a very informative no-nonsense website that just shows stats it'slaalmanac.com. It doesn't sensationalize statistics or appear to have any bias - just plain old-fashioned numbers. It turns out that violent crimes have reduced dramatically (according to the LA Almanac) - during my first year here there were 106,673 in total and 1,176 homicides. Compare that to 2020, there were 54,600 in total and 'only' 677 homicides.

Neither are great numbers but it just goes to show that things are actually improving ... as after being bombarded with headlines like these it is no wonder most of the country is terrified - 'Progressive prosecutors blasted as homicide numbers climb in Los Angeles, other left-wing cities.' (credit to scaremongers -Fox News)

The only other big difference that I can think of is the ever-



CARABAO CUP SEMI FINAL: no Salah, no Mane, no problem as Liverpool ease past Gunners to set up date with Chelsea

Liverpool reached their first Wembley final for six years on Thursday night as a double from Diogo Jota set up a Wembley date with Chelsea in the Carabao Cup.

Jota brilliantly filled the gaps left by Mo Salah and Sadio Mane - away at the Africa Cup Of Nations - as his lethal finishing wrecked Arsenal's trophy hopes for this season after a goalless semi-final first leg at Anfield.

Arsenal started impressively, Alexandre Lacazette hitting the woodwork from a freekick, but Liverpool struck

after 19 minutes when Jota's scuffed shot after a fine run beat scrambling Arsenal keeper Aaron Ramsdale.

Lacazette missed Arsenal's best chance after the break, shooting over when clean through, Liverpool had but chances of their own and sealed their first final in this competition since the 2016 loss to Manchester City when Jota ran onto Trent Alexander-Arnold's pass and lofted a precise finish over Ramsdale with 13 minutes left, the goal given by VAR after initially being disallowed for offside.

Arsenal's miserv when was complete Thomas Partey, on as a substitute after returning from Afcon at midday, received a second yellow card for a senseless late challenge on Fabinho.

The absence of Salah and Mane was bemoaned when Liverpool drew a blank against Arsenal's defiant 10 men in the semi-final first leg at Anfield - but there were no such complaints here, with Jota the matchwinner.

Raducanu 'proud' despite defeat while Murray admits loss 'not good enough'

Emma Raducanu said she was proud of the fight she demonstrated in her second-round match at the Australian Open on Thursday after she was defeated by Montenegro's Danka Kovinic in three tight sets despite suffering badly from blisters.

On а day of disappointment for Britain at Melbourne Park, Andy Murray bowed out with a straight sets defeat to the qualifier Taro Daniel shortly before Raducanu was eliminated.

Due to her injury the 19-year-old was forced to spend much of the match slicing her forehand, which she says unlocked a new part of her game and underlined her fighting spirit after winning the US

Open last year.

"I did discover elements of my game I didn't know I had before, and I can use that going forward," said Raducanu.

"And also I just know that I've got that fight in me. Even if I have, like, one shot, I know that I can pull myself out of deep situations. Because I'm still young, I feel like I can learn a backhand, I can learn some tactics, but it's quite hard to learn or teach someone that fight and grittiness to hang in there when things are pretty much all against you. So I'm quite proud of that."

Raducanu had reached the second round by defeating the former US Open champion Sloane Stephens before she fell

6-4, 4-6, 6-3 to Kovinic. She admitted that she has been struggling with blisters since returning to training after missing a few weeks due to Covid. Raducanu revealed that members in her team did not even want her to compete in Australia but she fought to be there.

"That thought when I was slicing forehands and really struggling, I was, like, 'do I [retire]?' But I didn't want to - as I said, some people in my team didn't want me to even go out there.

"So I fought so hard just to come out to Australia and play here, and I didn't want to go out like that. So I just left it all out on the
