■ England's Lionesses roar to victory at Wembley as football finally comes home

ENGLAND'S 'roarsome' Lionesses brought football home to a jubilant nation at Wembley at the weekend - erasing 56 years of hurt with a 2-1 extra-time victory over our old sporting rivals Germany.

As congratulations poured in for winning our first major football trophy since 1966, the Queen told Sarina Wiegman's superstars: "You have all set an example that will be an inspiration for girls and women today, and for future generations."

A record-breaking TV audience, predicted to be some 20 million, a watching Prince William, cheering celebrities and a thrilling all-female RAF flypast willed on our inspirational footballers to victory.

And 87,192 screaming fans—a record attendance for a women's Euros match – cheered on every England touch.

After an evenly-matched first half, Ella Toone broke the deadlock for the Lionesses with

an exquisite chip over German goalkeeper Merle Frohms in the 62nd minute.

England's well-organised opponents struck back through Lina Magull on 79 minutes.

But then Chloe Kelly chose the best possible moment to score her first international goal with an extra-time winner, toe-poking home a rebound in the 110th minute. Cue joy unconfined. Not only in the already rocking national stadium – but across the nation. With roars from the sofas, the fan zones and the pubs.

This was a breakthrough moment, not only for women's football in England but for its profile across the world.

To coin a cliché –

football was the winner and is now set to inspire boys as well as girls. And maybe even Gareth Southgate's England in this winter's World Cup in Qatar.

The Lionesses started the crunch match as underdogs with the Germans ranked No5 in the world, three places higher, and with a heritage of winning the tournament eight times before.

But as well as taking their chance to drive the game on, England were targeting revenge – with a 6-2 defeat against Germany in the 2009 final still rankling.

After Toone scored, Trafalgar Square erupted in cheers and fan Rihana Bhugalee, 14, from Dartford, said the atmosphere was "very

energetic and lively".

And when Kelly restored the Lionesses' advantage, fans went wild outside Wembley.

Elated supporter Lucy Richards, 19, wept and said: "I can't believe it, what a time to score!"

And at the final whistle match winner Kelly yelled: "This is amazing!" before launching into the chorus

of Neil Diamond's unofficial victory anthem Sweet Caroline. She added: "Thank you everyone who came out to support us.

"This is what dreams are made of as a young girl growing up watching football. To be here and score the winner – wow. I just want to celebrate now!" Captain Leah Williamson said: "I'm

taking it in. I'm so proud to be English."

And scorer Toone admitted: "It's the best moment of my life. I'm buzzing my head off!"

TV host and Three Lions singer David Baddiel, who rewrote the lyrics with The Lightning Seeds for the Lionesses before kick-off, said he can finally say "it's come home".

I'll slash income tax to 16%, vows Sunak

■ Tory leadership hopeful launches hail mary policy to claw back deficit against Truss

RISHI Sunak has vowed to slash the basic rate of income tax to just 16 per cent within seven years in his last-ditch attempt to woo Conservative voters.

The outsider in the race to replace Boris Johnson said that it will amount to a 20 per cent cut – the largest reduction in income tax in 30 years.

But the former chancellor immediately faced renewed accusations of reversing his position on tax from supporters of his rival for No10, Liz Truss.

Chief Secretary to the Treasury Simon Clarke, who is backing the Foreign Secretary, warned: "We cannot afford to wait to help families, they need support now.

"Liz will cut taxes in seven weeks, not seven years."

And a Truss campaign source added: "It's welcome that Rishi has performed another U-turn on tax, it's only a shame he didn't do this as chancellor when he repeatedly raised taxes.

"He has also made it conditional on getting growth first, knowing full well that his corporation tax rises are contractionary. The public and Conservative

Party members can see through these flip flops and U-turns."

Ms Truss has pledged an immediate £30billion in tax cuts if she becomes prime minister.

She has promised to freeze corporation tax and reverse the 1.25 per cent rise in National Insurance to help people with the cost-of-living crisis.

But Mr Sunak insists his No1 priority is to tackle inflation by getting borrowing under control and implementing reforms to improve productivity.

His income tax plan will not come until the end of the decade.

Ms Truss has previously said Mr Sunak's economic scheme will drive the country into recession.

With ballot papers being sent to members this week, Mr Sunak suggested Ms Truss was being "dishonest" with voters with promises of sweeping tax cuts and engaging in an "act of self-sabotage that condemns our party to defeat" at the general election.

While he said his new policy is part of his "radical" tax vision, it builds on his previously-announced 1p cut to

income tax in April 2024.

The deadline for taking off the additional 3p – the end of the next Parliament – could be as late as December 2029.

Tax has dominated the bitter race for Downing Street, with Mr Sunak repeatedly calling his rival's tax-plans "comforting fairy tales".

But Ms Truss' proposals appear to have convinced many of the party faithful, who will elect the next leader. Polls suggest she has a clear lead – with a growing number of senior Tory MPs, including Tom Tugendhat, saying her proposed cuts were based on "true Conservative principles".

Mr Sunak, in

announcing his new personal tax policy, again emphasised the need to control inflation before reducing taxes and suggested Ms Truss' plans would fuel inflation.

He said: "What I'm putting to people is a vision to deliver the biggest income tax cut since Margaret Thatcher's government. It is a radical vision but also a realistic one and there are some core principles I'm not prepared to compromise on, whatever the prize.

"Firstly, I will never

get taxes down in a way that just puts inflation up. Secondly, I will never make promises I can't pay for. And thirdly, I will always be honest about the challenges we face.

"Winning this leadership contest without levelling with people about what lies ahead would not only be dishonest, it would be an act of self-sabotage that condemns our party to defeat at the next general election and consigns us to a long period in opposition."

Doom and gloom ahead, warns Bank amid massive rate increase

The Bank of England warned the UK will fall into recession as it unveiled the biggest interest rates in 27 years this week.

In a dramatic set of forecasts for the economy, the Bank said inflation will surge above 13%, causing the worst squeeze

on living standards for more than 60 years.

Meanwhile, the regulator Ofgem has been accused of an "inhumane" move after its latest changes to the price cap meant energy bills could more than double to £4,200 a year by January.

More trouble for Labour leader

Keir Starmer has been found to have breached the MPs' code of conduct by failing to register eight interests on time, including gifts from football teams and the sale of a plot of land.

When the standards commissioner launched the inquiry into the Labour leader, Starmer

insisted he was "absolutely confident" he had not broken the MPs' code of conduct. Ruling that he had breached the code, Kathryn Stone noted the "breaches were minor and/or inadvertent, and that there was no deliberate attempt to mislead".

Boris bashes foes at wedding party

BORIS Johnson joked to his wedding party guests that his removal from No10 was the "greatest stitch-up since the Bayeux Tapestry".

The Prime Minister wore a beige linen suit as he and Carrie celebrated last year's marriage at Daylesford House – the home of JCB chairman Lord Bamford – near Chipping Norton.

One guest on Saturday revealed Mr Johnson, 58, quipped he had received "masses of letters to resign, mostly from my closest family".

Carrie, 34, delivered a "touchingly funny" speech that was "full of affection" for the PM.

She wore a £3,500 gown designed by Savannah Miller – older sister of actress Sienna – that she had rented for £25 from a website.

The bash celebrated the Johnsons' marriage in May last year at Westminster Cathedral.

Police 'tasered' 93-year-old amputee

Two police officers are being investigated on suspicion of manslaughter after a 93-year-old amputee with dementia was tasered and later died.

Sussex Police were called to the care home in St Leonards-on-Sea following reports that a wheelchair-bound male resident was threatening staff with a knife. It is understood that the man, Donald Burgess, was in a room away from other staff and residents by the time officers arrived. One of the officers deployed their pepper spray, and used their baton to try and restrain him. The second officer fired his Taser.

Leaders mourn peace broker Lord Trimble

POLITICAL leaders at the funeral of Lord Trimble this week were urged to break the deadlock over the Stormont assembly as a tribute to one of architects of the Northern Ireland peace process.

Nobel Peace Prize winner Lord Trimble died last week aged 77.

The former leader of the Ulster Unionist Party played a key role in forging the 1998 Good Friday/Belfast Agreement that ended decades of conflict in Northern Ireland.

Its assembly is currently suspended, with the Democratic Unionist Party refusing to take part in the power-sharing administration in protest at the Brexit Protocol.

Rev Dr Charles McMullen asked mourners: "Can we use this service today, in a fitting tribute to one of the greats, to redouble our efforts so our democratic institutions are quickly restored and we can all move forward?"

Lord Trimble's widow, Lady Daphne, took her place in the front row as the coffin was carried into the church by their sons and daughters.

Boris Johnson and former Taoiseach Bertie Ahern were among those at Harmony Hill Presbyterian Church in Lisburn, County Antrim, for the funeral of the former first minister.

Former Sinn Fein president Gerry Adams was also at the service.

After the Good Friday deal was signed, David Trimble was jointly awarded the Nobel prize with SDLP leader John Hume in recognition of their efforts to stop the bloodshed and establish a power-sharing system of governance.

Facing £3m legal bill, unrepentant Vardy blames it all on sexism

■ Rather than clearing name, ruling leaves Vardy with legal defeat and destroyed reputation

A "devastated" Rebekah Vardy has lost her libel case against Coleen Rooney, leaving her facing a bill for millions of pounds in legal costs as she claimed the judge had "got it wrong".

In a damning high court judgment in the "Wagatha Christie" case on Friday, Vardy was described as an "untrustworthy witness" who was likely to have destroyed potentially crucial evidence on purpose.

Mrs Justice Steyn concluded Vardy probably worked with her agent, Caroline Watt, to leak stories from Rooney's private Instagram account to the Sun, providing tips to tabloid journalists and aiding them with their inquiries.

'evasive'

Vardy now faces a substantial legal bill, reportedly around £3m, after deciding to pursue the case to trial. She must also deal with a reputation left in tatters after the judge's 75-page ruling described her evidence as "inconsistent", "evasive" or "implausible".

The judge was highly critical of the loss of key communications in the case. She said it was not believable that Watt accidentally dropped her mobile phone in the North Sea shortly after a legal request was made to search its WhatsApp messages.

After the ruling, Vardy pleaded with those who had subjected her to abuse to stop, adding: "As I explained in my evidence, I, my family and even my unborn baby were subjected to disgusting messages and vile abuse following Coleen's post and these have continued even during the course of

the trial.

"The case is over," she said, adding: "I am extremely sad and disappointed at the decision that the judge has reached. It is not the result that I had expected, nor believe was just. I brought this action to vindicate my reputation and am devastated by the judge's finding."

"The judge accepted that publication of Coleen's post was not in the 'public interest' and she also rejected her claim that I was the 'Secret Wag'. But as for the rest of her judgment, she got it wrong and this is something I cannot accept."

Speaking several days after the verdict, Vardy said she feels there was "a lot of sexism" in the coverage of the case.

In her first TV interview since losing the case, Vardy opened up about the mental health struggles she has experienced since the row began.

'misogynistic'

TalkTV's Kate McCann asked Vardy whether she thought the scrutiny by the media surrounding how she and Rooney dressed during the trial was influenced by sexism, to which she replied: "Totally - the whole thing was presented in such a misogynistic way."

Vardy, 40, pointed out that she does not think Johnny Depp's attire was subjected to the same level of observation during his recent high-profile trial with Amber Heard.

She added: "It just seems like women aren't allowed to defend themselves. Women aren't allowed to dress nicely. Yeah, there's a lot of sexism involved in it."

Treason charge for Windsor crossbow man

A man allegedly found with a crossbow in the grounds of Windsor Castle on Christmas Day has been charged under the Treason Act.

Jaswant Singh Chail, 20, has also been charged with threats to kill and possession of an offensive weapon.

Mr Chail, from Southampton, is in custody and will appear at Westminster Magistrates' Court on 17 August.

The charges were brought after an

investigation by the Metropolitan Police's Counter Terrorism Command.

Mr Chail was arrested at about 08:30 GMT on Christmas Day. The Met said he was stopped "within moments" of entering the grounds and he did not enter any buildings.

He has been charged with an offence under section 2 of the 1842 Treason Act, namely "discharging or aiming firearms, or throwing or using any offensive

matter or weapon, with intent to injure or alarm her Majesty", said Scotland Yard.

The Queen had been staying at Windsor Castle for Christmas, rather than spending it as usual on her Sandringham estate in Norfolk.

Under the 1842 Treason Act, it is an offence to assault the Queen, or have a firearm or offensive weapon in her presence with intent to injure or alarm her or to cause a breach of peace.

Ten teenagers jailed for Jack's unprovoked murder

■ 18-year old Jack Woodley was stabbed to death in brutal 80-second attack

Ten teenagers who murdered an 18-year-old man in a gang attack have been sentenced.

Jack Woodley, 18, died from a single stab wound during an 80-second attack in which he was punched, kicked and stamped upon by 10 youths.

All 10, now aged between 15 and 18, were convicted of murder and sentenced to life with minimum terms of between eight and 17 years.

Nine of them have launched appeals against their convictions.

A murder trial heard Mr Woodley, from Sunderland, had attended the final night of the Houghton Feast funfair in Houghton-le-Spring on 16 October.

Whilst there, he came to the attention of a group of youths who prosecutors said were intent on attacking someone.

He refused when they challenged him to a fight but they followed him out of the fair accompanied by about 30 to 40 youths.

As Mr Woodley neared the Britannia Inn, a 16-year-old boy ran up and punched him from behind triggering a melee during which a 15-year-old boy fatally stabbed Mr Woodley in the back.

The judge Rodney Jameson QC said each youth, none of whom can be identified, was responsible for Mr Woodley's death but their involvement varied.

He said any of the youths had the opportunity to withdraw from the attack but the "mob mentality took over and it cost Jack his life", although he said not all of them "intended to kill".

The judge said Mr Woodley was "standing on the threshold of his adult life" having got keys to his new home that day and was due to start a new job the following Monday.

"He had much to look forward to and must have had high hopes for the future," he said, adding: "None of those hopes will now be fulfilled."

He said the feast was seen as an "opportunity" by some young people to fight over "trivial rivalries" between neighbouring communities and Mr Woodley was marked by the attackers as being a "townie".

The judge said while it may seem "unfair" the youths could be released from prison at a relatively young age, the loss of Mr Woodley had to be balanced against each defendant's age, individual circumstances, actual involvement in the killing and chances of rehabilitation.

He said no sentence could compensate Mr Woodley's family for their "permanent and irreversible" loss and it was "not a measure of the worth" of his life which was "beyond calculation".

Even once they are deemed suitable for release by a parole board, each boy would remain on licence for the rest of their life, the judge added.

High Court judge rules against family of brain-dead Archie

IN A CASE which has deeply divided Britain, a High Court Judge this week ruled that a brain dead twelve year old boy cannot be moved by his family to a hospice for withdrawal of treatment.

The family of 12-year-old Archie Battersbee applied for permission at the court after the European Court of Human Rights (ECHR) refused a request to delay the withdrawal of life-sustaining support.

Archie's mother wanted him "in a peaceful hospice to say goodbye".

But doctors warned he was too unstable to move by ambulance and it would "hasten premature

deterioration".

Responding to the hospice ruling, Archie's mum, Hollie Dance, said: "All our wishes as a family have been denied by the authorities.

We are broken, but we are keeping going, because we love Archie and refuse to give up on him."

Archie (pictured, right), who is being treated at the Royal London Hospital, was found unconscious at home in Southend, Essex, on 7 April - his mother believes he may have been taking part in an online challenge.

He suffered "catastrophic" brain injuries and doctors think it is "highly likely" he is

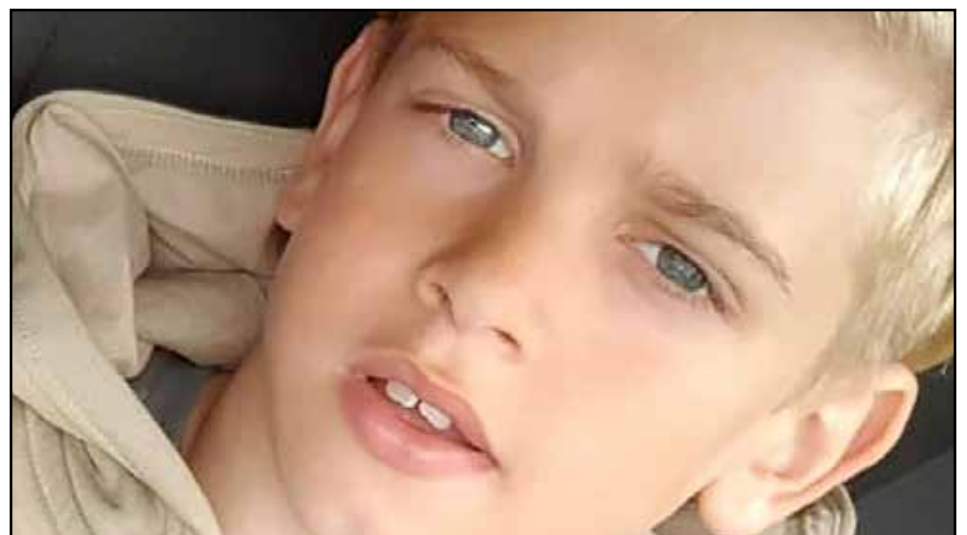
brain-stem dead.

Life-sustaining support, including mechanical ventilation and drug treatments, has been in place since April.

Three justices at the Court of Appeal are considering an application from Archie's family for permission to appeal the latest decision.

The judge has also refused permission to appeal against her ruling after lawyers for the family requested it.

Mrs Justice Theis granted a stay on the withdrawal of treatment until 2pm on Friday to allow time for a challenge to be lodged at the Court of Appeal - which Archie's family



confirmed they had done by 1.30pm.

Archie's family's application for permission to appeal will be now decided by three judges considering the written arguments

without a hearing.

Speaking after the judgment was delivered, Ms Dance told Sky News she feels "sick" and said it was an "outrageous decision".

In a later statement,

Ms Dance said: "All our wishes as a family have been denied by the authorities. We are broken, but we are keeping going, because we love Archie and refuse to give up on him."

Beloved comedy panel show **Mock The Week** has been axed after 17 years.

Presenter and comedian Dara O Briain, who fronted over 200 episodes of the programme, confirmed the news, sarcastically saying the ‘UK has finally run out of news’.

‘The storylines were getting crazier and crazier – global pandemics, divorce from Europe, novelty short-term prime ministers,’ he said. ‘It couldn’t go on.

‘And so, regrettably, we are closing the doors on Dara and Hugh’s Academy for Baby Comedians.

‘We just couldn’t be more silly than the news was already. Huge thanks to all our guests over the years, so many of whom went on to huge successes of their own, and never

write or call. It was a joy!’

Mock The Week has been credited with launching a number of comedians into household names, including the likes of Frankie Boyle, Angela Barnes and Russell Howard.

The long-running topical show will finish after the upcoming 21st season, due to air in the autumn.

Comedian Barnes, who appeared on the show regularly over the past few years, referenced one of its regular features, Unlikely Things, as she tweeted: “Mock The Week has been a massive part of my comedy life, thanks for having me along for the ride.

‘I’ve made many memories and many friends, and will be so sad to wave it off. On the bright side, I had LITERALLY

just run out of ideas for unlikely things to hear in an action film.”

After lamenting the news, Laura Lexx, who appeared in the last two series, said: “At least I got to do it. It was THE show to watch when I was a teenager and getting to sit on that panel was incredible so at least I didn’t miss it.”

Mock The Week was created by Dan Patterson and Mark Leveson, the duo behind comedy improvisation show *Whose Line Is It Anyway?*, which ran in the UK before becoming a hit series in the US.

Patterson said the decision was “desperately disappointing but hopefully we will resurface again soon”.

In a statement announcing the move, the BBC said: “We are really

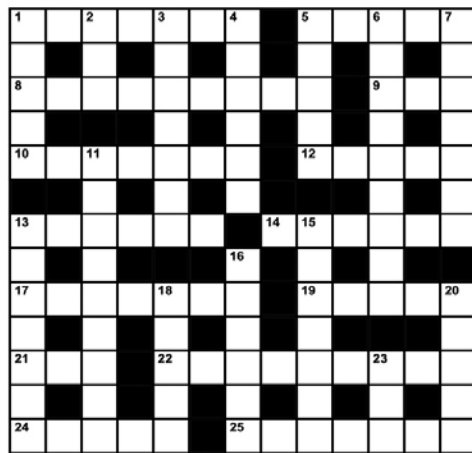

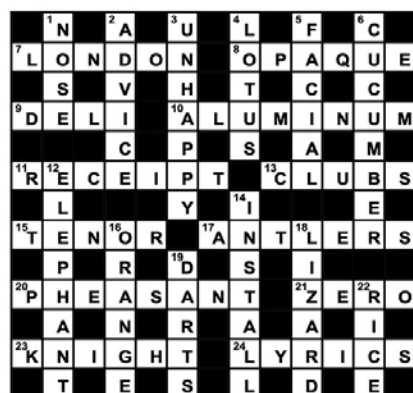

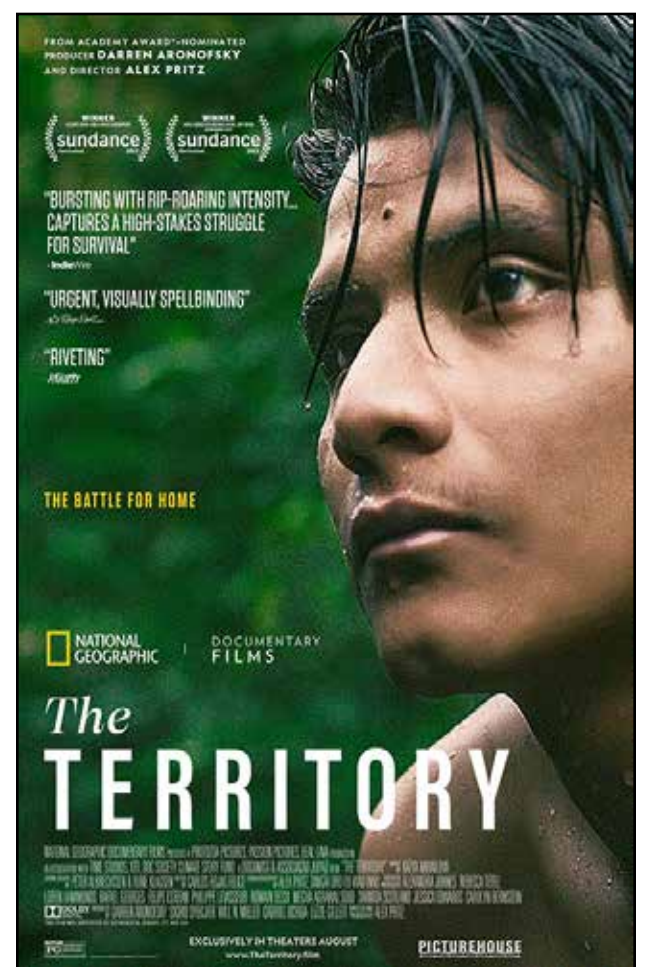
location) we have some slots available for Idris Elba's latest film, Beast.

Summer signing Darwin Nunez sealed victory as Liverpool landed the first blow of the season on champions Manchester City by winning a thrilling Community Shield encounter at the weekend.

The FA Cup winners were pipped to the Premier League title by a single point last term after a season-long fight with City, but came out on top in a tremendous game in Leicester.

Playing at the King Power Stadium rather than Wembley - which will host Sunday's Women's Euros final - the two sides did not hold back in a match that tends to be badged as a 'glorified friendly'.

Reds full-back Trent Alexander-Arnold scored the opening goal with a curling effort from the edge of the box which took a slight deflection off Nathan Ake and nestled in the far corner.

He celebrated by raising his finger to his lips in front of the City supporters, who had helped generate a thunderous atmosphere by trading jibes with their Liverpool counterparts.

City's star summer signing Erling Haaland showed glimpses of what he will bring by drawing a good save from Adrian, while Nunez had a one-on-one effort kept out by Ederson.

But it was another newcomer - Julian Alvarez - who scored next, staying alert after Phil Foden's shot was saved to poke home the equaliser from close range, with the goal awarded after a lengthy VAR check.

Mohamed Salah edged Liverpool back in front by scoring from the penalty spot with eight minutes remaining after referee Craig Pawson adjudged - from looking at the

Howe signs new and improved Toon deal

Newcastle United manager Eddie Howe has signed a new long-term contract just nine months after being appointed.

Howe joined the Magpies on a deal which ran until the summer

of 2024 when he took over from Steve Bruce in November 2021.

Newcastle were 19th in the Premier League at the time, five points from safety after 11 games, and he guided them to an 11th-place finish.

Howe said it was "a great feeling to commit" his future to the club.

"I'm extremely proud to be the head coach of Newcastle United and have enjoyed every moment here," he told reporters on Friday.

Lionesses 'changed the country'

EURO 2022: England women's captain hails team as football comes home

Captain Leah Williamson said her England side have "changed the game in this country" as she celebrated their historic Euro 2022 victory.

The Lionesses won their first major trophy as they beat Germany 2-1 in extra time at Wembley on Sunday.

They lifted the trophy and sang Sweet Caroline in front of thousands of fans at Trafalgar Square on Monday.

"We said we wanted to make our legacy about winning and that's what we did," Williamson said.

"The legacy of the tournament was already made before that final game - what we've done for women and young girls who can look up and aspire to be us.

"I think England have hosted an incredible tournament and we've changed the game in this country - and hopefully across Europe and across the world."

The Football Association is now set to hold talks with manager Sarina Wiegman about extending her contract with England after Sunday's success.

Dutch woman Wiegman, whose deal with England currently runs until 2025, has now won back-to-back European Women's Championships, after guiding the Netherlands to the title in 2017.

"She will have a couple of weeks off. When she gets back, we'll have a conversation," said Baroness Sue Campbell, the FA's head of women's football.

On the legacy of England's Euro 2022 triumph, FA chair Debbie Hewitt said: "We've got to get girls across the country playing football in schools.

"Once they have that opportunity, all of them, to play in schools and associate them with the clubs, then you will see

this just take off. It will be like rocket fuel, the impact of the win."

Hewitt said the Premier League could play its part in supporting the legacy of Euro 2022 by continuing to invest in the women's game.

She said: "We had over 17 million viewers last night watching this game in this country. If you are the Premier League. Why wouldn't you want to capitalise on that?"

England midfielder Fran Kirby said she wanted the success of Euro 2022 to "become normal".

"We want it to be that people come in to watch, and with sellout crowds in this country and all over the world, so hopefully we've played a big part in that and hopefully we can continue to grow it," Kirby said.

Ella Toone, who scored England's first goal in the final, added: "That's what we set out to do in this tournament - make

the nation proud, fight for women and get young girls involved as well and I think we've done that for every single woman in this world."

With less than a year until the women's World Cup in Australia

and New Zealand, expectations will be high for the new European champions.

"I think we should take time to reflect on this one first, enjoy this one before we start thinking about that [World Cup]," said

Kirby.

"Of course there's going to be a lot of expectation going into that, but we have an amazing squad, we have an amazing manager, so yeah, we're really excited."
