

Distraught family pledge justice for tragic Olivia

■ Liverpool left reeling after senseless murder of nine-year-old girl

THE family of nine-year girl who was killed in her home as the tragic victim of warring gangsters, have pledged to the slain youngster: "We will find who did this and we will get justice for you."

Olivia Pratt-Korbel was shot dead Monday night by a balaclava-clad gunman who entered her house while chasing a suspected rival.

Terrified Olivia was cowering behind her mother Cheryl Korbel, 46, when she was blasted in the chest by the mystery shooter aiming for another man who burst into her Liverpool home looking for safety on Monday night.

The man, later named by police as Joseph Nee, ran into Olivia's home on Kingsheath Avenue in Dovecot, followed by a masked gunman at about 22:00 BST on Monday.

Her mother Cheryl Korbel had opened her front door in response to the commotion outside.

Olivia was fatally shot and Ms Korbel was shot in the wrist as she tried to shut the door. Nee was shot in the upper body.

The gunman ran away before Nee was driven away in a black Audi.

In a heart-wrenching Facebook tribute the schoolgirl's family said they had lost "our Liv" and pledged to help remove weapons from the streets.

'heart aches'

Olivia's cousin, identified only as Rebecca Louise, said: "Our crazy beautiful Olivia. I can

only apologise for the cruel world we live in and the monsters in it.

"We WILL find who did this and we WILL get justice for you, baby girl. Lewis & I love you SO much it hurts.

"My heart aches so much and I don't think

we will ever digest what's happened. Forever nine years young.

"We all know we're in everyone's thoughts and we know we have not only the hearts of the city but the hearts of a nation behind us.

"Let's put this into

action and get these weapons off our streets."

A GoFundMe page set up to help Olivia's family has raised more than £25,000 at press time.

Rebecca said: "The outpouring of love since my last post has been

Man fleeing Olivia's Killer was in drug gang

■ Joseph Nee was arrested at hospital shortly after the killing

THE man who was shot and injured by Olivia Pratt-Korbel's killer was described as a "trusted foot soldier" of a drugs gang by a judge.

In 2009 Joseph Nee, now 35, was convicted of helping flood Liverpool with heroin and crack cocaine.

He was jailed for six-and-a-half years for his role in a gang driven by a "greed for the good life". They spent their money on luxury flats, TVs, high-end cars and

designer gear.

Police believe they only scratched the surface of the operation when they seized nearly 30,000 packages of drugs.

Merseyside officers said in 2009 the gang – which operated in the Kensington area of the city – stored weapons, including a machine gun, to ward off rivals.

Nine years later, career criminal Nee was jailed for 45 months for two counts of burglary and two counts of theft of a

motor vehicle. He also admitted dangerous driving, driving without insurance and driving while disqualified.

He and two other men were jailed for almost 10 years in 2018 after leading police on a 125mph chase through Cheshire and Merseyside.

Due to the excessive speeds officers withdrew from the pursuit but monitored the men from the force helicopter. The men eventually stopped

in Huyton, where all three abandoned their vehicle and fled.

They were arrested a short time later. Nee was wounded on Monday night after being targeted by a balaclava clad gunman on Kingsheath Avenue in the Dovecot area of Liverpool.

Nee, who was shot twice, was taken to hospital by associates in an Audi which collected him.

He had surgery for gun wounds before

being arrested by police for breach of his prison licence – for which he will be returned to serve the rest of his sentence. Detectives will continue to question him about Olivia's killing.

18%: Inflation expected to soar to highest level in 50 years

Inflation in Britain is expected to soar to its highest level in nearly 50 years, leaving millions of people struggling to cope.

Experts warn the relentless rise could see prices increasing by 18.6 per cent in January.

Such a sky-high inflation rate, last seen in 1976, would be "catastrophic" for older people, warned Dennis Reed, director of campaign group Silver Voices.

He said: "Millions will be thrown into poverty unless the Government takes radical action."

Caroline Abrahams, charity director at Age UK, claimed the forecast

would "strike fear into the hearts" of many people in retirement as it will take prices for essentials beyond their means.

She added: "The Government must act quickly – people urgently need reassurance they will not be abandoned and help is on the way."

'dire straits'

Sarah Coles, a senior personal finance analyst at Hargreaves Lansdown, said there were 10 food groups that have seen their prices rise more than 18.6 per cent in the past year – including bread, milk, pasta and butter.

She insisted: "Inflation at 18.6 per cent would

push millions of people into dire straits.

"And because these horrible price hikes are being driven by the essentials people need to stay alive – like food and heat – it's going to hit those on lower incomes hardest, who have nothing left to give."

The 18.6 per cent prediction, from investment bank Citi, was in line with separate predictions from the Resolution Foundation of 18.3 per cent. Experts at investment firm Goldman Sachs and accountants EY said inflation would be at least 15 per cent in the new year.

Benjamin Nabarro,

Citi's chief UK economist, warned affordability concerns were "growing more deafening by the day". He added: "The question now is what policy may do to offset the impact on both inflation and the real economy."

Mr Nabarro forecast that inflation will jump to 14.8 per cent in October after last week's 25 per cent rise in gas prices and seven per cent rise in electricity prices.

massive jump

Analysts predict the autumn energy price cap announced on Friday, will see a typical household paying £3,554 per year – with this rising to £4,650 from January.

It means between October and April – which includes the coldest months – the average household will pay an equivalent £4,102 per year for gas and electricity, a massive jump from today's figure of £1,971.

Consultancy Cornwall Insight warned that households will face an 80 per cent rise in bills going into the winter period when energy use soars.

It added: "While the energy price cap rise in April was already an unprecedented increase in domestic

consumer energy bills, predictions for October are concerning.

"With the cost of living spiralling and households looking at an energy bill rise of over £1,500 equivalent per year, it is difficult to see how many will cope with the coming winter."

Energy firm Utilita called for the Conservative leadership contest to be halted so the Government can take emergency action.

Chief executive Bill Bullen customers were in "distress" and "this cannot wait until September". He has written to Business Secretary Kwasi Kwarteng about the issue.

He said: "We have to get ahead of this problem, and the way to do that is to freeze the energy price cap at the current level.

"This will stop energy prices fuelling inflation. This will take away the fear of being able to heat a home. This will stop the need for further major additional help."

The inflation rate is being driven by soaring energy costs.

Octopus Energy chief executive Greg Jackson said: "There are systemic issues. There are loads of questions of how we pay for this. One thing we

can't do is be expected to pass those costs on to consumers." Business and industry warned firms will go to the wall unless the Government finds a way to help them manage their bills.

The producer price inflation (PPI), which measures changes in costs to industry, was 22.6 per cent in the year to July. In June, it hit 24.1 per cent, the highest rate since records began in January 1986.

James Brougham, economist at Make UK which represents manufacturers, said the PPI rate meant he was "pessimistic" high inflation will continue into 2024.

And he added: "It is impossible for that not to trickle down to CPI at that level." More than half of his members have said a sustained 20 per cent cost rise would be "catastrophic".

Mr Brougham said costs were driven up by the pandemic because there was elevated demand globally after lockdown lifted that "supply just cannot meet".

Rising oil prices have been the biggest strain followed by metals, bricks, glass and chemicals but it is "across the board".

overwhelming to say the least.

"People from all over the UK have sent their condolences with offers of help and we as a family couldn't be more grateful."

Sharing a photo of his niece in an emotional tribute on Facebook, Olivia's uncle Peter Korbel said: "Our family will remember this picture of my beautiful niece with happiness and pride... this tiny cheeky little girl with the Korbel attitude thrown in and then some xx."

'best friend'

During the week more floral tributes were placed close to the scene.

One read: "RIP baby girl, can't believe what has happened, feels like a nightmare. We will miss you so much our sassy queen. Love aunty Kim and uncle Tony."

Olivia's best friend Hattie and her brother Logan shared a touching tribute.

Hattie said: "Olivia you are the best friend anyone could wish for, like my big sister. I will miss you so much. Lots of love Hattie xx." Logan, who was in Olivia's class at St Margaret Mary's Primary School, said that "school won't be the same".

Nee was described by police as a "trusted foot soldier" for drug gangs. He was jailed for 45 months in 2018 for a string of burglaries but was released on licence last year.

He was arrested in hospital this week and will return to prison to serve the rest of his sentence for breach of licence.

Cheryl, who had two older children in the house, suffered a gunshot wound to the hand - with the fatal bullet that killed Olivia.

Expensive energy a price we must pay for Ukraine's freedom, declares Boris

■ "The people of Ukraine are paying in their blood," says PM during Kyiv visit

High energy bills are the price freedom-loving nations must pay to ensure Ukraine's continued independence, Boris Johnson said this week during a surprise visit to Kyiv.

Speaking on Wednesday, the Prime Minister showed unwavering support for the embattled people 'paying in their blood'.

The Prime Minister said "if we're paying in our energy bills for the evils of Vladimir Putin, the people of Ukraine are paying in their blood".

military aid

Making his last trip to Ukraine before leaving office, Mr Johnson set out a further £54 million of military aid, including drones to target Russian

forces.

His meeting with President Volodymyr Zelensky came on Ukraine's independence day, marking 31 years since breaking from Moscow's rule following the collapse of the Soviet Union.

Mr Johnson said Russian President Mr Putin had been "insane" to launch the invasion and the resistance had been like "an indomitable Ukrainian boxer".

soaring gas prices

The conflict, and the economic sanctions imposed on Russia, have contributed to soaring global gas prices which have driven up household bills.

Mr Johnson warned that British households will "have to endure the

cost-of-living crisis" in order to counter Russia's "inevitable manipulation of energy prices".

The Prime Minister will leave office on September 6, the day after either Liz Truss or Rishi Sunak emerges

as the victor in the Tory leadership contest.

He stressed that "the UK will continue to stand with our Ukrainian friends" and used his meeting with Mr Zelensky to set out a further package of

military aid, including 2,000 drones and loitering munitions.

He also received the Order of Liberty, the highest award that can be bestowed on foreign nationals, for the UK's support for Ukraine.

Former F1 boss denies £400 million tax fraud

Tycoon Bernie Ecclestone has denied that he hid more than £400million from the taxman.

In court on Monday, the 91-year-old (pictured, right) confirmed his name and address, and indicated he would plead not guilty at trial.

He is accused of failing to disclose a trust in Singapore with a bank account containing about \$650 million.

Flanked by lawyers and security staff, the billionaire former Formula 1 boss arrived at Westminster Magistrates Court in central London in a white Range Rover.

TV crews and photographers outside court had been warned by police not to "mob" Ecclestone because of his age.

Chief magistrate Paul Goldspring allowed him to stand outside the dock

after his counsel Claire Montgomery QC said he had a "little trouble hearing".

He was charged with fraud by false representation between July 13, 2013, and October 5, 2016, following an investigation by HMRC, the court heard.

At the end of the five-minute appearance, Mr Goldspring granted Ecclestone, of Knightsbridge, west London, bail until a preliminary hearing at London's Southwark Crown Court on September 19.

The Crown Prosecution Service authorized the charge against Ecclestone last month, after reviewing evidence from HMRC.

At the time, Chief Crown Prosecutor Andrew Penhale said the accusation was "in

respect of his failure to declare to HMRC the existence of assets held overseas believed to be worth in excess of £400million".

The three-times married former 1950s Grand Prix driver built his success through the sale of TV rights and administration of F1. He cut ties with the sport in 2020.

Police mulling 'legal options' over PC who urinated in York shop

■ Police chief says actions of Amelia Shearer, 24, 'incompatible' with expectations of officers

A police force is considering its "legal options" over an officer who urinated in a shop changing room while drunk and off-duty, and who later lied about it.

Amelia Shearer, 24, was found guilty of gross misconduct at a disciplinary hearing this week, following the incident that took place at the York branch of Urban Outfitters. Shearer was given a final written warning that will last five years.

Chief Constable Mark Webster of Cleveland police, which Shearer joined as a junior officer in 2019, has expressed concern about the outcome of the disciplinary hearing, saying Shearer's actions were "incompatible"

with the force's expectations of its officers and that "legal options" were being explored.

Webster said: "Officers must adhere to the highest standards of behaviour and exemplify our values, whether on or off duty. The actions of this officer are incompatible with my expectations for those who serve in Cleveland and out of keeping with their role, which other officers uphold with pride and integrity."

'public confidence'

"Cleveland police's department of standards and ethics prepare evidence for misconduct hearings. Evidence is heard and a determination made

by a panel chaired by an independent, legally qualified chair.

"The misconduct process is in place to protect our standards and ensure public confidence in policing so we are concerned by the outcome determined at yesterday's hearing. We are now considering the legal options available to us."

The incident, which occurred in September, happened after Shearer and a friend had multiple drinks at a bottomless brunch, before having more drinks at another venue.

The hearing heard evidence from an Urban Outfitters employee who was asked by Shearer if the store had toilets. She was told "no" and

immediately went into a cubicle without trying on any clothes. The employee radioed for his manager, and when Shearer came out of the cubicle, they saw a pool of what smelled like urine on the floor. Although she hurriedly left the shop, Shearer

was later tracked down in the city by police.

Shearer strenuously denied having urinated, but did acknowledge she and her friend were "loud and giggly".

The store paid £492 to have the cubicle professionally cleaned and the retailer's nine

fitting rooms had to be temporarily closed.

Olivia Checa-Dover, the barrister representing the force, told the panel its findings that Shearer had been dishonest meant she was now "undeployable" as an officer.

Lowly Wrexham FC 'heading for the Premier League'

■ Hollywood celebrity owners pledge bright future for Welsh club

LOWLY Wrexham FC are heading for the Premier League, said the club's Hollywood-actor owners.

Stars Ryan Reynolds and Rob McElhenney paid £2million for the struggling football club two years ago.

Last season Wrexham narrowly missed out on promotion to League Two are currently fifth in the National League, the game's fifth tier.

But Deadpool and X-Men star Ryan says the sky's the limit. He said: "It really is about putting Wrexham on a world stage to build this team.

"It's an underdog story and that's

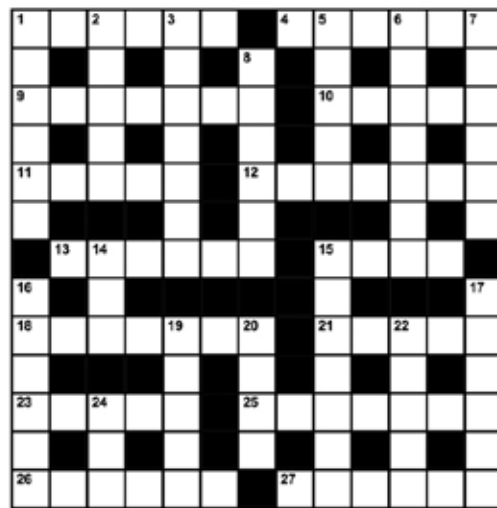

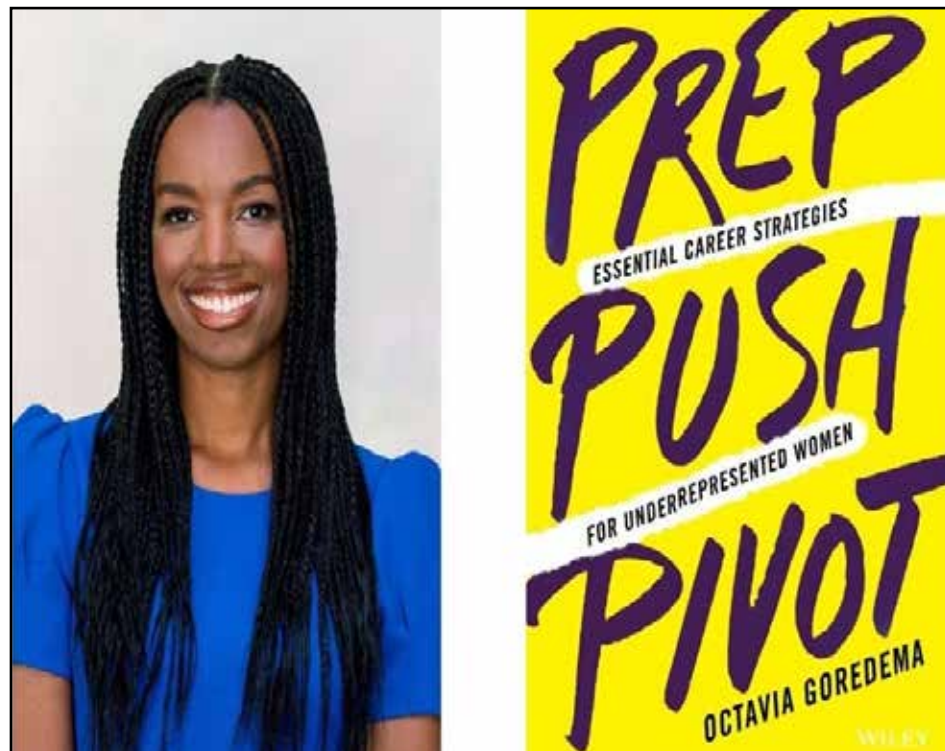

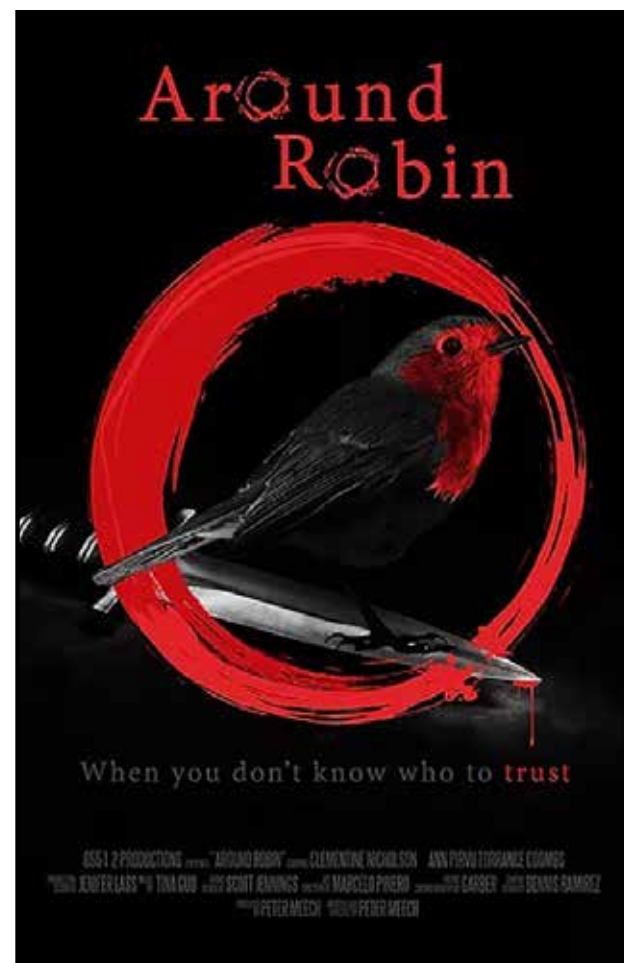

Tottenham will be confident of making progress after being drawn in the same group as Eintracht Frankfurt, last season's Europa League winners,

Sporting Lisbon and Marseille.

Although two-time winners Chelsea face two tough games against AC Milan, Thomas Tuchel's side will hope to advance to the knockout stage in Group E which is also made up of RB Salzburg and Dinamo Zagreb.

Sevilla and FC Copenhagen also await

Manchester City in Group G, while there are two heavyweight games between Paris St-Germain and Juventus in Group E.

But one of Bayern Munich, Barcelona and Inter Milan will miss out in Group C. The three club have been crowned champions of Europe 14 times between them.

Magpies splash out again on £60m Isak

Newcastle are set to sign Real Sociedad striker Alexander Isak for a club record fee of about £60m.

The Sweden international, 22, would boost the Magpies' attacking options given the injury record of Callum Wilson, who is awaiting results of a hamstring scan.

Ex-Borussia Dortmund player Isak has 44 goals in 132 appearances for Sociedad, and nine in 37

for his country.

Newcastle's transfer record is the £40m they paid for Joelinton in 2019.

The Brazilian striker-turned-midfielder was signed from German club Hoffenheim.

The club also paid £35m plus add-ons for fellow Brazilian midfielder Bruno Guimaraes last January but Isak's signing would be a significant shift from Newcastle's new owners,

who took over the club in October and have taken a considered approach to the transfer market.

Isak's signing would double Newcastle's spending this summer to just short of £120m after already signing Matt Targett, Sven Botman and Nick Pope, and bring the total to around £200m since the new owners, the sovereign wealth fund of Saudi Arabia, took over the club in October 2021.
