RIP, MA'AM

Queen Elizabeth II, the UK's longest-serving monarch, has died at Balmoral aged 96, after reigning for 70 years.

Her family gathered at her Scottish estate after concerns grew about her health earlier on Thursday.

With her death, her eldest son Charles, the former Prince of Wales, will lead the country in mourning as the new King and head of state for 14 Commonwealth realms.

In a statement, Buckingham Palace said: "The Queen died peacefully at Balmoral this afternoon.

"The King and the Queen Consort will remain at Balmoral this evening and will return to London tomorrow."

All the Queen's children travelled to Balmoral, near

Aberdeen, after doctors placed the Queen under medical supervision.

Queen Elizabeth II's tenure as head of state spanned post-war austerity, the transition from empire to Commonwealth, the end of the Cold War and the UK's entry into - and withdrawal from - the European Union.

weekly audiences

Her reign spanned 15 prime ministers starting with Winston Churchill,

born in 1874, and including Liz Truss, born 101 years later in 1975, and appointed by the Queen earlier this week.

She held weekly audiences with her prime minister throughout her reign.

At Buckingham Palace in London, crowds awaiting updates on the Queen's condition began crying as they heard of her death.

The Queen was born Elizabeth Alexandra Mary Windsor, in Mayfair,

London, on 21 April 1926.

Few could have foreseen she would become monarch but in December 1936 her uncle, Edward VIII, abdicated from the throne to marry the twice-divorced American, Wallis Simpson.

Philip

Elizabeth's father became King George VI and, at age 10, Lilibet, as she was known in the family, became heir to the throne.

Within three years,

Britain was at war with Nazi Germany. Elizabeth and her younger sister, Princess Margaret, spent much of wartime at Windsor Castle after their parents rejected suggestions they be evacuated to Canada.

After turning 18, Elizabeth spent five months with the Auxiliary Territorial Service and learned basic motor mechanic and driving skills. "I began to understand the esprit de cont. on page 3 col. 1

'Great intellect, charm and wit' - the world pays tribute to Queen Elizabeth

World leaders and dignitaries have paid tribute to Queen Elizabeth II, who has died at the age of 96.

They have honoured her deep sense of duty and her resilience, as well as the Queen's sense of humour and kindness.

France's Emmanuel Macron led the tributes, remembering "a kind-hearted queen" who was "a friend of France".

And former US President Barack Obama said the Queen had "captivated the world" with a "reign defined by grace, elegance and a tireless work ethic".

"Time and again, we were struck by her warmth, the way she put people at ease, and how she brought her considerable humour and charm to moments of great pomp and circumstance," Mr Obama, who met the Queen on several occasions, said in a statement.

Current US President Joe Biden - who first met Her Majesty 40 years ago - described her as "more than a monarch - she defined an era".

Remembering his visit to the UK in 2021 as president, Mr Biden said "she charmed us

with her wit, moved us with her kindness, and generously shared with us her wisdom".

Queen Elizabeth II met 13 US presidents during her reign.

Donald Trump said he would "never forget Her Majesty's generous friendship, great wisdom, and wonderful sense of humour".

'steady grace'

"What a grand and beautiful lady she was - there was nobody like her!" the former president wrote on his online platform, Truth Social.

And another former president, George W Bush, reflected fondly on the time he spent having tea with Her Majesty and her corgis, describing her "great intellect, charm and wit".

Canada - where Queen Elizabeth was head of state - has seen 12 prime ministers during her reign.

An emotional Justin Trudeau said she had "an obvious deep and abiding love for Canadians".

"In a complicated world, her steady grace and resolve brought comfort to us all," the prime minister said, adding that he would

miss their "chats" where she was "thoughtful, wise, curious, helpful, funny and so much more".

"She was one of my favourite people in the world, and I will miss her so," he said, holding back tears.

Flags have been lowered to half-mast around the world - including at the European Commission in Brussels, Belgium.

EU Commission President Ursula von der Leyen said the Queen's "empathy and ability to connect with every passing generation, while remaining rooted in the tradition that truly mattered to her, was an example of true leadership".

'deep respect'

King Willem-Alexander of The Netherlands - who is Queen Elizabeth's fifth cousin - said he and Queen Maxima remembered the "steadfast and wise" monarch with "deep respect and great affection".

Sweden's King Carl XVI Gustaf, also a distant relative to Her Majesty, said: "She has always been dear to my family and a precious link in our

shared family history."

And Belgium's King Philippe and Queen Mathilde said she was "an extraordinary personality... who, throughout her reign, showed dignity, courage and devotion".

'sense of duty'

German Chancellor Olaf Scholz paid tribute to the Queen's "wonderful humour" and said in a statement that "her commitment to German-British reconciliation after the horrors of World War Two will remain unforgettable".

Indian Prime Minister Narendra Modi recalled his "memorable meetings" with the monarch during two UK visits.

"I will never forget her warmth and kindness," he tweeted. "During one of the meetings, she showed me the handkerchief Mahatma Gandhi gifted her on her

wedding. I will always cherish that gesture."

As monarch for seven decades, Queen Elizabeth lived through times of extraordinary change, and this was reflected in several tributes.

As Barack Obama noted, she lived "through periods of prosperity and stagnation - from the Moon landing to the fall of the Berlin Wall".

'reassurance'

Irish President Michael D Higgins honoured the Queen's "extraordinary sense of duty", which he said would "hold a unique place in British history".

"Her reign of 70 years encompassed periods of enormous change, during which she represented a remarkable source of reassurance to the British people," he said in a lengthy statement.

Ireland's Taoiseach, Micheál Martin, spoke of her reign as one of

"historic duration" and described the Queen's passing as "the end of an era".

"Her dedication to duty and public service were self-evident and her wisdom and experience truly unique," Mr Martin said in a statement. He also recalled her "many gracious gestures and warm remarks" during a state visit to Ireland in 2011.

António Guterres, the UN's secretary-general, said Queen Elizabeth was "a reassuring presence throughout decades of sweeping change, including the decolonisation of Africa and Asia and the evolution of the Commonwealth".

In a statement, he paid tribute to "her unwavering, lifelong dedication to serving her people. The world will long remember her devotion and leadership".

A long life marked by determination and a sense of duty

■ **Born into a loving and close family, but never expecting to be Queen, Elizabeth accepted the role thrust upon her with dignity and grace. Despite many personal setbacks, she retained a wry and impish sense of humour**

The long reign of Queen Elizabeth II was marked by her strong sense of duty and her determination to dedicate her life to her throne and to her people.

She became for many the one constant point in a rapidly changing world as British influence declined, society changed beyond recognition and the role of the monarchy itself came into question.

Her success in maintaining the monarchy through such turbulent times was even more remarkable given that, at the time of her birth, no-one could have foreseen that the throne would be her destiny.

'horse and dogs'

Elizabeth Alexandra Mary Windsor was born on 21 April 1926, in a house just off Berkeley Square in London, the first child of Albert, Duke of York, second son of George V, and his duchess, the former Lady Elizabeth Bowes-Lyon.

Both Elizabeth and her sister, Margaret Rose, who was born in 1930, were educated at home and brought up in a loving family atmosphere. Elizabeth was extremely close to both her father and her grandfather, George V.

At the age of six, Elizabeth told her riding instructor that she wanted to become a "country lady with lots of horses and dogs".

She was said to have shown a remarkable sense of responsibility from a very early age. Winston Churchill, the

future prime minister, was quoted as saying that she possessed "an air of authority that was astonishing in an infant".

Despite not attending school, Elizabeth proved adept at languages and made a detailed study of constitutional history.

A special Girl Guides company, the 1st Buckingham Palace, was formed so that she could socialise with girls of her own age.

On the death of George V in 1936, his eldest son, known as David, became Edward VIII.

However, his choice of wife, the twice-divorced American Wallis Simpson, was deemed to be unacceptable on political and religious grounds. At the end of the year he abdicated.

A reluctant Duke of York became King George VI. His Coronation gave Elizabeth a foretaste of what lay in store for her and she later wrote that she had found the service "very, very wonderful".

public faith

Against a background of increasing tension in Europe, the new King, together with his wife, Queen Elizabeth, set out to restore public faith in the monarchy. Their example was not lost on their elder daughter.

In 1939, the 13-year-old princess accompanied the King and Queen to the Royal Naval College at Dartmouth.

Together with her sister Margaret, she was escorted by one of the cadets, her third cousin, Prince Philip of Greece.

It was not the first time

Through the war, she exchanged letters with her third cousin, Philip, Prince of Greece, who was serving in the Royal Navy. Their romance blossomed and couple married at Westminster Abbey on 20

they had met, but it was the first time she took an interest in him.

Prince Philip called on his royal relatives when on leave from the navy, and by 1944, when she was 18, Elizabeth was clearly in love with him. She kept his picture in her room and they exchanged letters.

The young princess briefly joined the Auxiliary Territorial Service (ATS) towards the end of the war, learning to drive and service a lorry. On VE Day, she joined the Royal Family at Buckingham Palace as thousands gathered in The Mall to celebrate the end of the war in Europe.

"We asked my parents if we could go out and see for ourselves," she later recalled. "I remember we were terrified of being recognised. I remember lines of unknown people linking arms and walking down Whitehall, all of us just swept along on a tide of happiness and relief."

After the war, her desire to marry Prince Philip faced a number of obstacles.

The King was reluctant to lose a daughter on whom he doted, and Philip had to overcome the prejudice of an establishment that could not accept his foreign ancestry.

'much too young'

But the wishes of the couple prevailed and on 20 November 1947 the couple married in Westminster Abbey.

Their first child, Charles, was born in 1948, followed by a sister,

November 1947, with the prince taking the title of Duke of Edinburgh.

She would later describe him as "my strength and stay" through 74 years of marriage, before his death in 2021, aged 99.

Anne, who arrived in 1950.

But the King, having suffered considerable stress during the war years, was terminally ill with lung cancer, brought about by a lifetime of heavy smoking.

In January 1952, Elizabeth, then 25, set off with Philip for an overseas tour. The King, against medical advice, went to the airport to see the couple off. It was to be the last time Elizabeth would see her father.

Elizabeth heard of the death of the King while staying at a game lodge in Kenya and the new Queen immediately returned to London.

"In a way, I didn't have an apprenticeship," she

In Liz they Truss?

■ Tories elect their new Prime Minister - who promises to 'deliver, deliver, deliver'

THE Tory Party has put its faith in Liz Truss to persuade the nation she is the new Prime Minister whose radical measures will tackle the cost-of-living crisis.

After a decisive leadership contest win over Rishi Sunak, she vowed to "deliver, deliver, deliver" for Britain and to kick-start the economy.

Ms Truss also paid a heartfelt tribute to "my friend" Boris Johnson for his service to the country as he prepared to leave No 10 for the last time.

Ms Truss said she will govern as a Conservative with tax cuts, a belief in personal responsibility and freedom at the heart of her premiership. But she insisted she is ready to sort out big structural problems facing the country, with the growing energy crisis and strained NHS top of the list.

The incoming PM made it clear that she knows the clock is ticking, as an election must be called within two years, but insisted she will drive through relentlessly the

reforms the UK needs. She told Conservative party members: "I know that our beliefs resonate with the British people. Our beliefs in freedom, in the ability to control your own life, in low taxes, in personal responsibility.

"I know that's why people voted for us in such numbers in 2019. And as your party leader, I intend to deliver what we promised those voters right across our great country.

'bold plan'

"During this leadership campaign, I campaigned as a Conservative and I will govern as a Conservative.

"We need to show that we will deliver over the next two years. I will deliver a bold plan to cut taxes and grow our economy.

"I will deliver on the energy crisis dealing with people's energy bills, but also dealing with the long-term issues we have on energy supply. And I will deliver on the National Health Service."

Ms Truss told members

that she expects a "great victory" for the Tories at the forthcoming General Election.

Her spokesman said: "Liz's message of tax cuts to grow the economy, tackling the energy crisis through immediate action and supply-side reform, and governing in a Conservative way really cut through.

"As PM she'll deliver for everyone in our United Kingdom and unleash opportunity across the country."

Mr Johnson said: "Congratulations to Liz Truss on her decisive win. I know she has the right plan to tackle the cost-of-living crisis, unite our party and continue the great work of uniting and levelling up our country.

"Now is the time for all Conservatives to get behind her 100 per cent."

Theresa May, his predecessor as Prime Minister, congratulated Ms Truss and added: "We Conservatives must now work together to address the challenges

Three arrested over death of Olivia Pratt-Korbel

A MAN has been arrested over the gun death of nine-year-old Olivia Pratt-Korbel.

The 34-year-old, from Liverpool, was held 12 miles from the shooting in Runcorn, Cheshire.

A second man, 41, from Knowsley on Merseyside, was also detained and is in custody on suspicion of assisting an offender.

Police also arrested a third man, aged 29, following a raid.

Olivia was shot in the chest 14 days ago by a balaclava-clad gunman, who chased convicted burglar Joseph Nee, 35, into her home in the Dovecot area of the city.

Her mother Cheryl Korbel, 46, had apparently opened the door in response to a

commotion outside.

The family had no knowledge of the gunman or Nee. Detective Chief Superintendent Mark Kameen, who is leading the investigation, said: "We still need the public's help in ensuring we can build a strong evidential picture so justice is served for Olivia and her family."

"Appeal for those who may have information – no matter how small – that could continue to help our inquiries to contact us directly or anonymously and we'll do the rest."

The opening of an inquest last week into Olivia's death heard how an officer had tried to save her life. He

pressed his hand on her wound as she was taken to Alder Hey Children's Hospital in the back of a police patrol car. But she was pronounced dead one hour later – while her mother needed treatment for a gunshot injury to her wrist.

A post-mortem examination found the medical cause of Olivia's death was a gunshot wound to the chest.

The horror has sparked an outpouring of grief and shock among the community.

Locals have reacted by laying wreaths and leaving cards near her family home – and more than 200 mourners attended a vigil in her memory at the weekend.

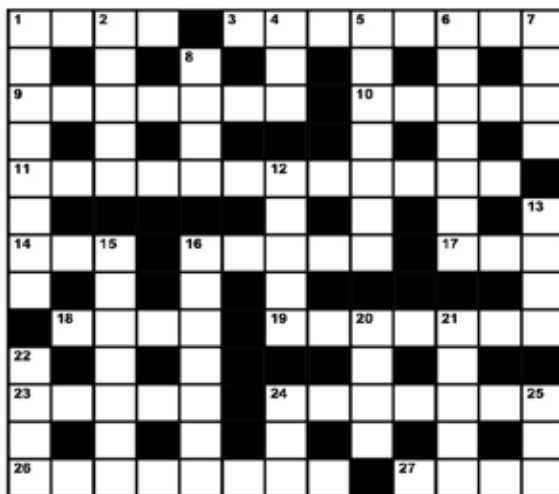

Meet A Member: Michael Quarterman

Meet Michael Quarterman, from Carshalton, Surrey, who moved to LA 41 years ago to work on the cruise ships.

Was there a particular reason you chose LA?

I was working at the London Hilton as a society photographer, and met another photographer who had worked on the cruise ships. He suggested I look into it if I wanted to escape England. After an interview, I had not heard from them, so I called to follow up, and it was the best call I ever made! An opening had just come in, and as long as I could be in LA in 10 days, I had the gig! It

could have been a cruise ship almost anywhere in the world.

What do you miss most from home?

The countryside - its peace and tranquility. Devonshire cream teas, real ale, and the humour.

What was your first impression of LA and has it changed since?

Working on the LA cruise ship was an amazing experience, but we only had about nine hours ashore, twice a week, to explore LA. so we were always wanting more time, this made LA more enticing. It seemed so big, with big roads and big cars. Now I know the

city really well, and you get used to it.

What do you find the biggest difference is living here versus Carshalton?

My village is an ancient settlement, mentioned in the Doomsday book, and whose meaning is "the settlement by the watercress springs". LA is also an ancient settlement, but has been transformed over the last 200 years or so, to be a futuristic city. Whereas Carshalton hasn't changed in centuries! Career wise, I would never have achieved what I have here, especially as a radio DJ. I came here as a photographer to work on the ships. On my very first cruise, I met a wonderful guy called Joe Powers, who had a chain of photography studios, and offered me to work for him, "if i ever got fed up w the cruise ship life".

On another cruise I met a great immigration lawyer. After several years and numerous cruise ships, I called them up, and said let's do it! Joe had a new studio opening up in Vegas, and offered me the chief photographer position. At a party there some months later, I met a girl who said "With your cute accent you'd be great on the radio!" Turns out she was the girlfriend of the music director of the big rock station in Vegas at KOMP. with over 100,000 watts of power, we rocked four states, and it was glorious! The playlist was flexible in those days, and I even sneaked my own records in the mix, that I got away with for years! I became the first British DJ to rock Vegas airwaves, but it became increasingly bothersome. I also got tired of the extreme heat of their six month summers and applied and got offered a job at a classic rock station in Ventura, KZTR. Some years later I was offered

to take over the famous Breakfast with the Beatles show on KLSX, after we lost their wonderful host Deirdre O'Donoghue. I revolutionized the show, adding elements such as live breakfast broadcasts, and movie soundbites, that were both profitable and entertaining.

Sadly radio has gone corporate, and you don't get the freedom we used to get, so it's hard for me to play the same 100 songs everyday! That's why I'm not in radio at the moment.

Lake Shrine, Sunset Ranch, and a lovely little cove, just north of Laguna Beach

What would you suggest to others who are thinking about making the move here?

Don't do it! lol. But if you do, get ready for endless rejection, but eventual acceptance!

Believe in yourself, and "don't stop believing", as Journey once sang....

and don't give up!

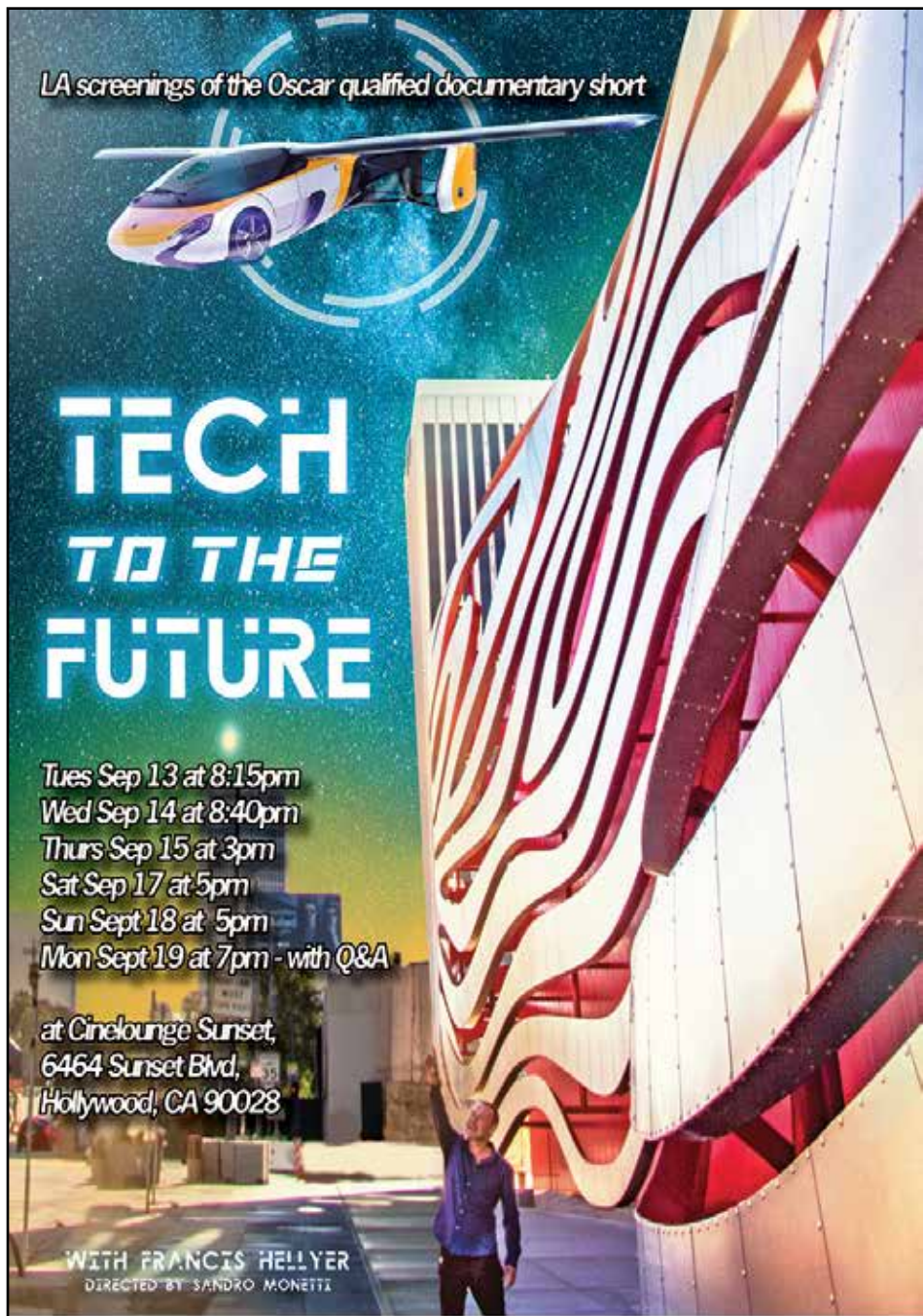

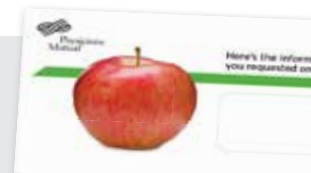

Klopp: other teams 'will be laughing at us'

Liverpool manager Jurgen Klopp has warned that opposition will be "laughing" at his side after they suffered a 4-1 hammering at the hands of Napoli in their Champions League Group A opener on Wednesday.

Liverpool were outplayed in the first half and went into half time 3-0 down following goals from Piotr Zielinski, Andre-Frank Zambo Anguissa and Giovanni Simeone.

Klopp's side were fortunate not to concede more goals before the break after Allison saved Victor Osimhen's penalty. Napoli grabbed a fourth goal two minutes into the second half before Luis Diaz grabbed a consolation strike.

Liverpool face Wolves on Saturday

in the Premier League and Klopp said Bruno Lage's team would have enjoyed their humiliation in Europe.

"It looks a little bit like we have to reinvent ourselves," Klopp told BT Sport in his postmatch interview.

"There's a lot of things lacking, and the fun part is that we have to do that in the middle of a Premier League and Champions League campaign.

"In three days we play against Wolves, and if they saw the game tonight they probably cannot stop laughing. They will say it's a perfect moment [to play Liverpool]. I would say it's a perfect moment. But we have to try to find a set-up to be much better in pretty much everything."

Asked what was

wrong with his team, Klopp said: "Everything [wrong] is obvious, but why it happened, I cannot answer now, let me think about it. It is a really tough cookie to take, but I have to take it."

"We have to find a set-up to be much better in pretty much everything."

This season Liverpool have also lost to Manchester United in the Premier League and drawn with Fulham, Crystal Palace and Everton.

In the heat of southern Italy, though, Liverpool produced their worst performance of the campaign, with even basic defending and midfield pressing lacking.

"It is really tough to take, it's not that difficult to explain when you

watched the game," Klopp, said. "OK, first of all, Napoli played a really good game, we didn't, that is the first explanation for the defeat.

"They scored one penalty and missed another, but the next two goals we served on a plate and we should defend better. We were not compact defensively or offensively. Until Thiago [Alcantara] entered the pitch I cannot remember one counter-pressing situation, we were too wide."

Former Liverpool defender Jamie Carragher was also critical of Liverpool's approach during the game and told CBS: "It's embarrassing. It really is.

"I said before it's kid stuff and this is the big problem with Liverpool right now."

Tuch out, Potter in at the Bridge

■ New owners wield the axe after indifferent start to season and Champions League defeat

Chelsea have appointed Graham Potter as their new manager following the sacking of Thomas Tuchel.

Potter has left fellow Premier League club Brighton to take up the role and has signed a five-year deal with the Blues.

The 47-year-old said he was "incredibly proud and excited to represent Chelsea".

Potter's first game in charge will be an away derby with fellow west London club Fulham on Saturday at 12:30 BST.

His assistant Billy Reid, first-team coaches Bjorn Hamberg and Bruno, goalkeeping coach Ben Roberts and assistant head of recruitment Kyle Macaulay will join him at the Chelsea, who have paid Brighton in excess of £21m in compensation.

"We are thrilled to bring Graham to Chelsea," said the Stamford Bridge club's chairman Todd Boehly.

"He is a proven coach and an innovator in the Premier League who fits our vision for the club.

"Not only is he extremely talented on the pitch, he has skills and capabilities that extend beyond the pitch which will make Chelsea a more successful club.

"He has had a major

impact at his previous clubs and we look forward to his positive impact at Chelsea.

"We look forward to supporting him, his coaching team and the squad in realizing their full potential in the coming months and years."

Former Ostersunds FK and Swansea City manager Potter led Brighton to a ninth-place finish last season, the club's highest ever top-flight finish.

He has guided them to fourth in the table this season after winning four, drawing one and losing one of their six Premier League games.

Chelsea decided to sack Tuchel, who won three trophies in 20 months at Stamford Bridge, with the Blues sixth in the top flight following a summer in which they spent £255.3m in the summer transfer window.

"I am very excited to partner with Chelsea's new ownership group and look forward to meeting and working with the exciting group of players and to develop a team and culture that our amazing fans can be proud of," said Potter.

He also offered a "sincere thanks" to Brighton, including

chairman Tony Bloom, for their support during his spell of just more than three-years at the club.

Brighton Under-21 coach Andrew Crofts has taken over as Brighton's interim head coach, while attacking midfielder Adam Lallana will be part of his coaching set up.

"I am very disappointed that Graham will be leaving us," said Bloom.

"He has done exceptionally well over the past three-and-a-bit seasons, he is an exceptional head coach and an exceptional person. He will be hugely missed at our football club.

"He leaves an excellent legacy for his successor with the club in its highest ever position, and on the back of leading us to our highest finish in the club's history last season.

"I would like to thank Graham, Billy, Bjorn, Bruno, Ben and Kyle for their work here, and wish them all the very best for the future.

"While our attention is now on appointing Graham's successor as head coach our immediate focus, of course, is on Saturday's game at Bournemouth and supporting Andrew Crofts as interim head coach."
