MELTDOWN!

- Pound plummets to 50-year low as markets react to Kwarteng's tax cuts
- Bank of England steps in to stabilize bond market after huge sell-off

The pound fell to its lowest level against the dollar since decimalization in 1971 this week as markets reacted to the UK's biggest tax cuts in 50 years and hints from the Chancellor that more could be on the way.

During a chaotic start to the week, sterling dropped by 4.9% to just \$1.0327 before regaining some ground to arrive at \$1.06 by the time markets opened in Europe on Monday. At press time the pound had recovered to \$1.11 but the market remained jittery with traders ready to respond strongly to any further bad economic news.

The latest fall adds to a sharp decline in the value of sterling over the past six months. In September so far, the pound has dropped by 3.5%, which will bring an increase in the price of imports including energy, food and clothing, worsening the already serious cost-of-living crisis.

extra debt

The tax cuts, along with a plan to support households in dealing with their rising energy bills, will require the government to borrow an extra 72 billion pounds

(\$77.7bn) in the next six months alone. As with other goods and services, the value of most of the world's major currencies operates on the principle of supply and demand.

The pound's plummeting value indicates that investors are concerned about the UK's ability to manage so much extra debt, especially as rising interest rates make borrowing much more costly.

When the Chancellor Kwasi Kwarteng announced the tax cuts last week it set into motion a chain of events that has left new Prime Minister Liz Truss badly damaged. Because the cuts were larger than the markets expected, the pound fell against the dollar amid concerns the UK would struggle to keep up debt payments from dwindling tax revenues. A weaker pound makes imported products more expensive, which in turn

prompted fears that inflation would continue to rise. Such a scenario would likely prompt the Bank of England to raise interest rates to try to dampen it down. Fear of such a move led to a huge wave of sell offs of government debt bonds, held in pounds and called gilts. The price of 5-year UK bonds – through which investors loan money to the government – recorded the sharpest fall since at least 1991.

anxiety

In a bid to stop the bleeding, the Bank of England stepped in to buy these bonds, pledging to keep doing so until the panic had passed, and although they succeeded in calming the markets – at least temporarily, anxiety remains high that Britain's woes will infect the rest of the G7 nations in an a highly febrile economic climate.

Labour MP suspended after describing Chancellor as 'superficially' black

MP Rupa Huq says she has apologised to Chancellor Kwasi Kwarteng for describing him as "superficially" black.

Speaking at a Labour Party conference fringe event, Ms Huq also said: "If you hear him on the Today programme, you wouldn't know he's black."

She has been suspended from sitting as a Labour MP, pending an investigation.

Leader Sir Keir Starmer called the remarks "racist" and said he taken "swift action".

He declined to comment on whether she should be sacked from the party, saying its investigation should now "take its course".

He added: "It's not for me to tell that independent

process what they should do."

The Ealing Central and Acton MP, who will now sit in Parliament as an independent, was recorded making the comments on Monday evening at a fringe event entitled What's Next for Labour's Agenda on Race.

The audio clip was published by the Guido Fawkes website minutes before Sir Keir Starmer began his speech to the Labour Party Conference in Liverpool.

During a Q&A session, she said: "He's superficially, he's, a black man but again he's got more in common... he went to Eton, he went to a very expensive prep school, all the way through top schools in the country.

"If you hear him on

the Today programme you wouldn't know he's black."

Following the publication of the clip on Tuesday, Ms Huq tweeted: "I have today contacted Kwasi Kwarteng to offer my sincere and heartfelt apologies for the comments I made at yesterday's Labour conference fringe meeting.

"My comments were ill-judged and I wholeheartedly apologise to anyone affected."

Tory Party chair Jake Berry called her comments "racist" and "disgusting".

Deputy Labour leader Angela Rayner said the remarks were "unacceptable," while the party's foreign affairs spokesman David Lammy described the remarks as "unfortunate" adding:

Rachel Reeves described the fall in the pound as "incredibly concerning". She added that the chancellor needed to lay out his plans to "get a grip on the public finances because that is what is giving real concern to market traders" and to "working people".

Anything made overseas including smartphones, computers, reading glasses and cars may get more expensive in UK shops. Even some items that are made in the UK can become more expensive as manufacturers and retailers pass on rising costs of materials to consumers.

Also, anything priced in dollars becomes more expensive for people in the UK. For example, given oil is priced in dollars, a weak pound will make it more expensive to buy petrol. The UK also imports more than 50% of its food, so the cost of everything from zucchini to bananas will go up.

"A weaker pound will make goods more expensive for both companies and consumers," said a commentator from investment management firm Brewin Dolphin. "Anyone on a fixed income, like many pensioners, or workers who have not had a pay rise in several years, will be hit especially hard because inflation eats into the purchasing power of

their income, effectively making them poorer," it added.

While the UK's tax plans were the initial trigger of the pound's freefall, economists say that investors' confidence in the British economy has been waning for some time due to other developments such as Brexit.

"The British pound has long been suffering for political decisions in the UK," said Alexander Tziamalis, a senior economics lecturer at Sheffield Hallam University.

"It has been hit by Brexit and is also facing the prospect of a second Scottish independence referendum and a potential trade war with the EU over the Northern Ireland protocol."

"I wouldn't have made them myself."

Mr Kwarteng, who became chancellor earlier this month, was born in east London and has Ghanaian heritage.

Former chancellor and Tory MP Sajid Javid said he was "appalled and saddened" by the clip adding: "Rather than give encouragement to racists and people who

seek to divide us, she should know better. Not too late for her to show that she does."

In a letter to Sir Keir, Mr Berry urged the Labour leader to "join me in unequivocally condemning these comments as nothing less than racist".

The Conservative Party chair also labelled her words as "vile" and

"disgusting".

Sunder Katwala, who chaired the event at which Ms Huq made the remarks, tweeted: "My comments from the chair that people should be judged on their politics and ideas, not race, and that Kwarteng being a Conservative did not mean he was not Black, were strongly applauded by the fringe audience."

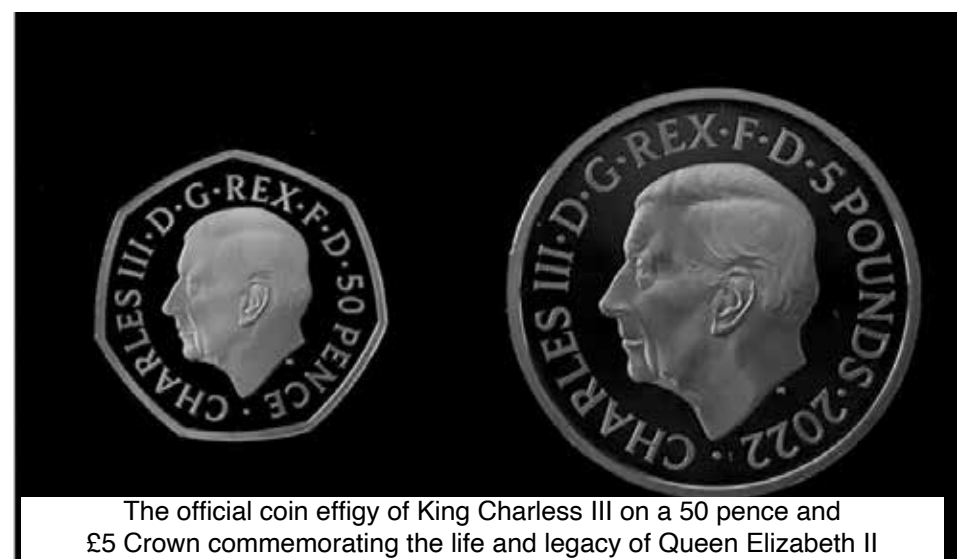

King Charles III 50p coin unveiled ahead of circulation this year

A new 50p design featuring an image of King Charles III has been unveiled by the Royal Mint and will

enter circulation by the end of the year.

Meanwhile, a special memorial coin range commemorating Queen

Elizabeth II will be released on Monday at 9am. Charles' portrait will appear on

Queen died of 'old age' says death certificate

Queen Elizabeth II's cause of death is described as "old age" in the register of deaths released on Thursday.

The registrar general for Scotland, Paul Lowe, confirmed that the Queen's death was registered in Aberdeenshire on 16 September.

The document states that the 96-year-old monarch died at 3.10pm on 8 September at Balmoral Castle, Ballater. Princess Anne registered her mother's death.

Douglas James Allan Glass is noted as the certifying registered medical practitioner. Old age was the only cause of death listed, with no other contributing factors. Glass was an apothecary to the Queen, her doctor in Scotland.

The record shows that the Queen died just over three hours before the news was announced by Buckingham Palace in a statement at 6.30pm.

The time of death confirms the Queen died as many of her family were still travelling to see her. The King, Queen Consort and Princess Royal were

at Balmoral because they were already in Scotland undertaking engagements.

The Prince of Wales, Earl and Countess of Wessex, and the Duke of York had flown from RAF Northolt, arriving at Aberdeen airport at 3.50pm and reaching Balmoral just after 5pm. The Duke of Sussex, travelling separately, arrived at Balmoral just before 8pm.

concerns

The prime minister, Liz Truss, was told of the Queen's death at 4.30pm, Downing Street has previously said.

Concerns had been raised at around 12.35pm, when Buckingham Palace issued a statement saying doctors were concerned for the Queen's health. Truss was later informed of her death by the cabinet secretary, Simon Case.

Old age is acceptable if the doctor certifying death has cared for the patient for a long time, was not aware of any disease or injury that contributed to death and had observed a gradual

decline in the person's general health and functioning.

The Queen had been experiencing sporadic mobility problems during the final period of her life and used a walking stick regularly in public. Her use of a walking stick came after she was admitted to a private London hospital for "preliminary investigations" in October last year – her first overnight admission for eight years.

light duties

The monarch was soon back at her Windsor Castle desk, but spent the following three months under doctors' orders to only conduct light duties and missed a number of prominent events, including the Cop26 climate summit in Glasgow and the Festival of Remembrance.

Following tradition, the Queen was spending her summer break at Balmoral, and a few days before she died performed one of her major duties of state and asked Truss to form a government and become her 15th prime minister.

a £5 crown and a 50p celebrating the Queen.

Nicola Howell, chief commercial officer at the Royal Mint, told the PA news agency: "We expect customers will start to be able to receive the commemorative range from October and then we expect the 50p memorial circulating coin to be appearing in people's change probably from December."

The King's effigy, which has received the personal approval of Charles, was created

by sculptor Martin Jennings, the Mint said. As is tradition, the King's portrait will face to the left, the opposite direction from Queen Elizabeth II.

'tradition'

Chris Barker, of the Royal Mint Museum, said: "Charles has followed that general tradition that we have in British coinage, going all the way back to Charles II actually, that the monarch faces in the opposite direction to their predecessor."

The Latin inscription surrounding the effigy translates to: "King Charles III, by the Grace of God, Defender of

the Faith". The design will start to appear on circulating and commemorative coins produced over the coming months.

The Royal Mint, based in Llantrisant, south Wales, has depicted the royal family on coins for over 1,100 years, documenting each monarch since Alfred the Great.

Anne Jessopp, its chief executive officer, said: "The Royal Mint has been trusted to make coins bearing the monarch's effigy for over 1,100 years and we are proud to continue this tradition into the reign of King Charles III.

"Although technology

has progressed, we continue to honour British craftsmanship passed down through the centuries. Our team of skilled modellers, tool-makers and engravers will ensure

that the King's effigy will be faithfully replicated on to millions of coins.

"It is a privilege to sculpt the first official effigy of His Majesty and to receive his

personal approval for the design. The portrait was sculpted from a photograph of the King, and was inspired by the iconic effigies that have graced Britain's coins over the centuries."

Harry Dunn crash: Anne Sacoolas appears by video link before UK court

■ Case of US citizen accused of causing death of teenager by dangerous driving sent to Old Bailey

Anne Sacoolas, the US citizen accused of causing the death of the British teenager Harry Dunn by dangerous driving, has appeared before a UK court by video link, where a magistrate granted her unconditional bail.

Her appearance, sitting beside one of her lawyers, marks the end of a three-year wait by Dunn's family for criminal proceedings to begin. They listened from the public gallery at Westminster Magistrates court as the case was sent to the Old Bailey.

Sacoolas, 45, faces a charge of causing death by dangerous driving by killing the 19-year-old in a road crash outside the US military

base RAF Croughton in Northamptonshire on 27 August 2019.

The chief magistrate, Paul Goldspring, told Sacoolas that she must attend the next hearing of the case in person, though that may change subject to an application to allow her to appear by video link.

Sacoolas spoke only to confirm her date of birth and name, while the chief magistrate agreed that her lawyer's address, rather than her own, could be used for correspondence.

The US government asserted diplomatic immunity on the defendant's behalf after the collision outside RAF Croughton, and she was able to leave the UK 19 days after the incident.

A decision was reached to charge Sacoolas with causing Dunn's death by dangerous driving in December 2019.

Wearing a blue suit jacket and a scarf and seated at a table, Sacoolas looked straight ahead throughout the hearing. Members of Dunn's family sat in the public gallery, including his mother, Charlotte Charles, his father, Tim Dunn, stepfather Bruce Charles, stepmother Tracey Dunn and his twin brother, Niall. Each of them was wearing a green tie or green scarf in remembrance of Harry.

Sending the case to the Old Bailey, the chief magistrate told Sacoolas: "I hope you followed most of that. The first

thing I have to do is send your case to the crown court. I'm going to grant you unconditional bail in this case – that means there are no restrictions

from the court on you." The family, who have said they will not be commenting on the case until the conclusion of criminal proceedings,

briefly stopped outside the court after the hearing, where a spokesperson reiterated their gratitude for the support shown to them.

Man guilty of murdering secret lover and their son near Inverness in 1976

■ Circumstantial evidence enough to convict William MacDowell, now 80, of killing Renee and Andrew MacRae

An 80-year-old man has been found guilty of murdering his secret lover and their three-year-old son almost half a century after the pair vanished without trace from a layby on the A9 near Inverness, concluding one of Scotland's most extensive and longest-running missing persons investigations.

Although the bodies of Renee MacRae, who was 36 when she disappeared in 1976, and her younger son, Andrew, have never been found, William MacDowell, now 80, was convicted by a "compelling and classic case of circumstantial evidence", as the prosecutor Alex Prentice KC described it in his closing speech to the jury.

MacDowell will die in prison after the judge

sentenced him to a minimum of 30 years, for both the killings and the disposal of the bodies, on Thursday, the day that would have been Andrew's 48th birthday.

The prosecution case was built on accounts from witnesses, some of whom died in the intervening decades or were too frail to attend court. They described a woman "deeply in love" with her married lover, who had promised her a new life in Shetland in a house "with a veranda and a big kitchen".

brutal reality

The jury heard testimony from MacRae's best friend, Valerie Steventon, who was too ill to appear in person, that MacRae told her MacDowell asked her to

bring Andrew to what turned out to be their final assignation "because he wanted to get to know him better". Instead, mother and child were met with the brutal reality of his intentions in a dark layby on the stormy night of 12 November 1976.

Another witness, then living in a nearby farmhouse and now deceased, described hearing "a bloodcurdling scream" that night, her daughter told the court. This was most likely the last sound that MacRae made, Prentice told the jury.

MacRae and Andrew vanished after dropping off her eldest son, Gordon Jr, then aged nine, with her estranged husband, also called Gordon, in Inverness, telling him she was visiting her sister in

Kilmarnock. Steventon, the only person in whom MacRae confided about her relationship, revealed that MacRae was instead meeting MacDowell, who had told her he had

booked a chalet for a weekend stay. Later that night, her BMW car was found burnt out on the A9 south of Inverness and blood was found in the boot. MacDowell, the

company secretary at Gordon MacRae's building firm, had begun his affair with MacRae in 1972, and Andrew was born a year later. MacRae then separated from her

husband, but the affair remained a secret.

Despite thousands of interviews, case reviews by Police Scotland's major investigations team and extensive searches of two nearby quarries in 2004 and 2019, no trace of the pair has ever been found.

It was Steventon who first drew police attention to MacDowell, who subsequently moved to Penrith in Cumbria. He maintained his innocence for decades, before finally being charged in September 2019.

'walking dead man'

MacDowell claimed he had an alibi for the evening in question, and accused Gordon MacRae of the killings, a suggestion the latter

described as "incredible" when it was put to him in court. He testified that his separation had not been acrimonious, but rather the couple had come to a "mutual recognition" that their lives had moved on. Gordon MacRae sacked MacDowell when

the affair came to light, and the jury heard that when another employee was sent to pick up his company car, MacDowell refused to hand it over because he was scrubbing the boot. It later emerged that the floor of the boot had been destroyed completely.

MacDowell did not give evidence himself, and his wife, Rosemary, described his multiple health problems to the jury, stating: "He's actually a walking dead man and he has got a DNR [do not resuscitate order] set up already."

The court heard of discrepancies in the alibi his wife gave him

for the night of the disappearance, and testimony from another witness, who saw a man with "wide and staring eyes" pushing what appeared to be a clothed object in a pushchair near the layby on the night the pair disappeared.

Alex Prentice told the jury that MacDowell killed MacRae and her son because he was concerned about what he might lose if the affair became public. "Life for Bill MacDowell would change dramatically if it all came out in the open. He would lose his job, his family and his home," he said.

MacRae's sister, Morag

Govans, now 84, welcomed the verdict, saying it was a day her family "feared would never come".

"Renee was a compassionate and caring mother. Both Andrew and his elder brother, Gordon, were her life. She adored them and was so proud of her boys. Andrew would be 48 today. He was never given the chance to build his own life.

"The passage of time has not eased the anguish we feel. We have never been able to lay Renee and Andrew to rest or properly mourn their loss. Not knowing where their remains lie only compounds the pain."

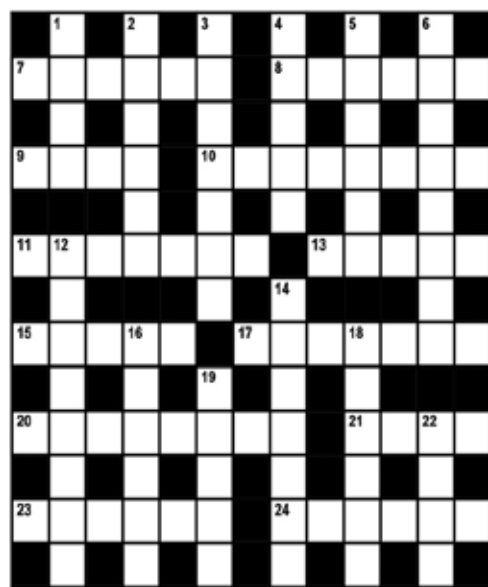

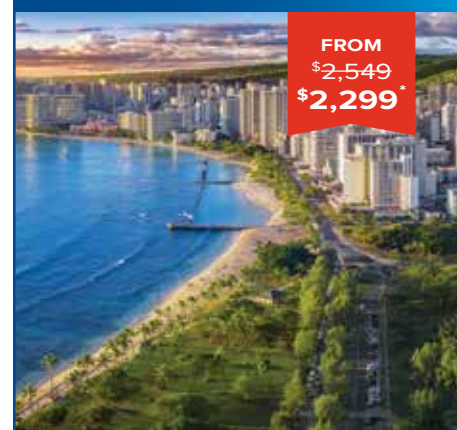

Back from a bittersweet Blighty visit

Hello Everyone!

Did you miss us?

In case you didn't notice, Craig and I took a couple of weeks off; the first time in over 15 years!

It was also the first time we sat on a plane together! As many of you know, we've been friends for almost two decades and have been on several trips but due to conflicting work schedules have always had to meet up at our destination. This time we were both already planning to attend the wedding of a mutual friend in England, so it was the perfect opportunity to try and synchronize our travel arrangements - and we finally managed it!

I've been flying solo for so many years it felt

rather strange at first to have a companion, but I was relieved to discover that Craig is just as delightful a partner in the air as he is on the ground. Our arrival in to the UK was bittersweet for it was only a few hours later the world learned that the Queen had died. It felt rather odd to be in England knowing she was no longer at the helm - I don't know whether this is an ex-pat thing, but it made me realize just how synonymous Great Britain and the Queen are to me and probably to many of you?

Mostly, I felt an emptiness and strangely enough, I didn't feel compelled to join 'the queue' or rush to lay flowers at Buckingham Palace. Perhaps knowing

if I did that would make it too real. Several of my friends and family members did go along and all say that they wouldn't have missed it for the world. One of the lovely things to come out of it was to see Britain (briefly) united again. The majority of the shops across the country replaced their window displays with tributes to the Queen. I find I get terribly homesick when there are big events or news stories breaking from Britain - I still regret not being there for the Jubilee, the 2012 Olympics, or the Euros. Although, as I've just discovered the part that mostly appeals to me is not actually attending 'the event' but soaking up the surrounding atmosphere and community spirit that comes along with it.

The show will feature hundreds of volunteers from Manchester

Trainspotting director to bring Matrix show to Manchester

Director Danny Boyle is to stage a live version of *The Matrix*, recreating the 1999 film through “dance, music and visual effects”.

Boyle is known for films like *Slumdog Millionaire* and *Trainspotting*, and the London 2012 Olympic opening ceremony.

He didn't make the seminal Keanu Reeves movie, but is now turning *The Matrix's* story of simulated reality into a live “large-scale immersive performance”.

It will be one of the opening shows at Manchester's £186m Factory arts venue.

The show, titled *Free Your Mind*, will be staged at the ambitious 7,000-capacity venue in October and November 2023.

“Spectacular visual effects, a cast of professional dancers and hundreds of Manchester participants will recreate some of the film's most iconic scenes, provoking visions of an alternative future,” a statement said.

Boyle, from Radcliffe in Greater Manchester, said the original *Matrix* movie was “an extraordinarily prophetic film and a wonderfully enjoyable film” whose warnings about the power and possible abuses of technology were ahead of its time.

“I remember seeing the first one and, as I

think was true for a lot of people, not really understanding what I was seeing, except enjoying it on a visceral level and being bewildered and intrigued on it.

Free Your Mind was the centrepiece of an announcement on Thursday of the opening line-up for the new venue, which has been known as *The Factory* - after the city's seminal record label - and has now been rechristened *Factory International*.

It was conceived in 2014 when then-Chancellor George Osborne pledged £78m as a cultural contribution to the Northern Powerhouse.

But the building has been beset by delays and rising budgets, and will

have to prove its worth at a time when people and businesses are struggling with rising costs.

Its budget now stands at £186m, with £99m is coming from the government, £51m from Manchester City Council, £7m from the National Lottery and around £5m from private fundraising.

The remaining £24m is still to be found through a five-year commercial fundraising strategy, which will include offering naming rights.

The venue will provide a permanent home for the Manchester International Festival - its bosses have said it will attract 850,000 people a year to the city, create 1,500 jobs and bring in £1.1bn to the economy over a decade.

Artistic director and chief executive John McGrath said the building was “an investment in the future of Manchester”.

Record-breaking Haaland eyes first Manchester derby

Erling Haaland prepares for his first derby against Manchester United on Sunday - after a record-breaking start at Manchester City.

Haaland seemingly breaks records every time he steps on the pitch for City, with 14 goals in his first 10 games before the international break.

Haaland has scored 11 goals in his first seven Premier League appearances, taking the old record of Mick Quinn from December 1992. He shares the record for most goals in his first 10 Premier League games with Quinn, Papiss Cisse and Diego Costa - with three games to spare.

His nine goals in his first five games were also a record - and made him the top scorer in August of any Premier League season.

Haaland is the first player to score in his first four away games in the Premier League.

He also broke a few records on his Champions League debut at Sevilla, with a double in a 4-0 win, and more with the late winner against his old side Dortmund.

Haaland became the

first player to score multiple times on his Champions League debut for three different clubs - after a hat-trick for Salzburg against Genk and two goals for Dortmund against Paris St-Germain.

That took him to 25 Champions League goals in just 20 games - smashing the old record of Ruud van Nistelrooy and Roberto Soldado, who scored 16 in their first 20 games.

He is the youngest player to score 25 goals in the competition, beating the record of Kylian Mbappe, who in turn took the landmark off Lionel Messi.

His goal against Dortmund took him to 26 goals in 21 games.

He has already

equalled the record for most goals in his first 30 Champions League games - with nine games left to score once and break Van Nistelrooy's record.

Haaland also has the record for fewest Champions League games needed to score 10, 15 and 20 goals. Nobody else has scored multiple goals in four successive appearances in the competition.

He is also the first City player to score on both his Premier League debut and Champions League debut for the club.

He had an even better start to his time in Germany. Haaland is the only player to score on his Dortmund debuts in the Bundesliga, German Cup and Champions League (as well as scoring in the German Super Cup).

He was the first player to hit a hat-trick on his Bundesliga debut as a substitute (coming on after 56 minutes at Augsburg).

He holds the record for most goals in his first two, three, five and six Bundesliga games games (five, seven, eight and nine goals respectively).

October. That enhances Scotland's chances of another major tournament, which is a great reward for an impressive international window in which Clarke's squad has shown different qualities while being stretched to the limit.

Injuries to defenders Scott McKenna and Kieran Tierney added more problems before the trip to Krakow, and resulted in Hibernian centre-back Ryan Porteous making his debut in game of huge importance.

But he, partner Jack Hendry, and Aaron Hickey were outstanding in keeping Ukraine out for the most part, though Oleksandr Petrakov's side will also rue some big misses.

The worst came from Andriy Yarmolenko after just seven minutes, as the former West Ham midfielder blazed over unmarked after a fantastic cross from Mykhaylo Mudryk.

But there were others too, with Gordon denying Artem Dovbyk when clean through, and then Mudryk's curling effort from distance was pushed wide by the Hearts goalkeeper.

Scotland had some good moments early on, with Che Adams forcing Andriy Lunin into a fine save after two minutes and Ryan Jack firing over inside the box. A penalty awarded for handball was overturned, too, after the referee checked again at the direction of the video assistant referee.

But the second half was mainly about tiring bodies staying focussed, which they did until the death as Porteous produced a last-ditch tackle in the final minute to stop Oleksandr Zubvok firing a shot on goal from just inside the box.

Trent left out in the cold by Southgate

■ Liverpool star just behind Trippier, says England boss

England boss Gareth Southgate feels Trent Alexander-Arnold's "all-round game" is behind that of right-back rival Kieran Trippier.

The Liverpool full-back was left out of Monday's 3-3 Nations League draw with Germany, and Southgate said he explained the situation to him.

Chelsea's Reece James started the game with Newcastle's Trippier on the bench.

"I've had long conversations with all of them [who have been left out]," Southgate said.

"The other night [against Italy], we didn't need the left-back cover. Against Germany we did because of the way we went with the team so we needed Chilly [Ben Chilwell] on the bench and we had Kieran who, at the moment, I feel his all-round game is ahead [of Alexander-Arnold]."

Alexander-Arnold has been a key player for a Liverpool side that have won the Premier League and Champions League in recent years but he has struggled to transfer that form to international football and has won just 17 caps since his 2018 debut.

As well as Alexander-Arnold's role for England, another topic of discussion has been Harry Maguire's selection, despite his poor form at Manchester United.

The centre-back, who started against Germany, gave away a penalty for the visitors' opener and was dispossessed in the move that led to their second goal.

"I know everybody says he's important to me, he's important to us," Southgate said. "It's us, it's not me."

"Why do we pick him? Because he's one of the players who gives us the

best chance of winning.

"So, really, we should all be wanting a Harry Maguire that's playing regularly and playing with confidence.

"That applies to, of course, quite a few players but he's the one that everything lands on, which must be a tough space for him, really, but he's showing tremendous character."

Southgate's loyalty to his players has been criticised following a run of six matches without a win and Nations League relegation.

But he has been praised for turning the England shirt into a "cape rather than a straitjacket" by the manager of World Cup opponents USA.

Southgate led England to the 2018 World Cup semi-finals and Euro 2020 final.

"Gareth has done a great job of helping the players cope with pressure," US

boss Gregg Berhalter said. "Actually using the jersey as a cape rather than a straitjacket and really giving them the freedom to play on the field, giving them the idea that they can represent their country in a positive way and make the country proud."

Despite England's poor recent run of form, which included a 4-0 defeat at home to Hungary, Berhalter is sure the Euro 2020 runners-up are capable of mounting a challenge in Qatar.

"I think we all agree

they have a squad that can win the World Cup," he said.

England kick off their World Cup campaign in Group B against Iran on 21 November, moving on to matches against USA (25 November) and Wales on November the 29th.
