POISONER AT WORK

Nurse murdered seven babies and tried to kill 10 more, court hears

IN WHAT may prove to be Britain's worst-ever case of child murder, a Cheshire nurse stands accused of murdering seven premature babies and trying to kill 10 more.

Lucy Letby is said to have gone on a year-long killing spree at the hospital neonatal unit where she worked.

And prosecutor Nick Johnson KC described her as "the constant malevolent presence when things took a turn for the worse for these 17 children".

He said Letby poisoned the babies with insulin or by feeding them too much milk or by injecting air into their veins.

The opening day of her trial at Manchester Crown Court this week was told she murdered one boy within 90 minutes of starting her shift at the Countess of Chester Hospital in Cheshire.

Mr Johnson said the nurse tried to kill some victims more than once – and even targeted babies despite not being their designated nurse.

Letby, 32, from Hereford, denies murdering five boys and two girls and attempting to murder another five boys and five girls there between June 2015 and June 2016.

Mr Johnson told a jury

of eight men and four women it was a "busy general hospital like so many others in the UK".

However, "unlike many other hospitals, within the neonatal unit at the Countess of Chester Hospital, a poisoner was at work".

He explained: "Prior to January 2015 the statistics for the mortality of babies in the unit were comparable to other like units.

'painstaking review'

"Over the next 18 months or so there was a significant rise in the number of babies who were dying and in the number of serious catastrophic collapses."

Mr Johnson went on: "Some of the babies who did not die collapsed dramatically but then – equally dramatically – recovered. Their collapse and recovery defied the normal experience of treating doctors.

"Babies who had not been unstable at all suddenly deteriorated. Sometimes babies who had been sick but then been on the mend suddenly deteriorated for

no apparent reason.

"Consultants noticed the inexplicable collapses and deaths did have one common denominator – the presence of one of the neonatal nurses, Lucy Letby."

"Many of the events in this case occurred on the night shifts. When Letby was moved on to day shifts, the collapses and deaths moved to the day."

Police were called in and conducted a "painstaking review" which suggested that "somebody in the neonatal unit poisoned two children with insulin."

He added: "The prosecution say the only reasonable conclusion from the evidence you will hear is somebody poisoned these babies deliberately with insulin. This was no accident.

"They were all the work of the woman in the dock, who we say was the constant malevolent presence when things took a turn for the worse for these 17 children."

Mr Johnson said the two children poisoned with insulin, identified as Child F and Child L, were

both twin boys, the first born in summer 2015 and the other in spring 2016.

He said each was poisoned a couple of days after birth when Letby was on duty.

'constant presence'

Mr Johnson said: "There's a very restricted number of people who could have been the poisoner, because entry to a neonatal unit is closely restricted."

But both survived due to the skill of medical staff who appreciated low blood sugar can have natural causes but did not realise they were being poisoned with insulin.

Child F and Child L each had a baby brother – Child E and Child M respectively – who were also allegedly poisoned

with insulin by Letby a couple of days after they were born, with all surviving apart from Child E.

The court heard Child E and Child M both had air injected into their bloodstream.

Other methods of harm included being fed too much milk.

Jurors saw a chart showing nurses who were on duty when the incidents took place.

Pointing out the first three alleged offences in chronological order, Mr Johnson said the chart showed the only person present each time was Letby. He said: "The constant presence when they were fatally attacked or collapsed catastrophically was Lucy Letby.

"It is a complicated case. Sometimes Letby tried to kill the same baby more than once. Sometimes a baby that she did not manage to kill the first time she tried the second time, and in one case even the third time.

But things took a dramatic turn on Thursday, day four of the trial, when prosecutor Johnson told jurors about a series of notes that the police found.

On one green Post-it note, which was shown to the court, she had written: "I don't deserve to live. I killed them on purpose because I'm not good enough to care for them."

The trial, which may last up to six months, continues.

Cut out the pomp when I'm crowned, says Charles

- Coronation of new king could last less than hour
- Reduced guest list to reflect modern Britain

THE Coronation of King Charles III could last less than an hour in front of a reduced guest list to reflect modern Britain, reports claim.

Traditional language is likely to be simplified and ancient rituals dispensed with in the ceremony at Westminster Abbey pencilled in for next June.

The 1953 Coronation of Queen Elizabeth II lasted for almost four hours in front of an 8,000-strong congregation.

But there is speculation the Duke of Norfolk, who as Earl Marshal is masterminding Operation Golden Orb, has been tasked with preparing a simpler, shorter ceremony reflecting a streamlined monarchy.

With only 2,000 guests and dignitaries, those set to miss out are likely to be MPs and peers.

Yet the King still wants to retain much of the pomp and pageantry that the world witnessed during Her Majesty's lying-in-state and funeral ceremonies.

The Queen's Coronation was based largely on the 1937

occasion of her father, King George VI, which in turn was modelled on that of King George V in 1911.

One source is quoted as saying: "The King has stripped back a lot of the Coronation in recognition that the world has changed in the past 70 years."

out of touch

The 1953 Coronation required the Queen to make various outfit changes but the source reportedly said: "King Charles is unlikely to do the same and the language will be adapted so as to be understandable to a more modern audience."

The King has committed to vow to be the "defender of the faith" not "defender of faith" as previously speculated.

The 1762 Gold State Coach, refurbished at great expense for the Queen's Platinum Jubilee, will also be part of his procession. Some lengthy rituals could be cut, such as the Court of Claims, an ancient court set up to assess which members of the

gentry had the right to perform certain roles, first recorded in 1377.

The traditional presentation of gold to the monarch is also likely to disappear in case it appears out of touch with the cost-of-living crisis.

Velvet chairs made for the 1953 Coronation are likely to be replaced by standard seating with breeches and tiaras replaced by suits and hats.

Discussions may have taken place on relaxing the requirement for peers to wear Coronation robes.

Lieutenant Colonel Anthony Mather, who started the plan for King Charles's Coronation that has since been updated, said: "No Coronation robes. Give them to a museum where they belong."

"It's not going to be a tweed jacket and a pair of jeans but a morning suit or lounge suit."

The Duke of Norfolk declined to comment. Buckingham Palace said: "All these reports are simply speculative. No arrangements have been confirmed."

Sturgeon hails 'independence generation'

First Minister Nicola Sturgeon has told her party they are "the independence generation" in her keynote speech to the annual SNP conference.

In a rallying cry to the delegates gathered in Aberdeen, Sturgeon said she firmly believed that her generation will "be the first, in the modern world, to live in an independent Scotland".

The SNP leader made the comments as Supreme Court judges prepare to consider whether the Scottish government has the legal power to hold a second independence referendum without the consent of Westminster. Sturgeon has described independence as "essential to escape Westminster control and mismanagement".

In her speech, she said that her party would

"respect the judgment" of the Supreme Court if it rules that the UK government must agree to another referendum, adding that she and her party would "reflect" on the decision and the wider independence movement.

'simple choice'

But she restated her plan to use the next Scottish elections as a proxy referendum on independence, telling delegates she felt there was a "simple choice" to be made: "Put our case for independence to the

people in an election or give up on Scottish democracy."

Under Sturgeon's plan, a mandate to begin Scotland's separation from the UK would begin if "more than 50 per cent of the popular vote went to pro-independence parties" in the next elections.

Opinion polls have shown that most Scots do not want another referendum next year while support for independence is at similar levels to 2014, when 55% voted to remain in the UK.

It wasn't all bad...

Community orchards are booming in England thanks to a renewed interest in living off the land sparked by the Covid-19 lockdowns. The orchards are also helping to revive "lost" apple varieties that are rarely sold in supermarkets, such as the Bloody Ploughman and the Beauty of Bath.

A rescue dog that got lost while chasing squirrels in a wood on the outskirts of Bristol trotted 4.6 miles across the city to get home, navigating busy streets and even the Clifton Suspension Bridge. When Libby Bowles noticed that Pip was missing, she had a "sick feeling", but she posted a notice on an online message board, and was soon getting alerts from people all over the city who had spotted the dog, a Spanish breed called a Podenco. By the time she got home from her search two hours later, Pip was waiting for her. "It makes me cringe to think of him crossing the big roads and a big roundabout, but somehow he did it," she said.

Hedgehog 'highways' help creatures flourish

Hedgehogs are flourishing in the Nottinghamshire village of Keyworth thanks to a community effort to create "highways" for the creatures. Residents of Dale Road cut 42 holes in their garden walls and fences to allow the animals to roam. "We had a lady on the street saying that she hadn't seen any in her garden for 30 years, and then suddenly after we drilled some holes they started appearing," said one resident.

Five new charges for Maddy suspect

■ But Brueckner insists he is blameless for McCann abduction

THE prime suspect for the kidnap of Madeleine McCann was facing five further sex crime charges this week, including three rape accusations.

Christian Brueckner has been accused of raping three victims in Portugal between 2000 and 2006. He has also been charged with indecently exposing himself to two girls aged 10 and 11 in Portugal in 2007 and 2017.

None of the charges relate to the disappearance of three-year-old Madeleine who vanished from her family's holiday apartment in Praia da Luz on the Algarve in May 2007.

Brueckner, 45, named in 2020 as prime suspect for the British girl's kidnap, was charged in Germany where he is serving a sentence for rape.

concerns

Although the offences were allegedly committed in another country, he will be prosecuted in Germany. The charges were confirmed by Hans Christian Wolters, public prosecutor in Braunschweig, north-west Germany.

Mr Wolters has said previously that investigators suspect

Brueckner killed Madeleine after snatching her from the flat while her younger twin siblings slept nearby.

The move will highlight concerns that the investigation into Brueckner in relation to Madeleine's disappearance has so far failed to positively link him to the crime.

Brueckner has strenuously denied any involvement in the McCann case.

sex offender

He is in prison in Oldenburg, north-west Germany, where he is serving seven years for the rape of an elderly woman in Praia da Luz in 2005.

The convicted sex offender is known to have travelled frequently between Portugal and Germany from 2000 to 2017.

The new charges are: Rape of a woman in her 70s at a holiday apartment in Portugal between 2000 and 2006;

Rape of a 20-year-old Irish woman in 2004 in Praia da Rocha, around 20 miles east of Praia da Luz;

Rape of a teenager in Praia da Luz between

2000 and 2006. Brueckner is further accused of tying up the girl and whipping her while he videoed the abuse;

Indecent exposure to a 10-year-old German girl in Faro in 2007;

Indecent exposure to an 11-year-old Portuguese girl in Bartolomeu de Messines – approximately 40 miles from Praia da Luz – in 2017.

The investigation

into Madeleine's disappearance is continuing irrespective of the charges brought, said prosecutors.

Her parents Kate and Gerry McCann, both 54, of Rothley, Leicestershire, have never given up hope that one day she will be found alive.

On the 15th anniversary of Madeleine's disappearance this year, they said that it

is "essential" to learn exactly what happened to their daughter. That same day, the Metropolitan Police, which continues to treat the case as a missing persons inquiry, said that it is still "committed" to finding out the truth.

Scotland Yard officers launched their own investigation into Madeleine's disappearance, Operation Grange, in July 2013.

India warns against using the Koh-i-Noor diamond for Charles coronation

■ Showing off the 105-carat gem would “transport” some “back to the days of the British Empire in India”

India’s ruling party has warned that crowning the British Queen Consort using the controversial Koh-i-Noor diamond would bring back “painful memories of the colonial past”.

Buckingham Palace is said to be reconsidering whether Camilla should wear the thousand-year-old jewel when she is crowned alongside King Charles, after India’s Bharatiya Janata Party (BJP) said it would “transport” some “back to the days of the British Empire in India”.

The Koh-i-Noor, which has been on public display in the Jewel House at the

Tower of London since 2002, is one of the largest cut diamonds in the world, weighing 105.6 carats. The diamond, which was once placed on Mughal king Shah Jahan’s throne in the 17th century, was taken away from India following the invasions of Iranian ruler Nadir Shah. It was obtained by the East India Company and presented to Queen Victoria in 1849. A campaign has sprung up in India urging Britain to return it, but the diamond is also claimed by Afghanistan, Pakistan and Iran.

The crown that now contains the diamond was made for Queen

Elizabeth – later the Queen Mother – in 1937, but the diamond had previously been mounted in the crowns of other royals, including Queen Alexandra, wife of Edward VII.

Controversy

“The Indian gem has a bloody history of colonial conquest,” said the Smithsonian magazine in 2017, and it raises the question of how modern nations should “deal with a colonial legacy of looting”.

Speaking to the magazine, the historian William Dalrymple, who has co-written a book about the diamond, said:



The famed diamond is claimed by India, Afghanistan, Pakistan and Iran

“If you ask anybody what should happen to Jewish art stolen by the Nazis, everyone would say of course they’ve got to be given back to their owners.

“And yet we’ve come to not say the same thing about Indian loot taken hundreds of years earlier, also at the point of a gun,” he said, adding in that the stone has become a “massive diplomatic grenade”.

Indeed, a resurgence

of interest from India in reclaiming the diamond is now “very visible” among a new generation on social media, Jyoti Atwal, associate professor at Jawaharlal Nehru University, told The Telegraph.

The spokesman for the BJP said that “the coronation of Camilla and the use of the crown jewel Koh-i-Noor brings back painful memories of the colonial past”.

Royal sources said no

decision on whether the Koh-i-Noor diamond crown will be used in the coronation has yet been made. But they added that the King and his team were “acutely aware” of the need to consider current sensitivities.

The British government insists the gem was acquired legally under the terms of the Last Treaty of Lahore of 1849 and has rejected any claims to it.

Boris puts his mouth where the money is

BORIS Johnson has begun his lucrative post-Downing Street career by reportedly pocketing nearly £316,000 (\$350,000) for a 30-minute speech in the US.

Mr Johnson, who resigned from office last month, got a standing ovation at Tuesday's insurance industry

conference in Colorado. He was said to have spoken about Brexit, Ukraine and his previous climate scepticism.

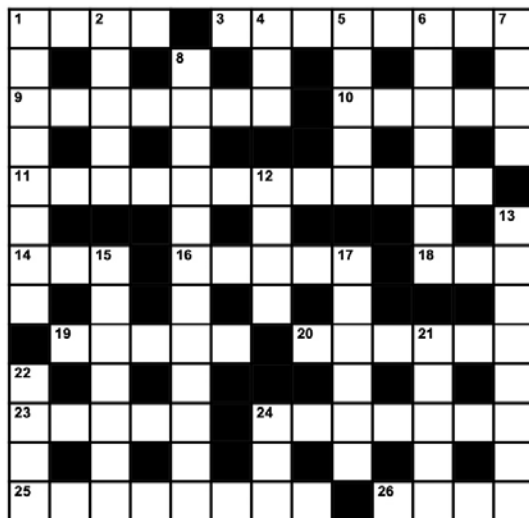

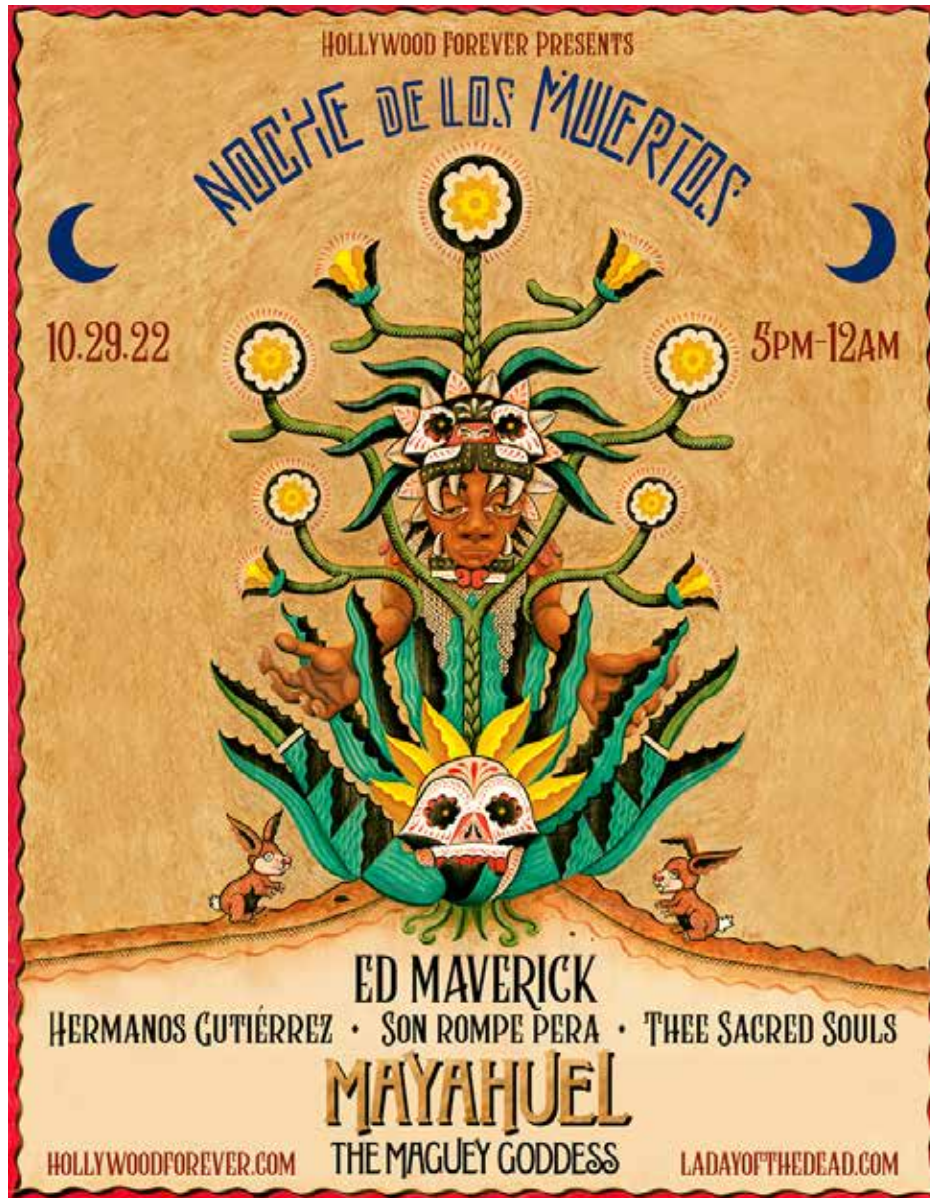

Gerald, from Greystones, Co. Wicklow, was scheduled to arrive in the around lunchtime Friday (after BW press time) at Smugglers Cove in Rancho Palos Verdes, having left Catalina 11pm the night before.

Gerald is no stranger to this kind of watery endeavor. He completed his first English Channel swim in 2018, before moving onto the Manhattan Island Marathon Swim (28.5 miles) the following year.

The Catalina crossing will make Gerald part of an exclusive club of folks who have done the so-called Triple Crown of Open Water Swimming. And this jaunty fellow says he considers himself to be the luckiest guy to be out there in the water, in the dark, swimming with the sea life, while raising awareness for the Gavin Glynn Foundation, which helps children fighting childhood cancer in Ireland. Says Gerald: "When I think of what the children and their families are going through, I have the easy hand".

Gerald, who is married with three children, began

training in earnest in late 2021, clocking up 25km or more a week, in the pool or sea depending on the weather.

During Gavin's battle with cancer the Glynn family travelled to several different countries for specialist cancer treatment for their youngest son. Southgate wary of difficult Euro 2024 draw

GARETH SOUTHGATE admitted England face qualification "jeopardy" for Euro 2024 after they were drawn with defending champions Italy and an emotional clash with Ukraine.

Two teams qualify from a group completed by Malta and North Macedonia, the team that knocked Italy out of the 2022 World Cup play-offs.

It means that after relatively straightforward campaigns in recent tournaments, the Three Lions must be on their guard if they want to reach the finals in Germany. Three Lions manager Southgate said: "You know there will be high-level games, and we certainly know enough about them, so it's not like there's too many surprises. It's a challenging group.

"Ukraine are a really strong team, and as North Macedonia showed against Italy, that's also got complications.

"I suppose it's the first time for a while there's maybe a bit more jeopardy and excitement in a qualifying group. It's good for football, because you need that jeopardy to make the competition more exciting."

The games against Ukraine will have an entirely different emotion. Their coach Oleksandr Petrakov said: "We have a connection with the guys on the front line because they send messages to the players. We feel they need our victory."

After Sunday's draw in Frankfurt, Roberto Mancini tried to put pressure on Southgate by installing England as the top dogs of Group C.

The Italy manager, whose side beat the Three Lions 1-0 last month, said: "England will be favourites but we must play all our games at 100 percent."

Kane and Son sparkle in narrow win

Defensive woes almost cost Spurs despite strike duo's dazzling show

Kane and Son is a combination we have got used to seeing and the pair linked up again for the 50th time in all competitions as Tottenham beat Frankfurt 3-2 to go top of their Champions League group.

"We just understand each other really well," South Korea star Son told BT Sport afterwards, as his double helped Tottenham edge closer to qualification for the knockout stages.

Kane set up Son's equaliser after Frankfurt had taken an early lead, before the 29-year-old England captain scored from the penalty spot.

Son, 30, went on to score a thumping volley in the second half, and

despite Kane missing another penalty in stoppage time, both were otherwise on top form at the Tottenham Hotspur Stadium.

"I know what [Kane] likes to do and he's the same. The relationship has always been a payoff for hard work. Many more [goals] to come I hope," added Son.

Since the start of last season, Liverpool's Mohamed Salah (39) is the only Premier League player with more goals in all competitions than Kane (36) and Son (29).

Tottenham have had a two-year absence from the Champions League and have not hit the heights they once did in Europe under former manager Mauricio

Pochettino.

Since their defeat by Liverpool in the 2018-19 final, Spurs have failed to go beyond the last 16 in the Champions League or the Europa League and were knocked out in the group stages of the Europa Conference League last season.

However, their fluent attacking display on Wednesday provides hope they could go further in Europe under manager Antonio Conte.

German football expert Raphael Honigstein said "Spurs are back" after their performance because "they come alive

when they go forward".

"That combination between Son and Kane is incredible," he added.

"Son is playing with real confidence and that is a testament to how Spurs have adapted to Antonio Conte's style of football. They are unstoppable like this."

Chelsea's despatch Milan to confirm revival under Potter

Chelsea enjoyed a comfortable victory at AC Milan after former Blues defender Fikayo Tomori received an early red card on Tuesday.

Tomori was sent off for pulling back Mason Mount in the area, with Jorginho converting the penalty.

Pierre-Emerick Aubameyang doubled the lead with a confident strike against his former club.

But Chelsea and England suffered a blow in the second half when right-back Reece James limped off.

The win continues Graham Potter's unbeaten start as Chelsea manager, with four wins in his first five games.

It moves Chelsea top of Group E with seven points from four matches, but it remains extremely tight with Red Bull Salzburg on six points and both Milan and Dinamo Zagreb on four.

Tomori has not enjoyed his reunion with his

boyhood club over the past couple of games - after Milan were beaten comprehensively at Stamford Bridge last week, the Chelsea youth product lasted just 18 minutes on Tuesday.

What looked like being a tight game was blown open when Tomori put his arm on the shoulder of England team-mate Mount, putting the midfielder off balance enough to send him tumbling to the floor.

Referee Daniel Siebert, who was central to the drama throughout to the ire of the home support, deemed it enough contact to be a penalty and that Tomori had not attempted to play the ball, thus overriding the double jeopardy rule and causing him to show the red card.

The decision was debated long and hard by Tomori and Milan's players, but eventually he had to leave the field and after a lengthy delay Jorginho calmly slotted

the penalty away.

"I definitely don't think the referee has had one of his better evenings," said Milan boss Stefano Pioli.

He added: "The penalty

and red card changed everything. Chelsea didn't need to play with a numerical superiority.

"I don't want to review the episode, it seems too

obvious. I don't want to comment. I told the referee what I think, I don't speak English very well but I think he understood."

McTominay, introduced with less than 10 minutes remaining, fired in the winner after fellow substitute Jadon Sancho teed him up in the box.

The result means United remain three points behind Group E leaders Real Sociedad, who beat Sheriff Tiraspol 3-0 for their fourth win in as many matches in the competition.

United dominated and had several huge chances to score but were left frustrated until McTominay's winner.

"In this team there is a lot of creativity and scoring capabilities. Sometimes you have a night where you will not succeed. Today was that

night," said Ten Hag.

"But the good thing was the team keep going and they don't give up. They keep believing and in the end we get the reward. That is the way we have to do it.

"I am really happy with that. It is about the spirit in the team and the squad. It is not just about the 11 players.

"Sometimes it works like that. Substitutes can have an impact when they have the right attitude and the right focus."

Omonia goalkeeper Francis Uzoho was undoubtedly the visitors' best performer as he kept out 11 of United's 12 shots on target.

But he could do nothing to stop McTominay's strike in the 93rd minute, having saved three big chances for Marcus Rashford in the first half.

Casemiro, who started in midfield alongside Fred, struck the crossbar in the first half too, before Fred headed over the bar from an unmarked position in the box.

Cristiano Ronaldo

could not take his chances either and McTominay had smashed a wild shot into the stands before finding the composure to score the winner in front of an elated Old Trafford crowd.

Victory means United's hopes of topping the group remains within their grasp. They face Sheriff Tiraspol at home in their next match on 27 October.

Omonia, who had few opportunities at the other end, could have scored themselves on the stroke of half-time but Bruno Felipe did not square it for team-mate Andronikos Kakoullis who was completely free in the middle.

Neil Lennon's side, who went 1-0 up in the reverse fixture last week before Rashford's double helped United claim a 3-2 win, were cheered on by 4,500 visiting fans.

"I am very proud of the team. We were a few minutes away from one of the greatest results in this club's history," said Lennon.

"We have made great strides in a short space of time. We came close to getting a draw against Sociedad and obviously tonight and last week. The players have been

fantastic since I came in March.

"I think this trip has put Omonia on the map a little in Europe. We need to build on that."
