Sunak takes the top job

Rishi Sunak has been named the new Prime Minister, and vowed to earn the nation's trust by tackling head on the "profound" economic crisis facing the country.

Speaking in a solemn tone outside No. 10 on Tuesday morning, Sunak declared that he was undaunted as he stamped his authority on the Conservative party.

He cleared key loyalists of his predecessors out of the Cabinet while assembling a team of senior figures from warring Tory factions to help deliver his vow to "fix" Britain's problems.

He brutally drew a line under Liz Truss's tumultuous 49 days in office, saying she made "mistakes".

The Premier, Britain's

third in two months, kept on Jeremy Hunt as Chancellor and left James Cleverly and Ben Wallace in their Foreign Office and Defence briefs.

Suella Braverman, who backed him for PM, was given the Home Secretary role again six days after she was forced out by Ms Truss. A No 10 source said Mr Sunak selected his team based on "unity, experience, continuity".

Mr Sunak told voters: "I will work day in and day out to deliver for you. All I can say is that I am not daunted. I know the high office I have accepted and

I hope to live up to its demands.

"But when the opportunity to serve comes along, you cannot question the moment, only your willingness. So I stand here before you ready to lead our country into the future. To put your needs above politics, to reach out and build a Government that represents the very best traditions of my party."

Mr Sunak promised to "fill tomorrow and every day thereafter with hope" in a speech outside No 10 an hour and a half after Ms Truss had left,

and following the King's invitation to form a Government.

Mr Sunak added that despite having "noble" aims, Ms Truss had got things wrong: "I admired her restlessness to create change - but some mistakes were made.

'economic stability'

"Not born of ill-will or bad intention - quite the opposite in fact. But mistakes, nonetheless. And I have been elected as leader of my party and your Prime Minister, in part, to fix them. And that work begins immediately.

"I will place economic stability and confidence at the heart of this Government's agenda. This will mean difficult

decisions to come. But you saw me during Covid doing everything I could to protect people and businesses with schemes like furlough.

"There are always limits, more so now than ever. But I promise you this - I will bring that same compassion to the challenges we face."

Key allies of Ms Truss and Boris Johnson were sacked including Justice Secretary Brandon Lewis, Levelling Up Secretary Simon Clarke and Tory party chairman Sir Jake Berry.

Mr Sunak held out an olive branch by keeping Ms Truss's "best mate" Therese Coffey in Cabinet.

A No 10 source said: "This Cabinet brings

the talents of the party together. It reflects a unified party and a Cabinet with significant experience, ensuring that at this uncertain time there is continuity at the heart of Government."

Labour, the SNP and some Tories claimed Mr Sunak does not have a mandate to lead the UK as he was "crowned" without a contest.

He insisted that the party's 2019 mandate was "not the sole property" of Boris Johnson but "belongs to and unites all of us".

Promising to deliver on that manifesto, he said the Government will focus on a stronger NHS, better schools, safer streets, control over

Truss defiant as she leaves Downing Street

■ Shortest-serving Prime Minister in British history defends her legacy, insists 'we need to be bold'

DEFIANT Liz Truss defended her legacy as she bowed out as the shortest-serving Prime Minister in British history.

Speaking in front of the iconic black door of 10 Downing Street on Monday, Ms Truss insisted she was right to pursue low-tax, high-growth policies to boost the economy.

She said her disastrous time in office had left her "more convinced than ever we need to be bold".

In her final speech as Prime Minister, after just 49 days in office, she said Britain must make the most of Brexit by slashing taxes.

She told the nation: "I believe in Britain, I believe in the British people and I know that brighter days lie ahead".

policy reversals

Her departure brought to an end a turbulent and at times chaotic premiership, marked in its final days by a series of humiliating policy reversals.

Government borrowing costs soared after then Chancellor Kwasi Kwarteng said he would cut corporation tax, income tax and remove the top rate of tax altogether.

The Bank of England had to take emergency action to prevent pension funds from collapsing and Jeremy Hunt was brought in to No11.

After initially defending her agenda, Ms Truss abandoned almost all of it in a bid to calm markets but saw support from her own MPs ebb away.

Having chaired her final Cabinet meeting before leaving Downing Street for the final time as PM, she said: "I am more convinced than ever we need to be bold and confront the challenges that we face."

'restoring power'

After quoting the Roman philosopher Seneca, she added: "We simply cannot afford to be a low-growth country where the Government takes up an increasing share of our national wealth and where there are huge divides between different parts of our country."

"We need to take advantage of our Brexit freedoms to do things differently."

She said the UK must cut taxes, adding that maximising the benefits of leaving the EU "means delivering more freedom for our own citizens and restoring power in

democratic institutions".

Ms Truss went on: "It means delivering growth that will lead to more job security, higher wages and greater opportunities for our children and grandchildren."

Ms Truss said one of her Government's biggest achievements had been providing support for millions of people to help with crippling energy bills this winter.

The former Prime Minister initially wanted to cap the annual amount people pay at £2,500 for two years.

The surge in wholesale gas prices has been largely blamed on Russia's invasion of Ukraine. A firm supporter of Kyiv, Ms Truss said: "We must be able to outcompete autocratic regimes, where power lies in the hands of a few."

"And now more than ever we must support Ukraine in their brave fight against [Vladimir] Putin's aggression. Ukraine must prevail."

"And we must continue to strengthen our nation's defences."

"That is what I have been striving to achieve... and I wish Rishi Sunak every success, for the good of our country."

Flanked by her

husband Hugh O'Leary and daughters Frances, 16, and Liberty, 13, Ms Truss said she would go back to being a backbench MP for her South West Norfolk constituency.

After the speech, Ms Truss went to Buckingham Palace to offer her resignation to

the King. From there she left for a holiday. A No10 source said Ms Truss still thought her economic plan was the right one and believed she would "keep making that point from the backbenches".

Ms Truss will now be able to claim the Public Duty Costs Allowance

currently set at £115,000 a year, to which all former prime ministers are entitled.

The allowance is a reimbursement of incurred expenses for office and secretarial costs "arising from their special position in public life".

Sunak, 42, is youngest UK leader in the modern era

Rishi Sunak will be the youngest UK Prime Minister in modern political history.

At 42, he is a year younger than David Cameron, who was 43 when he became PM in 2010.

Tony Blair was also 43 when he became Premier in 1997 – but was a few months older than Mr Cameron. Outgoing PM Liz Truss is 47.

Only two other PMs since 1900 have taken office below 50 – John Major (47 in 1990) and Harold Wilson (48 in 1964).

Mr Sunak will not be the youngest Prime

Minister in our history, however. William Pitt the Younger first took office in 1783 at just 24.

A number of politicians in their thirties held the job in the 18th century. And the Tory statesman Robert Jenkinson had just turned 42 when he took the job in 1812 – the same age as Mr Sunak.

Mr Sunak's appointment as PM will represent another milestone – he has made history in becoming the first non-white British PM.

And as MP for Richmond, North Yorkshire, he will be only the second Tory

PM representing a constituency in the North of England.

The first was Arthur Balfour, MP for Manchester East while Premier from 1902 to 1905.

Mr Sunak will be the third person in the job since the last general election, after Boris Johnson and Ms Truss.

The last time the UK had three different PMs in one parliament was in 1940, when Winston Churchill followed Stanley Baldwin (who served from 1935 to 1937) and Neville Chamberlain (1937-1940).

Biden: Rise Of 'Rashee Sanook' To PM 'matters'

Joe Biden congratulated Rishi Sunak on achieving a "ground-breaking milestone" – then made a hash of pronouncing his name.

The US President, speaking at a White House event to mark the Indian holiday of Diwali, said what sounded like "Rashee Sanook".

In part of his speech, Mr Biden said: "And whether it's the United Kingdom, where just today, we've got news that Rashee...Rashee Sanook is now the Prime Minister."

'pretty astounding'

He went on to say that becoming the first prime minister of colour was: "Pretty astounding. A ground-breaking milestone. And it matters, it matters."

Mr Biden and Mr Sunak spoke on the phone late the same evening.

A No 10 spokesman said: "Mr Biden said the UK remains America's closest ally. The leaders discussed the extent of UK-US cooperation, both bilaterally and in regions such as the Indo-Pacific where the AUKUS pact forms part of our efforts to enhance stability and counter China's malign influence.

"They reflected on the leading role our countries are playing in supporting the people of Ukraine and ensuring Putin fails.

"The leaders looked forward to meeting at the G20 Summit in Indonesia."

Huge jump in Channel crossings as almost two percent of all Albanian adult males come to Britain

■ Number of migrants arriving from the impoverished nation soars from 800 to 12,000

UP to two per cent of the entire adult male population of Albania has travelled to the UK via illegal Channel crossings this year, a top Border Force chief has revealed.

And he warned many of those end up working for Albanian crime gangs running "drug-smuggling, human-trafficking, gun and prostitution" rackets in the UK.

Dan O'Mahoney, the Clandestine Channel Threat Commander, told MPs the number of Albanians arriving on small boats has "accelerated rapidly" in a year from 800 to 12,000.

He said of those, 10,000 are single men and "large numbers... are deliberately gaming the system" by claiming asylum before vanishing from the hotels they are put up in.

Mr O'Mahoney added the soaring figures were due to the fact Albanian gangs have broken the Kurdish stranglehold on people-smuggling routes.

Speaking to the home affairs committee on Monday, he said: "Depending on how you look at it, one to two per cent of the entire adult male population of Albania has travelled to the UK by small boat.

"The rise has been exponential. We think that is, in the main, due to the fact Albanian criminal gangs have

gained a foothold in the north of France and they have begun facilitating very large numbers of migrants.

"Within that cohort there are undoubtedly people who need our help. But there are also large numbers who are deliberately gaming the system.

"There is a huge amount of very harmful, serious and organised criminality in the UK committed by Albanian criminal gangs.

"Whatever sort of criminality you can think of that is the most serious sort, there are Albanian criminal gangs who are dominating in those markets – be it drug smuggling, human trafficking, guns, prostitution."

His warnings came after shock figures last month showed the number of Albanians in UK prisons jumped from 180 in 2012 to 1,500 last year.

At that rate, ministers have been warned there will be more people from Albania in British jails than the 5,000 locked up in their own country within just four years.

Campaigners say the UK is at risk of becoming "Albania's Alcatraz".

Mr O'Mahoney said the Royal Navy has prevented hundreds of drownings as migrants try to cross the Channel in flimsy boats. He added: "Some of them will need our help and will file

borders, protecting the environment, supporting the armed forces, levelling up and building an economy that embraces the opportunities of Brexit.

Mr Sunak will be aware that having his ex-boss

Mr Johnson and Ms Truss on the backbenches, with close allies, has the potential to cause problems.

Bu Sunak warned of tough decisions and Mr Hunt said some measures will be "eye-watering". Tax hikes and spending cuts are expected to fill a black hole in Treasury coffers.

asylum claims.

"But a lot of them are not actually interested in claiming asylum... we'll put them in a hotel room, then they will disappear.

"They will work illegally for six months to a year and send money home.

"And they are able to do that because the way the asylum system works

and the way the National Referral Mechanism [for modern slavery victims] works makes it easy for them to do so."

More than 38,000 people have arrived in the UK so far this year compared with 28,526 for the whole of last year.

France has also stopped 28,000 attempts to cross – by destroying 1,072 boats.

Mr O'Mahoney said French laws prevent their police from detaining migrants or preventing them from making the crossings.

He told MPs: "I should put on record my thanks to the French... this is around double what they managed to achieve last year, so that is really, really significant."

Rushdie has lost sight of one eye and use of one hand after stabbing

AUTHOR Sir Salman Rushdie has lost sight in one eye and the use of one hand after he was stabbed in a brutal attack.

The 75-year-old, whose novel *The Satanic Verses* prompted a fatwa calling for his death, was knifed in the neck and torso more than a dozen times.

The Indian-born British writer was attacked as he walked on stage in New York on August 12. The extent of his injuries had been unknown until this weekend.

His agent Andrew Wylie said the wounds were "profound", adding: "He's lost the sight of one eye. He had three serious wounds in his neck.

"One hand is incapacitated because the nerves in his arm were cut. And he has about 15 more wounds in his chest and torso. So, it was a brutal attack."

Mr Wylie would not say whether he is still in hospital.

He added: "The attack was probably something that Salman and I have discussed in the past.

"Which was that the principal danger that he faced so many years after the fatwa was imposed is from a random person coming out of nowhere and attacking. So, you can't protect against that because it's totally unexpected and illogical. It was like John Lennon's murder."

The former Beatle was shot dead by a ex-fan in New York.

Hadi Matar, 24, from New Jersey, denies attempted murder of Sir Salman and assault.

January release date confirmed for Prince Harry's controversial memoir

■ Palace set for more controversy as "Spare" promises an account of "raw, unflinching honesty"

Prince Harry's memoir, an object of obsessive anticipation worldwide since it was first announced last year, is coming out Jan. 10.

The book will be called "Spare" and is being billed by Penguin Random House as an account told with "raw, unflinching honesty" and filled with "insight, revelation, self-examination, and hard-won wisdom about the eternal power of love over grief."

In a statement released Thursday, Penguin Random House summoned memories of the stunning 1997 death of Prince Harry's mother, Diana, and the subsequent image of Harry and his brother "walking behind their mother's coffin as the world watched in sorrow - and horror."

"As Diana, Princess of Wales, was laid to rest, billions wondered what the princes must be thinking and feeling - and how their lives would play out from that point on," the statement reads in part.

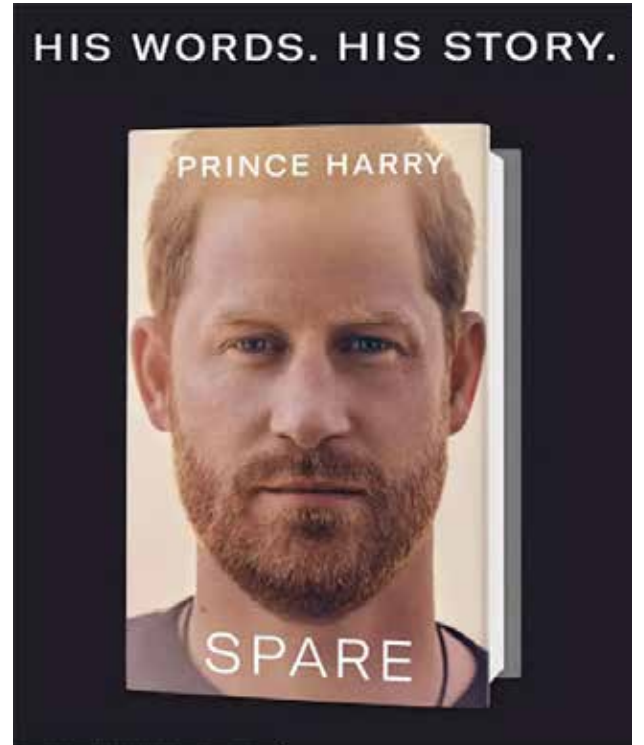
"For Harry, this is his story at last."

The memoir's title is an apparent reference to "the heir and the spare," a phrase often used to describe royal siblings. Harry's brother, William, is now Prince of Wales and heir to the British throne. When Harry was born, he was right behind William in the line of succession but has since been pushed down. Their father, King Charles III, assumed the throne upon Queen Elizabeth II's death last month.

Royals watchers and

the public at large have speculated endlessly since the book was first announced in July 2021. Within hours of Thursday's announcement, "Spare" was in the top 10 on Amazon.com's bestseller list.

The Duke of Sussex had already revealed a newsworthy willingness to discuss his private life when he and his American-born wife, Meghan, Duchess of Sussex, were interviewed by Oprah Winfrey for a bombshell March 2021 broadcast. The couple spoke of Meghan's deep unhappiness with her new life in England, the alleged racism within the royal family and Harry's fear that his wife's life might be endangered



had they remained in his native country.

In 1992, Diana worked with author Andrew Morton on her explosive memoir "Diana: Her True Story," in which she described at length her unhappy marriage to the future King Charles III. Harry and Meghan stepped back from royal

duties in 2020 and moved to the U.S. Harry told Winfrey that his family cut him off financially and that he helped pay for his security with money left to him by his mother. They have launched numerous initiatives, including a Netflix production deal and the nonprofit Archewell Foundation.

Therapy sessions for Harry Dunn's parents

HARRY Dunn's parents say they have needed constant therapy ahead of facing their son's killer Anne Sacoolas.

She will be sentenced in the UK next month.

Motorcyclist Harry, 19, died in August 2019 after Sacoolas ploughed into him in her car in Northamptonshire.

Sacoolas left the UK shortly after the deadly crash, claiming diplomatic immunity from prosecution, and the US refused to extradite her.

But last week, she appeared at the Old Bailey by video link when she pleaded guilty to causing Harry's death by careless driving.

This week Charlotte Charles and Tim Dunn appeared on CBS Morning in the US and said they were shocked when the judge ordered the 45-year-

old to return to the UK for her sentencing next month.

Ms Charles said: "We're having a lot of therapy right now. We started it some time ago.

"It's becoming more intense now, knowing that we may have to face her face to face.

"It was audible gasps all around the court when the judge in London said that she had to come back for sentencing."

Harry's parents said they have no wish to see mum-of-three Sacoolas, 45, jailed.

Ms Charles said: "It didn't need to be where we are now. Saying sorry would've been part of it.

"We'd lost everything. From the beginning, we said we didn't want to separate her from her children.

"She's a mother of three. We stand by that."

Give political statements the boot, Wrexham order star player

Wrexham have barred a player from wearing boots displaying an abusive message about Britain's governing Conservative Party, the fifth-tier National League club said in a statement on Tuesday.

Forward Paul Mullin posted pictures of the boots, taken at the club's Racecourse Ground, on Instagram on Monday.

Promotion-chasing Wrexham, owned by Hollywood stars Ryan Reynolds and Rob McElhenney, said the photographs were taken without the club's "knowledge or approval" and that they take a "neutral position" on political matters.

The club described the post as an "unwelcome distraction" before their home game against Halifax Town later on Tuesday but said the 27-year-old, who has scored 11 times in 14 league games this season,



will remain a key player in their promotion bid.

"For the record, the pictures wouldn't have been permitted to be taken, had we known, and the issue will be dealt with privately by the club," Wrexham said in the statement.

"The club also acknowledge that everyone is entitled to their own opinion, whether that be employees or supporters, but would also highlight that an individual view cannot be fairly attributed as the view of everyone or the club itself."

Orkney cuppa fan toasts her 'miracle' tea crop

The first production of tea from a small crop in Orkney has been described as a "dream come true".

Lynne Collinson has been growing the leaves in what she believes must be the UK's most northerly tea plantation.

She said she was delighted with the taste of the first batch, which has now been processed.

Mrs Collinson said her plantation would not be a major commercial enterprise any time soon, but hopes it will inspire people to try new things.

People in the UK consume tens of millions of cups of tea every day, but talk of tea plantations usually conjures up images of hillsides in countries like India.

But now the colder

and windier climate of the Northern Isles has joined the ranks of tea producing areas - on a tiny scale.

Speaking to BBC Radio Orkney, Mrs Collinson, of Shapinsay, described her plantation as "a miracle".

"It's tea growing out of doors in Orkney, probably the furthest north that tea has ever grown outside," she said.

"They are thriving, despite the wind, the rain, and the fact that tea plants just do not normally like this kind of condition."

She has been working with local plant scientist Peter Martin.

The crop is split between two outdoor fenced-in plantations under nets.

A further 35 plants are grown separately, under cover, in a polytunnel.

"The amount I've produced this year is 1.5kg (3.3lbs) of processed finished tea," she said.

"And that took 7kg (15.4lbs) of picked leaf."

The first batch of Norse Noir was processed in Crieff, Perthshire.

"I have only got 65 packs of 15g portions of tea in packs so I haven't got loads to play with," Mrs Collinson explained.

"It looks delicious because it's so rich and black."

"It's a dream come true, because it's all the hard work, and all the worrying about how the plants are doing. It's all over, there's actually now a product."

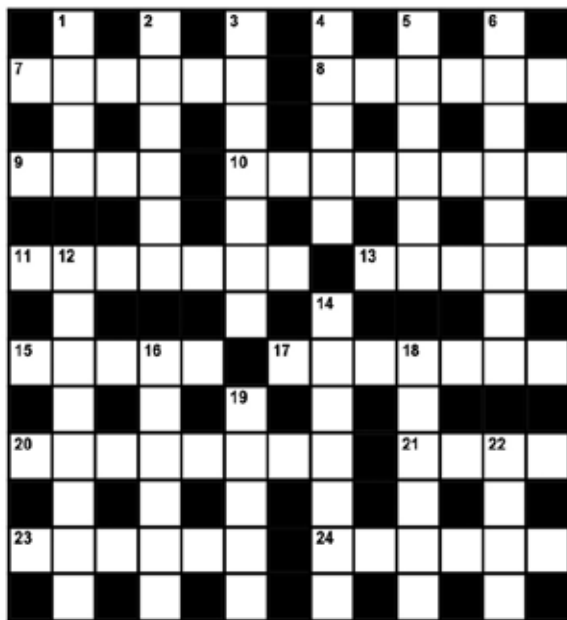

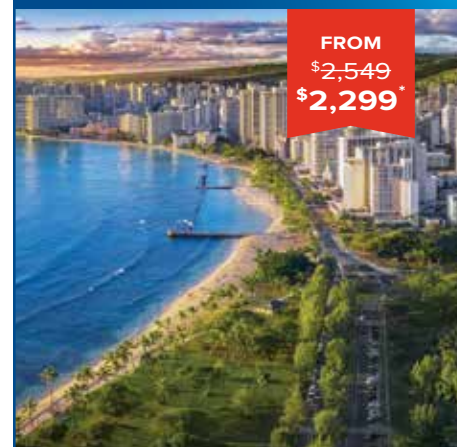

Best of all, they sell '99's' - for those of you who don't know what I mean it's a good old fashioned Mr Whippy Ice Cream with a chocolate flake stuck in it. I've not had one for years so maybe that clouded my judgement, but it was the best ice cream I have ever tasted. Ye Olde Kings Head is also the place to go if you want to pick up a free copy of this very newspaper - the British Weekly - it was such a treat to read the actual newspaper as I usually read it online.

It brought back memories of when I first moved to LA in the 90s - I didn't really know anyone and there wasn't much information on the World Wide Web, so I would pick up a copy of this, the (now defunct) Union Jack and the LA Weekly in the hope that I would find something fun to go along too. 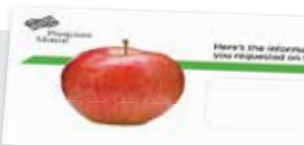

Ronaldo back in the goals for United

■ Europa League: Red Devils coast to easy win over Sheriff

Cristiano Ronaldo marked his return to the Manchester United fold with his 701st career goal to seal a comfortable 3-0 Europa League win over Sheriff Tiraspol at Old Trafford on Thursday night.

Dropped for last weekend's trip to Chelsea as punishment for refusing to come on as a substitute against Tottenham in the league, it seemed as though Ronaldo was destined not to score after being handed a starting role by manager Erik ten Hag.

But with nine minutes left, the Portuguese great got his head to a Bruno Fernandes cross. Sheriff keeper Maxym Koval made a low save but as the ball spilled loose, Ronaldo pounced to complete United's biggest win of the season and extend their unbeaten run to seven matches in all competitions.

It was a positive end to a difficult week for the five-time Ballon D'Or winner.

"He kept going and the team kept going to put him in the right position," said Ten Hag. "He kept going to get himself in the right position. He didn't give up and I think that's what he's done his whole career and in the end he got his reward for it."

For United, it set up a Europa League group decider with Real Sociedad in Spain next week, when the Premier League side must avenge their defeat on matchday one - and win by two goals in the process - to top the group and avoid a play-off that could pit them against European heavyweights Barcelona, Juventus or Atletico Madrid.

Diogo Dalot put the hosts on their way to victory with a near-post header from Christian Eriksen's corner a minute before the break.

Substitute Marcus Rashford then headed home Luke Shaw's left wing cross midway through the second period.

The problem with gauging any negative reaction to Ronaldo comes from the knowledge that when fans bellow his famous 'Siuu' celebration, it sounds very much like booing.

There was certainly a noise that wasn't supportive cheering when the Portuguese's name was read out just before kick-off and the best that could be said was that the reaction was mixed.

The truth is, at 37, Ronaldo has struggled to make an impact this season.

His best first-half opportunity came when Bruno Fernandes steered a header to him inside the six-yard box. Normally, the stabbed finish would have found the bottom corner. This time it went straight to goalkeeper Koval.

There was an audible gasp of expectation at the start of the second half, when Ronaldo stepped to his left as he has done so often in his

career to make space for a shot from the edge of the area.

The entire stadium waited for the net to bulge. Instead the shot flew wide, to Ronaldo's total disbelief. Shortly afterwards he did find

the net with a volley, which was correctly ruled out for offside. Within seconds a supportive 'Viva Ronaldo' chant rolled round the ground.

It marked a turning point from the stadium.

Ronaldo's goal brought jubilation, even though the game was won. And the noise that came from the tunnel area as he made his way to the dressing rooms at the final whistle was very much a positive one.

Arsenal need to reset after loss - Arteta

Premier League leaders Arsenal have to "reset" after losing to PSV Eindhoven and missing the chance to seal top spot in Europa League Group A, says boss Mikel Arteta.

The Gunners only needed a point in the Netherlands on Thursday night to advance to the last 16 next March.

But Joey Veerman's first-time finish from 16 yards and a header by substitute Luuk de Jong - after a mistake by keeper Aaron Ramsdale on his European debut - meant Arsenal lost in Europe for the first time this season.

"I'm very disappointed," added Arteta.

"We were nowhere near our level and we know that in Europe it's very difficult to win. I saw a number of the boys running out of energy because we had to chase the ball so much.

"It's the end of a long run where we won a lot of games and we have to reset."

PSV, managed by former Manchester United forward Ruud van Nistelrooy, also had three goals ruled out for offside as Arsenal were well

beaten.

The Gunners need to beat Zurich, who they defeated 2-1 in Switzerland on 8 September, in their final group game next Thursday at Emirates Stadium (20:00 GMT) to guarantee a place in the last 16.

If they fail to win and PSV beat Bodo/Glimt in Norway, Arsenal will face two extra games in the knockout round playoffs, which will also include teams who finished third in their Champions League groups, including Barcelona.
