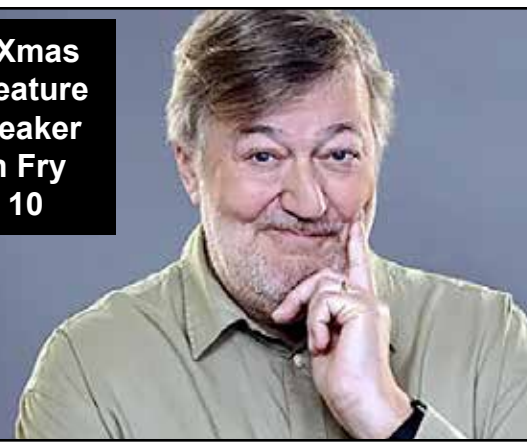

Migrant Crisis? Let's send them to Paraguay!

■ As illegal arrivals top 40,000, embattled Home Secretary desperate for a South American solution to ease the crisis

THE HOME SECRETARY has announced she is in talks with Paraguay, Belize and Peru as possible destinations to deport the growing tide of migrants arriving on British shores.

Suella Braverman is pushing through talks with alternative destinations to Rwanda, with Paraguay at the most advanced stage.

And another African country is "also in the mix", a source revealed.

It is understood Ms Braverman only agreed to return to the Home Office after supporting Rishi Sunak in the leadership contest on the basis she would "have a free hand" to tackle illegal immigration, particularly the problem of the small boats in the Channel.

So far this year, almost 40,000, have made the dangerous crossing from France with the help of organised criminal gangs. The daily cost to the taxpayer for housing them in hotels is almost £7 million.

A senior Whitehall source said: "We have other talks going on. Paraguay is the most

advanced at the moment. "We have to break the business model of the people traffickers and we can only do that if the people they are bringing over understand that their final destination will not be Britain."

legal problems

The Rwanda deportation deal was held up after a number of lawyers contested the plans to send illegal migrants to the east African country.

The final straw came when an unnamed judge in the Strasbourg-based European Court of Human Rights ruled against the flights in a private hearing. Legal problems mean it will be next year before the deportations to Rwanda can take place.

The deal with Rwanda has cost £120million, with more money yet to be paid. But deals with

different countries will mean that new legal challenges will have to be made if activists want to stop the flights.

The source said: "Obviously, Paraguay is a different country with different conditions and a different human rights record. It should be more difficult to challenge flights there."

'truly shameful'

The move has been welcomed by Tory MPs who have been pressing for action to be taken. Stoke-on-Trent North MP Jonathan Gullis said: "This is a terrific idea.

"We should be trying to do as many deals with as many countries as we can and get these planes off the ground.

"We should also be calling out these Labour-supporting Lefty activist lawyers who are doing everything they can to stop us tackling this

crisis."

Bassetlaw, Notts, MP Brendan Clarke-Smith said: "Offshore processing has the potential to break the business model of the criminal people-smuggling gangs and it's truly shameful that the Opposition and their allies have done nothing but try to frustrate this from the very start. Partnerships

with countries such as Rwanda and others are most welcome and will help us tackle illegal immigration."

Dudley North MP Marco Longhi added: "I would support any workable measures that would have the deterrent effect on illegal incursions on to UK soil.

"The whole point

of being immediately removed to any other country is to put off people from trying in the first place. Crossings would then stop."

On Monday, Ms Braverman warned in the Commons that the UK is facing "an invasion" on its coast with thousands of migrants coming across the Channel.

What us, worry? Top Tory insists there is nothing to fear despite Truss hack claim

■ “very robust protocols” in place insists Michael Gove

TORY MINISTER Michael Gove insisted this week the Government has “very robust protocols” in place after claims that Russian spies hacked Liz Truss’s phone.

Kremlin agents reportedly accessed the ex-premier’s mobile while she was foreign secretary.

And that could have given access to exchanges with officials about Ukraine as well as private conversations with Kwasi Kwarteng who later became her chancellor.

The embarrassing revelation is the second security row to rock the Government in two weeks.

It comes amid criticism of Suella Braverman’s reappointment as Home Secretary after she breached the ministerial code by passing on Government documents from her personal phone.

Boris Johnson and Cabinet secretary Simon Case.

But when quizzed about the matter yesterday, Levelling Up Secretary Mr Gove said: “I’m sure that Liz, both as foreign secretary and as prime minister, will have followed the advice that she was given by the intelligence and security communities.

‘hidden threats’

“The more that we talk in detail about these things, the more that we risk giving information to people who wish this country and its citizens harm.”

Mr Gove said he did not know the full details of “what security breach, if any, took place”.

He said: “What I do know is that the Government has very robust protocols in place in order to make sure that individuals are protected, but also that Government security and national security are protected as well.”

He refused to discuss the potential implications as “loose lips can sink ships when it comes to these

questions”.

Former MI6 chief Sir Alex Younger said MPs do not understand enough about cyber-security.

He said: “Levels of education aren’t high enough, and I don’t think people are focusing enough on the risks to their security and their devices, because these are hidden threats that aren’t properly understood.

“I think that’s true of ministers as anyone else, and there’s a premium on making sure that they’re properly educated.

‘not good enough’

“I would be extremely surprised, by the way though, if the sort of material that we handled in the agencies – so secret intelligence material – gets anywhere near mobile devices connected to the internet, in ministerial hands or otherwise.”

The former head of the Army, Lord Dannatt, said: “Our leaders must be sufficiently disciplined to only communicate through authorised means

Arsonist ‘made recce trip’ to migrant center before firebomb attack

A SUICIDAL fire bomber who targeted an immigration centre drove more than 100 miles to stake out the target the night before, it was claimed this week.

The attacker, who later killed himself, is suspected of carrying out reconnaissance while driving in a car park nearby.

His SUV is believed to have been spotted by security staff on Saturday night.

The 66-year-old man, from High Wycombe, Bucks, returned to the migrant processing centre at the Western Jet Foil base at Dover, Kent, on Sunday morning.

He laughed as he hurled three home-made incendiary devices at the site. Two people suffered minor injuries in Sunday’s attack.

Officers have searched the man’s home address – 120 miles from Dover. His motive is unclear but police are not treating it as terrorist-related at present.

The bomber hurled abuse at coach drivers who take asylum seekers to a processing centre at Manston near Ramsgate, Kent.

He allegedly shouted: “Do you know what you’re doing? All your children should be raped and killed.” He then drove to a BP fuel station

where he killed himself.

Bomb disposal experts made safe a fourth improvised device in the SUV. One source said: “He has clearly put a fair amount of planning into this. It looks like he knew the layout around the centre fairly well and had decided he was going to take his life.”

Another source said the man had recently been questioned on serious crimes. It was claimed he threatened to commit suicide in the interview and was put under supervision.

Police said: “The suspect, found deceased at a petrol station, is a 66-year-old man from the High Wycombe area.”

UK citizenship test so hard, says Meghan

THE Duchess of Sussex has revealed she studied for the UK's citizenship test – but even husband Prince Harry had “no idea” about some of the answers.

Meghan, 41, said she revised for the exam – although it is believed she ultimately did not take it before quitting Britain almost three years ago.

The royal mum-of-two spoke about her experience on the latest episode of her Spotify podcast series Archetypes.

Her guests were comedian Pamela Adlon, who became a British citizen in 2020, and Sophie Trudeau, the wife of Canadian PM Justin Trudeau.

Discussing the “Life in the UK” test, Meghan said: “That citizenship exam is so hard. I remember going, ‘Oh my goodness’. I would ask my husband, ‘Did you know this? Did you know this?’ And he would say, ‘I had no idea.’”

Pamela, who is best known for her role in the FX series *Better Things* and Showtime's *Californication*, joked: “I think they made it harder for you. They were like, ‘We're gonna really throw up walls on this one.’”

The Duchess – who was born in Los Angeles – did not elaborate on whether she sat the test, which asks questions about laws, working in the UK, its history, culture and other details of British life.

It can also contain questions about the Royal Family. Meghan would have needed to pass the test, which costs £50 per exam, before applying for citizenship. But experts said she did not live in the UK for the three years required for spousal citizenship after marrying Harry in 2018.

The UK terror survivors tracked down by ‘disaster trolls’

■ Injured Britons report being tracked down at work and home by those who claim they are crisis actors

IN A worrying indication that a disturbing American trend may have been exported to Britain, survivors of terror attacks in the UK have claimed that ‘disaster trolls’ have been tracking them to their homes and workplaces to see if they are lying about their injuries.

According to a report from the BBC, Martin Hibbert, who was paralyzed from the waist down when he and his daughter Eve were caught in the 2017 Manchester Arena blast, is now preparing to bring libel action against a conspiracy theorist based in Wales.

At the center of the allegations are Richard D Hall, who tracks down survivors of the attack – in which 22 people were killed and more than 100 injured – to determine whether it was faked. In an online post, Hall says he spied on Eve from a vehicle parked outside her home.

wider phenomenon

In a video shared with his followers online, Mr Hall demonstrates setting up a camera to film Eve, now profoundly disabled and in a wheelchair, to see whether she can in fact walk.

“I’m all for freedom of speech,” Martin Hibbert told me. “But it crosses the line when you’re saying I’m an actor or I’ve not got a spinal cord injury or Eve’s not disabled, she’s not in a wheelchair.”

“You don’t know how far he’s going to go to get answers.”

Mr Hall suggests that those who were killed in the attack are really alive and living abroad. He also promotes theories that several other UK terror attacks were staged. A former engineer and website

designer, he makes money from selling books and DVDs outlining his theories, as well as speaking at events and posting videos online. As recently as mid-October, he had more than 16 million views and 80,000 subscribers on YouTube.

And Mr Hall appears to be only emblematic of a wider phenomenon that survivors and bereaved families are experiencing.

A victim of the 2017 Westminster Bridge terror attack, who has been harassed by online conspiracy trolls, told the BBC that surviving a terror attack now seems to inevitably lead to being abused.

These types of conspiracy theories, and the abuse they inspire, echo those of Alex Jones, the US host of the conspiracist show and website Infowars, who this month was ordered to pay nearly \$1bn to families of the US Sandy Hook school shooting after falsely claiming the 2012 attack was a hoax.

Online abuse describing terror attacks as hoaxes, and those who were injured as so-called “crisis actors”, appear to be on the rise since the pandemic, according to survivors. Most of the abuse has been perpetrated online, but several victims say they now fear for their safety because the abuse has also begun to affect their lives offline.

more suspicious

According to the alarming results of one recent poll, almost one in five people in the UK think terror survivors are not telling the truth about what happened to them. A third say the pandemic has made them more suspicious of official explanations of UK terror attacks.

The survey of more than 4,000 people, weighted

to be representative of London, also suggests the UK population and that 14% believe the 2017 Manchester Arena attack carried out earlier this month by King’s College

actors” who pretended to be injured.

Martin Hibbert’s lawyer, Neil Hudgell, who is preparing a libel case against Mr Hall, said: “Martin’s got to the point of enough is enough. This needs tackling and to be silenced in legitimate ways.”

Mr Hall’s claims and tactics also include: Entering the workplace of Manchester Arena survivor Lisa Bridgett, posing as a customer, with the aim of secretly recording her to discover whether she’s lying about her injuries; visiting the homes of other Manchester survivors to try to question them about whether the attack was a hoax; and publicizing the names and locations of dozens of Manchester survivors and bereaved relatives of victims in a video – appealing to his followers to send him any information they have about them.

Barton cleared of assaulting wife



FORMER footballer Joey Barton (above) has been cleared of assaulting his wife after a judge ruled a trial would be unfair.

Wife Georgia called police on June 2 last year claiming he had hit her at their home in Kew, south west London.

Mrs Barton, who is said to have been left with a golfball sized bruise on her forehead and a bloody nose, was "upset and shaken", when she dialled 999 at 11.15pm, Wimbledon Magistrates' Court heard. But she later wrote to prosecutors explaining that the injury was caused accidentally during a drunken argument when friends intervened.

Prosecutors said the account was an attempt to "exculpate" her husband and refused to call her to give evidence.

District Judge Andrew Sweet said this meant Barton would not get a fair trial. The judge said prosecutors could have treated his wife as a hostile witness instead.

Bristol Rovers manager and former Manchester City star Barton, 40, denied assault.

Body-worn police footage played in court captured his wife, 36, saying: "I was pushed and kicked about and stuff."

The officer noted "a bit of a lump and some blood".

Prosecutor Daniel O'Donoghue said footage of Barton's arrest showed he was "clearly intoxicated".

Interest rates hiked to 3% as Bank struggles to battle inflation

■ British interest rates now at their highest since 2008 - with no end in sight for consumers

The Bank of England has increased interest rates by 0.75% to 3% bringing them to their highest level in 14 years.

In its November Monetary Policy report, the Bank said that inflation - which now stands at over 10% - is "too high" and that "raising interest rates is the best way we have to bring inflation down".

The move is the biggest increase since Black Wednesday in September 1992 and will mean increasingly crippling mortgage costs for many and is the continued legacy of the disastrous mini-budget, launched by former Chancellor Kwasi Kwarteng last month.

Economists believe rates will rise again in December and next year. For British consumers, this means mortgage customers and those with credit cards and personal loans should brace themselves for a series of interest rate hikes over the coming months.

better news in 2023?

Higher interest rates make borrowing more expensive and traditionally have encouraged people to save. While this may depress the economy in the short term, the benefits of pushing inflation down make the pain worth it, in the Bank of England's calculations.

The Bank is now predicting inflation will remain above 10% for the next two quarters before falling sharply from the middle of next year when, among other

factors, the price of energy is not expected to rise so rapidly.

Responding to the hike, the Chancellor of the Exchequer, Jeremy Hunt said that interest

rates were rising across the world "as countries manage rising prices largely driven by the Covid-19 pandemic and Putin's invasion of Ukraine".

Toshack speaks of 'frightening' Covid fight

FOOTBALL legend John Toshack has spoken for the first time about his "frightening" fight for life against Covid.

The ex-Liverpool and Wales striker feared the worst as he spent two weeks in hospital on a ventilator battling to survive.

Toshack, 73, who lives in Spain where he has twice managed Real Madrid, was rushed into intensive care with breathing problems in February this year.

He told the BBC: "I've been seriously ill and I've recovered. Thank God, I'm out okay."

The former Swansea boss added: "When somebody tells you that you were out for two weeks, it's frightening."

Former top Tory Hancock punished for reality show stint

Matt Hancock, who was stripped of the Tory whip for travelling to Australia to take part in *I'm A Celebrity*, has defended his appearance on the reality show, saying that politicians needed to "leave their ivory towers" and "go to where the people are". His critics were not convinced, but one did see an upside. "I'm looking forward to him eating a kangaroo's penis," said a member of the Conservative Association in his West Suffolk constituency. "Quote me. You can quote me on that."

Long property boom coming to an end?

BRITAIN'S seemingly-endless property boom is finally coming to a halt - with many experts predicting a price crash if mortgage rates continue to rise.

The Bank of England's historic interest rate hike of 0.75 percentage points to 3% this week is the biggest single rate rise in more than three decades, which will feed through into higher mortgage costs for most Britons, who tend to have adjustable rate mortgages.

The average property price in the UK fell for the first time since July 2021, dropping 0.9% month-on-month in October. Annual house price growth also slowed last month from 9.5% to 7.2% in September.

For years, home ownership in Britain has been a one-way bet with prices rising every year since 2012. Now,

that boom is over.

The drop in house prices is fuelled partly by dropping demand. Approvals for purchases fell to 66,800 in September, compared to more than 74,300 in August, according to the BoE. The very obvious reason for that demand drop is rising mortgage rates.

'uncertain'

Nationwide Building Society chief economist Robert Gardner said the "outlook is extremely uncertain" for the property market, and it will be determined by "how the broader economy performs".

Throughout the Covid-19 pandemic, the housing market remained surprisingly strong, despite the worsening cost of living crisis. The market was temporarily boosted by a strong jobs market, a

persistent shortage of properties on the market and a race for space amid the rise in working from home. But that trend could not last, and usual, the bigger the party, the longer the hangover.

Affordability rates for many Britons are at historic lows. For the average first-time buyer on an average income with a 20% deposit, a 5.5% mortgage rate, and purchasing a typical first-time buyer home would need to spend around 45% of their take-home pay on their mortgage. For many Britons, that is simply unthinkable.

Leading estate agency Savills has predicted a 10% drop in property values in 2023 with transactions expected to fall by 27% in that period, from 1.19m this year to 870,000 - the lowest level in more than a decade.

In other news....It wasn't all bad

A lawyer has broken through what she has described as a "triple-glazed glass ceiling", by becoming Britain's first blind and black female barrister.

Londoner Jess Inaba, 23, qualified last month after five years of legal study. She had used her own Braille materials, compiled with the help of friends who read books to her, and plans to apply for pupillage in January. "It's really good feeling," she said. "I know I'm giving hope to others in similar situations to mine."

Rare textiles found at Tudor mansion

An extremely rare collection of Elizabethan textiles has been found at a Tudor mansion in Nottingham. The textiles – identified at Wollaton Hall during the filming of the BBC's Antiques Roadshow – include a bedspread, two pillowcases and a "farthingale" sleeve. Made from thick cotton, the sleeve was used to support the voluminous sleeves of the silvery dress that Elizabeth I wore for The Ditchley Portrait, in around 1592. Ninya Mikhaila, a textile historian, said that when she was shown the sleeve she was rendered "literally speechless".

Bird sets record by flying 8,425 miles

A bar-tailed godwit has set a world record by flying at least 8,425 miles from Alaska to Tasmania, without pausing to eat, drink or sleep. The five-month-old bird, which had been fitted with a 5G satellite tag, set off on 13 October, and touched down in Ansons Bay in northeast Tasmania just 11 days later. Its route had taken it over several islands in Oceania, including New Caledonia, but it did not take the opportunity to stop off to refuel. Eric Woehler, a researcher at BirdLife Tasmania, said the godwit had probably lost "half or more of its body weight" over the course of its marathon flight.

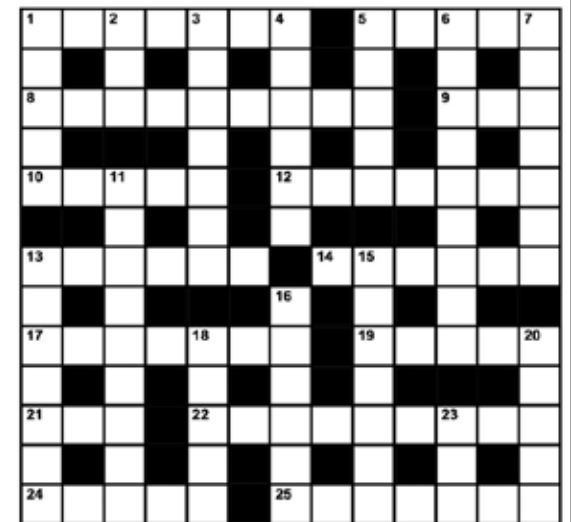

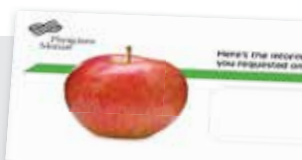

Hundreds of poorly paid police officers poised to quit for a new life Down Under

■ Western Australia's recruitment drive draws big response from UK PCs battling low morale, scandals and pay disputes

HUNDREDS of poorly paid police officers are poised to quit for a new life Down Under, according to a report in a leading British newspaper this week.

Western Australia has issued a "come and join us" plea to fed-up officers pounding the UK's increasingly lawless streets.

The list of perks includes £47,000 starting salaries and free housing.

The recruitment drive has sparked a "phenomenal response" with 600 officers in touch in the first 48 hours. More than 200 have since submitted formal applications.

The Anglo-Australian recruitment drive is the latest blow to a UK police service reeling after a string of high-profile scandals amid historic battles over pay and conditions.

In a direct appeal Col Blanch, commissioner of the Western Australian Police Force, said: "As Europe heads towards the bitterly cold winter, and as the long sunny days return to Western Australia, I am calling

for UK officers to join me.

"We're poised to take your application. It's a long way to travel but once you arrive I am confident you'll settle in easily and quickly."

The campaign to lure British officers, seen as the best in the world, includes fast-tracked Australian citizenship and six weeks paid annual leave.

Those moving to the largest policing jurisdiction in the world have also been promised significantly less violence, particularly knife crime.

Jobs in Australia's largest state – population 2.6 million – include frontline roles with officers handed a standard issue Glock 22 firearm.

Expats will also get free fitness facilities and the chance to enjoy a "vast variety of environments, communities, policing roles, styles and travel opportunities".

And in a dig at the notoriously grim weather back home, those behind the drive make clear Western

Australia enjoys sunshine for nine months of the year with daily access to "spectacular coastal views and lifestyle – sun, sand and surf".

The inducements are a world away from the grim reality of life as a British bobby.

Scores of former UK and Irish officers who have already taken the plunge are ready to help new recruits settle. They include Sergeant Andrew Dueman, who quit the Met in 2007 and is now helping to lead the campaign.

Applications have been received from those currently serving right across the British Isles.

But the desperate plea for officers to move Down Under shows that things may not be quite so rosy there. In July it was reported a record number had quit the Western Australian force, claiming mental fatigue and pressure on families.

In the past year 340 police officers left, with 60 quitting in June alone.

Mick Kelly, of the WA Police Union, said:

"Our people have said enough's enough, my mental health and family relationships are breaking down. They've left because of a culture of senior executives not caring for the workers and the members, so it's quite disturbing."

It is one of several industries facing staff shortages, with many lured into high-paying mining jobs because of an "absolutely booming economy" that has sparked "fluidity in the workforce".

However, the recruitment campaign will worry those desperately trying to persuade a new generation of recruits to sign up in the UK.



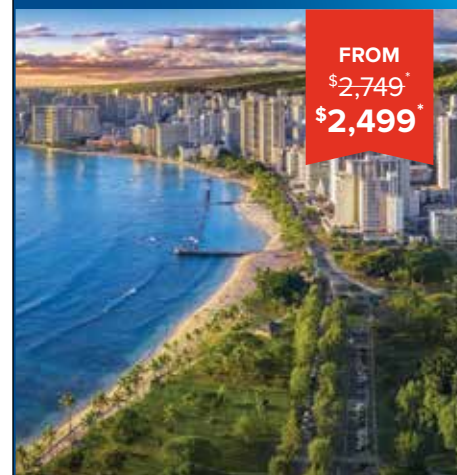

Arteta: winning helps winning

Arsenal boss Mikel Arteta says that "winning helps winning" as his side narrowly beat Zurich to secure their place in the last 16 of the Europa League on Thursday.

Kieran Tierney's thumping 20-yard drive into the bottom right corner ensured the Gunners finished top of Group A on 15 points, two clear of PSV Eindhoven.

It was also the Premier League leaders' 10th

victory in 12 matches in all competitions, a habit Arteta is keen to retain with his side facing three more matches until their season breaks for the World Cup in Qatar.

"Job done. I don't think it was the prettiest game we have played but we manage to win it," Arteta told BT Sport.

"Today was really important. We know how important it is going to be with all the teams playing

in February. Winning helps winning.

"The atmosphere in the dressing room is much better after a win than a loss."

While Arsenal's margin of victory could have been more significant, there were still other positives for Arteta to take.

The Spaniard was able to introduce Bukayo Saka after the break to allay any fitness concerns and he also rested several key players

prior to Sunday's Premier League trip to Chelsea.

The only complaint was that Arsenal did not put the result beyond doubt during a dominant first-half display in which Eddie Nketiah twice stung the palms of Zurich goalkeeper Yanick Brecher, and Fabio Vieira saw his goalbound effort blocked from close range.

That ensured a nervy finale with Adrian Guerrero's left-foot effort ruled out for offside and Ukrainian forward Bogdan

Viunnyk seeing his rasping drive just fly wide of the top left corner as the visitors searched for an equaliser.

However, the hosts held on and have now won all eight of their matches against Swiss clubs in European competition.

Arsenal's defeat at PSV had left them needing a win to guarantee their progress without the prospect of a two-legged play-off in February against one of the clubs dropping down from the Champions League.

While they made a

slow start, largely due to their improvised line-up containing seven changes from last Sunday's 5-0 win over Nottingham Forest, the Premier League leaders achieved their objective.

Arteta's side have now won all nine of their home games in all competitions this season but this performance will not be one he is likely to refer back to quickly, and he will also have been concerned to see Japan international Takehiro Tomiyasu limp off less than 15 minutes after coming on as a substitute.

Ronnie Radford dead at 79

RONNIE Radford, scorer of arguably the greatest FA Cup goal, has died at 79.

Radford wrote himself into the competition's history with his stunning strike as Southern League club Hereford knocked First Division Newcastle out of the Cup in a third-round replay in February, 1972. Hereford, a phoenix club now in Vanarama National League North, said in a statement: "Hereford are devastated to hear of Ronnie's passing, and wish to extend our deepest condolences to his family and friends at this very sad time.

"Ronnie is not just a part of Hereford United folklore, he is a part of football history and has kept Hereford on the football map since 1972."

Newcastle looked to be coasting at Edgar Street when Malcolm Macdonald fired them in front in the replay after a 2-2 draw, but Radford's piledriver set the stage for team-mate Ricky George to secure a 2-1 win.

The 'Voice of Football' John Motson said: "He scored the goal that changed my life.

"I stumbled across arguably the greatest giant-killing of them all - and it earned me a promotion of sorts on to the programme's roster of regular commentators."

United's latest prospect makes his mark in Spain

■ **EUROPA LEAGUE: Alejandro Garnacho scores only goal in 1-0 win as United miss out on top spot**

Teenager **Alejandro Garnacho** scored an outstanding goal as Manchester United ended Real Sociedad's flawless Europa League record on Thursday night, but had to settle for second place in Group E.

Erik ten Hag's side needed to win by two goals or more in Spain to finish top of the group, and their spirits were lifted when Garnacho showed terrific pace before firing Cristiano Ronaldo's pass into the corner of the net.

It was a wonderful moment for the 18-year-old Madrid-born winger, who was making his second start for the Red Devils.

Ronaldo missed a great

chance to double the lead with a lob on to the roof of the net, before David de Gea produced a fine double save to keep out Andoni Gorosabel and Pablo Marin.

United finish the group stage level on 15 points with Sociedad, who advance to the last 16 with a superior goal difference.

The Red Devils will now play in February's knockout-round play-offs, where they will face one of the clubs dropping down from the Champions League.

Teams they could meet over two legs include Barcelona, Ronaldo's former club Juventus, Ajax, who Ten Hag managed for five years,

and Ukraine's Shakhtar Donetsk.

Bayer Leverkusen, Sporting Lisbon, Red Bull Salzburg and Sevilla are also in Monday's draw for the knockout round.

Had United scored one more goal without conceding, they would have advanced as group winners and avoided two extra games in February.

They were in complete control in the first half but did not manage a single shot on target after half-time, and ended the match with substitute Harry Maguire up front alongside Ronaldo and Marcus Rashford.

On a wet night in the Basque Country, Garnacho became

United's youngest non-English scorer in Europe at the age of 18 years and 125 days.

Four weeks ago the Argentina youth international scored a late winner for United's under-21 side in the EFL Trophy at Barrow, and last Thursday made his full debut in the 3-0 Europa League win over Sheriff Tiraspol at Old Trafford.

In San Sebastian, Garnacho showed what a talent he is with a composed 17th-minute finish after receiving Ronaldo's well-timed pass outside the penalty area before finishing inside the box.

Ten Hag praised Garnacho's "great finish" a week after revealing he had been irked by the teenager's attitude earlier

in the season - a situation Bruno Fernandes expanded on in Spain.

"He is still only young but he is doing very well," said Fernandes after the game.

"At the beginning of the season he was not at his best. He didn't have the best attitude that he should have on tour. But he is deserving of his chances now."

Fornals brace as Hammers ensure perfect record

Pablo Fornals scored twice on Thursday night as West Ham finished the Europa Conference League group stage with a perfect record by beating FCSB in Romania.

With top spot in Group B and a place in the last 16 already assured, manager David Moyes opted to give some of West Ham's promising youngsters a chance to shine, and they made the most of the opportunity by contributing to a dominant display.

But it was the experienced Fornals who made the telling difference, his double helping to secure a sixth win from six group games.

Fornals scored his first before the break with a fierce drive before a

header by 18-year-old debutant Divin Mubama was turned over his line by Joyskim Dawa.

Fornals rounded off the impressive win by sweeping home his side's third midway through the second half.

With nothing at stake in this game, Moyes fielded a very youthful side with Mubama joined in the first XI by midfielder Oscar Scarles, who was making his debut at the age of just 16 years and 326 days.

In addition there were midfielders Conor Coventry, 22, and Flynn Downes, 23, and 22-year-old full-backs Ben Johnson, joined by a sprinkling of the club's more experienced players.

Downes has consistently impressed in

this competition, but they all brought energy and hunger into a game that could easily have played out like a pre-season friendly, given the lack of anything to play for.

Despite his age, Scarles played with real maturity on the left and provided a number of dangerous crosses, and the crowning moment really should have been a goal for 18-year-old Mubama.

Although he initially celebrated what was West Ham's second as his own after heading a cross powerfully towards goal, it was later given to FCSB's Dawa as he tried in vain to clear off the line.

But that will be the only disappointment on a night that should be seen as a huge success for the club's youth development.
