Farewell, Leslie Phillips

“He was quite simply a national treasure. People loved him. He was mobbed everywhere he went.”

Actor Leslie Phillips, who was known for appearing in the Carry On films, has died aged 98 after a long illness.

Phillips was also familiar to younger fans as the voice of the Sorting Hat in Harry Potter films. Phillips' agent Jonathan Lloyd confirmed the star died peacefully in his sleep on Monday.

The comic actor starred in more than 200 films, TV and radio series over his eight-decade career.

He was known for catchphrases such as “Ding dong” - a reference to the name of his character Jack Bell in 1959's Carry on Nurse - “I say” and “Well, hello”, which he delivered with suggestive intonation.

While he only starred in four of the 31 Carry On films, the actor said his famous catchphrases followed him for the rest of his career.

His death - which comes two years after Barbara Windsor's - leaves Jim Dale, 86, as the last surviving regular from the Carry On films.

Coronation Street actor Tony Maudsley, who worked with Phillips, was among those paying tribute, tweeting: “RIP Leslie Phillips. Working with him was a joy. And yes he did say DING

DONG (because I asked him to).”

Actor and comedian Sanjeev Bhaskar shared a video of the “wonderful” Phillips on his own BBC show, The Kumars at No 42, in which the late star recalled how he once found himself stuck in the London Underground surrounded by members of the public demanding he do his catchphrases.

Bhaskar recalled him as “a truly warm, funny and gentle man”.

plummy accent

His wife Zara told the Sun: “I've lost a wonderful husband and the public has lost a truly great showman.

“He was quite simply a national treasure. People loved him. He was mobbed everywhere he went.”

Trainspotting writer Irvine Welsh posted his own tribute to Phillips, who he exchanged messages with online, saying he “always liked his pater”.

Broadcaster Piers Morgan said it was “sad news”, describing Phillips as a “wonderful character and superb comedy actor”.

Although he became known for his plummy accent and exaggerated portrayals of the English upper-class, Phillips was born in Tottenham, north London, speaking estuary English.

His hardscrabble upbringing instilled in him a lifelong appetite for hard work, which endeared him to casting agents and directors throughout his long career.

He attended Italia Conti Stage School before serving as a lieutenant in the Durham Light Infantry during World War Two - between 1942 and 1945, when he was invalidated out.

He then took elocution lessons to enable him to speak “proper” English, which in his early days was an essential part of any actor's equipment.

The 1930s had marked his first film appearances, but it was later in his career, in 1959 and 1960, when he starred in Carry On Nurse, Carry On Teacher and Carry On Constable.

He became well known for his appearances in the Doctor film franchise - succeeding Dirk Bogarde

in films like 1960's Doctor in Love - as well as in a series of fast-moving comedies that teamed him with Scots comedian and impressionist Stanley Baxter.

He also appeared in Brothers In Law, The Smallest Show On Earth and The Man Who Liked Funerals.

high living

But the show which cemented his status as a national institution was BBC Radio's The Navy Lark. Appearing alongside Ronnie Barker and Jon Pertwee, Phillips played as a hopeless lieutenant on HMS Troutbridge -between

1959 and 1977. It was never clear - deliberately so - whether he was a simpleton or a crook in this company of Royal Navy undesirables on the recommissioned frigate stationed off Portsmouth.

With the confidence that came from being told frequently he was a good-looking lad he developed a taste for fast cars, high living and beautiful women when the money rolled in. For a time he was the highest earning actor on the West End stage, and joined the so-called Ibiza crowd in the 70s, keeping a house there in a colony of artists and writers that included

his great friend Denholm Elliott.

He was married three times and had a long relationship (between the first and second marriages) with Caroline Mortimer, the daughter of Penelope Mortimer and step-daughter of Rumpole of the Bailey author John Mortimer.

In 1997 he received a lifetime achievement award from the Evening Standard, and 10 years later another from the Critics' Circle. In 1998 he was appointed OBE, and in 2008 CBE.

The actor suffered two strokes six months apart at the age of 90.

'Whisper list' contains 40 politicians never to accept a drink from, MP claims

■ Names of people known for 'bullying or sexual misconduct' are shared around Westminster, says Charlotte Nichols

A Labour MP has claimed there is a "whisper list" of roughly 40 politicians to keep at arm's length in Westminster – including two former cabinet ministers.

Charlotte Nichols, the MP for Warrington North, said she was warned of colleagues to never accept a drink from or be alone with. The list, which is not written down, includes people known for "bullying or sexual misconduct".

She said: "We need to be aware of these MPs from a range of political parties for our friends' sake who may visit parliament, for our staffers' sake and

of course for our own safety and professional reputation as well."

In order to stay safe, she admitted she would avoid them "as far as possible", even if it meant dodging trying to work with them.

'impunity'

Nichols said the list "is not 100%", as someone whom most people would deem "good and safe" had left her facing a harrowing ordeal.

"Everyone will know of a whisper network list of people to avoid in parliament. When I joined, I was sat down and told of people I should

never accept a drink from, never be alone with and avoid as far as possible to stay safe."

Speaking to BBC Radio 5 Live, Nichols, who was elected in 2019, said she would have the "perfect job" if it was not for abuse online and "the culture of toxicity" within Westminster itself.

She added: "We all know [who they are] and nothing is done and they continue to walk around and do their jobs – and there's that kind of culture of impunity on it."

Nichols did not identify any of these politicians, but said there were roughly 40 on the list,

Sunak to revive Bill of Rights in bid to curb rising migrant tide

Rishi Sunak is planning to revive a British Bill of Rights in a move to curb record numbers of migrants crossing the Channel.

Deputy Prime Minister and Justice Secretary Dominic Raab said this week that legislation giving UK courts supremacy over the European Court of Human Rights would

return "in the coming weeks".

Ministers previously said it would stop Strasbourg judges interfering in the Government's controversial policy to deport asylum seekers to Rwanda to have asylum claims processed.

But the Bill of rights was shelved by then Premier Liz Truss in

September, after she was warned it was "unlikely to progress in its current form".

However, Mr Raab, who championed the legislation before he was sacked by Ms Truss, said the Bill's return would "reinject a healthy dose of common sense" and "end abuse of our laws".

He added: "It will put an end to the mission

creep of continuously expanding human rights laws and re-establish proper democratic oversight from Parliament.

"It will make crystal clear that the UK Supreme Court is not subordinate to the European Court of Human Rights."

Cabinet Office Minister Oliver Dowden on Tuesday insisted Mr Sunak was "totally committed" to dealing with the migrant problem. He warned there was no easy

Top Tory quits amid bullying claims

IN AN early setback for Rishi Sunak, Sir Gavin Williamson quit his role as Cabinet Office minister this week following a flurry of bullying accusations.

The ex-Government enforcer said the allegations against him had become a "distraction" for the Prime Minister.

His resignation followed claims he told a

senior civil servant to "slit your throat" and to "jump out of the window".

No 10 is probing the claim while the Tory Party and the anti-bullying watchdog within Parliament

investigate accusations by ex-chief whip Wendy Morton that Sir Gavin sent her expletive-filled complaints over failing to obtain a ticket for Queen Elizabeth's funeral.

Pressure had mounted on the twice-fired minister without portfolio as his former deputy Anne Milton alleged he had used intimidatory and threatening tactics when chief whip.

The ex-MoD official who claims they were bullied by then defence secretary Sir Gavin has submitted a formal complaint to Parliament's

Independent Complaints and Grievance Scheme, according to Sky News.

In his resignation letter to the Prime Minister, Sir Gavin wrote: "As you know, there is an ongoing complaints process concerning text messages I sent to a colleague. I am complying with this process and have apologised to the recipient for those messages.

"Since then, there have been other allegations made about my past conduct. I refute the characterisation of these claims, but I recognise these are becoming a distraction for the good work this Government is doing.

"I have therefore decided to step back from government so that I can comply fully with the complaints process that is underway and clear my name of any wrongdoing.

"It is with real sadness that I tender my resignation, but I want to take this opportunity to offer my full and total support from the back benches. I am incredibly proud to have worked with you in Government over the last few years and during the campaign."

Before Sir Gavin quit last night, ex-MP Ms Milton told Channel 4 News her then boss was "unethical and immoral" in his reign as Tory chief whip and used "leverage" to instill fear in his colleagues.

She said the whips office once gave financial help to a Tory MP, adding: "I do remember [Sir Gavin] asking me to give the MP in question the cheque.

"He waved it under my nose and said, 'Make sure when you give him this cheque, he knows I now own him.' I don't think it was a joke. It was the seriousness with which he said it." She said she gave the MP the cheque – but not the message.

Victim's son claims Lucan 'alive and well and living as an Australian pensioner'

It has been nearly 50 years since the aristocrat Lord Lucan murdered his children's nanny, attacked his wife and then disappeared into the night, but his vanishing act is still one of the UK's biggest mysteries.

Now a leading computer scientist has told the Daily Mirror that an elderly man living in Brisbane, Australia is a definite match for the runaway murderer.

Professor Hassan Ugail's findings – which will send

the Dowager Countess of Lucan, who had recently filed for divorce and won custody of their three children.

shockwaves through the British establishment, – are the result of an artificial intelligence algorithm that ran 4,000 cross-checks of seven photos, four of Lucan and three of the mystery pensioner.

"According to the computer algorithm, based on thousands of experiments, these pictures belong to the same individual or someone who looks extremely like them – like identical twins," Professor Ugail said.

"This is science and mathematical fact. You can't cheat the algorithm," he added.

estranged wife

On 7 November 1974, Lucan – born Richard John Bingham – killed his family nanny Sandra Rivett with a lead pipe in the basement of his Belgravia home, according to the inquest into her death. It is believed he mistook her for his estranged wife, Veronica,

After bludgeoning Rivett he then found Lady Lucan and attacked her with the pipe, leaving her for dead in a pool of blood. He drove to a friend's house in East Sussex in a borrowed car, before vanishing in the early hours of 8 November. The car was later found abandoned in Newhaven with blood stains inside. Lady Lucan, who said she had long been abused by her husband, believes he threw himself from a cross-Channel ferry soon after the murder.

'this isn't emotion'

Lucan was a known gambler and struggling with massive debt issues. Evidently, their marriage was grimly unhappy.

In 2016, a High Court judge ruled Lucan to be dead, which has allowed for his son to adopt his father's title. However, the official death certificate does not mean the speculation has been laid to rest.

There have been numerous claims that Lucan is still alive, with reported sightings in places as far apart as Greece and Botswana and New Zealand.

Rivett's son, Neil Berriman, has spent years trying to establish the whereabouts of the man that an inquest jury concluded in 1975 was responsible for his mother's death. After becoming convinced an 87-year-old man who lives near Brisbane, Australia, is actually Lord Lucan, Berriman asked Professor Ugail to compare three pictures of the pensioner to four old pictures of the

vanished peer.

Following Ugail's findings, Berriman said: "I've spent nine years trying to prove this man is Lucan. Now, with this new scientific information, the police must act.

"This isn't emotion. It's fact."

The Daily Mirror printed a pixelated image of the man earlier this week, but was trumped shortly afterwards by the Daily Mail, who printed a complete image of the suspect – along with a competing analysis purporting to exonerate him.

It emerged that the rival

study involving detailed facial mapping techniques had been conducted by Dr Shelina Jilani of Home Office-approved Acumé Forensic, based in Leeds, which concluded there were sufficient differences to "eliminate" any chance the British expat was Lord Lucan.

Dr Jilani's findings were reported by MailOnline on Monday night.

The unpixelated version of the image revealed what appeared to be clear physical differences between the two men – including the size of their eyes, nose and the protrusion of their ears.

■ Royal couple narrowly avoid being splattered by anti-slavery protester

THE King and Queen narrowly missed being splattered with eggs hurled by an anti-slavery protester this week.

University graduate Patrick Thelwell, 23, was pulled to the ground and arrested after four eggs were thrown at Charles and Camilla in York.

The suspect, standing near to a "Not My King" banner, was heard booing and shouting: "This country was built on the blood of slaves."

People in the crowd shouted, "Shame on you" and "God save the King". Others gave three cheers for an apparently unperturbed Charles.

North Yorkshire Police said a man was arrested on suspicion of a public order offence and remained in custody.

Despite the security scare for the royals and their Scotland Yard bodyguards, the rest of their two-day visit to Yorkshire went as planned.

They took part in an ancient ceremony in which monarchs ask the Lord Mayor of York's permission to enter the city through Micklegate Bar, the most important of its four medieval gateways.

Charles, 73, and Camilla, 75, went on a walkabout, accompanied by Jason Tweedie-Long, five, who has nystagmus, a serious visual condition.

Jason, who had asked the city council to see the King, was given a press corps position by Buckingham Palace officials.

The King and Queen each took one of his hands as they walked together.

Spending squeeze scuppers plan for new royal yacht

PLANS to build a £250million successor to the Royal Yacht Britannia have been scrapped as part of a squeeze on government spending.

The national flagship plan was sunk by Rishi Sunak's administration as Whitehall braced for cuts in the November 17 autumn statement by Chancellor Jeremy Hunt.

The plan was championed by Boris Johnson when he was PM, but has faced criticism from MPs at a time when there are other priorities for defence spending.

Defence Secretary Ben Wallace told MPs he was prioritising the procurement of the multi-role ocean surveillance ship (MROSS) instead of the flagship.

He said: "In the face

of the Russian illegal and unprovoked invasion of Ukraine and Putin's reckless disregard of international arrangements designed to keep world order, it is right that we prioritize delivering capabilities which safeguard our national infrastructure."

That meant he had "also directed the termination of the national flagship competition with immediate effect to bring forward the first MROSS ship in its place".

The flagship had been expected to be constructed in the UK and take to the water in 2024 or 2025, and would have toured the world as a "floating embassy".

It is believed the two private consortia bidding for the work were told

that the project is being axed.

The Commons Defence Committee warned in 2021 that there was "no evidence of the advantage

to the Royal Navy of acquiring the national flagship".

It also said initial expenditure of around £250million, combined

with the £20-30million a year running costs and expense of providing a crew, would pile extra pressure on the senior service.

NHS nurses set to make history with first-ever strike

Nurses across the UK will stage mass walkouts within weeks after voting to take strike action over pay and working standards.

The strikes will affect more than half of hospitals and community teams nationwide, with nursing staff at 176 out of a total 311 NHS organizations backing walkouts after clearing a 50% turnout threshold required to hold ballots. The Royal College of Nurses (RCN) said the "strong and clear" result of the members' ballots – the first in favour of nationwide strikes in the union's 106-year

history – showed that "enough is enough".

Nurses will "no longer tolerate a financial knife-edge at home and a raw deal at work", said the union's general secretary, Pat Cullen. The RCN is seeking a 5% pay rise for its members above the Retail Price Index (RPI) inflation, currently at 12.6%. Cullen said the strikes were also aimed at raising healthcare standards that are "falling too low", adding: "This action will be as much for patients as it is for nurses."

The strike action is expected to begin next month and could last

until spring and affect hundreds of thousands of patients.

Another report, quoting a "senior health source", said the RCN "will commit to delivering a bank holiday, or Christmas Day, level of service" during walkouts, "with some chemotherapy, dialysis and planned surgery cancelled". Under a "life-preserving care model", nurses in A&E and in intensive care will be "exempt" from the strikes, the paper said.

Health Secretary Steve

Barclay described the vote result as "disappointing" and argued that the union's demands "simply aren't reasonable or affordable".

A senior hospital staff nurse told the BBC that

she felt she had "no choice" but to take strike action. Jodie Elliott said that her pay had "not kept up with inflation for ten years" and that low staffing levels meant "care is becoming unsafe".

Tributes flow for EastEnders star

EastEnders stars this week praised actor Bill Treacher, who has died aged 92.

Bill, who played Arthur Fowler until 1996 and was one of the BBC soap's original cast members, died on Saturday night.

Bill, who lived in

Suffolk, leaves a wife, Australian actress Katherine Kessey, 76, and their children Jamie and Sophie.

His family called him "a brilliant actor and a wonderful husband and father, plus a very fine human being".

It wasn't all bad...

A 12-year-old boy who arrived in Scotland as a refugee from the war in Ukraine has been signed by Dundee United FC's academy.

Stanislav Drabych was enrolled in a school that offered specialist training at home in Lviv. Following the Russian invasion, he worried that his footballing dreams were over. But in March,

he and his family were taken in by an aunt in Angus, where his talent was quickly spotted by his new school, and he was put forward for a trial.

"It's like Christmas Day, I can play again," he told the BBC. "If we stay in Scotland I'll play for Dundee United – because they helped me, I'll help them to win the Scottish league."

Duran Duran star Andy Taylor battling terminal cancer

DURAN Duran star Andy Taylor is battling terminal cancer, heartbroken bandmate Simon Le Bon has revealed.

The news emerged on what became a bittersweet night, as the Brummie band were inducted into America's Rock & Roll Hall of Fame.

Guitarist Andy, 61, had hoped to fly to Los Angeles from his home in Ibiza to join the group on Saturday but doctors warned him not to.

Frontman Simon, flanked by other bandmates John Taylor, Nick Rhodes and Roger Taylor, told the audience that Andy's absence was

due to the prostate cancer he had suffered for four years.

The pals then read extracts from a letter from Andy, now a dad of four and grandad.

He wrote: "Just over four years ago I was diagnosed with stage 4 metastatic prostate cancer. Many families have experienced the slow burn of this disease and of course we are no different. Although my current condition is not immediately life-threatening, there is no cure. I was doing OK after some very sophisticated life-extending treatment – that was until a week or so ago when I suffered a setback.

"None of this should detract from what this band (with or without me) has achieved and sustained for 44 years. You can dream about what happened to us, but to experience it, on one's own terms, as mates, was beyond incredible.

"I'm sure as hell glad I'm around to see the day."

Backstage, Simon, 64, said: "It is absolutely devastating news to find out that a colleague, a mate, a friend, one of our family, is not going to be around for very long.

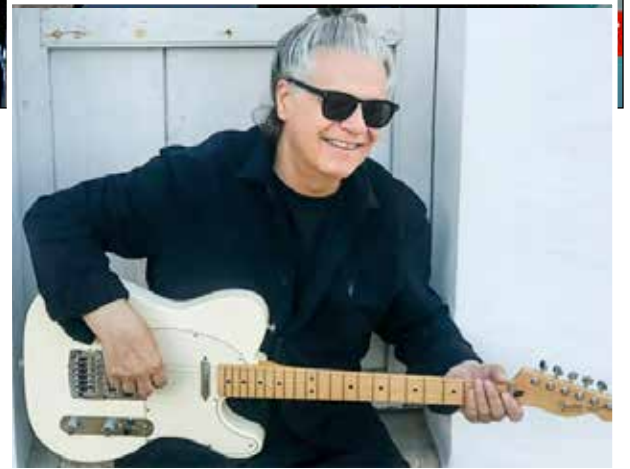
"We love Andy dearly and I'm not going to stand here and cry – I think that would be inappropriate. But that's what I feel like."

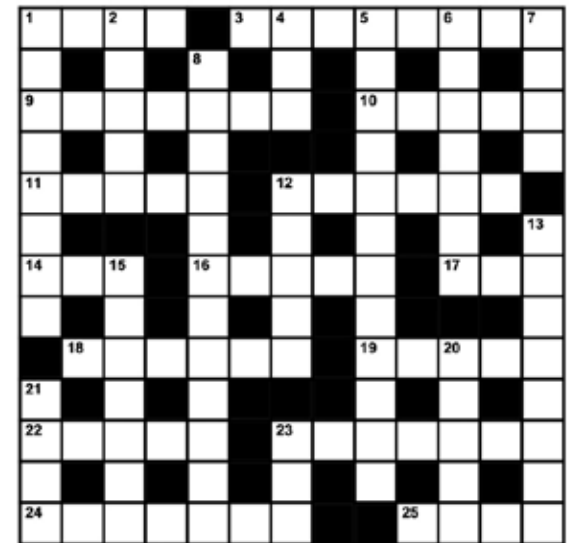

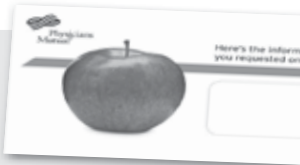

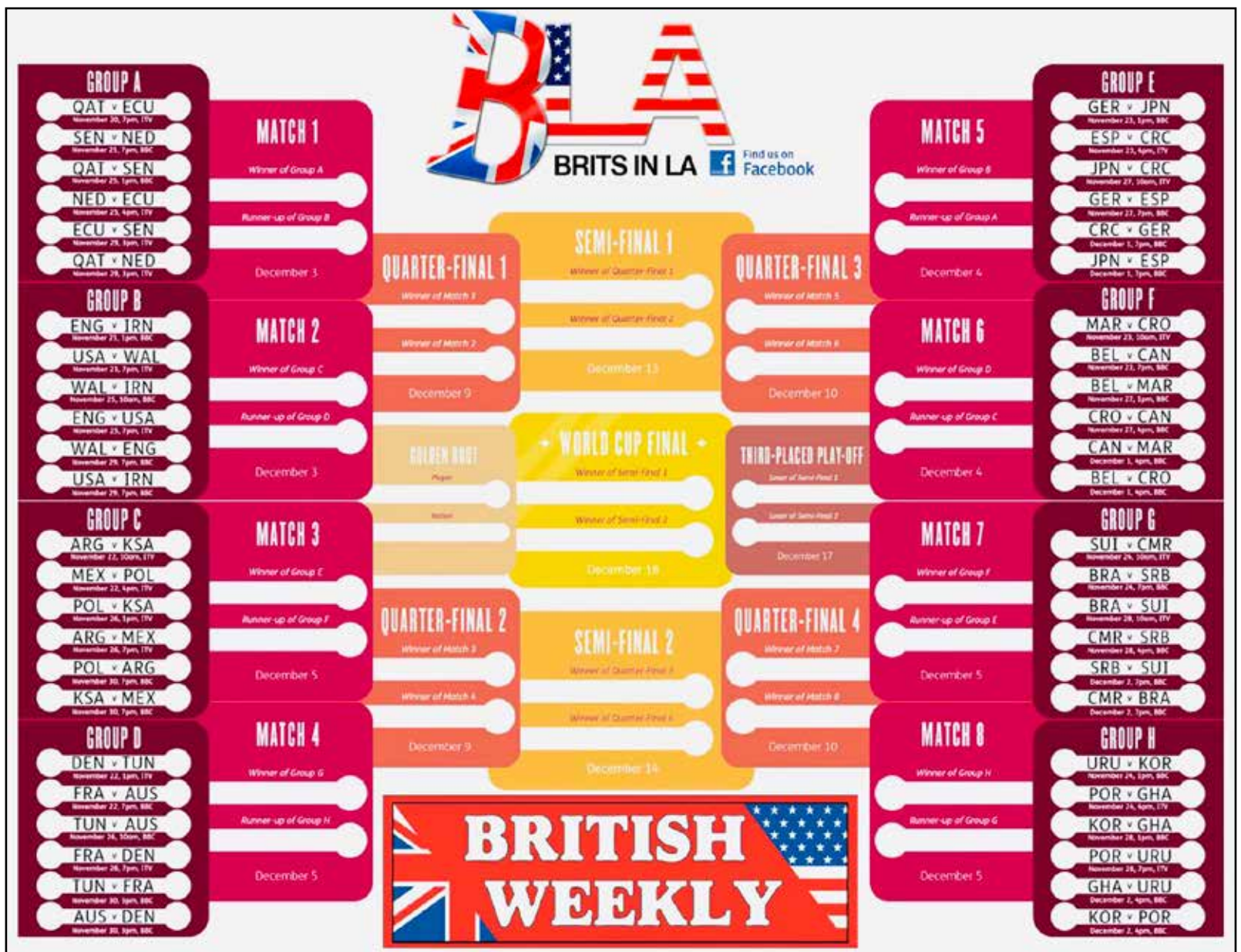

Liverpool manager Jürgen Klopp says he is committed to the club no matter what happens with the current ownership.

Fenway Sports Group (FSG) have said they are looking for new investment but some reports claim they are willing to sell Liverpool in its entirety.

The move has sparked concern among some Liverpool fans worried about potential upheaval at Anfield, with questions over Klopp's future.

Speaking for the first time since the stories about FSG emerged on Monday, Klopp said he was going nowhere and the news had not impacted his plans for that third-round tie against the League One side.

What I read is that they are looking for investment," he said. "Good idea, I like that.

"But it didn't distract preparation at all. The

players didn't ask me and, for me, it means nothing.

"I have a great relationship with FSG. I really like how it works but if it does change, I am committed to the club and that is nothing to do with the people here."

Klopp said any comparison with Chelsea, whose new ownership also triggered massive changes behind the scenes and, eventually, the dismissal of manager Thomas Tuchel, are invalid.

"The situation is completely different," he said. "Chelsea had to get sold because the owner was in trouble and there was urgency in the situation. We don't have that here at all.

"It is important whilst this process is happening we just keep going and planning.

"These things take time and in that time we have to keep going. I will make sure that will be the case."

Keep your nose clean, United boss warns Garnacho after dazzling cameo sees off Villa

Manchester United manager Erik ten Hag has warned Alejandro Garnacho he needs to make sure his attitude and lifestyle are right if he wants to make a sustained impact at Old Trafford.

The 18-year-old substitute produced an outstanding half-hour cameo Thursday night to help United beat Aston Villa in the Carabao Cup and book a home fourth-round tie with Burnley next month.

Villa led twice through Ollie Watkins and a Diogo Dalot own goal in a thrilling second half that followed a desperate first.

But they had no answer to Garnacho's direct running as the Argentina wide-man became the youngest United player to claim two assists in a game as he created goals for Bruno Fernandes and then Scott McTominay, with a brilliant long pass into the heart of the visitors' box.

That positive contribution is in stark contrast to his experience on United's pre-season tour of Thailand and Australia, when he was prevented from playing in matches as a disciplinary measure after twice turning up late for team meetings.

And, while Ten Hag praised Garnacho for his performance against

Villa, the Dutchman's words came with a clear warning.

"It depends on his approach, on his attitude," said Ten Hag. "If he keeps his attitude and wants to improve every day and when he is doing the right things in his lifestyle, it is possible.

"You can see he has capabilities and can contribute to attacking football. Also he has something, he can break open a compact defending line.

"All teams that want to attack, that want to play in opponents' half, they need players like that. He can outplay them and also in the final decisions he can do the right things."

The difference between the first half and the second could not have been more pronounced.

While the highlights of a tepid opening period were a needless yellow card for a clumsy tackle by Harry Maguire on Ollie Watkins and two speculative set-pieces by Douglas Luiz and Fernandes, the action after the break was electric.

It took Villa just three minutes to take the lead as Watkins finished superbly past Martin Dubravka after being sent clear by Jacob Ramsey.

The smoke from a flare set off in celebration of Villa's opener had not

even begun to clear by the time Fernandes crossed for Anthony Martial to equalise a minute later.

When Dalot turned Leon Bailey's header into his own net, new Villa boss Unai Emery must have thought he was going to start his reign with successive victories.

He reckoned without Garnacho. The youngster was involved in the equaliser as Ashley Young stretched to prevent him getting to the ball and

inadvertently set up Rashford, who steadied himself before applying a fine finish.

The best was yet to come, though.

Maddison earns World Cup squad place

Leicester midfielder James Maddison has been included in England's 26-man squad for the Fifa World Cup in Qatar, which was announced on Thursday.

Manager Gareth Southgate has also picked Manchester United forward Marcus Rashford and Newcastle striker Callum Wilson, Manchester City full-back Kyle Walker and Arsenal defender Ben White.

Speaking to the media after his announcement, Southgate praised Leicester star Maddison and said he had "earned the right" for a seat on the plane to Qatar. "He's playing really well – he's a good player, we've always said that," said the Three Lions boss. "He can give us something slightly different to the other attacking players we've got. He is playing as well as any of the attacking players in this country."

Twenty-one players out of the 26 were also selected in the squad that reached the final of the European Championship last year.

But AC Milan centre-back Fikayo Tomori, Brentford striker Ivan Toney and West Ham forward Jarrod Bowen miss out.

England face Iran in their World Cup opener on 21 November (13:00 GMT).

They are joined in

Group B by Wales and the United States.

Manchester City midfielder Calvin Phillips, despite only recently returning from two months out with a shoulder problem, is also included, as is centre-back Harry Maguire, who has struggled to get a game for Manchester United this season.

However, Maguire's club team-mate Jadon Sancho has not made the squad.

T20 World Cup: England beat India to storm into World Cup final

CRICKET: England stormed into the Men's T20 World Cup final with a sensational 10-wicket demolition of India at the Adelaide Oval on Thursday.

Openers Jos Buttler and Alex Hales overcame a feverish India-supporting atmosphere and chased 169 without the loss of a wicket.

They romped home with a massive 24 balls to spare to set up a final against Pakistan on Sunday and seal one of England's greatest

white-ball wins.

Hales ended 86 not out from 47 and Buttler unbeaten on 80 from 49, the England skipper clinching the match with the pair's 10th six.

Earlier, despite 50 from Virat Kohli, England's bowlers restricted India well until Hardik Pandya's 63 from 33 balls powered his side to what had looked a testing score.

But Hales, recalled after more than three years in the international wilderness, gave England a rapid start

and Buttler continued the onslaught.

Their stand of 170 is a record in a men's T20 World Cup, beating the 168 shared by South Africa's Quinton de Kock and Rilee Rossouw in their Super 12 game against Bangladesh last month.

It denies the tournament what would have been a mouth-watering India-Pakistan finale, instead ensuring a repeat of the famous 1992 50-over World Cup final at the Melbourne Cricket Ground (MCG).
