# Harry & Meghan: Sweet AND Salty?

'Explosive' Netflix docuseries airs with more of a whimper than a bang
Couple showcase their early lives and the first days of their courtship
But the British press get a roasting as Harry relives trauma of Diana's death

NETFLIX's much-heralded docuseries Harry & Meghan debuted this week, making no bones about who they view as the real enemy – and it's NOT the royal family.

After weeks of feverish speculation in the British press about which juicy bombshells the controvesial royal couple would detonate and who in the royal family would be cast as public enemy number one, the villains of the piece turned out to be....the beastly British press.

Three episodes of the highly anticipated - and feared - show dropped this week, and the were a perfect blend of saccharine and acid. The former in the retelling of their 'fairytale' romance, and the latter in their description of London's newspaper publishers, whom the couple accuse of hounding them, especially Meghan, out of remorseless greed and scarcely concealed racism. The rovals are essentially treated with

kid gloves – at least thus far – with their worst sins being a failure to grasp why Meghan should be protected from press harassment.

Prince Harry said some members of the family felt negative treatment in the media was "a rite of passage" - but he added: "The difference is the race element."

## 'rite of passage'

Buckingham Palace has not yet responded to the claims.

At the start of episode one, a message says members of the Royal Family declined to comment on "the content within this series".

The episodes released on Thursday - which include sit-down interviews with the couple and their friends, as well as a video diary - cover a range of topics, including the couple's difficult relationship with the tabloid press, and the Royal Family's response to 'racist' news articles written about Meghan.

"The direction from the Palace was don't say anything," says Harry. "But what people need to understand is, as far as a lot of the family were concerned, everything that she was being put through, they had been put through as well.

"So it was almost like a rite of passage, and some of the members of the family were like 'my wife had to go through that, so why should your girlfriend be treated any differently? Why should you get special treatment? Why should she be protected?"

"I said 'the difference here is the race element'."

He says there is a "huge level of unconscious bias" in the Royal Family, adding: "It is actually no one's fault. But once it has been pointed out, or identified within yourself you then need to make it right."

The Duke of Sussex who is fifth in line to the throne - says he is really proud that his children are mixed race, and it makes him want to "make the world a better place for them". "But, equally, what's most important for the two of us is to make sure that we don't repeat the same mistakes that perhaps our parents made."

## 'a great love story'

The couple also spoke about meeting other royals, with Meghan saying she found it surprising that the formality "carries over" even when not in public. She says: "When Will and Kate came over, and I met her for the first time, they came over for dinner, I remember I was in ripped jeans and I was barefoot. I was a hugger. I've always been a hugger, I didn't realise that that is really jarring for a lot of Brits.

AS the first episodes of the long-awaited Harry & Meghan docuseries dropped this week, much of the British establishment held its collective breath. But at first glance, the real targets of the show seem to be the British media, rather than the royal family. Predictably, they were not amused.

Those expecting one bombshell salacious after another in the first episode were mostly left underwhelmed. In what could be better described as Harry & Meghan: The Early Years, the celebrity couple delivered what was essentially a love letter....to themselves. They present themselves as under siege, facing prejudice and threats, at war with the media. And as such it's a view looking inwards rather than outwards, with a supporting chorus of friends and experts.

The British tabloids saw it differently, of course, immediately spinning a narrative that the show was part of a 'war on the monarchy'. The Express blared the headline 'So Hurtful! Royals Deeply Upset by Harry's Slurs'

In much of episode one, the duke and duchess spoke about their relationship - including how they met via a friend on Instagram and met for drinks in London's Soho for their first date.

Harry describes it as a "great love story", adding: "I think for so many people in the family, especially obviously the men, there can be a temptation or an urge to marry someone who would fit in the mould, as opposed to somebody who you are perhaps destined to be with.

"The difference between making decisions with your head, or your heart. And my mum certainly made most of her decisions if not all of them - from her heart. And I am my mother's son."

He adds: "She sacrificed (Meghan) everything she ever knew, the freedom that she had, to join me in my world.

Prince Harry tells the docuseries: "My job is to keep my family safe. But the nature of being born into this position... and the level of hate that is being stirred up in the last three years especially against my wife and my son, I'm generally concerned for the safety of my family."

The duke adds that, as a royal, it is his "duty to uncover this exploitation and bribery that happens within our media".

Meghan, meanwhile, says she felt that "no matter how hard I tried, no matter how good I was, no matter what I did, they [the media] were still going to find a way to destroy me".

In other moments from the series: Harry calls the press pack of roval correspondents "essentially an extended PR arm of the Royal Family. An agreement that has been there for over 30 years". He says he believes the media see his trauma as its "narrative to control" In

episode three, constant media intrusion, and given his history, few will blame him. The next episodes promise to be a delicious watch...

Meghan calls the time around their engagement an "orchestrated reality show"

Harry says his family were "incredibly impressed" with Meghan when they first met her. "But the fact that I was dating an American actress was probably what clouded their judgment more than anything else at the beginning"

The duke compares Meghan to Princess Diana, saying: "So much of what Meghan is, and how she is, is so similar to my mum. She has the same compassion, she has the same empathy, she has the same confidence, she has this warmth about her".

And although Princess Diana's Panorama interview was secured under deceit, Harry says his mother "spoke the truth of her experience"

The duchess's mother, Doria Ragland, says she warned Meghan that the harassment was "about race".

"I said, you may not want to hear it but this is what's coming down the pike," says Ms Ragland.



# **Justice at last for Harry Dunn**

Anne Sacoolas handed eight month suspended sentence for her role in death of British teenager

A US citizen responsible for the death of teenage motorcyclist Harry Dunn has been sentenced to eight months in prison, suspended for a year.

Anne Sacoolas was driving on the wrong side of the road when she hit the 19-year-old outside a US military base in Northamptonshire in 2019.

The case led to a transatlantic row between the US and UK governments.

Charlotte Charles said of the family's three-year wait for justice "we didn't back down because we have values".

Mrs Charles, Harry's mother, added that her "promise" to get justice for her son through the UK courts was "well and truly complete".

Following the crash, Sacoolas had diplomatic immunity asserted on her behalf by the US administration and left the country 19 days later. She never returned to the UK.

Sacoolas, who admitted earlier this year to causing

death by careless driving, appeared at London's Old Bailey via video-link after her employer, the US government, advised her not to travel to the UK to attend in person.

Mrs Charles said the 45-year-old's failure to attend was "despicable", adding she was "absolutely disgusted" at the actions of the US.

Mr Dunn's father, Tim Dunn, said: "It's been such a relentless time, we as a family fought off everything we can to get to this point."

Mrs Charles added: "Anne Sacoolas has a criminal record for the rest of her life.

"That was something she never thought she'd see, something the US government never thought they'd see.

"Harry we done it. We're good, we're good."

Mrs Charles also spoke about being unable to say goodbye to her son because he was too injured by the time she reached the hospital.

"I couldn't comfort him

at all. I couldn't let him know that I was there. So for me, the next best thing was to kiss that bruised lip of his and just let him know that I would fight for justice," she told Sky News.

She said the family was no longer interested in meeting Sacoolas, adding: "The time for any contact, for any remorse, is long gone."

In her sentencing remarks, which were broadcast live, Judge Mrs Justice Cheema-Grubb said: "There is no doubt that the calm and dignified persistence of these parents and the family of that young man has led, through three years of heartbreak and effort, to your appearance before the court and the opportunity for you to acknowledge your guilt of a crime."


An immediate jail sentence would have needed Sacoolas to surrender to the court, so the judge's only real option was a suspended sentence.

## The last surviving Dambuster, 'Johnny' Johnson, dies aged 101

■ Johnson was a bomb-aimer in squadron that destroyed German dams during second world war

The last survivor of the Dambuster bouncing bomb raids of 1943 has died at the age of 101.

Leonard George "Johnny" Johnson was a bomb-aimer in the 617 squadron which destroyed vital dams in Germany's industrial Ruhr valley during the second world war.

His family said Johnson died peacefully in his sleep on Wednesday, according to BBC News. Les Munro, the last

Dambuster surviving pilot, died at the age of 96 in 2015. His death left only Canadian frontgunner Fred Sutherland and Johnson. Sutherland died in 2019 at the age of 95.

After his 100th birthday last year, Johnson told the BBC: "I've had a very lucky life in every respect." Speaking of the famous Dambuster raids, he said: "It was an exhilarating experience ... [I felt] honoured to

have had the chance to take part."

The bouncing bomb raids caused catastrophic flooding in the Ruhr valley, destroying hydroelectric power stations and factories. About 1,300 people on the ground are thought to have been killed, according to the Imperial War Museum.

Of the 133 crew members who took part, 53 were killed in the raids and three were captured.

Johnson, who was born in Lincolnshire and lived in Bristol, was 21 at the time. He went on to become a squadron leader in the

RAF and retired from the force in 1962 to become a teacher in Torquay. He also represented the Conservative party as a

local councillor.

A campaign to get Johnson knighted ended in failure, but he was awarded a CBE in 2017.

# **Stranglers drummer** Jet Black dies at 84

Jet Black, the original drummer for 1970s punks The Stranglers, has died aged 84, the band confirmed on Thursday.

The musician, who was born Brian Duffy, was a founding member of the Guildford group, playing on hits Golden Brown, Peaches and No More Heroes.

He last performed with them in 2015, announcing his retirement a few years later due to ill health.

In а statement online. his exbandmates described him as an "elder statesman" of British "elder music.

and Bassist COfrontman JJ Burnel said: "After years of ill health, Jet has finally been released. He was a force of nature. An inspiration. "The Stranglers

would not have been if it wasn't for him. The most erudite of men. A rebel with many causes."

Sil Willcox, the band's manager, added: "Jet Black was the real deal. Astute in business, a talented drummer and an

obsessive perfectionist.

"I will cherish the times we planned, pranked, ate, drank and laughed on so many great nights together."

The Stranglers formed in west Surrey in 1974 and went on to became an integral part of the riotous UK punk and new wave scenes.

Despite the indolent, youthful rage associated with the genre, Black - a semi-professional drummer in the late 1950s and early 1960s - was in fact by then a successful businessman in his mid-30s.

He owned a fleet of

ice cream vans and later an off-licence called The Jackpot. In the early days, the Stranglers used one of the vans as a tour bus and his shop as their headquarters.

Black wrote several books chronicling his time in the band - most notably The Stranglers' infamous 1980 arrest in Nice, France, where they had allegedly incited a riot.

An enthusiastic furniture designer, he also patented the Jet Black Power Bass Drum Pedal.

When asked how he would like be

remembered by the band's website 12 years ago, Black replied: "I guess if we are actually remembered, then that will do."

In a statement, his representative confirmed the musician had passed 'peacefully' away on



## **Meet A Member: Paul Rogan**

Meet Paul Rogan from London who moved to LA 15 years ago to pursue acting.

## Was there a particular reason you chose LA?

For an actor of course Los Angeles is the dream. In England I was an actor, stand-up comedian, improviser. and voiceover performer. I've found that people in the entertainment industries here are surprisingly easy going and approachable, and you can get opportunities here that don't exist in England. I booked TV and commercial work here within a short time of arriving. Here, they love our Englishness, and they assume we all trained at RADA!

Of course the sun, sea and space don't hurt - my wife, who is American, would happily have gone back to Chicago, but the first time I visited Chicago it was in a winter, and stepping out the airport was the coldest I'd even been. It felt like I was being assaulted by the White Walkers from Game of Thrones.

## What do you miss most from home?

I miss family and friends, obviously, but it is so much easier these days to stay in touch. I know Brits here who came out in the 50s and 60's, and it must have felt so much more cut off from 'home'. I can see my family, and read the English newspapers for free every day, even if I have no idea who the 'celebrities' are that the Daily Mail is shocked about. Being able to watch English football on TV was a huge surprise and relief. Now when I'm in England and the game isn't on at 7 in the morning, I'm thrown.

## What was your first impression of LA and

has it changed since? We stayed with friends, so I saw aspects of LA that locals see. If you just came as a tourist and saw only The Chinese Theatre and Hollywood Boulevard etc. you might think it tacky and nothing special. But there is a magic here. I remember the first time we drove along Sunset Boulevard where it transitions from West Hollywood to Beverly Hills, and it was stunning. My view hasn't changed: I still love the Hollywood sign, and a sunset at Malibu.

## What do you find the biggest difference is living here versus London?

What it all looks like the light, the low-rise main streets, the everchanging nature of it. In London the houses are all terraced and therefore won't change much. Here, houses have their own lot and our Valley neighborhood is constantly changing as houses get rebuilt.

Do you have a hidden gem in LA that you want to share with us? Coffee at Aroma on Tujunga, The Ojai Valley Inn; Paradise Cove, tacos at Brentwood Country Mart. None of these are particularly hidden of course but not all Brits may know them yet.


## What would you suggest to others who are thinking about making the move here?

You've got one life. Do it! You can always go home again!

One of my great passions is improvised comedy, which I did a lot in England, guesting with the Comedy Store Players etc. When I got here I joined Impro Theatre, a company that improvise comedy plays, and I created a show (long before Austentatious in

## Ultra-aggressive style pays off again as England win thrilling First Test in Rawalpindi

First Test, Rawalpindi (day five of five). England won by 74 runs England 657 (Brook 153, Crawley 122, Pope 108, Duckett 107) & 264-7 dec (Brook 87)

Pakistan 579 (Babar 136, Imam 121, Shafique 114, Jacks 6-161) & 268 (Anderson 4-36, Robinson 4-50)

CRICKET: England pulled off one of their greatest-ever Test cricket victories this week with a 74-run win over Pakistan in the first Test in Rawalpindi this week.

With the sun dropping at the end of a tensionfilled final day on Tuesday, England took the last wicket with only minutes of light remaining to secure a victory that will live long in the memory.

In scenes reminiscent of England's famous win in the dark in Karachi in 2000, Jack Leach trapped Naseem Shah lbw to leave Pakistan 268 all out, 75 short of their target of 343.

That England were in a position to win was thanks to James Anderson and Ollie Robinson, who gave a masterful exhibition of reverse-swing bowling to claim four wickets each in the hosts's second innings.

But Pakistan were defiant throughout. Saud Shakeel made 76, Mohammad Rizwan 46 and Azhar Ali 40. At 176-3 and 259-5, the home side were right in the hunt.

But after Robinson removed Salman Agha and Azhar, England could only be defeated by the fading light.

With the stadium nearly full and the crowd engrossed, 40-year-old Anderson snared Zahid Mahmood and Haris Rauf in the same over.

Naseem and Mohammad Ali survived for 52 balls, before Leach sent England into wild celebrations.

There was only a threeday gap to the second Test in Multan, which began on Friday, when England have the chance to secure the series.

The drama of victory being secured late on the fifth day was entirely in keeping with the extraordinary action of the previous four days.

England plundered an astounding 921 runs over two innings in 136.5 overs at a scoring rate of 6.73, the fastest of any team batting twice in Test history. The 506-4 runs they racked up on day one is a Test record.

Stokes' bold Ben declaration at tea on Sunday engineered a contest that had all four results possible going into the final session of the match.

With darkness creeping in, England looked to have missed their chance when Naseem's edge off Stokes sailed between wicketkeeper Ollie Pope and first slip Joe Root, only for Leach to provide the decisive intervention.

It ended a run of 11 away Tests without victory and secured a first win over Pakistan outside the UK for 22 years with an entire XI that had never played a Test in Pakistan before.

All this after the England squad was badly affected on the eve of the match by a virus that raised the prospect of the Test being delayed by a dav.

They had a stand-in wicketkeeper in Pope and an attack relying heavily on three part-time spinners, from which Liam Livingstone did not bowl because of a knee injury and will return home.

Above all, this is the finest win of England's era under Stokes new Brendon and coach

## We're just getting started, says Trescothick

England are "just getting started" with their thrilling results and performances, according to assistant coach Marcus Trescothick.

"It is the exciting part," he said. "If it continues on in this form then it bodes for a great series.

"We do not look too far ahead in what is going on but it is exciting because Ashes series are the pinnacle of what we do in Test cricket."

"Walker and Mbappe are two very great players. Walker is one of the best right-backs in the world, I can't wait to see this battle."

Walker is familiar with Mbappe, having come up against the Paris St-Germain forward with Manchester City in the previous two Champions League campaigns.

City won two and lost one of the three meetings in which both players featured - and Mbappe has admitted he found facing Walker challenging.

On the Frenchman's comments, Walker said: "That's nice to hear because he had a tough game against me. I know
