# 30 YEAR TERM FOR MONSTER OF THE MET

David Carrick used his position to take “monstrous advantage of women” during a 17-year spree of brutal sexual offending

Rapist police officer David Carrick acted like he was “untouchable”, a judge said this week as she told him he will spend at least 30 years behind bars.

Mrs Justice Cheema-Grubb praised the bravery of 12 women who brought down one of Britain’s worst sex offenders.

Carrick – who was given 36 life terms – used his job to take “monstrous advantage of women” during a 17-year spree of brutal sexual offending.

The judge said the former firearms officer was guilty of an “astonishing degree of moral corruption” warning that the “malign influence of men like you in positions of power stands in the way of a revolution of women’s dignity”.

Carrick told one of his victims he was the “safest person” she could be with before raping her at gunpoint.

But the sentence is already being challenged with at least seven referrals under the Unduly Lenient Sentence scheme.

Sir Mark Rowley,

Britain’s most senior police officer, apologized and admitted the Metropolitan Police had let women down.

Carrick held a gun to one of his victim’s head, locked another victim in a tiny cupboard, “whistling at her as if she was a dog” and sent traumatised victims pictures of him holding a police-issued gun, saying: “Remember, I am the boss.”

### ‘abusing the trust’

Mrs Justice Cheema-Grubb told Carrick: “These women are not weak or ineffectual. They were victims of your criminal mindset.”

“It is remarkable that with one woman being driven to report an allegation against you, despite your position and power, others felt able to act.

“Even today, courage calls to courage everywhere and its voice

cannot be denied.”

The judge told him his crimes were aggravated by the “use and abuse” of his role and said he “reassured, tricked or intimidated” his victims, “abusing the trust that the public vest in police officers”.

She continued: “These convictions represent a spectacular downfall for a man charged with upholding the law and empowered to do so even to the extent of being authorised to bear a firearm in the execution of your duty.

“Behind a public appearance of propriety and trustworthiness you took monstrous advantage of women.

“You brazenly raped and sexually assaulted a number of women, some very brutally and you behaved as if you were untouchable.

“You were bold and at times relentless, trusting

that no victim would overcome her shame and fear to report you.

# Cocaine addict former MP jailed for four years for expenses fraud

**“You knew perfectly what you were doing with this fraud, you were behaving perfectly rationally, if dishonestly,” judge tells Jared O’Mara**

The former Labour MP Jared O’Mara has been sentenced to four years in prison after abusing his elected position to make fraudulent expense claims to fund his cocaine and alcohol habits.

Described by his own barrister as an “inadequate individual” who could not cope with the strains of public life, O’Mara was convicted of six counts of fraud after trying to claim about £52,000 of taxpayers’ money for work that was never done and jobs that did not exist.

The 41-year-old, who represented the Sheffield Hallam constituency from 2017 to 2019, went on trial for submitting “dishonest” invoices to the Independent Parliamentary Standards Authority (Ipsa) between June and August 2019.

Sentencing him at Leeds crown court on Thursday, the judge, Tom Bayliss KC, said O’Mara’s autism did not reduce his culpability.

“You knew perfectly what you were doing with this fraud, you were behaving perfectly rationally, if dishonestly, and you were using your autism diagnosis to extract

money from Ipsa to fund your cocaine and alcohol driven lifestyle. It was deliberate, it was cynical and it was dishonest.”

Leeds Crown Court heard he made four claims for a total of £19,400 from a “fictitious” organisation called Confident About Autism South Yorkshire, which jurors were told referred to his friend, John Woodliff.

O’Mara also submitted a false contract of employment for Woodliff, saying he worked as a constituency support officer.

The ex-MP was found not guilty of two fraud charges over invoices from another friend, Gareth Arnold, for media and PR work that prosecutors had claimed was never carried out.

But he was convicted of an offence of fraud after emailing Ipsa in February 2020, falsely claiming a police investigation into him had concluded and he was entitled to be paid the two invoices relating to Arnold, which totalled £4,650.

Arnold, who became O’Mara’s chief of staff in June 2019, was found guilty of three fraud

charges, and cleared of three.

Woodliff was found not guilty of one offence of fraud. During the trial, the court was told that Ipsa did not pay any of the claims due to a lack of evidence the work

Opening the case just over two weeks ago, prosecutor James Bourne-Arton told the jury: “O’Mara viewed Ipsa, and the taxpayers’ money that they administered, as a source of income that was his to claim and use as he wished, not least in the enjoyment of his extensive cocaine habit.”

The court heard Arnold went to South Yorkshire Police in July 2019 after “reaching a point at which he was no longer willing to participate in the fraud”.

Leeds crown court had heard lurid details of O’Mara taking up to five grams a day of cocaine and drinking a litre of vodka as he struggled to cope with his job as an MP and the resulting media scrutiny.

Sentencing him on Thursday, Judge Tom Bayliss KC said the fraud was spurred on by O’Mara’s financial

difficulties.

“Those difficulties were caused by a hedonistic and self-indulgent lifestyle, fuelled by your consumption of large amounts of vodka and, of course, co He said O’Mara “did not give one iota about his constituents”.

“You blatantly abused

your position as a Member of Parliament to commit these frauds.”

O’Mara was catapulted into the spotlight at the 2017 General Election when he defeated former Lib Dem leader Sir Nick Clegg.

However, within three months of entering

Parliament he had been suspended by Labour over historic misogynistic, homophobic and racist comments posted online.

Allegations of sexual harassment followed, and O’Mara ultimately quit the Labour Party and finally resigned as an MP in 2019.

## Pupils stunned as murder-suicide takes life of top school principal

**PUPILS at one of Britain’s top private schools were left in shock this week after their head teacher and fellow pupil were shot dead.**

Epsom College principal Emma Pattison and her daughter Lettie were found dead of gunshot wounds along with Emma’s husband George, in what is being investigated as a murder-suicide.

Police have revealed that Ms Pattison called her sister Deborah Kirk in a panic minutes before her death. Relatives raced to her aid but they arrived too late and discovered her body and those of her daughter and husband.

Officers fear Mr Pattison shot his wife and seven-year-old child in the early hours of Sunday morning before turning the gun on himself.

Surrey Police said: “Officers are confident

there is no third-party involvement. A firearm was found at the scene [but] causes of death will not be confirmed until post-mortems have been completed.”

Officers confirmed they recovered a gun licensed and registered to Mr Pattison from the grace and favour cottage.

And they revealed that just days before he had informed police of a change of address, as per the terms of his firearms licence.

The details emerged as tributes continued to be paid to Mrs Pattison, 45, the first female head of Epsom College in 250 years.

Mr Pattison, 39, a management consultant, is believed to have held a firearms licence for a number of years.

He is not believed to have had previous contact with the police other than an incident in

2016 when it is claimed he reported Mrs Pattison for allegedly hitting him.

She was spoken to by officers but the complaint was withdrawn and no further action taken.

The horrific shooting and the suggestion of past friction with his wife are set to raise fresh questions about effective background checks into gun licence holders after recent high-profile incidents.

A former firearms officer, who wanted to remain anonymous, said: “Surrey Police are likely to come in for heavy criticism.

“Pattison had his licence renewed and within days he appears to have shot his family dead.

“What we need to know is whether the necessary and thorough background and mental health checks were carried out.”

## Cornish Pasty wars getting tasty...

PIE wars are heating up again in Cornwall after Greggs was accused of invading the county.

The Newcastle-based bakery has long struggled to establish itself in the home of the pasty with past bids abandoned due to local opposition.

But after opening up in county town Truro in December, some residents fear the business feels emboldened to spread further into the region.

Planning consent is being sought for an Esso filling station on the A30 at Altarnun near Bodmin Moor.

And a further store looks set to open at a new service station in Newquay after an advertising hoarding appeared there.

Once both sites are open it would bring the number in Cornwall to five.

The bakery chain opened its first store in the county in 2019 in Saltash, close to the Devon border. But it closed after just nine months because it didn't win enough customers.

Before the Truro outlet, it launched two shops in Cornwall but these are tucked away at Pennygillam Industrial Estate on the outskirts of Launceston and at Cornwall Services by the A30.

But locals said they never believed Greggs would try to open one in the "heart of the county" at Truro.

One resident described it as "the devil's spawn" while another said any new stores in Cornwall "won't last".

A third added: "There is no way we would ever eat that rubbish when you have vast amounts of places selling the real thing, the iconic Cornish pasty."

# Paedophile jailed for 36 years for killing an immigrant mum and her two-year-old

■ Dundee man lured petite Filipina to his house before killing her and raping her child

A PAEDOPHILE has been jailed for 36 years for killing a mum and her two-year-old.

Andrew Innes, 52, lured Bennylyn Burke, 25, and daughter Jellica to his house after meeting the mum on a dating website.

He battered 4ft 6in Bennylyn around the head with a hammer and stabbed her with a Samurai sword.

Days later he smothered her daughter after abusing her.

Innes put their bodies in rubble bags and concealed them in concrete beneath the kitchen floor.

He also spent days raping and abusing a girl of seven – and casually told police she might have died if they had arrived 24 hours later.

Asked by a PC where Bennylyn was, Innes told him: "Under the kitchen floor."

Of the girl, he added: "Under the floor with mum. I couldn't look after a child. The child was screaming."

Bennylyn's family wept at Edinburgh High Court as a jury found Innes guilty

of murder after one of the most harrowing trials in Scottish history. Innes had admitted killing but denied murder – claiming he was "insane as a result of steroids" prescribed for Crohn's disease.

But judge Lord Beckett dismissed his excuse and said his crimes were "amongst the very worst".

He was also convicted of sexually abusing the toddler and raping the seven-year-old between February 20 and March 5

2021.

Referring to the seven-year-old, the judge added: "You gagged and handcuffed her. Your abuse extended over days after she had witnessed the murder of Bennylyn and had become aware of the disappearance of Jellica.

"It is a crime of exceptional cruelty and depravity."

The five-day trial heard he drove Bennylyn and Jellica from their home in Bristol to his Dundee

house on February 18. They were reported missing two weeks later.

Innes, who worked for computer game firms, had joined 34 dating sites and was looking for mums in their 20s.

Bennylyn had moved to the UK in search of a better life in 2019 after growing up in the Philippines in poverty.

Her family, who travelled from the Philippines for the trial, said: "Bennylyn was the

hope and light of our family.

"Bennylyn had bright ideas and big dreams. We shall be forever haunted by what happened to her such a long way from us. Never do we imagine it will end in such horror."

Detective Chief Inspector Graham Smith said: "In almost 30 years of policing, the depravity shown by Andrew Innes was beyond anything I, or colleagues, had witnessed before."

## Trigger warning over Bard language

William Shakespeare has fallen foul of modern-day sensibilities after theatre bosses slapped a "misogyny and racism" warning on A Midsummer Night's Dream.

The playwright's enduring comedy has been regularly performed at the three incarnations of London's Globe Theatre for the past 400 years.

The latest version, telling the tale of four rebellious lovers who get lost in a magical forest, is set to run from April as part of a summer season.

But theatregoers buying a ticket on the

Globe's website will be given a trigger warning for potentially sensitive themes in the 16th century play. It reads: "Content guidance: the play contains language of violence, sexual references, misogyny and racism."

It ends with a plea to anyone concerned about its themes to contact the ticketing team.

The venue, which opened in 1997, is a replica of the original Globe theatre built by Shakespeare's company the Lord Chamberlain's Men.


The Globe said:

"Content guidance is written in advance of the creation of each production and based on what is present in the play.

"These will be updated as the production comes to life." The trigger warning comes after education experts at the theatre attacked the play for its misogyny.

A major comic plot line in the play, which was written around 1595 and premiered in 1605, sees King Oberon give a love potion to Queen Titania so that she falls for the ass-headed character Bottom.

Academics, who have



also aimed to "decolonise" the Bard's work, say this is troubling because Titania is drugged, so she cannot consent. Hailey Bachrach,

founder of the project Shakespeare and Consent, said this kind of thread can "make Shakespeare problematic".

# Rushdie: I've had nightmares since attack

In New Yorker interview, writer breaks his silence over near-fatal attack

**SIR Salman Rushdie has broken his silence over the "colossal attack" that almost killed him.**

The author was stabbed on stage as he prepared to deliver a speech in New York last August.

He says his life has now been irreversibly changed – he is blind in one eye, his lower lip droops to one side

and he has severe nerve damage in his left hand.

He also suffers nightmares and has lost more than 40lbs in weight.

Sir Salman, author of the controversial 1988 novel *The Satanic Verses*, said: "There have been nightmares. Not exactly the incident, but just frightening. Those seem to be diminishing. There is such a thing as PTSD,

you know.

"I'm fine. I'm able to get up and walk around. When I say I'm fine, I mean there are bits of my body that need constant check-ups. It was a colossal attack. But, considering what happened, I'm not so bad. The big injuries are healed, essentially. I have feeling in my thumb and index finger and in the bottom half of


the palm. I'm doing a lot of hand therapy, and I'm told that I'm doing very well.

"I've found it very, very difficult to write."

In the interview and podcast with *The New Yorker*, Sir Salman, 75, joked that people like him more now that he has survived an assassination attempt.

The *Satanic Verses* had led to him facing death threats, with then-Iranian leader Ayatollah Ruhollah Khomeini issuing a fatwa – or decree – calling for his assassination.

Sir Salman added: "People didn't like it. Because I should have died. Now that I've almost died, everybody loves me. That was my mistake back then. Not only did I live, but I tried to live well.

When asked about his alleged attacker, Hadi Matar, the novelist described him as an "idiot".

Matar, 24, was arrested and charged with second-degree attempted murder and second-degree assault. He pleaded not guilty and his trial is likely to go ahead next year.

# Grammy winner Harry: "This doesn't happen to people like me"

**AN EMOTIONAL Harry Styles stunned the audience at the Grammys this week as he beat out hot favorites Adele and Beyoncé to take home the awards for album of the year for *Harry's House*.**

"This doesn't happen to people like me very often," he expressed after taking the stage to accept the award presented by Trevor Noah and a lineup of fans. "This is so nice, thank you."

Before passing the mic to the producers of his third studio album, Styles also took time to express that he doesn't go into the studio thinking about whether he will win awards and added that "there's no such thing as best."

Fellow contenders in the category included *Voyage* by

## Pondering the powder in Mammoth

IT MAY be 308 miles to Mammoth Mountain from Los Angeles, but in many ways it seems very much part of the SoCal landscape. Big Bear and Mount Baldy may be closer, but the drive to Mammoth feels like a snap, taking in the 14 and the 395 highways, long, straight roads which are almost always open, with zero vertigo-inducing narrow, windy sections or perilous drop-offs and fabulous views of the High Sierra to your left and the Owens valley to the right. And when the weather turns stormy and everyone in the LA basin decides to go skiing, getting to Big Bear can take almost as long.

I first visited Mammoth Lakes in the summer of 1984 and was decidedly underwhelmed.

Although mountains and backcountry was – and remains – breathtaking, the town of Mammoth Lakes felt like a forlorn winter sports town waiting for the mercury to plummet so it could return to life. Good places to eat were almost impossible to find, restaurant menus ran a very small gamut from pizza to ribs to chili to burgers and the bars usually served only three kinds of beer – Bud, Miller Lite and Michelob. Good luck finding any microbrews or imported ales. And as for the wine, provided you liked Hearty Burgundy from Gallo served from a large jug you were fine. Otherwise....

### That was then....

Almost forty years on the place has

changed almost beyond recognition, and IMHO, is much the better for it. Less cow town, more civilized ski destination. It's far more expensive, of course, but that's the price for development. But its main appeal, its large mountain and reliable snow, remain unchanged. Mammoth boasts more than 3,500 acres of skiable terrain, serviced by 28 lifts and 175 trails, meaning you can ski – or board – all day without covering much of the same terrain twice. Lift tickets range from about \$170 to over \$200 per day for an adult, although most of my group and many of the regulars there use the Ikon pass, (ikonpass.com) which seems the much smarter option, allowing unlimited skiing at many resorts for one price AND allowing holders to purchase discounted buddy passes

for friends.

As for accommodation, there is everything from cheap and cheerful (Quality Inn), to luxury hotel (Westin Monache), and everything in between, including thousands of VRBO and AirBnB properties, from cramped, dated and tired 1960s boxes to modern, glass-fronted sleek trailside mansions.

### Too much snow?

I recently joined a group of eight others for a three-day weekend following the epic snowfall that started before New Year and continued almost unabated for three weeks. The roads were all open, although four-wheel drive or chains were required at the exit to Mammoth Lakes. The snow was EVERYWHERE, piled into every spare parking lot. In many places, including our condo, it

reached up to the second floor and beyond. I even heard talk from a local that the town was running of places to store the white stuff! The town was jammed, of course, meaning some tiresomes lines at the bottom of the mountain, but by the time you took a ride up to mid-mountain or higher, the lines thinned out and what awaited was glorious hours of bluebird conditions, blue skies and miles of powder as far as the eye could see.

My group were early risers determined to not dally and pay the price of a 45-minute wait at the main gondola in Mammoth Village, the swanky dining and shopping hub at the top of the town's main drag. Consequently our group were on the gondola bright and early by 8.30am and enjoyed hours of powdery fun. A typical day would be spent taking the high speed gondola to the mountain's upper reaches, and gambolling on the runs reached by lifts 1, 3, 6 and 23 before stopping for lunch mid-mountain at McCoys then slowly wending our way over to Canyon Lodge for more drinks and taking in the rave-like atmosphere. The DJ and partying 20-somethings at Canyon made for a novelty at first, but by 3.30 most of us were

ready for a subdued gondola ride back to base camp, followed by the hot tub...and a snooze.

### Our recommendations

Mammoth manages to have something for both the older, upscale visitor and the younger, budget-conscious party crowd. Personally I enjoyed the restaurant bar at the **Westin Monache** for great happy hour wine and food, and the nearby **Petra's Bistro**, (petrasbistro.com) whose wine list runs at least ten pages and has plenty of choices to keep any enophile happy, plus reliable bistro dishes like duck leg confit and coq au vin to replace those burned-up calories.

There are countless places to rent your gear too, but I used **The Green Room** to rent skis, poles, boots and a helmet for \$46 day. (greenroom-mammoth.com).

In sum, Mammoth is a perfect place to visit right now and three days seems about the minimum stay when you consider it is a half day drive. But if you're younger and more vigorous, your mileage may vary....

Taking the 395 highway also provides the added benefit of stopping in the historic western towns of Bishop, Lone Pine or Independence. I like **Mahogany Smoked Meats** in Bishop (smokedmeats.com) for its jaw-dropping selection of jerky, including elk and wild boar in various iterations. And don't miss the **Alabama Hills Café & Bakery** (alabamahillscafe.com) in Lone Pine, for a very hearty breakfast, and fabulous baked goods, which really hit the spot, no matter if you are pre-ski carbo loading, or replenishing your calories after a demanding few days on the slopes.



# Happy return for Sancho on thrilling night

■ Troubled star scores equalizer in pulsating Roses match at Old Trafford

Marcus Rashford and Jadon Sancho combined to deny managerless Leeds a rare Old Trafford victory Wednesday night as Manchester United came back from two goals down to snatch a point from a thrilling Roses clash.

The hosts looked finished when Raphael Varane turned Crysencio Summerville's cutback into his own net to put Leeds two ahead after Wilfried Gnonto had given them a first-minute lead.

But Rashford halved the deficit when he headed home Diogo Dalot's inviting cross before Sancho, only just back to first-team duties after recovering from physical and mental issues, scored his first

Premier League goal since September when he drove home from 10 yards after Luke Shaw's initial shot had been blocked.

Varane brought an excellent save out of Illan Meslier as Manchester United hunted a goal to extend their 13-match winning streak on home soil.

Anything less than a point would have been extremely harsh on Leeds, who sacked manager Jesse Marsch on Monday, and they also hit the post through Brenden Aaronson in between the home side's two goals.

The result moves them a point clear of the relegation zone and above West Ham into 16th, although after

this superb contest, the Elland Road rematch in four days' time will be an occasion to relish.

The general narrative around Elland Road in the wake of Marsch's dismissal has been that the Leeds' hierarchy would use a week that features two games against Manchester United to recruit a replacement before key clashes with relegation rivals Everton and Southampton later this month.

Leeds had not won a league game at Old Trafford since 1981 and before kick-off many of their fans were speculating about what their margin of defeat would be, rather than whether they could get something from the

SEAN DYCHE will not be resting on his laurels following Everton's morale-boosting win against Arsenal last Saturday.


The new Everton boss told reports the performance was as important as the result against league leaders, but knows an equally stern test awaits in the Liverpool derby at Anfield on Monday.
