FIRST MINISTER IN SHOCK RESIGNATION

■ Modern political life “takes its toll on you and on those around you”, says departing Nicola Sturgeon

Nicola Sturgeon has resigned as Scotland’s first minister in a surprise decision that has thrown the Scottish National party into turmoil, triggering its first leadership contest in nearly 20 years.

In a hastily arranged press conference in Edinburgh on Wednesday, Sturgeon said she no longer had the stamina to continue in the highly pressured and demanding role.

She said “in my head and in my heart” she believed this was the right time for her to quit and build a new career outside politics, after eight years as Scotland’s longest-serving first minister and as the first woman to hold the post.

“A first minister is never off duty. Particularly in this day and age, there is virtually no privacy. Ordinary stuff that most people take for granted, like going for a coffee with friends or for a walk on your own, becomes very difficult,” she said.

“And the nature and form of modern political discourse means there is a much greater intensity – dare I say it, brutality – to life as a politician than in

years gone by. All in all, it takes its toll on you and on those around you.”

She said the SNP’s national executive had been asked to begin the process of electing a new leader and would remain in office until her successor is chosen. It last fought a leadership election in 2004, when Sturgeon ran as Alex Salmond’s running mate.

Her resignation, which many had suspected could happen nearer the next Holyrood election in 2026, triggered speculation about her successor and also opens up the prospect of a significant Labour revival in Scotland.

Bookmakers quickly tipped Angus Robertson, the SNP’s former Westminster leader and now Sturgeon’s cabinet secretary for culture and external affairs, as the lead candidate but there remains no clear successor to Sturgeon. She was anointed party leader in

2014 without a contest after Salmond resigned; this time little attention has been paid to succession planning within the party.

Labour sources believe her resignation has given them an unexpected opportunity to win back up to 15 or 20 seats at the next general election, boosting their chances of securing an overall UK-wide majority.

Bolstered by Labour voters supporting yes in the 2014 independence referendum, Sturgeon had been highly skilled at attracting Labour voters to the SNP, by pulling her party firmly to the left and making the SNP the flag bearers for Scotland’s anti-Tory vote.

With Scottish Labour hosting its spring conference in Edinburgh this weekend, its strategists believe it is highly unlikely her successor will have the skills or appeal to replicate that at the next election, allowing it to regain lost

ground.

“This puts 14, 15, 16 seats up for grabs,” said one candidate. A Scottish business leader with links to the party was even more bullish. “It should now be 15+, and maybe as high as 25,” they said.

The SNP leader has had a series of political setbacks recently, including the UK supreme court defeat of her plans for a fresh independence referendum and a damaging row over double rapist Isla Bryson

being sent to a female jail after announcing she was a trans woman.

Sturgeon told reporters at Bute House, her official residence in Edinburgh, that she had felt for some months that her energy and desire to remain as first minister was wavering. That feeling had solidified in early January and had grown since, she added.

“I have spent almost three decades in frontline politics, a decade and a

half on the top or second-top rung of government,” she said.

“So if this was just a question of my ability or my resilience to get through the latest period of pressure I wouldn’t be standing here today, but it’s not. This decision comes from a deeper and longer-term assessment. I know it may seem sudden, but I have been wrestling with it, albeit with oscillating levels of intensity, for some weeks.”

Fury as Labour leader bans his predecessor from standing again

■ Corbyn decries Starmer's decision as "flagrant attack" on democracy

JEREMY Corbyn voiced fury this week after Sir Keir Starmer barred him from standing at the next general election as a Labour candidate.

The Labour leader said the party was now "unrecognisable" from its time under Mr Corbyn from 2015 to 2020.

But Islington North MP Mr Corbyn, 73, called the ban a "flagrant attack" on democracy and said any attempt to block his candidacy was "denial of due process".

Speaking to the Jewish community in east London on Wednesday, Sir Keir said: "Let me be very clear, Jeremy Corbyn will not stand at the next general election as a Labour Party candidate."

Sir Keir also welcomed an equalities watchdog decision to lift Labour out of special measures over anti-Semitism during Mr Corbyn's tenure.

Throwing down the gauntlet to the Left, he said: "I understand that some people won't like the changes that we've made.

"But I say this with all candour – the Labour

Party is unrecognisable from 2019 and it will never go back.

"It will never again be a party captured by narrow interest, it will never again lose sight of its purpose or its morals. And it will never again be brought to its knees by racism or bigotry. If you don't like that, if you don't like the changes we've made, then I say the door is open and you can leave."

The Equality and Human Rights Commission (EHRC) monitored Labour after ruling in 2020 that it was responsible for unlawful acts of harassment and discrimination under Mr Corbyn.

But this week it said that under Sir Keir, Labour had improved its complaints and training procedures to protect current and future members.

Mr Corbyn was suspended from the parliamentary party over his response to EHRC's damning report in 2020. He now sits as an independent.

Sir Keir has long indicated Mr Corbyn will

not be standing again for Labour.

But this is the first time he confirmed the barring of the veteran MP, who led the party to two election defeats.

Mr Corbyn tweeted: "Keir Starmer's statement about my future is a flagrant attack on the democratic rights of Islington North Labour Party members.

"It is up to them – not party leaders – to decide who their candidate should be. Any attempt to block my candidacy is a denial of due process and should be opposed by anybody who believes in the value of democracy."

Asked whether he

would ban the Corbyn-supporting Momentum campaign, Sir Keir said he did not have the power, but repeated his open-door policy to opponents.

Sir Keir was introduced at Toynbee Hall on

Wednesday by Marie van der Zyl, president of the Board of Deputies of British Jews.

She said a Labour leader addressing the audience "not too long ago" would have been "an

impossibility".

But she added: "At the next election, I believe all British Jews will once again be free to vote according to their political persuasion rather than out of fear."

Sturgeon: tough act to follow for the SNP

NICOLA Sturgeon's historic career as First Minister will be remembered for her fight for Scottish independence and the way she tackled the Covid crisis.

The ambitious politician, who joined the Scottish National Party when she was just 16, rose through the ranks and became its leader when Alex Salmond stood down after the 2014 Scottish referendum.

Days later, she was voted in as First Minister.

But she will now stand down from the top job without realising her key political ambition – independence for Scotland.

During her leadership, she also faced the health crisis sparked by Covid and announced a string of tough restrictions to curb its spread.

But her government is now facing criticism as the NHS struggles to recover from the pandemic, with

soaring waiting times in emergency departments.

Ms Sturgeon's dream of leading Scotland to independence looked dashed last year when the Supreme Court ruled Holyrood could not lawfully legislate on the constitutional issue.

Next month her party will meet to discuss whether it should treat the next UK election as a "de facto referendum".

In recent weeks, legislation from her government which pushed through controversial gender reforms has taken centre stage in Ms Sturgeon's career.

The UK Government blocked the Gender Recognition Reform (Scotland) Act, which was aimed at making it easier for people to self-identify as a chosen gender.

The controversial issue was exacerbated when it emerged a transgender prisoner – who as a man

had committed two rapes – was being held in a women's jail.

Ms Sturgeon's political career has spanned nearly three decades and, since she became First Minister, she has worked with five different Prime Ministers south of the border.

In an interview with BBC's Woman's Hour, Ms Sturgeon revealed it was former Tory PM Margaret Thatcher who inspired her to go into politics.

She said she had a "strong feeling that it was wrong for Scotland to be governed by a Tory Government that we hadn't elected".

In recent weeks, Ms Sturgeon has also been quizzed over the origin of finances used by her husband, SNP chief executive Peter Murrell, to loan the party more than £100,000 in 2021.

Ms Sturgeon has said the funds were entirely his own.

No official role for Harry and Meghan at Coronation, suggests Palace

THE Duke and Duchess of Sussex are expected to attend the King's Coronation but with no official role.

Speculation has been rife over whether Prince Harry and Meghan (above) would make an appearance at the historic occasion at Westminster Abbey on May 6.

It follows their string of attacks on the royals, with the Duke's tell-all memoir the latest salvo.

But a friend said: "Members of the [royal] family have told me both Harry and Meghan will definitely come. They fully expect that."

"And they should realise that there is only one subject that many members of the Royal Family will be willing to discuss and that's the weather."

If the Sussexes, who quit royal duties in 2020, do attend it is understood they will not have an official role at the ceremony, or appear on Buckingham Palace's balcony.

The disgraced Duke of York is another who is not expected to have a ceremonial role at the King's Coronation as he is not a working member of the monarchy.

However, Prince Andrew is still a Knight of the Garter, who traditionally have performed significant

roles at coronations.

Four people stood at the corners of the Coronation Chair when the late Queen was crowned.

There had been suggestions that the Prince of Wales and King Charles's three siblings could perform the role at his Coronation.

But sources close to the Palace have dismissed the suggestion that Andrew could be involved.

Meanwhile, it has emerged that the King's anointment oil has been created by a chemist who worked on a council estate in Hull.

Mark Hutton, a pharmacist who was employed at a Lloyds Pharmacy, has produced a modern incarnation of the oil using a secret recipe dating back to the days of Charles I.

The chemist, 66, who also served as a church minister, spent eight months sourcing the ingredients replacing animal-derived products with synthetic versions.

He said: "I know it was all a secret, but for me, making the coronation oil, not only as a pharmacist but also as a now retired minister... to have done that considering the biblical history and the significance of it, it's been worth living for me, that."

■ Camilla to ditch disputed diamond for hubby's big day

THE Queen Consort is to wear a recycled crown at the Coronation that will not feature the controversial Koh-i-Noor diamond because of its colonial associations.

Camilla will wear the crown made for George V's wife Queen Mary in 1911.

In a tribute to Queen Elizabeth, this will be reset with the Cullinan III, IV and V diamonds that she often wore in brooches.

Traditionally, a new crown is made for a Queen Consort at the Coronation.

This will be the first time one has been reused since 1727 when George II's wife Queen Caroline wore the crown of James II's wife Mary of Modena.

imperialism

The 105.6 carat Koh-i-Noor was seized by the British East India Company and given to Queen Victoria in 1849. India has demanded its return since gaining

independence in 1947. It took pride of place at the front of Queen Mary's crown for her coronation in 1911, and was later used for the Queen Mother's crown for her and King George VI's coronation. Concern has been expressed in India that using the gem would be an unwelcome reminder of imperialism.

However, there have also been demands in South Africa for the return of the jewels cut from the world's biggest diamond discovered at Cullinan near Pretoria in 1905, which will be worn by Camilla. Queen Mary's crown – made by Garrard's jewellers – has been removed from display at the Tower of London for modification ahead of the ceremony at Westminster Abbey on May 6. Four of the

crown's eight arches will be removed.

St Edward's Crown, which will be worn by the King, has now returned to display after modification.

This week Buckingham Palace said: "The choice of Queen Mary's Crown by Her Majesty is the first time in recent history that an existing crown will be used for the Coronation

of a consort instead of a new commission, in the interests of sustainability and efficiency.

"Some minor changes and additions will be undertaken by the Crown Jeweller, in keeping with the long-standing tradition that the insertion of jewels is unique to the occasion, and reflects the consort's individual style."

Clarkson headed back to the farm

UNDER-FIRE Jeremy Clarkson says there will be a third season of his farming show.

'Fagins' exploiting at 'Victorian' levels

C R I M I N A L exploitation of children is at its highest level in modern times, a police chief has warned.

Shaun Sawyer said "Fagin gangs" – a reference to Charles Dickens' classic *Oliver Twist* – are taking advantage of school exclusions and a lack of youth facilities to groom youngsters.

The chief constable of Devon and Cornwall said levels of exploitation were "almost back to Victorian times".

'more exploitation'

Mr Sawyer is the national lead for tackling modern slavery and human trafficking, aiming to halt modern-day "Fagins" from manipulating children.

He said: "We are seeing more exploitation than before in modern times. They are UK nationals.

"More police officers will make a dent, but it

won't stop the causes.

"One of the solutions to the causes is the gap between the dysfunctional home and the school."

Mr Sawyer also suggested there was a gender bias against viewing boys as victims of exploitation.

massive increase

He said drug gangs and county lines have overtaken sexual and labour exploitation as the biggest reasons to class someone as a modern slave.

Youngsters are being groomed by inner city crooks to ferry drugs, as well as to deal them.

Latest figures show that, in one three-month period, 638 under-18s claimed to be criminally exploited – the majority because of county lines – Mr Sawyer added.

That was a massive increase of 94.5 per cent up on the previous year.

Saving Easter: West Mercia cops crack huge egg heist

Police officers in Shropshire have "helped save Easter" after foiling a plot to steal £40,000 worth of Cadbury's Creme Eggs.

Police cracked the case after almost 200,000 Creme Eggs were stolen from a unit in Stafford Park, Telford, over the weekend. "Other chocolate treats were also taken," said Metro.co.uk, with the entire haul thought to be worth "around £40,000".

Describing the offence as an "eggs-travagant theft", West Mercia Police tweeted that they had "helped save Easter for Creme Egg fans" after "a vehicle, presumably purporting to be the Easter bunny, was stopped northbound on the M42 and a...man was arrested".

Joby Pool, aged 32, "used a stolen lorry cab to make off with chocolate after breaking into a Telford industrial unit



The chocolate haul was estimated to be worth around £40,000

with a metal grinder", reported The Guardian. He is now facing a two-year jail sentence after pleading guilty to theft and criminal damage, and is expected to be sentenced on 14 March.

Prosecutor Owen Beale told Kidderminster Magistrates Court the self-employed ground worker had used a stolen tractor unit to tow away the trailer full of chocolate.

But shortly after reaching the northbound M42 Pool was spotted by police and "gave up at junction 11 and walked towards the police with his hands up. He was arrested and the load was recovered."

Beale told the court that the crime was "clearly an organised criminal matter". He added: "You don't just happen to learn about a trailer with that kind of value being

available."

Pool, from West Yorkshire, was previously convicted of theft, handling stolen goods and driving while disqualified in 2019. Defence solicitor John McMillan told the court that as there had been "no interference with the food products that were taken" the chocolate treats were ready to "go back on the shelves."

Trans community stunned by brutal stabbing of 15 year old girl

■ Candlelight vigils held in several cities following murder of Brianna Ghey

Two 15-year-olds have appeared in court charged with the murder of a 15 year old girl in a case that has stunned and galvanized the British trans community.

The defendants, a boy and a girl, both aged 15, appeared via video link at Liverpool Crown Court, speaking only to confirm their names, following the brutal murder of Brianna Ghey at the weekend. A trial has been set for Monday 10 July at Liverpool Crown Court and is expected to last for around three weeks.

Brianna, transgender girl from Birchwood in Warrington, was found by members of the public as she lay with fatal stab

wounds on a path in Culcheth Linear Park at around 3.13pm on Saturday.

Vigils have been held across the UK and Ireland as the trans community came together to remember the teenager.

Crowds of mourners gathered on Wednesday night outside the Department for Education building in London, City Hall in Belfast, Dalton Square in Lancaster, and on O'Connell Street in Dublin, holding trans pride flags, placards and candles.

The London vigil held a minute's silence at 7pm.

Bouquets of flowers and a sign saying RIP Brianna were left at the door of the

building, which was also defaced with graffiti.

The crowd chanted: "When trans rights are under attack, what do you do?"

"Stand up, fight back."

They also chanted: "Say her name - Brianna Ghey."

At the Belfast and Dublin events people carried signs saying "rest in power" and placards reading "say her name: Brianna".

A GoFundMe page set up to help Brianna's family has passed £88,000 just two days after it was launched.

However, Cheshire Police have insisted there is no evidence to suggest her murder was a hate crime.

Paying tribute to the teenager, who had a large following on social media site TikTok, her family said:

"Brianna was a much-loved daughter, granddaughter, and baby sister.

"She was a larger-than-life character who would leave a lasting impression on all that met her. Brianna was beautiful, witty and

hilarious, strong, fearless and one of a kind.

"The loss of her young life has left a massive hole in our family, and we know that the teachers and her friends who were involved in her life will feel the same."

Forty Years On: Fawlty Towers set to reopen its doors

Fawlty Towers is set to be revived after more than 40 years.

John Cleese returns as writer and star alongside his daughter Camilla Cleese.

The classic show ran for two series on BBC Two in 1975 and 1979, following the lives of Torquay hotelier Basil and his wife Sybil as they tried to keep their business and marriage afloat.

The new series will explore how the misanthropic Basil navigates the modern world.

Castle Rock Entertainment announced on Tuesday it had closed a deal with Cleese to bring back the television series, but it's not yet clear which channel or streaming service it would appear on.

The revival will also see Basil and his daughter, who he has just discovered is his, team up

to run a boutique hotel.

Fawlty Towers was originally written by Cleese and his then-wife and co-star Connie Booth. Set in a fictional hotel in the seaside town of Torquay, it found Cleese's snobbish protagonist, Basil Fawlty, struggling to run his business, despite the help of his Booth's character, chambermaid Polly, his wife and the hapless Spanish waiter, Manuel, played by Andrew Sachs.

Basil is shown trying and often failing to keep his struggles - induced by farcical run-ins with hotel guests, staff and tradespeople - secret from Sybil, played by Prunella Scales.

Classic episodes included Basil "thrashing" his own car with a tree branch, out of frustration, and Manuel's pet rat running round the hotel when the health inspector visits.

Camilla Cleese is the daughter of John Cleese and Barbara Trentham, the late American model and actress.

The UK-born American actress, writer and producer has credits on the One Show, as well as on the US TV shows @Midnight and the Bachelorette Weekend.

She has also written and performed stand-up comedy for the likes of the Laugh Factory in Hollywood and the Just For Laughs International Comedy Gala in Sydney. Her writing credits include her father's live show in 2011 called John Cleese: The Alimony Tour.

The new series will see actor Rob Reiner, his wife and actress Michelle Reiner, director and producer Matthew George and Derrick Rossi all act as executive producers.

Cleese - one of the original members of Monty Python - said when he first met George "he offered an excellent idea" which led to "one of the best creative sessions I can remember".

"By dessert we had an overall concept so good that, a few days later, it won the approval of Rob and Michele Reiner," he

said.

"Camilla and I look forward enormously to expanding it into a series."

George said he was "obsessed with Fawlty Towers" and meeting Cleese and his daughter was one of the "great thrills" of his life.

"I've watched the first two seasons so many times I have lost count," he said. "I dreamed of one day being involved in a continuation of the story.

Now it's come true."

When Fawlty Towers was first broadcast, it won several Baftas, including for best scripted comedy, with Cleese also picking up the award for best entertainment performance.

Four decades on, the show is still seen as one of the best of its kind, and in 2019, it was named as the greatest British sitcom of all time by a panel of TV comedy experts for Radio

Times magazine.

In a 2009 interview Cleese said there would never be another series with the original cast.

"I think everyone would be excited if we did it," he said. "The problem is, when you do do something that is generally accepted as being very good, a horrible problem arises, which is: how do you top it? The expectation of what you will do is so high."

Marsch U-turn stuns Saints

Southampton's search for a manager has been plunged into turmoil after a U-turn from top target Jesse Marsch.

The sacked Leeds head coach had agreed to join the Premier League's bottom club.

But talks broke down after last-minute discussions with the owners, Sport Republic.

Saints were offering a contract only until the end of the season with the option to extend if Marsch saved them from relegation, which left the American feeling uneasy.

His change of heart leaves the club in a state of flux after they sacked Nathan Jones on Sunday.

Jones' assistant, Ruben Selles, will now be at the helm for Saturday's trip to Chelsea.

With no viable alternative, there is a strong possibility Selles will remain in the dugout for the rest of the season.

Chelsea left frustrated in Dortmund

Twenty one shots, eight on target, no goals and another defeat.

It was a familiar story for Chelsea on Wednesday as they showed a lack of a cutting edge in the final third on their way to defeat by Borussia Dortmund in Germany.

The Blues had enough chances to win the first leg of their Champions League last-16 tie - and win it comfortably - but poor finishing, great saves and the woodwork conspired against them.

There has, understandably, been plenty of scrutiny focused on Graham Potter since he became Chelsea boss in September, but even his biggest critics must sympathize with him after this loss.

Against a Dortmund side who had won every game they had played so far in 2023, the visitors were the better side for large periods, but as chances came and went before Karim Adeyemi broke to score a brilliant solo goal for the hosts, it must have felt like luck had once again deserted Potter and Chelsea.

"Overall we were pleased with the performance for big parts of the game," said Potter.

"It was an even first half, we managed the game quite well and had some good opportunities.

In the second half, apart from the decisive action where we didn't do well enough, I thought we were the dominant, better team.

"We need a bit of luck maybe in the final execution and I think we deserved a goal. We have to keep going. It is half-time and we look forward to Stamford Bridge."

As mentioned, Chelsea had 21 shots on goal at Dortmund with eight of those on target. The Blues' expected goals, which measures how good your chances were, was 2.14 - the fourth-highest rating of any team in

this season's Champions League without scoring.

The lack of goals is an issue that has troubled Chelsea throughout Potter's time at the club so far. In his 24 matches, they have scored just 25 goals. They have not managed more than one goal in match since 2 November.

Their struggles in the final third make it all the more bewildering that despite spending around £288m in January - more than the combined total of all clubs in the Bundesliga, La Liga, Serie A and Ligue 1 - they did not invest in a proven out-and-out striker, while also leaving

former Arsenal and Barcelona forward Pierre Emmerick-Aubameyang out of their Champions League squad.

Joao Felix, one of the January arrivals, put in a superb performance,

particular in the first half, but he was guilty of some of Chelsea's biggest missed opportunities, shooting over from a good position in the first half and then hitting the crossbar when it seemed easier to score.

City resume normal service

Manchester City returned to the top of the Premier League for the first time since November as they leapfrogged leaders Arsenal with a vital 3-1 victory at Emirates Stadium Wednesday night.

The reigning champions turned on the power in the second half in the biggest game of the domestic season as Arsenal paid a heavy price for individual errors.

Takehiro Tomiyasu's poor backpass allowed Kevin de Bruyne to loft a finish over Arsenal goalkeeper Aaron Ramsdale after 24 minutes but Arsenal deservedly drew level three minutes before half-time, Bukayo Saka scoring from the spot after City goalkeeper

finish after 72 minutes before they ended Arsenal's hopes with 10 minutes left.

Inevitably, Haaland was the scorer from De Bruyne's pass to put City top on goal difference having played one game more than Arsenal.

City have returned to the top of the Premier League by striking a devastating blow on the long-time leaders.

City, by their own standards, have not quite hit the heights this season but they now find themselves looking down on Arsenal once more, albeit the Gunners have a game in hand.

Even here, City lacked their usual fluency in the first 45 minutes and Arsenal arguably deserved more than being on level terms at

Ederson fouled Eddie Nketiah.

City, lacking spark in the opening phase, improved after the break and had a penalty of their own ruled out for offside against Erling Haaland before they showed a ruthless streak to punish Arsenal.

Gabriel lost possession to allow Bernardo Silva and Haaland to set up Jack Grealish for a deflected

the interval. And yet, once they moved through the gears in the second half City carried enough threat to put Arsenal away and return to the position they have occupied so often in recent years.

City gratefully accepted the gifts Arsenal offered and once Grealish restored their lead - a touch off the luckless Tomiyasu sending his shot past Ramsdale - this game was done.

Haaland's goal emphasised City's supremacy and they closed out the win with ease, the celebrations at the final whistle reflecting the significance of the result.

Europa thrills: Just like old times for Barca and United

Erik ten Hag said Manchester United "have a lot of character and determination" after his side contested Thursday's thrilling first-leg draw at Barcelona to leave their Europa League play-off tie finely poised.

Having previously met in two Champions League finals - both of which Barca won - the sides are trying to reach those heady heights again.

This encounter at the Nou Camp in Europe's secondary competition was another step on that road back to the top.

Xavi's men grabbed the opener when Marcos Alonso headed in at the back post from Raphinha's corner, but United responded immediately through the in-form Marcus Rashford as he slipped in a finish at the near post.

They showed their resilience to turn the game around as Rashford's cross was then turned into his own net by Barcelona defender Jules Kounde.

But United were unable to hold on as ex-Leeds winger Raphinha's cross from wide on the right sailed all the way into the net.

Barca, though, almost snatched a late victory when Casemiro's

attempted clearance struck his own post, but little separated the sides heading into next Thursday's second leg.

United manager Ten Hag told BT Sport: "I think it was a great game. Two attacking teams, I think it was a Champions League game, even more than that, so I really enjoyed the game. In the end (it finished) 2-2, and cont. on page 19, col. 1
