SUNAK: Brexit deal means 'we taken back control'

RISHI SUNAK finally nailed down a new Brexit deal with the EU this week, and declared the agreement "puts beyond all doubt that we have now taken back control."

By securing major concessions that will end border tensions, the Prime Minister was praised by leading Brexiteers for a "brilliant" and "spectacular" result.

Mr Sunak said the deal will remove trade barriers for Northern Ireland, providing stability in the region, and give the UK a "veto" on EU law.

It also ensures the Union will "endure". He said: "Today's agreement is written in the language of laws and treaties. But really, it's about much more than that. "It's about stability in Northern Ireland. It's about real people and real businesses. It's about showing that our Union, that has lasted for centuries, can and will endure.

"And it's about breaking down the barriers between us. Setting aside the arguments that have for too long divided us. And remembering the fellow feeling that defines us - this family of nations, this United Kingdom."

A key part of the deal, known as the Windsor

Framework, is an emergency "Stormont brake" on changes to EU goods rules that can be pulled by the Assembly in Belfast.

Mr Sunak said it would give a "veto" and is a "very powerful mechanism" for Stormont to use when it has concerns over EU law.

'new chapter'

The PM faced laughter in the Commons as he opened his speech by paying tribute to his predecessors "for laying the groundwork for today's agreement".

One Labour MP could be heard shouting: "Where's Boris?"

Mr Sunak's landmark statement to the Commons came to a conclusion after two hours and 29 minutes.

He said: "Under the protocol, retail food products made to UK standards could not be sold in Northern Ireland.

"Today's agreement completely changes that. This means the ban on British products like sausages entering Northern Ireland has now

been scrapped.

"If it's available on supermarket shelves in Great Britain, then it will be available on supermarket shelves in Northern Ireland."

Mr Sunak finalised changes to the protocol in talks at the Fairmont Hotel in Windsor Park, Berkshire, with Ursula von der Leyen, the European Commission president.

Standing beside the PM, the Eurocrat warmly referred to him as "dear Rishi" and hailed a "new chapter in our partnership" that will foster a "stronger EU-UK relationship".

She also said Brussels will immediately start the ball rolling on the UK joining the EU's Horizon scientific research programme. The EU chief had tea with the King at Windsor Castle, despite criticism that the meeting would drag Charles into the politically contentious agreement.

Northern Ireland Minister and arch-

Leaver Steve Baker said the agreement could be a "really fantastic" outcome.

But elsewhere in Northern Ireland the reception was more cautious, with DUP leader Sir Jeffrey Donaldson asking in the Commons for a guarantee that the application of EU law would not put barriers in the way of trading with the rest of the UK.

He said: "Ultimately, my party will now assess all these proposed outcomes and arrangements against our seven tests. And whether it respects and restores Northern

Ireland's place within the United Kingdom."

Mr Sunak issued a warning to potential Tory rebels that they should think about the people of Northern Ireland, who have suffered community tensions since a trade border was imposed down the Irish Sea.

Key Brexiteers serving within Mr Sunak's Government backed the deal, which was partly negotiated by Northern Ireland Secretary Chris Heaton-Harris, a previously close ally to Mr Johnson. The former PM is believed to still be considering the new deal

on the protocol.

The Northern Ireland protocol that set out post-Brexit trading rules caused chaos for traders.

Mr Sunak will scrap legislation introduced by Mr Johnson to override parts of his own protocol deal, and in turn Brussels will end its legal action against the UK.

The protocol was designed to prevent a hard border with Ireland after Brexit but means Northern Ireland has continued to follow EU rules on goods to prevent checks being needed when crossing into the Republic.

Harry and Meghan left 'stunned' as Charles cuts short lease on their Windsor home

■ Charles reportedly 'evicts' royal couple as payback for their very public criticism of the family...and plans to have Andrew move in instead

KING CHARLES has made a highly significant decision to terminate Harry and Meghan's access to their cottage on the Windsor estate... and has insisted that his disgraced younger brother Prince Andrew move in instead.

The move has reportedly left the celebrity couple "stunned" and angry, according to one of their closest allies.

Royal insiders described as an act of revenge after his younger son criticised the family in his memoir Spare.

Sources close to Harry and Meghan suggested that the monarch was being "cruel" in cutting short their lease on five-bedroom Frogmore Cottage.

The decision is understood to have been made only a day after the fifth in line to the throne's bombshell book was published.

Their biographer Omid Scobie quoted a friend of the Sussexes as saying: "It all feels very final and like a cruel punishment. It's like [the family want to cut them out of the picture for good."

The King intends to

move Andrew, 63, out of 30-room Royal Lodge and into nearby Frogmore.

But the Duke of York, who lives in one side of the Grade II-listed mansion while his ex-wife Sarah has the other, is said to be opposing the efforts to make him downsize.

One source said yesterday: "He doesn't want to leave. He is resisting it and putting his foot down."

Harry and Meghan have spent little time in Frogmore but regard it as their sole haven in Britain, since it is inside the royal security cordon at Windsor.

The house, which was converted from staff accommodation and renovated at a cost of £2.4million to the taxpayer, guarantees them protection at a time when the Home Office is refusing to guarantee the pair access to armed police bodyguards pending a High Court case brought by Harry.

The Prince, 38, and Meghan, 41, repaid the costs after quitting their official royal roles and stumped up a lump sum for future rent covering several years, according

to Buckingham Palace officials.

But now they have been told to vacate the property.

They were initially urged to move out quickly but have been given until the summer, according to their biographer.

In an online blog Mr Scobie discussed the importance of Frogmore as a British base for Harry and Meghan, who live in California with children Archie and Lilibet.

He continued: "With the Sussexes still unable to access royal police protection when in the UK, there is just one remaining space that meets the family of four's security needs when visiting - Frogmore Cottage.

"Less than three years into that long-term lease, Prince Harry has been dealt a crushing blow after his father, King Charles, announced he is evicting the family from their Windsor property - a decision made shortly after his revealing memoir, Spare, was released in January. The property, they were told,

is needed for someone else.

"It's news, sources tell me, that has left Harry and Meghan stunned, and at least two members of the Royal Family 'appalled'.

"The decision on the Sussexes' home is a clear sign of just how sour relations between the King and his son have become.

"Given the timing of the news, it's hard not to view it as a response to his son's literary tell-all, which is said to have left the monarch 'spitting mad'."

The King's move has also cast fresh doubt on whether Harry and Meghan will attend his Coronation on May 6 and dampened the hopes of some courtiers who have been talking up the chances of the family meeting for reconciliation talks before then.

Some have portrayed the monarch as a man who loves his younger son dearly and is anxious to extend an olive branch to him.

But stripping Harry of his only home in Britain, and not offering him an alternative, contrasts sharply with that view.

Prince Andrew is under pressure to move out because the 74-year-old King intends to cut the financial support his brother has received via the monarch's private income from the Duchy of Lancaster estate since 1993. In that year Queen Elizabeth II agreed to cover the cost of her middle son Andrew's £249,000 Parliamentary annuity and similar payments given to Princess Anne, Prince Edward and other members of the Royal Family.

Since then, the cost of supporting them has

grown considerably - and the King wants to cut costs.

Some royal watchers were astonished at the King's 'vindictiveness' towards his son. Michael

Cole, a onetime BBC royal correspondent, told GB News: "What do they say about revenge being a dish best eaten cold? What we're seeing is the swinging fist of majesty."

Consort no more: Camilla soon to be known as the Queen

CAMILLA'S decades-long journey to full acceptance will end after her husband is crowned King and she is referred to as the Queen, sources have said.

Until now, Camilla, 75, has been known as Queen Consort. But it is understood the suffix will be dropped after the Coronation.

And in a break with tradition, her five teenage grandchildren will join Prince George as they play a starring role on May 6.

Camilla is said to be extremely keen for Lola and Eliza, 15, Freddy, 13, and twins Louis

and Gus, 13, to hold the canopy over her as she is anointed.

In the past, duchesses have performed the key role, considered one of the most sacred parts of the ceremony.

Lola and Freddy are the children of Camilla's son, cookery writer and critic Tom Parker Bowles, 48. Eliza, Louis and Gus are the daughter and sons of her art curator daughter, Laura Lopes, 45.

Charles is also said to be incredibly close to the children.

As a future monarch, Prince George, nine, is also expected to have an

official Coronation role.

A royal source said: "There's a view in the Palace that Queen Consort is cumbersome and it might be simpler for Camilla to be known just as the Queen when the time is right."

'sincere wish'

Queen Elizabeth made the then Duchess of Cornwall Queen Consort on the eve of her Platinum Jubilee last February. She said it was her "sincere wish". The title became effective on September 8 when Elizabeth died.

The kinship between the two ended years

of speculation and conjecture over Camilla's status.

She had spent years being ostracised and blamed for the breakdown of Charles' marriage to Diana. But in the decades after Charles' divorce and Diana's death in 1997, Camilla has enjoyed soaring popularity and acceptance into the Royal Family.

After her wedding, she gradually took a more prominent role. In 2016 she was made a Privy Counsellor.

Camilla has now updated her charity name, the Duchess of Cornwall's Reading Room to the Queen's Reading Room.

It is likely the Court Circular, the register of royal engagements, could also follow suit.

Palace officials are said to have been looking at precedent, including titles used for the wife

AT LONG LAST, A SLUMP: but prices remain eye-wateringly high

Britain's housing market facing a "significant slump" this year

■ Repeated rate hikes and spiking inflation finally put the brakes on the long-buoyant property sector

BRITAIN'S housing market faces a "significant" slump this year after property prices plunged, experts have warned.

Values dropped by 1.1 per cent in the year to February, the first time prices have fallen since June 2020, according to building society Nationwide.

The slump has led to house prices dropping at their fastest rate in more

than a decade.

Rising interest rates pushing up mortgage bills and the soaring cost of living squeezing budgets means buyers are not always willing to pay the top asking prices.

Ed Molyneux, co-founder of digital property specialists Moverly, said: "Unfortunately, we've

seen yet further evidence from Nationwide that

the decline in house prices seen during the latter stages of 2022 has rolled over into the new year.

"It's likely that this slump is here to stay for the short term, at least, and we can expect to see a further reduction in property values over the coming months."

Woman jailed for torturing her husband of 20 years



Sheree Spencer: "coercive and controlling behaviour"

A WOMAN who downed three bottles of wine a day has been jailed for torturing her husband of 20 years.

Sheree Spencer gave her spouse a cauliflower ear and a chipped elbow. She also smashed a wine glass on the back of his head.

The 45-year-old admitted coercive and controlling behaviour towards her husband between January 2016 and June 2021. She also pleaded guilty to three offences of assault causing actual bodily harm at Hull Crown Court.

The unnamed husband gave 43 photos, 36 video clips and nine mobile phone recordings to police when her abuse was revealed. In one recording she was heard saying: "You're not a ****ing man - I want you out of my life."

Spencer's "unpredictable and threatening" behaviour saw her spouse become estranged from his family.

He told the court: "She threatened to make false allegations to the police."

Defence barrister Richard Pratt KC said a mixture of alcohol and prescription medication caused her to behave in a way which "appalled" her.

Spencer, of Market Weighton, East Yorkshire, was jailed for four years.

She was grinning as she was taken to the cells.

Disgruntled passenger beats BA in court over refund...without a lawyer

A WOMAN who took British Airways to court to get a £2,500 flight refund has won her case without a lawyer.

Jennie Barber used her A level in law to beat the airline giant using 80-year-old legislation.

She said: "If you're an ordinary person, who is not a legal professional, going up against someone like British Airways is scary - and it is intimidating."

Ms Barber had booked two return flights to Japan in January 2020, due to depart that May and which were pulled due to Covid restrictions.

She originally requested a refund in flight vouchers, but as Japan did not open its borders as quickly as other countries, she could not use them. Ms Barber, from Birmingham, said

she spent about a year trying to persuade BA to reimburse her in cash instead, but the firm would not budge.

With no other option she mounted a legal challenge in February 2022, ahead of a court hearing in January this year. In preparing her case she came across the Law Reform (Frustrated Contracts) Act 1943.

This stated that because the sale involved something that was impossible to deliver, she was legally entitled to her money back.

The case was heard at Redditch Magistrates Court, Worcs, on January 20, where Ms Barber was awarded £2,523.42 to cover flights, interest up to the date of judgment and costs.

Ms Barber said she was moved to take matters

into her own hands because she "didn't feel it was right" there was no leeway on vouchers when Japan's borders stayed shut.

In a statement, BA said: "We were the first UK

airline to offer customers the unprecedented flexibility to change their plans during the pandemic by providing them with vouchers for future travel."

In reaction to the

case, consumer solicitor Gary Rycroft said: "I am absolutely thrilled that Jennie decided to see through this case. She absolutely knew what her legal rights are and she stuck to her guns."

Prime Ministers past and present lead tributes to "inspirational" former Commons Speaker Betty Boothroyd

Former Tiller girl controlled the Commons during eight years as Speaker, from 1992 to 2000

Prime ministers past and present led tributes to "inspirational" former Commons Speaker Betty Boothroyd, who has died aged 93.

Baroness Boothroyd, the first woman elected to bring rowdy MPs to order, was widely regarded as one of the finest in the role.

She controlled the Commons during eight years as Speaker, from 1992 to 2000.

The former Tiller Girls dancer continued her plain speaking from the Lords.

PM Rishi Sunak said this week: "A remarkable woman who dedicated her life to politics, she was an inspiration as the first woman Speaker. The passion, wit and sense

of fairness she brought to politics will not be forgotten."

Labour leader Sir Keir Starmer said Lady Boothroyd "smashed the glass ceiling for female politicians" with "wit and style that will never be replicated".

Former PM Sir Tony Blair said: "She was a truly outstanding Speaker, presiding with great authority, warmth and wit, for which she had our deep respect and admiration. It was a privilege to be in Parliament during her tenure and to know her as the big-hearted and kind person she was."

Theresa May said Lady Boothroyd, right, was "formidable in the chair", commanding respect

across the House. The Tory ex-PM said: "I will always remember her inimitable style, but also her immense personal warmth and kindness."

Sir John Major called her "a superb Speaker, easy to like and easier still to admire". He added:

"She was full of common sense and utterly fair in her rulings.

"She set a standard for every future Speaker."

Current Speaker, Sir Lindsay Hoyle, called her "one of a kind". He said: "She stuck by the rules, had a no-nonsense

style, but any reprimands she did issue were done with good humour and charm."

Born in Dewsbury, West Yorks, Baroness Boothroyd was a professional dancer from 1946-8 and appeared in pantomimes in London's West End.

She unsuccessfully fought four parliamentary seats for Labour before winning West Bromwich in 1973.

Tory MP Shaun Bailey, who holds her seat, said: "I've always been conscious I'm following in the footsteps of someone who paved the way for so many."

Tory peer Eric Pickles said: "She threw wonderful parties in Speakers House.

"I have a much-treasured memory of Betty and [ex-Labour chancellor] Denis Healey singing music hall songs."

Woman completes 10-year National Trust scone-tasting mission

A woman from London has completed a decade-long mission to sample a scone at every National Trust location with a tearoom or restaurant.

Sarah Merker, 49, from Isleworth, west London, tasted scones at 244 National Trust sites across England, Wales and Northern Ireland. Merker ranked and reviewed each scone on her blog, aptly named nationaltrustscones.com

Merker completed her goal on Wednesday when she visited the Giant's Causeway in Northern Ireland, where she sampled one last scone. On Twitter, she described it as "fresh, warm and absolutely delicious".

"I'll really miss it"

"It's all very emotional, it's been a weird experience," Merker told the PA news

agency. "It's just played a very important part of my life.

"I don't know what I'd call it – it's more than a hobby ... It's taken up a lot of my time and effort over the past 10 years and I'll really miss it."

Merker, a marketing director, started the National Trust scone project in August 2013 with the ambition of "visiting every National Trust property and

EY Item Club, said: "We think the fall in property prices still has some way to run.

"Although mortgage rates have dipped from post-mini-Budget peaks, they're still close to their highest in a decade."

The Nationwide figures revealed house prices fell for the sixth time in a row on a monthly basis. The average cost of a home slipped to £257,406 between January and February.

Last month, mortgage lender Halifax predicted a fall in property values of around eight per cent

this year.

The property market has come under pressure after a surge in mortgage rates following the mini-Budget last September and the Bank of England's battle to cut soaring inflation.

Many mortgage providers withdrew their cheap deals and hiked rates, adding hundreds of pounds to home loan repayments.

The Bank of England has hiked the base interest rate 10 times in a row to four per cent to tame the worst inflation crunch in 40 years – and more rises are possible.

That has raised rates on international financial markets for UK debt, which mortgage providers use to price their products.

Record price rises for

groceries, energy and fuel, on top of tax rises, mean most households have less disposable income to spend on buying houses, it was said.

The slump has been seen across the country. A London terrace house listed in January has seen its price reduced twice, by £125,000 and £50,000.

The seller is now listening to offers over £950,000. A flat in Manchester listed at the same time has also seen two reductions this year, of £20,000 and £40,000, leading to a new asking price of £220,000.

And a semi in Newcastle listed in August had its price reduced by £25,000 last month, to make a guide price of £125,000.

having a scone at it" where possible, she said in her blog.

She shared some of the journey with her husband, Peter, who died from cancer in 2018. The couple had visited the Giant's Causeway before they became National Trust members in 2013, which inspired Merker to end the project at the site as a way to honour Peter.

"He'd been there for so much of it and obviously I have memories of doing it with him," she said.

"So, for me, it was really important to finish it for him as well – I wanted to make sure I got to the end."

Armed with her £84 annual membership, Merker began rating and reviewing the scones at all locations where scones were available,

which involved visiting every National Trust property that had a cup symbol by it in the National Trust 2022 handbook, indicating it had a food outlet, she explained on her blog.

"I thought it would take me maybe five years or something. I didn't expect to do it quickly," she said, "but I didn't think it would take me 10 years."

RIP: former Consul General Merrick Baker-Bates

THERE WAS sad news for the local British community this week with the news of the death of Merrick Baker-Bates, British Consul General in Los Angeles from 1992-1997. Merrick passed away on Friday, February 24.

Merrick was a tireless promoter of British business and culture during his time in the City of Angels, and managing his duties with effortless ease and charm, not to mention a very welcome warmth with everyone he encountered.

Born on July 22nd 1939, Merrick entered HM

Diplomatic Services in 1963 as 3rd, later 2nd Secretary Tokyo, he then went on to become 1st Secretary Washington, 1st Secretary Tokyo, Deputy High Commissioner and Counsellor Kuala Lumpur, Head of Atlantic & Antarctic, FCO and Commissioner British Antarctic Territory until he became the British Consul General in Los Angeles in 1992 where he served for 5 years.

His close friend the film producer Katy Haber MBE worked with him extensively on local humanitarian

projects and summed up his contribution to our community with the following words: "I am truly devastated by the news of the passing of CG Merrick Baker-Bates CMG. No one has contributed more to the British community in the US than Merrick, who during his tenure as CG, founded UK/LA that ultimately became Britweek. He was far more than a politician, he was a humanitarian, using his platform to reach out to the poor and the downtrodden, opening up the doors of the Consulate

And the 4,300 travelling Mariners fans, with their shoal of inflatable fish, were living the dream on the South Coast as the Saints were battered by their mid-table League Two visitors.

The lowest-ranked club left in the competition will take their place among the big fish in the last eight after a turbot-charged display produced the biggest shock this season.

Grimsby boss Paul Hurst said: "You turn up and kind of hope for a miracle. So to be in the quarter-final of the FA Cup is unbelievable.

"We've gone down in the history books now. It's a very special night."

Ruben Selles made nine changes and was forced to introduce James Ward-Prowse after the break.

But despite pulling one back and late pressure, the Saints were sunk by a club three divisions and 64 places below them in the league pyramid and were booted off at full-time.

With Grimsby playing at this stage for only the 11th time, Saints had chances to win the tie in the first half.

Mislav Orsic then curled a shot wide but, from a rare counter-attack, Joshua Emmanuel's cross hit the arm of Brazilian Lyanco as he stooped for a header and Holohan netted from the spot.

Arsenal have that title-winning look as 'basic' Toffees come unstuck

BUKAYO SAKA quickly ripped apart Sean Dyche's "back to basics" Everton blueprint in the latest sign that Arsenal really are ready to graduate as champions with a 4-0 stroll at The Emirates.

Another first-class performance left Everton's war-dog of a manager wishing he had some of the Arsenal pups' new tricks.

Because when Dyche was appointed in January, he told his players they needed to return to "basic principles".

Those lessons drummed into players from the moment they first begin to kick a ball in earnest.

Goalkeepers, for instance, should never be beaten at their near post.

Yet here was England No.1 Jordan Pickford waving helplessly at Saka's fierce right-foot drive after his stunning turn had caught Vitaliy Mykolenko on his heels in the 40th minute.

But that was nothing like the kindergarten howler committed by Idrissa Gueye as the game ticked over into first-half stoppage time.

Do not take too long on the ball and always be aware of what's behind you.

Yet, having tidied up possession just outside his own area, Gueye's brain seemed to freeze.

Facing back towards Pickford, Gueye seemed to take an age to decide to play the ball to him. Then, just before he did, Saka nipped in to toe-poke the ball to Gabriel Martinelli and within a second he was 2-0.

Gueye was grounded for the second half as Everton tried somewhat

forlornly to retrieve a playground battle that had been surrendered somewhat emphatically.

From the inclusion of Michael Keane for the first start of the season, it was clear Everton's plan was to bully Arsenal, as they had done to some extent at Goodison in the shock 1-0 win that marked Dyche's first game in charge.

The young side Mikel Arteta has assembled seem generally able to knock down and perform whatever the circumstances.

They rode the inevitable squall of resilience Everton produced early in the second half, then picked them off again. Leandro Trossard scampered down the left, picked out the unmarked Martin Odegaard and it was 3-0. Martinelli got on the end of a ball from Eddie Nketiah for a much-deserved second goal of his own to round off the scoring.

The win takes Arsenal five points clear of Manchester City at the top.

Increasingly, it seems the "basics" will not be enough to topple Arsenal. In fact, it will take something rather extraordinary.

Late show keeps quadruple dream alive

■ FA CUP: Garnacho grabs headlines again as Red Devils down West Ham, 3-1

THEY left it late but Alejandro Garnacho ensured Manchester United's unlikely quadruple dream inched a touch closer at Old Trafford on Wednesday night.

A tie heading into extra-time after the two sides exchanged goals, West Ham going ahead through Said Benrahma and an own-goal from Nayef Aguerd, was settled in the final minute of normal time. And it was settled by a player who is making a habit of it, having done the same at Fulham earlier in the season. Fred added the gloss late on but it was Garnacho who proved the difference.

Manager Erik ten Hag had been adamant in the build-up to this cup tie that his squad could cope with the considerable workload presented by competing on three more fronts this season. But the rigours of the weekend's Carabao Cup triumph against Newcastle at

Wembley and a trip to face Liverpool at Anfield on Sunday clearly played a part in his team selection.

Six players were rolled in and out of a starting line-up that had none of his first choice centre-backs, Luke Shaw, Casemiro or Marcus Rashford.

United were stretched at times during a first half when, on balance, West Ham looked the more likely.

The hosts needed David De Gea, fresh from his club record 181st clean sheet on Sunday, to keep them in the game on 24 minutes when the Spaniard denied Michail Antonio brilliantly with a strong right hand.

Ten Hag is fast developing a well-deserved reputation for decisive interventions off the bench and having seen midfield dominated by Declan Rice, he brought on Casemiro at the start of the second half.

The Brazilian immediately energised and sharpened United's engine room but it was West Ham who grabbed the initiative nine minutes into the half.

The opening goal carried with it a degree of controversy with Tomas Soucek just keeping the ball in play hard against the left flank and feeding Emerson, whose cut-back was picked up by Benrahma and placed beautifully into the far right corner of De Gea's goal from 20 yards.

It was no more than West Ham deserved and it prompted Ten Hag to bring on further cavalry in Rashford and Lisandro Martinez.

With the game stretched, United probed and Casemiro headed in from Bruno Fernandes's free kick only for VAR to rule his run offside.

It was a warning West Ham hardly needed with United building a head of steam and seven minutes later another set piece, a corner from
