CHEERS TO CHARLES!

■ Boozy Brits set to give pubs a £120m bonanza this weekend

MILLIONS of patriotic and proud punters will raise a toast to newly-crowned King Charles this weekend in a £120million tonic to the great British boozier.

Pubs that have seen business battered by Covid, energy bills and reduced trade from the cost-of-living crisis will finally have something to cheer over the Coronation weekend.

The nationwide celebration will see 17 million more pints served than usual as the good times return for a knees-up like no other.

Emma McClarkin, of the British Beer & Pub Association, said: "Our brewers and pubs are looking forward to the King's Coronation being a time for communities across the country to join in celebration – and what better place to do that than at your local?"

"In a critically difficult time for our industry, we hope people will mark this historic national celebration by visiting their local, one iconic British institution supporting another."

Thousands of breweries are marking the special occasion with Coronation ales, while hostellers hope to entice punters back with set-piece celebrations including barbecues and afternoon teas.

Harvey's, one of the UK's oldest independent breweries based in Lewes, East Sussex, has brewed Carolean Crown to mark the Coronation. It is aptly billed as an ale that looks to herald a new era, while reflecting on the past.

The return of the great British pub to the centre of community celebrations comes as towns and villages up and down the country prepare to celebrate the Coronation at more than 3,000 street parties.

Overall, the seismic occasion, the first since Charles's "darling mama", Queen Elizabeth II was crowned in Westminster Abbey almost 70 years

ago on June 2, 1953, is set to provide a multi-billion pound boost to a hospitality sector still reeling from the fallout of the pandemic and belt-tightening.

The Bank Holiday weekend is set to deliver a £350million boost to the battered hospitality sector. UKHospitality chief executive Kate Nicholls said: "May has the potential to be a historic month for the sector, which is set for one of its busiest times in recent memory.

"We know the British public turn out in their droves for big events and we expect the Coronation to be no different...and we anticipate this will

translate to a huge uplift in sales for the sector.

"Bank holidays alone are always popular for eating

and drinking out and this with a historic occasion is incredibly exciting for

hospitality, at a time when the support of the public is absolutely essential to its survival."

William to honor Camilla in 'loving' tribute to father

PRINCE William will declare his support for Queen Camilla in a "heartfelt and loving" speech dedicated to his father the day after they are crowned, royal insiders have revealed.

The decision of the Prince of Wales (pictured, right) to pay tribute to his stepmother at

Sunday's Windsor Castle Coronation concert will put the 40-year-old in direct conflict with his estranged brother Prince Harry.

In his explosive memoir Spare, the Duke of Sussex, 38, blamed Camilla, 75, for leaking stories about the Royal Family to transform her image.

He wrote: "I have complex feelings about gaining a step-parent who I thought had recently sacrificed me on her personal PR altar."

Harry also said he and William had "begged" Charles not to marry Camilla over fears she would become their **cont. on page 4, col. 1**

Top cop issues stern warning to troublemakers

Windsor coronation police chief warns of 'lower tolerance' for protest disruption

The police chief in charge of security in Windsor has said he will have "a lower tolerance" for disruption caused by protest due to the "iconic" nature of the coronation.

The Thames Valley police assistant chief constable Christian Bunt, the gold commander for the policing operation over the coming weekend, also said he would make use of new public order laws, which were fast-tracked in the weeks leading up to the event.

The laws include a 12-month prison sentence for protesters who block roads and a six-month prison sentence or unlimited fine for anyone who locks on to others, objects or buildings. Police will also be able to stop and search protesters they suspect are setting out to cause "disruption".

Official warning letters have been sent to anti-monarchists planning to stage peaceful protests at the coronation, but the cabinet minister responsible for introducing the laws, Tom Tugendhat,

insisted people would still have the "liberty to protest".

Chief constable Christian Bunt told reporters on Wednesday he had a duty to balance the right to protest with the rights of those attending to enjoy events, such as the coronation concert in the town's castle.

The human rights group Liberty said Bunt's comments set a "really dangerous precedent" that would "discourage lots of people from feeling able to stand up for what they believe in", while the environmental activist group Just Stop Oil said the move was not about "protecting the rights of spectators" but "silencing dissent".

Windsor will be the biggest focal point for the weekend's events outside London. Big screens will be placed along the Long Walk, the 2.5-mile promenade through Windsor Great Park, on Saturday and 20,000 ticket holders will attend

the concert on Sunday. Hundreds of officers, including covert, firearms and search specialists, will police the occasion.

In a briefing to journalists, Bunt, who led the security operation in Windsor for the queen's funeral, said: "While the event in Windsor is very different in nature [to London], we've not had any groups or individuals showing interest in protesting in Windsor up to now, I'm also alive to the fact that we could get protest in Windsor over the weekend.

"My strategic objective is to provide a lawful and proportionate response to protest, balancing the rights of those who want to protest peacefully with those who want to lawfully go about their business and enjoy the events in Windsor. Thames Valley police respect the rights of those wanting to protest peacefully and legally, and we are experienced in doing so, and our response will be lawful and proportionate."

On using the new powers, he added: "Due

to the nature of the event, I will be adopting a lower tolerance level for any disruption, protest or otherwise; this includes action that undermines the safety of the event or poses a serious risk of disruption to the celebrations.

"We have a range of existing legislation we can use, while we also have at our disposal the new public order legislation passed this week."

But Liberty's policy and campaigns manager,

Emmanuelle Andrews, said: "The policing of the coronation across the country is shaping up to be a human rights nightmare. Protest is not a gift from the state; it's our fundamental right and should be respected as such.

"The police and the government have created a really hostile environment for protesters over the past few years, and everything we've seen around the coronation has added to that. Just this

week we've seen protest groups sent intimidatory letters, anti-protest laws rushed through, and plans for facial recognition to be deployed against millions of people.

"Comments like this on the policing of the coronation are going to discourage lots of people from feeling able to stand up for what they believe in. It's setting a really dangerous precedent for us as a supposedly democratic nation."

Patriotic stage is set for star-studded Castle concert

THE curtain has been lifted on the Union Jack-themed Coronation Concert stage that will showcase Britain's brilliance to a global audience of billions this weekend.

For the first time, the East Terrace of Windsor Castle will host a live concert. And the spectacular will be broadcast to more than 100 countries.

Sunday evening's show includes Take That, Olly Murs, Lionel Richie and Steve Winwood and will be attended by 20,000 invited members of the public.

Mocked-up photos reveal the stage design with multiple levels for the 74-piece orchestra and band.

Four additional catwalks branch out of the flag geometry from the stage into the crowd

to create more areas for performers and choreography.

The extravaganza will be hosted by actor Hugh Bonneville and is being broadcast across BBC television and radio stations.

It will be interspersed with pre-recorded sketches that reveal little-known facts about the monarch and will also include moments from Winnie the Pooh – seemingly echoing the famous moment Paddington Bear drank tea with the Queen during her Platinum Jubilee celebrations.

Other global stars invited by King Charles to perform live at the concert are music acts Katy Perry, Paloma Faith, Nicole Scherzinger of The Pussycat Dolls and Chinese pianist Lang Lang.

Additions include Nigerian singer Tiwa Savage and DJ Pete Tong with his Ibiza Classics project.

The classical world will be celebrated by The Royal Ballet, The Royal Opera, The Royal Shakespeare Company and The Royal College of Music.

Hollywood stars including Tom Cruise and Dame Joan Collins will join Bear Grylls and Sir Tom Jones in appearing via video message.

Singer Olly Murs said: "It's such an honour to be asked to perform for King Charles' Coronation concert at such an iconic castle."

Jury's verdict is sweet music to Sheeran's ears

■ New York court clears pop superstar of plagiarism charges

ED SHEERAN was left exultant this week after a New York jury exonerated him for copyright infringement, finding that he did not copy Marvin Gaye's 1973 song *Let's Get It On* for his 2014 track *Thinking Out Loud*.

"I feel like the truth was heard and the truth was believed," Sheeran said just after the verdict was read. "It's nice that we can both move on with our lives now - it's sad that it had to come to this."

He gave a longer statement to reporters outside the courthouse:

"I'm obviously very happy with the outcome of the case, and it looks like I'm not having to retire from my day job after all. But at the same time, I am unbelievably frustrated that baseless claims like this are allowed to go to court at all," he said, in part.

"We have spent the last eight years talking about two songs with dramatically different lyrics, melodies and four chords which are also different and used by songwriters every day, all over the world. These chords are common building blocks, which

were used to create music long before 'Let's Get It On' was written and will be used to make music long after we are all gone."

He explained that, as he saw it, the trial was about much more than his one song.

"If the jury had decided this matter the other way, we might as well say goodbye to the creative freedom of songwriters," Sheeran continued. "We need to be able to write our original music and engage in independent creation without worrying every step of the way that such creativity will be wrongly

called into question."

The heirs of Gaye's co-writer on the hit, Ed Townsend, had alleged in a 2017 lawsuit that Sheeran's song, which was co-written by Amy Wadge, had "overt common elements" and "striking similarities" to the classic, while Sheeran's team argued in a court filing that any similarities are a coincidence.

"The two songs share versions of a similar and

unprotectable chord progression that was freely available to all songwriters," Sheeran's team reportedly wrote.

The British hitmaker himself testified during the first week of the trial, saying that "most pop songs can fit over most pop songs." That squares with what he's said before, that "there's only so many notes and very few chords used in pop music." Sheeran himself has performed a

mashup of the two songs in concert.

During his testimony, Sheeran pulled out his guitar to demonstrate his songwriting process for his lawyer and the jury. He even sang part of his hit that's under fire. He also said he hadn't heard Gaye's classic until after he released "Thinking Out Loud." Instead, he testified, he drew inspiration from another rock legend, Van Morrison.

Royals cram in last minute rehearsals

The Royal Family geared up for King Charles's Coronation with a last-minute rehearsal at Westminster Abbey on Wednesday.

With just three days to go until the historic event, a host of senior royals arrived at the venue.

A smiling King Charles and Camilla led the way as they greeted the Dean of Westminster and other church officials before heading inside the historic abbey.

The Prince and Princess of Wales also attended with their children George, nine, Charlotte, eight, and five-year-old Louis, to ensure they know what will be expected of them on Coronation day.

George will have the special duty of being one of his grandfather's Pages of Honour.

He and three other youngsters will attend to the King on the day and carry his robes as he enters and leaves the abbey.

Both Charles and William were keen for George to play a big part in the ceremony, given that one day he too will become King and host his own Coronation.

Charlotte and young Louis have no official role but will form part of the royal congregation.

They are expected to sit in a prominent position with their mother Kate and will form part of the Coronation procession.

The youngsters will later appear on the Buckingham Palace balcony alongside other senior royals.

William will kneel before his father and vow to be his "liege man of life and limb" during the Coronation service in the only homage of royal blood in the ceremony.

He will also help clothe the King in a golden robe - known as the mantle - ahead of his crowning.

Camilla was joined at the rehearsal by her grandsons, who will act as her Pages of Honour. Her great-nephew will also

take on this role on the day.

Princess Anne headed to the abbey after visiting soldiers from the Household Division at Wellington Barracks, who will play a role in the military processions.

A separate full-scale Coronation rehearsal was held on Tuesday night with thousands of personnel from the Army, Navy and RAF marching from Buckingham Palace past Trafalgar Square and Downing Street to Westminster Abbey.

The Diamond Jubilee State Coach and Gold State Coach - which will be used by both the King and Queen during their processions to and from the abbey on Coronation day - were also driven down the Mall as part of the preparations shortly after midnight.

“Great to be home” - Trump jets into Scotland to open new golf course

Donald Trump celebrated his maternal roots as he jetted into the UK this week to promote one of his golf resorts.

Leaving behind a wealth of legal battles in the US, the 76-year-old former President waved and clenched his fist after his private Boeing 757-200 landed at Aberdeen on Sunday.

As bagpipes played, Mr Trump stepped on to a red carpet and shouted to film crews: “It’s great to be home. It’s the home of my mother.”

After arriving in a

bullet-proof 4x4 at his Trump International Scotland Course at the Menie Estate in Balmedie, he cut a red ribbon to mark breaking ground on a “spectacular” second course.

He has named it MacLeod, after his mother, Mary Anne MacLeod.

Mary was born on the isle of Lewis, in the Outer Hebrides, before emigrating to the US.

Mr Trump said: “This project is very close to my heart and I am delighted to say that this is our first day of work on the new

course.

“It will be dedicated to my late mother and that is a source of great pride to me and my family.

“My mother was an incredible woman who loved Scotland.

“She returned here every year and she loved the Queen. I got to know the Queen too during my visits here. I love Scotland just as much.”

Mr Trump’s officials have not revealed how long he will stay but he did visit his other luxury Scottish course at Turnberry, South Ayrshire, on Wednesday.

‘I always wanted to work with children,’ accused baby killer Letby tells court

Lucy Letby told jurors this week she had dreamed of being a nurse and of working “with children” since secondary school.

The woman accused of the murder of multiple babies in a neo-natal unit started her defence evidence by explaining how she grew up in Hereford and “went to school locally”.

Asked when she first wanted to be a nurse, she said: “I have always wanted to work with children.” She told the court she chose A-levels “which would best support that career”.

Letby said she studied for a nursing degree at

Chester University with most work placements at the Countess of Chester Hospital children’s ward or its neo-natal unit. She became a Band 5 nurse in 2011. She said: “I always strived to go on every course possible to be the best I could.” She qualified to work with intensive care babies in 2015.

Her barrister Ben Myers asked: “Over the period of 2015 and 2016 we are looking at and the babies on this indictment, could you put a figure on the number of babies you cared for?”

Letby said: “It would be hundreds.”

He asked: “Did you care for them?” She

replied: “Yes. I only ever did my best.” Asked if she ever wanted to hurt any, she said: “No, that’s completely against being what a nurse is.”

Mr Myers went on: “How much did you value being a nurse?” She told him: “It was everything.”

He asked some quickfire questions related to the charges: “Have you ever tried to kill any baby you cared for?” Letby replied to him: “No.”

“Have you ever intentionally harmed or tried to intentionally harm any babies as alleged?” She said: “No, never.”

She denies all charges. The trial continues.

“wicked stepmother”.

But a royal source said: “William feels entirely differently to his brother on these matters.

“His speech will be heartfelt and loving, paying tribute to his father as a man of principle who has also devoted himself to duty and to the causes he believes in. The Prince also feels it is important to pay tribute to how Camilla has dedicated

herself to causes and has made a real difference to many in her royal role and also contributing to his father’s happiness.”

On her Platinum Jubilee anniversary last February, Queen Elizabeth declared her “sincere wish” that Camilla be known as Queen Consort. But it was confirmed earlier this month that she would be crowned Queen.

Sources say Harry has already told King Charles he will not linger during the weekend, but will rush home to California

and belatedly celebrate son Prince Archie’s fourth birthday, which also takes place on Saturday.

The Duke may even use the eight-hour time difference to jet back to his mansion in Montecito immediately after the ceremony.

His wife Meghan, 41, is staying in the US with Archie and his sister Princess Lilibet, one.

NOW ON SAIL: Tall ship offering slow passage across Channel

A 104-year-old pirate-looking ship will see a passenger service return to a Kent port for the first time in a decade.

The Morgenster is a historic 48m tall sail training ship which will soon be taking passengers across the North Sea from Ramsgate on a "pioneer trip" travelling almost entirely by sail.

The vessel set sail for the first time on the route on May 1st and future crossings are "quite likely" after 10 years without ferry crossings at the port.

Karel De Boer is the founder of Fair Ferry,

which is organizing the trip and is investigating whether the ferry service between Ramsgate and Ostend in Belgium can be resumed permanently by sailing this route with passengers.

He told KentOnline: "A lot of people have wanted to book with us and we are almost fully booked. "We are already thinking about next year."

The huge ship, which was built in 1919, will dock on a floating jetty close to the lifeboat station.

The 44-year-old chose the Port of Ramsgate for its "historic qualities"

and because "it's been 10 years from the last ferry crossing there, so it seemed like a good time to see if we could bring it back".

The Morgenster - meaning Morning Star in Dutch - was originally built as a herring lugger before being converted into a motor fishing vessel in 1927.

After a period of use for sport fishing and hosting pirate radio stations, she was converted back to a sailing vessel in 1983.

She made her maiden voyage as a sail training ship in 2008.

The trip will take

about four days and is described as a "mini cruise", however it is not the luxurious laid-back trip people may be used to.

Mr De Boer explained: "People who come on the boat will have the opportunity to help sail it and even steer the boat.

"It's not mandatory,

but we try to encourage people to take part in the sailing as much as we can.

"It is a training crew and they will get everybody involved with the sailing."

And while the interior of the boat is basic and designed for sailing, Mr De Boer assures

"everything is there".

"It's not a luxurious ship - it has two-person cabins and four-person cabins with shared showers.

"There is a lounge and eating area too.

"Everything is there but it's not a luxurious cruise - it's an expert sailing holiday."

Specialists rocked by stunning Wales fossil find

ONE of the world's most important fossil deposits has been found in Wales, experts have revealed.

More than 170 species were discovered in rocks from 460 million years ago - at a time when the area was covered by an ocean.

Museum Wales researchers found the fossils near Llandrindod Wells, in Powys, at a secret location on private

land known as Castle Bank.

Llandrindod residents Dr Joseph Botting and Dr Lucy Muir were behind the discovery.

They said the find is important because it gives a new insight into how life was evolving at the time.

The Castle Bank fossils include the youngest known examples of some unusual groups of extinct

animals, including the water bear-like opabinia and wiwaxias, strange oval-shaped molluscs.

The newly-discovered pieces also include many different types of worms, sponges, barnacles, starfish and a primitive horseshoe crab.

Very fine details can be seen on many of the fossils under the microscope, including eyes and possible primitive brains.

New Leeds United manager Sam Allardyce has said he is “up there” with any manager in the Premier League including Manchester City boss Pep Guardiola and Liverpool’s Jurgen Klopp.

Allardyce (above), who replaced Javi Gracia this week, said he may look “antiquated” but is the equal of any manager in the league.

“I’m 68 but there’s nobody ahead of me in football terms. Not Pep, not Klopp, not [Mikel] Arteta,” he said.

Allardyce’s task is to

keep Leeds in the Premier League.

With four games remaining, they are only outside the relegation places on goal difference and face a daunting run-in with fixtures against Manchester City, Newcastle United, West Ham and Tottenham to come.

HISTORY-MAKING HAALAND

■ City marksman breaks EPL single season scoring record

Manchester City striker Erling Haaland has broken the record for most goals in a Premier League season.

The Norwegian scored his 35th league goal of the campaign on Wednesday night against West Ham to move past Alan Shearer and Andrew Cole's previous best of 34.

Haaland had already set a record for a 38-game season, beating Mohamed Salah's 32 goals for Liverpool in 2017-18.

"It's a special night and a special moment. I'm really happy and proud," Haaland told Sky Sports. The 22-year-old has another five games to add to his tally.

"It feels amazing and I'm really happy and I'm also happy for the three points," he told BBC Match of the Day. "In the end that's what matters

and I'm happy.

"Yeah, it's going well and now it's time to focus on game by game. I've said this for a long time and that's what the team is doing. The team is so good and I'm happy."

Haaland's 35th top-flight goal of the season came via a deft finish in the second half of a 3-0 win against the Hammers that sent City back to the top of the league.

He was given a guard of honour by his teammates, boss Pep Guardiola and the club's backroom staff after the final whistle at Etihad Stadium.

"I've not seen it before either," Haaland added. "It was a nice feeling scoring that goal, it always is.

"It was painful when everyone hit me on the back in the guard of honour."

Cole's 34 goals for Newcastle in 1993-94 were matched by Shearer as he fired Blackburn to the title the following year but there were 22 teams in the top flight in both seasons, giving them an extra four matches to play - Shearer started all 42 in his record season, while Cole missed two in his.

Haaland, in his debut season in English football, has set the new marker in just his 31st game of the year.

His 35 goals are also the most by a player in a single campaign in the English top division since Ron Davies scored 37 for Southampton in 1966-67. Dixie Dean holds the record with 60 in 39 games for Everton in 1927-28.

Manchester City manager Pep Guardiola said: "Incredible. He's

just 22 - and still has five games left. How many games I made the substitution after a hat-trick in 60 minutes, maybe he'd have scored more. But maybe he'd have got injured. He's special. Congratulations to him.

"We expected him to score goals but to break Cole and Shearer records ... I'm pretty sure what he wants is to win the Premier League.

"It's unbelievable. How many important goals he's scored to win games,

we are so satisfied.

"He's a unique person and he's so special. He deserved the guard of honour because it's an incredible milestone. Another day he might break his own record. He's scored a lot of goals!"

Alexis MacAllister converted deep into injury time to settle a Premier League thriller at Amex Stadium.

United - in the fourth and final Champions League qualification spot - stay four points ahead of fifth-placed Liverpool, but now have only one game in hand.

And Brighton deserved this victory for a relentless approach that finally gave them the breakthrough seconds from the end after Luke Shaw handled, the penalty awarded after
