William pays emotional tribute to his father

■ 20,000 strong crowd flock to Windsor Castle for Coronation Concert

The Prince of Wales has paid an emotional tribute to his father on behalf of the nation – and said he knew the late Queen would be “fondly keeping an eye on us”.

William, 40, told King Charles: “Pa, we are all so proud of you.”

The King, 74, who joined a large group of his family in the royal box, looked deeply touched by his elder son’s speech during the Coronation Concert at Windsor Castle on Sunday night

William praised the King’s work and commitment to duty towards the end of the show, watched by a 20,000-strong crowd and a worldwide television audience.

It came a day after a historic and deeply religious Coronation service in which William kissed his father’s cheek. It was a ceremony widely praised for showcasing the best of

modern Britain as well as its traditions.

William said: “I want to say a few words about my father, and why I believe this weekend is so important.”

Joking about one of the biggest hits of Lionel Richie, one of the concert’s stars, he added: “But don’t worry, unlike Lionel, I won’t go on all night long. As my grandmother said when she was crowned, coronations are a declaration of our hopes for the future. And I know she’s up there, fondly keeping an eye on us. She would be a proud mother.”

“For all that celebrations are magnificent, at the heart of the pageantry is a simple message. Service. My father’s first words on entering Westminster Abbey yesterday were a pledge of service.

“It was a pledge to continue to serve. Because for over 50 years, in every corner

of the UK, across the Commonwealth and around the world, he has dedicated himself to serve others, both current and future generations, and those whose memory must not be neglected.

“Take the natural world. He warned us of the risks to our planet’s health long before it was an everyday issue.

“Or the Prince’s Trust. It has supported over a million young people, many from disadvantaged backgrounds, to realise their ambitions.

“And, perhaps most importantly of all, my father has always understood that people of all faiths, all backgrounds, and all communities, deserve to be celebrated and supported.”

The Prince, who with his wife Kate will take on much of the burden of responsibility as the King and Queen get older, also pledged his

own life to serving the nation.

He said: “I also want to express my pride and gratitude for the millions of people who serve – in the forces, in classrooms, hospital wards and local communities. I wish I could mention you all.

“Your service inspires us all. And tonight we celebrate you too. I commit myself to serve you all.

“King, country and Commonwealth. God

save the King!”

The appearance of pop legend Lionel Richie prompted a royal sing-a-long during his rendition of classic hit Easy.

The star’s performance also sparked huge applause and even a dance from the King and Queen.

The Duke and Duchess of Edinburgh were also seen dancing to the legend’s music.

Prince George jumped and waved his flag

alongside his sister Charlotte during a performance of another of Richie’s smash hits, All Night Long.

As William concluded his message, “God save the King” was repeated loudly by the thousands in attendance.

The speech was followed by the national anthem, which was sung by all present. The King smiled and waved to the crowd at the end of the anthem.

King raises a toast to absent grandson

THE King offered an olive branch to the Duke and Duchess of Sussex by raising a toast to Prince Archie to celebrate him turning four on the day of the Coronation, according to one account.

Charles is said to have made the gesture at Buckingham Palace on Saturday during a family lunch.

Prince Harry, 38, was reportedly offered the chance to join him at the Palace, but instead headed home in time to celebrate his son Archie’s birthday in the US after a swift exit from the

Coronation ceremony at Westminster Abbey.

The majority of the Royal Family were said to have “breathed a sigh of relief” that Harry had not joined them for the lunch.

But the King, 74, seemed “genuinely quite disappointed that he didn’t stay,” one source reportedly said.

Prince William, 40, congratulated his father before they started the buffet. The King raised a glass to his three grandchildren present: Prince George, who was a Page of Honour, along with Princess Charlotte

and Prince Louis, who were also at the Abbey ceremony.

But he also toasted “those that weren’t there” and wished his other grandson Archie a happy fourth birthday “wherever he was”. The source said: “It was apparently a very sweet moment.”

The King, Queen and members of the Royal Family were joined by Camilla’s close family and by the Princess of Wales’s parents Michael and Carole Middleton and siblings Pippa and James.

“Too white” comment prompts uproar

A TELEVISED comment by Bridgerton star Adjoa Andoh about the Buckingham Palace balcony being too white has become the most complained about moment of 2023 so far, Ofcom has said.

Almost 4,200 complaints have been filed about the remark, with the regulatory body, which Ofcom oversees the TV, radio and video-on-demand sectors as well as fixed line telecoms, mobiles and postal services.

The remarks were made when the actress, 60, appeared on ITV's live coverage of Saturday's coronation celebrations.

Ms Andoh plays Lady Agatha Danbury in the Netflix show, which centers around a fictionalized London high society set in the Regency period.

Commenting during the Coronation, she said: “Looking at all those young people, there is a bit of me that has gone from the rich diversity of the Abbey to the terribly white balcony. I’m very struck by that.”

The former Casualty and EastEnders star acknowledged the backlash she received after appearing as a pundit. Ms Andoh told radio host Paddy O’Connell: “I think I upset a few people.

“I was talking about the day and how marvellous it was and then looking at the balcony at the end and suddenly went, ‘Oh, it’s so white’ because the day had been so, so mixed and I didn’t mean to upset anybody.”

On Wednesday, Ofcom said the comment received 4,165 complaints, making it the most complained about moment of the year.

Piers Morgan ‘stole Prince’s bank details’ court told

Phone hacking trial points finger at former Mirror editor

Piers Morgan authorised the illegal blagging of a prince’s private bank details when he was editor of the Daily Mirror, it has been alleged at the high court.

Prince Michael of Kent’s personal financial records were published by the Mirror in 1999, allegedly revealing that Queen Elizabeth II’s cousin was millions of pounds in debt and had an unauthorised £220,000 overdraft at Coutts bank.

When the prince’s lawyers complained to Morgan that the story was inaccurate and the records must have been obtained illegally, Morgan dismissed their “poor and thinly disguised threat” and insisted the information had come from an “impeccable source”.

In reality, the Mirror obtained the information after employing private investigators to pose as the prince’s accountant, phone the bank and illegally “blag” his account details, the court heard on Thursday.

Before the article was published, two hoax calls were made to Coutts seeking to confirm the prince’s bank account number. The Mirror’s publisher later settled a legal claim from Prince Michael and issued an apology to him.

David Sherborne, representing claimants in the phone-hacking trial against Mirror Group Newspapers, said the incident pointed to a culture of widespread illegality and cover-ups at the highest level of the company. The barrister said it was “inconceivable the legal department and Mr Morgan were not

aware of the source of this story”.

The high court also heard claims that:

Morgan “lies at the heart” of allegations of unlawful information-gathering, including phone hacking, under the Mirror’s parent company and was “directly” involved in illegal behaviour.

The journalist who helped obtain Prince Michael of Kent’s financial records was Gary Jones, now the editor of the Daily Express.

The Mirror regularly used the services of Southern Investigations, a private investigations agency heavily implicated in police corruption and the murder of its former employee Daniel Morgan.

Phone hacking was so widespread at the Daily Mirror, Sunday Mirror and People that even those newspapers’ editors were illegally accessing voicemails.

The claims were made on the second day of the Mirror group’s phone-hacking trial, in which more than 100 alleged phone hacking victims are bringing cases against the publisher. Four individuals have had their claims chosen as test cases, including Prince Harry, and will give evidence in court next month.

Sherborne, the claimants’ barrister, told the court there was widespread illegal behaviour at every level of the organisation. “Mr Morgan lies right at the heart of this in a number of ways. He was a very hands-on editor, also very closely connected to the board ... We have the direct involvement of Mr Morgan in a number of these incidents and his

knowledge of voicemail interception,” he said.

On the opening day of the trial MGN, publisher of The Mirror, Sunday Mirror and The People, who contesting some of the claims and say some have been brought too late, did however offer an apology to some of the

plaintiffs

A spokesperson said: “Where historical wrongdoing has taken place we have made admissions, take full responsibility and apologise unreservedly, but we will vigorously defend against allegations of wrongdoing where our

journalists acted lawfully. MGN is now part of a very different company.

“We are committed to acting with integrity and our objective in this trial is to allow the business and journalists to move forward from events that took place many years ago.”

We cannot lose Newcastle match, Sam warns Leeds

Sam Allardyce has warned his Leeds players they cannot afford to lose Saturday's clash with his former club Newcastle, and has challenged his squad to use the fear of relegation to spur them to safety in their final three games of the season.

Leeds, who are second-bottom and two points shy of safety, host Newcastle at lunchtime before facing West Ham away and Tottenham at home. Allardyce said his goal was to get to the final day still in with a chance of survival after losing to Manchester City in his first game as head coach last week.

He believes a positive result on Saturday is vital. "To give ourselves

the best chance we've got to try and get a point on the board but more importantly three if we can," he said. "But I have said to the players and I will say it now: 'When we come off the field on Saturday, we can't afford to lose.'

"We must get something. The biggest thing that can happen on Saturday is that we don't lose. Then we've got a point on the board. I want to still be in it when we play Tottenham. But the fear of relegation needs to drive them on. The fear of losing their Premier League status should make them fight hard."

Allardyce said his claim last week that he was "up there" with Pep

Toon win 'will boost Gunners'

The "mental approach" of Arsenal's side will be boosted by results such as a crucial win over Newcastle, says former Premier League defender Steve Brown.

The 2-0 win this week over the Magpies has kept the Gunners within touching distance of Manchester City in the title race.

Speaking on BBC Radio London's The Far Post podcast, Brown said: "I think what they did up there deserves more credit than what it probably gets because that is one of the toughest fixtures away along with Man City.

"When you look at

the statistics from that game, Newcastle gave as good as they got and were actually ahead in a number of the stats, so in terms of looking at Arsenal there was a resilience there that perhaps wasn't there in the draws they have had.

"It was really important for them as a team that they got back to that. It was a massive win and a clean sheet up at St James' Park is really hard to do."

It was in this fixture last season that Arsenal's hunt for a top-four place was effectively ended and the victory showed they had learnt from that experience.

Guardiola and Jürgen Klopp was a tactic to take the pressure off his players, but avoided a repeat on Thursday.

He said: "All those who criticized me sounded a bit thick when all I was doing was diversifying off the players on to myself, which was a great tactic that I picked up from Alex Ferguson. So there was no pressure on the players because I took it all - I took all the stick. But there's none of that this week. It's simply focusing on Newcastle."

City on a Real knife edge

■ Champions League: honors even after De Bruyne secures 1-1 tie at the Bernabeu

Kevin de Bruyne's screamer on Wednesday night earned Manchester City a Champions League semi-final first-leg draw at Real Madrid to keep their dream of the Treble on track.

City know any win next Wednesday at home against Madrid will send them to only their second Champions League final, against either Inter Milan or AC Milan.

Pep Guardiola's side dominated the early stages at a nervy Bernabeu, with Thibaut Courtois denying De Bruyne, Rodri and Erling Haaland twice.

But Vinicius Jr scored with Real's only chance of the first half, a 25-yard thunderbolt which flew past Ederson following a brilliant run by Eduardo Camavinga.

Just as Real began to dominate a period of the second half, City found a way back with De Bruyne fizzing a shot from a similar distance into the bottom corner.

Aurelien Tchouameni

almost gave Real, looking to extend their record tally to 15 European crowns, the lead again with another strike from range but it was well saved by Ederson.

City are now unbeaten in 21 games in all competitions, a run which includes 17 wins. Seven more victories and they get the Treble (winners of league, FA Cup and Champions League titles).

The Champions League is the one that has been missing for City and they are arguably the best European team of the current era never to win it.

It sounds so simple, but they just need to beat Real, who are third in La Liga, at home and then either the team fourth or fifth in Italy's Serie A in the final in Istanbul. Milan face Inter on Wednesday.

Not that Guardiola will let his players get carried away with that scenario.

They lead the Premier League from Arsenal with four games to go and face Manchester United, the only English team to win

the Treble, in the FA Cup final in June.

Talk before the game was of revenge, with Real beating City at this stage last season in a 6-5 aggregate classic.

But, a year on, City look more grown up and almost unbeatable. This game was edgy and heated but lacked some of the chaos of last season's first leg, which ended 4-3.

Guardiola knows his best team now so the days of throwing a tactical shock, which often did not work, in a game like this seem a thing of the past.

They played this game as if they were at home, with Real supporters booing their relentless possession. Courtois had four saves to make in the opening 16 minutes alone.

But then they trailed to Vinicius' goal - with the Brazilian also scoring against City last year.

However their heads did not drop, and their three-month unbeaten run continues thanks to De Bruyne.

Ilkay Gundogan laid the ball off for De Bruyne, who thrashed a shot past his Belgium teammate Courtois. Having also netted in 2020, De

Bruyne is the first player in Champions League history to score in separate away games against Real in the knockout stages.

City - who did not make

any substitutions - never had a chance to win the game, with that their last shot. Next week they will hope to see 51-goal Haaland get more joy in front of goal.
