# BORIS: THE PARTY'S OVER

■ Former prime minister found to have deliberately misled Parliament over lockdown parties

**BORIS JOHNSON'S colorful career in British politics has come to an inglorious end.**

Following his decision to stand down as an MP last Friday, this week saw a damning report from the Privileges Committee, which said the former PM had committed repeated offences with his denials over lockdown parties the height of Covid.

Mr Johnson - who helped the Conservative Party win a landslide election victory under his leadership only three years ago - is the first former prime minister to have been found to have deliberately misled Parliament.

Johnson would have faced a 90-day suspension if he were still an MP.

### 'deranged'

In a damning report, the Privileges Committee said the former PM had committed repeated offences with his Partygate denials.

But in typical fashion Johnson remained defiant, describing the Committee's conclusions as "deranged".

In a blistering statement, he branded the committee a "kangaroo court" and claimed its year-long inquiry had delivered "what is intended to be the final knife-thrust in a protracted political assassination".

It has been confirmed a by-election to replace him in his Uxbridge and South

Ruislip constituency will take place on 20 July.

On the same day, voters will also elect a replacement for Johnson ally Nigel Adams, who also stood down as MP for Selby and Ainsty in the wake of the former PM's resignation.

The seven-person committee, chaired by Labour's Harriet Harman but with a Tory majority, has been considering whether Mr Johnson misled MPs about Covid breaches in Downing Street during the pandemic.

When giving evidence to the committee in March, Mr Johnson staunchly denied misleading Parliament on purpose, in a stormy session.

But in its lengthy report, which runs to 106 pages, the committee concluded that Mr Johnson's "personal knowledge of breaches", combined with "his repeated failures pro-actively to investigate" them, amounted to "a deliberate closing of his mind" to the facts.

### 'contempt'

The committee focused on six gatherings between May 2020 and January 2021, and statements Mr Johnson made to Parliament about them.

The committee concluded that officials did not advise Mr Johnson

that social-distancing guidelines had been followed at all times, despite him making the claim in the House of Commons.

In key evidence, one of Mr Johnson's most senior officials, Martin Reynolds, said he advised the former prime minister against making the claim, questioning whether it was "realistic".

Some of Mr Johnson's denials, the committee added, were "so disingenuous that they were by their very nature deliberate attempts to mislead".

They amounted to a "contempt" of Parliament, the MPs added, because they stopped Parliament carrying out its "essential task" of holding him to account.

Explaining their recommendation for a 90-day suspension, they found that he had also committed a repeated contempt by:

- Deliberately misleading MPs on the Privileges Committee while they were investigating him

- Referring to the committee's findings before they were published, in his resignation statement last week

- "Impugning the committee" in his criticism of it, and being complicit

in a "campaign of abuse" against its members

The committee has also recommended that Mr Johnson should be stripped of the pass given to former MPs allowing them access to Parliament.

Two of the committee's MPs, the SNP's Allan Dorans and Labour's Yvonne Fovargue, wanted to go further and expel him from the Commons - but were outvoted by the committee's four Tory MPs.

### 'overreached'

The report will be debated by MPs, with a vote held on whether to approve the findings on Monday.

MPs are expected to approve the report, after Commons leader Penny Mordaunt said Tory MPs would not be ordered to vote against it.

So far, only a handful of Conservative MPs have openly criticised the report, including Johnson loyalist and former culture secretary, Nadine Dorries.

In a tweet, Ms Dorries claimed the report had "overreached" and said any Tory MP who voted to approve it was "fundamentally not a Conservative".

Other Tory MPs supportive of Mr Johnson hit out at the findings, with Jacob Rees Mogg saying the committee looked "foolish" and Simon Clarke adding the report was "absolutely extraordinary to the point of sheer vindictiveness".

But Labour's deputy leader, Angela Rayner, said the committee had "gone off the evidence" to reach "a very damning conclusion".

She said Mr Johnson

was a "disgraced prime minister" who "shouldn't be anywhere near Parliament".

The Liberal Democrats have called for Mr Johnson to be stripped of the £115,000 annual allowance available to former prime ministers to run their office.

"This damning report should be the final nail in the coffin for Boris Johnson's political career," the party's deputy leader, Daisy Cooper, said.

A campaign group representing families bereaved by Covid said he should "never be allowed to stand for any form of public office again".

The committee's report was met with disdain by Mr Johnson, who warned the committee was driven by "the sole political objective of finding me guilty and expelling me from Parliament".

# Top Tories fall out over gongs

■ Sunak and Johnson at odds as PM refuses to rubber stamp honors for BoJo's toadies and cronies

A war of words has erupted between Rishi Sunak and Boris Johnson over the former prime minister's attempt to give peerages to several close allies.

Mr Sunak accused his former boss of asking him to "overrule" the vetting advice on his House of Lords nominations.

But in a fiery statement, Mr Johnson accused Mr Sunak of "talking rubbish".

The House of Lords Appointments Commission (HOLAC) said it rejected eight of Mr Johnson's nominations.

There has been no confirmation of who the nominees were, and why they were not included on Mr Johnson's controversial resignation honours list.

A Cabinet Office spokesperson said HOLAC did not support the peerage nominations of the MPs put forward by Mr Johnson.

The honours list was published by Mr Sunak's government on Friday, without the names of some of Mr Johnson's key supporters, including

Conservative MPs Nadine Dorries and Nigel Adams.

A few hours after his honours list was released, Mr Johnson announced he was standing down as an MP over an investigation into whether he had misled Parliament about lockdown parties.

Competing claims have now surfaced about how and why the names would not have appeared on the list.

## public spat

Mr Adams and Ms Dorries have both announced they would immediately standing down as MPs, triggering by-elections to replace them.

Earlier, the row over the nominations spilled into a public spat between Mr Johnson and Mr Sunak.

Speaking at a tech conference in London earlier, Mr Sunak claimed Mr Johnson had asked him to do "something I wasn't prepared to do" on peerage nominations.

"I didn't think that was right. And if people don't like that, then tough," Mr Sunak said.

A few hours later, Mr

Johnson claimed it "was not necessary to overrule HOLAC - but simply to ask them to renew their vetting, which was a mere formality".

Mr Sunak's comments are the first made publicly about the dispute over peerages, and marks a heightening of tensions between the two.

Their relationship has been an uneasy one after Mr Sunak quit as chancellor in Mr Johnson's government, setting off a wave of resignations that brought down his premiership.

The process of vetting Mr Johnson's nominees for peerages appears to be the one of the points of disagreement between the former allies.

## 'weasel words'

There has been speculation in media reports about what would happen if a serving MP was nominated for a peerage, and whether they could remain in the House of Commons until the next general election, before taking up their seats in the Lords.

But HOLAC says its

vetting checks expire after six months, meaning its advice on nominations is only valid for that period.

In an interview with TalkTV, Ms Dorries claimed Downing Street had not been "telling the truth" about her nomination for a peerage.

Ms Dorries said Mr Johnson had told her in autumn last year she had been put on his resignation honours list.

Ms Dorries accused the prime minister of using "weasel words" to give Mr Johnson the impression Mr Sunak would ask HOLAC to restart the vetting process.

She said Mr Sunak used those words because he "knew a situation had been engineered" in which her name would not be on the list.

When asked who she believed had stopped her

from entering the House of Lords, she replied: "The prime minister - Rishi Sunak."

Following her interview, the Cabinet Office said it would be "unprecedented for a sitting prime minister to invite HOLAC to reconsider the vetting of individual nominees on a former prime minister's resignation list.

"It is not therefore a formality."

## Scot cops catch and release Sturgeon

Nicola Sturgeon has been released without charge pending further investigations after being arrested by police investigating the SNP's finances.

It was the latest remarkable twist in Police Scotland's ongoing Operation Branchform inquiry.

The former first minister was taken into custody and questioned by detectives at a police station after she attended voluntarily shortly after 10:00 on Sunday.

Officers had up to 12 hours from the time Ms Sturgeon was arrested before they had to decide whether to charge her with a crime or release her while their inquiries continue.

In the end, she was released from custody at about 17:25 on the same day - well before the deadline expired and just over seven hours since her arrest.

Shortly afterwards, she published a statement on Twitter saying that she knew "beyond doubt

that I am innocent of any wrongdoing".

She also said she would "never do anything to harm either the SNP or the country" and that the situation she had found herself in earlier in the day was "both a shock and deeply distressing".

Despite her release, police have said the case remains active for the purposes of the Contempt of Court Act 1981.

## complaints

It means everyone has to be careful about what they say to avoid potentially prejudicing any future trial.

The police investigation into this case began almost two years ago when complaints were made relating to more than £660,000 that was donated to the SNP by activists.

The money was raised after the party sought funds for a future referendum campaign, and Police Scotland launched Operation Branchform to examine what happened to it.

Earlier this year, officers sent an initial report seeking advice and guidance from the body which prosecutes crimes in Scotland, the Crown Office and Procurator Fiscal Service (COPFS).

That advice was provided and the investigation continued.

Ultimately, the detectives will send what is called a standard prosecution report to COPFS.

Prosecutors will then consider whether there is sufficient evidence to suggest a crime was committed and the suspect was responsible.

They will take the public interest into account. That can be influenced by the particular circumstances of the case - for example, whether the person involved was in a position of trust or authority.

If they feel the evidence meets the necessary tests, the case will go to court.

Alternatively, COPFS can instruct the police to carry out further inquiries if they decide there is insufficient evidence.

# Glenda Jackson exits stage at 87

■ Liverpool-born actress won two Oscars, three Emmys, two Baftas and a Tony before switching to politics

Glenda Jackson, widely regarded as one of the greatest thespians Britain has produced, has died aged 87.

Ms Jackson, who won two best actress Oscars for *Women in Love* and *A Touch of Class*, also collected three Emmys, two Baftas and a Tony in an acting career which spanned six decades.

Sir Jonathan Pryce said he believed she was "the greatest actor that this country has ever produced".

Jackson gave up acting to join the House of Commons as a Labour MP in north London from 1992 to 2015.

That included two years as a junior transport minister in Tony Blair's New Labour government from 1997.

She later returned to acting, playing King Lear on stage in 2016, then winning a Bafta for her screen comeback in the TV drama *Elizabeth Is Missing* in 2020.

## 'amazing actress'

In a statement on Thursday, her agent Lionel Lerner said: "Glenda Jackson, two-time Academy Award-winning actress and politician, died peacefully at her home in Blackheath, London this morning after a brief illness with her family at her side."

Other tributes were paid from across the worlds of the arts and politics.

Labour MP Tulip Siddiq, who now sits in Jackson's former seat, **tweeted**: "Devastated to hear that my predecessor Glenda Jackson has died."

"A formidable politician, an amazing actress and a very supportive mentor to me. Hampstead and Kilburn will miss you Glenda."

But although her craft

was universally admired, her flinty edge was never far below the surface, and she had scant patience for the usual foibles and pretensions of her profession.

"I regard acting," she once said, "as a serious job for serious-minded people."

Famously prickly, her view of Tinseltown often bordered on contempt. "If I'm too strong for some people," she said, "that's their problem".

Glenda May Jackson was born on 9 May 1936 in Birkenhead, in Wirral, the daughter of a bricklayer.

She attended the local grammar school, leaving at 16 to work at Boots.

Bored, she joined a YMCA drama group. "I had no real ambition about acting," she later recalled. "But I knew there had to be something better than the bloody chemist's shop."

Two years later, she won a scholarship to the Royal Academy of Dramatic Art (RADA).

It was, according to one reviewer, her "intense, sexually-charged talent" that won her a place at the prestigious academy.

She made an impression while still at RADA, when she appeared in a production of Terence

Rattigan's *Separate Tables*.

By 1963 she had married actor and art dealer Roy Hodges. The couple had a son, Dan, who is a noted political commentator.

She joined the Royal Shakespeare Company (RSC) in 1964. A year later, her big breakthrough came in Peter Brook's stage production of *Marat/Sade*.

Jackson played the lunatic asylum inmate who finds herself acting the role of Charlotte Corday, the assassin of the French revolutionary, Jean Marat.

In 1969, she won her first Oscar, for best actress, in Ken Russell's adaptation of the DH Lawrence novel, *Women in Love*.

The beautifully shot film became notorious for its nude scenes which, Jackson later recalled, she played with "a prevailing sense of coldness".

## intensity

Her co-star Oliver Reed - hardly a shrinking violet himself - memorably described acting alongside her as like "being run over by a Bedford truck".

In 1971, having appeared as Elizabeth I in the historically dubious film, *Mary, Queen of Scots*, she reprised the role in BBC TV's *Elizabeth R*.

The six-part series saw her play the Virgin Queen from princess to ailing old woman.

Jackson played the part with her customary intensity, even shaving her hair to accommodate the make-up required as her character aged.

She was now firmly established as one of the world's foremost dramatic actresses. She responded by sending herself up.

In 1971, she made her first appearance on the *Morecambe and Wise Show* - playing a comedy Cleopatra.

"All men are fools," she declared with a flourish, "and what makes them so is not having beauty like what I have got." The audience loved it, and Hollywood took note.

Soon she found herself cast opposite George Segal in a romantic comedy, *A Touch of Class*.

Jackson plays a British divorcee who has an affair with a married American, and falls in love. Her classy,

understated performance won her a second Oscar.

"Stick with us," cabled Morecambe, "and we will get you another one". But - as with her previous Academy Award - she refused to go to Hollywood to pick up the statuette.

"You don't do a play to compete for an award," she explained. "I didn't win them. They were given to me."

At the age of 56, Jackson announced she was quitting acting - to stand as a Labour parliamentary candidate in the 1992 general election.

"The best theatre is trying to tell the truth," she said. "And the best politics is trying to tell the truth."

In an otherwise miserable election for her party, she won a notable victory in Hampstead and Highgate, which had been a Conservative seat for two decades.

When Labour came to power in 1997, Jackson

became a junior minister with responsibility for London Transport.

She resigned two years later, to make a bid to become Labour's candidate for the London mayor, but was defeated by Frank Dobson.

## controversial

A left-winger by inclination, she became a fierce critic of Tony Blair's New Labour project and spoke out against the invasion of Iraq.

In 2005, she threatened to stand against Blair for the party leadership unless he announced his intention to stand down.

But the most controversial moment in her political career came in April 2013, when Parliament was recalled to pay tribute to the former prime minister, Margaret Thatcher.

Lady Thatcher had just died. But Jackson saw no reason to rein in her criticism of a woman she

# Nottingham left shaken by senseless triple murder

■ Two students and a site manager killed by mentally ill man in horror knife attack

The city of Nottingham has been shaken by a series of attacks which left two teenage students and another man dead.

Barnaby Webber, 19, Grace O'Malley-Kumar, 19, and Ian Coates, 65, were fatally stabbed. Three people were later hit by a van police believe was stolen from the older stabbing victim.

A suspect was Tasered by police before being arrested on suspicion of murder.

Counter-terrorism police are involved in the investigation, but no link to extremism has been confirmed.

Police said they were still in the early stages of the inquiry into the attacks, which occurred during the early hours of Tuesday, and had yet to determine an exact motive.

The BBC has been told by official sources the 31-year-old suspect was originally from West

Africa but had been in the UK for "many years" and had settled status.

It is also understood the man has a history of mental health issues.

He did not have a criminal record, they added.

Several roads in Nottingham were closed throughout the day as police combed for evidence, and armed officers were seen on the city's streets.

## 'devastated'

Nottingham City Council leader David Mellen said the city was in "shock and mourning", while the city's three MPs said the area had been "devastated" by the bloodshed.

In a statement, Mr Webber's - from Taunton in Somerset - said: "Complete devastation is not enough to describe our pain and loss at the senseless murder of our son.

"At 19 he was just at the start of his journey into adulthood and was developing into a wonderful young man.

"As parents we are enormously proud of everything he achieved and all the plans he had made.

"His brother is bereft beyond belief, and at this time we ask for privacy as a family to be allowed time to process and grieve."

Grace O'Malley-Kumar has been named locally as the second victim and a talented sportswoman.

England Hockey said it was "deeply saddened" by Ms O'Malley-Kumar's death.

"Grace was a popular member of the England U16 and U18 squads and our thoughts are with Grace's family, friends, teammates and the whole hockey community at this time," it said.

Club, close to the Essex border, also paid tribute to their former player, describing her as a "fiercely competitive, talented and dedicated cricketer and hockey player" who was "fun, friendly and brilliant".

And Southgate Hockey Club in London said it was "shocked and devastated" by the death of the "much loved" team member.

Mr Coates, who was 65, was the site manager at Nottingham's Huntingdon Academy. The school said he did all he could "for the benefit of our children" and would be greatly missed.

Tributes have been

pouring in for all three victims, and a vigil was held in Nottingham city centre on Thursday.

The deadly episode unfolded in less than two hours, seemingly at random.

Police were called out to Ilkeston Road around 04:00 BST where they found the two students fatally injured.

Some time after 05:00 the body of Coates, whose van was apparently stolen, was found with knife wounds in Magdala Road, just under two miles (3.2 km) from the scene of the first two killings.

Around 05:30 the van was driven into three people waiting at a bus

stop on Milton Street in the city centre. One of those hit remains in hospital fighting for their life. The other two were lucky to escape with minor injuries.

Shortly after the van attack the vehicle was stopped in nearby Maples Street and the suspect was detained after being Tasered.

In the afternoon armed officers carried out a raid on a property on Ilkeston Road.

Nottinghamshire Police, which described the incident as "horrific and tragic", said detectives were not looking for anyone else in connection with the inquiry.

# Gordon McQueen dead at 70

■ Towering defender starred for Leeds, Manchester United and Scotland

Former Manchester United and Scotland footballer Gordon McQueen has died at the age of 70 after a battle against dementia.

McQueen - who played 184 times for the Red Devils and won the FA Cup in 1983 - was diagnosed with vascular dementia in 2021, with his family regularly documenting his journey to raise awareness about the disease.

His daughter Hayley - a Sky Sports presenter who has regularly spoken out about his ordeal - posted a tribute to her father on social media announcing his tragic passing.

She said she felt 'numb' after his loss and described the harrowing few months of watching

him deteriorate - but vowed to remember him for the man he was.

'Beyond heartbroken to announce we have lost our wonderful dad,' she said on Instagram alongside a family photo.

'I thought when the day came I'd be prepared & feel a sense of relief that he is no longer trying to battle this awful disease but I just feel numb.

'I'm hoping we can now remember him for the man he was and not the man he became this last few years. We thought we were losing him when home palliative care came to look after him back in December, we were distraught but being the big strong man that he is, battled on for many months.'

In a full statement from the McQueen family, they said they hailed Gordon as 'the ultimate entertainer' who was 'the heart and soul of the dressing room' and showed bravery until the very end.

'It is with the heaviest of hearts we announce the passing of our beloved husband, father and grandfather,' the statement read.

'We hope that as well as creating many great football memories for club and his country, he will be remembered for the love, laughter and bravery that characterized his career and his family life - not least during his recent battles with ill health.

McQueen will be

mostly remembered for his time at Old Trafford, where he also won the Community Shield.

He started his career at St Mirren in 1970, playing 57 times for the Saints in his native Scotland before

joining Leeds United in 1972.

McQueen would go on to make 140 appearances for the Whites and was part of their famous 1973-74 First Division-winning side.

In 1985 he signed for Chinese outfit Seiko, where he played for one year before hanging up his boots. For Scotland, he was capped 30 times, scoring five goals.

# Farewell to the crossword king

**THE world of cruciverbalists suffered a sad loss this week with the death of Roger Squires, who has died aged 91.**

Mr Squires enjoys a place in the record books for being the world's most prolific compiler. He compiled under the pseudonym Rufus in The Guardian, Dante in the Financial Times and was the Monday setter for the Daily Telegraph.

Over a cruciverbal career spanning almost six decades, Roger entertained and delighted solvers, and

gained recognition as the most prolific compiler who has ever picked up a pencil to fill in a little grid containing black and white squares.

Roger's first Telegraph was published in November 1986, which was the start of an unbroken run of Monday puzzles until his retirement in December 2017. His puzzles were immensely popular with solvers. They were very much at the easier end of the cryptic spectrum, so were a great starting point for anyone wanting to step up from

the Quick Crossword to the Cryptic. They were also full of humour, with clues that were designed to amuse as well as challenge, as was evident from one the one billed as his two millionth in print, published in The Telegraph in 1992, and was even used as the title of a book about crosswords: Two girls, one on each knee (7) In case you're wondering, PAT + ELLA (two girls) combine to give patella, the kneecap.

Roger's favourite clue of his own devising, and

one certain to make the solver chuckle, appeared in the Telegraph Crossword in September 2009:

Roman marbles missing? (3,6,6) The word "Roman" is a clue that you are looking for a Latin phrase meaning "marbles missing"; or, in other words, non compos mentis.

Another favorite: disturb presbyterians for pop singer (13). The answer is an anagram of the second word: Britney Spears.

Roger's cruciverbal achievements weren't just limited to The Telegraph. He was recognised by the Guinness Book of Records as the world's most prolific crossword compiler, with more than 75,000 published in all, using almost 2.5 million individual clues. His puzzles appeared in almost 600 outlets in more than 30 countries.

Roger's life included much more than just crosswords. He was a magician and member of

The Magic Circle, an FA coach and referee, flew for the RAF (surviving a ditching off Sri Lanka in which he surfaced from a depth of 60 feet), and made over 250 television appearances, including in Crossroads and Doctor Who.

And finally...a favorite clue for everyone devoted to this very-British art: angry expressions which call for solutions (10) The answer seems rather appropriate: Crosswords.

believed "had inflicted heinous social, economic and spiritual damage upon the country".

Conservative MPs were furious when the Speaker refused to rule her remarks out of order. One political commentator accused the Labour left of being "petty", "childish" and "self-indulgent" with its ungracious attacks on the Iron Lady's memory. The writer was Jackson's son, Dan Hodges.

Jackson decided not to defend her seat at the 2015 general election. And - at the age of 79 - she returned to acting.

She played the 104-year-old Adelaide Fouque in a BBC Radio 4 production entitled Emile Zola: Blood

Sex and Money.

And, in 2016 - a full quarter of a century after last treading the boards - took on the role of King Lear at the Old Vic.

The writer Marilyn Stasio best summed up the experience of watching her act: "It is like looking straight into the sun," she wrote in Variety magazine.

"Her expressive face registers her thoughts while guarding her feelings. But it's the voice that really thrills.

"Deeply pitched and clarion clear, it's the commanding voice of stern authority. Don't mess with this household god or she'll turn you to stone."

I wanted to work in other mediums as well as the film video sculptures that I was known for and started working in Neon and have the freedom to explore this without the constraints that I felt London had.

## What do you miss most from home?

I miss my family and friends the most and Sunday roasts! I try to go back and visit at least 3 times a year

to see my nearest and dearest and also to visit new art exhibitions, curators and The Groucho Club!

Saying goodbye to my parents at the airport was a tearful event... This was the first time I had ever travelled alone although my dog Pippa was traveling on a different flight so we would be reunited after ten hours! My friend Nadine Coyle was living here at the time and she came to pick me up at the airport -we drove to Huntington Beach, where she and her family lived. Its long beach felt like home as it allowed dogs to run free on the sand.

## What do you find is the biggest difference between living here and your hometown?

There are so many differences between living here and Cardiff, where I grew up. The city is so big, so many different places to explore and activities to enjoy, from surfing to hiking and watching movies in the open air! But you definitely need to drive. The food is also amazing, just so many options from street food to fine dining. The art scene is also exploding with many important galleries from Hauser and Wirth to Gagosian and Museums like The Broad and The Hammer.

## Our coach stays, insist Wolves

Wolves have dismissed speculation surrounding Julen Lopetegui's future and say he will remain as their head coach next season.

Lopetegui took over in November when Wolves were bottom of the Premier League table and guided them to safety.

However, the Spaniard's future had been uncertain because of the club's financial situation.

On Thursday sporting director Matt Hobbs said Lopetegui was "committed, he loves the area and the club".

The former Spain and Real Madrid coach, 56, had previously said it would be "difficult to compete" in the top flight without investment and mentioned Wolves' Financial Fair Play

"problems".

However, Hobbs says he "never saw a situation" where Lopetegui, who won nine of his 23 league games after replacing Bruno Lage, was not in charge next season.

"There's been a lot of chat about the club on the back of Julen's press conferences before the season finished," the sporting director said.

"What's important is we've been in constant contact throughout. I was never in any doubt that he would remain at Wolves, but we have to acknowledge the project is different to what he thought it was.

"We had to allow him time to understand it and get his head around how to build a squad to be competitive in the Premier League."

## Bellingham: Real interest gave me 'goosebumps'

England midfielder Jude Bellingham said he had "goosebumps" and his "heart was close to stopping" when he was told Real Madrid wanted to sign him.

Bellingham, 19, has joined the Spanish club from Borussia Dortmund for an initial 103m euros (£88.5m).

The fee could reach 133.9m euros (£115m) with add-ons.

"I'd always been aware of the interest from England so that was pretty normal," said Bellingham at his presentation as a Real Madrid player.

"It was a bit of a surprise when my dad sat me down and said: 'You've had a bit of interest from Real Madrid.'

"I think that was maybe about 12-15 months ago. When he said that I had goosebumps, my heart was close to stopping. It's something you don't expect growing up -

being able to play for a team like this."

Dortmund made Bellingham the most expensive 17-year-old in football when they signed him from Birmingham City for £25m in 2020 and he enhanced his reputation with his performances for the German club.

He became Dortmund's youngest captain at 19 and was named the Bundesliga's player of the season for the last campaign.

Bellingham had been linked with Liverpool, Manchester City and Manchester United before choosing to move to Real Madrid.

Tottenham have submitted a joint £50m bid to Leicester City for England midfielder James Maddison, 26, and 25-year-old England forward Harvey Barnes, says the Daily Mail.

Meanwhile Manchester United, Manchester

City and Chelsea could all enter the bidding war for West Ham's 24-year-old England midfielder Declan Rice after Arsenal's initial £90m bid was turned down.

Arsenal are continuing to prioritise a deal for Rice and have therefore pulled out of the race to sign 21-year-old Brighton and Ecuador midfielder Moises Caicedo.

Caicedo has decided to join Chelsea, with the final negotiations now taking place.

Chelsea and Germany forward Kai Havertz, 24, has agreed personal terms with Arsenal, who are yet to finalise a deal with the Blues.

Chelsea face competition from Manchester United for the signing of Inter Milan's Cameroon goalkeeper Andre Onana, 27, although United have also shortlisted Porto's Portugal keeper Diogo Costa, 23.

# The Ashes start to glow once more

■ England and Australia face off at Edgbaston; hosts hoping "Bazball" will regain the coveted urn

**FRIDAY at Edgbaston saw the latest chapter in sport's greatest love story begin to unfold.**

England host Australia in the First Test of the summer's Ashes series, continuing a saga which began 140 years ago. And whether it is Ben Stokes or Pat Cummins getting their hands on the Ashes urn at The Oval at the end of July, they will be holding a (replica) romantic gift.

The concept of the Ashes was formed by a mock obituary in an English newspaper in the summer of 1882, but it was only the following winter in Australia that a real prize came into existence.

Australian Florence Morphy gave the small terracotta urn to England captain Ivo Bligh as a trophy and symbol of her love. The pair would eventually be married, while the two rival teams had something tangible to

compete for.

Over the intervening 140 years, England and Australia have become the best of enemies. Three Lions and Baggy Greens coming together at regular intervals to measure their cricketing excellence and celebrate everything we like and dislike about each other.

The visitors are favorites due both to their recent dominance in this contest, and their current form, which saw them dispatch India at the Oval at the weekend with a 209-run victory to clinch the World Test title for the first time. The Test Championship is contested over a two-year cycle, during which Australia topped the league stage, before controlling this week's final from the outset.

Australia captain Pat Cummins has told reporters winning the Ashes would be "legacy-defining".

"Whether we like it or not, Ashes tend to define eras and teams," said Cummins, 30.

"We've played awesome cricket for the last two years and being there at the end holding the trophy feels really well deserved.

"That's great for our team and Ashes are hard to win,

"It's not going to be easy but if we were to win it, that is legacy-defining stuff."

They possess the world's number one Test batter in Marnus Labuschagne and, in Steve Smith, a player who could well end his career as the most prolific Ashes run-scorer since Don Bradman. But since the beginning of the last Ashes, teammate Usman Khawaja has averaged more than both of them.

But on the other side of the ledger, both big hitting David Warner and Khawaja have poor recent

records in the UK. In 2019, Warner averaged just 9.50 as Stuart Broad put him in a hutch and kept him as a

bunny. Khawaja averages less than 18 in the seven Tests he has played on English grass.

And not since 1926 have Australia fielded two openers aged north

## Rice will cost more, Gunners told

**West Ham have rejected Arsenal's first bid for England midfielder Declan Rice.**

Gunners boss Mikel Arteta has made Rice one of his main transfer targets, with suggestions that a deal was close.

However, it is understood the initial offer for the 24-year-old has left the Hammers unimpressed as it contains a number of clauses.

Sources at West Ham do expect further communication from Arsenal, although they are also anticipating an offer from Manchester City.

City are refusing to comment on potential interest in Rice.

There is uncertainty over the futures of City captain Ilkay Gundogan and team-mate Bernardo Silva, which could force

the club's manager, Pep Guardiola, into the transfer market.

West Ham chairman David Sullivan has said he is "99%" sure that Rice, who captained the Hammers to victory in the Europa Conference League earlier this month, will leave the club this summer.

Rice has played 245 games and scored 15 goals for West Ham, having made his debut

in the 2016-17 season after coming through the academy.

He has been capped 41 times by England, playing in all five of their matches at last winter's World Cup.

Rice has one year left on his contract, although the Hammers have the option to extend that until the summer of 2025, leaving them in a strong position to negotiate a substantial transfer fee.
