

# BRUTAL BABET BATTERS BRITAIN

■ Lethal storm brings record rainfall, high winds and widespread misery to Scotland and Northern England

SCOTLAND and much of northern England were left counting the damage and mopping up this week after the region was battered by an historic storm which brought high winds, record amounts of rain and widespread flooding.

Much of the country is still recovering from Storm Babet's lethal onslaught which cost at least seven lives and left hundreds homeless, with many more counting the cost.

In Brechin, Angus, one of the communities worst hit by Babet, some residents may have to move out permanently, it emerged as Scotland's First Minister Humza Yousaf visited this week.

Mr Yousaf was also overheard telling one resident it would be "a long road to recovery". He said discussions would continue with the local authority over the coming "days, weeks and months" about what support the government could provide, potentially including money for flood defence improvements.

The havoc wreaked in Scotland is expected to cost insurers well over £300million, possibly the

costliest in the country's history.

A driver killed when a tree hit his van near Forfar, Angus, last Thursday was named as grandfather John Gillan, 56, of Arbroath.

His family said they were "devastated by his loss and the circumstances in which he died".

He was among seven killed, along with Chesterfield grandmother Maureen Gilbert, 83, who died in her flooded home, prompting questions in Parliament.

The housebound grandmother died as she tried to flee rising water levels and was found by her son and grandson after they became concerned when her street flooded. The pensioner had lived in the street all her life and her home was previously ravaged by floods in 2007, said her

heartbroken family.

Despite her son Paul installing defences, the fast-rising flood level was too much when the nearby River Rother burst its banks at Chesterfield in Derbyshire.

Paul said: "For me to have to come and find her myself was... the upsetting thing for me. I didn't want to find my own mum.

"I came to the window, forced it open and found my mum floating in the water and then rang the police.

"I'm not saying anything could have happened differently, we just don't know. I just don't think there's enough being done with flood defences.

Everybody on the street did as much as they could on the pretext that the water would come."

In England, the Environment Agency said that while 41,540 properties were protected

thanks to flood defences, around 1,260 buildings were inundated. The Association of British Insurers said the average flood insurance claim is £30,000 but it was too early to make estimates for Babet's cost.

The Flood-Re scheme, a joint government and industry initiative set up in 2016, assists those at high risk of flooding. Insurers pay a levy of £135million a year.

In Chesterfield, Derbyshire, landlord Mick Cook was among those wondering how they would be able to afford to fix the damage.

He said: "I don't have flood insurance because I rent it out."

Over 100 flood warnings were still in place as the worst of the storm moved south, particularly along the Rivers Severn and Trent.

Nottinghamshire County Council had earlier urged residents in 500 homes to evacuate as it declared a major incident in Retford with high water levels along the River Idle.

Environment Agency flood duty manager Katharine Smith said teams were on the ground helping communities

across England.

"Temporary defences, including pumps and barriers, have been deployed to minimise the impact of flooding where needed," she said.

"Flood gates have also been closed in affected areas. We also advise people to stay away from swollen rivers and urge people not to drive through flood water."

The storm also brought winds of up to 70 miles per hour, with an astounding 26 inches falling in some parts of Scotland – more than expected during an entire year.

# Sunak: governments must come together to contain huge AI risks

LONDON: Rishi Sunak has warned that only governments could tackle the risks posed by AI, a technology he said could make it easier to build chemical or biological weapons, spread fear and, in a worse-case scenario, escape human control.

Speaking on Thursday ahead of a global gathering he has convened next week to examine the risks of the technology, Sunak said he hoped the participants could agree on the nature of the risks and establish a global panel to assess them.

Britain will set up an artificial intelligence (AI) safety institute to "examine, evaluate and test new types of AI

so that we understand what each new model is capable of, exploring all the risks from social harms like bias and misinformation through to the most extreme risks," Sunak said.

Representatives of AI companies, political leaders and experts will meet at Bletchley Park - where Britain's World War Two code-breakers worked - in southern England on Nov. 1-2.

"Get this wrong, and AI could make it easier to build chemical or biological weapons," Sunak said.

"And in the most unlikely but extreme cases, there is even the risk that humanity could lose control of AI completely."

Sunak wants Britain to be a global leader in AI safety, carving out a role after Brexit between the competing economic blocs of the United States, China and the European Union.

Around 100 participants at next week's meeting will discuss subjects including the unpredictable advances of AI and the potential for humans to lose control of it, according to the agenda.

Sunak said China had been invited but he could not guarantee that a representative of the country would attend.

U.S. Vice President Kamala Harris and Google DeepMind CEO Demis Hassabis are on the guest list.

Leaders of the Group of Seven (G7) economies, comprising Canada, France, Germany, Italy,

Japan, Britain, the United States and the European Union, in May called for adoption of standards

to create trustworthy AI and to set up a ministerial forum dubbed the Hiroshima AI process.

## BBC boss grilled over the word they just won't use

WITH the conflict in the Middle East about to enter a dangerous new stage with Israel's ground invasion of Gaza, in the UK a different battle is emerging - one to control the narrative among the major news outlets.

The BBC in particular is under massive pressure from the Government over its handling of the terror attack on Israel, specifically their refusal to describe Hamas militants as terrorists.

Immigration Minister

Robert Jenrick warned that many Jewish viewers have now lost faith in the BBC's coverage.

Mr Jenrick told BBC Director-general Tim Davie: "I've never been so disappointed in the BBC as I have been this past

fortnight.

"I worry that the organisation has lost the confidence of many people - and in particular the British Jewish community.

"That loss of confidence began with the BBC's refusal to call Hamas terrorists.

"Will you reconsider that, and change your editorial policy?"

But Mr Davie resolutely defended the Corporation's coverage, telling the 1922 Committee of Conservative MPs that he was not planning on making any changes.

The BBC also faced criticism after a reporter appeared to blame Israel for a rocket strike on a Gaza hospital.

Prime Minister Rishi Sunak told the Commons on Monday that British intelligence services believe it is likely that the rocket came from within Gaza.

Mr Davie was told he shared "responsibility" for the anti-Semitism "Jews woke up to" after the

reporting of the hospital strike.

He was challenged on the sources the BBC is using to assess events.

One MP said allegations of bias against Israel at the broadcasters are "not new", with concerns raised 20 years ago about its approach.

Mr Davie is the first BBC Director-General to address the committee in 100 years, with ministers attending alongside backbenchers.

One Tory source said the "moral decline of the BBC is concerning" while another said Mr Davie's performance had been "unconvincing".

Conservative Jonathan Gullis, who wants an independent inquiry into the coverage, said MPs "respected" Mr Davie for turning up to answer their questions but said his standing did not improve as a result of the session.

"In fact it has got worse," he added. "It just wound more people up, and not just vocal critics of the BBC.

"It was just bizarre. Refusing to call Hamas terrorists is a very strange hill to die on. It is completely tone deaf."

Conservative deputy chairman Lee Anderson criticised Mr Davie's response to MPs' questioning. He said: "He obviously doesn't spend much time watching the BBC."

In the days following the attack, a group of the UK's most senior lawyers accused the BBC of siding with Hamas by refusing to call it a terror group and talking about it in "more sympathetic terms".

Lord Wolfson KC, Lord Pannick KC, Lord Grabiner KC and Jeremy Brier KC wrote to broadcasting regulator Ofcom, calling for it to investigate.

On Friday, Mr Davie met the Board of Deputies of British Jews president Marie van der Zyl and its chief executive Michael Wegier to discuss their "outrage" at Hamas being described as militants instead of terrorists.

# Old Trafford bids an emotional goodbye to Sir Bobby

■ United and England legend passed away on Saturday aged 86

Manchester United's players wore black armbands while there was a minute's silence before the midweek Champions League game with FC Copenhagen at Old Trafford in honour of legend Sir Bobby Charlton.

On an emotional night, a wreath was placed on Sir Bobby's seat in the directors' box as United played at home for the first time since his passing on Saturday.

United boss Erik ten Hag, led by a lone piper, laid a wreath on the pitch.

Charlton was also remembered on the cover of the match programme.

Before the game - which United won 1-0 - two black and white images of the England 1966 World Cup winner looked down from the glass fronted main entrance at Old Trafford next to the words 'Sir Bobby Charlton 1937-2023 Forever Loved'.

Many United fans, who were advised to arrive early for 20:00 BST kick-off, laid floral tributes outside the ground.

Inside Old Trafford the stadium announcer urged supporters to take their seats well before kick-off as there would be a pre-match tribute to "one of the greatest players there has ever been".

A banner read "Sir Bobby. Born in Ashington. Made in Manchester", while Copenhagen fans joined in chants of "One Bobby Charlton".

Ten Hag walked onto the pitch with Alex Stepney, a former team-mate of Sir Bobby's, and Under-21 captain Dan Gore, before laying a wreath and taking part in a minute's silence.

The trio had been led out by piper Terry Carr, while away supporters unveiled a banner that read "Passion is what separates the good from the great. Rest in peace Sir Bobby Charlton."

Sir Bobby played alongside elder brother Jack against West Germany at Wembley in 1966 as one of only 11 England players to win the World Cup, and also captained Manchester United to the game's major honours, including

the European Cup in 1968.

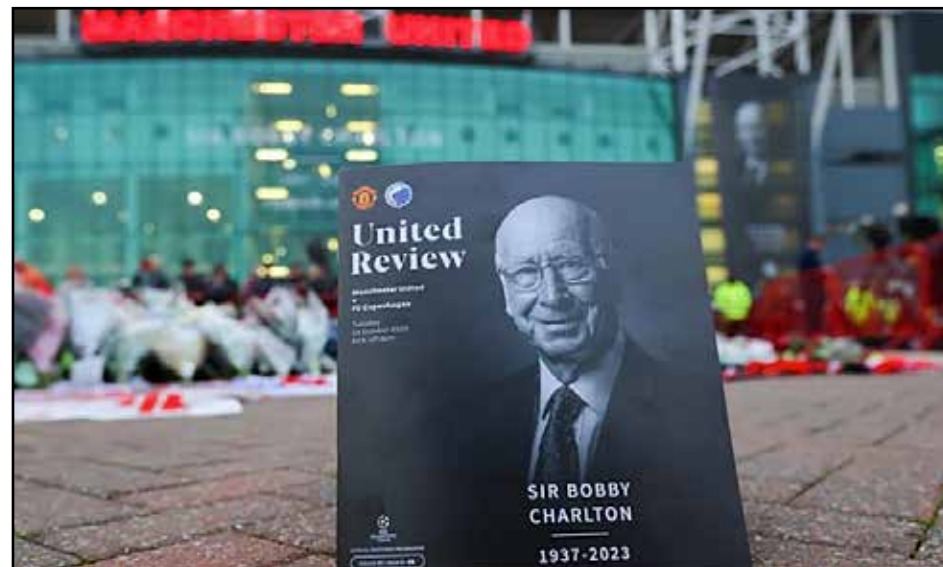
The European Cup win, with Sir Bobby scoring twice in a 4-1 win against Benfica at Wembley, carried great poignancy and emotion because he was a survivor of the Munich air disaster on 6 February 1958 which killed 23 people, including eight players and three members of the club's staff.

Ten Hag said before the game that his players wanted to "fulfil Sir Bobby's legacy".

The outpouring of grief at the death of Sir Bobby is a measure of the unique admiration and affection he inspired. No other British sporting legend was ever held in such high esteem or could have provoked such a wave of emotion at his passing.

His iconic stature was based in part on his remarkable deeds in the playing arena, for he was undoubtedly the greatest footballer this country had ever seen.

At the peak of his career, the destinies of the entire tournament were shaped

by his displays of graceful talent under extreme pressure. It was his explosive skill, thunderous shooting and wholehearted commitment that pulled England to the summit of the World Cup victory in 1966.

Two years later he

magnificently led Manchester United to become the first English side to win the European Cup.

His total of 606 League appearances for the club remains a record to this day, and this service was matched by his long years

as an ambassador and director at the club.

Even towards the end of his playing career at Old Trafford, he was still the consummate professional, as his teammate Martin Buchan recalled: "He was utterly dedicated to both United and to football."

## Tributes flow for Bill Kenwright

STARS of sport and stage have paid tribute to Bill Kenwright after his death, aged 78, eight weeks after liver cancer surgery.

The Liverpoolian was chairman of Everton FC for nearly 20 years and one of Britain's most successful theatre producers.

His family said he "passed away peacefully" on Monday night "surrounded by family and loved ones".

They said: "Bill was driven by his passions and devoted his life to them; his deep love of theatre, film, music and his beloved Everton, and the families they created.

"He impacted the lives of thousands, whether that be through

the launching of careers or his unending loyalty, generosity and unfaltering friendship and support.

"The shows will of course go on, as he would have wished, and his towering legacy will continue".

His actress partner Jenny Seagrove said: "I lost my darling Bill last night". They were in a relationship since 1994

and had a daughter, Lucy.

Kenwright started out as a musician and actor, playing Gordon Clegg in Coronation Street from 1968.

He quickly found success behind the scenes, producing more than 500 West End, Broadway, UK touring and international theatre productions, films and music albums.

Kenwright worked on a string of hit musicals, including Blood Brothers and Joseph And The Amazing Technicolor Dreamcoat.

He joined Goodison Park's board in 1989, becoming chairman in 2004. Everton said: "The club has lost a chairman, a leader, a friend, and an inspiration."

## Bulger killer granted private parole hearing

One of the two killers of James Bulger has been granted a private hearing to decide whether he should be released from prison.

It means Jon Venables' hearing before a Parole Board panel next month will take place behind closed doors.

The board will decide if Venables (above) is safe to live in the community or whether he must remain in jail.

The plan for a private hearing was challenged by journalists and James' mother, who argued it should be public.

Several leading news outlets petitioned to have the hearing held publicly, arguing there was legitimate public interest in how Venables would be managed in the community.

Jon Venables was 10-years-old when he and Robert Thompson murdered two-year-old James Bulger in 1993.

He spent eight years in jail before being released on a strict licence - but in 2017 he was jailed again after child abuse images were found on his computer. In 2020, the Parole Board rejected his last application to be released.

Caroline Corby, chair of the Parole Board for England and Wales, said that while she had "deep sympathy" for Jon Venables' victims, the hearing must take place in private.

"The Panel will need to hear about Jon Venables' past, present and future life," she said.

"The Panel will need

to question witnesses in detail, including Jon Venables, if he is willing to give evidence.

"In order to respect the injunction, substantial parts of the evidence would need to be held in private including evidence which is likely to be fundamental to the decision of the Panel."

Venables is protected by a lifelong anonymity order.

The High Court ruled in 2001 that his new identity must remain secret amid concerns that his life would be in danger were his whereabouts to become public knowledge.

Mrs Corby continued: "In circumstances where evidence which is likely to be critical to the Panel's decision cannot be heard in public, it is difficult to see how a public hearing would aid transparency or public understanding of the parole system or the decision in this case."

She added that even if parts of the hearing were held in public, "there is a risk that some information could inadvertently be revealed, putting Jon Venables at risk", and also break the lifelong anonymity order that protects his new identity.

"If the hearing were in public, the Panel may not be able to take best evidence which could impact on the fairness of the hearing. Although Jon Venables has had previous court hearings held in public when he pleaded guilty to the offences for which he was recalled, these proceedings were very different in nature to a parole hearing."

## PCs sacked after lying about 'DWB' stop and search on black athletes

TWO constables have been sacked after it was found they lied following a stop and search swoop on top black athletes.

A disciplinary panel ruled it amounted to gross misconduct.

Jonathan Clapham and Sam Franks falsely claimed they smelt cannabis when they pulled over Team GB sprint star Bianca Williams, 29, and her Portuguese partner Ricardo Dos Santos, 28.

They had been driving home from training when they were pulled over in July 2020.

The officers were part of a support group unit tasked with helping to cut crime such as gang and knife offences.

They and fellow officers Acting Sergeant Rachel Simpson, PC Allan Casey and PC Michael Bond were accused of racial profiling.

The team followed the black couple as they drove in a Mercedes to their West London home with their three-month-old son.

It was claimed they followed Mr Dos Santos because of his "appalling" and "suspicious" driving and were doing their duty when they conducted the search. The terrified couple were pulled over outside their property, handcuffed and searched on suspicion of having drugs and weapons. Nothing was found.

On Tuesday, following a six-week hearing, the panel found PC Clapham and PC Franks had lied about smelling cannabis but cleared them and the others of racism.

The Independent Office for Police Conduct brought the case alleging the detention of Ms Williams and Mr Dos Santos was "because they were black" and was "excessive and unjustified". Karon Monaghan KC, for the IOPC, said its case was that there was "institutional discrimination".

She said reports had indicated that black people in London were

"much more likely" to be stopped and searched and were "routinely treated" with "more suspicion and hostility" by police. They were "stereotyped as criminal". Mr Dos Santos, an Olympic sprinter, accused the officers of detaining him for "DWB – driving while black".

He told the panel he had been "afraid" for the safety of his partner and his son due to "traumatic experiences" as a young black person stopped by police on "multiple occasions".

He believed that as a black man driving a "nice car" he was stereotyped as someone who "must be

engaged in criminality".

The athlete revealed he had once been stopped nine times within four weeks of buying a car in 2018.

Ms Williams cried as she watched footage of him being hauled from the driver's seat to the roadside and handcuffed. Panel chairwoman Chiew Yin Jones said Clapham and Franks had breached standards concerning honesty and integrity.

Metropolitan Police Deputy Assistant Commissioner Matt Ward said: "Mr Dos Santos and Ms Williams deserved better and I apologise for the distress they suffered."

## 13 life terms for PC who abused 210 girls

**A PAEDOPHILE PC who forced 210 girls to send him indecent videos and pictures of themselves over Snapchat has been given 13 life sentences.**

Lewis Edwards, 24, posed as a teenager to groom the youngsters, aged between 10 and 16.

He secretly recorded the footage they sent him and used it to blackmail victims by saying he would tell or harm their

loved ones if they did not carry on.

The monster also sent the children videos of himself performing sex acts.

Several girls felt suicidal, self-harmed and suffered depression, Cardiff Crown Court heard. In a victim impact statement one said: "I was a little girl...I lost my innocence."

Edwards, who joined

South Wales Police in 2021 and has since quit, was caught after detectives raided his home in Bridgend in February and seized phones and computer equipment.

He admitted 138 child sex offences, 22 counts of blackmail and a further offence of refusing to disclose the password to a mobile and USB stick.

But he refused to appear in court on

Monday when Judge Tracey Lloyd-Clarke branded him "cruel and sadistic" and ordered him to serve a minimum 12 years.

She added his crimes were "significantly aggravated" by the fact he was a police officer.

Snapchat said it worked with police to tackle abuse and has "recently added a new pop-up warning for teens".

# As Labour allegedly ponder new laws on pronouns, JK Rowling jokes about being imprisoned for 'misgendering'

World-renowned author J.K. Rowling said she'd rather go to prison for two years than 'repeat the lie that trans women are women'.

The Harry Potter creator took to X last week to react to a picture of a message projected on the exterior wall of a building that read: "Repeat After Us: Trans Women Are Women."

Rowling shared the photograph, with a caption declaring: "No."

Her comment comes amid reports from several British media outlets that the Labour Party is considering classifying "misgendering" or using pronouns that match a person's sex but not their self-declared chosen sexual identity, as an "aggravated offense" that comes with a prison sentence of up to two years. With Sir Keir Starmer's party enjoying a double-digit lead in the polls ahead of next year's

general election, some fear such drastic change in the law is inevitable.

For her part, Rowling pushed back on the idea that she should kowtow to trans ideologues to stay out of prison: "I'll happily do two years if the alternative is compelled speech and forced denial of the reality of importance and sex. Bring on the court case, I say. It will be more fun than I've ever had on a red carpet."

Rowling envisioned life behind bars in a subsequent post in response to another X commenter who replied to her, writing, "See you on the inside. I quite fancy the kitchens." In response, Rowling added that she was "hoping for the library, obviously," while contending, "I think I could do ok in the kitchens."

"Laundry might be a problem," she continued. "I have a tendency to shrink stuff/turn it pink accidentally. Guessing that won't be an issue if it's mostly scrubs and sheets, though." When another X commenter assured her, "I'm a good ironer," Rowling responded, "I'm ok at ironing. It's the not checking there's a random red sock in amongst the sheets that's the issue."

Rowling has emerged as being among the most vocal British celebrity critics of trans ideology in recent years, specifically the claim that biological sex is not binary. In 2020,

she reacted to an opinion piece that featured the headline "people who menstruate," declaring, "I'm sure there used to be a word for those people." Rowling's comments reflect her concern that trans ideology is seeking to erase the distinctions between the sexes to appease those suffering from gender confusion or gender dysphoria and either don't identify with either sex or identify as the opposite sex.

The famous author further insisted that "sex is real and has lived consequences." She added: "If sex isn't real, there's no same-

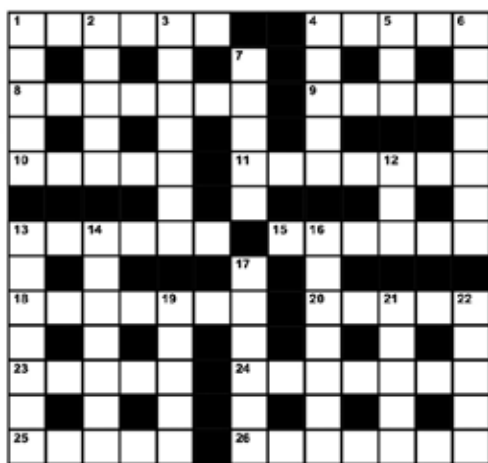
sex attraction. If sex isn't real, the lived reality of women globally is erased. I know and love trans people, but erasing the concept of sex removes the ability of many to meaningfully discuss their lives. It isn't hate to speak the truth."

The author's criticism of trans ideology has led to a social media backlash against the author, and most recently, the removal of a Harry Potter-themed quiz from a New Zealand book festival amid claims that its presence at the event presented a risk of "causing distress around to particular members of the community."

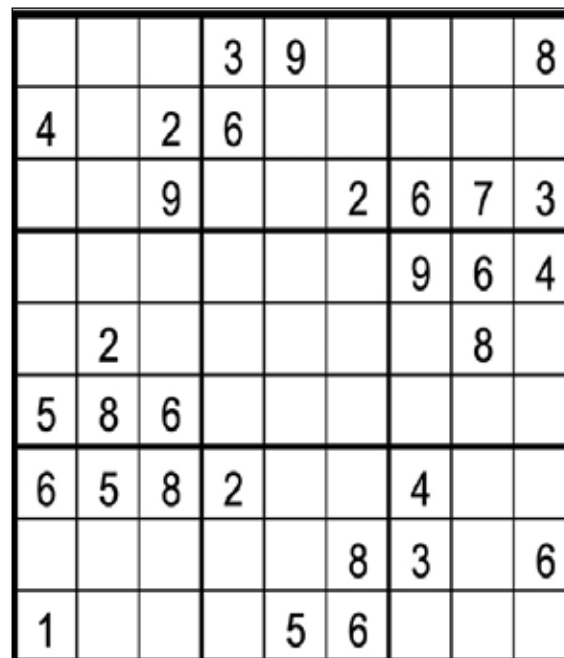

The Rolling Stones legend, 80, played Sister Kevin - a man who pretends to be a nun to sleep with real holy women at the convent - in a parody of Sister Act 3.

In the sketch, as the

nuns gathered to be questioned about an "upsetting" incident, Mick rolled in wearing a habit and rosary necklace. He confessed: "I was the one who corrupted these poor women with my lips and my hips."

"This is probably the worst sex scandal in the history of the church, but look on the bright side - before I got here, all these



sisters just mumbled 'Our Father' and now they're screaming 'Oh, God!'."

Jagger earlier crashed the set of a Spanish-language soap sketch on the show, playing dad to a character involved in a fight.

Musician Bad Bunny, 29, who hosted the show for the first time, and comic Marcello Hernandez, 26, starred alongside the rocker, who wore a pencil moustache and a cream suit.

His antics came just two days after the band's surprise gig in New York City to celebrate the release of their first new album since 2005, Hackney Diamonds.

Before a celebrity-

strewn audience of invited guests that included Christie Brinkley, Elvis Costello and Trevor Noah at the downtown club Racket NYC, the Stones made a notable racket themselves over seven songs, four from the new Hackney Diamonds disc.

Following an opening DJ set by Questlove, Jagger pranced and prowled a stage much smaller than he is used to. Now 80, he moved like a man half his age. His tongue wagged slightly as he caught his breath after the punk-inspired tune, Bite My Head Off.

"You might be familiar with this one," Jagger said before Richards began the opening riff to Jumpin' Jack Flash, instantly trumping the thousands of bar band versions attempted in the 55 years since the song's release.

Jagger was then joined by Lady Gaga, dressed in a sequined maroon pantsuit, to recreate her duet with Jagger on the new song Sweet Sounds of Heaven.

## Unai Emery left buoyant after another strong Aston Villa show

Aston Villa manager Unai Emery has challenged his players to "show every day" that they can be a contender after beating AZ Alkmaar in the Europa Conference League.

Villa sealed a comfortable 4-1 victory over the Dutch outfit at AFAS Stadion on Thursday and they are second in the table at the halfway point of the group stage, level on points with leaders Legia Warsaw.

AZ reached the semi-finals of the Conference League last season, losing against West Ham, and are currently second in the Eredivisie, unbeaten in their opening nine games.

Villa, however, made easy work of their trip to the Netherlands as Leon Bailey, Youri Tielemans, Ollie Watkins and John McGinn all scored.

"If we want to be a contender we have to show every day and when we are playing those matches, we have to show everybody our wishes. I think we did it," Emery told a news conference.

Bailey and Tielemans got Villa off to the perfect start with a goal apiece in the space of 10 first-half minutes.

Alkmaar spurned several good opportunities before the break, included a guilt-edged chance for top scorer Vangelis Pavlidis when he was clear through on goal.

Watkins then further strengthened the visitors' grip on the game early in the second period, reacting quickest to turn home after Bailey's shot had been saved.

Captain McGinn grabbed Villa's fourth when he showed desire to get ahead of his man and poke in at the near post.

# No way for Reds Toulouse

**EUROPA LEAGUE: Klopp's men in ruthless mood as they rout French hosts**

A much-changed Liverpool side continued their perfect record in the Europa League with a ruthless 5-1 win over French club Toulouse in Group E on Thursday night.

The hosts burst into the lead at Anfield as Diogo Jota skipped past a couple of defenders in the ninth minute before burying the ball into the net.

Toulouse responded through Thijs Dallinga, who was played onside by Trent Alexander-Arnold and able to slot

in an equaliser after a 40-yard run.

But stand-in captain Alexander-Arnold quickly made amends, crossing for Wataru Endo who headed home his first Liverpool goal in the 30th minute, before Darwin Nunez blasted in a third to give the Reds a 3-1 lead at half-time.

Midway through the second half Nunez glided past Toulouse keeper Guillaume Restes, but struck the post and was thankful to see Ryan Gravenberch score a fourth on the

rebound.

Liverpool ultimately cruised to their win as substitute Mohamed Salah scored a fifth in stoppage time, coolly

converting a close-range shot in off the crossbar for his ninth goal of the season.

The win means Liverpool cemented

their place at the top of Group E, on nine points after three matches, while Toulouse dropped to third, five points off the Reds.

## England's World Cup ends with a whimper

**CRICKET:** England's World Cup is all but over after a shambolic eight-wicket defeat by Sri Lanka in Bengaluru on Thursday.

The defending champions are not mathematically out but now must win all of their remaining games, including against unbeaten hosts India on Sunday, and hope an unlikely set of results go their way.

Attempting to respond to a record defeat by South Africa at the weekend, England's campaign slumped into complete disarray as they were bowled out for 156.

They reached 45-0 before the wicket of Dawid Malan, caught behind off 36-year-old Angelo Mathews for 28, began a miserable slide.

Joe Root ran himself out for a nervy three, Jonny Bairstow swiped to mid-on for 30 and captain Jos Buttler was caught behind for eight playing a flashing drive.

Ben Stokes dug in but holed out for 43 from 73

balls as wickets tumbled around him. England's innings subsided in 33.2 overs.

David Willey dismissed Kusal Perera and Kusal Mendis to reduce Sri Lanka to 23-2 inside six overs, but they still eased to victory with 24.2 to spare - Pathum Nissanka ending 77 not out and Sadeera Samarawickrama unbeaten on 65.

Sri Lanka, whose only previous win in this year's tournament came against the Netherlands, jump to fifth in the standings while England are ninth, with only net run-rate keeping them off the bottom of the table.

This was one of England's worst performances in the history of this tournament, saved for a match they had billed as must-win.

The result is an era of dominance in white-ball cricket - one in which England have become 50 and 20-over world champions - facing a sorry end after four defeats in five matches to start the title defence.
