HAPPY SOLSTICE!



THOUSANDS of druids, pagans, hippies, tourists and costumed witches and wizards gathered around Stonehenge to celebrate the summer solstice this week.

Summer officially arrived in the Northern Hemisphere on Thursday, the earliest start to the season in over two centuries and the precise moment when Earth's north pole was most tilted towards the sun was greeted with hoots, prayers, invocations and dancing by the gathered crowd.

On the summer sol-

stice, the longest day of the year in the Northern Hemisphere, the sun rises in perfect alignment with the Heel Stone and Altar Stone of Stonehenge's 5000-year-old circle.

Thousands of people flock to the site each year on both solstices to witness the phenomenon for themselves.

For this one night,

worshippers are allowed to spend the night inside the stone circle. Others chant or play their acoustic guitars. Alcohol is banned, as are sound systems. You can bring a blanket, but no sleeping bags. And definitely, no climbing on the stones.

Mysteriously erected around 2,500 B.C.E., Stonehenge is thought to be a spiritual or ritual

ground of some sort, although the true reasons why people conceived of the idea to build it, and what they may have used it for, are still unknown. The stones were raised and meticulously arranged in the late Neolithic, or Stone Age, period—a time when creating such a monument would have been a brilliant feat of advanced construction and engineering.

Thing had been a little less celebratory earlier

in the week, when two people from the pressure group Just Stop Oil were arrested after spraying the stones with orange

powder paint.

they released clouds of orange on to the monument.

Wiltshire Police issued the following statement: "A man in his 70s and a woman in her 20s were arrested on suspicion of criminal damage, damaging an ancient monument and deterring a person from engaging in a lawful activity."

'act of vandalism'

"It follows reports that an orange substance had been sprayed on some of the stones by two suspects."

Rishi Sunak condemned the action, saying: "This is a disgraceful act of vandalism to one of the UK's and the world's oldest and most important monuments."

And Labour leader, Keir Starmer, said the group was "pathetic". "Those responsible must face the full force of the law," he said.

Members of the public attempted to stop the spraying and a visitor managed to wrestle a spray can from one of the protesters.

Sean Moran, a guide, said: "It was devastating. I was very angry. We were having a great time and enjoying it when it happened. There's living lichen on

those stones. Biologists from around the world [come] to study it ... Did they think of that?"

A senior druid and pagan priest, King Arthur Pendragon, said he "totally" disapproved of the Just Stop Oil protest and that the group's actions "alienate any sympathy" for their cause.

Pendragon, who is standing as an independent parliamentary candidate for the area, said: "Stonehenge is a living, working temple at times of celebration and pilgrimage such as the summer solstice and, as a well-known protester myself, I totally disapprove of such behaviour as demonstrated by these people, who do nothing to enhance and everything to alienate any sympathy anyone has or had for their cause."

Paul Anderson, who was visiting the stones from Newcastle upon Tyne, said: "We were around the other side and we saw a lot of orange mist. I can't see how that's good publicity, doing something like that to an ancient monument. Coming from Newcastle, after the Sycamore Gap tree was felled, it beggars belief."

On Thursday English Heritage chief executive Dr Nick Merriman said there appeared to be "no visible damage" to the world heritage site.

Dr Merriman told BBC Radio 4: "It's difficult to understand and we're deeply saddened about this vandalism, but we've been really touched by the messages of sympathy and support we've had."

"Our experts have already managed to clean the orange powder from the stones because we were really worried about what would happen if they got in contact with water."

Two this week's visitors had travelled 5,000 miles from the US west coast to see Stonehenge. As a result of the protests Mike and Julie, who did not want to give their surname, had to look on from afar after the path through the site was closed off. Mike said: "It's a shame, it really is. They are ruining it for people who have come from across the world to have their moment and see it."

Just Stop Oil were also busy at Stansted Airport this week to protest singer Taylor Swift's jet-setting travel on her current British tour. Two people were arrested for spray painting several private jets on the airport's tarmac a similar orange hue. Ms. Swift's plane was reportedly not among those hit by the protesters, who used fire extinguishers loaded with paint to leave their mark.

Labour heading for landslide win on July 4

■ Tories unable to make inroads into Opposition lead



NO CONTEST: Keir Starmer enjoys a 20 point lead over Rishi Sunak

WITH less than three weeks to go to election day, things are looking grim for the Conservatives, with three separate opinion polls this week predicting a record defeat on July 4th.

Leading pollster YouGov showed Keir Starmer's Labour was on track to win 425 parliamentary seats in the 650-strong House of Commons, the most in its history. Savanta predicted 516 seats for Labour and More in Common gave it 406.

YouGov had the Conservatives on 108 and the Liberal Democrats on 67, while Savanta predicted the Conservatives would take 53 parliamentary seats and the Liberal Democrats 50. More in Common forecast 155 and 49 seats respectively.

Chris Hopkins, Political Research Director at Savanta, said its projection put Labour on course "for

a historic majority".

They are largely in line with previous surveys predicting a Labour victory, but show the scale of the Conservatives' defeat could be even worse than previously thought.

YouGov's forecast of 108 seats for the Conservatives was around 32 lower than its previous poll two weeks earlier.

Both Savanta and YouGov predicted that the party of Winston Churchill and Margaret Thatcher could be left with the lowest number of seats in its near 200-year history contesting elections.

In a further blow for Rishi Sunak this week, it has emerged that Tory

insiders may have bet on the election date.

Four people linked to the prime minister are being looked into over allegations of bets - including the Conservative Party's director of campaigning Tony Lee and a police officer in Mr Sunak's close protection team.

Two Tory election candidates - Laura Saunders and Craig Williams - have confirmed they were being looked into by the Gambling Commission.

Asked about the cases at special election edition of BBC's Question Time, Mr Sunak said he was "incredibly angry, incredibly angry, to learn of these allegations".

"But what I can tell you is if anyone is found to have broken the rules, not only should they face the full consequences of the law, I will make sure that they are booted out of the Conservative Party."

Record numbers join UK ton-up club

THE number of people over 100 has more than doubled in 20 years.

There were 15,120 centenarians in England and Wales in 2022, compared with 6,920 in 2002, the Office for National Statis-

tics said.

The number living to be more than 105 has also jumped - from 300 to 640.

Caroline Abrahams, charity director at Age UK, said: "It demonstrates the true worth of

advances in medicine.

"But a bigger older population will mean significant challenges for policymakers in terms of the need to invest in the services which an ageing society will rely on."

Ed is most played for third year running

ED Sheeran was the most-played artist in the UK in 2023, for the third year in a row – and the seventh time overall.

The Shape Of You singer, 33, beat US superstar Taylor Swift to the top spot in the PPL list of acts played across the UK on radio and TV and in public places.

Swift 34, who is currently touring Britain, was in second place after jumping from number 10 to match her previous high in 2015.

In terms of individual tracks, Flowers by Miley Cyrus was the most played song of 2023, pipping Sheeran's Eyes Closed to the title.

Seven of the Top 10 acts are British, including Coldplay which is the only group on the list dominated by solo stars.

PPL licenses use of recorded music on radio, TV and in places such as shops, offices, bars, restaurants, gyms and warehouses in the UK.

PPL's Peter Leatham said the charts "provide a snapshot of some of the most popular music being played publicly in the UK".

He added: "As the global music market gets more competitive, it is fascinating to see seven out of the top 10 most played acts are British."

Farage: Germans 'need to get a sense of humor'

Reform UK leader laughs off local outrage at England fans' 'Ten German Bombers' chant

Nigel Farage has said German authorities need to "get a sense of humour" amid calls for fans to be punished for chanting 'Ten German Bombers' at the Euro football championships.

German police chief Peter Both told English fans "don't be dicks" after fans were heard singing the song, which mocks German casualties during World War Two at last week's friendly against Bosnia and Herzegovina at St James' Park.

The chant is partially a corruption of the nursery rhyme Ten Green Bottles but sung to the tune of traditional folk song She'll Be Coming Round The Mountain.

It replaces the lyrics "bottles hanging on the wall" from the former with "German bombers in the air" - before the line: "...but the RAF from England shot them down".

'puritan world'

Mr Both said: "If they sing a song like this, I can't change it. It's not punishable in Germany.

"I hope that all the other peaceful and law-abiding fans say to them: 'Stop it.'"

Reacting to the comments on LBC's Nick Ferrari at Breakfast, the Reform UK leader said: "It's very important that young men are not men, they shouldn't drink beer, they shouldn't have fun, they shouldn't chant, no no, we are to live in a modern puritan world.

"Is it any wonder that so many young Gen Z-ers are now supporting me on TikTok and elsewhere because they're being told not to be young lads. I know this is difficult for the Germans but please, get a sense of humour."

England Supporters

Travel Club members caught singing Ten German Bombers have previously been warned they face being banned from future matches, after it was sung during the team's friendly in Germany in 2017.

Farage also defended Andrew Tate, claiming the controversial influencer was 'important voice' for men. Farage has also argued against diversity quotas and said people on benefits were 'too stupid' to work in appearances over past year.

'male culture'

Farage praised Tate for being an "important voice" for the emasculated and giving boys "perhaps a bit of confidence at school" in online interviews that appear to be aimed at young men over the past year. He had previously claimed that Tate was defending "male culture" while acknowledging that the influencer had gone "over the top" and elsewhere that he had said some "pretty horrible" things.

Since December 2022, Tate has been facing charges in Romania of human trafficking, rape, and forming a criminal gang to sexually exploit women, which he denies.

Many politicians and teachers have spoken out against Tate's influence on young boys in the UK, after the self-proclaimed misogynist said women belonged in the home and were a man's property. "There's no way you can be rooted in reality and not be sexist," Tate said in one video.

'cultural battles'

Farage has recently argued against diversity quotas for BAME (Black, Asian, Minority and Ethnic) people, saying "the idea we should give

people jobs according to how suntanned they are, the colour of their skin" was nonsense, to suggesting that some people on benefits are "too fat ... too stupid, too lazy" to work.

Farage said: "The banking sector, now full of idiots, people are promoted not because of ability, but ethnicity or gender ... The white male - you lot - are going to feel the world's

against you. Andrew Tate tapped into that. You're going to feel the world's against you, you're going to feel resentful and angry ... These are massive cultural battles."

Tributes flow to former Arsenal and Everton star Campbell

“A goal machine, a giant of a man, with an even bigger heart.”

Former Arsenal player Kevin Campbell has died aged 54 after a “short illness,” the Premier League club announced on Saturday.

Campbell played 228 times for Arsenal in the 1980s and 1990s, winning the English First Division title (the predecessor to the Premier League), the FA Cup and the European Cup Winners’ Cup with the North London club.

He later moved to Nottingham Forest and Everton, where he became the club’s first Black captain and a fan favorite, especially for his remarkable record of scoring nine goals in five games to help ensure the Toffees avoided relegation from the Premier League in the 1998/99 season.

Tributes have poured

in from former teammates, with Wayne Rooney – who played with Campbell at Everton – saying he was “devastated to hear the news.”

“Kev was a great teammate but more importantly a brilliant person who helped me a lot in my early years,” the former England and Manchester United striker said on X, formerly known as Twitter.

He had spells at West Bromwich Albion and Cardiff City before retiring from soccer in 2007 and embarking on a media career as a pundit.

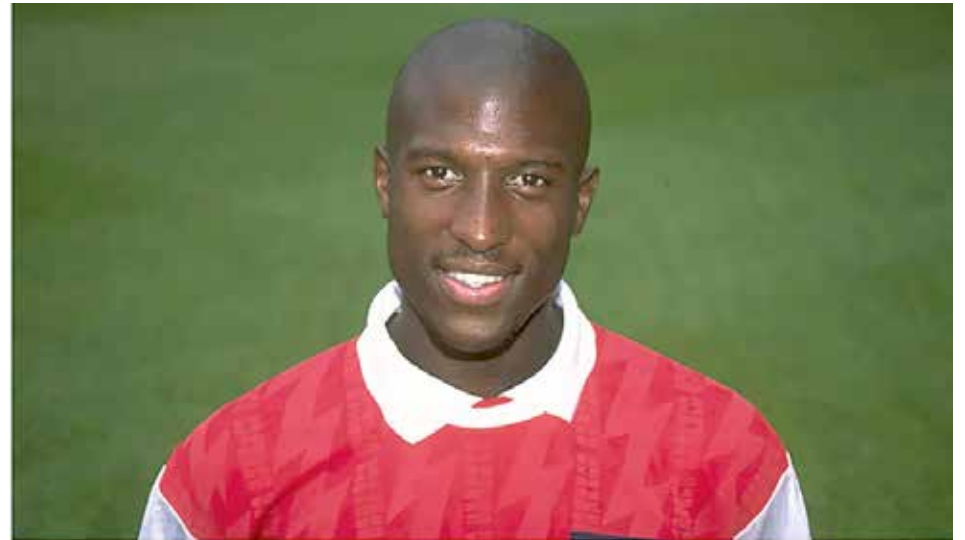
Born in London, Campbell grew up supporting Arsenal and joined the club’s academy aged 15 where his knack for goalscoring was quickly established.

He later formed a close partnership with fellow forward Ian Wright and the two men proved integral to Arsenal’s historic 1992/93 season in which it became the first club to win the FA Cup and League Cup double.

Wright on Saturday posted several pictures on social media of the two of them.

Such was Campbell’s popularity at Arsenal that “he remained a dear and cherished friend to many at the club, always maintaining the close links that began in his very early days at Highbury,” the Gunners said in a statement.

Similarly at Everton, he became “one of the most popular men to ever wear the royal blue jersey,” the club said in a statement.

Meanwhile, former Arsenal captain Tony Adams said on X: “Super Kev: a goal machine, a giant of a man, with an even bigger heart.”

“An intensely private and truly wonderful human being. I’m devastated for his loved ones, and all of us. Love you

Super Kev, Skipper.”

Campbell’s 24-year-old son Tyrese thanked those paying tribute for “the outpouring of love” that had followed his father’s death.

“The pain of this is indescribable and as a son you look at your dad as invincible. He is my idol,

the one who I wanted to be when I grew up,” he said on Instagram Stories.

“He was the life and soul of every party and room he blessed, a one-in-a-million person that was loved by everyone. A special, special person. I’ll miss you Dad.”

Sir Bradley Wiggins faces losing “absolutely everything”

■ Cycling great is now homeless after burning through £13m fortune

SIR Bradley Wiggins faces losing “absolutely everything” including his eight Olympic medals after being declared bankrupt, his lawyer has said.

The cycling great, 44 – who was the first Briton to win the Tour de France – has seen his £13million fortune disappear due to failed business ventures.

He is homeless and staying with his ex-wife and friends after his £975,000 converted barn in Lancashire was repossessed and sold months ago, lawyer Alan Sellers revealed this week.

“In reality, Brad is sofa-surfing,” he said. “He stays with friends



“It’s a very sad state of affairs,” said a friend of the five-time Olympic gold winner

and family. It is a total mess.

“He has lost absolutely everything. His family home, his home in Majorca, his savings and investments. He doesn’t have a penny. It’s a very sad state of affairs.”

Trustees are being appointed to dispose of Sir Bradley’s assets, which could include his

five gold Olympic medals and Tour de France trophy, after he was declared bankrupt by a court on June 3.

His former wife Cath, with whom he has three children, has been letting him stay at a red-brick semi she owns in Lytham St Annes “to help him out”, said Mr Sellers, who is head of

sports law at Liverpool solicitors Bond Turner.

Sir Bradley claims to see his Olympic medals as meaningless “junk” since his retirement in 2016, the lawyer added. Wiggins is Britain’s most decorated Olympian with eight medals, just ahead of fellow cyclists Chris Hoy and Jason

Kenny. He stepped up to the podium at every Olympic Games from Sydney 2000 to Rio 2016, and was famously pictured on a gold throne after winning the Road Time Trial at London 2012.

In 2017, Spear's Magazine cited his net worth as £13million, helped by lucrative brand deals with Fred Perry, Skoda and others.

But in 2020 Wiggins Rights Ltd, which he owned with Cath and his mum Linda, entered liquidation, owing £650,000 including £313,447 to HMRC.

In 2022, liquidators made a £1million claim against him to pay back an overdrawn director's loan. A few months later it was revealed he'd entered into an Individual Voluntary Arrangement to stave off bankruptcy.

ery" after a fall during Monday evening's performance of Player Kings, a spokesperson for the Noël Coward theatre in London has said.

McKellen was taken to hospital after the fall. The audience was evacuated from the West End theatre and informed that the evening show was cancelled.

A spokesperson for the theatre later confirmed that Tuesday evening's performance had also been cancelled "so Ian can rest". McKellen was expected to next appear in Wednesday's matinee performance.

McKellen, 85, who plays John Falstaff, was in a battle scene involving the Prince of Wales and Henry Percy when he fell off the front of the stage. As the house lights came up, the actor cried out in pain and staff rushed to help, the BBC reported.

Paul Nero, a writer and broadcaster, wrote on X: "Audience shocked by Sir Ian McKellen's fall off stage tonight at Noel Coward theatre. Staff working hard to help

him. Thoughts with him, cast and crew."

An audience member, Paul Critchley, a Methodist minister from Norfolk, told the PA news agency:

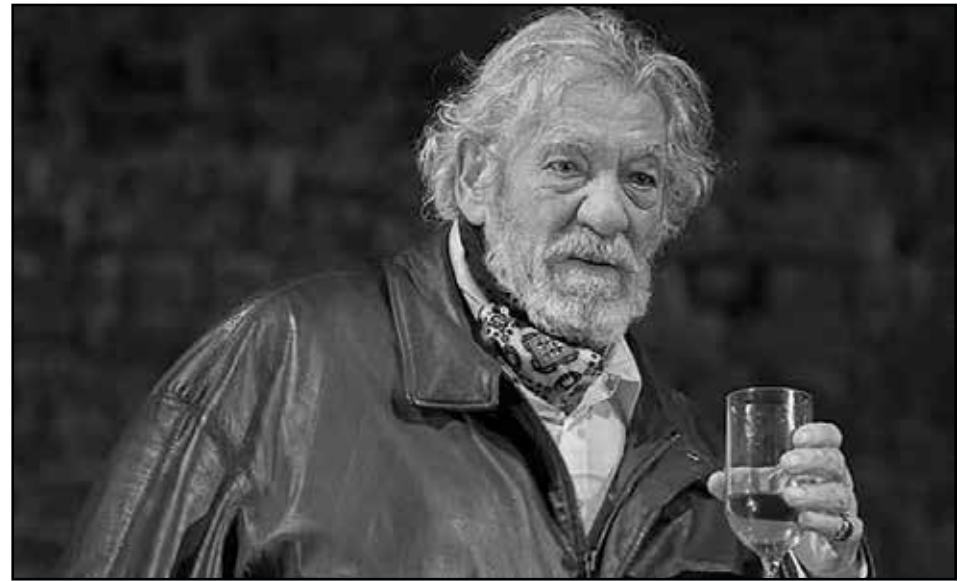
"Sir Ian seemed to trip as he moved downstage to take a more active part in the scene.

"He picked up momentum as he moved downstage which resulted in him falling off the stage directly in front of the audience.

"The house lights came up very quickly as the stage management and front of house team dealt with the incident. We were evacuated immediately so that Sir Ian could be treated in privacy.

"An announcement was made by theatre management that the show had been cancelled, that Sir Ian was receiving treatment and an ambulance had been called.

"It was a shock to witness his fall and I wish him a speedy recovery. My thoughts are also with his fellow cast members, stage crew and front of house team

at the Noel Coward Theatre."

Another member of the audience, Sandro Trapani, told the BBC the incident was "very

shocking".

"I really hope that he is going to be all right,"

"As far as I saw, he was conscious because he was asking for assis-

tance."

Player Kings is a production of Shakespeare's Henry IV Parts I and II, and started its 12-week West End run in April.

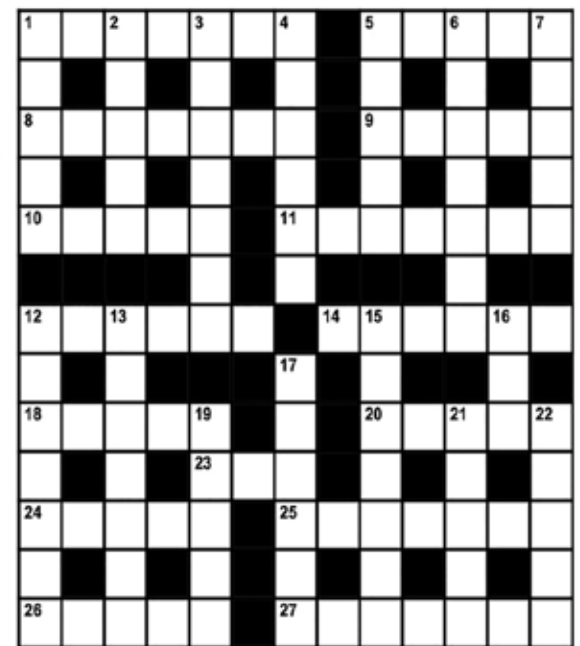

Charles and Camilla lead pomp-filled Garter Day service

King Charles had a busy week of obligations this week, with both the Trooping the Color ceremony at the weekend and then the annual Garter Day service two days later.

The monarch, who is continuing his weekly cancer treatment in between events, fully embraced the pomp and pageantry with Queen Camilla.

Wearing white plumed hats and dark blue velvet robes, they were joined by Charles's eldest son William and the King's siblings Anne and Edward.

Normally William's wife Kate would attend but she is continuing her cancer treatment after making a

much-lauded public appearance at Saturday's Trooping the Colour.

As is tradition, the royals walked behind the official procession of the Knights and Ladies of the Order of the Garter, who currently include former Prime Ministers Sir Tony Blair and Sir John Major.

New members being installed this year were Lord Lloyd-Webber, the Duchess of Gloucester, Lord Kakkar and Lord Peach – making the total 21 out of a maximum 24.

Former MI5 director-general Baroness Manningham-Buller is the order's new Chancellor – the first woman to hold the post since its inception in 1475.

The grand procession, guarded by members of the Household Cavalry Regiment, began at 2.45pm at Windsor Castle's State Apartments – winding downhill to St George's Chapel in the grounds.

Watching in the public viewing areas were hordes of well-wishers who had been waiting for hours, many with picnic hampers.

One onlooker commented: "Since King Charles and the Princess of Wales had their cancer announcements, Windsor Castle has never been so busy.

"They're all hoping for a glimpse of the King when they go round the grounds."

When Charles, 75, and Camilla, 76, ar-

rived at the chapel, a fanfare of trumpets was played.

Waiting inside was the Duke of Kent, 88, who is a Royal Knight Companion but too frail to take part in the procession.

Among those watching outside were Anne and Edward's spouses Sir Tim Laurence and Sophie, Duchess of Edinburgh, who wore a striking pink Zimmermann dress and Jane Taylor hat.

Prince Andrew, as a Royal Knight Companion, was at an earlier lunch for the order but, as last year, was not permitted to join the procession. The annual celebration commemorates the Order of the Garter – the oldest Order of Chivalry.

The Garter – awarded by the sovereign without prime ministerial advice for outstanding public service and achievement – is the most senior order of knighthood in the British honours system.

Established in 1348 by Edward III after he was inspired by tales of King Arthur and the Knights of the Round Table, it is outranked only by the Victoria and George Crosses.

Cooper confirmed as new Foxes boss

Leicester City have appointed former Nottingham Forest boss Steve Cooper as their new manager on a three-year deal.

Cooper, 44, has been out of work since leaving Forest in December 2023.

The Foxes have been searching for a new manager since Enzo Maresca departed for Chelsea at the start of June.

Maresca joined Leicester at the start

of last season, guiding the club to first place in the Championship and an immediate return to the Premier League after their relegation in 2022-23.

"I am really excited and proud to be appointed Leicester City's first-team manager," said Cooper.

"This is a fantastic club with a rich history and passionate supporters. I am excited to work with such a talented squad and

I'm looking forward to the challenge of achieving our shared ambitions in the Premier League."

Leicester were disappointed that Maresca opted to leave the club following their Championship title win.

The Foxes considered a number of replacements, including West Brom manager Carlos Corberan.

Cooper provides the Foxes with Premier League experience, having kept Forest in the top flight by finishing 16th following their promotion in 2022.

He was a popu-

lar figure with Forest supporters but he was sacked midway through last season, with the club 17th in the table.

The former Forest boss guided England's Under-17s to victory at the 2017 World Cup and also spent two years at Swansea, taking them to the Championship play-off final in 2021 where they lost

to Brentford.

Cooper's first competitive fixture in charge will be on 19 August, when Leicester host Tottenham in the Premier League.

"We are delighted to welcome Steve to Leicester City. His vision for the team, including his ability to develop players and implement a dynamic style of play, is very

much aligned with our aspirations for the club," said Leicester chairman Aiyawatt Srivaddhanaprabha.

Scots 'proved we can bounce back'

Scotland proved they can "bounce back from adversity" in Wednesday's well-earned Euro 2024 draw with Switzerland, says defender Jack Hendry.

Steve Clarke's side went into their second group game having come off the back of a 5-1 mauling by hosts Germany in the tournament opener.

But a hard-fought point in Cologne against the Swiss sends the Scots into Sunday's encounter with Hungary knowing a win would likely send them through to the knockouts of a major finals the first time.

"Hopefully we can continue this momentum now," Al-Ettifaq cen-

tre-back Hendry said. "It felt like we did ourselves justice last night. It shows how much we can bounce back from adversity.

"It was a very emotional evening. The fans were incredible. From the national anthem to the lap of honour at the end, they really pushed us on.

"We would've taken [this position]. We are more than determined to make history."

Hendry is wary of "top nation" Hungary, who are at the Euros "on merit".

Clarke confirmed he will be without Kieran Tierney for that must-win game after the Arsenal defender was stretchered off on Wednesday.

After being rolled by striker Dan Ndoye, the Arsenal defender, who spent last season loan at Real Sociedad, was stretchered off after suffering what looked like a serious muscle issue.

And while Hendry says his team-mate "will be a miss" in Stuttgart, he feels Scott McKenna's cameo highlights the squad's strength.

"There are ready-made replacements there if Kieran can't make the game," he said.

"One of our strengths is our squad. Scott [McKenna] came in and did extremely well."

A nation like Scotland losing a player of Tierney's calibre is always

likely to have a significant impact, but his influence in Clarke's side is striking when you dissect their results with and without him.

Since Clarke's appointment in 2019, Tierney has played 35 games for his country, with 16 victories coming from those caps - a win percentage of 46%.

In the 22 games he has not featured in, that win

rate drops to 41%.

Nine losses have come in the 35 caps he has earned under Clarke. The same number of defeats have come in the 22 matches he has missed.

Scotland also ship more goals when Tierney isn't in the team - a concession rate of 1.1 per game with him in the side jumps up to 1.7 without him.

Remarkably, in the

35 fixtures Tierney has played under Clarke, the defence have conceded just two more goals than the 37 they have lost in the 22 matches he has been absent for.

Euro 2024: for the also rans, it's still all about the permutations

We are only one week into Euro 2024, but already the word 'permutations' is flying around.

With Scotland and England having played twice, the calculators are out as people try to plot a potential route into the last 16.

The top two teams in all six groups qualify automatically, but the four best third-placed teams also make it through.

England need to avoid defeat against Slovenia in their final group game on Tuesday to progress from Group C. If Denmark fail to beat Serbia, then England will qualify regardless of their result against Slovenia. However, if England lose to Slovenia and Serbia win their game then Slovenia will win the group.

England must beat Slovenia to top the group if Denmark win against Serbia.

Even if England do

not finish in the top two, they could progress as one of the best third-placed teams.

No team has failed to reach the knockout stages in a 24-team Euros after gaining four points.

If Scotland lose their final group match to Hungary, they will finish fourth and be eliminated.

If the match is drawn, Scotland will finish the group in third and could yet qualify - but that would depend on results in other groups.

If Scotland win the game, they will finish either second or third - depending on the result in Switzerland's match with Germany.

As Scotland drew with Switzerland, their positions will be decided on overall goal difference, then overall goals scored, then disciplinary points, then their ranking in European qualifiers.

As it stands, Scot-

land's goal difference is six worse than Switzerland's, so it would need a significant swing in the final round of games.

The results of the third-placed teams are compared based on their three group stage matches, according to the following criteria:

A: Higher number of points

B: Superior goal difference

C: Higher number of goals scored

D: Higher number of wins

E: Lower disciplinary points total based only on yellow and red cards received in all group matches (red card = 3 points, yellow card = 1 point, expulsion for two yellow cards in one match = 3 points)

F: Position in the overall European Qualifiers rankings, or if Germany, the host association team, is involved in the comparison, drawing of lots.

Southgate, who has taken charge of 97 England matches, felt his side were losing possession too easily.

"There's a huge amount of work to do, that's evident from the two performances we have given - clearly it was not what we would've hoped for," added Southgate.

there can be no cheap excuses when they perform as badly as this.

Once again, a goal subdued England rather than inspired them as they found themselves overrun and prone to far too many errors all over the pitch.

The old, nagging habit of going into retreat after going ahead returned. Serbia were not good enough to take advantage in England's first game but Denmark were not passing up the invita-

tion.

It was a surprise to see Kane substituted after 69 minutes with England seeking a winner while Foden, who was also replaced, had actually been the most threatening player on Southgate's side.

England's efforts were summed up by the extent of Southgate's reshuffle. They are still up and running in Euro 2024 but even the most optimistic fan inside the Frankfurt Arena would accept this was nowhere near the standard required to make a serious impact in Germany.

DISMAL ENGLAND!

England wasted the chance to secure their place in the Euro 2024 knockout stages as Group C winners as they were fortunate to take a 1-1 draw from a dismal display against Denmark in Frankfurt on Thursday.

Gareth Southgate's side would have topped Group C with a win after the earlier draw between Slovenia and Serbia - but were ultimately grateful for a point from a disorganised, shambolic mess of performance.

Harry Kane scored in his fourth successive major tournament to give England an 18th-minute lead but, as so often under manager Southgate, this was the signal for them to shrink into their

shell to allow Danish domination.

Denmark got the equaliser they deserved when Morten Hjulmand struck a thunderous 25-yard equaliser after 34 minutes.

Phil Foden struck the post after the break and, while England are still at the head of their group, they must deliver vast improvements against Slovenia.

As an audition for potential favourites to win Euro 2024, this was a disappointing failure.

England's dreadful display was placed firmly in context by the fact manager Southgate, hardly known for hasty or rash changes, made four substitutions with more than 20 minutes left.

The England fans inside Frankfurt Arena also made their displeasure known, with several bursts of loud jeering well before the final whistle and a hostile send off at the end.

It is a long time since England looked as disorganised as they did here, especially in midfield where they were out-passed for long periods by Denmark, with veteran Christian Eriksen pulling the strings.

The central partnership of Declan Rice and Trent Alexander-Arnold looked horribly ill-at-ease and outmanoeuvred. This, presumably, will be the last time it is used.

Jude Bellingham, England's great talisman and match-winner

against Serbia, could not rescue them this time as even he looked jaded and unable to exert any in-

fluence as they struggled desperately.

England's players were often seen complaining

about the state of the playing surface, which did cut up early on, but

We have no replacement for Phillips, says Southgate

Manager Gareth Southgate says England are struggling in midfield at Euro 2024 and have not found a "natural replacement for Calvin Phillips".

The Three Lions produced a limp performance in their 1-1 draw with Denmark on Thursday, a result that leaves them top of Group C and in a strong position to qualify for the last 16.

However, just as in England's 1-0 win over Serbia on Sunday, Southgate's side failed to maintain control of the match and did not perform at their best.

Phillips, 28, had played a key role in England's run to the European Championship final in 2021, but was not selected for Germany following a disappointing loan spell with West Ham after he had struggled to feature at Manchester City.

Former Liverpool midfielder Jordan Henderson, 34, had been instrumental in the 2018 World Cup, when England reached the semi-finals, but was also left out of the 26-man squad.

Liverpool's Trent Alexander-Arnold, an attacking right-back for his club, has partnered Arsenal's Declan Rice in midfield in England's two games in the tournament.

But Alexander-Arnold, 25, was substituted early in the second half, replaced by Chelsea's Conor Gallagher, with England often second best.

On Alexander-Arnold, Southgate said: "He has had some moments where he has delivered as we thought. It's an experiment - we don't have a natural replacement for Calvin Phillips. At the moment we're not flowing as we would like."

In Frankfurt, Harry Kane gave England an 18th-minute lead with his first goal of the tournament, only for Denmark to equalise 16 minutes later through Morten Hjulmand's long-range strike.

But Denmark - 16 places below fifth-placed England in the Fifa rankings - were the better team for large parts of the second half, although England did hit the post through Phil Foden.

Southgate's side could not find a winning goal that would have taken them through to the knockout stages with a game to spare.

"We understand people will be disappointed with the performances and rightly so - we have to make them a lot better," said Southgate in an interview.

"At the moment we're not using the ball well cont. on page 19, col. 4
