Tories out after 14 years as Labour sweep to power with 174 seat majority

STARMERGEDDON!

Sir Keir Starmer's Labour Party has swept to power in Britain, winning a big majority in Thursday's general election.

The Labour leader promised to build a "government of service" after becoming the country's first Labour prime minister since 2010.

Speaking outside 10 Downing Street on Friday morning following his party's landslide election win, he pledged to restore trust in politics and "navigate away to calmer waters".

And appealing directly to voters who did not back his party, he vowed to put "country first" and govern "unburdened by doctrine".

He was cheered into the famous street by a crowd of supporters, who were waving Union Jacks, and the flags of Scotland and Wales. The PM and his wife Victoria hugged old friends and colleagues who had lined up to applaud him.

Speaking from the lectern, he cautioned that despite Labour's huge parliamentary majority of 174, his aim of "rebuilding" Britain "will take a while".

Sir Keir, who has formally replaced Tory leader Rishi Sunak after an audience with the King at Buckingham Palace, has started to appoint his new cabinet, before it meets for

the first time on Saturday.

It marks a dramatic turnaround in fortunes for Sir Keir's party, which won just 203 seats under his predecessor Jeremy Corbyn in 2019, its worst result in terms of seats since 1935.

Despite increasing its share of the national vote by only around 2%, the party has more than doubled its number of seats to 412, a result just short of the historic 179 majority won by Tony Blair in 1997. Labour's victory came largely as a result of a dramatic 20-point drop in Tory support, with the party down 250 seats to 121, a historic low.

vote share

At 59.7%, turnout was the worst since 2001 and only narrowly ahead of the worst-ever 57.2% recorded in the 1918 election at the end of World War One.

In fact, with just two results yet to declare, Labour has won fewer votes overall - 9.7m compared to 10.3m - than at the last election.

Its increased vote share came entirely as a result of a 17-point increase in support in Scotland, where it regained its status as the largest party as the SNP



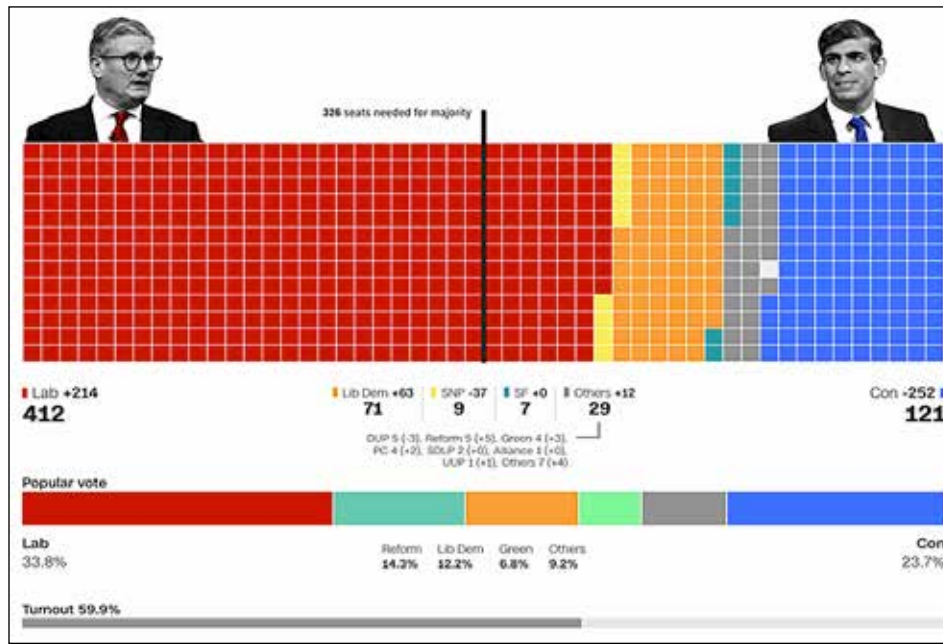

slumped from 48 to just nine seats.

On a good night for smaller parties, the Liberal Democrats won 71 seats, the party's best result in a century, whilst Nigel Farage will become one of four MPs for Reform UK, following a breakthrough night for the fledgling party.

The rain in London cleared for Sir Keir as he returned from Buckingham Palace to make his first speech as PM.

He said a "weariness in the heart of a nation" **cont. on page 2, col. 4**

On his way out, Rishi apologizes to nation

■ Outgoing PM also has kind words for his successor

Rishi Sunak has apologised to the nation following the Conservative Party's general election defeat - the worst in its parliamentary history.

Accepting responsibility for the result, Mr Sunak said he heard voters' "anger" at his government.

"To the country I would like to say first and foremost I am sorry," he said.

"I have given this job my all but you have sent a clear message that the government of the UK must change, and yours is the judgement that matters.

"I have heard your an-

ger, your disappointment, and I take responsibility for this loss."

Mr Sunak delivered his speech outside Number 10, despite earlier rain - this time with a broly on hand to avoid a repeat of his sodden election announcement in May.

Mr Sunak said he would step down as party leader, adding "not immediately but once the formal arrangements for selecting my successor are in place".

The MP for Richmond and Northallerton insisted there would be "an orderly transition" and also paid tribute to Sir Keir,

whom he described as "a decent and public-spirited man who I respect".

Having said goodbye to staff in Downing Street just before his speech, Mr Sunak then got into a car with his wife Akshata to travel to offer his resignation to the King.

"I am free"

In an earlier victory speech in central London, Sir Keir said "change begins now", adding "it feels good, I have to be honest".

Foreign Secretary James Cleverly told reporters that a "large number of people who had previ-

ously voted Conservative have voted Reform" and the Conservatives now had to "think hard" about how to win back their support.

Former minister Steve Baker, long a thorn in the side of Tory leaders over Brexit, expressed relief following the news he had lost his seat after 14 years as the MP for Wycombe.

"Thank God, I am free - it's over," he said from the empty hall where the ballots had been counted overnight.

Reform has four MPs so far - including chairman Richard Tice and former Tory Lee Anderson - and has finished second in many parts of the country, taking large amounts of votes from the Conserva-

tives.

In a victory speech in London, Sir Keir told cheering Labour supporters the country was waking up to "the sunlight of hope" which was "shining once again on a country with the opportunity after 14 years to get its future back".

He added: "Now we can look forward - walk into the morning."

The Liberal Democrats have slightly fewer votes than Reform but have benefitted most from the Tory collapse, surging to a record 71 MPs, including the constituencies of three former Tory PMs - Boris Johnson, David Cameron and Theresa May.

Lib Dem leader Sir Ed

Davey said: "This is a record-breaking night for the Liberal Democrats."

He added: "We will now work hard to keep that trust with a focus on the issues that matter most to them, most of all the NHS and care."

The Green Party of England and Wales now has four MPs, with co-leaders Carla Denyer and Adrian Ramsay among the winners.

But it has been a terrible night for the SNP, which has been reduced to just eight MPs so far. Sir Keir Starmer's landslide is short of the 179 majority won by Tony Blair in 1997, with its vote share across the country up by just 2%, largely thanks to big gains in Scotland.

had developed in recent years, likening a lack of trust in politicians to a "wound".

He added: "This lack of trust can only be healed by actions not words, I know that".

"But we can make a start today with the simple acknowledgement that public service is a privilege," he added.

Sir Keir's path to No 10 followed a cautious campaign in which Labour made few new policy pledges and managed to largely retain the large

polling lead over the Tories it began with when Mr Sunak called the election in May.

Despite its resounding overall victory, Labour lost a number of former strongholds to independent candidates campaigning on pro-Gaza platforms.

In one of the biggest shocks of the night, shadow minister Jonathan Ashworth lost his Leicester South seat, which had a majority of more than 22,000.

Shadow culture secretary Thangam Debbonaire lost in Bristol Central to the Greens, who celebrated their most

successful election night ever after winning four seats, up from the one they held in the last Parliament.

And shadow health secretary Wes Streeting - one of Labour's most high-profile figures during the campaign - saw his majority in Ilford North slashed from more than 9,000 to just 528.

Mr Corbyn - standing as an independent after Sir Keir blocked him from standing again for the party he once led - was also returned in the North Islington seat he has represented since 1983, defeating Labour's official candidate by 7,247.

This is just the beginning, vows buoyant Nigel Farage

■ Reform Leader promises to build a 'mass movement'

Nigel Farage is finally heading to Westminster to take a seat on the green benches.

After seven failed attempts the Reform UK leader has won his place in Parliament, persuading the people of Clacton to put him there after changing his mind mid-campaign and throwing his hat in the electoral ring.

And while his party might not have matched the initial expectations of the exit poll which predicted a total tally of 13 seats, there will be three others alongside Mr Farage, pacing the corridors of power bearing the light blue of Reform UK.

The party is hailing it as a breakthrough moment, and there's no doubting its significance.

Firstly, because a parliamentary seat gives Mr Farage a new platform at the heart of British politics.

When he was a member of the European Parliament he used his position

to amplify his message, largely centred on criticising the very institutions he was elected to.

Secondly the party sees this as a stepping stone to something more.

Chairman Richard Tice, the former party leader who stepped aside when Mr Farage took the helm, has long had a two-election strategy with the first – this one – meant to create a base of support they could build on by the time of the next.

offensive remarks

During his victory speech in Clacton, Mr Farage said his aim was to build a "mass movement" to challenge the next general election "properly".

He's described a "gap on the centre right of British politics" that he plans to fill.

But while the party outperformed even their own initial expectations this time round, they acknowledge it wasn't

without issue.

The latter stages of Reform UK's election campaign were plagued with controversy over alleged racist and homophobic comments by party campaigners.

They had to drop candidates over offensive remarks.

They've blamed the speed at which they had to recruit candidates and failures in vetting, an issue which Farage acknowledged in a speech on Friday, acknowledging he had to "professionalise and democratise" the party, saying he would "get rid" of some "idiots" who'd been let in.

The young party's rapid rise stretched it and exposed cracks.

But it attracted huge support and had a big impact on the election.

As well as winning four seats, it came second in many others, largely at the expense of the Conservatives. That is already

weighing heavily on Tory minds as they start to consider their own party's future direction.

Much of what happens next might depend on how the Tories respond, as well as whether Reform UK can put the structures in place to

withstand the extra scrutiny that comes with electoral success.

But this result will only fuel Reform UK's ambition.

And Farage got some quick validation from his most famous supporter, US presidential candidate

Donald Trump.

Posting on his Truth Social platform, Trump said: "Congratulations to Nigel Farage on his big WIN of a Parliament Seat Amid Reform UK Election Success. Nigel is a man who truly loves his Country! DJT."

Exit Stage Right: the papers on Sunak

RISHI Sunak's brief and inglorious tenure in No 10 is over, and the nation's opinion writers wasted no time in burying stilettoes of criticism in his departing back.

Perhaps most pithy analysis came from the *Financial Times*, who had this to say of the departing Prime Minister, in an editorial titled: Ineffectual and Snippy: the rapid rise and stunning fall of Rishi Sunak.

"Few British politicians have risen as high as fast as Rishi Sunak. But it is the speed and severity of his fall for which he is now more likely to be remembered. Having gone from junior minister to prime minister in barely three years, Sunak has left

his Conservative party with its worst-ever result. His Icarus-like arc makes him Britain's third shortest-serving prime minister since the second world war, after Alec Douglas-Home and Liz Truss, in office for just 20 months. Few observers deny that Sunak received a dismal inheritance when he took over in October 2022. The Conservatives were more than 20 points behind in the polls, following the scandals of Boris Johnson's tenure and the economic shock of Liz Truss's.

"Sunak failed to distance himself from his unpopular predecessors. Having promised "integrity, professionalism and accountability at every level", he reappoint-

ed Gavin Williamson and Suella Braverman to the cabinet after they had been forced to resign. He approved resignation honours lists for Truss and Johnson, even though the latter would soon be censured by the House of Commons for lying over lockdown parties.

"Short-trousered in public and short-tempered in private, Sunak quickly looked unprepared for his rapid promotion. "Ineffectual is the first word that springs to mind," said **Tim Bale**, professor of politics at Queen Mary University of London. "Just because you inherit a poisoned chalice doesn't mean you have to drink it."

Sinn Féin now largest party in Northern Ireland

Sinn Féin is now the largest party across Northern Ireland's councils, assembly and at Westminster.

The nationalist party, which does not take its seats in the House of Commons, has seven seats after Thursday's UK general election, the same number as in 2019.

Its leader, Mary Lou McDonald, said it was time to "prepare for a new future together on this island".

The party came out on top after a disappointing night for the Democratic Unionist Party (DUP).

The DUP had eight seats in 2019 and returns in 2024 with five.

Its most high profile casualty in Thursday's vote was Ian Paisley, who lost the North Antrim seat his father had first won in 1970.

In Lagan Valley, Sorcha Eastwood of the Alliance Party took the seat which had been held by the former DUP leader Sir Jeffrey Donaldson since 1997.

Robin Swann of the Ulster Unionist Party (UUP) won in South Antrim at the expense of the DUP's Paul Girvan.

For Sinn Féin, there was a 4.2% increase in vote share compared to the general election five years ago.

The party also welcomed new faces, including Dáire Hughes and Cathal Mallaghan.

Former Royal College of Nursing leader Pat Cullen, a prominent figure during recent UK health strikes, was returned for Sinn Féin in Fermanagh and South Tyrone.

Ms McDonald said Sinn Féin was "determined to build a constructive relationship with the new Labour government".

She said her party expected the new prime minister "to uphold the Good Friday Agreement, which Labour helped deliver.

Inching Up: Green Party wins four seats

The Green Party has had its most successful election night ever after winning four seats.

Up until now, the party had only ever won in the East Sussex constituency of Brighton Pavilion.

In this election, the Green Party was able to hold that seat, whilst also securing wins in Bristol Central, Waveney Valley and North Herefordshire.

Party co-leader Carla Denyer said Bristol had "made history" by electing her as the city's first Green MP.

She defeated Labour's shadow culture secretary Thangam Debbonaire by a majority of 10,000.

Her co-leader Adrian Ramsay overturned a

22,000 Conservative majority to win Waveney Valley, with a huge swing to his party of 32.1%.

The Green Party is currently on course to win 7% of the vote which would be its best general election performance yet.

public support

At the last general election in 2019, it secured less than 3%.

Ms Denyer said she believed there was public support for the party's policies - including a proposal to increase the minimum wage and raise taxes to help invest in public services.

She said people had been hesitant about voting for her party in the past because they didn't

think they would win.

However, she said her result proved that "if you want Green, you can vote Green and you will get a Green MP".

The Green Party won a seat in the House of Commons for the first

time in 2010, when Caroline Lucas became the MP for Brighton Pavilion. Last year, she said she would not be standing again.

Sian Berry took on the seat for her party, winning with a majority of

14,000 - down by around 5,000 from the last election.

In North Herefordshire, Ellie Chowns defeated the Conservatives' Bill Wiggin, who had previously held the seat with a 25,000 majority.

Wales: Labour roars back with string of wins

Labour has won back a string of Welsh seats from the Conservatives, as Sir Keir Starmer's landslide election victory was confirmed.

The Tories were wiped out in Wales, with Welsh Secretary David TC Davies losing his seat, as well as the three former Welsh secretaries, Alun Cairns, Stephen Crabb and Simon Hart.

triumphant night

Labour finished on 27 seats, up nine on 2019, Plaid on four and the Lib Dems one.

Another ousted Tory was Craig Williams, former aide to Rishi Sunak, who had party support withdrawn after admitting betting on the date of the election.

On a triumphant night for Labour, and a disastrous one for the Tories, Plaid Cymru celebrated winning both its target seats of Ynys Môn and Caerfyrddin from the Conservatives.

There was good news for the Liberal Democrats, who took back

Brecon, Radnor and Cwm Tawe seat from the Conservatives, removing Wales Office minister Fay Jones from parliament.

It means the Lib Dems have a Welsh MP for the first time since 2019.

Labour won back Bridgend, Monmouthshire and Wrexham and also took the new seats of Bangor Aberconwy, Clwyd North, Clwyd East, Montgomeryshire and Glyndŵr and Mid and South Pembrokeshire from the Conservatives.

Labour held Swansea West, with a win for new candidate and Starmer ally Torsten Bell, widely seen as ripe for early promotion in the new government expected to take power on Friday.

Tories on zero

Labour retained Gower, Pontypridd, Torfaen, Caerphilly, Newport East, Aberfan Maesteg, Rhondda and Ogmore and Cardiff South and Penarth.

The party also kept

control of Alyn and Deeside, Llanelli, Cardiff West, Cardiff East, Merthyr Tydfil and Aberdare and the Blaenau Gwent and Rhymney constituency.

Labour's Kanishka Narayan became the first ethnic minority Welsh MP, in the Vale of Glamorgan.

The Tories were reduced from 14 seats in Boris Johnson's 2019 election victory to none under Rishi Sunak.

Labour, with the help of Plaid Cymru, saw the Tories fall to zero seats in Wales on Friday for the first time since 2001. They have been badly damaged by the performance of Nigel Farage's Reform UK, which split the right-wing vote and came second in a series of seats.

But Labour also saw its vote share fall to 37%, from 40.9%.

Plaid Cymru hugely increased its majority in Ceredigion Preseli and easily retained Dwyfor Meirionnydd, finishing the night on four seats.

Across Europe the result was cautiously welcomed, with Germany's Frankfurter Allgemeine Zeitung stating the results mean "the British [have] had a burden lifted from their shoulders", but any renewed stability in the UK is seen as fragile.

Voters "were primarily concerned with getting rid of the Conservatives," the paper says, adding that "Labour has a stable majority, but also problems within the party".

German business daily Handelsblatt says the British election result "opens up the opportunity to correct Brexit".

"Now is the time to correct one of the biggest mistakes in British politics. A security pact with the EU can only be the beginning," the paper said.

Mr Farage's success attracted a lot of attention. German Tabloid Bild dubbed it an "election earthquake", albeit one for which the

paper says Labour can be thankful, seeing that Reform took many votes from the Conservatives.

French media largely hails Labour's victory, also noting the election of Nigel Farage. Le Figaro says that despite the Reform party leader's success in Clacton, "the British people have overwhelmingly chosen a moderate centre-left leader".

According to Le Monde, the UK's return to the centre-left is "striking, especially seen from France, where the far right has the wind in its sails on the eve of the second round of the legislative elections".

Italian newspaper Il Corriere della Sera says of the Conservative defeat: "The party of Winston Churchill and Margaret Thatcher emerges from this election with broken bones: it will take years to recover. Has the right-wing wind that blows across the continent stopped at the English Channel? Obviously not... If the person in charge disappoints, he is replaced."

Truss, Rees-Mogg and other Tory big beasts lose their seats

Former prime minister Liz Truss has lost her seat in Labour's landslide election victory, as the Conservatives slump to a historic defeat.

She lost her South West Norfolk constituency to Labour by 630 votes, having previously held a huge 24,180 majority.

The ex-premier was among a clutch of senior Tories ejected from Parliament, in a result set to reshape the direction of the party.

These include Commons leader Penny Mordaunt, who was tipped as a future Tory leadership contender, and former cabinet minister Sir Jacob Rees-Mogg.

'a battering'

But Chancellor Jeremy Hunt, who had been seen as vulnerable in his Godalming and Ash constituency, managed to hold on with a slender 891 majority.

Speaking after her defeat, Ms Truss said her party had not "delivered sufficiently" in areas such as "keeping taxes low" and reducing immigration.

Asked if she would stay on in Conservative politics, Ms Truss said "I've got a lot to think about" and asked people to "give me a bit of time". With only a small number of seats left to declare,

the Conservatives are heading for a historic loss in terms of seats after a dramatic 20 point decline in support.

The party lost a string of seats in southern England to the Liberal Democrats, who have won over 70 seats and are set for their best result in a century.

Unlike the last election in 2019, when as the Brexit Party it stood aside in more than 300 Tory-held seats, Reform's decision to field candidates across Britain contributed to heavy Tory losses, particularly in Brexit-voting areas.

Twelve ministers attending cabinet have lost their seats, including Defence Secretary Grant Shapps, Justice Secretary Alex Chalk and Technology Secretary Michelle Donelan.

Conceding the election after he was re-elected in Richmond and Northal-

lerton, Prime Minister Rishi Sunak called the results a "sobering verdict" for his party.

Speaking after losing her seat, Ms Mordaunt said her party had "taken a battering because it failed to honour the trust that people had placed in it".

'terrible night'

She warned against "talking to an ever smaller slice of ourselves," adding, "if we want again to be the natural party of government, then our values must be the people's".

In other high-profile Tory losses:

Veterans Minister **Johnny Mercer** lost to Labour in Plymouth Moor View

Education Secretary **Gillian Keegan** lost to the Liberal Democrats in Chichester, a West Sussex seat the Tories have held for a century

Speaking earlier, before his defeat, Sir Jacob said it was "clearly a terrible night" for his party, that had come to take its "core vote for granted".

"We need to win voters at every single election. If you take your base for granted... your voters will

look to other parties." He thought the party had made a mistake by ousting Boris Johnson, who led it to victory in the 2019 election but was forced to step down as prime minister in 2022 following a series of scandals.

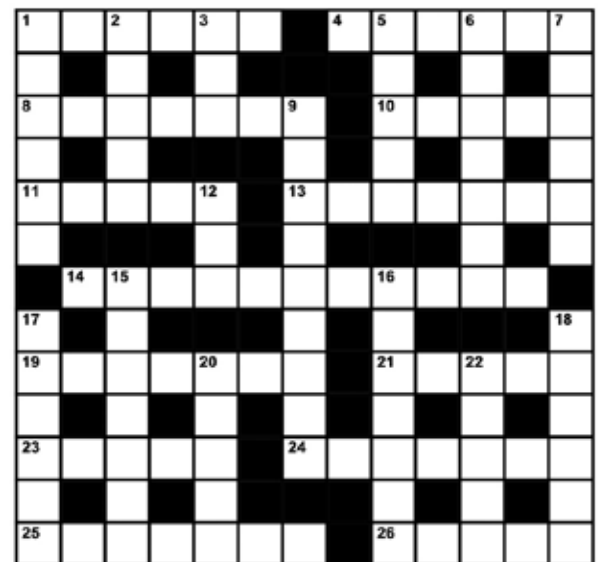

utes into the game," he added.

"To change the mindset, and for us all to keep the belief, it has a lot of power behind it - for ourselves and other teams."

The Manchester City centre-back also said he is "all good" despite appearing in training with heavy strapping around his knee on Wednesday.

Stones will have to find a new centre-back partner with Marc Guehi suspended for Saturday's quarter-final.

Manager Gareth Southgate will take charge of his 100th game at the weekend, but it hasn't been easy for the England boss at Euro 2024.

His side have faced jeers - and even some cups being thrown by angry supporters - amid underwhelming performances, but they were greeted by a better reaction after beating Slovakia.

Stones said the criticism Southgate has faced will further motivate the Three Lions manager.

He added: "He pushes it aside, I can only comment on how that'll only affect him in a good way. It will make him want to win even more, do better. It gets brushed aside very quickly."

As Southgate nears his landmark century, Stones praised the way the 53-year-old has changed the national team's "culture" as they look to win a first major trophy.

"The great attributes and qualities he has as a manager - he's simple and clear with what he wants," added Stones.

"To be here and try to leave a mark in this tournament is important and we have that goal at the end of it, to do something that has not been done before."

Following a legendary Anfield figure like Jurgen Klopp is a challenge to embrace rather than shy away from, said Arne Slot in his first news conference as Liverpool manager.

Dutchman Slot has signed a three-year deal and succeeds Klopp, who stood down after eight-and-a-half largely successful seasons.

The 45-year-old only has to look at Manchester United to understand how much of a struggle it can be replacing an iconic manager.

However, the former Feyenoord chief has no trepidation about the task that lies ahead.

"You can look at it both ways," he said. "They are big shoes to fill but you are also inheriting a squad and a team which has a winning culture."

"As a manager you want to work at a club with good players and an opportunity to win something. The past has shown there is a possibility to win some trophies. I look at it as ideal."

Slot feels planning conversations with play-

ers are a normal part of the job and unrelated to the legacy Klopp has left behind.

"As a manager, you go to bed at night and think about what you are going to do and what you will tell the players," he said. "That is not just the first day, it is the whole period."

"People look at us and think we only think about the tactics board but you have to think about the way you talk to the players. It is not about convincing them, it is part of the job to think about the

best way to get the best out of them; whether to approach them as an individual or as a team.

"I don't have Jurgen Klopp in mind, thinking 'what would he say'. No. I have to get to know the players to get the maximum out of them."

Slot has spoken to Klopp, although he is not willing to divulge the advice imparted by

the German.

However, he is thankful Klopp sang a song in his honour at the end of his final game at Anfield.

"That was special," he said. "There are not many managers the fans sing for. They did for me after a few years at Feyenoord but without having worked here, the fans singing is a good start."

UEFA clears both big Manchester clubs to play in Europe next season

Manchester City and Manchester United have been cleared to take their places in European competition next season after conflicts over multi-club ownership with Girona and Nice respectively were resolved.

However, United will be prevented from signing highly-rated Nice defender Jean-Clair Todibo by Uefa.

City Football Group owns City and Girona, while Ineos controls the football operations of United and Nice, and Uefa does not allow clubs with the same ownership to be involved in the same competition.

The Club Financial Control Body (CFCB) of European football's governing body said on Friday "significant changes" had been made at Girona and Nice which would "substantially restrict investors' influence

and decision-making power".

In addition, shares have been transferred through independent trustees to a blind trust, which will be supervised by the CFCB.

Among additional guarantees given by the City Football Group and Sir Jim Ratcliffe's Ineos Group to prove the independence of the respective clubs, they agreed not to transfer players "permanently or on loan, either directly or indirectly from July 2024 to September 2025".

This means United will not be able to sign Frenchman Todibo, the £40m-rated defender Ratcliffe had hoped would switch clubs.

However, City's pursuit of Brazilian winger Savio will be unaffected as he has returned to parent club Troyes, who are also part of the City Football Group, after his loan with Gi-

rona expired on 30 June.

A CFG source told reporters that City and Girona were compliant with all the CFCB requests.

Ineos said in a statement: "We are pleased with the positive decision from the First Chamber of the Uefa Club Financial Control Body which will see Manchester United play in the Europa League next season. The focus for Manchester United is on

the season ahead and performance on the pitch."

City will be playing in their 14th consecutive Champions League campaign, but Girona qualified for the first time by finishing third in La Liga, their highest ever league position.

Nice also seemed set to qualify for Europe's most prestigious club competition for a long time last season, but eventually finished fifth in Ligue 1. Man-

chester United qualified for the Europa League by beating Premier League champions City in the FA Cup final.

It remains to be seen how the matter is dealt with over the longer term, given the shares are due to be transferred back in July 2025.

At that point, CFCB say the clubs will be considered to be "under the control or decisive influence of their investor".

England exhales as Jude let off lightly...

■ Star man free to play against Swiss after UEFA investigation into Slovakia gesture

Jude Bellingham is free to play in England's Euro 2024 quarter-final against Switzerland on Saturday after being given a one-match suspended ban and fine for a gesture he made in the last-16 win over Slovakia.

The 21-year-old's ban is suspended for a year and he has also been fined £25,400 (30,000 Euros).

The midfielder's crotch-grabbing gesture towards the Slovakian bench after scoring a late equaliser in the 2-1 victory was investigated by Uefa.

Bellingham, who has made the gesture while playing for his club side Real Madrid, denied that it was aimed at England's opponents.

Responding to the incident on social media, Bellingham said it

was "an inside-joke gesture towards some close friends who were at the game", adding he had "nothing but respect for how Slovakia played".

"I thought it was a common sense decision," manager Gareth Southgate said of the sanction when asked later on Friday.

"Clearly when you score a goal of the quality that he did at the moment that he is you are going to have an incredible rush of adrenaline.

"I think there was no intent in the gesture towards anybody other than communication he has with his family. From our perspective we thought it was a sensible outcome."

Bellingham has started all four of England's Euro 2024 matches, scoring two of England's

four goals in Germany, including the 95th-minute overhead kick equaliser against Slovakia.

England play a dangerous and cohesive Switzerland side in Dusseldorf today, a match where they must raise their game significantly if they are to progress in the competition.

Meanwhile, the Football Association has been fined £9,310 (11,000 euros) for crowd issues involving England supporters. A fine of 10,000 euros was issued for crowd disturbances, and 1,000 euros for lighting fireworks.

While Bellingham is available for Saturday's match, Turkey defender Merih Demiral has been handed a two-match ban for a gesture he made during his side's last-16 win against Austria.

Slovakia drama 'helped us' says Stones

John Stones says England's dramatic last-16 comeback win against Slovakia could prove an "emotional turning point" in their bid for Euro 2024 glory.

The Three Lions emerged 2-1 victors after Jude Bellingham levelled with an injury-time overhead kick, before captain Harry Kane notched the decisive strike in extra

time.

Stones, speaking as England prepared for Saturday's quarter-final against Switzerland (17:00), said the success will "change a lot of things".

"It shows that unity, and togetherness, as a team," said the 30-year-old defender.

When you have done those things, you can be-

lieve you can do it better, and when it gets tough you can always recap to these moments."

Stones felt England were heading for an early exit before their late fightback - and will now use that performance as "fuel" for the rest of the tournament.

"I thought we were going home up to 60 min-
