UNITED AGAINST HATE

Thousands come together to face down far-right rioters • Law enforcement delivers swift justice after country is racked by a week of anti-immigrant violence

BRITONS in their tens of thousands turned out to face down far-right thugs this week, following several days of sickening violence that threatened to tear the country apart.

Thousands of anti-racist protesters took to the streets of several major cities and smaller towns on Wednesday and Thursday in a show of love over hate - prompting the hate-mongers behind gatherings targeting immigration centres to backpedal on the gatherings ever being planned.

Around 100 hate-fuelled protests were planned across the country on Wednesday night, many of which were planned in now-deleted far-right groups on apps such as Telegram, with police deployed in their biggest mobilisation of resources since the 2011 riots.

chaos and disorder

Thugs had been using now-banned channels on the app to threaten the lives of anti-racism campaigners, make sick slurs and exchange tips on how to 'hood up'. But their promises to turn up at immigration centers at 8pm

vanished into thin air in face of overwhelming opposition from law-abiding Britons.

Police estimated at least 25,000 anti-racist activists turned out in force in cities across the UK - and said that tempers were also cooled by drizzly weather that hit southern parts of England on Wednesday night.

And to add to a strong sense that law and order was being restored, scores of protesters from violent clashes earlier in the week were arrested with dozens of convictions sealed in rapid time, as courts worked 24-hour shifts to process the backlog quickly and create a stern deterrent for other would-be troublemakers.

Almost a week of chaos and disorder was sparked by the stabbing deaths of three young girls at a Taylor Swift-themed dance class in Southport on July 29.

In the days that followed more than 100 people were arrested

and dozens of police injured in the biggest outbreak of nationwide public disorder in decades.

'criminal thuggery'

The powder keg atmosphere exploded into full-blown mayhem and disorder as mobs ran riot in major towns and cities across the UK, fuelled by baseless social media claims and anonymous messaging apps linked to Russian disinformation bot farms.

In some cases fami-

lies were forced to flee homes and businesses as protests hijacked by far-right thugs turned into full-scale riots, triggering "criminal thuggery", ransacking and looting.

Hundreds participated in widespread disorder in Liverpool, Manchester, Rotherham, Middlesbrough and other towns across the north of England in which police struggled to avoid being overwhelmed. Many protesters could be heard chanting "We want

our country back" and "Tommy Robinson" the alter-ego of Stephen Yaxley-Lennon, once the de-facto leader of the far-right group the English Defence League. Meanwhile their hero encouraged their actions via social media... from the comfort of a sunbed at a resort in Cyprus, where he is currently on holiday.

Robert Jenrick, the Tory leadership candidate and former immigration minister, said: "You've got some far-

right thugs, you've got groups of yobs, morons joining in marauding around the streets smashing up shops, attacking communities [and] attacking a mosque, in one case.

"There is no justification for the violence that we're seeing on the streets and the millions of people in our country who feel angry at mass migration should not be tarnished with the brush of what is happening in those towns and cities right now."

Hard men turn soft when faced with stiff jail terms

■ Courts work 24-hour shifts to jail riot ringleaders

At least two grown men wept in the dock on Wednesday as courts began handing out justice for sickening riots sweeping the country.

More than 20 people including a boy of 14 appeared in court charged with offences including violent disorder, burglary, assaulting emergency workers and arson.

It came as Home Secretary Yvette Cooper warned thugs to expect police knocking on the door as she pledged swift justice and a "reckoning" for those involved in violence.

Andrew Smith, 41, of Sunderland, sobbed as he pleaded guilty to violent disorder in the city last Friday. At Newcastle Crown Court he was remanded in custody until his sentencing on September 2.

A 14-year-old, who cannot be named, appeared at Liverpool Magistrates' Court to admit violent disorder after setting off fireworks towards the public and a police car.

He was reported as saying "I'm sorry, I wasn't firing them at you though" when he was arrested by a police officer

after giving chase.

At Sheffield Magistrates' Court, Chris Coulson, 30, wiped away tears as he denied an offence of affray.

He was remanded in custody and will go on trial next month.

Eleven people appeared in court in Liverpool on Wednesday, seven of whom pleaded guilty to violent disorder and other crimes.

Adam Wharton, 28, indicated a guilty plea for looting the city's Spellow Library, which had been set alight during the riot.

Derek Drummond, 58, indicated guilty pleas to violent disorder and assaulting an emergency worker, after he allegedly punched a police officer in the face.

The oldest, William Morgan, 69, from Walton, admitted possessing an offensive weapon after being caught throwing bricks at police and holding a wooden baton.

Declan Geiran, 29, pleaded guilty to arson after using an "implement" to set fire to a police van.

In Sunderland, Josh Kellett, 29, who had worn a balaclava but was iden-

tified by "distinctive" tattoos, admitted throwing stones at police.

Three people also appeared in court in Belfast.

Earlier, Ms Cooper warned courts were on "standby" to deal with thugs and all those involved would "pay the price for their crimes" - including those inciting violence on social media.

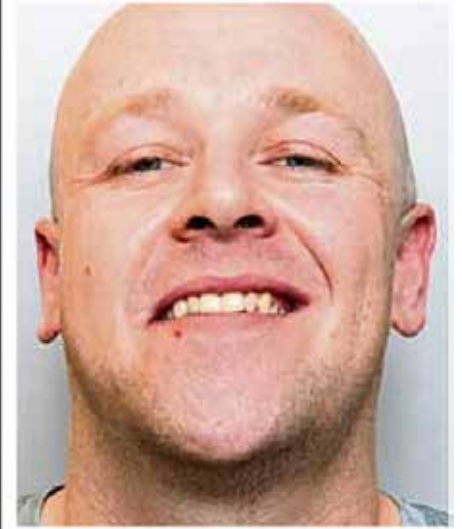
The Home Secretary said: "If it's a crime offline, it's a crime online."

"You can't just have the armchair thuggery or the people being able to incite and organise violence and also not face consequences for this."

"So we should be clear: there will be people who were thinking they were going on their summer holidays this week, and instead they will face a knock on the door from the police."

Ms Cooper also became the first Government figure to use the term Islamophobia to describe the actions of some rioters behind the unrest.

She said: "We have certainly seen some targeted attacks on mosques and that clearly reflects Islamophobia and people shouldn't be targeted for

their faith or for the colour of their skin.

As more than 400 people were arrested and 100 charged for shocking acts of lawlessness, England's top prosecutor said he would consider laying terrorism charges.

Director of Public Prosecutions Stephen Parkinson said: "Where you have organised groups planning activity for the purposes of advancing an ideology...planning really, really serious dis-

ruption, then yes, we will consider terrorism offences."

Mr Parkinson said he wanted online influencers abroad who stirred up unrest to face justice. He added:

"We have liaison prosecutors spread around the globe who've got local links with the local judiciary and law enforcement."

To handle the expected prisoner surge, Justice Minister Heidi Alexander

said 567 more jail places had been laid on, with 6,000 specialist police officers at the ready.

She said overnight courts could be made to work because "these are extraordinary circumstances and we need to be delivering swift justice".

The minister warned: "We will make sure anyone who is given a custodial sentence as a result of the riots and disorder, there will be a prison place waiting for them."

Amid a flurry of fake news stories, shadowy Russian bots stoked much of the disorder



TELEGRAM: Conversations on the popular messaging app appear to link Russian channels to the UK riots

IN A WORRYING development for British democracy, it emerged this week that foreign-backed actors - mostly Russian - used bot accounts to share anti-immigration narratives to stoke division and encourage this week's riots.

Conversations between Russian trolls on Telegram appeared to speak about how they had infiltrated British far-right channels on the platform to organize anti-Muslim demonstrations across the UK.

Other Russian language channels spoke

about 'deliberately' stirring far-right channels to anger members, according to several news sources.

A Russian Telegram channel called 'Old England' sent a screenshot from a far-right UK Telegram channel, appearing **cont. on page 5, col. 2**

Arrest for Southport killer rumor monger

A WEALTHY British woman accused of being first to spread the fake rumours about the Southport killer which sparked nationwide riots has been arrested.

Racist riots spread across the country after misinformation spread on social media claiming the fatal stabbing was carried out by Ali Al-Shakati, believed to be a fictitious name, a Muslim asylum seeker who was on an MI6 watchlist.

Bonnie Spofforth, a mother-of-three and the managing director of a clothing company, been arrested on suspicion of publishing written material to stir up racial hatred, and false communication. She remains in police custody.

Chief Superintendent Alison Ross said: 'We have all seen the violent disorder that has taken place across the UK over the past week, much of which has been fuelled by malicious and inaccurate communications online.'

'It's a stark reminder of the dangers of posting information on social media platforms without checking the accuracy.'

Spofforth, 55, posted the false claim at 4.49pm on Monday, July 29, the day of the attack, saying: 'Ali Al-Shakati was the suspect, he was an asylum seeker who came to the UK by boat last year and was on an MI6 watch list. If this is true, then all hell is about to break loose.'

The businesswoman, who lives in a £1.5million farmhouse in Cheshire, denied she had made up the story, telling reporters she 'first received this information from somebody in Southport'.

'I'm mortified that I'm being accused of this. I did not make it up', she said.

Musk and Starmer clash over 'two-tier' policing

"Civil War is inevitable" claims the erratic billionaire, alleging British police crack down harder on far-right demonstrators than on militant Islamists

Elon Musk has clashed with Keir Starmer on X, accusing the Prime Minister of discriminatory "two-tiered" policing as authorities scramble to clamp down on violent far-right riots against Muslims and immigrants that have rocked the country for a week.

The posts came after 10 Downing Street on Monday criticised earlier comments by the billionaire and technology entrepreneur on his X platform, saying that Musk "does not speak for Britain".

On Sunday, Musk tweeted that "civil war is inevitable," in the UK, in response to a post claiming that "open borders and migration" had led to the protests.

'no justification'

The anti-migration narrative that is being spread on social channels has been blamed for sparking the disorder in the first place, after misinformation spread online that a 17-year-old suspect who killed three girls in a mass stabbing in Southport was a Muslim immigrant. That claim has since been debunked, as the suspect is confirmed to have been born in the UK.

The UK government condemned the post on Monday.

"There's no justification for comments like that," a spokesperson for Starmer told reporters. "What we've seen in this country is organized, violent thuggery that has no place, either on our streets or online. We're talking about a minority of thugs that do not speak for Britain ... I think you can tell from that that the prime minister does not share those sentiments."

The billionaire has since Monday retweeted or commented under posts attacking UK authorities for arresting and charging suspects arrested

for taking part in the riots.

In one response to a post that claimed that an "armed Muslim" patrol group had attacked civilians and a news network crew, Musk directly tweeted at Prime Minister Starmer, asking: "Why aren't all communities protected?"

Musk has also tweeted in support of those attacking officials for arresting people believed to have posted offensive comments online, espousing a "free speech absolutist" stance he has long pushed. He posted a meme of a cartoon character strapped to an electrocution chair and likened the scene to the punishment people would face for posting their views online in the UK by 2030.

"Is this Britain or the Soviet Union?" he asked in yet another tweet.

'very thin line'

Musk's claims were dismissed by Lee McGowan, a professor studying far-right groups at Belfast's Queen's University who said: "Musk and others would claim the right of free speech and for people to say what they want, but there is a very thin line here.... "These influencers are channeling hate. In Belfast, we have seen some shops attacked even where the owners - who are paying taxes and contributing to society - and are legally entitled to be here, have had their premises attacked and burnt out."

Musk further tweeted the hashtag #TwoTierKeir, referencing controversial theories being spread that claim authorities are cracking down more severely on the protesting groups than on minorities.

London Met Police Commissioner Sir Mark Rowley told Sky News



Musk also claimed Starmer planned to send rioters to camps on the Falkland Islands

on Wednesday that the claim was "complete nonsense".

"We have commentators from either end of the political spectrum

who like to throw accusations of bias at the police because we stand in the middle, we operate independently under the law without fear or favour...

"The serious voices who echo those are of more concern to me because the risk is ... they legitimise the violence cont. on page 4, col. 1

that the officers I'm sending (out) today, will face on the streets ... they are putting them at risk."

And on Thursday Musk was at it again, sharing fake claims that convicted rioters would be sent to detention camps in the Falklands.

Musk deleted his post after about 30 minutes but not before it had garnered nearly two million views.

In it, Musk shared the image posted by the co-leader of the far-right group Britain First, Ashlea Simon, which she captioned with, "we're all being deported to the Falklands".

The fake piece, purportedly written by a senior news reporter for the Telegraph and mocked up in the newspaper's style, said camps in the Falklands "would be used to detain prisoners from the ongoing riots as the British prison system is already at capacity".

The Telegraph said on Thursday it had never published the article in question. In a statement, a spokesperson for the Telegraph Media Group said: "This is a fabricated headline for an article that does not exist. We notified relevant platforms and requested that the post be taken down."

Musk, who is the billionaire co-founder of SpaceX and chief executive of Tesla, bought Twitter in 2022 for \$44bn. He rebranded it as X last year. There has been a string of controversies about the direction the platform has taken under his leadership, including accusations that he is not serious enough about removing harmful content.

The Royal National Orthopaedic Hospital NHS trust said in a post on Thursday that it was closing its account on X after 13 years because the platform is "no longer consistent with our Trust values".

Begum may take UK to ECHR over citizenship

Shamima Begum's lawyers could take her case to the European Court of Human Rights.

The 24-year-old was this week denied the chance to challenge the removal of her British citizenship at the Supreme Court.

Last year, she lost her appeal against the decision on national security grounds.

It was made after she was found in a Syrian refugee camp having travelled to so-called Islamic State-controlled territory in 2015.

On Monday justices at the UK's highest court said Ms Begum could not appeal again after she lost a Court of Appeal bid in February.

Following the ruling, her lawyers said they "will take every possible legal step" on her behalf, including a petition to Strasbourg.

"The UK courts have for five years offered no exit route despite the critical humanitarian crisis in the camps.

"Instead the Supreme Court has today left resolution to another court, this time in Strasbourg."

BRITONS are being urged to leave Lebanon urgently amid deepening tensions in the region.

UK forces have been deployed in the area to help with any evacuations as tensions rise – with worries the "situation could deteriorate rapidly".

'tensions are high'

Consular experts were drafted in to help with plans as the RAF put transport helicopters on standby. Landing ship RFA Cardigan Bay and destroyer HMS Duncan

Jenrick emerges as man to beat

Robert Jenrick is the frontrunner in the race for the Tory leadership, polling shows.

The former immigration minister and standard-bearer for the Tory Right is ahead on 24.2%, a survey of 468 party members suggests.

To tackle the small boats crisis, he backs leaving the European Convention on Human Rights – something 86% of those polled agree with.

Shadow housing secretary Kemi Badenoch and former home secretary Dame Priti Patel – both prominent figures on the Right – are close behind him on 23.4% and 21% respectively.

Shadow home secretary James Cleverly is fourth with 4.9%, followed by shadow security minister Tom Tugendhat on 3.4% while shadow work and pensions secretary Mel Stride has 1.9%.

However, just over one in five said they were undecided in the survey carried out from July 31 to August 5.

Mark Littlewood, director of Popular Conservatism, a Right-wing Tory faction which carried out the research, said: "With a significant

number still undecided, everything is to play for.

"It is imperative that Conservative MPs offer the membership a proper choice in the last two candidates from whom the members will choose."

'root and branch reform'

The poll also found an overwhelming 90% either strongly agree or agree that the Conservative Party needs to become more democratic, with a greater role for members in choosing leaders, policies and candidates.

More than three-quarters said Rishi Sunak's successor should welcome Reform UK MPs, candidates and members into the Tory fold.

Just over four in five

said the Tories should focus on winning over the four million voters who backed Nigel Farage's party at the general election.

Mr Littlewood added: "Members want a return to popular Conservative policies. They want root-and-branch reform of the party's structures to make it more democratic and they want the wider Conservative family to unite to avoid a future defeat similar to July's election defeat.

"Whoever becomes leader will have to address those concerns – concerns which we hear from members every day. If they do, the party will have a route back into government."

It follows a declaration by Dame Priti that she is the candidate to repair the party after its crushing defeat.

She told GB News: "Having been a member for 30 years, I've been consistent in my views, my beliefs, my values.

"I am not a politician that's had to go on a journey to rediscover myself or my views. People know what they get with me."

Denying Conservatism has "failed", she added: "We need to come together and stand up for who we are and demonstrate to the British people our views are their views and actually we can represent the hard-working silent majority of our country."

Brits urged: Get out of Lebanon now

are already in the Mediterranean to support humanitarian efforts.

Foreign Secretary David Lammy said: "Tensions are high, and the situation could deteriorate rapidly. While we are working round the clock to strengthen our consular presence in Lebanon, my message to British nationals there is clear – leave now.

"A widening of this conflict is in nobody's interest – the consequences could be catastrophic. That's why we continue to call for de-escalation and a diplomatic solu-

tion."

Western diplomats are trying frantically to calm escalating tensions after the killing of Hamas political leader Ismail Haniyeh in Tehran by Israel.

retaliation

The US has since urged Israel to seize the chance for a ceasefire. The killing of Haniyeh plus Israel's assassination of a Hezbollah chief in Lebanese capital Beirut have the region holding its breath. Retaliation against Israel is feared on either front or both

after Iran and its terrorist proxies vowed to act.

Israel's PM Benjamin Netanyahu had said retaliation would follow after a Hezbollah rocket strike in the Israel-occupied Golan Heights killed 12 children on July 27.

With the potential for exits from Lebanon being limited or closed amid little warning if conflict widens, British citizens are being urged to go while commercial options remain available.

Already several airlines have suspended,

rescheduled or cancelled flights to and from Beirut. Elsewhere, a Palestinian knifeman killed two elderly civilians and wounded two more in a Tel Aviv suburb.

In the wake of that rampage, which ended when the attacker was shot dead by police, Israeli strikes killed 18 people in Gaza.

Hamas, which is at war with Israel in the enclave, called the stabbings a "natural response" to Israeli attacks on Palestinians and to the assassination of Haniyeh last week.

Stride: No deal With Reform Party on my watch

Mel Stride has become the first Tory leadership candidate to rule out any deal with Nigel Farage or the Reform Party.

After the first day of violent disorders across Britain last week, Mr Farage questioned whether the truth about the Southport stabbings was "being withheld from us", adding "I don't know the answer to that, but I think it is a fair and legitimate question".

Mr Stride said: "In making these statements he has linked the violence to community division resulting from immigration. He is irresponsible and wrong to fuel the fires of rumour and in doing so, can only further damage social cohesion."

The MP for Central Devon added: "As leader I will reunite and rebuild trust in the Conservative Party. Some have suggested that a deal should be done with Mr Farage as part of that process.

"That will not happen under my leadership."

to show messages reading 'from Russia with love' and 'we support you'.

An investigation by leading British news outlet Metro.co.uk into the organising tactics of the far-right had revealed a sophisticated network of influencers working to seed anti-Muslim and Islamophobic narratives, spread misinformation and stage violent demonstrations in some of the UK's most vulnerable communities.

'misinformation'

Following the riot on July 30, more ads calling for anti-Islam demonstrations began to spread on local group chats, resulting in more than a hundred demonstrations erupting across the country.

Technology Minister Peter Kyle said the Government had "seen bot activity online, much of which may well be amplified by foreign state actors amplifying some of the disinformation and misinformation that we've seen."

"Anyone who stokes this violence, whether on the internet or in person, can be prosecuted and face prison."

Kyle also met with tech firms to urge them to do more to clamp

down on inflammatory and far-right content online and to ensure they are not promoting inflammatory content.

Following his talks, he said: "The terrible violence we have witnessed in recent days is disgraceful."

"I have been clear it is unacceptable that people are using social media to cause damage, distress and destruction in our communities."

"Today I had useful meetings with Tiktok, Meta, Google and X, to make clear their responsibility to continue to work with us to stop the spread of hateful misinformation and incitement."

"There is a significant amount of content circulating that platforms need to be dealing with at pace."

Swift action by the government, law enforcement and 24-hour session courts during the week has resulted in stiff sentences for ring-leaders of the violence, which has caused tensions to go off the boil by the weekend, although the mood remained tense as the weekend approached.

With 6,000 riot officers mobilized by midweek, Prime Minister Keir Starmer was able to deliver on his pledge that troublemakers be handed 'substantive' prison sentences 'before the end of this week'.



Katie Price boobs again

Katie Price has been arrested at Heathrow Airport for failing to attend court and taken into police custody.

An arrest warrant was issued for the former glamour model on 30 July after she failed to attend a court hearing relating to her bankruptcies.

The Metropolitan Police said a 46-year-old woman was arrested at Heathrow Airport at

19:45 BST.

Ms Price will appear before a judge at the Royal Courts of Justice on Friday.

Ms Price was detained after returning to the UK. Photos have emerged showing her with bandages around her face, near police vans at the airport.

A judge at a previous hearing said she risked arrest if she did not attend

further court dates, adding that evidence must be provided if she could not appear.

Ms Price was declared bankrupt in November 2019 and again in March this year.

At a hearing in February, she was ordered to pay 40% of her monthly income from the website OnlyFans for the next three years, in relation to her first bankruptcy.

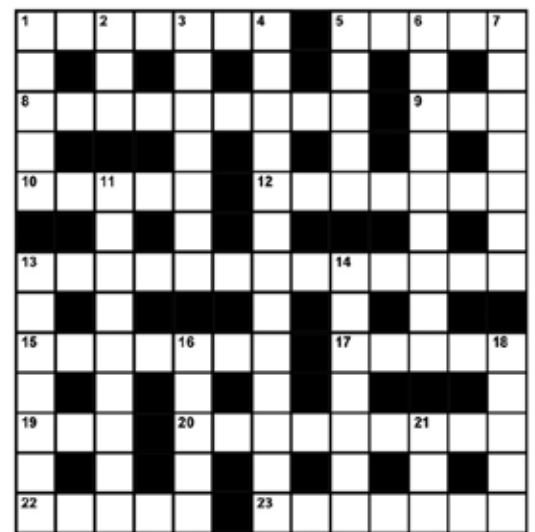

If no written objection is timely filed, the court may grant the petition without a hearing.

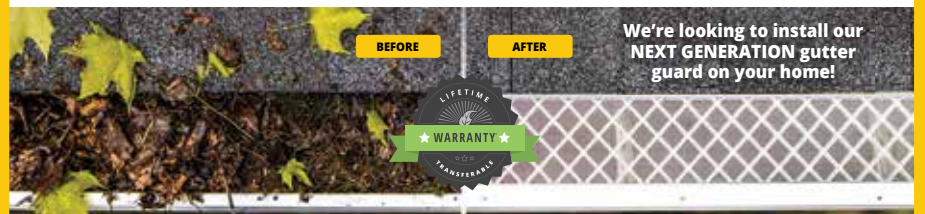

Richi rejects Saudi switch

Striker Richarlison says he wants to stay at Tottenham Hotspur after turning down a move to Saudi Arabia.

The Brazil forward, 27, joined Spurs from Everton in 2022 for a club-record fee of £60m.

He has scored 15 goals in 66 appearances for Tottenham and was not always a starter last season under manager Ange Postecoglou.

Richarlison, whose contract runs until 2027, has attracted interest

from a number of clubs in Saudi Arabia, with one unnamed team tabling a bid.

However, he says he wants to remain in England in order to improve his chances of continuing his international

career with Brazil.

"There has been an offer but my dream of playing for the Brazilian Selecao and in the Premier League speaks louder," Richarlison told ESPN Brazil, external.

Spurs are interested in signing a striker this summer and have identified Bournemouth's Dominic Solanke as a target.

The Cherries are keen to keep Solanke, who scored 21 goals in 42 games for Bournemouth last season but was overlooked for England's Euro 2024 squad.

He has a £65m release clause in his Bournemouth contract - which has three years left on it - but Tottenham value the striker at a lower price.

Chelsea winger Raheem Sterling says he misses playing for England because it is "one of the best feelings you can ever have".

The 29-year-old has not played for his country since the 2022 World Cup, when he flew home to attend a family emergency during the tournament in Qatar.

Former Three Lions boss Gareth Southgate left the forward out of multiple squads after that, including his party for Euro 2024.

Southgate resigned following the defeat against Spain in the final and the Football Association is yet to appoint his successor, but Under-21 boss Lee Carsley is expected to take interim charge for the Nations League games in September.

When asked if he misses being around the England camp, Sterling said: "Of course, I love playing for England. It is one of the best feelings you can ever have.

"To see the boys out there brought me joy. To be honest they were the only games I watched - the England ones."

Leading England batsman Graham Thorpe dead at 55

■ Doughty left-hander enjoyed stellar career for county and country

THE CRICKET world was this week mourning English batsman Graham Thorpe, who has died aged 55.

The doughty left-hander will be remembered as one of the best batters of his generation. Across his 100 Tests between 1993 and 2005, Thorpe was a world-class player in a struggling England side and a key part in the upturn that followed.

With his trademark headband in place, he could grind out runs against some of the game's greats or lead a brave counter-attack with a flurry of boundaries.

Between his playing and coaching careers, Thorpe spent nearly 30 years as a key part of the England set-up.

Thorpe's skill was developed on the club grounds of Surrey, the county he would go on to represent throughout his entire first-class career from 1988 to 2005.

On his England debut against Australia in 1993 he scored a second-innings 114 not out, having come in with the hosts in a precarious position.

It was a clear sign of what was to come.

Thorpe, who hit 2,380

runs in 82 one-day internationals, would go on to score 6,744 runs in 100 Tests at an average of 44.66, with 16 hundreds.

He scored a swash-buckling 200 not out, his highest Test score, from 231 balls against New Zealand in 2002, having dug in for 118 from 301 against Pakistan in Lahore 16 months earlier - a knock containing just two boundaries.

Fearless against pace and one of England's best against spin, Thorpe averaged 45.17 at home, 47.85 in Asia and 48.18 in Australia - a player for all situations.

Ask his former captain Nasser Hussain to rank England's best players of that era and Thorpe's name would be near the top, if not number one, in the list.

"When people reel off the list of England greats, he seems to slip people's minds, but he was a man for a crisis, for a battle," Hussain said in 2021.

Thorpe was the stern-faced rock in a batting line-up that faltered all too often - the one England fans could usually rely on.

In one of that side's greatest victories, against Pakistan in Karachi in 2000, it was Thorpe who

hit the winning runs in the gloom, ending 64 not out.

He was also a fine fielder and particularly accomplished in the slips.

But it was not all success.

After he had previously missed tours because of the challenges of life on the road, Thorpe's first marriage publicly broke down in 2002.

He subsequently took an indefinite break from cricket and, despite initially making himself available, pulled out of England's 2002-03 Ashes squad to face Australia.

Thorpe would miss more than a year at international level, but he returned with what he described as his finest innings.

After being recalled in 2003 for the final Test of the summer at the Oval, he scored 124 in the first innings against South Africa.

In typically composed style he held his arms aloft and punched the air after reaching three figures, his home crowd giving an emotional, extended ovation from the stands.

"There were times when I thought I wasn't going to play again and more importantly I had

to wipe away the memory of how I walked away from cricket last year," he said afterwards.

"I didn't want to leave cricket like that, and you couldn't have written it better to get a century on your home ground."

That innings marked the start of a resurgence for Thorpe in the latter years of his career.

After his recall, he scored 1,635 runs at 56.37 as England's fortunes improved under new captain Michael Vaughan.

Thorpe hit five centuries in that period, including one packed with his trademark grit, batting with a broken finger against West Indies.

He played his 100th Test against Bangladesh early in the 2005 season, but it proved to be his last.

Having played in five unsuccessful Ashes series, Thorpe was left out when Vaughan's side famously won back the

urn in 2005, the younger batting options of Ian Bell and Kevin Pietersen preferred.

After retiring that summer, Thorpe began coaching in Australia with New South Wales.

He soon returned to work with Surrey and by 2010 was again involved in the England set-up, as

batting coach of the development Lions side before moving up to assist the senior men's side.

He left his role as assistant coach in February 2022 after a 4-0 Ashes defeat in Australia, but also had been part of the backroom team for England's 50-over World Cup win in 2019.

Alvarez off to Atleti

Atletico Madrid have agreed an £81.5m deal to sign Manchester City forward Julian Alvarez.

The fee is made up of an initial £64.4m (75m euros) with a further £17.1m (20m euros) in potential add-ons.

It would be a record sale for City, surpassing the £50m Chelsea paid for Raheem Sterling in 2022.

Alvarez said he would wait until Argentina's involvement in the 2024 Olympics football end-

ed before making a decision on his future. The team were knocked out by hosts France last Friday.

City manager Pep Guardiola had been keen to keep the 24-year-old, and said earlier in August he "counted" on Alvarez before the start of the season.

"I count on him, but he said in the news that decisions will be made all together," said Guardiola.

But, as has been the case in the past with

Ilkay Gundogan, Riyad Mahrez and Aymeric Laporte, City will not stand in the way of a player who wants to leave.

Atletico, who have also agreed a deal to sign Chelsea midfielder Conor Gallagher, are yet to agree personal terms with Alvarez.

The Argentine, who joined City in 2022 in a £14.1m deal from River Plate, has scored 36 goals in 106 appearances for Guardiola's side.

Keely's just golden!

■ Lancashire flyer ends Team GB's long wait for Olympic athletics gold with dominating performance in 800m

BRITISH ATHLETICS has a new golden girl and her name is Keely Hodgkinson.

On a steamy night in northern Paris on Monday, the 800m star did not just live up to her billing as a gold medal certainty, she did so with a generational performance.

The 22-year-old Lancashire flyer lit up the City of Light with a remarkable performance securing Team GB's first Olympic gold medal in athletics for eight years while upgrading the silver she bagged in Tokyo in 2020.

Wigan-born Keely has now emulated her hero Dame Kelly Holmes who won 800m and 1,500m gold in an unforgettable Athens Olympics double 20 years ago.

Leading from start to finish, Keely made light work of the two-lap race and on crossing the line sobbed after realising her life's dream.

She said: "I have worked so hard for this and you could see how much it meant to me when I crossed the line. I am the Olympic champion for the next four years and no one can take that away from me."

Draped in a Union flag, she sought out her emotional mum and dad, Dean and Rachel, in the crowd at the Stade de France.

She went to the front with just over 500m left, and dictated matters until crossing the line in 1min 56.72secs, comfortably ahead of Ethiopia's Tsige Duguma and Kenya's Mary Moraa. In fact, she dictated matters from the off.

As she pulled away in the home straight, Hodgkinson even had time to

look up at the giant screen to see her epic finish in all its cinematic glory.

Then came the emotion, then came the celebrations.

The smiling blonde, who describes herself as a "risk-taker with a rebellious stride", now has the world at her feet.

Among the many wanting to embrace her was Lord Coe, the double Olympic champion over 1500m who gathered two silvers at 800m to boot.

He is an all-time great of middle-distance running and that is what Hodgkinson will now surely become.

Such is her self-belief, though, such is her talent, Hodgkinson might even think about doubling up with the 1500m.

But that is all to come. In a city made for this most stylish of athletes, the youngster will enjoy this magnificent feat for now.

Cycling gold

There was also joy for Team GB on a night of high drama at a blisteringly hot Saint Quentin-en-Yvelines velodrome, where the female track cycling sprint trio of Katy Marchant, Sophie Capewell and Emma Finucane, who set a world record in qualifying, then sealed gold and another new world record cheered on by Sophie, Duchess of Edinburgh.

The victory was particularly emotional for Capewell, 25, whose dad Nigel came fourth in Paralympic track cycling at Atlanta 1996 and Sydney 2000. He passed away in 2021.

On the water Joe Clarke, 31, grabbed silver in the men's canoe slalom while reigning world champion

Kimberley Woods, 28, snatched a bronze in the women's equivalent to go with her earlier kayak slalom third place finish.

In an event making its Olympic debut Clarke, overlooked for Tokyo 2020, had to settle for second after missing out on a medal in the men's kayak single final. He said: "I came here for gold. I've got silver, which I'm very proud of. What a Games."

triathlon bronze

Earlier, defending champions Britain were forced to settle for bronze in the triathlon mixed team relay after initially being announced as silver medallists following a photo finish with the USA. Amid chaos and confusion after a thrilling race lasting 1hr 25 mins and 39 seconds, the Team GB quartet of Alex Yee, Georgia Taylor-Brown, Samuel Dickinson and Beth Potter were downgraded after officials reviewed the photo finish.

The podium place was a third triathlon medal for Team GB at the Games after individual gold for Yee and bronze for Potter.
