ROYAL ACCLAIM FOR GB'S OLYMPIC HEROES

"Well done on all you've achieved, you've been an inspiration to us all."

THE King has hailed the "raw talent, true grit and hard toil" of Team GB after our sporting heroes matched the Olympic medal count from London 2012.

The curtain came down on the Paris Games on Sunday with British athletes winning a total of 65 medals – 14 golds, 22 silvers and 29 bronze – beating by one the haul from Tokyo three years ago.

The thrilling final day saw cyclist Emma Finucane taking bronze in the individual sprint to become the first British woman in 60 years to win three medals at a single Olympics. Emily Campbell completed the medal tally with a brilliant bronze in the 81kg+weightlifting.

Charles, with Queen Camilla, released a moving message at the end of the two-week sporting extravaganza. He wrote: "My wife joins me in sending our warmest congratulations to the competitors and their support teams from Team GB, and across the whole Commonwealth, for their many outstand-

ing successes at the Olympic Games in Paris.

"Your achievements, across so many disciplines, were forged from that invaluable combination of raw talent, true grit and hard toil over many years, burnished these past weeks by sportsmanship and team spirit in the finest tradition of the Games.

'entertaining a nation'

"To those who missed out on the greatest prizes, you have most certainly not fallen short in the pride that you, too, have generated for your nations. As we thank France for hosting such a wonderful tournament and look to the Paralympics ahead, I can only say that you have all been an inspiration."

The Prince and Princess of Wales posted a video message on social media, which included an introduction by US rapper Snoop Dogg and

a clip from David Beckham.

Kate, in a rare appearance due to her cancer fight, said: "From all of us watching at home, congratulations to Team GB."

And unshaven William, wearing a Team GB shirt, added: "Well done on all you've achieved, you've been an inspiration to us all."

Prime Minister Sir Keir Starmer posted: "You're bringing home more than just medals. You've inspired a new generation of athletes while entertaining a nation. Thank you."

'on top of the world'

Sunday's final sporting action began at 7am with the women's cycling marathon.

The first British medal came from Belfast-born Emma, 21, who had already won bronze in the keirin and gold in the team sprint. She beamed: "I feel on top of the world.

"This week has been a rollercoaster, so many highs and so many lows. That bronze medal felt like a gold medal to me."

The spirit of Team GB could not be better highlighted than in the performance of Nottingham's Emily.

Though she had hoped to upgrade her silver from Tokyo, the 30-year-

old celebrated her third place with a cartwheel across the stage after lifting a personal best of 288kg in total. She said: "In Tokyo, I was new to the sport and enjoying things, it was a bonus medal. This one has come

On-stage prankster leaves Truss seething

Liz Truss walked off stage at a public event this week after a banner showing a picture of a lettuce and the words "I crashed the economy" was unfurled above her.

The former prime minister was on stage at Beccles Public Hall, Suffolk, when the banner appeared.

A video posted on X showed the speech being stopped and Ms Truss saying "that's not funny" before walking off stage.

The activism group Led By Donkeys claimed responsibility for the stunt, while Suffolk Police said a man had been arrested and released without charge.

"Liz Truss is on a pro-Trump speaking tour. So we dropped a strategically-positioned remote-controlled lettuce banner," the group posted on social media.


"She didn't find it fun-

Before the event, a spokesperson for Beccles Public Hall had urged people to "remain civil". An advert posted on Facebook last week said: "We recognise that people have differing opinions on politics.

"We would however encourage any dialogue to remain civil."

In 2022, during Ms Truss' 49 days as prime minister, the Daily Star newspaper created a live web-cam feed to test whether her term in office would outlast a 60p iceberg lettuce.

It was in response to her mini-Budget, which included £45bn of unfunded tax cuts and triggered economic turmoil.

Ms Truss lost the South West Norfolk seat, which she had held for the Conservatives since 2010, in July's general election.

"What Led By Donkeys did is the best thing I've ever seen happen at Beccles Public Hall," said Paul Williams, 54, a businessman in Beccles.

"I've seen increases in my mortgage payments and I'm sure everyone else has because of her mini budget.

"I fully back [Led By Donkeys] and I actually support them."

Leanne Howes, 43, visiting Beccles from nearby Lowestoft, defended Ms Truss' right to freedom of expression.

"I'm not a fan of Liz Truss but I think anyone who is on stage and expressing what they want to do have freedom of speech.

"We are entitled to say what we want... Everyone has the right to express how they feel, even if we don't agree with it,"

Intelligence have become increasingly concerned that Iran is ramping up preparations for a possible attack following the death of Hamas's political leader Ismail Haniyeh in Tehran.

A report by the Iranian news agency said President Pezeshkian had a late Monday night phone conversation with Sir Keir and added: "Pezeshkian stated that from the point of view of the Islamic Republic of Iran, war in any part of the world is not in the interest of any country, emphasizing that a punitive response to an aggressor is a legal right of states and a way to stop crime and aggression."

Mr Pezeshkian said that the West's silence about "unprecedented

mane crime" in Gaza and Israeli attacks elsewhere in the Middle East was "irresponsible" and encouraged Israel to put regional and global security at risk.

Pezeshkian has acknowledged that he will follow the orders of Iranian Supreme Leader Ayatollah Ali Khamenei, who has already said that Israel "paved the way for a severe punishment upon itself with this action".

Accusing Israel of having violated Iran's "sovereignty and territorial integrity" by killing Haniyeh in Tehran, Iranian Foreign Ministry spokesman Nasser Kanaani said in a statement shared on Telegram that calls for Iran to de-escalate "lack political logic" and "amount to open and practical support for the source of international crimes and terrorism in the region".

Two boys of 12 among those convicted following Southport riots

- Pair are youngest rioters convicted of a criminal offence following widespread disorder across the UK
 - British justice system moves fast with almost 1,000 sentenced in past ten days to provide visible deterrent

TWO boys aged 12 have become the youngest rioters convicted of a criminal offence in the wake of the Southport attack.

The first youngster admitted two charges of violent disorder after throwing a missile at a police van and taking part in two separate incidents of unrest.

Magistrates heard the child, who cannot be named for legal reasons, was part of a group that gathered on July 31 outside a hotel housing asylum seekers.

petrol bombs

Prosecutors said the boy was "filmed by police kicking the front window of a vape shop" and was also seen kicking a bus as it drove past him in Manchester.

He will be sentenced at Manchester Magistrates' Court on September 2.

Another 12-year-old appeared at Liverpool Youth Court charged with violent disorder in Southport on July 30 and also pleaded guilty.

Jessica Pridding, prosecuting, said: "The defendant was seen on CCTV among the crowd and he appears on the footage to throw something towards the line of uniformed police officers carrying shields. He appears to mount a bicycle and ride away from the police officers."

He will be sentenced on September 17.

An 11-year-old boy has been charged with rioting and throwing petrol bombs after disorder in Belfast on July 15. He is due to appear at Belfast Youth Court on September 6.

Another man was jailed after punching a police officer in the face during disorder at an anti-immigration protest in Weymouth, Dorset.

'shameful disorder'

Jason Barry Francis, 38, was jailed for two years after pleading guilty to violent disorder and assault of an emergency worker at Bournemouth Crown Court yesterday.

Elsewhere, a man was jailed for two years and eight months at Sheffield Crown Court for his part in the rioting outside a hotel housing asylum seekers in Rotherham.

Ricky Hardman, 41, was arrested after a picture of him brandishing a piece of wood during

In Manchester, a man has admitted throwing a missile at police during "shameful disorder" in Bolton town centre on August 4. Niall Charnock, 31, was caught on social media footage breaking through a police barricade and throwing something at officers.

'celebrating'

At Teesside Crown Court, a 22-year-old who threw a vacuum cleaner through a house window and told a police officer, "I hope your children get raped", during riots in Middlesbrough was jailed for 26 months.

Thomas Rogers pleaded guilty to violent disorder and possession of an offensive weapon after he was seen throwing bricks at police. A teenager seen "celebrating" after throwing a rock which hit a police officer during riots in Darlington was detained for 18 months.

Meanwhile in Birmingham, a rapper who posted a video falsely accusing right wing ac-



tivist Tommy Robinson of calling on people to attack mosques has appeared in court. Omar Abdirizak is charged with conveying information known to be false, intending to cause

non-trivial psychological or physical harm.

But despite the government's determination to crack down swiftly and harshly on rioters, it has also emerged that many of them could be released from prison after serving just 40% of their sentence, Downing Street has admitted. The prison overcrowding crisis has forced ministers to take emergency action.



15 months for housewife who told her FB group to "blow up mosques"

A housewife who told her local Facebook group to "blow the mosques up with adults in it" has been jailed for 15 months.

Julie Sweeney, 53, was one of a number of people appearing in court following rioting across the country sparked by misinformation about the killings of three girls in Southport.

At Chester Crown Court, Sweeney, 53, admitted posting the message from her home in Church Lawton, Cheshire, on August 3.

After she was arrested she said: "I'm not being rude but there are a lot of people saying it." Sweeney now admits posting the comment "in anger", insisting she had "no intention to put people in

Sentencing, Judge Steven Everett said: "Socalled keyboard warriors like her have to learn to take responsibility for

their language.'

Her jailing came as those held for allegedly being involved in the mayhem reached 1,024 with 575 charged. One judge said the leaders should face rioting charges with a 10year sentence.

Judge John Thackray KC had to hand a threeyear term to a yob who kicked a female police officer to the ground in Hull.

The 27-year-old Scot, his skin suit ripped, lay on the Saint-Quentinen-Yvelines Velodrome floor as medics rushed to his aid.

But he later said: "I'm all right. I'm just a bit sore, but that is part and parcel of racing. I mucked it up a little bit." Team GB finished the Olympics in seventh place. The athletes did not secure as many gold medals as previous games with the 14 this time compared with 22 in Tokyo and a record breaking 29 in London.

While it was an extraordinary performance from Team GB, it was even more so for Sam Reardon.

'non stop journey'

The accidental Olympian clinched two medals despite not knowing he would be competing until after the Games had started. Sam had been training at his local track at Bromley in South London, when he was called up as a replacement. A day later, he landed in Paris and by the end of the first weekend of athletics action, he had helped Britain's mixed 4x400m team to bronze.

And on the final night, he added men's 4x400m bronze.

Sam, 20, said: "It's been a crazy non-stop journey. I'm forever a double Olympic medallist. I could end my career here and be happy."

Thomas Bach, the In-Olympic ternational Committee president, revealed on Saturday he will stand down next year. World Athletics chief Lord Coe stopped short of officially throwing his hat in the ring but said: "I've always made it clear if the opportunity arose I would give it serious thought." Lord Coe, 67, and a former Tory MP, won four Olympic medals and is still the only man to have twice been crowned men's 1500m champion.

Scotch of the rocks!

■ Neolithic structure's famed Altar Stone transported from Scotland, new research reveals

THE iconic Altar Stone at Stonehenge came from Scotland, not Wales as previously thought – and may have been transported by sea, a study has found.

Research into the giant rock also suggests that long-distance trade networks existed in the Neolithic period some 5,000 years ago, say scientists.

It had been believed that the six-ton slab probably originated in the Brecon Beacons in Wales.

But Australian scientists now think that it hails from North East Scotland, more than 460 miles from its World-Heritage site on Salisbury Plain.

They employed advanced mass spectrometer devices to examine the composition of the Altar Stone.

The team's findings, published in the journal

Nature, point to the existence of "unexpectedly advanced" transport at the time of the stone's arrival in modern-day Wiltshire.

'chemical fingerprint'

Researchers from Perth's Curtin University studied the age and chemistry of mineral grains in fragments of the recumbent megalith. The 50cm-thick (20in) sandstone block measuring 5m by 1m (16ft x 3ft) sits at the centre of the landmark stone circle.

Study lead author Anthony Clarke said analysis matched the fragments with rocks from Scotland – and differentiated them from Welsh bedrock. He added: "This provides a distinct chemical fingerprint suggesting the stone came from rocks in the Orcadian Basin. The findings raise fascinating questions...as

to how such a massive stone was transported over vast distances around 2,600 BC."

The PhD student revealed: "This discovery also holds personal significance. I grew up in the Mynydd Preseli [Preseli Mountains], Wales, where some of Stonehenge's stones came from. I first visited Stonehenge when I was one year old and now, at 25, I returned from

Australia to help make this scientific discovery...I've come full circle at the stone circle."

Co-author Prof Chris Kirkland said the results had "significant" implications for understanding ancient communities: "Transporting such massive cargo overland from Scotland to southern England would have been extremely challenging, indicating a likely marine shipping route."

The study was done in collaboration with Aberystwyth University, Adelaide University and University College London. Prof Richard Bevins, of Aberystwyth, said the findings overturned the century-old view of the stone's origin, adding: "The hunt will still very much be on to pin down where exactly in the North East of Scotland the Altar Stone came from."

DOWN WONDER: healthy Aussies are living longer

THEY may be Down Under but their life expectations are well over those of other English-speaking nations.

Research has revealed Australians outlive people in Canada, Ireland, New Zealand, the UK and the US by up to five years. Most of the lifespan advantage accrues between the ages of 45 and 84 with death rates from drug and alcohol misuse, cancer, and cardiovascular and respiratory diseases all lower.

Experts said there are several explanations for Australia's high ranking, including the country's large proportion of people born overseas – nearly 30% in 2018 – from populations with high life expectancies. Other reasons include a low prevalence of smoking, public mental health initiatives and a highly rated healthcare system.

Study author Professor

Jessica Ho, of Pennsylvania State University, US, said: "Australia performs well. Overall, Australia offers a potential model for lower-performing Anglophone countries, such as the US and UK, to follow to reduce both premature mortality and inequalities in life expectancy."

Australia has a four to five-year life expectancy advantage over the US and a one to two-and-a-half-year advantage over Canada, New Zealand, Ireland and the UK. All regions in the UK and Ireland have life expectancies above 81 for women and 76.5 for men.

pleaded guilty to violent disorder and assaulting an emergency worker, after playing a "prominent role" on August 3. Hull Crown Court heard he led a group confronting police trying to protect a hotel housing asylum seekers and was seen charging at officers. Whiteley was also in a group that targeted a garage, setting cars alight and threatening staff.

Sentencing him, the judge said: "The prosecution do need to look, for those who are playing front and central roles, at the alternative charge of riot rather than violent disorder."

In Sheffield, Glyn Guest, 60, was jailed for two years and eight months.

He pulled a female officer to the ground and grabbed her riot shield near a Rotherham hotel housing asylum seekers.

At the same court, dadof-three Trevor Lloyd, 49, who was part of a mob that stormed the hotel, was also jailed for three

At Manchester Magistrates' Court, Warren Gilchrest, 52, was convicted of encouraging violence in the city's Piccadilly Gardens. He told a judge: "I'm guilty, Miss, but I'm not sure what it means."

In Birmingham, Habeeb Khan pleaded not guilty at the city's crown court to a charge of possessing an imitation AK-47 assault rifle with intent to cause "members of the [English Defence League]" to believe violence would be used against them.

Khan, 49, also denied sending a threatening communication on social media. He was remanded ahead of his trial in November.

The Crown Prosecution Service said it has worked around the clock to ensure people "face the consequences of their actions".

Graham Thorpe threw himself in front of train, inquest hears

■ English cricketing great had suffered long battle with depression and had attempted suicide before, heartbroken wife reveals

The former England cricketer Graham Thorpe died after being struck by a train at a railway station in Surrey, the opening of an inquest into his death has heard. The 55-year-old took his own life, his wife, Amanda, revealed on Monday.

Thorpe died on the morning of 4 August having suffered "traumatic injuries" during the incident at Esher railway station, Surrey coroner's court in Woking heard on Tuesday.

The area coroner for Surrey, Simon Wickens,

recorded his cause of death as one of multiple injuries. He offered his condolences not just to Thorpe's family, but to "all those touched by his life and career". A date for the full inquest will be fixed at a later time.

The coroner had received a referral from British Transport Police. The force said previously: "Officers were called to Esher railway station at 8.26am on August 4 to reports of a casualty on the tracks.

Paramedics also attended, however sadly a person was pronounced dead at the scene. The

incident is not being treated as suspicious."

Amanda Thorpe told The Times that her husband attempted suicide two years ago. "Graham was renowned as someone who was very mentally strong on the field and he was in good physical health," she said. "But mental illness is a real disease and can affect anyone. Despite having a wife and two daughters whom he loved and who loved him, he did not get bet-

"He was so unwell in recent times and he really did believe that we would be better off without him and we are devastated that he acted on that and took his own life."

She and their two daughters – Kitty, 22, and 19-year-old Emma – have detailed his long-term battle with mental health in the hope this will inspire others to seek help.

Amanda said he always played down, especially to their daughters, his achievements. But she stressed the family held wonderful memories, how "Thor-

pey" treasured them and how he would "get up and dance anywhere, to anything".

Amanda went on: "That's the Graham I know and remember and loved. Graham was a free spirit."

She said she would now fight for others struggling with mental health issues by creating a foundation in her husband's name.

Kitty said of his health battles: "We are not ashamed of talking about it. There is nothing to hide. This is the time to share the news, however horrible it is. He loved us but he just couldn't see a way out."

Emma said: "I didn't really realise how good he was until reading all the tributes. If someone

asked him what he did, he'd say he knocked a ball about a bit."

In reality, he hit 16 Test hundreds for England and represented his country 182 times.

Thorpe, who also had children Henry and Amelia from his first marriage, made his international debut in 1993 and retired from playing in 2005.



AFTER FOUR years' service as HM's Consul General in Los Angeles, Emily Cloke's term will step down at the end of this month.

Before joining the diplomatic service Ms. Cloke started her career as a lawyer in the City of London after studying law at Cambridge University. She later worked overseas as Trade Director for the British Embassy in Tehran, setting up and leading the UK's trade section and strategy following the re-opening of the British Embassy in 2015, and as Head of Trade at the British Embassy Sweden, before coming to Los Angeles in 2020.

As the senior representative of the UK government in Southern California, Arizona, Nevada, Utah and Hawaii, her remit is to promote trade and investment, scientific cooperation, tackling climate change, creative and media collaborations and educational partnerships between the UK and the southwestern United States. She also oversees delivery of essential consular services to a 600,000-strong British resident community and British visitors.

Confirming her departure this week, Ms Cloke penned the following goodbye members of the British American Chamber of Commerce:





The Olympians arrived back in London on the Eurostar on Monday morning, disembarking at St Pancras station where they were met by fans and London Mayor Sadiq Khan. The athletes, many proudly wearing their golds, silvers and bronzes, were

met by cheers from waiting fans.

For Daley, it was a bitter-sweet moment as he confirmed his retirement, while also revealing he had accidentally left his silver medal behind in Paris. The diving superstar said: "It was emotional at the end, up there on the platform, knowing it was my last competitive dive. But I have to make the decision at some point and it feels like the right time. It's the right time to call it a day."

Having stepped away from the sport in 2021 after the Tokyo Olympics, Daley made a return last year at the request of his son. His appearance in Paris made him the first British diver to compete at five Olympics.

Daley, who won Olympic gold at the Tokyo Games, said: "There was a lot of pressure and expectations. I was eager for it to be done.

"But when I walked out, and saw my husband and kids and my friends and family in the audience, I was like, you know what? This is exactly why I did this."

Asked what he would do next, he said he intends to spend more time with his children and his knitting.

Triathlon gold medallist Alex Yee told the awaiting media he didn't have much time off to celebrate his big victory.

The Paris sensation said: "Well, we've got a race on Saturday. It's non-stop for us triathletes."

of me and I cannot wait to work with him again. I know what it takes to succeed at the highest level. I'm determined to continue that record at this special club."

Mazraoui, 26, who has also agreed a five-year contract with a further 12-month option, also played under Ten Hag at Ajax.

The Morocco rightback said: "Erik ten Hag played an important part in my development as a player, so it's exciting to be reuniting with him as I enter the prime years of my career. I know what he expects from his players and I'll give everything to help the group be successful.

"I know that I'm joining the club at an exciting time. Everyone I've spoken to has the same ambition for us to win trophies together and I can feel the determination to achieve that."

The pair are set to make their debuts in Friday night's Premier League opener against Fulham at Old Trafford.

Ten Hag is still in the

market for a holding midfielder to sit alongside Kobbie Mainoo and United have identified Paris Saint-Germain's Manuel Ugarte, Burnley's Sander Berge and Monaco's Youssouf Fofana as options.

Luke Shaw has suffered another injury blow, which United say will keep him out until next month's international break.

Vardy fairy tale opens new chapter with top flight return

IAMIE Vardy finds himself back in the Premier League this month, in the unlikely position of leading his team's front line at the ripe old age of

But the Leicester City striker is used to bucking the odds, only turning professional at 24 and later firing his team to a Cinderella Premier League title and earning several England caps.

Vardy sold the film rights to his life story years ago. The only reason it has not been made is that his rags-to-riches tale may still have a way to go.

If he can lead Leicester to Premier League salvation this season, that will surely provide a fitting pay-off.

Vardy grew up in Sheffield, was rejected by boyhood club Wednesday,

played part-time and was convicted of assault following a punch-up outside a nightclub before his aptitude in front of goal began to surface.

Fast forward through spells at Stocksbridge Park Steels, Halifax and Fleetwood before he ended up in the East Midlands.

Since then, he has helped the 5,000-1 outsiders lift the Premier League trophy, tasted Champions League football, enjoyed FA Cup success and, after Leicester were relegated, he helped return them at the first time of asking.

Vardy's Foxes - with whom he has spent 12 seasons - are odds-on favourites to return to the Championship at the first time of asking.

"It's a big blow for Ben and England as he's captained the Test team remarkably well," former England captain Michael Vaughan told reporters.

"Let's hope he can get fit for Pakistan, then New Zealand, then everyone will be thinking about next year - fingers crossed Ben can get this injury right and have a fully fit 2025."

Former Chelsea star William Gallas has accused the club's owners of turning the Blues into an "average club" that no

one fears.

The two-time Premier League winner (pictured, right) played at Stamford Bridge during their trophy-laden era, but that has all changed under Todd Boehly and Clearlake Capital.

More than £1billion has been shelled out on new talent but Chelsea have had two of their worst seasons in recent

memory and Gallas does not believe many would get near the Blues teams

He said: "I'm looking at this squad and I don't see nearly enough quality. There are so many players in the squad that don't have the quality to play for Chelsea.

"I look at some of these guys and there is no way they would get into the best Chelsea teams from the past few years – half of them wouldn't get on the bench.

"These players aren't



good enough to win a Premier League title and that should always be the aim of a club like

Chelsea. Are they good enough to qualify for the Champions League? I have serious doubts."

First blood to Pep's boys

■ City edge game United on penalties at Wembley in curtain-raiser as Walker declares: 'title is ours to lose'

Manchester City avenged their FA Cup final defeat by Manchester United as Pep Guardiola's side triumphed 7-6 on penalties after the Community Shield had finished level at Wembley last weekend.

Bernardo Silva levelled for the Blues in the final minute but then had City's first spot-kick saved by Andre Onana to give United the advantage.

However, Ederson saved Jadon Sancho's effort before veteran defender Jonny Evans fired over, allowing Manuel Akanji to secure victory in this competition for the first time since 2019 in front of 78,416.

Alejandro Garnacho thought he had given United victory nine minutes from time when he collected possession at the end of a flowing move deep into the City half, instigated by skipper Bruno Fernandes, and then drove a low shot into the bottom corner.

Silva's initial bad-tempered response to that was to barge into Garnacho long after he had moved the ball on to earn himself a booking.

The Portuguese's next intervention was far more positive. As young Norwegian Oscar Bobb was spinning into space by the goal-line, Silva was pulling onto makeshift left-back Facundo Pellistri at the far post. Hardly the tallest, Silva had enough spring and intuition to climb above the Uruguayan and head in the equaliser at the far post.

It set up a climax that triggered elation in the City ranks and disappointment among the United support, many of whom left well before the trophy presentation.

The thrilling ending was hardly in keeping with a sometimes stodgy occasion as both sides struggled to reach their highest levels.

Both sides hit the post. James McAtee did so in the first half when he seized on a wayward Lisandro Martinez pass. Marcus Rashford did the same in the second, when he sent Garnacho's low cross against the base of the post with only Ederson to beat.

Following the win City defender Kyle Walker claimed a record fifth successive Premier League title for Manchester City "is our trophy to lose".

City begin their historic quest at Chelsea on Sunday and Walker believes no other side will ever have the chance to lift five consecutive titles.

The City skipper said: "I wouldn't say it's ego, but we've done this four
