GRENFELL: 72 KILLED BY 'DISHONESTY, INDIFFERENCE AND COMPLACENCY'

■ Damning report exposes 'path to disaster' that turned Grenfell Tower into death trap

GREED, dishonesty and complacency put Grenfell Tower on a "path to disaster" that ended with the tragic loss of 72 lives, a damning report has declared.

After a seven-year inquiry found decades of wrongdoing, failures and negligence prior to the inferno, Sir Keir Starmer apologized on behalf of the state.

The Prime Minister admitted that victims and their families were "let down very badly" before, during and after the London tower block blaze fire in 2017.

But despite the report's hard-hitting findings, bereaved relatives still face a long fight for justice, since any criminal prosecutions are unlikely to start for at least 18 months.

Yvette Williams, from campaign group Justice4Grenfell, said: "The wheels of justice turn very slowly, especially when communities like ours are the victims and the perpetrators are the wealthy and powerful.

"We cannot understand why the police need another 18 months when they have all the forensic evidence they need from the tower and should have been gathering evidence from the inquiry along the way." The painstaking in-

vestigation by retired judge Sir Martin Moore-Bick into the horror on June 14, 2017 declared that every one of the 72 deaths could have been prevented.

'badly failed'

His 1,700-page report detailed failures by architects, refurbishment firms, regulators, the local council and different governments.

Sir Martin said: "Those who lived in the tower were badly failed over a number of years and in a number of different ways by those who were responsible for ensuring the safety of the building and its occupants."

He named architects Studio E, principal contractor Rydon Maintenance and some of its sub-contractors, including Harley Curtain Wall, which became Harley Facades.

The report also criticized the tenant management group, makers of Grenfell's cladding and officials who certified its suitability for use on high-rises. Sir Martin said: "Not all of them

bear the same degree of responsibility for the eventual disaster but... all contributed to it in one way or another, in most cases through incompetence but in some cases through dishonesty and greed."

He said that no one involved in the design of external walls or the choice of materials, such as Studio E, "acted in accordance with the standards of a reasonably competent person in their position". The firm had a "cavalier attitude" to fire safety regulations while Rydon and Harley relied on experience rather than technical analysis or expertise.

'dishonest scheme'

There were emotional scenes as Sir Martin addressed the bereaved and survivors at Dorland House, West London.

The inquiry's seven-volume findings showed people in positions of responsibility did not heed or act on warnings from earlier blazes. A year before Grenfell, the then-Tory government was "well

aware" of the risks of combustible cladding and insulation, particularly in high-rises, "but failed to act".

A drive to cut red tape years before meant that safety fears were "ignored, delayed or disregarded" despite the Lakanal House fire that killed six in Camberwell in 2009.

Three companies were subject to particularly heavy criticism: Cladding firm Arconic "concealed from the market the true extent of the danger" of using its product, particularly on high-rises; Kingspan, which "knowingly created a false market in in-

sulation" for buildings over 60ft high and Celotex, which wanted to tap into that market, "embarked on a dishonest scheme to mislead its customers".

Sir Martin said: "One very significant reason why Grenfell Tower came to be clad in combustible materials was systematic dishonesty on the part of those who made and sold the rain-screen cladding panels and insulation." The blaze was "the culmination of decades of failure by central government and other bodies in positions of responsibility in the construction industry to look carefully

into the danger of incorporating combustible materials into the external walls of high-rise residential buildings".

Sir Keir now aims to stop firms involved in the disaster from receiving government contracts. He said it was "imperative that there is full accountability, including through the criminal justice process, and that this happens as swiftly as possible".

Baroness Theresa May, the Prime Minister at the time of the disaster, said national and local government, regulators and industry "must all acknowledge their part".

Tory councillor's wife facing 'substantial' jail term for urging attacks on asylum seekers

THE wife of a Conservative councillor has admitted sending a social media message stirring up racial hatred against asylum seekers on the day of the Southport attacks.

Lucy Connolly, who is married to West Northamptonshire councillor Raymond Connolly, pleaded guilty at Northampton Crown Court on Monday to a charge of inciting racial hatred by publishing and distributing "threatening or abusive" written material on Twitter/X.

Details of the offence were not opened by the prosecutor in the case but a previous hearing was told the 41-year-old childminder posted

a message which read: "Mass deportation now, set fire to all the f***** hotels full of the bastards for all I care... If that makes me racist, so be it."

Connolly, of Parkfield Avenue, Northampton, entered her guilty plea via a video-link to HMP Peterborough during a hearing lasting just seven minutes.

'racist mindset'

Connolly spoke only to enter her plea and confirm that she could hear the judge.

Adjourning Connolly's case for sentence at Birmingham Crown Court on October 17, Judge Adrienne Lucking KC told her the ordering of pre-sentence reports

was no indication of the likely sentence.

The judge said the case was being transferred to Birmingham to avoid any potential appearance of bias given Connolly's husband held a political post in the local area.

Judge Lucking told Connolly: "Sentencing will entirely be a matter for the judge on the next occasion but it's likely to be a substantial custodial sentence.

"In the meantime, you are remanded in custody."

A father-of-three was jailed at Northampton Crown Court for 38 months on August 9 after re-posting part of Connolly's Twitter/X message.

Tyler Kay, 26, of Ellfield Court, Northampton, admitted a charge of publishing material intended to stir up racial hatred.

Passing sentence on Kay after he pleaded guilty, Judge Lucking told him: "You posted as you did because you thought there were no

consequences for yourself from stirring up racial hatred in others.

"The overall tone of the posts clearly reveals your fundamentally racist mindset.

"I am sure that when you intentionally created the posts you intended that racial hatred would be stirred

up by your utterly repulsive, racist and shocking posts that have no place in a civilised society."

Connolly issued an apology for her Twitter/X post before her arrest last month, saying she had acted on "false and malicious" information.

Judge 'astonished' as mum misses 12-year-old son's court date - to jet off for Ibiza holiday

The mother of one of Britain's youngest criminals involved in last month's riots has been summonsed by a judge after missing her 12-year-old son's court appearance to go on holiday to Ibiza.

District Judge Joanne

Hirst told Manchester Magistrates' Court she was 'frankly astonished' that the boy's mother had decided to fly abroad for a five-day sunshine break, with her son due in court having admitted two counts of violent disorder.

Judge Hirst adjourned

sentencing of the boy and ordered a parental summons so the mother must appear before the court to explain herself.

The youngster, who was accompanied to court by his uncle, had earlier admitted being part of a mob that attacked a bus

outside a hotel housing asylum seekers in Manchester on July 31.

Days later on August 3, in Manchester city centre, he was part of a group filmed kicking the windows of a vape shop and throwing a missile at a police van.

Dozens of towns and cities saw violence erupt following the killing of three young girls at a Taylor Swift themed dance class in Southport on July 29.

'serious situation'

District Judge Hirst was told the boy's mother was not present, having booked a holiday in July and gone abroad on Sunday and was only due to fly back to the UK on Thursday, missing his sentencing hearing on Monday.

She thanked the boy's uncle for accompanying his nephew to court in his mother's absence, but added: "One day before the hearing we find out the mum has gone on holiday and is not with her son who played a great

part in the recent civil disorder than any adult or child I've seen coming through these courts.

"I'm frankly astonished.

"I will require a full explanation from mum on her decision to go on holiday one day before her 12-year-old son comes to court facing a potential custodial sentence.

"This is a serious situation, it has now deteriorated in my view because of the actions of the mother.

"She is on notice, I will be challenging her about this decision."

Addressing the boy as she adjourned sentencing to September 11, Judge Hirst told him: "Boys like you need their mums in their lives. I need your mum here."

In a separate hearing in the same court, a 16-year-old boy was told he was being given 'the biggest chance in your life' by Judge Hirst, who decided to pass a referral order rather than jail the youngster.

The teenager, accompanied by his mother, had admitted violent disorder

by throwing a bottle at a police horse during widespread trouble in Bolton town centre last month.

The court heard the youngster's father had died and his mother, who accompanied him to court, was having treatment for cancer.

He was asked by the judge: "What were you thinking?"

The boy replied: "I was not really thinking anything. We came into town and everything just erupted. Adrenaline. I'm disgusted with myself."

The youngster's mother told the court: "He's frightened to death of going to prison. I think this has been a massive wake-up call."

The judge warned the youngster he had narrowly avoided custody and instead gave him a 12-month referral order with intensive supervision and a curfew.

She added: "It was mindless violence. I'm going to give you a chance. This is the biggest chance in your life that you will get."

12 asylum seekers dead as boat 'ripped open' in Channel

Six children and a pregnant woman are among at least 12 people who died this week after a boat carrying dozens of asylum seekers to the UK was "ripped open" in one of the worst Channel tragedies since the small boats crisis began.

In a major test for Keir Starmer's government, which is facing demands from charities to open up safe routes for those wanting to come to the UK, the French authorities said that 10 of those who had lost their lives were female and many are believed to be from Eritrea.

The French interior minister, Gérald Darmanin, said more than 50 people had been rescued including two who are in a critical condition from the "terrible shipwreck" off Cap Gris-Nez

on Tuesday morning. Only eight of the 70 passengers were wearing lifejackets, according to French officials.

The incident, in which everyone on board was plunged into the sea, is believed to have caused the second highest number of fatalities to befall people while attempting to reach the UK since the small boats crisis began.

After the latest fatalities, the prime minister is facing calls to open legal routes so that potential refugees are not forced to take such desperate journeys before claiming asylum in the UK. In a further development, Darmanin called for a new migration treaty to be negotiated between the UK and EU to ease the path for asylum seekers.

The UK home secretary, Yvette Cooper, de-

scribed the incident as "horrifying and deeply tragic", as she said "vital" efforts to dismantle "dangerous and criminal smuggler gangs" and to boost border security "must proceed apace".

Cooper said she was in touch with the French government and was being kept updated on the situation.

"Our hearts go out to the loved ones of all those who have lost their lives and all those who have been seriously injured," she said.

The French authorities were called to the incident when a dinghy was reported to have got into trouble off Le Portel on the northern French coast, about 28 miles south-west of Calais.

All of the people on board ended up in the water, many of whom were not wearing life-

jackets, according to the French coastguard. It is understood the shipwreck took place in French waters and UK search and rescue vessels are on standby.

The Boulogne-sur-Mer prosecutor Guirec Le Bras said that at least 12 people died – includ-

ing six minors and 10 females. He added that those killed were "primarily of Eritrean origin", but that officials "do not have consolidated details that would allow us to specify the exact nationalities".

Frédéric Cuvillier, the mayor of Boulogne-sur-

Mer, told the BBC that a pregnant woman was among the victims.

In the past week more than 2,000 people seeking asylum have arrived in the UK on small boats. More than 600 arrived on 28 August in 10 boats, while 351 arrived on 2 September in six vessels.

UK defends Israel arms cut

The UK has defended its decision to suspend some arms sales to Israel Benjamin Netanyahu called the decision "shameful".

The Israeli Prime Minister posted on social media that the decision "will only embolden Hamas".

But Husam Zomlot, the Palestinians' top envoy to the UK, called the partial ban an "important first step" to the UK's fulfilment of its "legal obligations under domestic and international law".

On Monday, the UK suspended around 30 out of 350 weapons export licences to Israel.

But Defence Secretary John Healey insisted the UK remained a "staunch ally" of Israel, and insisted Israel's security would not be weakened by the decision.

Government ministers say the weapons could be used in Gaza to violate international law.

Human rights group

Amnesty International UK said the measures were "too limited".

Others have criticised the timing of the announcement for coming on the same day funerals took place for six hostages killed by Hamas last week.

Mr Healey told reporters it was "agonising" seeing the faces of the dead hostages, but said the timing was "driven by the fact that this was a legal process" and the need to report to Parliament.

Foreign Secretary David Lammy said on Monday the suspension would affect equipment such as parts for fighter jets, helicopters and drones.

Mr Healey said these were chosen because they supplement equipment used in Gaza for "offensive purposes", while the "vast majority of other parts our country exports to Israel are

either not related to the conflict or maybe used for Israel's defence".

UK arms sales to Israel are small in comparison to other allies, contributing just 1% of the country's defence imports.

The UK exports arms to multiple countries including Ukraine, Saudi Arabia and Turkey.

The US is by far the largest supplier of arms to Israel, accounting for 69% of its imports of major conventional arms between 2019 and 2023, according to the Stockholm International Peace Research Institute.

In a statement, Mr Zomlot said that the Palestinian Mission to the UK would "continue working" with the UK government towards a "full arms embargo".

Amnesty International UK accused the government of "gesture politics", given less than 10% of arms export licences were suspended.

Tributes flow for Danger Mouse creator

Brian Trueman, who was best known for his animation work, enjoyed a long and productive career at Granada TV

The Danger Mouse writer Brian Trueman has died at the age of 92.

His son Jonathan announced the death in a Facebook post, saying he died in Stepping Hill hospital in Stockport on Sunday night "after a short illness".

"If you knew him, we're sure you'll appreciate that he wouldn't want a sentimental tribute here," he said. "But we're equally sure that, if you knew him, you'll know just how much he'll be missed."

Trueman spent 20 years at Granada TV and while there he wrote and presented the TV series

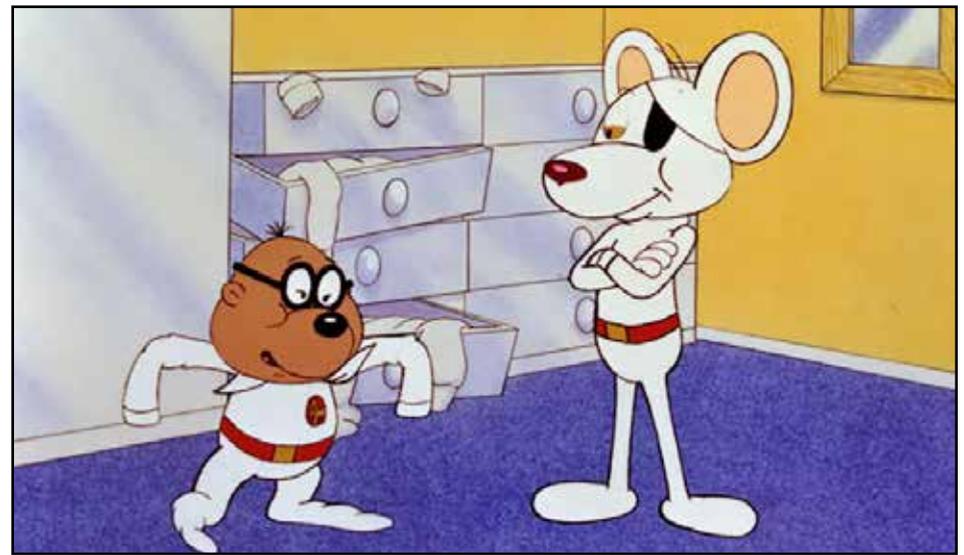


Brian Trueman: a talented British creator of entertainment for adults and children. (above): Danger Mouse and sidekick Penfold

Cinema and conceived, produced, wrote and presented House for the Future.

However, he was best known for his work writing for the animation

company Cosgrove Hall Films, particularly Chorlton and the Wheelies, some of the scripts for Count Duckula, and the original Danger Mouse episodes, which were



voiced by Sir David Jason.

Cosgrove Hall Films Archive paid tribute to Trueman on Instagram, saying: "We're very sad to hear of the passing of Brian Trueman."

"For many years Brian worked for Cosgrove Hall Films as writer, voice actor and narrator.

"Brian's writing and humour had the unique ability to appeal to both

adults and children, which contributed to the success of Cosgrove Hall series such as Danger Mouse, The Wind in the Willows, Jamie and the Magic Torch."

KNIFE CRIME BRITAIN: Boy charged with murder of 84 year-old dog walker

A 14-year-old boy has been charged with the murder of an 80-year-old man in a park.

Bhim Kohli died on Monday after an attack at Franklin Park in Braunstone Town, Leicestershire, while walking his dog on Sunday.

The youth, who cannot be named for legal reasons, has been remanded into custody.

A post-mortem examination showed Mr Kohli

had died of a neck injury from a large bladed weapon.

Paying tribute earlier on Wednesday, Mr Kohli's family said "our hearts have been completely broken".

They added: "Bhim was a loving husband, dad and grandad. He was also a son, brother and uncle.

"He adored his grandkids with all his heart and loved spending time

with them. He really was such a loving, caring person whose life was centred around his family.

"He has always been a very hardworking man and even at the age of 80 he was still very active.

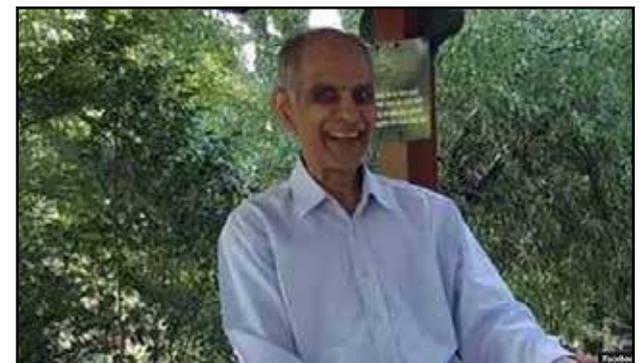
"One of his great passions was his allotment, he would go every day to tend to his plots and was so proud of them. He also enjoyed walking the family dog Rocky on

the park many times a day.

"Bhim loved to laugh. He was always very happy and talkative, the joker of the family and always loved to outsmart us with a smile."

Four other children who were arrested in connection with the attack were released with no further action.

tion Service, said: "The CPS has reviewed a file of evidence from Leicestershire Police and has authorised a charge of murder against a 14-year-old boy in relation to the death of Bhim

Sen Kohli.

"The Crown Prosecution Service reminds all concerned that criminal proceedings against this defendant are now active and that the youth has a right to a fair trial."

Fans look back in anger over Oasis ticket fiasco

OASIS fans were left frustrated and infuriated in equal measure this week after a ticketing fiasco which has prompted Sir Keir Starmer to promise the Government will get a "grip" on "surge pricing".

His invention follows hundreds of complaints from the rockers' fans.

Standard tickets more than doubled in price from £148 to £355 on Ticketmaster, which admitted they reflected high levels of demand.

It said prices were set by the "event organiser, according to their market value".

An estimated 14 million people spent Saturday battling to secure their chance to see brothers Noel and Liam Gallagher on stage during next year's 17-date tour, which is now sold out.

The Prime Minister said: "This is really important, because this isn't just an Oasis problem. This is a problem for tickets for all sorts of

events, where people go online straight away... and within seconds sometimes, sometimes minutes, all the tickets are gone, and the prices start going through the roof, which means many people can't afford it.

"You have to stop that. We're consulting on that.

"I do think there are a number of things that we can do and we should do, because otherwise you get to the situation where families simply

can't go, or are absolutely spending a fortune on tickets. So we'll grip this and make sure that actually tickets are available at a price that people can actually afford."

Culture Secretary Lisa Nandy called the saga "incredibly depressing".

Ms Nandy said: "This Government is committed to putting fans back at the heart of music. So we will include issues around the transparency and use of dynamic pricing,

including the technology around queuing systems which incentivise it, in our forthcoming consultation on consumer protections for resale."

Minister Lucy Powell says she was among those hit by dynamic pricing, buying two tickets for £350 each for Heaton Park in July, originally quoted at £148.50, not including a £2.75 booking fee.

Fans said the "in demand" pricing was

"sickening" and "scandalous". Before the furore, the Government had vowed to "bring in protections to stop people being ripped off by touts".

There has also been concern about non-official sellers Viago-go, which had a seat at Wembley listed at £5,289.

The secondary seller defended the practice saying fans sell the tickets and "resale is legal in the UK".

Prague street is named in honor of 'Britain's Schindler'

■ Sir Nicholas Winton saved hundreds of Jewish schoolchildren from almost certain death in the months leading up to WWII

A new street in Prague has been named after Sir Nicholas Winton, the British man who helped save hundreds of mostly Jewish children from the Nazis.

On Sunday four of them – now in their 80s and 90s – attended a ceremony for the street, which runs past a small train station from where tens of thousands of Czechoslovak Jews were deported during the Holocaust.

It coincided with the 85th anniversary of the last planned Kindertransport journey from Prague, which was prevented from departing due to the outbreak of World War Two.

"This was my passport to freedom," said Lady Milena Grenfell-Baines, clutching a document the size of a birthday card.

The card, slightly yellowed with age, showed that Milena Fleischmann (her maiden name), aged nine, was granted leave by His Majesty's Government to enter the United Kingdom.

A photo of a cheerful girl wearing a smart, white-collared shirt was stuck to the front. The reverse was stamped with a swastika.

Clutching this docu-

ment, and with a name tag hung around her neck, Milena travelled by train across Nazi Germany, watching over her three-year-old sister, Eva.

From there, they and dozens of other unaccompanied Jewish children crossed into Holland, before boarding a boat for England.

"We were all given cups of tea with milk. Nobody had ever had tea with milk. We all poured it out," she said.

'no eyewitnesses'

Eventually Milena and Eva were reunited with their parents, who also managed to escape. The Fleischmanns were the lucky ones. Many of their friends and relatives were not.

"I think it's so important, because very soon, no eyewitnesses will be here anymore," Milena, a youthful 94, told the BBC.

She spoke sitting on a chair on the same railway platform where tens of thousands of Czechoslovak Jews were herded onto trains bound for the Theresienstadt ghetto. Most would later be murdered at Auschwitz.

The station – Praha Bubny – has since been transformed into a me-

morial, and a much larger, modern station is being built nearby. A path for pedestrians and cyclists running beneath the tracks will from now on be known as Nicholas Winton Street.

"People need to remember why that street is called Nicholas Winton Street," Milena went on. "Because there is a big generation – thanks to him – alive today."

She and three other 'children' were brought to Prague to attend the ceremony organised by the Association of Jewish Refugees (AJR).

"In remembering Sir Nicholas, we also honour the parents who sent away their children to an uncertain future, as well as the foster families who gave sanctuary to the youngest victims of Nazi oppression," said Michael Newman, head of the AJR.

Milena didn't find out that the card – and therefore her survival – was largely the work of a 29-year-old British stockbroker until the 1980s, when the story appeared on the BBC programme *That's Life*.

In now legendary footage, a speechless Winton, who was dubbed the

"British Schindler" in reference to the German businessman whose exploits were immortalized in the film *Schindler's List*, was reunited with dozens of the then children he had helped to save in the final months before the outbreak of war.

In subsequent interviews he was always at pains to stress the operation was a team effort.

Apart from a month spent in Prague from Christmas 1938 to January 1939, most of the work – badgering politicians and diplomats, finding foster families, sometimes creating fake documents – was done from the safety of his home in London.

He was knighted in 2003 and died in 2015 at the age of 106.

Most of all, he remained haunted by the children

he was unable to save. Milena's train was the eighth – and final – transport to leave occupied Prague.

A ninth – the largest, carrying some 250 children – was scheduled to leave on September 1st, 1939. But war intervened, and the train never left the station. All but a handful of the children are believed to have perished.

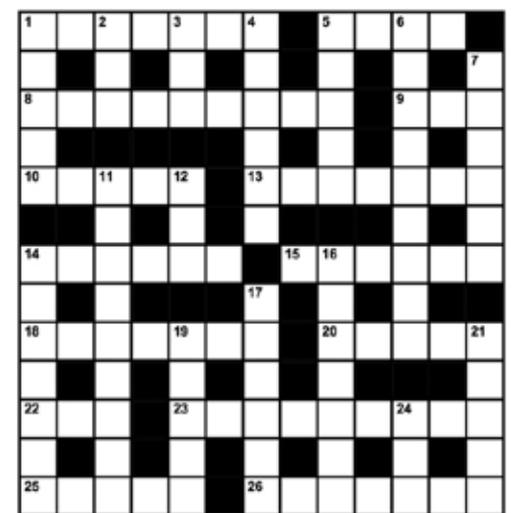

Slow Horses gallops back, better than ever

■ Season Four of the British spy drama returns to Apple TV

THIS WEEK brings the very welcome return of *Slow Horses* on Apple TV, reuniting us with the dysfunctional family of British misfit intelligence operatives presided over by the gloriously unkempt Jackson Lamb.

The fourth season of the show, which debuted on Wednesday, has been hailed by many critics as its best outing yet, solidifying its reputation as one of the most engaging espionage dramas of recent years. Based on the novels by Mick Herron, the show focuses on a small group of intelligence service misfits who have been relegated, either through bad luck or human error, to Slough House, the dingy London office building housing where they ply their trade.

This season picks up where the previous one left off, with the team diving deeper into a complex web of intrigue and betrayal. The show opens with the bombing of a London shopping mall and the seeming death of one of their own, before developing into a wider story of conspiracy, rogue agents and bad actors both within and without the British government.

This season's scripts remain tight as a drum, with writer Will Smith continuing to balance sharp, cerebral storytelling with moments of genuine tension and dark humor, as he weaves together multiple plot threads in a way that is both intricate and accessible. The character development is particularly noteworthy; the show continues to explore the nuances

of its flawed, compelling characters, revealing new dimensions to their personalities and relationships.

Gary Oldman returns as Jackson Lamb, the irascible, flatulent but fiercely loyal head of the Slough House team, with his signature blend of gravitas and cynicism. Other familiar faces include Kristin Scott Thomas as the formidable Diana Taverner, Jack Lowden as the earnest River Cartwright and Jonathan Pryce, delightfully batty but endlessly shrewd as River's grandfather David. Veteran actress Saskia Reeves also returns as Catherine Standish, the alcoholic ex-agent who knows where all the bodies are buried, as well as Rosalind Eleazar as Louisa Guy who is still struggling to process the death last season of her lover, and Christopher Chung as the eternally awful comms whiz, Roddy Ho.

There are also a handful of new faces joining the cast this time

around, all of whom bring something new to the table. In Slough House, the overeager Moira (Joanna Scanlan) works to get back to her old job as soon as possible, while the dead-eyed J.K. (Tom Brooke) sits and twitches in the corner. Over at the Park, the slick-bit-out-of-his-depth new First Desk Claude (James Callis) butts heads with Taverner, who, as usual, leaves her male counterparts in the dust.

But the most notable additional is its villain: Frank Harkness (Hugo Weaving), who runs a sort of mercenary home for boys, one of whom might just be responsible for the bombing that sets off the season's course of events. Harkness reads as an almost perfect foil to Lamb's sweaty, smelly mess of a leadership strategy. Weaving gives the role a ruthless sense of control, right down to his perfectly manicured beard.

In the end though, this is a show about a

family. A dysfunctional, chaotic and belligerent unit of MI5 rejects, to be sure, but a family nonetheless, presided over by a messy but deeply honorable paterfamilias in Lamb.

"There's a jadedness in Lamb, but he's very loyal to these misfits," Oldman recently told the *Radio Times*. "When it really comes down to it, he probably cares more than most, although he gives the impression, as a protection, that he doesn't."

"I've enjoyed it so much. Long may it continue." While Root is having the time of his life with the bat, Atkinson is doing the same with bat and ball, amassing 33 wickets in five Tests.

Having burst on the scene with a 12-wicket haul against the West Indies earlier this year he has not looked back. His Lord's display has put him on a different level and in the international limelight.

It was a pity there was such a paltry crowd to see his latest heroics, which is a major embarrassment for cricket's hierarchy.

The decision to price adult tickets at £95 certainly did not help encourage the fans to turn up.

Sri Lanka resumed on 53-2 but were never in with a chance of stopping England, who did not need a pumped-up gathering to spur them on to a 2-0 series lead.

Dimuth Karunaratne (55), Dinesh Chandimal (58) and Dhananjaya de Silva (50) showed stomach for the fight.

The fast bowler then removed Milan Rathnayake slashing outside the off-stump, caught by Smith.

The smiling Atkinson raced with arms out wide to be mobbed by his teammates.

Woakes wrapped up the win when Lahiru Kumara holed out as Sri Lanka were dismissed for 292.

Now England will hope to make it a 3-0 whitewash in the final Test starting at The Oval on Friday.

■ Clarke's men pay penalty and spoil heroic fightback

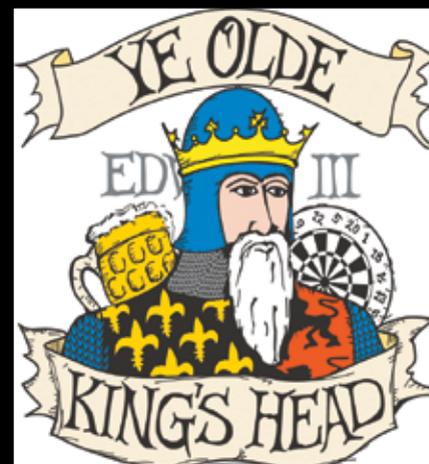
Scotland's miserable 2024 continued in agonizing fashion on Thursday as Poland were gifted a stoppage-time penalty to quell a valiant Nations League comeback at Hampden and secure a 3-2 victory.

Billy Gilmour and Scott McTominay had scored second-half goals for the revived Scots to cancel out Sebastian Szymanski's long-range effort and Robert Lewandowski's perfectly executed spot-kick for the visitors.

However, as Steve Clarke's side pushed for a winner, Nicola Zalewski was the victim of a rash challenge by Grant Hanley and the Pole - who also won the earlier penalty - picked himself up to score the 97th-minute winner.

Scotland, who meekly exited this summer's Euros with one point from three group games, now must travel to face Portugal on Sunday with a record of just one win in 13 and five defeats in 2024.
