

# NO JAIL, BUT EDWARDS' 'REPUTATION IN TATTERS'

This week's sentencing seals a fall from grace for Edwards, a UK household name for around two decades, after he pleaded guilty to three counts of making indecent images of children

Former BBC news anchor Huw Edwards, once one of the most prominent media figures in Britain, has been given a suspended prison sentence for images of child sexual abuse on his phone.

Edwards, 63, pleaded guilty in Westminster Magistrates' Court in July to three counts of making indecent images of children, a charge related to photos sent to him on the WhatsApp messaging service by a man convicted of distributing images of child sex abuse.

Chief Magistrate Paul Goldspring sentenced Edwards to a six-month prison term suspended for two years. He will be listed on a sex offenders register for seven years.

"It is not an exaggeration to say your longearned reputation is in tatters," Goldspring said.

Edwards' fall from grace over the past year has caused turmoil for the BBC after it was revealed the publicly funded broadcaster paid him about \$263,000 for five months of his salary after he had been arrested in November while on leave.

The BBC has asked him to pay it back.

"We are appalled by his crimes," the BBC said in a statement after the sentencing. "He has betrayed not just the BBC, but audiences who put their trust in him."

Edwards had been one of the BBC's top earners when he was suspended in July 2023 over separate claims made last year involving a teenager he allegedly paid for sexually explicit photos.

Police investigated and decided not to

bring charges.

Although Edwards was not publicly named at the time those allegations surfaced, his wife later revealed he was the news presenter investigated and said he was hospitalised for serious mental health issues.

He never returned to the air but the BBC kept him on the payroll until he resigned in April for health reasons.

### 400 images

Then, it was revealed that more than 375 sexual images were sent to Edwards on WhatsApp between December 2020 and August 2021.

More than 40 were indecent images of children, including

seven classified as "category A" — the most indecent — with children estimated to be between 13 and 15. One child was aged between 7 and 9.

In chats with Alex Williams, who was later convicted of distributing child sex abuse images, Edwards was asked if he wanted sexual images of a person whose "age could be discerned as being between 14 and 16," and Edwards replied, "yes xxx," prosecutor Ian Hope said.

"From that chat in December 2020, Alex Williams said that he had 'a file of vids and pics for you of someone special,"" Hope said.

Edwards asked who the subject and was then sent three images that appeared to be the same person who appeared to be aged 14 to 16, Hope said. At one point, Williams asked for a "Christmas gift after all the hot videos" he had sent. Edwards remarked that some of the images were "amazing," Hope said.

Williams, 25, was given a suspended 1-year sentence in March for possessing and distributing indecent images as well as possessing prohibited images of children.

## Titanic shipbuilder facing administration - again

Shipbuilding company Harland and Wolff has confirmed the business is to be placed into administration for the second time in five years.

practi-Insolvency tioners Teneo are being lined up to act as administrators and some "non-core" staff are being made redundant.

However, the company's board said there was a "credible pathway" for its four shipyards to continue trading under new ownership.

Its main yard is in Belfast, best known for building the Titanic,

with other operations at Appledore in England and Methil and Arnish in Scotland.

The company said the administration process would be confined to the holding company, Harland & Wolff Group Holdings plc, and the operational companies which run the yards are expected to continue trading.

However, shareholders will see the value of their investments in the business entirely wiped out.

The firm said its noncore operations are being wound down.

That process had al-

ready started with the closure of its Scilly Isles ferry service before sailing had even begun.

Other non-core operations include a small business in the US and a marine services business which is to be sold in the hope of preserving 14 jobs.

A small number of non-core staff and others in support roles were told Monday they were losing their jobs.

The company warned that "a further reduction in headcount in our core activities may be necessary" depending on the progress of the sales process.

The spokesperson said: "We are clear that following a thorough review of the company's financial situation, at present the market is best-placed to address these challenges and providing government funding would have meant a significant risk

of losing taxpayer money."

The spokesperson added that the government will work with all parties to find an outcome "that delivers shipbuilding and manufacturing in Belfast, Scotland and across the rest of the UK and protects jobs".

### It's not safe for me to meet my constituents, claims Farage

■ Insiders question Reform UK leader's claim that his parliamentary security team advised against in-person meetings

Nigel Farage has claimed he received official parliamentary advice against holding in-person meetings for his constituents - called 'surgeries' in the UK though his claim was immediately called into question by insiders.

On Thursday the Reform UK leader, who became the MP for Clacton in Essex in July, said he had been advised not to hold the physical weekly meetings that are a staple for most MPs, citing fears the public would "flow through the door with knives in their pockets".

He recalled the murder of the Conservative MP David Amess at a surgery in Essex three years ago. Farage said he had been given guidance by "the [Commons] speaker's office, and beneath the speaker's office there is a security team who give advice and say you should do some things and not do others".

However, a Westminster source said this was not advice that the office of the speaker, Lindsay Hoyle, or the security team would give to any MP as it would interfere with their democratic duties. They would, however, offer advice on how measures could be taken to ensure safety, the source said.

Farage has come under fire for spending time in the US supporting Donald Trump's presidential campaign instead of focusing on his role as an MP

During an LBC radio phone-in with Nick Ferrari, he was asked how many surgeries he had held in his constituency since he was elected. He responded: "Do I have an office in Clacton? Yes. Am I allowing the public to flow through the door

with their knives in their pockets? No, no I'm not."

Asked why people would want to be violent, he said: "Well they did in Southend. They murdered David Amess, and he was a far less controversial figure than me."

Farage said he is "not holding physical vet" meetings with constituents but would "when parliament allows me".

He added: "So we're not in a fit state to do the old-style surgeries, but do you know what, if you've got something to say to me as a Clacton resident, Zoom is not the end of the world."

Hoyle, the speaker, said: "As a constituency MP in Chorley, I hold regular surgeries myself with constituents - and whenever a member [MP] asks for my advice on this matter, I always say that if you are go-

### **Prince William wishes Harry happy** 40th birthday on social media

■ Prince and Princess of Wales echo birthday wishes sent from royal family's X account despite strained relations

The Prince and Princess of Wales have delivered a small peace offering in their rift with the Duke of Sussex by wishing Prince Harry happy birthday for the first time in three years.

In a post on X, the royal family shared a photograph of a smiling Harry to mark his 40th birthday, complete with a cake emoji. The message said: "Wishing The Duke of Sussex a very happy 40th birthday today!"

Reposting the online greeting with almost identical wording, William and Kate's X account said: "Wishing a Happy 40th Birthday to The Duke of Sussex!"

It is the first time the royal family have shared such a public birthday greeting to Harry since 2021, the year the Sussexes accused unnamed royals of animosity and racism in an interview with Oprah Winfrey.

Harry was celebrating his birthday on Sunday at his Montecito home with Meghan and their two children, Prince Archie and Princess Lilibet, before reportedly heading away for a gathering with close friends.

Harry, who stepped down as a working royal in 2020, remains estranged from William and has a strained relationship with their father, King Charles.

Last February Harry flew to the UK to see his father after the king's cancer diagnosis. The meeting was kept to just 45 minutes and there was no meeting with his brother.

He travelled to London again in May to celebrate a decade of his Invictus Games and attended a service at St Paul's Cathedral but did not meet up with his brother or father.

There was also a brief return to the UK in August for the funeral of his uncle Lord Fellowes, when he stayed at Althorp, the ancestral home of his late mother, Diana, Princess of Wales. He reportedly had no interaction with William at the church service.

The duke continues to pursue legal cases against tabloid newspapers over allegations of phone hacking and unlawful information gathering, in a battle he believes has annoyed his family. In his memoir, Spare, he wrote of what

### Kate eases gently back into her official duties

The Princess of Wales has carried out her first official work meeting since she began cancer treatment earlier this year.

In another small step on her return to public life, the princess had a meeting on Tuesday in Windsor Castle about her early childhood project.

It follows last week's

video message from Catherine where she revealed her relief that her chemotherapy had ended.

The princess said this year had been "incredibly tough" but she had gained a "renewed sense of hope and appreciation of life".

This meeting in Windsor was recorded in the

Court Circular, which lists royal engagements.

The princess has worked from home and had meetings at home before, but this was the first officially recorded work engagement since her treatment began.

## New documentary accuses Mohamed Al Fayed of raping five women

### ■ More than 20 of Fayed's former employees tell BBC of sexual assault and of Harrods' cover-up

The former Harrods owner Mohamed Al Fayed has been accused of raping five women and sexually abusing at least 15 others when they worked at the luxury department store, according to a BBC investigation.

More than 20 women, all of whom were Fayed's former employees, told a documentary crew they were sexually assaulted by him and that Harrods covered up the abuse.

The store's current owners said they were "utterly appalled" by the allegations and apologized to the victims.

Fayed, who sold Harrods in 2010, died last year aged 94. At least one of obituaries noted there were repeated allegations of sexual harassment of female staff during his lifetime. In 2009 the Crown Prosecution Service decided not to

charge Fayed over the claim he had sexually assaulted a 15-year-old girl at the store. In 2013 he was interviewed by police after a woman alleged he had sexually attacked her at his Park Lane apartment after a job interview. The police reopened the case in 2015 but took no further action. Fayed always denied the allegations.

The alleged victims give detailed accounts of the abuse, including some on camera, in the new documentary, Al Fayed: Predator at Harrods. It alleges the abuse took place in London, Paris, Saint-Tropez and Abu Dhabi.

One woman told the BBC she was raped as a teenager in Fayed's Park Lane apartment. "Mohamed Al Faved was a monster, a sexual predator with no moral compass," she told the BBC.

Three other women

claimed they were also raped by him in the apartment. A fifth woman, named only as Gemma, said on camera that Faved raped her at his Villa Windsor apartment in Paris and then made her wash herself with disinfectant.

She told the program: "Obviously he wanted me to erase any trace of him being anywhere near me."

The documentary-makers say the women came forward after seeing Fayed sympathetically portrayed in the Netflix series The Crown. The episodes in question covered Diana, Princess of Wales's relationship with Fayed's son Dodi, and their deaths in a car crash in 1997.

One woman, named only as Sophia, says Fayed tried to rape her more than once when she was a personal assistant to him from 1988

to 1991. Speaking of Fayed's portrayal in The Crown, she said: "People shouldn't remember him like that."

Bruce Drummond, a barrister representing several of the women, said: "The spider's web of corruption and abuse at this company was unbelievable and very dark."

In a statement, Harrods said: "We are utterly appalled by the allegations of abuse perpetrated by Mohamed Al Fayed. These were the actions of an individual who was intent on abusing his power wherever he operated and we condemn them in the strongest terms. We also acknowledge that during this time as a business we failed our employees who were his victims and for this we sincerely apologise.

"The Harrods of today is a very different organisation to the one owned and controlled by Al Faved between 1985 and 2010; it is one that seeks to put the welfare of our employees at the heart of everything we do.

"This is why, since new information came

## **Glasgow set to host next Commonwealth Games**

■ After Australians back out due to spiralling costs, Scottish city aims for slimmed down - and cheaper - model for the future

The Commonwealth Games are set to return to Glasgow in 2026.

Final plans are still to be agreed with Commonwealth the Games Federation (CGF) but organizers have gained backing from the Scottish government to rescue the event.

The deal comes following talks between Health Scotland's Secretary Neil Gray and Commonwealth Australia Games (CGA) on Monday.

The sporting event was due to be held in the Australian state of Victoria but it withdrew last year due to rising costs.

Glasgow last hosted the games in 2014. The opening ceremony took place at Celtic Park, while the closing festivities lit up Hampden Park.

The 2026 event is expected to be scaled down with fewer sports, but athletics and swimming will

remain. Commonwealth

Games Scotland (CGS) said it has developed a concept that "can be delivered within two years and for a budget of £115m, with no ask of public funds".

Mr Gray said the Scottish government has written to CGS to confirm its support.

No public funding will be required for the delivery of the event and the Scottish government will not provide any financial underwriting.

CGS will now decide whether it wishes to proceed with its proposal before being considered by the CGF.

Mr Gray said: "The fact that Glasgow was asked to step in and host the 2026 games is testament to Glasgow and Scotland's fantastic reputation for hosting international events

"That said, we have been clear that our financial resources are

limited."

Mr Gray added the government had conducted a thorough assessment of the proposal, with support from the relevant Commonwealth authorities, Games Glasgow City Council, and the UK government.

He added: "In 2026 all eyes will once again be on Glasgow, and I have every confidence that Scotland's largest city will provide a fitting platform for some of the world's top athletes."

Ian Reid CBE, chair of CGS, said the organisation will be "working hard over the coming days to bring the final pieces of the puzzle together".

In a statement, the CGF said it was delighted CGS had received Scottish government support.

CGF president Chris Jenkins said: "We have been working with CGS and the Scottish

"At the heart of our discussions has been an investment of £100m from the CGF

and the commitment that Glasgow 2026 would not require financial underwriting from either the Scottish or UK governments."

Mr Jenkins confirmed that CGA had contributed around £2.3m to "further enhance the games delivery".

He added: "We believe Glasgow 2026 will be an important first step in our commitment to reset and reframe the Commonwealth Games as a co-created, sustainable model that minimizes costs, inspires athletes, and excites hosts and international federations."

### **Baby Reindeer hoofs it to glory at the Emmys**

Baby Reindeer, the hugely popular but highly contentious British TV hit, took the Emmy Awards by storm this week, winning four trophies at the ceremony in Los Angeles.

The show's creator and star, Scottish comedian Richard Gadd, won three of those - for acting in, writing and executive producing the show.

His co-star Jessica Gunning, who played stalker Martha, was named best supporting actress in a limited series.

"Oh my goodness me, blinking heckers," she said on accepting the award.

"Thank you so much. I honestly feel like I'm going to wake up any minute now and this whole thing has been a dream."

Gadd's account of being stalked by a woman for several years and being sexually abused by a male TV industry figure, has been the most talked about show of the year. However, its claim

to be "a true story" has made it controversial, and the real-life woman who allegedly inspired Gunning's character is currently suing Netflix for defamation, negligence and privacy violations.

Accepting his award for best writing for a limited series, Gadd told the audience: "Ten years ago, I was down and out.

"I never ever thought I'd get my life together. I never ever thought I'd be able to rectify myself for what happened to me and get myself back on my feet again.

"And then here I am, just over a decade later, picking up one of the biggest writing awards in television.

"I don't mean that to sound arrogant. I mean it as encouragement for anyone who's going through a difficult time right now to persevere."

Speaking before the ceremony, he claimed the UK media had focused too much on the fallout from the show.

Asked whether he would have done anything differently in hindsight, he replied: "I can't really answer that right now, because you can't change the past.

"The past has happened, and the show has had a phenomenal impact on people. I think there's a lot of, especially in the UK press, this incredible focus on the negative.

"But you can't ignore the positive impact that Baby Reindeer has had. It's been number one in countries like Lebanon and Qatar and places where you never, ever thought it would break through. It's had a cross-cultural impact that very few shows have."

Manchester City's Champions League campaign opened in frustrating fashion as they were held to a draw by impressive Inter Milan at Etihad Stadium on Wednesday night.

Pep Guardiola's side were never at their most fluent, not helped by an injury to Kevin de Bruyne that forced him off at half-time - but City's Italian opponents were well worth their draw.

In a repeat of the 2023 Champions League final won by City in Istanbul, Inter showed superb organisation and attacking threat despite facing increased pressure in the second half.

Erling Haaland, seek-

ing his 100th goal for the hosts, was largely kept quiet, and both sides had chances to make the breakthrough but were unable to capitalize.

Phil Foden, on as a second-half substitute for the injured De Bruyne, saw a shot saved by Inter keeper Yann Sommer, who also thwarted Josko Gvardiol.

Inter wasted many good situations, with former Manchester United defender Matteo Darmian choosing a flamboyant backheel when the shot was on, while another one-time Old Trafford star, Henrikh Mkhitaryan, fired over the top from close range, leaving coach

Simone Inzaghi on his knees beating the turf in frustration.

But City went close to a dramatic late winner as Foden fired straight at Sommer after a delightful move and Ilkay Gundogan had two headed chances in the box.

"We faced a really difficult team," said Guardiola, whose side failed to score in a Champions League match for the first time since October 2022.

"I'm still really, really satisfied for the game we played, especially with how [Inter] defended, they are masters of that, so big, they help each other unbelievably. So you cannot expect to create a lot of chances."



## **Villa's Triumphant European Return**

### Emery's men impress with emphatic 3-0 away win

Aston Villa marked their return to European football's top club competition after a 41-year absence with a thoroughly deserved victory over Swiss champions Young Boys on Tuesday night.

Unai Emery's team took time to settle on the artificial surface in Bern but went in front through Youri Tielemans, who finished off a wellworked corner routine with a driven finish into the far corner.

Villa were gifted a second by some calamitous defending from the home side, with Ollie Watkins intercepting Mohamed Ali Camara's pass towards goalkeeper David von Ballmoos and Jacob Ramsey firing in off the inside of the post.

The hosts were spared further punishment before half-time by the video assistant referee (VAR), who disallowed Watkins' powerful effort for handball. Silvere

Ganvoula and Filip Ugrinic forced saves out of Emi Martinez in the second half and substitute Jhon Duran had a left-footed finish ruled out for handball against Amadou Onana, but the Belgian midfielder's low effort put the seal on a comfortable evening for Emery's side.

The visitors wore black armbands in Switzerland in memory of former striker and 1982 European Cup winner Gary Shaw, who passed away on Monday from injuries sustained in a heavy fall. An image of Shaw was displayed on the big screen before kick-off, with both sets of fans taking part in a period of applause.

Villa supporters had flocked to Switzerland in their numbers in anticipation of the club's first match at this level since 1983, when Juventus knocked Tony Barton's reigning European champions out of the competition at the quarter-final stage.

With games against the likes of Bayern Munich, RB Leipzig and the Turin side to come in the tournament's new-look league phase, this could prove to be a crucial three points for Emery's team but there were one or two nervy moments early on as Young Boys threatened to stun their opponents.

Ebrima Colley twice went close, stinging Martinez's palms with a low shot before curling a tremendous, long-range effort narrowly over the Argentine's crossbar.


