# 10 Liam dead at 31

## ■ Drink and drugs involved as heart-throb singer falls to his death

**Liam Payne, the former One Direction star, has died aged 31 in Argentina after falling from the third floor of a hotel in Buenos Aires, police say.**

In a statement, police said they discovered Payne's body after an emergency crew responded to an call in the upscale neighbourhood of Palermo on Wednesday.

Payne had risen to global fame as part of the much-loved boyband created on the X Factor TV show in 2010, along with Harry Styles, Louis Tomlinson, Niall Horan and Zayn Malik.

Earlier this month, Payne had attended the Argentina concert of his former One Direction bandmate Niall Horan.

According to police in Buenos Aires, officers at the scene were initially responding to reports "of an aggressive man who may have been under the effects of drugs and alcohol".

### "serious injuries"

When they arrived at the hotel, officials were told a loud sound had been heard in an interior courtyard. Soon after, they discovered the body there. A police investigation has been launched.

Emergency medical services director Alberto Crescenti told local media that Payne had suffered "serious injuries" and that an autopsy will be carried

out.

Mr Crescenti declined to answer questions about the circumstances of Payne's fall from the balcony.

The star's body has been transferred to a morgue in the city.

Payne posted on Snapchat just hours before the incident, saying: "It's a lovely day here in Argentina" but the video was from earlier in the week where he had spent time with his girlfriend Kate Cassidy.

The UK Foreign Office confirmed it was in touch with authorities in Argentina "regarding reports of the death of a British man". No further details were given.

Once news of his death broke, fans began gathering outside the Buenos Aires hotel where the death took place, prompting police to cordon off the entrance. Some lit candles in his memory.

"I was in my living room and my sister told me Liam died," a young fan named Violeta Antier told Reuters news agency. "We couldn't believe it. We came here directly to confirm it was true."

Ms Antier said she saw Payne at the Niall Horan concert just two weeks

ago.

Another woman cried as she explained why she had come to the hotel, telling Reuters in Spanish: "This is the only way I have to say goodbye to him".

One Direction had global success with hits such as What Makes You Beautiful and Story of My Life, while Payne also enjoyed some solo success after the band announced in 2015 that they were going on hiatus the following year.

Tributes have also been pouring in online.

### "lost for words"

Max George, from boyband The Wanted, said he met Payne while he was competing on The X Factor with One Direction, and described his death as "absolutely devastating".

"Over the last few years I had the pleasure of getting to know him personally and spent some treasured time with him," he said on Instagram.

George said Payne had been "wonderful" in terms of support when his bandmate Tom Parker fell ill with a brain tumour.

When Parker died in 2022 at the age of 33,

Payne attended the funeral.

Singer Olly Murs, who was on The X Factor a year before One Direction, said he was "lost for words".

"Liam shared the same passions as me, the same dreams so to see his life now end so young hits hard, I'm truly gutted and devastated for his family and of course his son Bear losing a dad," he wrote on Instagram.

On Instagram, presenter Dermot O'Leary said he remembered Payne fondly.

"I remember him as a 14-year-old turning up to audition on the X factor and blowing us away singing Sinatra," he wrote alongside a picture of the

pair.

"He was always a joy, had time for everyone, polite, grateful and was always humble."

In August this year, Payne was announced as a judge on a new Netflix talent show alongside former Destiny's Child singer Kelly Rowland and The Pussycat Dolls star Nicole Scherzinger.

Payne, who was born in Wolverhampton in the UK, first tried for stardom when he auditioned for ITV talent show The X Factor in 2008 – but judge Simon Cowell told him to "come back in two years".

He did, impressing the judges more in 2010, and was put together with four other solo hopefuls at the boot camp stage

and One Direction were born.

The group had four UK number one albums and four number one singles as well as topping charts around the world, before Zayn Malik left in 2015, prompting the band's hiatus.

In 2017, Payne's debut solo single Strip That Down, which peaked at number three on the Official UK Chart, and his collaboration with Rita Ora on the song For You - from the Fifty Shades Freed soundtrack – also reached the top 10.

He began a relationship with Girls Aloud star Cheryl Tweedy in 2016 and they had a son, Bear, the following year. The couple split in 2018.

# Alex Salmond dead at 69

■ Former First Minister dominated politics for two decades in Scotland but was dogged by recent allegations of sexual misconduct

**FORMER Scotland first minister Alex Salmond has died at the age of 69.**

The Alba Party leader died suddenly in North Macedonia on Saturday night, just minutes after he had made a speech at the Institute for Cultural Diplomacy Forum in the city of Ohrid.

A post-mortem examination confirmed Mr Salmond's cause of death as a heart attack, the Alba Party said on Monday.

Eyewitness Mark Donfried, director of the Academy for Cultural Diplomacy, claimed Salmond collapsed as he tried to open a bottle of ketchup.

Salmond dominated Scottish politics for two decades but his power reached its peak in 2014 with the decision by David Cameron to grant the powers to hold a referendum on Scottish independence and reflected his achievement in leading the Scottish National party to power at Holyrood.

Salmond's power base lay in north-east Scotland but, under his leadership, the SNP transformed its electoral fortunes in the Labour heartlands of the central belt.

It was a paradox of his

career that he was better suited to the cut and thrust of Westminster debate than the more constrained environment of Holyrood. He was an orator and debater who flourished on the bigger stage and became an influential player in the politics of the UK as a whole.

After Salmond lost his Westminster seat in 2017, a nightmarish sequence of events dominated his life and placed enormous strains upon him. These centred around allegations from within the SNP and Scottish government of inappropriate sexual conduct in earlier years.

## 'scandal of our age'

Salmond was eventually cleared on all charges, but much of the damage to his reputation had been done. The provenance of these allegations remains bitterly contested, and at the time of his death Salmond was pursuing through the courts an action for damages against the Scottish government and named individuals, including his successor, Nicola Sturgeon. Recently, the former Scottish minister and scion of an SNP dynasty, Fergus Ewing MSP, described

the pursuit of Salmond as "the scandal of our age".

Born in Linlithgow, West Lothian, Alex was the son of Mary (nee Milne) and Robert Salmond, both civil servants. The local MP, Tam Dalyell, first encountered Salmond as a schoolboy at Linlithgow Academy who insisted on asking awkward questions about such subjects as prices and incomes policy.

The SNP was on an upsurge, on the back of the "Scotland's Oil" campaign, a cause that Salmond embraced in 1973, becoming a leading light in student debating at St Andrews University and president of the Federation of Student Nationalists. He graduated in 1978 with honours in economics.

Salmond brought a cutting edge to the SNP's presence at Westminster. In 1988, he attracted national attention by getting himself suspended for a week from the House of Commons for interrupting Nigel Lawson's budget speech. His election as leader of the SNP in 1990 created the platform for greater prominence and internal modernisation.

Tributes were paid to the former SNP leader from across the political spectrum, with First Minister John Swinney lodging a motion of condolence at Holyrood, while books of condolence have been opened in the parliament for MSPs and members of the public to leave messages.

A Scottish government spokesperson said: "Over the last few days, the Scottish government and UK government have been engaging with Alex Salmond's family and

working closely together in accordance with their wishes, to ensure the swift and dignified repatriation of the former first minister to Scotland."

They added: "The Scottish government continues to engage with Mr Salmond's family, and we stand ready to offer further advice and support, should it be required."

It later emerged that businessman and philanthropist Sir Tom Hunter paid for the plane flying Alex Salmond's body home from North Mace-

donia and a private family funeral was scheduled for Friday followed by a public memorial event at a later date.

In a statement, Sir Tom said: "Whilst he and I disagreed on some of his ambitions, Alex Salmond devoted his life to Scotland and the Scottish people and as such he, and importantly his family, deserved the dignity and privacy of a private return to the home of his birth.

"Our deepest sympathy and thoughts are with his family at this time."

## UK inflation drops below 2%

UK inflation fell unexpectedly to 1.7% in the year to September, the lowest rate in three-and-a-half years.

It means the annual rate prices are rising at is now below the Bank of England's 2% target, paving the way for further inter-

est rate cuts.

Lower airfares and petrol prices were the main drivers behind the surprise slowdown, official figures showed.

Separately, September's inflation figure is also normally used to set how much many benefits will

rise by next April.

UK interest rates are currently at 5%. The Bank made a first cut in August but decided to hold them last month.

It is already widely expected that they will be cut in November.

## Coleen vows to 'set record straight' in the jungle

Coleen Rooney has promised to "set the record straight about Wagatha Christie" when she enters the *I'm A Celebrity* jungle.

The 38-year-old, who is married to ex-footballer Wayne Rooney, has signed a £1.5million deal to join the hit ITV show next month, reportedly the highest fee paid to any star to appear on the series.

An insider said the former model has been "dismayed" by how she's been portrayed during her court drama with Rebekah Vardy and "wants to tell her truth".

It comes as Rebekah is reportedly ready to sue Coleen if she says "Wagatha Christie" – a term she trademarked after the trial.

It combines WAG (Wives And Girlfriends) with mystery author Agatha Christie.

A source close to Coleen says she is "delighted" to be appearing on the show as it will allow her to "set the record straight".

The insider added: "One thing she is desperate to make clear is how she never, ever wanted it to go to court.

"It was [Rebekah] who wanted her day in front of the judge.

"In the end, Coleen just stood up for herself and followed legal advice."

The wife of footballer Jamie Vardy unsuccessfully sued Coleen, who had identified Rebekah's Instagram account as the source of press leaks. Rebekah, 42, was ordered to pay 90% of Coleen's legal costs, but this is being contested over claims it has been inflated by items including fancy dinners.

Last week, Rebekah was ordered to pay Coleen a further £100,000 after losing her High Court claim in 2022.

# Novichok poison victim the unwitting victim of Russian spy murder plot

## Salisbury woman sprayed herself with deadly 'perfume' found by her boyfriend

The woman killed in the Salisbury novichok poisonings began foaming at the mouth and convulsing 10 or 15 minutes after unwittingly spraying the nerve agent on her wrists, an inquiry has heard.

Dawn Sturgess, 44, got into a bath with all her clothes on after becoming contaminated with novichok, which had been secreted in a fake perfume bottle that her boyfriend, Charlie Rowley, had given her, the inquiry into her death was told.

In police interviews read out at the inquiry, Rowley said he had told her "look what I found" before giving Sturgess what he thought was perfume as a present. He told how he had also spilled novichok on himself, and said his memory had been compromised and he was plagued by "peculiar dreams".

### 'very, very strange'

The inquiry has heard that the UK government believes the novichok was brought into Britain by agents tasked by Vladimir Putin to target the former spy Sergei Skripal, who was settled in Salisbury after a spy exchange. Skripal and his daughter, Yulia, were poisoned on 4 March 2018.

On 30 June 2018, Sturgess, a mother of three, and Rowley fell ill at his home in Amesbury, 11 miles north of Salisbury.

The inquiry was shown CCTV footage of Sturgess and Rowley spending time with other friends in Salisbury on the day before they fell ill and then catching a bus to Amesbury.

The next morning,

Rowley said, he was "hanging around" the kitchen when he spotted the package he had found containing the fake perfume bottle. Rowley said: "I spotted the package I picked up a couple of days prior and thought, now's a better time than ever to give her a present. I think Dawn was a bit moody with me."

He said he told her: "Look what I found." He said the package was difficult to open but consisted of a bottle and dispenser. He struggled to get the dispenser into the bottle. "It was just tight," he said. He eventually managed to get it open.

"Dawn began feeling unwell about 10 to 15 minutes after she sprayed the perfume on her wrist. She said I might need to help her but then she said she felt very, very strange and that she had to go and lie in the bath.

"After a minute I went into the bathroom to see what she was doing and found her lying in the bath with her clothes on, just lying in the bath, convulsing and foaming at the mouth. She had drool coming out of her mouth. I panicked. I tried to help her while I waited for ages for the ambulance. Her condition got worse and worse."

### 'peculiar dreams'

Sturgess was taken to hospital and Rowley went out. Later he felt ill and returned to his flat. "I looked in the mirror and noticed the size of my eyes. I've never seen my eyes that small in my whole life. I ended up in Salisbury hospital."

He said his memory

had been affected. "I have very little memory of what happened before I was poisoned. This is partly because of the novichok. I noticed it affected thought processes in my head. Since the poisoning it has been a lot harder to concentrate ... I have a lot of peculiar

dreams." He added: "It's annoying that I brought it [the bottle] into the house."

A key puzzle that remains is where Rowley found the bottle. Commander Dominic Murphy, the head of the Met police's counter-terrorism command, said

that as his account "developed" Rowley said he found the bottle in a Cancer Research charity shop bin in Salisbury. No trace of novichok was found in the bins but Murphy said the police could not rule out that the bottle was found there.

# Assisted Dying bill introduced into House of Commons

■ If it becomes law, measure would “allow adults who are terminally ill, subject to safeguards and protections, to request and be provided with assistance to end their own life”.

A bill to legalise assisted dying for terminally ill adults in England and Wales has been formally introduced in the House of Commons, triggering what is expected to be intense discussion over the coming weeks and months on an emotionally charged and controversial issue.

MPs will hold their first debate on the Labour MP Kim Leadbeater’s private member’s bill on 29 November. They will be given a free vote on the bill, meaning they can vote according to individual conscience.

The text of the terminally ill adults (end of life) bill has not been published, but its title states that it would “allow adults who are terminally ill, subject to safeguards and protections, to request and be provided with assistance to end their own life”.

The bill is expected

to propose that assisted dying be restricted to mentally competent adults with six months or less to live, although a 12-month prognosis is also a possibility. The details will be published in the coming weeks before the Commons debate.

### ‘dog-whistle message’

As Leadbeater introduced her bill, supporters and opponents of assisted dying gathered outside parliament. Organisations opposed to changing the law on assisted dying – including Christian Concern, the Christian Medical Fellowship and the Society for the Protection of Unborn Children – called on MPs to “kill the bill, not the ill”.

Dr Gordon Macdonald, the chief executive of Care Not Killing, said the bill “sends a dog-whistle message to

the terminally ill, vulnerable, elderly and disabled people, especially those on low or fixed incomes, that their lives are worth less than others”. He called for more focus on improving access to palliative care.

My Death, My Decision, which campaigns for a change in the law, said the introduction of the bill was a “significant and long-awaited step” to “end the inhumane blanket ban on assisted dying”. But it said the bill would exclude most people with conditions such as Parkinson’s, Huntington’s and multiple sclerosis from having the option of an assisted death.

### ‘slippery slope’

Earlier, Justin Welby, the archbishop of Canterbury, said the bill was “dangerous” and that in “every other place where it’s been done, [it] has

led to a slippery slope”.

Leadbeater said such concerns would be invalid with the right legislation. “We’ve got the benefit in this country of looking at what other countries have done. And I’m very clear, based on what I’ve seen so far and the research that I’ve done, that if we get this right from the start, which some places have done, places like Oregon and certain

states in Australia, we have very strict criteria, then those jurisdictions do not broaden out the criteria,” she told ITV’s Good Morning Britain.

If the bill clears its first hurdle next month, it will face line-by-line examination in committee and further Commons votes before being sent to the Lords where the process begins again. Any change in the law would not be agreed until next

year at the earliest.

A poll of more than 7,000 people this month found that almost three-quarters agreed that adults “who are intolerably suffering from an incurable condition and who wish to end their lives” should be allowed medical help to do so. It was conducted by Electoral Calculus for Humanists UK, a campaign group that supports assisted dying.

## World gone nuts: allegations fly as “King Conker” takes world title

The Conker World Championships has been embroiled in allegations of cheating after the winner of the tournament was discovered to have a steel conker in

his pocket, shaped and painted to look like a real one and threaded on identical lace.

Known as ‘King Conker’, David Jakins claimed the 2024 title at the in-

ternational event in England last weekend. The 82-year-old, who was also responsible for drilling and threading the conkers from which competitors choose randomly, is also facing accusations of marking the strings of in order to identify the strongest ones.

He has denied all of the allegations.

St John Burkett, spokesperson for the Conker World Championships, said he and other organisers became aware of the steel conker by the end of the competition, and that the committee had met to investigate the allegations.

‘I have to say it looks exactly like a real conker,’ he told Sky News, adding that the committee is likely to rule out foul play.

‘He showed us it at the end. It’s almost a bit like a lucky charm, I think, like a treasured possession.’

He added that organisers had ‘managed to find a few of the conkers David won matches with,

which he threw into the crowd’, and that he had personally overseen the men’s final.

But the lower-than-expected inflation rate has also opened the door for a December cut too.

Danni Hewson, head of financial analysis at AJ Bell, said a 0.25 percentage point cut was “pretty much nailed on” for November and expectations of a second cut in December had “jumped up”.

The Bank’s base interest rate heavily influences the rates High Street banks and other money lenders charge custom-

ers for loans, as well as credit cards.

The higher level has meant people are paying more to borrow money for things like mortgages, but savers have also received better returns. Increased mortgage repayments for landlords can also result higher rents.

The cost of living has surged in recent years, with inflation peaking at 11% in 2022 - way above the Bank of England’s 2% target, partly due to the increase in energy prices following Russia’s invasion of Ukraine.

## Sacré Bleu: Britain turns to French wood to restore Nelson's flagship

One of the most celebrated warships in British history is being repaired...using wood from France.

Horatio Nelson's flagship, HMS Victory, has been undergoing restoration by the National Museum of the Royal Navy at Portsmouth's Historic Dockyard.

She led Britain to victory over the French in the Battle of Trafalgar in 1805.

Andrew Baines, executive director of museum operations, said: "The Royal Navy has a long history of using timbers from across Europe and the world."

The conservation work is part of a 10 year project titled The Big Repair, which will cost £40-£45m.

Mr Baines said: "It's a huge undertaking which involves conserving and replacing many of her timbers, which have become weathered over the years."

"The majority of the oak for this task is likely to be supplied from France, where there is a centuries-old forestry system in place that can sustainably supply mature oaks for this kind of task."

Mr Baines said they "require timber of a much higher grade than was originally used in the ship's construction".

He acknowledged that some have said Nelson "might have been shocked" by the use of wood from his old enemy.

"We like to think that

actually he would have approved of the best, most sustainable oak being used," he added.

Visitors to Portsmouth Historic Dockyard can see the work take place as the shipwrights care for the iconic vessel.

The Battle of Trafalgar witnessed both the defeat of Napoleon Bonaparte's plans for France to invade Britain, and the death of Admiral Lord Nelson.

During the engagement, on 21 October 1805, Britain clashed with the Combined French and Spanish fleet at Cape Trafalgar, off the coast of Spain.

Ironically enough, France's much-admired sustainable forestry system was devised by... Napoleon.

But try hard to make it there on October 29 when Halloween comes early on a night of fiendish fun.

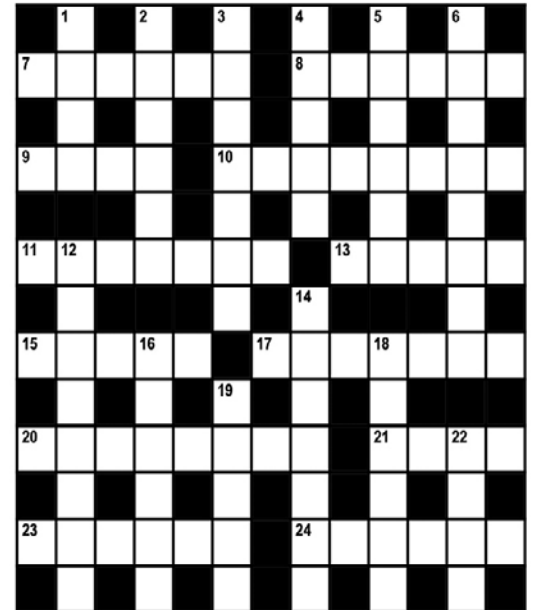

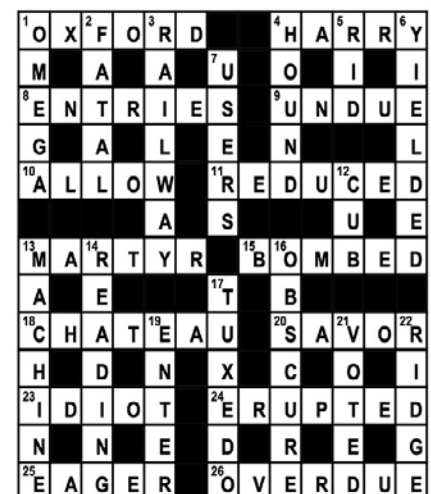

# Ten Weeks on the Camino

■ Nick Stark laces up his hiking boots and walks across Northern Spain via the famed Camino Frances. This week: Pamplona to Logrono

### Pamplona to Puente La Reina (15 miles)

After five days by foot from our starting point in St Jean Pied-de-Port, two rest days in the hectic town of Pamplona were very welcome. But even we can tire of great wines and imaginative tapas, and we were soon ready to strap on our backpacks and continue our trudge westwards. Our first destination lay 15 miles away in Puente La Reina, a town named after its magnificent bridge. It would not be the last we crossed on our Camino. But I'm getting ahead of myself. Leaving Pamplona we spent a couple of hours negotiating its dull urban outskirts before the suburbs gave way to a woody upland sweep along a rocky path lined with hawthorne and blackberry bushes, which took us up to the famed Alto de Perdon at about 2500ft.

The topography here provides Navarra's highest winds, birthing an impressive network of wind turbines which feed much of the region's power needs. The famed artwork at the peak was installed in 1996 and features life-size bronze images of pilgrims, horses and donkeys all heading west, and which (according to my guidebook), is 'heavy with symbolism of forgiveness both given and received'. Given the buffeting from the wind I was receiving, I was happy enough to snap a selfie and move on without contemplating the subject too long, happy to descend back into groves of Holm oaks, almond trees and wheat fields en route to Puente La Reina.

Our bodies had quickly adjusted to walking, but things still started

to get painful around the ten mile mark. Ankles, knees, tendons and cartilage all complained quite loudly as we limped into Puente La Reina, where we checked into the Estrella Guia Solo Peregrinos hostel, a clean and modern space run by a charming Brazilian woman, who fostered a calm atmosphere with meditative music and plenty of aromatherapy in the air.

We learned that her place is just part of a network of similar hostels along the Camino run by Brazilians, all of whom visited as pilgrims before being called back by something within to become hostel owners in their own right.

Our delight with this charming town was heightened by a fabulous meal at the Ganbara wine bar just round the corner, where we feasted on local roasted peppers with ventresca tuna, braised leeks with blue

goat cheese from a local artisanal cheesemaker, and bacalao (salt cod), washed down with as astoundingly cheap but beautifully structured local Navarran rosé.

And then there's the town's bridge, a six arched Romanesque beauty over the river Arga. Magnificently preserved, it makes a perfect Instagram backdrop as you depart en route to Estrella.

### Puente La Reina to Estrella (13.6 miles)

The road quickly turns rocky on this section and winds uphill to a series of picturesque hilltop towns. The highlight is negotiating a 2,000 year-old Roman road between the towns of Ciraqui and Lorca, about seven miles into the day's journey. The road was part of the Via Trajana back in the first century and cart tracks and cobble stones are clearly visible, even today. Here the Camino farmlands start to yield

to vineyards with the approach of the La Rioja region. After a hot, dusty day we were happy to arrive at Estrella, another former Roman town where our hostel perched charmingly on the banks of the river Ega, giving us some wonderful white noise to fall asleep to.

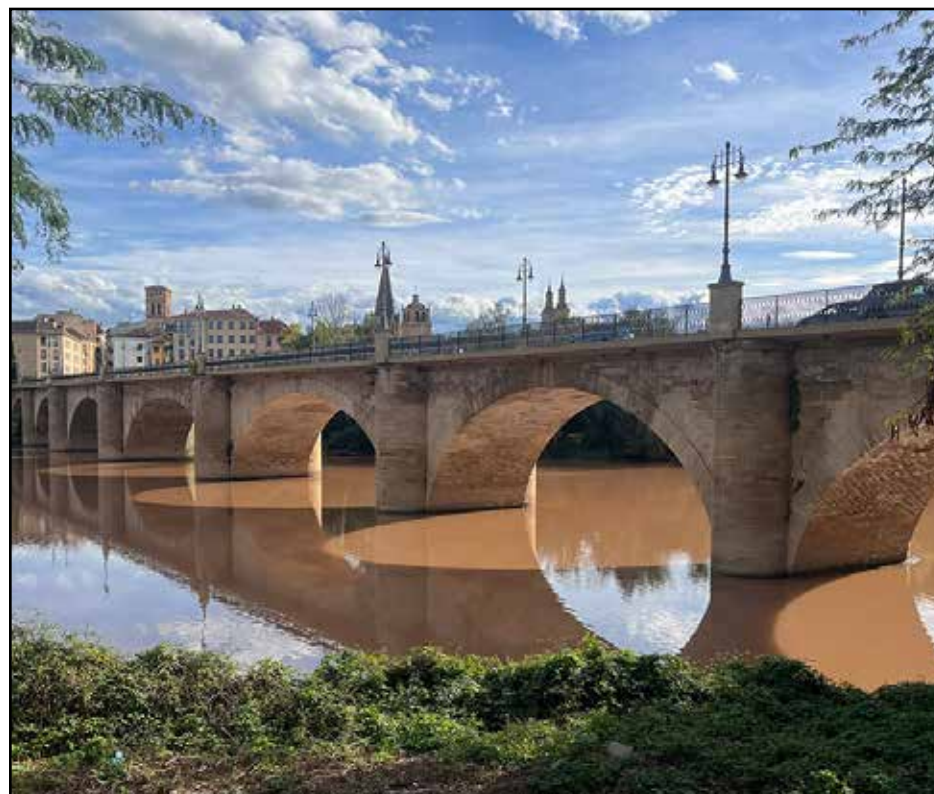
### Estrella to Los Arcos (13 miles)

One of the Camino's most famous places lies just a little outside of Estrella, among the vineyards of the Bodegas Irache winery ([www.irache.com](http://www.irache.com)). The clever proprietors have installed a 'wine fountain' which is really just a tap

on the side of their fermentation warehouse where pilgrims are invited to take a sip to help them on their way. Over-indulging or filling your Hydro Flask is possible but strongly discouraged, especially since the fountain has a webcam where folks can witness your glut-tony. For us, just a sip was enough given the long uphill climb that took us out of the vineyards and back into groves of holly oak and pine trees as we plodded up to Los Arcos. The town is named for Navarra's famed bowmen who were decisive in a three-way battle for the town back in the 13th century between their king and those of Aragon and Castille. Today it has a bustling main square (plaza mayor), mostly full of pilgrims, and the astoundingly baroque church of Santa Maria de los Arcos, a 14th century wonder boasting a black Madonna (which was quite a thing in these parts, back in the day) and a gorgeously preserved gothic cloister.

**Los Arcos to Logroño (16.5m)**

The road to Logroño is a long series of dusty dirt roads, wide open skies, and vines. Lots and lots of vines, mostly Tempranillo but with some Garnacha. Since it was still September most of the fruit had not yet been picked, and was hanging juicy and plump on the vine, tempting passersby such as myself. The hills, such as they were, were rolling and gentle but without much shade, prompting us to fill our water bottles whenever we passed through the villages on route.

These villages clearly benefit from Camino traffic. Most of the hous-

es look recently built and are in complete visual harmony with the 15th century originals they abut. The balconies are awash in colorful window boxes of geranium or violas. The streets are clean. The cars, such as they are, are usually late model French or German sedans. And each town has one or two bars for thirsty travelers to whet their whistles with either a 'caña' (small draft beer) or a café con leche while wolfing down the requisite 'bocadillo' (little bite) usually a ham and cheese bolillo (roll) or the ubiquitous tortilla espanola, the delicious egg, potato and onion local staple which we turned to almost every day for sustenance.

The dirt road gradually gave way to a paved one and soon enough we arrived at Logroño, greeted (again) by a quite magnificent bridge linking the old town with the new. We gratefully settled into an apartment chosen for its proximity to the Plaza Mayor and its vital amenity - a washing machine. Regular laundry can be quite a challenge

on the Camino, and neither of us were keen to smell like vagabonds, so a laundry stop every three days or so was non-negotiable.

The town itself was a delight - anchored by a bustling main square with a marvellous cathedral to gawk at, and with dozens of sinuous and inviting alleyways branching off it, heaving with locals enjoying local wines and tapas/pinchos every evening. We spent two days here, indulging as much as possible in the food and wine, which leans heavily on game, with partridges, blood sausage, wild boar and more of their ilk on many menus.

And like Pamplona, there was a ver noisy fiesta going on. Lucky us. The streets were again filled with drummers and marchers and bibulous celebrants, dozens of whom seemed determined to conduct high-volume debates underneath our bedroom window at 4am.

All part of the fun, I guess.

# Lando: second to Max still a success

Lando Norris says he and McLaren will be able to call 2024 a success even if they do not succeed in beating Red Bull's Max Verstappen to the title.

Norris heads into this weekend's United States Grand Prix, the first of the final six races of the season, 52 points adrift of Verstappen.

Briton Norris won the previous race in Singapore four weeks ago with Verstappen second.

Norris said: "We're fighting against the best of the best but no matter what it has still been a successful season."

The gap between Ver-

stappen and Norris equates to an average of nearly nine points a race - more than the gap between first and second places.

It has narrowed from 78 points following the Belgian Grand Prix, four races ago.

Norris said: "If I finish second it's because Red Bull and Max have done a better job."

"We started (the season) a long way behind. Everyone thought Max was going to have an easy win."

"For that not to be the case after the gap they had after race one, it's still

a year to be proud of.

"But as the season goes on, you always reevaluate what are our expectations and now we are a top team and fighting for drivers' and constructors' championships."

"I've been doing a good job. I have been happy with the job I have been doing as a team and confident if we keep our heads down and keep pushing, we can close the gap."

"It's not easy, we need more than me first and Max second but I can't change that, just keep my head down and focus on myself."

# Tuchel takes England hot seat

## ■ German manager signs 18-month deal to lead England towards 2026 World Cup

Thomas Tuchel has been appointed England manager from 1 January 2025.

The 51-year-old German, who has signed an 18-month contract, becomes the third non-British permanent manager of the men's team after Sven-Goran Eriksson and Fabio Capello.

Gareth Southgate resigned in July after England's defeat by Spain in the Euro 2024 final.

Lee Carsley, who has overseen four games since being appointed interim manager in August, will remain in charge for the Nations League matches against Greece and the Republic of Ireland next month.

Former Chelsea boss Tuchel, who left Bayern Munich at the end of last season, said: "I am very proud to have been given the honour of leading the England team.

"I have long felt a personal connection to the game in this country, and it has given me some incredible moments already.

"To have the chance to represent England is a huge privilege, and the opportunity to work with this special and talented group of players is very exciting."

Chief executive Mark Bullingham said the Football Association had appointed "one of

the best coaches in the world".

He said: "Thomas and the team have a single-minded focus on giving us the best possible chance to win the World Cup in 2026."

England have not won a major trophy since the 1966 World Cup.

They will start their qualification process for the 2026 tournament in Canada, Mexico and the United States next year.

The FA approached Manchester City manager Pep Guardiola in the summer to see if he had an interest in the role, while Newcastle United boss Eddie Howe and ex-Brighton and Chelsea manager Graham Potter were also linked with the position.

The FA said Tuchel was the "preferred candidate" from "several" managers interviewed.

It said the FA board approved the decision last week and Tuchel signed a contract on 8 October.

Under Carsley, England lost to Greece on 10 October and beat Finland on 13 October.

"The announcement was delayed to minimize distraction around the international camp that has just concluded," an FA statement read.

English coach Anthony Barry, who worked with Tuchel at Chelsea

and Bayern, will be his assistant.

Tuchel won the German Cup with Borussia Dortmund and two Ligue 1 titles at Paris St-Germain, including a domestic treble in 2019-20.

He became Chelsea manager in January 2021, winning the Champions League, Club World Cup and Uefa Super Cup before being sacked in September 2022.

After Bayern failed to win the Bundesliga title last season for the first time since 2011-12, Tuchel left despite still having a year to run on his contract.

Carsley will return to manage England Under-21s when Tuchel takes over.

## Tuchel 'sorry' for his German passport

THOMAS Tuchel made a strong impression in his first press conference since his appointment as new England manager was announced, immediately addressing concerns that he was not an Englishman.

"I'm sorry, I have a German passport," he said on

Wednesday.
