



Royals get a (mostly) warm welcome Down Under

Charles makes first visit to Australia since ascending to the throne, but his appearance in Canberra is marred by heckling from Aboriginal activist

KING CHARLES and Queen Camilla have concluded a mostly successful tour of Australia, being greeted by thousands of people out on the streets of Sydney on Tuesday.

For Buckingham Palace, this was the ideal ending to the royal tour of Australia.

The optics were positive. Despite a headline-grabbing protest in Canberra on Monday, the public mood on the ground in Sydney was supportive.

But getting to this point - with a successful completion of this trip ahead of a poignant goodbye - will have come as a huge relief to royal aides.

Back in February, this tour looked unlikely to happen with the King diagnosed with cancer and having treatment.

But it stayed in the diary with modifications on the advice of doctors.

The duration of this visit has been shorter and the engagements have been arranged to avoid early starts and late finishes.

Even with the alterations, it has still been a busy schedule for the King and Queen.

On Tuesday alone the royal couple between them visited a National

Centre of Indigenous Excellence, a food bank, a social housing project, a literacy initiative, a community barbecue, meeting two leading cancer researchers, celebrating the Sydney Opera House's 50th anniversary, and a naval review in Sydney Harbour.

An Australian arm of the King's Foundation was officially launched, expanding a charity which promotes sustainability and provides training in traditional craft skills

His health challenges haven't shown and he has appeared moved by the response he's had from the public on his first visit here as monarch.

The protest at Parliament House in Canberra on Monday was uncomfortable but not unexpected.

Australian senator Lidia Thorpe, an Aboriginal Australian woman, interrupted the ceremony in Canberra by shouting for about a minute before she was escorted away by security.

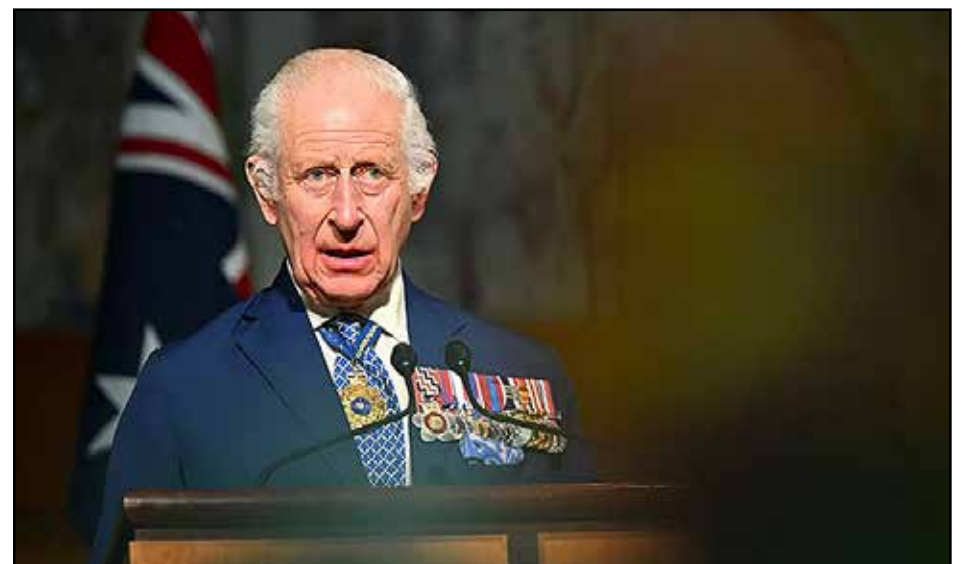
After making claims of genocide against "our people", she could be heard yelling: "This is not your land, you are not my King."

But Aboriginal elder Aunty Violet Sheridan, who had earlier welcomed the King and Queen, said Thorpe's protest was "disrespectful", adding: "She does not speak for me."

The ceremony concluded without any reference to the incident, and the royal couple proceeded to meet hundreds of people who had waited outside to greet them.

After her protest, Thorpe told reporters she had wanted to send a "clear message" to the King. "To be sovereign you have to be of the land," she said. "He is not of this land."

Thorpe, who is an independent senator from Victoria, is among those who have advocated for a treaty between Australia's government and its first inhabitants.

Trump cries foul at 'interference' from Labour Party activists for Harris

Donald Trump's campaign has filed a Federal Election Commission (FEC) complaint against the Labour Party, accusing it of "blatant foreign interference" in the US election in aid of the Harris-Walz campaign.

The complaint cites media reports about contact between Labour and the Harris campaign as well as apparent volunteering efforts, arguing that this amounts to illegal "contributions".

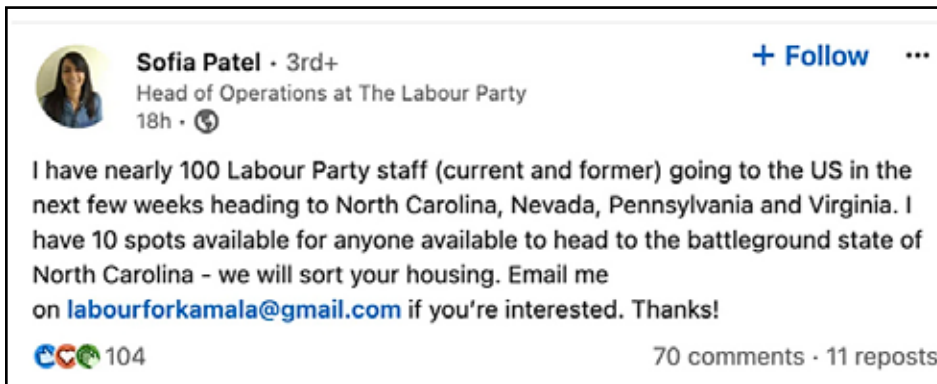
Labour activists campaigning in the US presidential election are doing so in a personal capacity.

Prime Minister Sir Keir Starmer, the Labour leader, has sought to play down the row - pointing out that Labour has long sent volunteers to US elections.

It is considered normal for party officials from the UK to be in contact with counterparts in the US. This has also taken place previously between Trump's Republican Party and the UK's Conservative Party.

When asked if he risked jeopardising his relationship with any future Trump administration, Starmer simply said "no".

Sir Keir pointed to a

dinner the two men had together at Trump Tower in New York last month, saying they "established a good relationship".

The dispute appears to have begun with a LinkedIn post which asked for people to travel to the US and said nearly 100 were signed up to go.

The post, from Labour Party head of operations Sofia Patel, added that 10 "spots" are available and

that "we will sort your housing".

It appears to have since been deleted.

'political stunt'

The Trump campaign complaint cites this, as well as newspaper reporting that Labour-linked individuals have travelled to the US to campaign for Harris.

That reporting, the complaint alleges, creates

a "reasonable inference that the Labour Party has made, and the Harris campaign has accepted, illegal foreign national contributions".

The complaint also refers to Washington Post reporting that communications were exchanged between the parties and that senior officials have met in private.

The Trump campaign has also made compari-



sons with an international programme in 2016 in which the Australian Labor Party, or ALP, sent delegates to help with Bernie Sanders' campaign. In that instance, however, the ALP paid for flights and daily stipends. The party and the campaign were each handed down civil penalties of \$14,500.

Activists' trips by the UK Labour Party have not been organised or funded

by the party, it is understood from party officials.

Foreign nationals are permitted to serve as campaign volunteers as long as they are not compensated, according to FEC rules.

A former Labour activist who volunteered for Barack Obama's presidential campaign in 2008 called Trump's allegations "nothing more than a political stunt".

Farage milkshake thrower admits assault

A woman has pleaded guilty to assault by beating after throwing a milkshake over the Reform UK leader, Nigel Farage, outside a pub in Clacton-on-Sea during the general election campaign.

Victoria Thomas Bowen, 25, also admitted criminal damage after causing £17.50-worth of damage to a jacket belonging to Farage's security officer James Woolfenden.

Farage, who is now Clacton's MP, was

doused as he left the Moon and Starfish Wetherspoon's pub in the Essex seaside town on 4 June.

He had earlier addressed supporters at an election rally and was left with the yellow liquid splattered across his dark blue suit.

Thomas Bowen had originally denied the charges and was due to go on trial at Westminster magistrates court on

Monday but changed her pleas to guilty before proceedings began. An Ikram, the deputy senior district judge, adjourned sentencing to 16 December and told the defendant: "You have pleaded guilty to, in my judgment, two serious charges.

"This was an unprovoked, targeted attack now on an elected member of parliament. I take a serious view of these offences. I am seeking

a pre-sentence report, which will consider all options for sentence."

In a witness statement read out in court, Farage said he had not been injured but "this incident caused me concern as I have only been going about my job" and that he tried to "have as much public engagement as possible".

"I'm saddened that this has happened at a public campaign," he added.

Shot putt legend Geoff Capes dead at 75

■ Fomer policeman enjoyed long career in athletics and also found success as a budgie breeder

Geoff Capes, the long-time British record-holder in the shot put, world's strongest man winner and multiple Highland Games champion, has died at the age of 75.

During a long career Capes also won two European indoor shot put titles and two Commonwealth Games gold medals. In addition, he competed in three Olympic Games.

In all, he improved the British record from 19.56m to 21.68m – holding the mark from 1972 to 2003 – and competed for Britain a remarkable 67 times. At the height of his fame the shot circle at Crystal Palace was

moved to the centre of the home straight so that he would be centre stage. A bona fide athletics icon, he would often start competitions with his track-suit on and then take it off in the fourth or fifth round when “he meant business”.

‘tearaway’

Amazingly, Capes was the smallest of five brothers and in his early days ran a 4:48 mile and competed in cross-country. This running ability never left him during his throwing days either as he beat another British star of the era, Brendan Foster not once but twice in exhibition 200m races in

Gateshead then Spalding.

The turning point for Capes as an athlete was when he met the international sprint hurdler Stuart Storey. A self-confessed “tearaway”, Capes knuckled down under Storey’s coaching and began setting age records from 16 onwards. They remained lifelong friends, too, with Storey sadly breaking the news of Capes’ death.

In the weights room Capes learnt how to lift when working on the Lincolnshire farming fens alongside his father and eight siblings, before later combining a police career with his

athletics and strongman triumphs. During his lengthy career, 1974 was his best season when he won European indoor and Commonwealth titles and announced himself as a truly world-class thrower. His biggest ever throw, however, came in 1980 when he threw 21.68m in Cwmbbran.

He went to the Moscow Olympics that year aiming for a medal but a back injury thwarted his chances and he wound up fifth.

Outside athletics he was a six-time Highland Games champion and won the world’s strongest man title in 1983 and 1985.

Somewhat bizarrely, given his huge size, after his sports career he became a top budgerigar breeder at his home near Grantham. A passion for breeding the small birds saw him crowned the budgerigar society’s president, as well as winning the world showing title.

Classic Pie ‘n’ Mash needs saving, says Essex MP

An Essex MP has led a parliamentary debate calling for traditional pie ‘n’ mash with liquor to get protected status, like champagne and Cornish Pasties.

Richard Holden, the Conservative MP for Basildon and Billericay, said the dish was “part of that Cockney diaspora”, describing it as “the original fast food”.

He led a debate in Westminster Hall this week to stop producers claiming it - but with a different recipe.

Andy Green, who founded the Modern Cockney Festival, said obtaining the status “may kickstart a fresh look from government agencies and public bodies to recognise the tradition and culture that pie ‘n’ mash rep-

resents”.

Mr Holden said: “With British staples like Cornish Pasties, Bramley Apple Pies and Melton Mowbray Pork Pies already enjoying protection, it’s now time we protect this important dish to be recognised and celebrated, as it is enjoyed by families for decades to come.”

PC's trial in Kaba case 'a farce'

A former Met Police marksman, who was cleared of the murder of a suspected armed robber, has said the case against Martyn Blake was "a farce from start to finish".

Mr Blake, 40, shot Chris Kaba in the forehead during a police vehicle stop in Streatham, south London, in September 2022.

The officer, who was cleared of murder earlier this week, told the Old Bailey how he feared one of his colleagues might be killed by 24-year-old Mr Kaba, who had been boxed in by police cars and was trying to ram his way free.

Former Met officer Tony Long – who was found not guilty in 2015 of the murder of Azelle Rodney – said: "I was frustrated and annoyed like most serving police officers about the circumstances."

"This stuff doesn't go away"

He told BBC London: "From the body-worn footage, it explains in a second the kind of threat that Martyn Blake and his colleagues were under."

"Everyone they asked said... Martyn is not the sort of person who would panic or be angry in this scenario."

"Most people who had anything to do with the case – including the jurors who came back so quickly – evidently were thinking, as soon as they saw the the video at the beginning... 'why are we here?' So I don't think it (the trial) should have ever taken place."

Mr Long shot Azelle Rodney, 24, in north London, in April 2005 during an operation to foil a robbery.

PC cleared of murder in Chris Kaba case

■ Community activists decry decision but Met chief says the accused made "a split-second decision on what he believed was necessary to protect his colleagues"

A police officer has been cleared of murdering a man he shot in the head in south London two years ago.

Martyn Blake, 40, shot Chris Kaba, who was unarmed, during a police vehicle stop in Streatham in September 2022.

Speaking after the verdict at the Old Bailey on Monday, Mr Kaba's family said it was "painful proof that our lives are not valued by the system".

Metropolitan Police Commissioner Sir Mark Rowley said: "No police officer is above the law, but we have been clear the system holding police to account is broken."

Mr Blake, who denied intending to kill the 24-year-old, took a deep breath as the jury's decision was read out, but otherwise did not react to the not guilty verdict.

The Met said the officer, who was suspended throughout the process, would be immediately reinstated.

Mr Kaba, who was due to become a father, had been followed by police because the car he was driving had been linked to a previous shooting in

Brixton.

After being boxed in by police cars during the stop, he drove backwards and forwards trying to ram his way free, which Mr Blake said made him believe one of his colleagues would be killed, and he opened fire to stop the car, the jury heard.

Mr Kaba died from a single gunshot wound to the forehead.

One of Mr Blake's fellow firearms officers told the court he would have taken a shot if Mr Blake had not, and another said he was "fractions of a second" away from doing the same.

The Metropolitan Police Commissioner said Mr Blake had paid "a huge personal and professional sacrifice" in the two years since the shooting.

'Lack of support'

Sir Mark said the officer had made "a split-second decision on what he believed was necessary to protect his colleagues and to protect London".

He criticised the systems used to hold police officers who take lethal shots to account.

"I worry about the lack

of support officers face for doing their best, but most of all, I worry for the public," he said.

"The more we crush the spirit of good officers, the less they can fight crime – that risks London becoming less safe."

In protest after Mr Blake was charged with murder, more than 100 Met firearms officers turned in their permits that allowed them to carry weapons.

Such were the concerns that officers would again hand in their weapons if he was convicted, the

army was put on standby to provide an armed response in the capital if required, it was reported.

Mr Kaba's family said they were devastated by the verdict, and that the acquittal of Mr Blake "wasn't just a failure for our family, but for all those affected by police violence".

A gathering of about 150 people held a vigil outside the Old Bailey on Monday evening, some holding signs with slogans including "this is not justice" and "police are

perpetrators".

Earlier, Sheeda Queen, a cousin of Mr Kaba, and a member of the Justice for Chris campaign group, described "a deep pain of injustice, adding to the unbearable sorrow".

Following Mr. Blake's acquittal, the presiding judge ordered reporting restrictions lifted, and it was revealed that Mr Kaba was a leading member of one of South London's most violent drug gangs, and was a leading suspect in two gang-related murders in the area.

Vengeful daughter posted naked pictures of dad's ex on dating site

A police officer's daughter has been jailed for three years after posting sexual images of his ex-lover on an escort site in an act of revenge.

Eleanor Brown, 24, "conspired" with her sister Sophie and her mother Sarah – both ex-police officers – to create a fake profile of the woman on the site, Leeds Crown Court heard.

Brown had held a grudge against her victim since she was a teenager after her father Geoff had a short-lived affair with her in 2012, the court was told.

The affair took place while her father and the victim were both police officers but it ended and they stayed with their spouses, Judge Alex Menary said.

Ten years later, Brown noticed the woman's husband had started a business and this was a trigger for first posting offensive messages on his Facebook page, calling his wife a "home-wrecking slag" and a "tramp".

Brown then sent the husband sexual images of his wife before creating the fake profile on an escorting and sex services

website, also featuring intimate photographs.

Neither the mother or sister were charged in the case.

Sophie Brown, who was a patrol officer, was reportedly found to have committed gross misconduct at a police hearing in April for having "encouraged" her sister's actions.

The misconduct panel ruled she would have been sacked had she not already resigned.

The escort profile created by Brown was titled "Ex-police with all my uniform which I like to wear for my clients" and

used the phrase "kinky copper", the court heard.

Judge Menary said the escort site post included the husband's mobile number and he was then bombarded with texts

and calls after it went live.

In a victim personal statement read in court, the woman said that to describe herself as feeling "violated" was an "understatement".

Jeff Lynne's ELO announce farewell show in London

■ Final show at Hyde Park next July will be 'special night in London with our UK fans'

Jeff Lynne's ELO have announced that they will play their final show at Hyde Park in London on 13 July.

The show – part of a series of outdoor concerts in the capital – will follow the band's current Over and Out tour in the US.

"My return to touring began at Hyde Park in 2014," Lynne said in a press release. "It seems like the perfect place to do our final show. We

couldn't be more excited to share this special night in London with our UK fans. As the song goes, 'We're gonna do it one more time!'"

The Birmingham band effectively split in 1986. ELO Part II, led by Bev Bevan, continued to tour; a Lynne-led ELO returned with album Zoom in 2001, their first since 1986's Balance of Power, but a tour for that record was scrapped.

Frontman Lynne and

pianist Richard Tandy reunited to perform acoustic versions of their songs for a 2012 BBC special, and again a year later for a BBC Children in Need concert.

A fully fledged Lynne-led reunion took flight in 2014 when the band played BBC Radio 2's Festival in a Day at Hyde park. A new album, Alone in the Universe, was released in 2015, and a subsequent tour included a slot on the Pyra-

The TSG (Traditional Speciality Guaranteed) status is defined by the specificity and traditional element of the dish and decision makers will need to see a recipe agreed.

Almost 30 years ago there were 60 pie 'n' mash shops across London, but there was barely a third of that total left by 2020.

Mr Green said there was "a narrative that pie 'n' mash shops are closing and maybe pie 'n' mash is dying" but, he added, "the reality is it's evolving".

"Listed traditional food status would give a mark, a statement that despite rumours of its death, pie

'n' mash is very much alive and thriving," he said.

Mr Green said its Cockney identity had spread further than the traditional areas of east and south London, marked by the spread of pie 'n' mash shops, from Bishop's Stortford in Hertfordshire to Tunbridge Wells in Kent.

He said some shops were "evolving" with the times by offering vegetarian options and delivery services.

The iconic dish which has become synonymous with Cockney culture is thought to date back to the 1840s.

Traditionally, it consisted of a savoury pie filled with minced beef, served with mashed potatoes

and a parsley liquor. But for anyone feeling adventurous, pie 'n' mash can also be served with stewed jellied eels - another Cockney favourite.

Those who love it, like the Cockney Modern Festival organisers, say it is an artisanal food with recipes handed down throughout generations "like precious family heirlooms".

Mr Holden said he has written to more than 40 MPs who have a pie 'n' mash shop in their constituency, adding: "It's part of a campaign to celebrate and really promote pie and mash, which has spread out from its beginnings in central and east London, down the Thames Gateway and out into the world."

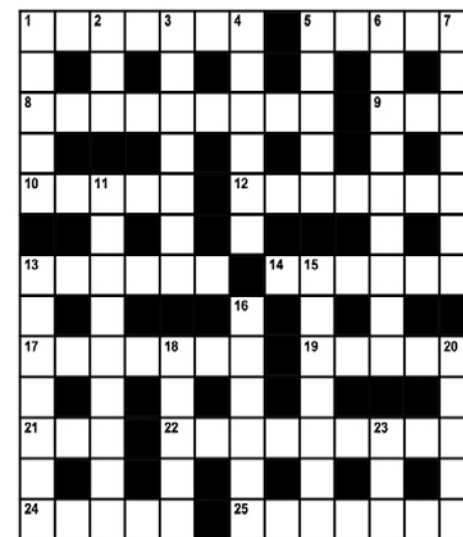

TEN WEEKS ON THE CAMINO: Nick Stark walks through the vineyards of Rioja, enjoys the magic of Burgos and a bit of El Cid

Logrono to Najera 17m

By the time you've settled into your third week walking the Camino Frances, your body should have adjusted to the demands you've been making of it.

Your legs and feet will already have about 150m in them and your blisters should have transformed into callouses, unbothered by chafing from your boots. As the body adjusts, the mind tends to focus more on the gorgeous landscape surrounding you and that 15lb backpack starts to feel a lot less onerous. And the prospect of 350-odd miles more doesn't seem so daunting.

At least that's how it worked for us.

We bid a fond farewell to Logrono and set out for Najera, a memorable step of 17 miles through this region's famed red earth, rolling hills and extensive vineyards. This is Rioja country, the area getting its name from the local river, the Rio Oja, which we cross several times en route to our destination. There are plenty of long desolate stretches of pathway here, with barely a pilgrim in sight ahead or behind, but every 90 minutes or so we came to a hilltop town to get fed and watered. The cafés and bars in this part of the world depend heavily on pilgrim traffic, and location really does matter: first bar in town was usually jammed with pilgrims eager to put down their packs and whet their whistles, but the patient pilgrim who could bear to turn the next corner or walk another two minutes was usually rewarded with bigger smiles, no lines and slightly cheaper prices.

Najera to Santo Domingo 13m

Our destination for the night was the 'Hospedar-

ia Cistercense', which in plain English means a hostel run by Cistercian nuns. Although I was intrigued by this prospect it turned out to be one of our least stimulating stays. The nuns in their habits were brisk and businesslike, in fact far less friendly than the entrepreneurial hospidaleros we were used to dealing with. To make

things even less enticing, the building itself is a dreary 1960s-style former student lodging devoid of any charm or individual identity. And their morning desayuno (breakfast) featured the worst coffee I can ever remember drinking. We had Fortunately the town has a bustling strip of bars and restaurants, so at least dinner

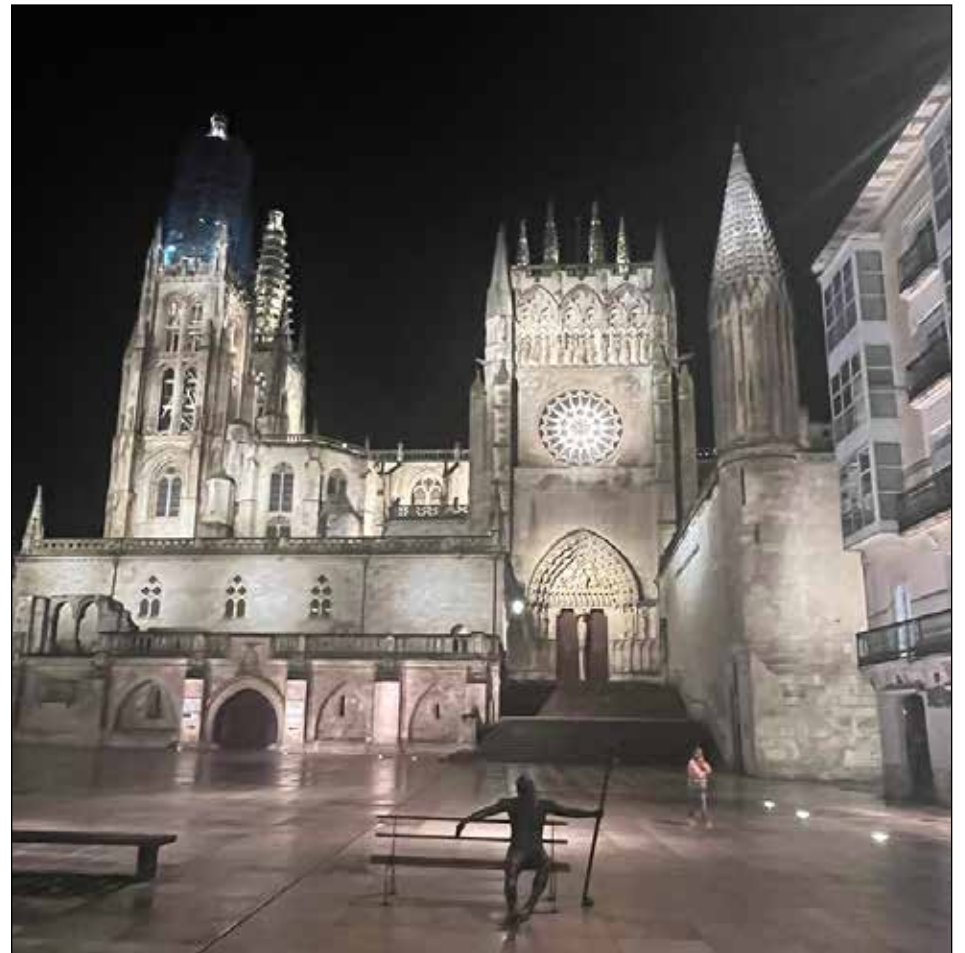

feet, the vineyards of Rioja began to yield to fields of wheat and other arable crops. We were entering Spain's breadbasket and the region of Castilla y Leon, an historic and large swathe of the country that comprises its largest autonomous region and where we would spend the next two weeks. From a walking perspective it was an easy section, with rolling hills and mostly deserted paths between towns, with the most pressing issue being to avoid the tractors driven by local farmers eager to harvest their crops before the coming rains. Fields of sunflowers were everywhere, but they were all a few weeks past their peak, their wan and brown faces turned sadly earthwards. The town of Belorado is a picture-perfect little place wedged between two small mountains dotted with caves favored originally by hermits and early Christians. Which is a complete contrast to our next stop, Villafranca, a town whose existence relies chiefly on its role as a crossroads through which Spanish semi-trucks thunder laden with farm produce. Good only for an overnight stop and a quick exit at sunrise.

Villafranca to Atapuerca (11m) Things started to look up again, so to speak, on the long uphill climb out of Villafranca through a gloomy oak and pine forest which looks positively primordial when viewed from the path. In medieval times this was a bandit hideout used to prey on pilgrims, prompting the Knights Templar to build a fortified village nearby from which to sally forth and protect the faithful. There is also a monument to dozens of unarmed villagers killed by General Franco's troops during the Spanish civil war, a grim reminder that this



country was not always as civilized as it now seems. And for anthropologists there is an interesting excavation in the nearby Atapuerca mountain range, where bone fragments from around 800,000 years ago provide the oldest known evidence of hominid settlement in Western Europe.

Atapuerca to Burgos (12m)

As we approached the city of Burgos we could feel the landscape flattening out, the mountains fading away and the biodiversity of the farming dwindling down to a single crop: wheat. The approach to Burgos takes the best part of half a day and is very pleasant if you take the Camino route by the river, where you can enjoy shade and quiet right until you stumble across the entrance to the city's Casco Antiguo (Ancient District), which is an absolute delight.

Burgos is justly famous for two things: its magnificent cathedral, which dominates the old town and is considered by many second only to those in Seville and Toledo for its splendor; and for its most famous son, Rodrigo Díaz de Vivar, better known as El Cid, scourge of the Moors during the Reconquista, as Catholic Spain re-established its supremacy over Islam, and characterized forever by Charlton Heston in the movie of

the same name.

As with Logroño and Pamplona, the side streets are characterized by sinuous and winding alleyways full of bustling bars and cafés selling low-price local wine and fabulous tapas. The food here is classic Castilian: dominated by meats such as lechazo (suckling lamb), cochinita (suckling pig), jamon iberico (the classic Spanish cured ham) and morcilla (blood sausage). The meat theme continues with their famed cocido (a hearty meat and vegetable stew) and the robust but challenging callos (tripe soup). Not surprisingly, red wines are heavily favored given their meat-driven menu, with the Tempranillo regions of Ribera del Duero, Toro and Rueda the most popular.

If you do find yourself in Burgos, do not miss whetting your whistle at the **Victoria Vermouteria**, a fabulous neighborhood bar located just to the right at the old town's entrance. The place boasts a large selection of regional artisanal vermouths, which the locals typically enjoy with an ice cube, a slice of orange and an olive. The buzz is lively, the service prompt, and best of all, every evening at 10pm everything comes to a halt as a brass soundtrack fills the air and the locals belt out a rousing rendition of the local Burgos anthem. Magical stuff.

Spurs win, United draw

Richarlison scored from the penalty spot to help Tottenham maintain their perfect start in the Europa League with a 1-0 victory over AZ Alkmaar on Thursday night.

In his first start for Spurs this season after injury trouble, the Brazilian briefly argued with James Maddison to take the penalty after Maxim Dekker had kicked out at Lucas Bergvall in the box.

Captain Maddison relinquished the responsibility and Richarlison confidently sent the ball straight down the middle to hand Tottenham the decisive goal in the 53rd minute.

Ange Postecoglou's side had struggled to break down AZ's defence until then and couldn't make the most of their few clear-cut first-half chances.

Mikey Moore glanced a close-range header wide early on, while Timo Werner's problems in front of goal continued with two lacklustre efforts before he was replaced by Brennan Johnson during the break.

But Spurs were much improved after the interval, with exciting English teenager Moore playing a starring role at Tottenham Hotspur Stadium.

The 17-year-old was a constant threat as he swapped the right wing for the left after Werner's departure.

Tottenham found themselves under pressure in parts with Fraser Forster needed at full stretch to stop a looping header from Alexandre Penetra.

Former Spurs forward Troy Parrott, who moved to the Dutch side in July, had the chance to equalise with 15 minutes remaining but he drilled his strike straight at Forster.

AZ were forced to play the last five minutes with 10 men, though, as David Moller Wolfe received a second yellow card.

The result leaves Spurs on nine points from three games in the Europa League, although tougher tests lie in store with Galatasaray and Roma to follow in November.

Jose Mourinho was sent off as his Fenerbahce side came from behind to condemn his old club Manchester United to a third successive Europa League draw in Istanbul.

United had led at the break in Thursday's match through Christian Eriksen's fourth goal of the season.

But the hosts levelled four minutes after the restart when Youssef En-Nesyri got between United defenders to head home Allan Saint-Maximin's cross from close range.

With the noise levels rising and excitement at fever pitch, Mourinho

was red carded by French referee Clement Turpin just before the hour as he led the home side's penalty claims after Bright Osayi-Samuel went down under a challenge by United midfielder Manuel Ugarte.

Despite furious protests from the Fenerbahce bench, VAR backed up Turpin's view there was nothing illegal about the incident and Turpin came to the technical area to tell Mourinho to leave. The Portuguese took his time but eventually relocated to the steps at the front of the stand next to the dug-outs, close enough to continue to give instructions to his coaching staff.

United had their chances to win the game but substitute Rasmus Hojlund opted to go on alone rather than play a pass to the better placed Alejandro Garnacho and his shot rolled harmlessly through to home goalkeeper Dominik Livakovic. Then Garnacho lost control of the ball as he ran into the area and that chance went begging too.

The visitors also failed to avoid another injury issue, as manager Erik ten Hag had hoped, as Brazilian wide-man Antony was stretchered off when he landed awkwardly after attempting an unnecessary flick by the touchline.
