

# Kate's Kremlin trolls cut down to size

■ Government acts to punish Russian network, which stands accused of spreading malicious rumours about the Princess of Wales

**A Russian network accused of spreading malicious rumours about the Princess of Wales has been sanctioned by the Government.**

Three Russian agencies and three senior figures are accused of being part of the Doppelganger group, which swamps social media with fake posts, counterfeit documents and deepfake material.

The disinformation group, identified as being behind online rumours about Kate's health, were also accused by the Foreign Office of trying to "undermine and destabilise Ukraine and its democracy".

In the weeks before Kate revealed her cancer diagnosis in March, social media was swamped with conspiracy theories as she took a break from the public eye after abdominal surgery in January. Despite Kensington Palace having stated that the princess would not return to royal duties before Easter, her prolonged absence was

met with malicious rumours online that added to her ordeal.

When a video was published showing Kate and husband Prince William visiting a farm shop in Windsor the Doppelganger group seized on it to spread further misinformation.

Days later, Kate released a video message bravely revealing her cancer diagnosis, putting a stop to the online speculation.

### 'lies and intolerance'

Professor Martin Innes of the Security, Crime, and Intelligence Innovation Institute at Cardiff University, where the group's involvement in the rumours was identified, said: "Doppelganger was leaping on the conspiracies and amplifying them and nudging their visibility forward."

The Foreign Office has accused Doppelganger

of creating many fake versions of legitimate news websites in a bid to trick social media users into believing false information.

Sanctions including asset freezes and travel bans were imposed on the agencies Social Design Agency, Structura

National Technologies and Ano Dialog, and individuals Ilya Andreevich Gambashidze, Nikolay Aleksandrovich Tupikin and Andrey Naumovich Perla.

The Foreign Office said the Social Design Agency and Structura tried to deliver a series

of "interference operations" designed to weaken international support for Ukraine.

Foreign Secretary David Lammy said: "Putin is so desperate to undermine European support for Ukraine he is now resorting to clumsy, ineffective efforts to try and

stoke unrest.

"Today's sanctions send a clear message; we will not tolerate your lies and interference, and we are coming after you."

Russia has rejected accusations of online interference. Kensington Palace declined to comment.

# Tommy Robinson jailed for contempt of court

■ Far right activist remains unrepentant after breaching injunction with disproved claims about Syrian refugee

**FAR-right activist Tommy Robinson has been jailed for 18 months after admitting contempt of court by repeating false allegations against a Syrian refugee – in breach of an injunction.**

At Woolwich Crown Court this week, the anti-Islam activist, whose real name is Stephen Yaxley-Lennon, admitted 10 breaches of a High Court order made in 2021.

Lawyers for the solicitor general said Robinson was “thumbing his nose” at the law. His barristers said it was his “principles that have brought him before the court”.

Passing sentence, Mr Justice Johnson said the breaches were not “accidental, negligent or merely reckless”. He added: “It was a planned, deliberate, direct, flagrant breach of the court’s orders. Nobody is above the law. Nobody can pick and choose which injunctions they obey and those they do not. It is in the interests of the whole community that injunctions are obeyed.”

Robinson, wearing a grey suit and white shirt, looked up at dozens of supporters in the public gallery before shrugging his shoulders as he was jailed. Some followers

blew kisses when he was led from the dock. He had been barred from repeating false claims about Jamal Hijazi after the then-schoolboy successfully sued him for libel.

The Solicitor General issued the first contempt claim in June, saying Robinson “knowingly” breached the order on four occasions, including by having “published, caused, authorized or procured” the film *Silenced* in May last year.

The programme remains pinned to the top of Robinson’s profile on social media site X, while he also repeated

claims in three interviews between February and June 2023.

The second claim was issued in August concerning six further

breaches, including playing the film to a demo in Trafalgar Square in central London earlier this year.

Mr Justice Johnson

said the 18-month sentence would only be reduced to 14 if Robinson “purges” his contempt, such as by removing the film from his X account.

## First Minister endorses Harris

**Scotland’s First Minister has endorsed Kamala Harris in the US presidential election.**

John Swinney joked that his endorsement is not just because her opponent, Donald Trump, is against Scottish independence.

Speaking to journalists after First Minister’s Questions, the SNP leader said: “People in the United States of America should vote for Kamala Harris and I have not come to

that conclusion only because Donald Trump is opposed to Scottish independence.”

The comment referenced a recent clip of the Republican nominee from a podcast in which he reaffirmed his position on the union.

During the appearance with comedian Andrew Schulz, Mr Trump discussed his heritage in Scotland, the future of the UK and the film *Brave-*

heart.

Pointing to the 2014 independence referendum, he said: “You know, they tried to break up Scotland from the rest of the empire, so to speak.

“It made it by about like a half a point. They kept it together. So I hope it stays together. I hope it always stays together.”

Scotland voted 55% to 45% to remain in the UK.

Mr Trump also spoke about his mother Mary

MacLeod, who was born and raised on the Isle of Lewis before moving to America.

“My mother was great,” he said. “She was a Stornoway. The Hebrides. That’s, you know, that’s really serious Scottish.

“The Scottish people, they’re tough people.

“They’re good people. Actually, they’re very great people. But they’re good fighters.”

Mr Trump also spoke about his love for the blockbuster *Braveheart*, which he said “may be the greatest movie I’ve

ever seen”.

Trump owns several major golf courses in Scotland, including in

Balmedie, near Aberdeen and the Trump Turnberry Hotel and Resort in South Ayrshire.

## Cult members guilty of kidnap plot

**Members of an “anti-establishment cult” who stormed into a court with handcuffs have been found guilty of trying to kidnap a coroner.**

Mark Christopher, 59, Matthew Martin, 47, Shiza Harper, 45, and Sean Harper, 38, wanted to “shut down” Essex Coroner’s Court and abduct senior coroner Lincoln

Brookes in April 2023.

They were part of a “conspiracy theory” group who believed they could overrule the judicial system in England and Wales, a trial heard.

All four have been found guilty at Chelmsford Crown Court of conspiracy to kidnap and conspiracy to commit false imprisonment.

Christopher was also

found guilty of sending a letter or email with intent to cause distress or anxiety.

Martin was cleared of assault by beating and criminal damage by the jury.

The defendants, from Essex and east London, will be sentenced in November, Mr Justice Goss said.

# Ready for AI Parky?

■ TV legend returns (sort of) in AI podcast format, which his son describes as “paying tribute to his legacy”

The son of the late Sir Michael Parkinson, Michael “Mike” Parkinson Jr, has clarified that a new podcast using artificial intelligence (AI) to emulate his father’s voice is not an attempt to resurrect him.

Speaking on ITV’s Good Morning Britain, he explained: “Really, what this came from was, was an extension of the work I’ve done with my dad, which essentially is looking after the archive, giving it more life after he’s gone, and also just paying tribute to his legacy.”

He added that his father, who passed away at 88 last year, had always been intrigued by the potential of technology in his field: “He would do live shows and we would write books based on the archive. We

would do documentaries based on the archive. He was fascinated by the art of interviewing.”

Mike shared his father’s wishful thinking about interviewing capabilities: “He basically used to have a conversation with me saying, ‘I wish there was the technology which could bring back people I never had a chance to interview’. He would have loved to have brought back Frank Sinatra.”

“he’s not my dad”

When asked about interacting with the AI as if it were his father, he firmly stated: “He’s not my dad. The thing about it is, he’s not my dad. I mean, I’m not bringing my father back. It’s not some kind of Hamlet’s ghost moment.”

The AI rendition of

Sir Michael’s voice will feature in the upcoming eight-part podcast series, Virtually Parkinson, set to be released later this year. Benjamin Field from Deep Fusion Films, the producers of the project, explained to the programme that they had input over 1,000 hours of Sir Michael’s interviews into the AI. He clarified: “We are not passing it off as Michael Parkinson”.

He further elaborated: “The podcast is not about Michael Parkinson, per se. It’s actually about the exploration of the relationship between AI and humans”. Parkinson Jr had approached the company with the idea of creating a new podcast series using his father’s voice to accompany The Michael Parkinson Channel on YouTube, which hosts

## Brawling Labour MP suspended

■ Mike Amesbury captured on CCTV punching a man to the ground

THE LABOUR Party have suspended MP Mike Amesbury after CCTV footage emerged appearing to show him punching a man to the ground.

He has also had the Labour whip withdrawn, meaning he will now sit as an independent MP in Parliament.

In shocking footage first released by the Daily Mail, the Runcorn and Helsby MP is apparently seen continuing to hit the man as he lies in the street.

Cheshire Police said a 55-year-old man had been voluntarily interviewed under caution in relation to the incident and had since been released pending further enquiries.

Amesbury has de-

clined to comment.

It comes after a different video, posted on X, purported to show Amesbury shouting and swearing at the man lying in the street in Frodsham, Cheshire.

A Labour Party spokesman said: “Mike Amesbury MP has been assisting Cheshire Police with their inquiries following an incident on Friday night.

"As these inquiries are now ongoing, the Labour Party has administratively suspended Mr Amesbury's membership of the Labour Party pending an investigation."

It is not clear what happened in the build-up to the moments caught on film.

In the initial clip, Amesbury can be heard shouting: "You won't threaten the MP ever again, will you?"

In a statement issued before the Daily Mail footage emerged, Cheshire Police said: "At 02:48 BST on Saturday 26 October police were called to reports of an assault in Frodsham."

"A caller reported he had been assaulted by a man in Main Street. Enquiries are ongoing."

Posting on his own Facebook page on Saturday, the 55-year-old backbencher said: "Last night I was involved in an incident that took place after I felt threatened following an evening out with friends."

**"horrendous"**

"This morning I contacted Cheshire Police myself to report what happened."

"I will not be making any further public comment but will of course cooperate with any inquiries if required by Cheshire Police."

Senior minister Pat McFadden said the CCTV footage was "very graphic", but he wanted to "let the police do their job and reach a conclusion before I say anything more".

A spokesperson for Reform UK - whose candidate came second behind Amesbury in July's general election - called for him to resign.

Former Conservative MP Dehenna Davison, whose father died from a single punch, called the CCTV footage "horrendous".

## Masked gang rob home of England cricket captain

### ■ Ben Stokes is latest high-profile sportsman to be victimized at home while playing overseas

England cricket captain Ben Stokes says a masked gang burgled his home - when his wife and two children were there - while he was in Pakistan for the recent Test series.

The 33-year-old said his family did not come to "any physical harm" but a number of "sentimental" items were taken.

Durham police confirmed an investigation is ongoing.

Stokes posted pictures of the missing items, including the medal for the OBE which he received in 2020.

"By far the worst thing about this crime is that it was carried out while my wife and two young children were in the

house," he said.

"Thankfully, none of my family came to any physical harm."

"Understandably, however, the experience has had an impact on their emotional and mental state."

"All we can think about is how much worse this situation could have been."

Stokes, who lives in Castle Eden in County Durham, said the incident occurred on the evening of 17 October.

The following day, England were beaten by Pakistan in the second Test, with Stokes dismissed for 37.

He returned to the UK after the conclusion of last week's third Test, which England lost by

nine wickets as Pakistan took the series 2-1.

"I am releasing photographs of some of the stolen items - which I hope may be easily identified - in the hope that we can find the people who are responsible for this," added Stokes.

"Although we have lost cherished possessions, to be clear, my sole

motivation in sharing these photographs is not the recovery of material items. It is to catch the people who did this."

"They escaped with jewellery, other valuables and a good deal of personal items. Many of those items have real sentimental value for me and my family. They are irreplaceable."

"This is an appeal for

any help in finding these people who carried out this act."

As well as the medal, Stokes posted pictures of three necklaces, a ring and a designer bag.

A number of footballers have had their homes burgled while away playing in recent years, including Raheem Sterling during the 2022 World Cup in Qatar.

## Birthrates drop to record low in England/Wales

Women in England and Wales had an average of 1.44 children between 2022 and 2023, the lowest rate on record.

Only 591,072 babies were born in 2023, fewer than in any year since 1977 and a fall of more than 14,000 on the previous year, figures from the Office for National Statistics showed.

The average age of new mums and dads has increased to 33.8 for fathers and 30.9 for mothers.

Research suggests millennials, born up to the mid-1990s, are not having children because of financial pressures, not feeling ready or having not found the right partner.

While the number of births fell to a record low last year, the number of women of child-bearing age was at its highest ever at 12 million.

This meant the total fertility rate in 2023 was the lowest recorded since 1938.

Greg Ceely, head of

population health monitoring at the ONS, said total fertility rates had been declining since 2010 but was particularly notable in some age groups.

"The decline in fertility rates has been the most dramatic in the 20-24 and 25-29 age groups," he said.

For countries to maintain their populations, the fertility rate needs to be around 2.1 children per woman.

But despite a declining fertility rate in England and Wales since the 1970s, the population has continued to grow, largely because of immigration.

In most countries around the world, fertility rates are falling.

In Scotland, the total fertility rate also fell to 1.3, and the number of babies born was also down to the lowest ever figure of 45,935, according to the National Records of Scotland.

There were 27,374 live

births in Wales in 2023 and 563,561 in England.

**'Cost-of-living pressures'**

A recent study from University College London (UCL) found that only one in four 32-year-olds in England who want children are actively trying to have them.

When researchers looked at the reasons for why, financial and work pressures were often cited

for those born in 1989-90.

UCL's Dr Alina Pelikh said the falling fertility rate highlighted the challenges faced by younger generations.

"While parents will naturally have many reasons for deciding on the timing and spacing of their children, it is likely that current cost-of-living pressures, with rising housing and childcare expenses, are also shaping

the environment in which this group is making fertility decisions."

Katie, 38, from Wolverhampton, said she previously wanted three children, but being a step parent had changed her opinion due to "the stress" of parenthood.

"I'm just happy doing what I'm doing as a child-free woman... not having to be tied to anything," she said.

## Nicked: 22 tonnes of cheese means an awful lot of Cheddar

Man arrested over theft of 22 tonnes of cheese from Neal's Yard Dairy  
Met police arrest man, 63, on suspicion of fraud by false representation and handling stolen goods

Detectives investigating the theft of 22 tonnes of

cheese from Neal's Yard Dairy have arrested a 63-year-old man on suspicion of fraud by false representation and handling stolen goods.

The London cheese specialist delivered 950 wheels of cheddar – reported to be worth up to £300,000 – to

an alleged fraudster posing as a wholesale distributor for a big French retailer.

The cheese is believed to have been spirited away to Russia or the Middle East, according to suppliers to the company who were caught up in the scam on

21 October.

A Metropolitan police spokesperson said the 63-year-old man was arrested and taken to a south London police station where he was questioned.

The spokesperson added: "He has since been bailed pending further inquiries. Inquiries remain ongoing."

Neal's Yard still paid Westcombe Dairy in Somerset, as well as the producers Hafod and Pitchfork, so they would not have to bear the cost of the theft "despite the signifi-

cant financial blow".

The celebrity chef Jamie Oliver was among figures from the food world who rallied around the retailer. He told his 10.5 million Instagram followers to be alert for "lorryloads of posh cheese" being sold "for cheap".

"There has been a great cheese robbery. Some of the best cheddar cheese in the world has been stolen," he wrote.

Oliver described it as a "real shame", adding: "If anyone hears anything about posh cheese going

for cheap, it's probably some wrong'uns."

Tom Calver, the director of Westcombe Dairy in Westcombe, Somerset, produced some of the stolen cheese and said he was "hugely distressed" when he heard the news.

"I was really concerned about what it was and the implications of it. Neal's Yard have been fantastic," he said. "We are just trying to support them as much as possible by encouraging people to shop with them. It is a huge, very difficult loss."

Giving evidence during the eight-day trial, Mr Brookes said the plot left him "fearful for the safety of my family".

Det Ch Insp Nathan Hutchinson said it had been an "intimidating and traumatising ordeal" for all involved.

"The ideologies of this group were concerning and they genuinely believed that they had the power to construct their own legal system, threaten others and were above English law," he said.

The defendants were part of an online subscription-based movement called the Federal Postal Court, which had self-conferred legal pow-

ers, the trial heard.

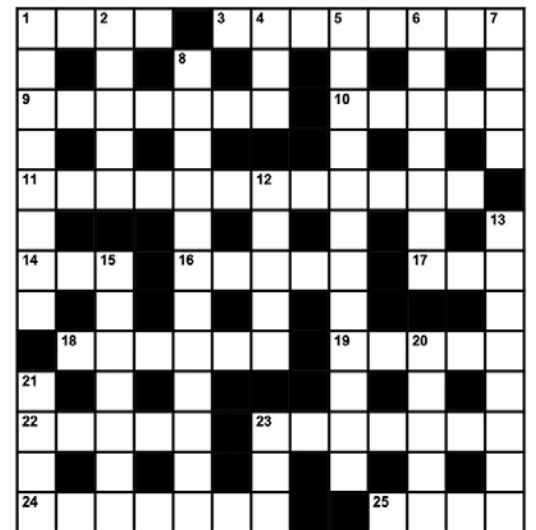
Christopher, from Forest Gate, east London, was the chief judge, with Martin and Sean Harper his sheriffs and Shiza Harper a "postal inspector".

Mr Walker said they had a "significant following" online and described the group as an "anti-establishment protest, cult or conspiracy theory".

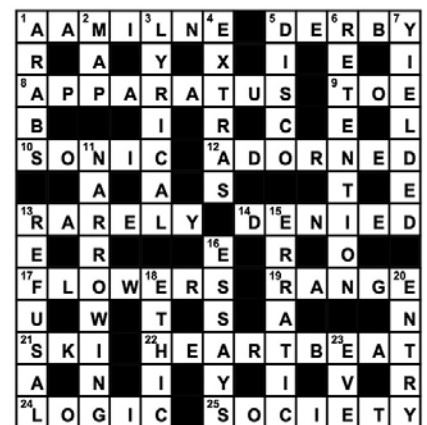

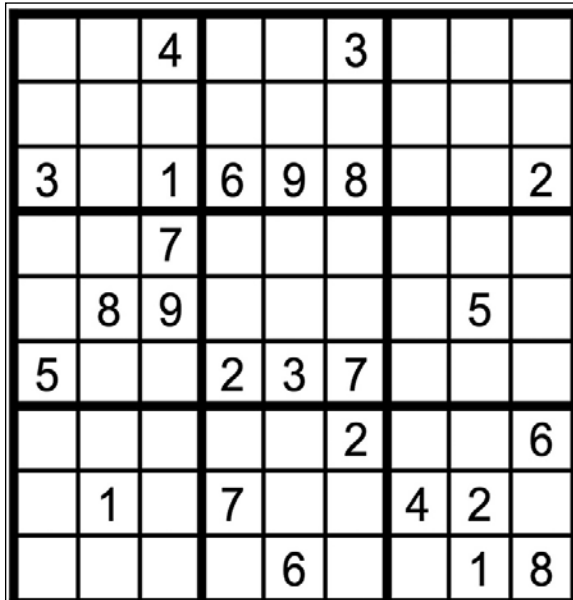

# Braving the Meseta

TEN WEEKS ON THE CAMINO: Nick Stark trudges through the breadbasket of Spain...and finds it quite to his taste

**Burgos to Hontanas (18.6m)**  
It was some regret that we left the wonderful town of Burgos.

Not only were we leaving a fascinating foodie destination, we were also embarking on what many pilgrims consider the most testing section of the Camino Frances: the Meseta. This great interior plain the breadbasket of Spain and stretches about 125 miles from Burgos to Astorga. The terrain is known for its rolling fields of wheat stretching as far as the eye can see, with wide skies and dry, relentless heat in summer and cruel, bitter cold in winter. For long stretches there are no trees, no fountains and no shade. Only the small hamlets along the route with services provide extra life to this long walk.

Those extremes cause many pilgrims to skip this section entirely, but we were walking in early October, and found it temperate but still testing, because its unrelenting nature gets under your skin, forcing you to test your mind, confront your heart, and make you wonder a little bit about your connection to this world.

Conventional pilgrim wisdom suggests it is here that you will finally start to look within and contemplate your choices in life, both those behind you and those ahead. You can block out those voices of course, by replacing them with podcasts, music or books on tape, but I was determined to resist that, and found the contemplative nature of plodding across the Meseta, one step at a time, one village at a time, one day at a time, intensely cleansing and clarifying.

The first day's destination was Hontanas, a charming medieval village a distant 18.6 miles away. We were very footsore when we arrived at

the **Albergue Brigida**, an airy and thoroughly modernized country farmhouse built of stone and huge local timbers. Our mood improved as we shared a Pilgrim's Dinner with 26 others, helping ourselves from a table-sized pan of seafood paella with carafes of wine and unlimited bread and salad for 14 euros. We swapped stories with others from around the world before stumbling into bed for an early night.

**Hontanas to Boadilla (17.7m)**

From Hontanas it was only a slightly less daunting distance to Boadilla, where the modern albergue seemed to be the only real center of life in the village. For 63 euros we had a roomy, light filled room and again shared a dinner with perhaps 30 other people, one of whom was a trainee opera singer who enchanted us all with a chorus of the famed aria *O Mio Babbino Caro* as dinner was served. The place seemed to be run by

two staff members only, Eduardo and Sergio, who managed to serve drinks from the bar, check in the newcomers, cook, serve and clean up after both dinner and breakfast and clean the rooms during the day. They did all this with constant smiles and good humor, and their dedication to helping pilgrims was far from unique. We found, almost without exception, all the *hospitaleros* on our journey to be equally dedicated.

**Boadilla to Carrion de los Condes (15.2m)**

After Boadilla the rains of autumn returned, and we had a thoroughly cold and soggy all-day trudge of 15 miles to Carrion de Los Condes, where we stayed at the more upmarket Hotel San Zoilo, which was attached to a monastery of the same name and boasted beautiful cloisters and Gothic arches adjacent to the rooms. It was full of beautiful spaces to pause and reflect...and digest the hefty traditional dinner

served in the hotel's excellent restaurant.

**Carrion de los Condes to Ledigos (14.4m)**

From Carrion it was more rain and wind en route to **Albergue La Morena** in Ledigos. Again, this was a tiny village in the middle of the plain with no obvious life to speak of outside of the Albergue, apart from one tiny bar and tienda (market) to pick up a few necessities.

By now we were starting to see the same faces from our previous days: Johannes, a friendly and lanky young German with

a rainbow flag attached to his backpack who looked like a young Christian Eriksen, and Jochen, a short, middle aged native of Hamburg who always sported three days stubble and had either a glass of wine or caña (draft beer in his hand). Then there was Dave and Ellie, originally from Hertfordshire but now British expats living Down Under in Sydney, and best of all, Kevin from Derbyshire, 72-year old solo traveler who had a smile for everyone and who always would greet me with an 'Ey up me duck' whenever we ran

across him...which was usually in a bar.

These folks became what known as our Camino family, and most of them we saw, again and again, all the way to the finish line in Santiago. As any pilgrim will tell you, it's the people you meet and the stories you hear that really are the best part of anybody's Camino.

**Ledigos to Sahagun (10m)**

More wide open skies, more rain and more wind greeted us for a completely forgettable trudge to Sahagun as the province

Castille Y Leon turned into Leon proper. The only highlight would be the almost deserted village of Terradillos de los Templarios, which once housed a large detachment of Templars, one of the most famous Christian military orders, whose original purpose was to protect the lives of Christians on pilgrimage to Jerusalem following its conquest. As guardians of the holy places, the Templars also extended this role to protecting the Camino de Santiago from this location in the 12th century.

Sahagun itself is an unremarkable town, but we enjoyed one of our best meals there at the traditional Los Arcos restaurant, where their Parrilada Sampler (kind of a mixed grill) offered a groaning tray of spicy chorizo sausages, beef sirloin, tenderloin and prime rib as well as the ubiquitous loma (pork loin). The menu advertised it as serving two, but four people would have been sated too by a rather obscene amount of food.

Thanks goodness for another long walk tomorrow!

The goal sparked the game into life and goalkeeper Vitezslav Jaros, making his full debut for the Reds, made a brilliant one-handed save moments later to keep out Simon Adingra's header.

Evan Ferguson then

fired over the bar but Liverpool had a golden chance to add a second when the visitors broke three on one, but Gakpo unselfishly decided to pass to Dominik Szoboszlai and his effort was blocked by the recovering Brighton defence.

However, Gakpo was not to be denied his second when a mistake by Tariq Lamptey allowed him to run unchallenged into the box and fire home.

Brighton pushed in the closing stages and got a goal back when a Liverpool defensive mistake was pounced upon and Adingra prodded in to halve the deficit.

That roused the home fans but Luis Diaz made sure of Liverpool's prog-

ress when he squeezed in an 81st-minute third, despite a late deflected finish by Lamptey.

Reacting to the win, Reds boss Arne Slot was full of praise for his striker: "Cody [Gakpo] has been, in my opinion, a good player for Liverpool for a long time now.

"He continues to bring that and that's a good thing. For me, he is a regular starter. He's not started every game but he's started on a regular basis and he's in tough competition with Luis Diaz who, when he went to the left [wing], also scored a goal.

"That's normal if you play at a club like Liverpool, you've got two quality players for many positions. But, for me,
