BRITISH STARS BID FAREWELL TO LIAM

■ Tragic 1D star laid to rest in Buckinghamshire

THE STARS came out in force on Wednesday as former members of One Direction joined showbiz royalty at the funeral of bandmate Liam Payne.

Harry Styles, Zayn Malik, Niall Horan and Louis Tomlinson joined friends and family at the service for 31-year-old Payne, who died after falling from a hotel balcony in Buenos Aires last month.

Cheryl Tweedy, James Corden and Simon Cowell were also on hand as a horse-drawn carriage carried the coffin to St. Mary's Church in Amersham, 25 miles northwest of London. Undertakers carried the dark blue casket with silver handles, topped with white roses, into the 800-year-old church for the private service.

The funeral location was not made public in advance to prevent a large crowd from gathering, though dozens of local people and fans still gathered nearby.

"Growing up, I was a massive fan of One Direction, so I almost felt like a little piece of the child in me was gone," said 20-year-old Tara Lloyd,

who works at the nearby Amersham Hospital.

The crowd fell silent when Payne's parents, Geoff and Karen, emerged from a car to stand beside the carriage, which was topped with floral tributes reading "Son" and "Daddy." Payne had a 7-year-old son, Bear, with singer Tweedy, who was formerly married to Arsenal and England football star Ashley Cole. Among the other mourners were Payne's girlfriend Kate Cassidy and former soccer player Robbie Keane.

After the service, Cowell could be seen in floods of tears as he embraced Payne's parents outside the church, before the late singer's coffin was driven away in a black hearse.

One Direction formed in 2010 after the five teenagers auditioned for "The X-Factor" as solo acts and were brought together by Cowell, a judge on the show. With their loyal

fan base of "Directioners" they became one of the most successful boy bands of all time.

After the group split in 2016, Payne embarked on a solo career which failed to match the success of One Direction. He was also open about struggling with his mental health and alcohol amid the pressures of fame.

Prosecutors in Argentina said that Payne had traces of alcohol, cocaine

and a prescription antidepressant in his system when he fell to his death from the third-floor balcony of his room at the Casa Sur Hotel in the Argentine

capital on Oct. 16. They have charged three people over his death.

Ukraine strikes Russia with UK-made missiles

■ As Biden ups the ante, airfields and key logistics hubs deep inside Russia have come within Ukraine's range

Ukraine has used longer-range **UK-made** Storm Shadow missiles against targets inside Russia for the first time. it was confirmed this week.

The move follows US President Joe Biden giving Ukraine the green light to use Atacms missiles supplied by Washington to strike inside Russia, prompting a furious response from the Kremlin.

Ukraine had been using both missiles for months, but only against targets in territory occupied by Russia.

Storm Shadow is an Anglo-French cruise missile with a maximum range of around 250km (155 miles). The French call it Scalp.

It is launched from an aircraft, then flies at close to the speed of sound, hugging the terrain, before dropping down and detonating its high explosive warhead.

Štorm Shadow - made by manufacturer MBDA - is considered an ideal weapon for penetrating hardened bunkers and ammunition stores, such as those used by

Russia in its war against Ukraine.

The UK has supplied Storm Shadow missiles to Ukraine for months but, like the US, had not allowed Kyiv to use them to strike inside Russia.

major assault

But this changed after the Biden administration updated its rules, allowing comparable Atacms missiles to be used outside of Ukraine's bor-

On Wednesday, it was confirmed Ukraine used UK-supplied Storm Shadow missiles against targets inside Russia for the first time.

The Ministry of Defence has not yet publicly commented. But the UK government was known to have been supportive of allowing Ukraine more freedom to use missiles as it saw fit, although it had followed US policy.

Ukraine hopes the use of longer-range missiles inside Russia will help it defend the small chunk of Russian territory it currently occupies in the Kursk region. A major assault by Russian and Northern Korean troops is expected.

But Ukrainian cities and front lines are also under daily bombardment from Russia.

Many of the missiles and glide bombs that wreak devastation on military positions, blocks of flats and hospitals are launched by Russian aircraft far within Russia itself.

Kyiv has said that not being allowed to hit the bases these attacks were launched from was akin to making it fight this war with one arm tied behind its back.

With the green light to use Storm Shadow and Atacms missiles, airfields and key logistics hubs deep inside Russia have come within Ukraine's range.

Russian air defence forces have shot down two British Storm Shadow cruise missiles, Russia's Defence Ministry said on Thursday in its daily report on events over the past 24 hours.

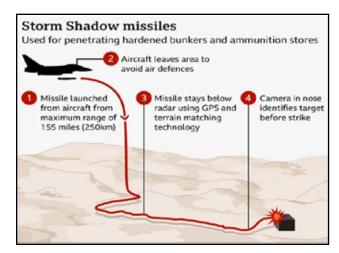

Tributes flow for John Prescott

Tributes have been paid to Lord John Prescott, a major figure in Labour politics and the former deputy prime minister, following his death at the age of 86.

Known for his blunt, no-nonsense style, Lord Prescott was Sir Tony Blair's loyal deputy for 10 years after Labour's 1997 general election landslide.

Sir Tony said he was

"devastated" by the death of his friend, telling the BBC there was "no one quite like him in British politics".

His successor Gordon Brown called Lord Prescott a "working class hero", while Prime Minister Sir Keir Starmer hailed a "true giant" of the Labour movement.

The King praised his "decades of public service" and recalled

"with great fondness his unique and indomitable character, as well as his infectious sense of humour".

'enormous help'

In a statement announcing his death, Lord Prescott's wife and two sons said he had been in a care home recently living with Alzheimer's.

Morecambe memorabilia coming under the hammer

A never-before-seen collection of treasures belonging to comedy legend Eric Morecambe is to be sold at auction.

A lifetime of showbiz memorabilia and personal items from the comedian's former home, Brachefield in Harpenden, Hertfordshire, will go up for sale after his widow, Joan, died aged 97, in March.

The collection includes telegrams from the late Prince Philip and letters from Margaret Thatcher and fellow comics Ronnie Barker and Tommy Coo-

Morecambe's daughter Gail Stuart, who lives in Northamptonshire, said it had been an "interesting year" for herself and her siblings with a "real sense of it being the end of an era".

Morecambe met comedy partner Ernie Wise in 1940 aged 14 and despite a wartime separation formed an enduring double-act.

They had many lean years touring theatres before they broke into TV and by 1977 their Christmas special was watched by 28 million viewers.

More than 40 years after Morecambe's death in 1984, Hansons Auctioneers in Derbyshire will offer his belongings via 700 lots in January.

Morecambe's three children, Gail, Gary and Steven will give fans of the comedy star the opportunity to own some of his belongings.

Items include his glasses, the piano he practised on, a painting of the star by royal portrait artist Richard Stone, annotated joke books and piles of sketch ideas

Gary Morecambe, 58, an author from London, said the family were "genuinely excited" about the auction of their parents' lifelong possessions.

He said seeing the memorabilia go to new homes marked a definitive end of a wonderful era that "for Gail and I at least, began in the 1950s".

"I think what makes it such a unique occasion, and such a momentous time in our lives, is that our mother barely touched anything in the house after our father's

'great comedian'

'Hence we have had everything quite literally under the same roof for 56 years.

"When thinking about my father, it's always easy to contemplate the great comedian he unquestionably was to the detriment of the other side of his life - the home-loving man, who had a serious passion for the natural world."

Ms Stuart, 71, added that while growing up she had no idea her childhood was blessed with the material surroundings and "special individuals...our parents".

"We grew up sharing Dad with the British people, the amazing fans. It wasn't until Dad died that I realized the affection for Dad and for Morecambe and Wise ran so deep."

The collection will be offered on 10 and 11 January, with the catalogue due to go live on 1 December.

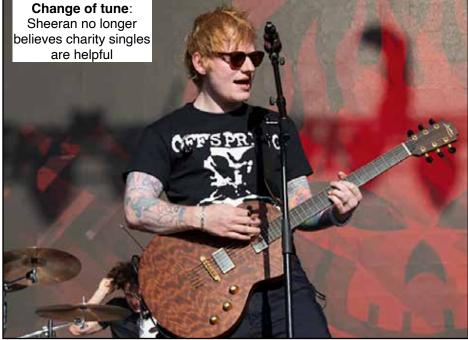
Sheeran keen to rip off the Band-Aid

A decade ago, Ed Sheeran joined the British and Irish supergroup Band Aid to cover the charity single "Do They Know Christmas?".... but now he wishes he hadn't.

The 2014 iteration of the song - which originally premiered in 1989 and was updated in 2004 - also featured One Direction and Sam Smith, among others. Last week, these same names appeared when Band Aid announced the lineup for the 2024 version. But now, Sheeran claims he was never contacted to extend permission to use his vocals on the recording - and even if he had been, he would have

"My approval wasn't sought on this new Band Aid 40 release. Had I had the choice I would have respectfully declined the use of my vocals," the musician wrote on an Instagram Story.

Helmed by Bob Geldof and Midge Ure, the 2014 Band Aid 30 was updated to reference the Ebola epidemic in West Afri-Sheeran has



come to see the song in a different light, sharing: "A decade on and my understanding of the narrative associated with this has changed ... This is just my personal stance, I'm hoping it's a forward-looking one. Love to all x."

Sheeran referenced a lengthy Instagram Story post from Fuse ODG, a well-known singer, songwriter and rapper, who criticized the Band Aid initiative as being harmful to Africa. The

Ghanian-English musician, who revealed that he turned down the offer to participate in the 2014 recording, wrote: "While they may generate sympathy and donations, they perpetuate damaging stereotypes that stifle Africa's economic growth, tourism, and investment, ultimately costing the continent trillions and destroying its dignity, pride and identity."

He added: "By showdehumanizing casing imagery, these initiatives fuel pity rather than partnership, discouraging meaningful engagement. My mission has been to reclaim the narrative, empowering Africans to tell their own stories, redefine their identity and position Africa as a thriving hub for investment and tourism. Today, the diaspora drives the largest funds back into the continent, not Band Aid or foreign aid providing that Africa's solutions and progress lies in its own hands."

Man, 92, charged with woman's 1967 rape and murder

A 92-year-old man has been charged with the rape and murder of an elderly woman in a case that has remained cold for nearly six decades.

Louisa Dunne, 75, was found strangled on her living room floor by a neighbour on Brittania Road in Easton, Bristol, on 28 June 1967.

Ryland Headley, of Clarence Road, Ipswich, appeared before magistrates via video link and was remanded into custody ahead of an appearance at Bristol Crown Court on Thursday.

Avon and Somerset Police said the charge comes after they began reviewing the case in 2023, prompting further forensic examination of some items.

Mr Headley, who was accompanied by his solicitor, was not asked to enter pleas on the two charges against him.

He spoke only to confirm his name, date of birth and address.

DI Dave Marchant said: "This development marks a hugely significant moment in this investigation.

"Now criminal proceedings are under way it's important to stress the defendant has the right to a fair trial."

He added: "Any speculation or misinformation on the circumstances of this case has the potential to prejudice these ongoing proceedings

"We've updated Louisa's family about this charging decision and a specialist liaison officer will continue to support them in the coming days, weeks and months."

Scope of Al Fayed abuse could be 'on the scale of Savile'

■ Former Harrods tycoon's "tentacles went far and wide", says survivors' advocate

The scale of Mohamed Al Fayed's sexual abuse could be similar to that of Jimmy Savile's, Harrods' newly appointed survivors' advocate said this week.

There has been a torrent of allegations against the late billionaire businessman since a BBC documentary in September broadcast the claims of 20 women.

Speaking about her appointment earlier this month, Dame Jasvinder Sanghera said she had been contacted by a former pupil from a school for deaf children.

Al Fayed "had access to vulnerable young women from that school", she said, adding that testimony she had heard suggested that Al Fayed's "tentacles went far and wide".

The school told the

BBC that as far as it was aware Al Fayed did not have access to the school, and that it takes safeguarding very seriously.

"We could be talking about something on the scale of Jimmy Savile," Dame Jasvinder told BBC Radio 4's World at One programme.

'power and influence'

"What we do know is that there are many people - and survivors have said this to me already that were complicit [in Al Fayed's abuse].

"They looked the other way. This could not have happened without people knowing about it, and he used his position of power and influence."

Savile was one of Britain's most notorious and prolific sex offenders. He was a TV presenter and DJ who, until his death in

2011, used his prominent status to rape and sexually assault hundreds of people.

In 2012, the Metropolitan Police said they believed there were 450 victims of Savile's abuse. He often used philanthropic work as a cover for his crimes.

Dame Jasvinder added that there are currently about 290 women engaged in Harrods' compensation process for former employees who say they had been abused by Al Fayed, and that she had written a personal letter to each of them.

Separately, more than

70 women have contacted the BBC since the documentary was broadcast, with accounts of abuse by Al Fayed, including sexual harassment, sexual assault and rape.

But Dame Jasvinder believes there are others who have not yet come forward.

Farm on Windsor estate burgled, police reveal

Burglars broke into a farm on the estate surrounding Windsor Castle last month and stole two vehicles, Thames Valley Police has said.

The break-in, first reported in the Sun newspaper, was at a farm on the Windsor estate which also includes residences of the Royal Family.

The Prince and Princess of Wales were reported to be at their house on the estate during the night-time burglary, but Kensington Palace has not commented. A pick-up truck and quad bike were stolen from the farm and no arrests have been made so far, according to the police.

King Charles and Queen Camilla were not at Windsor Castle when the farm raid took place.

Prince William and Catherine live with their three children in Adelaide Cottage, not far from Windsor Castle.

Senior royals have their own police protection and there is no suggestion of any direct danger from

Royal Lodge, another residence in Windsor, occupied by the Duke of York, has its own security arrangements - said to cost several million pounds per year.

The burglary took place at around 23:45 on Sunday 13 October, and was reported to have involved scaling a six-foot perimeter fence and escaping by breaking through a gate with a stolen vehicle.

"Offenders entered a

farm building and made off with a black Isuzu pick-up and a red quad bike. They then made off towards the Old Windsor/Datchet area," said the statement from Thames Valley police.

"No arrests have been made at this stage and an investigation is ongoing."

There have been previous security incidents at Windsor. On Christmas Day in 2021 an intruder was arrested in the grounds of Windsor Cas-

Jaswant Singh Chail, who had been armed with a crossbow, was lat-

er jailed for nine years.
The 15,800-acre Windsor estate, west of London, includes working farms, conservation areas, Windsor Great Park and famous royal landmarks, such as Windsor Castle.

Last year Windsor Castle was the UK's most popular royal tourist attraction, with 1.4 million visitors.

"surrounded by the love of his family and the jazz music of Marian Montgomery". Sir Tony said the pair would talk via videocall in recent times, and Lord Prescott was "still as lively and punchy as ever".

The former prime minister said Lord Prescott reached parts of the electorate that he could not, and was "loyal, committed and an enormous help" as his deputy.

However, he said their relationship was not just political and they developed a "genuine admiration, respect and affection for each other".

Brown described

him as a "colossus" and "a titan of the Labour movement".

Lord Prescott played an invaluable role as peacemaker between Brown and Sir Tony, often being described as their "marriage counsellor".

'truly a one-off'

Paying tribute in the House of Commons, Sir Keir said Lord Prescott was "a man who fought for working-class ambition because he lived it", adding: "He truly was a one-off."

Deputy Prime Minister Angela Rayner - who shares a working class and trade union background with Lord Prescott - said he was "not only a Labour legend but an inspiration to me"

She said he had been "a huge support", offering the advice to "be authentically yourself and keep thinking about the people you're there to represent".

Lord Mandelson, a key architect of New Labour, hailed him as an "all time great" of the party.

The former cabinet minister, who at times clashed with Lord Prescott in government, said he was "the anchor of New Labour" and "the glue that kept us together".

He told the BBC Lord Prescott was a "fighter for working people" and wanted them "to have all the opportunities that he'd had", which made him "an essential part of New Labour".

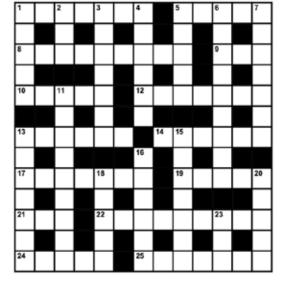

Uphill in the rain: the Camino is often a slog

TEN WEEKS ON THE CAMINO: Nick Stark suffers a little as he savors the last quiet leg of his quest before the hordes of Sarria

The long walk from the French border near Biarritz to the northwestern Spanish town of Santiago de Compostela is a stretch of about 480 miles, marked by three distinct geographical regions.

After toiling over the Pyrenees on day one you descend towards the green hills of Navarra, marked by forests, streams, rolling farmland, fields of sunflowers and increasingly (as you enter Castille and Leon), vineyards.

After about 100 miles you start on the long flat plateau of the Meseta, which stretches a further 215 miles, with Logroño at the eastern end and Astorga to the west.

For the final 165-odd miles you pass through the wine region of El Bierzo and cross into Galicia. At the junction of the two is a cluster of smallish mountain ranges including the Montes de Leon and the O Courel and Os Ancares ranges. This is an area of outstanding natural beauty with several popular nature reserves and biospheres benefitting from the wetter and cloudier weather, due both to higher elevations and proximity to the Atlantic, with various weather systems coming off the Bay of Biscay. For the peregino (pilgrim), this means gorgeous but arduous uphill hikes through forested uplands. And rain. Lots and lots of rain.

But after you negotiate two demanding uphill sections you descend into the town of Sarria and are rewarded with an easy final 75 miles into Santiago de Compostela.

dreaded touregrinos

But perhaps rewarded is not the right word. The vast majority of pilgrims carry with them the credencial, a type of passport in which you collect stamps from your travels and upon presentation of which at the Pilgrims office in Santiago you will receive a Compostela, a

certificate (in Latin, no only have to walk the fi-

less) that you have completed your Camino. But in order to receive this you nal 100km of the Camino, which typically means starting from Sarria. The fact is that most folks can't take six weeks to walk the whole thing and have a week or perhaps ten days to 'do' a Camino, meaning that fully 75% of those who complete their Camino only do 100km, descending on Sarria en masse. The town and the road quickly becomes jammed with schoolchildren, religious groups, sullen German teenagers playing rap music and surburban moms from Ohio sporting inappropriately snug-fitting athleisure wear, all of them full of high spirits, shrieking with laughter and, it seems, possessed of a lamentable absence of spatial awareness for the rest of us, blocking the nar-

selfie for Instagram.

In some circles these newcomers are called 'touregrinos', a hybrid of the Spanish word for tourist and pilgrim. It is not a compliment. But the Camino does teach patience. And acceptance. And though the change in the hike's vibe at Sarria was jarring, the reality is that everyone does their own Camino, and we have to accept that. Even us old lags. Still, it was hard not to look back wistfully at the long stretches behind us with endless paths stretching infinitely into lonely skies with barely another pelegrino in sight from one village to the next.

All that was ahead of us as we left Molinaseca

and headed towards Villafranca 22 miles down the road. As the town petered out and the tarmac gave way to dirt roads we clambered slowly up through forests of chestnut and oak before reaching town, an unremarkable spot whose main attractions were the impressive Iglesia de San Francisco which dominates town's approach and the restaurant Meson Don Nacho, a classic place right out General Franco's era, where we were the only non-locals tucking into some very traditional dishes including pimientos asados del Bierzo (Bierzo-style roasted peppers), steamed white asparagus, Caldo Gallego (a very popular Galician soup) and Fabiada Asturiana (Asturian style red beans stewed with chorizo, blood sausage and bacon).

endless downpours

Suitably fortified by such belly-filling treats, we headed out in steady rain the following day for a 12-mile slow uphill trek to Las Herrerias, the last village before a steep incline into the Os Ancares mountains. We stayed at the Paraiso del Bierzo lodge, which, as my daughter might say, was giving a total golf club vibe, full of oak beams and wrought iron and quiet affluence as it sat at the entrance to the village, perched above a grassy field full of local Galician cattle.

The conditions only worsened the following day. We had 18 miles ahead of us with steady rain turning to an endless downpour and thick fog as we plodded up to the charming mountain hamlet of O Cebreiro and the last real peak of our Camino. Locals here offer horseback rides to the summit, which for us walkers meant that in addition to negotiating rivulets of rain runoff on the already slippery slate and clay path, we also had horse manure to negotiate. We had both donned our hikers' ponchos which fit neatly over our backbacks but had the drawback of turning into a sail if the wind caught you

just right...which it did, repeatedly, almost knocking us off our feet more times than I can remember.

O Cebreiro is considered a highlight for many pilgrims and we were sorely tempted by the blackboard promises of hot soup and pulpo a feira (boiled octopus) outside several restaurants and albergues, but we had to press on, so we settled for a quick and warming cafe con leche before pressing on over the nearby peak. It was only 4500ft, but given the difficulty of the terrain and conditions, it felt much higher.

manure everywhere

As readers of this series will know, the downhill sections are far tougher on the knees, ankles and connective tissue than the uphill climbs, and the trail brought forth from us all sorts of oohs, aahs and more colorful Anglo-Saxon language as we descended towards Triacastela. As afternoon wore towards dusk the rain finally abated, but as we neared our albergue we had to deal with two large herds of cows being led towards their stables for the night. Yes, we really were walking till the cows came home. Like most of their breed, Galician cows are docile and agreeable animals, but they do like to take a certain side of the lane, the side which is flatter and more well-trod. Which for us meant moving to the other side, where

we stood ankle deep in mud, puddles and manure waiting for them to pass. Fortunately I wasn't wearing my Birkenstocks.

The next day was an

easy 11-mile jaunt to Sarria where we booked into an albergue by the river and spent the evening exploring old town. We knew to expect a wave of touregrinos filling the place, but even so, their sheer volume and their demob-happy giddy, mood surprised us. They outnumbered the locals by at least ten to one. We enjoyed a quiet glass of wine before bedtime and looked at each other knowingly. From here on out, the Camino would not be the same.

Postecoglou says he accepts the FA's guilty verdict and that Bentancur will miss a number of matches.

Final flourish brings feelgood factor back for the Scots

SCOTLAND's men's team were in bouyant mood this week after two stirring victories in four days banished the misery for their poor recent performances.

A stirring display on Friday in their 1-0 Nations League clash at home to Croatia suggested coach Steve Clarke had finally found the formula to turn his team's fortunes around, and a stunning 2-1 comeback win in Poland cemented mood as they move into 2025 with confidence renewed.

Key to the double victory was the performance of John McGinn, who according to his brother, McGinn used the disappointment of not starting against Croatia to drive him on to deliver an "outstanding" display.

The Aston Villa captain returned from injury last month but was named among the substitutes for Friday's Nations League game at Hampden.

Off the bench, the talismanic midfielder came on to score a late winner before netting the opener in the dramatic victory in Warsaw.

The goals took Mc-Ginn's Scotland tally to 20, meaning he now ranks in the top five scorers in the men's national team's history.

Speaking on to the BBC, McGinn's brother Stephen said: "One of the biggest things that happens to John when he

gets a setback is he comes back stronger than ever.

"I know how disappointed he was not to be starting on Friday night. In football, you don't have any given right to start a game, but it can just light a fire up.

"I think it was his best performance in Poland. I thought he was outstanding. That's the pressure that comes with being super John McGinn, it's nice to see that back."

An ability to bounce back from adversity is one of Steve Clarke's key qualities - and the nation appear to be benefitting from that resilient mentality once again.

The Scots will have to navigate a Nations League relegation playoff in March to ensure

they remain with the big hitters, but a formation shift - coupled with the addition of teenage winger Ben Doak - has refreshed a team many suggested had hit their ceiling.

Kane: Don't count me out yet

England captain Harry Kane says the 2026 Fifa World Cup may not be his last international tournament.

The 31-year-old's future remains uncertain, despite extending his alltime scoring record to 69 goals in 103 appearances for his country when he scored the opener in the 5-0 win against the Republic of Ireland on Sun-

England interim manager Lee Carsley benched Kane for the 3-0 victory in Greece on Thursday, while he was criticized for his performances at Euro 2024

But when asked if the next World Cup, to be held in the United States, Canada and Mexico. would be his last shot at glory with England, the Bayern Munich striker said: "I don't think so.

"I think there's a perception when you get to your 30s that you're coming to an end, but for me I'm performing at the highest level I've ever performed and feel as good as I've ever felt, so it's about taking in the moment. "I don't like to look too far ahead and in my career, I never have,

the [2026] World Cup is going to be exciting.

"In America it will be an incredible occasion and ultimately it's about trying to win that, looking at where you are, where to improve and it will be no different in a couple of years."

Kane was speaking at the unveiling of a statue and a mural of him at the Peter May Sports Centre in east London, where he began playing as a five-year-old for Ridgeway Rovers.

"It's pretty special to be honest," said Kane.

"I played on these pitches as a five-year-old with dreams of playing for England, and I've been lucky enough to achieve that.

"Hopefully the boys and girls will walk past and be inspired by the story of my journey, my life and hard work."

When asked what it would take to get a statue of him at Wembley Stadium, he added: "I think we need to win a major tournament."

England will look to do that under Thomas Tuchel, who will begin his 18-month contract as manager on 1 January after Carsley's temporary spell.

Kane played under Tuchel at Bayern last season and is confident the German can end the Three Lions' trophy drought.

"He's a fantastic coach and a really good guy as well," he said. "I'm excited to work with him again."

New two year deal for Pep

■ City boss will stay at club till at least 2027

Manchester City manager Pep Guardiola says he could not leave the club after suffering four consecutive defeats for the first time in his coaching career

Guardiola has signed a two-year contract with City which will keep him at the club until 2027.

The 53-year-old Spaniard joined City in 2016 and has won 18 trophies, including six Premier League titles.

His contract had been due to expire at the end of the current season, and he signs a new deal on the back of defeats to Tottenham, Brighton, Sporting and Bournemouth.

"I felt I could not leave now. Maybe the four defeats was why," Guardiola told the club's website.

"I think we deserve, after four defeats in a row, to bounce back and try to turn the situation. I think we deserve to be here. I am not arrogant to say, but it's the truth."

Guardiola said he is determined to help City "overcome" their current difficult predicament and reach a level where they "are more stable and more consistent" to scale the heights of the past.

"We have to recover that because right now we don't have it and that's the target we have to do," he added.

It is the first time Guardiola has endured such a streak of losses - excluding penalty shootouts - in his managerial career.

Guardiola also said that being in charge of City "means so much" to him and he has "everything a manager could ever wish

for" at the club.

"This is my ninth season here. We have experienced so many amazing times together. I have a really special feeling for this football club," he said.

"Hopefully now we can add more trophies to the ones we have already won. That will be my focus."

It was reported that Guardiola had agreed a new

contract on Wednesday and the club confirmed the news a day later.

During his time in Manchester, Guardiola has helped City become just **cont. on page 19, col. 6**
