# MPs say yes to assisted dying bill

■ Measure 'will allow terminally ill patients to seek 'death with dignity'

MPs have backed proposals to legalize assisted dying in England and Wales in a historic vote which paves the way for a change in the law.

In Thursday's Commons vote - the first on the issue in nearly a decade - MPs supported a bill which would allow terminally ill adults expected to die within six months to seek help to end their own life by 330 to 275, a majority of 55.

It followed an emotional debate in the chamber, where MPs from both sides shared personal stories which had informed their decisions.

The bill will now face many more months of debate and scrutiny by MPs and peers, who could choose to amend it, with the approval of both Houses of Parliament required before it becomes law.

Supporters gathered outside Parliament wept and hugged each other as the result was announced. Campaign group Dignity in Dying said the vote was a "historic step towards greater choice and protection for dying people".

Dame Esther Rantzen, one of the most high-profile campaigners for assisted dying, said she was "absolutely thrilled".

The broadcaster, who has terminal lung cancer, said any change in the law would probably come too late to affect her personally.

### 'bit overwhelmed'

But she said "future generations will be spared the ordeals we have to suffer at the moment" if the bill becomes law.

Labour MP Kim Leadbeater, who put forward the bill, she was "a bit overwhelmed" following the vote and it meant "a huge amount" to be able to tell campaigners the bill had passed its first parliamentary hurdle.

However, Conservative Danny Kruger, a leading opponent of the bill, said it could be defeated at a later stage if MPs' concerns were not properly addressed.

He said many of his colleagues believed the bill was "very dangerous" and he hoped that if safeguards in the legislation were not strengthened they would choose to vote against it in the future.

MPs were given a free vote, meaning they could make a decision based on their own conscience rather than having to follow a party line.

Prime Minister Sir Keir Starmer and his Conservative predecessor Rishi Sunak voted in favour, while Tory leader Kemi Badenoch voted against.

The PM, who previously supported a change in the law in 2015, did not speak in the debate or reveal how he planned to vote in advance, saying he did not want to influence the decisions of MPs.

### free from coercion

The government has taken a neutral stance on the bill and has said

it will work to ensure it is effective if Parliament backs a change in the law.

The bill will face months of further scrutiny and votes in the Commons and Lords before the proposed changes could become law.

At present, laws throughout the UK prevent people from asking for medical help to die.

But the new Bill proposes giving terminally ill people the right to choose to end their life.

It says that anyone who wants to end their life must:

- Be over 18 and live in England and Wales, and have been registered with a GP for at least 12 months

- Have the mental capacity to make the choice and be deemed to have expressed a clear, settled and informed wish, free from coercion or pressure

- Be expected to die within six months

- Make two separate declarations, witnessed and signed, about their wish to die

- Satisfy two independent doctors that they are eligible - with at least seven days between each assessment

Under the proposals, a High Court judge would have to rule each time a person makes a request to end their life. A patient would then have to wait 14 days after the ruling, allowing them to have a period of reflection.

A doctor would prepare the substance being used to end the patient's life, but the person would take it themselves. The bill does not say which drug would be used.

It would be illegal to use dishonesty, pressure or coerce someone into declaring they want to end their life, with a possible 14-year prison sentence.

# PM blasts Tories as 2023 figures show numbers of migrants close to 1m

■ **Starmer vows Labour will 'turn the page' on immigration but refuses to set a cap on numbers**

Sir Keir Starmer has blasted the Conservatives, accusing them of running an "open border experiment" as he laid out Labour's reaction to the latest migration figures.

The Prime Minister was responding to the latest data, which revealed net migration to the UK hit a record 906,000 in 2023.

The Prime Minister said that Labour will "turn the page" on the issue and announced a deal with Iraq that he claimed will tackle people smuggling upstream "before it reaches our shores."

He said: "I'm pleased to announce today a new security agreement between Iraq and the UK. This is a world first, that will help us smash the people smuggling gangs and secure our borders.

"The Home Secretary has been out in Iraq to seal this deal, and we've also announced funding for Iraqi law enforcement to tackle this problem upstream, way before it reaches our

shores.

"We're also tackling the utter mess we inherited in the Home Office."

Starmer told a press conference: "Time and again the Conservative Party promised they would get the numbers down. Time and again they failed.

## 'off the scale'

"A failure on this scale isn't just bad luck, it isn't a global trend or taking your eye off the ball. No, this is a different order of failure. This happened by design, not accident."

The Office for National Statistics (ONS) originally estimated it was 740,000 but has now revised this figure upwards by 166,000.

It said annual net migration - the difference between those entering and leaving the country - has since fallen to 728,000 in the year to June 2024.

Sir Keir Starmer seized on the figures - which cover a period before Labour took office - to accuse the Tories of "running an open borders

experiment".

He called the increase in net migration in recent years "off the scale".

The PM promised that proposals for new laws to bring immigration down would be published "imminently".

Conservative shadow home secretary Chris Philp said the idea his party pursued an "open borders experiment" in government was "clearly nonsense".

He said Sir Keir had "no credibility" on migration and what he had announced had "almost no substance".

"This is a man who has ruled out having a cap on legal migration, it's a man who cancelled the Rwanda deterrent before it even started. On his watch already small boat crossings are up by 23% compared to last year," he added.

Speaking at a Downing Street press conference, the prime minister said the "shocking" statistics showed the previous government had increased levels of migration "by design, not

accident".

He promised changes to the rules on work visas and skills training to reduce the dependence on foreign workers in some parts of economy.

But he declined to set a target for reducing overall net migration, adding that aiming for "arbitrary" figures had "achieved absolutely nothing" in the past.

Immigration has risen sharply under the points-based system for work visas put in place by the Conservatives af-

ter Brexit.

Boris Johnson's government also allowed students to stay in the UK longer after graduation find a job, and expanded the visa route for workers in the health-care sector.

Rishi Sunak then tightened rules, contributing to the fall this year, including by restricting the ability of international students and care workers to bring family members into the UK, and raised salary thresholds for work visas.

Reform UK leader Nigel Farage called the latest figures "horrendous" and he had had "enough of being lied to" by the Conservatives. The numbers would be "even worse" under Labour, he added.

Separate figures from the Home Office show more than 130,000 people were awaiting an initial decision for their asylum case as of September. The number of those claiming asylum has more than doubled since September 2021.

## 'It's a sleepy little place': disbelief in north Wales after dramatic arrest of American terror suspect

■ **Daniel Andreas San Diego had been a fugitive from the FBI for two decades before he was found in Maenan village**

Maenan, in north Wales, is not a place where very much happens. But earlier this week armed police descended on this tiny settlement, leaving neighbours in "disbelief".

They learned that a man they had sometimes seen near his home on the outskirts of the woods was in fact one of the FBI's most wanted men.

Daniel Andreas San Diego, 46, was arrested on Monday by officers from Britain's National Crime Agency (NCA), supported by North Wales police. Describing him as an "animal rights extremist", the FBI said he is alleged to have been involved in the bombing

of two office buildings in San Francisco in 2003.

San Diego kept very much to himself, his neighbours said, and they knew very little about him. But they did not suspect for a minute that the reason he always stayed close to his remote rural home was because he was allegedly hiding out from the FBI.

"I've never seen him at all," a neighbour said. "He never goes out, the car is always on the drive, it never moves."

## extradition

In Maenan, where only a few hundred people live - the majority of them Welsh speakers - most people only knew that "an American man" had

moved into the house by word-of-mouth. He is believed to have been living under an assumed name. The FBI had offered a reward of up to \$250,000 (£200,000) for information leading directly to his arrest and considered him "armed and dangerous".

The agency said the first alleged bombing was in August 2003, with two explosions an hour apart on the campus of a biotechnology firm. A month later a nutritional products company was bombed.

Now, 21 years later, he is facing extradition, after he was apprehended more than 5,000 miles away, in the settlement

of Maenan, between Conwy and Betws-y-Coed.

San Diego is believed to have been living for around a year or two in a house on the edge of the woods, many twists and turns away from the main road, high up along a steep, barely surfaced country track. He may have been living in Wales for several years. He is believed to have been working – although in what field is not clear.

## remote corner

In Maenan, neighbours said they knew a “single American or Canadian man” had moved into the house which they said looked “well kept” from the outside.

Nobody in this remote corner of rural Wales said they saw or heard armed police swarm the house on Monday. Nor did they really know anything about the man who had been living there.

Others had seen him in the woods but had never spoken to him, or really given him a second thought, until they recognised San Diego’s picture on the news.

“My partner saw him, a bit of a way up there,” said David Hughes, owner of the Maenan Abbey Hotel on the main road. “It’s quite remote, you would never be able to find him, it’s quite a way off the main road.”

His partner had been walking his dog around four weeks ago when he had seen San Diego in the woods, he said, later recognising him from his picture on the news.

“I just feel a bit of disbelief really,” Hughes said. “It’s a sleepy little place, and you don’t expect things like that to happen here.”

“It’s not even a village, it’s a parish,” he added. “There’s 20 different addresses that all share the same postcode.”

# Final chapter for Barbara Taylor Bradford’s fairytale life

■ **Bestselling novelist enjoyed long career as a journalist before her 1979 debut novel, “A Woman of Substance”**

**Barbara Taylor Bradford, a British journalist who became a publishing sensation in her 40s with the saga “A Woman of Substance” and wrote more than a dozen other novels that sold tens of millions of copies, has died. She was 91.**

Bradford died Sunday at her home in New York City, a spokesperson said Monday.

Starting with “A Woman of Substance,” published in 1979, Bradford averaged nearly a book a year as one of the world’s most popular and wealthiest writers, her net worth estimated at more than \$200 million and her fame so high that her image appeared on a postage stamp in 1999. In 2007, Queen Elizabeth II awarded her an OBE.

Her books were published in 40 languages and sold more than 90 million copies around the world.

## Leeds native

With titles like “Breaking the Rules” and “Act of Will,” she specialized in stories of women fighting for love and power in a man’s world. Her favorite among her books was “The Women In His Life,” inspired by her husband’s escape from the Nazis.

Bradford was married for 56 years to German-born film producer Robert Bradford, who died in 2019.

A native of Leeds, West Yorkshire, she was an only child in a working class family who loved books early. As a girl, she had a story published in a local magazine. By age 16, she left school against her parents’ wishes to become a reporter for the Yorkshire Evening Post.

Over the next 30 years, she would work as fashion editor of Woman’s Own Magazine, cover a variety of beats for the

London Evening News and, in the United States, write a syndicated column about interior design.

Although she wrote children’s stories and advice books, novels were her dream. “A Woman of Substance” was a multi-generational chronicle of the travails and triumphs of retail baron Emma Harte, who would be featured in several other Bradford novels. The book has sold more than 30 million copies and was the basis of a 1984 television miniseries starring Jenny Seagrove as a young Emma and Deborah Kerr as Emma late in life.

## ‘powerhouse’

“And if you want to meet the real Emma, meet me,” Bradford told the Telegraph of London in 2009. “Emma had to be tough and ruthless at times: but then so am I. I have to be, as a businesswoman. And I’m a

bloody good businesswoman.”

Seagrove, who became friends with Bradford after starring in the miniseries, described her as a “powerhouse of glamour

and warmth” and a “force of nature” who stayed true to her roots.

“Success never diluted her warmth and humor or her ability to relate to everyone she met, whether

a cleaner or a princess,” Seagrove said. “She never, ever forgot that she was just a girl from Yorkshire that worked hard and made good. RIP dear friend.”

# Bell hater in Birkenhead causes a right old ding-dong

A council has decided to break with a 137-year tradition and limit the chimes of a town's clocktower to once an hour after a single noise complaint from a nearby resident.

The bells of Birkenhead Town Hall now toll on the hour, rather than every 15 minutes, because a man who lives nearby complained they rang too loud and too often.

## 'noise nuisance'

In a statement Wirral Council said the times were changed after its own environmental health officer found the sounds were a "statutory noise nuisance".

But heritage campaigner Philip Barton said many local people cherished the more regular chime and "live their lives by them".

close to Hamilton Square reaches 60m in height (200ft).

A resident who lived nearby complained about the volume and frequency of the quarter-hourly tolling of the bells, prompting a council investigation.

An officer went to their home and measured the noise, finding the chim-

ing to have breached limits capable of being classed as a nuisance.

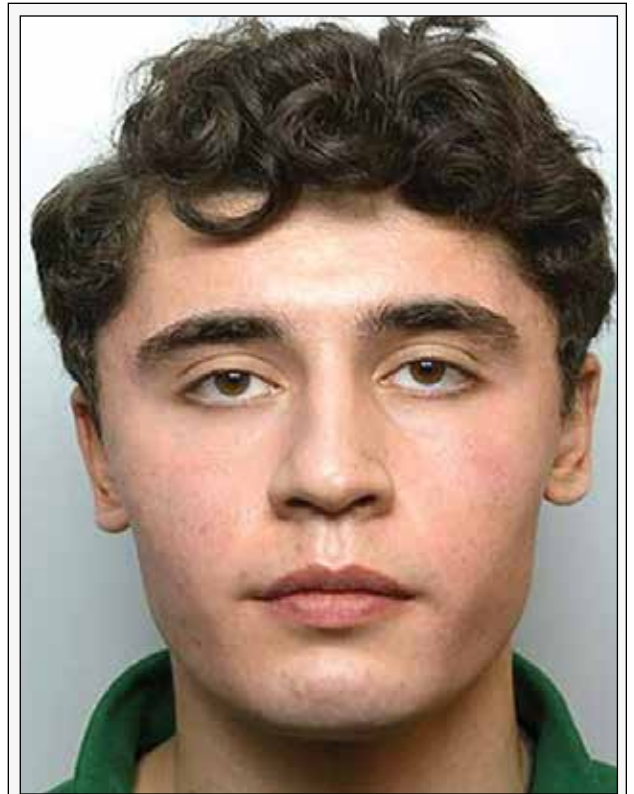
A council spokeswoman said a "compromise" was reached to move to hourly chimes while the authority considered other options.

"We've all got clocks and watches and phones to tell the time, but the chimes are a little bit

more than that", Mr Barton said.

The campaigner said he understood the council had to comply with its own noise rules, but added "as far as I'm aware, it's the first complaint in 137 years".

The Birkenhead resident said it was a "great shame" the bells would not be heard as often.

## "Hapless" British soldier who spied for Iran may face life term

**A BRITISH soldier who escaped jail by clinging to the bottom of a food truck could be put away for life after being found guilty of spying for Iran.**

Daniel Khalife, 23, who has an Iranian mother and Lebanese father, was recruited by the rogue state via Facebook just weeks after joining the Royal Corps of Signals.

Security officials are unsure what information he passed via encrypted app Telegram as the traitor deleted it.

Khalife provoked a nationwide manhunt after escaping HMP Wandsworth – where he was being held on remand for spying – and going on the run for three days in September last year.

On Monday the disgraced soldier was convicted of committing an act prejudicial to the safety or interests of the state and eliciting information about members of the Armed Forces. He was cleared of a bomb hoax.

Justice Bobbie Cheema-Grubb warned Khalife he would face "a long custodial sentence" when he is sentenced early next year.

Jurors rejected Khalife's lies that he had been on a one-man "double agent"

mission after being told his Iranian heritage would stop him getting a role in British intelligence.

Even his lawyer accepted the "hapless" operation bore more resemblance to Scooby-Doo than James Bond. Prime Minister Sir Keir Starmer said he "welcomes the verdict and that justice has been served" but there were serious concerns in Downing Street about how a foreign enemy had recruited a soldier.

The trial heard Khalife played a "cynical game" after contacting a man linked to Iranian intelligence on Facebook weeks after joining the Army aged 16 in September 2018.

Khalife collected sensitive information that posed a real danger and on one occasion was sent to collect £1,500 left in a dog waste bag in a North London park.

The spy got the names of 15 squaddies – including elite soldiers – which are believed to have been passed to Iran. In November 2021 the renegade made an anonymous call to the MI5 public line, confessing to being in contact with Iran for more than two years.

# QUITE A SCORE: Ramsey's 1966 team notes net a bundle

A bundle of papers belonging to the manager of England's 1966 World Cup-winning team found hidden in an old suitcase has sold for £17,064.

Handwritten plans from Sir Alf Ramsey, photographs of former captain Bobby Moore and scouting reports from former Manchester United boss Sir Matt Busby were featured in the lot at Diss Auction Rooms in Norfolk.

The documents were given to Sir Alf's former neighbour and friend, who he lived alongside during his spell as Ipswich Town manager between 1955 and 1963.

Auctioneer Elizabeth Talbot said: "It could have

made less, it could have made a lot more, but how does one value a piece of important history like that?"

While the items were expected to fetch more than £1,000, the auction was

opened with a starting bid of £6,000.

Ms Talbot said she was "blown away" by the amount of interest over the internet and phone.

"We do know there was a lot of interest from vari-

ous museums, academics, football fans and authors. I think it has to have that to make the competition work," she said.

"I'm just pleased it did a lot more than we estimated."

# Claws come out as Jaguar ditch the leaping cat

Luxury car manufacturer Jaguar caused a stir this week by unveiling new logo - a ditching its iconic leaping big cat.

The move comes ahead of its relaunch as an electric-only brand.

The British vehicle maker, owned by India's Tata Motors, will launch three new electric cars in 2026, having taken new cars off sale more than a year ago to focus on reinventing the brand.

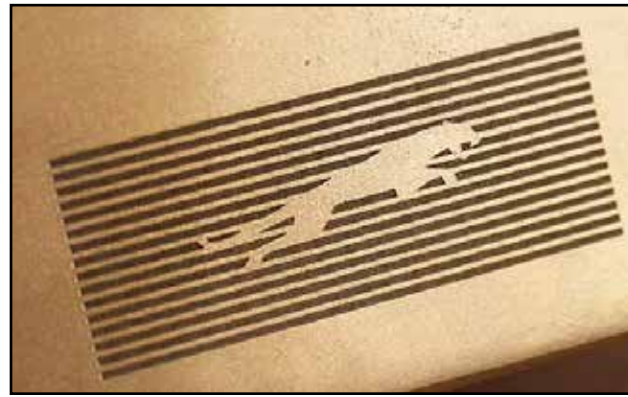
As part of its rebrand, Jaguar revealed a brand new logo on Tuesday, alongside a new prancing "leaper" cat design which will likely feature in their vehicles' interior.

The new bespoke logo, written as JaGUAr, has "seamlessly blended upper and lower case characters in visual harmony", the company said.

Jaguar, which has sites around the country including in Warwickshire, Coventry, Solihull and Castle Bromwich, announced its transition to electric vehicles in 2021.

Managing director Rawdon Glover said taking new cars off sale was "intentional" as it looked to create a barrier between the old models and the new Jaguar vehicles.

"We need to change people's perceptions of what Jaguar stands for,"

he said.

"And that's not a straightforward, easy thing to do. So having a fire break in between old and new is, actually, very helpful."

The new Jaguar brand was "imaginative, bold and artistic" and "unique and fearless," he added. The first car within the new brand would be a four-door GT built in Solihull, West Midlands.

Jaguar's rebrand was controversial and received widespread criticism on social media. Some criticized the removal of the big cat imagery, which has been on the car since the 1950s. Others criticized the font choice and the fact that the content

did not feature any vehicles.

Jaguar's chief creative officer, Sir Gerry McGovern, said the rebrand was built around "exuberant modernism" and was "imaginative, bold and artistic at every touchpoint".

## PC proves kiss of death for mistletoe

**THE POPULARITY of mistletoe at Christmas has nosedived in recent years with Brits in the workplace only too aware it can be a minefield in an era of sexual harassment claims.**

Office workers nervous of kissing under the mistletoe has decimated sales of the festive plant.

Just a quarter of the amount of mistletoe sold in the 90s is likely to be bought at Britain's only annual mistletoe auctions.

Renowned auctioneer Nick "Mr Mistletoe" Champion has lamented that the sprigs, once a fun staple of office Christmas parties, are now rarely

purchased by the young.

Mr Champion, 66, who has been staging mistletoe auctions for 47 years in Tenbury Wells, Worcs, says it is a crying shame as the cold snap will make a bumper quality crop.

It's anticipated that around 500 mistletoe lots will go under the hammer in two auctions in the self-appointed mistletoe capital of Britain in the next fortnight - compared to 2,000 lots in mistletoe's 90s heyday. Mr Champion bemoaned: "We used to have four auctions but young people aren't interested in kissing under the mistletoe anymore."

"Workers used to kiss

under the mistletoe at Christmas parties, but with all the wokery nowadays they would be accused of abuse."

Auctions of mistletoe and holly collected by farmers have been held in Tenbury Wells since 1862. This year sales are on November 26 and December 3.

Mr Champion explained: "Mistletoe needs a frost around now to ripen the berries. The recent cold spell means that it should be a great crop." He said there is much higher demand for holly, which fetches around £5 per kilo against £3 for mistletoe.

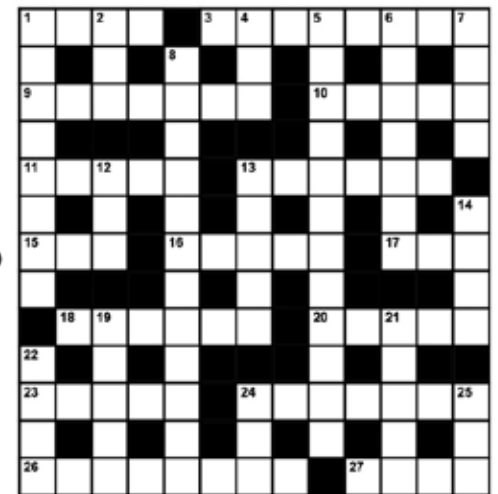

# A bittersweet farewell to the Camino Frances

■ **TEN WEEKS ON THE CAMINO:** After an unforgettable journey, Nick Stark finishes his trek in Santiago...then ponders what it all meant

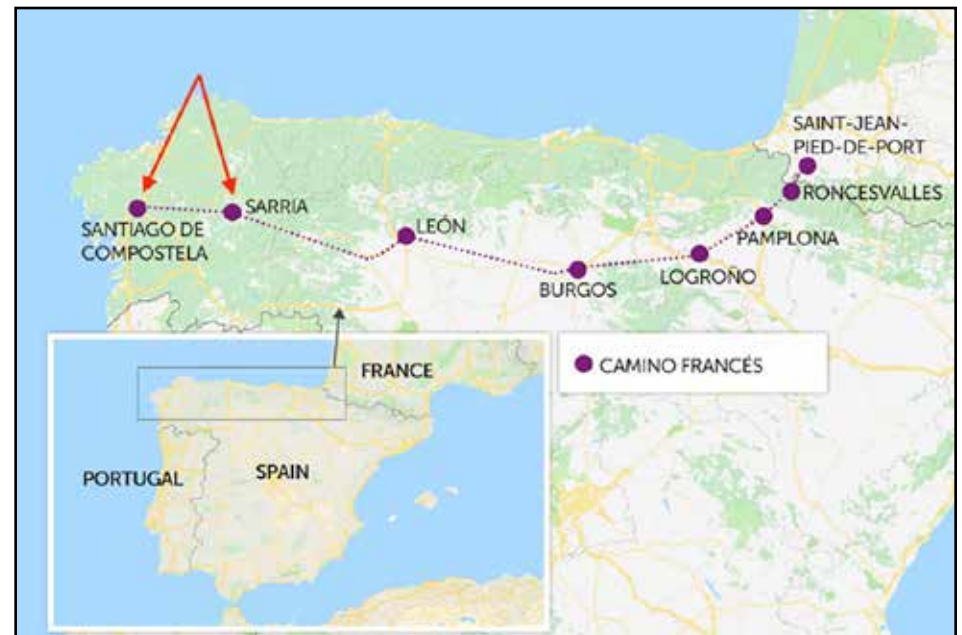
We left Sarria in the pre-dawn darkness and were soon dodging crowds of newly arrived pilgrims whose Camino was just beginning while ours was drawing to an end. Their exuberant mood was in marked contrast to our own, and the overcast

days that followed mirrored the gloom we both felt at reaching the final days of what had been an astounding adventure.

Galicia's position at the foot of the Bay of Biscay makes it one of the wettest areas of Spain, with the resultant land-

scape dotted with misty hills and thick forests of chestnut, coastal oak and eucalyptus. The journey to the small town of Portomarín was uneventful and hardly strenuous, and the town itself, as is almost always the case in Spain, is dominated by a large public square full of outdoor cafes and bars, and the requisite imposing Gothic cathedral.

After an excellent meal of Cantabrian anchovies with blue cheese and truffles at the Osteria Italiano in the main square we headed off to bed, with another pre-dawn start and 16 miles ahead of us to Palas de Rei. There's not much to recommend this charmless town apart from the Pulperia de Nossa Terra, where I enjoyed the best octopus not just of the trip, but which I have ever eaten. The preferred preparation in Galicia is 'a feira' (fair style), wherein the chef boils it and serves with olive oil, salt and pa-

prika. Deceptively simple but the result is a succulent cephalopod which goes down like butter - especially with a bottle of the excellent crisp local white wine Godello.

But if Palas de Rei was dull, it made our next destination look like Las Vegas. Arzua is a further 18 miles down the road and is essentially one long street lined with shops, office buildings and restaurants culminating in a traffic-blighted square.

Our penultimate stop was O Pedrouzo, a far more charming town an-

## But What About Our Bags?



The most common question we've been asked is if we carried everything on our back for each day's hike.

The answer is no. We carried only our valuables - passport, money, mobile phones, ipad, massage gun (yes, this was absolutely essential) hydroflasks and a waterproof poncho. Everything else was sent ahead with Jacotrans, a Spanish company who will pick up your bag (30lb limit) around 8am each morning and transport in their van it to your next stop. You simply text them the night before via Whatsapp and leave 6-8 euros, depending in the region, in an envelope attached to your bag. Most albergues and hotels will have the envelopes at reception. Easy-peasy. ([jacotrans.es](http://jacotrans.es))

We spent several days in Madrid before returning home so we had extra bag of clothes sent from our starting point in St Jean Pied de Port via the French equivalent of Jacotrans, Express Bourricot ([expressbourricot.com](http://expressbourricot.com)), who for 70 euros will take your bag 500 miles across the Camino Frances and store it for up to three months in Santiago. We considered it money very well spent.

We left our pondering for another day. We had a hotel to check into, showers to take and clean clothes to don. We stayed in Santiago for several days more, attending a very moving Pilgrim's Mass at the Cathedral, bumping into friends we had made along the way, and eating and drinking in an effort to regain the

15lbs we had shed along the way. Or perhaps just trying to milk the last few moments of an experience we didn't want to end. We returned to California just in time to vote in the Presidential Election.

For some folk the Camino is a life changing experience, and the road calls back to them, so they return, year after year. We met a pilgrim from Silver Lake with eight caminos under his belt. For some the devotion to the experience is

so strong they buy hotels or albergues on the road and become full time *hospitaleros*. A month on, we are still processing what the Camino meant to us. But its lessons are simple and timeless. 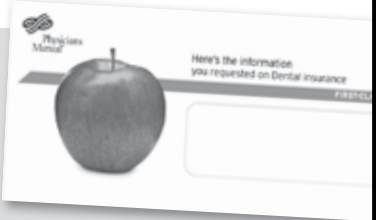

## Honors even for Spurs

Veteran defender Mats Hummels snatched a late equaliser for Claudio Ranieri's Roma to frustrate Tottenham in the Europa League on Thursday.

The 35-year-old Germany international, playing his first European match since the Champions League final in July, gave away a penalty in the fifth minute but made amends in stoppage time, tapping in Angelino's whipped cross to earn a 2-2 draw for the visitors.

Spurs had been the superior side for much of the match after Son Heung-min turned in the penalty that Hummels gave away. He was slow to a loose ball in the box and brought down young midfielder Pape Matar Sarr.

Brennan Johnson also struck a good first-time finish after a Dejan Kulusevski cutback after defender Evan N'Dicka had equalised.

Stephan El Shaarawy also struck an excellent volley which was ruled out by VAR for offside.

But Spurs should have extended their lead further in the first half as Johnson had a shot cleared off the line, Dominic Solanke saw a shot saved, Son blazed over a rebound after the in-form Kulusevski hit the post.

The match felt comfortable for Spurs, who could have built a bigger lead, but a flurry of second half efforts from Roma, including former Manchester City wing-back Angelino hitting a first-time volley onto the bar, were warnings.

Porro and Solanke both went close but Roma had two more goals ruled out for offside calls on Artem Dovbyk and Manu Kone. Spurs are ninth in the Europa League league phase standings, outside of the top eight that avoid a play-off match, with matches against Rangers, Hoffenheim and Elfsborg to come.

# Not so Sporting: Gunners demolish hosts

ARSENAL roared back into form in the Champions League, despatching Sporting 5-1 in Lisbon with a dominating performance.

The Gunners scored five goals in an away match in the club football's most prestigious league for just the third time and the first time since October 2008, a 5-2 win against Fenerbahce.

The north London side were on a five-game winless run away from home in the Champions League (drawing two, losing three) while failing to score in each of the last four but they ended that in emphatic fashion Tuesday night.

Five different players scored for Arsenal in a brilliant performance as Mikel Arteta's side made light work of the team who had beaten Manchester City 4-1 in their previous Champions League match.

The Gunners were 3-0 up at half-time and despite Goncalo Inacio scoring two minutes after the break, they kept their composure and continued to control the match.

Gabriel scored his first goal in the competi-

tion while Bukayo Saka scored and provided an assist and Kai Havertz netted his 100th goal in his club career across all competitions.

Arsenal accumulated an xG of 3.89, their most on record for a match in the competition (since 2013-14), as they moved up to seventh in the Champions League table.

Bukayo Saka told reporters "this is where we belong" after the match and so it proved, with his side comfortable throughout, in what could have been a tricky away fixture, as Gabriel Martinelli, Kai Havertz, Gabriel, Saka and Leandro Trossard all scored.

"We've shown the level we can play at," Saka said. "We know they haven't lost here this season but we believed in ourselves."

"Everyone was top, I'm really proud of all the boys today."

Martinelli tapped home from Jurrien Timber's low cross as Arteta's side went in front early on.

They doubled the lead in similar fashion, Saka getting in behind the Sporting defence and

firing the ball across the box for Havertz to prod in from close range.

Gabriel scored his first Champions League goal on the stroke of half-time, powering in a header from a Declan Rice corner.

Shortly after the break Goncalo Inacio got a goal back for Sporting with a smart left-footed strike but it was a mere consolation for the hosts.

Ousmane Diomande was lucky to avoid a second yellow card when he went straight through the back of Martin Ode-

gaard and conceded a penalty.

Saka scored the resulting spot-kick, whipping it into the bottom corner.

Mikel Merino's fierce strike from the edge of the area was then parried by home goalkeeper Franco Israel into the path of Trossard, who headed into an empty net for Arsenal's fifth.

Martinelli's goal, recorded at six minutes 43 seconds, was Arsenal's fastest in the competition since Theo Walcott netted against Basel in September 2016 (06:42).

The home side's incredible unbeaten run of 17 wins and one draw in all competitions since the start of the season was ended in emphatic fashion by the north London side.

Viktor Gyokeres, who scored a hat-trick against City, was left frustrated as he failed to find a way past the Arsenal defence.

The Swedish striker fired a free-kick over the bar and had a strike from the edge of the area well saved by David Raya when he went through on goal.

## Thrilling first win for Amorim

Manchester United made a winning Old Trafford start under new boss Ruben Amorim as his side came from behind to beat Norwegian team Bodo/Glimt in the Europa League on Thursday.

United scored after just 81 seconds in Amorim's first game in charge at Ipswich, and took them just 48 seconds to find the net this time around.

A catastrophic error from goalkeeper Nikita Haikin, who inexplicably allowed Rasmus Hojlund to close him down as he went to make a routine clear-

ance, gave Alejandro Garnacho a tap-in.

But rather than pave the way for an easy victory, it was the prelude for a period of frustration for the hosts as Bodo/Glimt turned the game on its head with two goals in four minutes to take the lead with just a quarter of the match gone.

Thankfully for United, Hojlund brought a scream of delight from Amorim with an outstanding finish to pull them level before the break.

Hojlund won the game when he turned home Manuel Ugarte's

cross from close range five minutes into the second period.

While Amorim will be pleased with a result that boosts United's chances of a top-eight finish in the Europa League table and automatic qualification for the last 16 in March, he will be frustrated at the number of chances his side wasted to ease their way to victory.

Garnacho bore a lot of responsibility. The Argentine sent one effort across goal when team-mates were in a better position. He then curled a shot over under no pressure after

he had been set up by Amad Diallo.

Substitute Marcus Rashford also drilled a shot wide as United continued to press. But the fourth would

not come, leading to a few nervous moments before the final whistle gave Amorim his first win since leaving Sporting earlier this month.

## Brighton move into second

Brighton and Hove Albion moved second in the Premier League table on Friday night despite failing to win at home to bottom club Southampton.

Kaoru Mitoma capitalised on poor Saints defending to head Brighton in front midway through the first half.

Victory would have taken Brighton six points behind leaders Liverpool, but they were pegged back when Flynn Downes slammed home just before the hour.

Instead they are second, level on points, goal difference and goals scored with Manchester City, but with a better head-to-head record.

Southampton thought they had taken the lead through Cameron Archer shortly after Downes' goal, but it was ruled out for a debatable offside as team-mate Adam Armstrong was ruled to have been interfering with play.

Brighton dominated the opening stages Friday evening, with Southampton nearly caught out on several occasions attempting to play out from the back.

Georginio Rutter was inches away from handing Brighton the lead on 16 minutes, cutting in from the right and striking the post with his left-footed drive.

And they did lead when Tariq Lamptey - making his first league start of an injury-inflicted season - crossed from the right.

Jack Stephens missed his header and the ball was allowed to bounce through to Mitoma, who evaded marker Yukinari Sugawara to head home.

But Brighton failed to press their advantage, and were punished when Armstrong's blocked effort fell perfectly for Downes to strike from 16 yards.

# Ruud awakening for the Foxes?

Leicester City have appointed former PSV Eindhoven boss Ruud van Nistelrooy as their new manager.

The Dutchman replaces Steve Cooper, who was sacked last weekend after just 12 Premier League matches in charge of the Foxes.

He has signed a contract until June 2027 at the King Power Stadium.

Van Nistelrooy's appointment comes two weeks after he left his role as interim head coach at Manchester United following Ru-

ben Amorim's arrival.

"I'm proud, I'm excited," Van Nistelrooy, 48, said.

"Everybody that I speak to about Leicester City is enthusiastic. They have great stories about the quality of the people working at the club, the supporters and, of course, the recent history of the club is impressive.

"I'm excited to start and to get to know everyone and give everything I can for the football club."

Leicester are 16th in the Premier League, one point above the

Liverpool dominated Carlo Ancelotti's side, who have now lost three of their five games and must fight for a play-off place in the tournament's new format.

In a game where the

two superstars, Liverpool's Mohamed Salah and Real's Kylian Mbappe, failed from the penalty spot, Alexis MacAllister put the hosts ahead after 52 minutes with a low shot across Thibaut Courtois in front of an elated Kop.
