# HARRY: MY LIFE IN US IS 'WHAT DIANA WOULD HAVE WANTED'

**Duke of Sussex focused on "being the best husband and the best dad that I can be"**

**Prince Harry said his life in the US is what his mother Princess Diana would have "wanted" for him.**

The Duke and Duchess of Sussex relocated to Montecito, California four years ago, after announcing they would step back as senior royals and work to become financially independent.

Speaking to Andrew Sorkin at The New York Times Dealbook Sum-

mit on Wednesday, the prince was asked if he planned to remain in America for good. "I do," he said, "I very much enjoy living here and bringing my kids up here".

He added his family were able to access a degree of privacy and freedom they "undoubtedly

wouldn't be able to do in the UK" due to concerns around security.

Harry has pursued legal action over changes to his police protection for when he is in the UK. His security was downgraded when he stopped being a working royal.

In the interview he spoke of the impact of life in the spotlight on his mental health and on his mother, Princess Diana who was killed in a 1997 car crash in Paris while being chased by photographers.

### 'inner turmoil'

"I think again, when you are kind of trapped within this bubble, it kind of feels like there's no way out," Harry said.

He continued: "What happened to my mum and the fact that I was a kid and felt helpless, there comes the inner turmoil. I felt helpless.

"One of my biggest weaknesses is feeling helpless."

He said what worried him most was "that would happen to me,

or to my wife, or to my kids".

For now, Harry said his focus was on "being the best husband and the best dad that I can be".

Asked about the press attention he and his wife receive, he made a joke that they had apparently moved house and divorced "10-12 times".

"It's just like what? It's

hard to keep up with but that's why you sort of ignore of it," he said.

The Duchess of Sussex meanwhile made a solo red carpet appearance at the Paley Honors Gala at the Beverly Wilshire Hotel on Wednesday.

The glitzy fundraiser honored actor, director, entrepreneur and philanthropist Tyler

Perry, with whom the royal couple enjoy a close relationship. Perry is also the godfather of their three-year-old daughter, Lilibet.

The Duchess, 43, wowed an A-list crowd, pairing a strapless black Oscar de la Renta gown with a sizzling front slit and strappy Celine heels for the event.

## Panic grips nation as Xmas Guinness shortage looms

**Pubs and bars across the country are expected to face shortages of Guinness this Christmas following unprecedented demand for the alcoholic drink in the last three weeks.**

Diageo, the owners of the Irish stout, have said they have seen an

'exceptional demand' for the beverage in the UK. The firm is believed to be working to production capacity, with limits said to be in place on keg orders in an attempt to manage expectations during the festive period.

From July to October

this year, insights from food and drinks industry research firm CGA found that while beer volume had declined by 0.5%, kegs of Guinness had grown in demand by 20.9%.

One of the reasons for the surge in popu-

## The Russian Connection: how UK drug gangs swapped dirty money for untraceable cryptocurrency

**A multi-billion-dollar money laundering operation that formed when UK gangs were struggling to offload cash during lockdown has been uncovered by the National Crime Agency.**

Discovering the Russian-speaking network embedded in the UK's street drugs market is the biggest success against money laundering in a decade, say investigators.

The global operation, based in Moscow, has been taking dirty money from crime gangs for a fee, and allowing them to exchange it for untraceable cryptocurrency, protecting drugs profits from detection.

The network has also been used by the Russian state to fund espionage.

### cyber criminals

The network stretches across 30 countries, and 84 people have so far been arrested, including 71 in the UK, the NCA and its partners told reporters at a briefing earlier this week.

UK Security Minister Dan Jarvis said the operation "exposed Russian kleptocrats, drug gangs and cyber criminals - all of whom relied on the flow of dirty money".

On Wednesday, the United States Treasury sanctioned the key figures at the top of the network. Ekaterina Zhdanova, the head of a Moscow-based cryptocurrency network called Smart, has been identified as being at the heart of the operation. She was previously sanctioned by US authorities in November 2023 for allegedly moving money for Russian elites.

Bradley Smith, Acting Under Secretary for Terrorism and Financial Intelligence for the US Treasury, said the country "remains committed to disrupting any effort by Russia to use digital assets or other illicit financial schemes to accrue, store, and transfer their ill-gotten gains".

Rob Jones, director general of operations at the NCA, said the thread connecting Russian elites, crypto-rich cyber criminals and UK drugs gangs had been "invisible until now".

"We have identified and acted against the Russians pulling the strings at the very top," he continued, adding that the NCA had now made it "extremely difficult" for the key players to operate.

The trail that led to the

enormous and complicated network was spotted during the 2021 pandemic lockdown, as drugs gangs across Europe struggled to move piles of cash from street sales into the legitimate economy.

That, in turn, made it harder for them to buy in more produce, such as cocaine from South America.

### ransomware

The NCA says two cryptocurrency networks based in Moscow, known as Smart and TGR, offered a solution.

Both were sitting on large piles of cryptocurrency from ransomware attacks. That's a form of online extortion in which a gang paralyzes an organisation's computer systems until it pays a fee to regain control.

TGR and Smart took the profits from those attacks and struck a deal with British drugs networks, giving them an almost instantaneous way of converting dirty street money into a useable asset.

Cash was gathered around the UK then exchanged for cryptocurrency from Moscow. In return for taking on

the risk of receiving the cash, the Russian-led network charged commission. Its network of couriers would launder the cash, pushing it through seemingly legitimate businesses like construction firms in the UK and elsewhere, or using mules to fly it in baggage to Dubai.

Ultimately, the cash re-entered the economy as it was paid into bank accounts as seemingly legitimate profits.

In effect, Smart and TGR were mimicking a legitimate bank, by charging a small fee for

providing a network to move money from country to country.

The first clue came when police stopped Fawad Saiedi, a drugs courier, in 2021. He was carrying £250,000 in his car.

He later admitted co-ordinating the move of £15.6m of dirty money and he was jailed for more than four years.

As the NCA dug deeper, they found he had been working for Ekaterina Zhdanova, the head of the Smart cryptocurrency exchange service in Moscow.

Another UK-based courier network was run by Semen Kuksov, the son of a Russian oil executive. He and his associates collected more than £12m in drugs cash in just 10 weeks to be exchanged for virtual currency. Last February, he was jailed for almost six years.

So far, the NCA and its partners have seized £20m in cash, relating to an estimated £700m in drugs sales - and the vast majority of the arrests and charges so far are of couriers like Saiedi and Kuksov.

## Porridge and crumpets set to be listed as junk food in advertising ban



**Certain types of porridge, crumpets and breakfast cereals are included in a list of products that fall under a new junk food advertising ban.**

The government says the legislation, which applies to both paid online

adverts and TV adverts shown before 21:00, is designed to curb childhood obesity.

Due to come into force in October 2025, food classed by the government as "less healthy" falls under the ban, and includes fast food, soft

drinks and ready meals as well as pastries, cereal bars and sweetened yoghurts.

Details of the restrictions show baked goods including crumpets, scones and pancakes are all considered junk food

larity in recent weeks is thought to be due to the rise of social posts on platforms like TikTok and Instagram from so-called Guinnfluencers. Earlier this year, JD Weatherspoon founder and chairman Tim Martin cited Guinness and other ales as one of the reasons for higher sales.

Speaking about an 'increased momentum' on stouts and ales, he said in May: "The gods of fashion have smiled upon Guinness, previously consumed by blokes my age, but now widely adopted by younger generations."

Last year, Kim Kardashian shared a photo on Instagram of her at a London pub with a pint of Guinness and a baby Guinness on St. Patrick's Day - which has only added interest from her 359 million followers since.

In recent months, Diageo have also been working with the likes of Lewis Capaldi and Jason Momoa on Guinness campaigns. Earlier this year, the Aquaman actor co-directed and starred in a 'Lovely Day for a Guinness' short film.

The popularity of Guinness, which is brewed at St James's Gate in Dublin, has also seen heightened interest in its a zero-alcohol Guinness 0.0 and for its Nitrosurge device, which delivers pub-quality 'smooth' pour at home.

In a statement to the Manchester Evening News, a Diageo spokesperson said: "Over the past month we have seen exceptional consumer demand for Guinness in GB.

"We have maximised supply and we are working proactively with our customers to manage the distribution to trade as efficiently as possible."

# No liquidation for much-loved tea brand

## ■ Vape manufacturer steps in to rescue venerable Typhoo tea

**Typhoo Tea has been rescued by vape maker Supreme in a £10m deal which it said would keep the brand "in British hands".**

The 120-year-old tea-maker fell in to administration in November as its sales slumped and debts rose.

Manchester-based Supreme makes the e-cigarette brand 88Vape and distributes nicotine and home products to supermarkets.

Typhoo currently has fewer than 30 staff in the UK, mainly in sales and marketing, after much of its operations - both in the UK and abroad - have been outsourced over the years.

### memorable ads

In the 1980s, its adverts featured some of the biggest stars on TV, including the late presenter and singer Cilla Black and late actor and comedian Frankie Howerd.

One of its most memorable ad slogans was "you only get an 'oo' with Typhoo", and one advert famously featured entertainer Su Pollard being serenaded by ponies while drinking tea on the beach.

In 2016, celebrity chef Nigella Lawson was named as brand ambassador.

In the 1980s, its adverts featured some of the biggest stars on TV, including the late presenter and singer Cilla Black and late actor and comedian Frankie Howerd.

"Typhoo is such an iconic brand," said Supreme chief executive Sandy Chadha. The company said the decision to buy it was a mix of "sound business rationale and personal affinity".

### pre-tax losses

It added that the deal was part of Supreme's strategy to branch out into other areas. Currently the company works with soft drinks, gym supplements and multivitamin gummy brands, as well as non-food items such as batteries and home lighting. It also manufactures sports nutrition and wellness and soft drinks, and also has its own sales websites to sell direct to customers.

Typhoo fell into administration after its pre-tax losses rose

from £9.6m to £38m. Its sales fell from £33.7m to £25.3m, according to its latest results which covered the year to the end of September 2023.

### rebrand effort

Its debts became more than the value of its assets, and costs related to a break-in at its Wirral plant added to its woes.

But Supreme said buying the company was a "significant step"

and that Typhoo would "thrive" because of the brand loyalty customers had to the tea brand.

Although priced at the cheaper end of the tea market, and despite a rebrand attempt, Typhoo had been suffering from what analysts say is a wider downturn in sales of black tea.

A cuppa remains a daily staple for many in Britain, but competition from the likes of coffee,

soft drinks and herbal tea have eaten in to sales.

Supermarkets introducing their own-label brands has also led to the decline of the big names.

However, despite many people cutting back on living costs as prices rise, Typhoo remained one of the biggest names in tea along with PG Tips, Tetley and Yorkshire Tea.

## New Jag too 'fearlessly creative' to be loved by everyone...

### ■ Unveiling of 'Type 00' in Barbie Pink stirs up more controversy for famed British automaker

Jaguar has defended its new concept EV, saying that it "won't be loved by everyone" because it is "fearlessly creative".

The automaker's drastic makeover continued to court controversy this week, with the official release of their "Type 00", first seen this week in Florida as part of the Art Miami festival.

The struggling British brand has been at pains to jettison almost every aspect of its 90-year history, including its aging, traditionalist client base, and has been beset in recent weeks by rows over the supposed "wokeness" of

its reinvention, and a resulting barrage of what it calls "vile hatred and intolerance" online directed at both the campaign and staff.

Rawdon Glover, managing director of the company, told the press customers Jaguar's new EVs will be younger, more affluent, urban, independently minded, creative, and wishing to "carve their own path."

#### brand reset

Tellingly, Glover adds that the brand "needs to build a relationship with almost an entirely new client base."

The Type 00 will not go on sale but is a "design vision concept," intended to encapsulate the look of the three production models which will follow.

The name encapsulates the bigger picture: The first "0" represents zero tailpipe emissions, as all future Jaguars will be pure EVs, and the second represents a complete brand reset. No matter what you think of the design, it certainly delivers on the brief given by JLR's chief creative officer, Professor Gerry McGovern four years ago to four competing design

teams: to produce something not only unlike any previous Jaguar, but unlike anything else on the road.

As if to underline the new informality at the company McGovern himself assured a small group of invited press at

the event: "We have not been sniffing the white stuff...You will feel uncomfortable—and that's OK."

Commenting on the controversial choice of a Barbie pink model at the reveal on Monday night McGovern added: "Con-

trovery has always surrounded British creativity when it's been at its best".

No matter how well their EV line sells down the road, the revamped British classic marque has certainly already succeeded in earning a few headlines.

## Pie thieves make no dough from their larceny

### ■ Baked goods worth £25,000 stolen from Michelin-starred chef

A stolen van that contained 2,500 pies from a Michelin-starred chef has been found by police - but the pies themselves have perished.

Tommy Banks, who runs award-winning restaurants in North Yorkshire, said the van had been due to drop off the pies, worth £25,000, at York Christmas Market on Monday morning.

However, he believed the white Fiat Ducato had been snatched

from a business park in Melmerby, near Ripon, on Sunday night.

The refrigerated van was found abandoned with false number plates in the Hemlington area of Middlesbrough, North Yorkshire Police said.

Mr Banks said the vehicle was "badly damaged" and "almost certainly a write-off", while the pies were "damaged and not refrigerated, so are also written off".

He described a tonne of food going to waste as "a real shame" and "just rubbish".

"I don't think the guys who stole the van were necessarily trying to steal pies. I think they were trying to steal a van and the pies were just collateral," Mr Banks added.

The missing pies represented a week's worth of stock, said Mr Banks, who had managed to keep his business open

and trading.

"A van is a van, but the amount of work that goes into making pies is huge," he said.

North Yorkshire Police said the van was found abandoned in Cleveland

on Friday and reported as stolen on Monday.

A spokesperson added that the vehicle had been forensically examined, with an investigation launched into the theft.

They added: "We are pleased that the owner has now been reunited with his van, but just as sad as everyone else to hear that the tasty pies in the van have sadly perished."

under the new legislation.

Adverts for sugary breakfast cereals will also disappear from pre-watershed television screens, with granola, muesli and "porridge oats, including instant porridge and other hot oat-based cereals" all classed as "less healthy" food.

The promotion of

sweetened yoghurts and sugary drinks - including fizzy drinks and some fruit juices - will also be restricted.

The government will classify products according to a scoring system based on their sugar, fat and protein content, banning advertising on all foods designated as "less healthy".

This means healthy versions of products - including porridge products with no added sugar, salt or fat, and

unsweetened yoghurt products - will not be subject to the ban.

As well as TV advertising, the new legislation applies to paid-for online ads for these products to reduce children's exposure to foods high in fat, sugar or salt.

The legislation comes in the context of rising childhood obesity levels in the UK, with NHS data suggesting almost one in 10 reception-aged children (9.2%) lives with obesity.

## Ukraine-type war 'could wipe out Army in six months'

The British army would be wiped out in as little as six months if it was forced to fight a war on the scale of the Ukraine conflict, a defence minister has warned.

Alistair Carns said a rate of casualties similar

to Russia's invasion of Ukraine would lead to the army being "expended" within six to 12 months.

He said it illustrated the need to "generate depth and mass rapidly in the event of a crisis".

In comments report-

ed by Sky News, Carns, a former Royal Marines colonel, said Russia was suffering losses of about 1,500 soldiers killed or injured a day.

"In a war of scale - not a limited intervention, but

A controversy over an elasticated band and a few scrawled words has got the Football Association in knots and has split football fans.

For a decade, football has run the Rainbow Laces campaign in col-

laboration with Stonewall, the high-profile LGBTQ+ charity. And while it was not officially connected with Rainbow Laces, the biggest controversy came when captains were told not to wear multi-coloured

armbands at Qatar 2022. But over the past week, one Premier League captain - Ipswich Town's Sam Morsy - refused to wear a rainbow armband while Marc Guehi, of Crystal Palace, twice wrote slogans on his.

one similar to Ukraine - our army for example on the current casualty rates would be expended - as part of a broader multinational coalition - in six months to a year," he said in a speech at a conference on reserves at the

Royal United Services Institute thinktank in London.

He added: "That doesn't mean we need a bigger army, but it does mean you need to generate depth and mass rapidly in the event of a crisis."

Official figures show the army had 109,245 personnel on 1 October, including 25,814 volunteer

reservists.

Carns said: "The reserves are critical, absolutely central, to that process. Without them we cannot generate mass, we cannot meet the plethora of defence tasks."

Carns, the minister for veterans and people, said the UK needed to "catch up with Nato allies" to place a greater emphasis on the reserves.

Ipswich insisted they are committed to "being

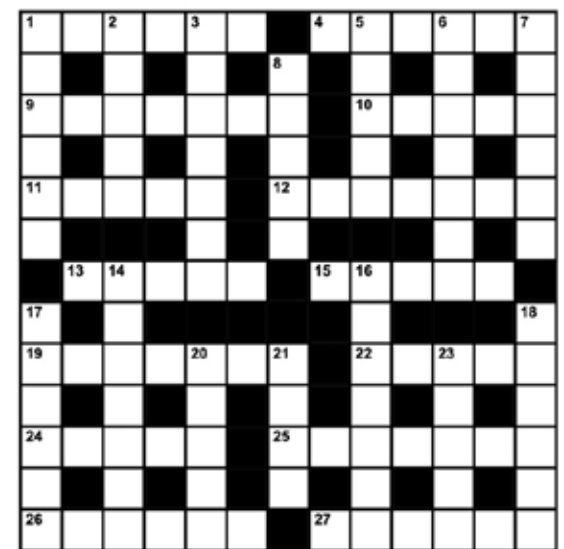
a fully inclusive club that welcomes everyone" but "respect the decision" of their skipper.

## Binge-worthy Rivals brings a welcome return to Rutshire

■ New series based on Jilly Cooper's classic bonkbuster brings back the 1980s in all its big-haired glory

IF you're seeking some unabashedly fun, sexy and very British viewing on the small screen to binge-watch this weekend, you can't do better than *Rivals*, now streaming on Hulu!

Based on Jilly Cooper's 1988 novel from wildly popular Rutshire Chronicles series, (named after a fictional area of the Cotswolds), *Rivals* combines scandal, satire, and steamy drama set in the flashy yet cutthroat world of

1980s British television. Led by the stellar casting of David Tennant, Alex Hassell, and Aidan Turner, the series dives into rivalries and relationships, delivering a mix of glamour, intrigue, and cheeky humor.

For those unfamiliar with Cooper's work, her books were THE bonkbusters of the late 1980s, their mood and tone perfectly captured the go-go zeitgeist of Margaret Thatcher's Britain. Imagine an endless so-

cial whirl of shopping, drinking and fornicating among the upper and upper middle classes, and throw in a supporting casts of hedonistic pop stars, tycoons and page three models, and you get the idea.

### setting the tone

Generations of young women, particularly in the UK, found escapism – and sometimes, sexual awakening – in Cooper's books, which were passed around schools and sneaked off the shelves of older sisters. It should be noted, though, that Cooper has plenty of male fans too, including former prime ministe

But for me the show's biggest achievement is how perfectly it captures the tone of Cooper's books, lighthearted, witty, sexy and uproariously funny.

The story centers on the bitter feud between Lord Tony Baddingham

**PRINCIPAL OVER PRINCIPLE:** the promise of real money is used to lure Declan O'Hara (Aiden Turner) away from the BBC in *Rivals*

(Tennant), a calculating television executive, and Rupert Campbell-Black (Hassell), a rakish former Olympian turned politician. Their rivalry is mirrored in the struggles of Declan O'Hara (Turner), a principled Irish journalist lured from the BBC to Tony's independent station. While the titular rivalry promises intense drama, it often takes a backseat to an array of subplots involving romantic entanglements and professional power plays.

### soapy roots

The series leans heavily on its soapy roots, offering scenes packed with lust, betrayal, and opulence. From nude tennis matches to clan-

destine affairs, the show captures the outrageous decadence of its source material with a playful tone that often borders on farce.

One of the show's strengths lies in its performances. Tennant imbues Tony with a balance of charm and menace, while Hassell's Rupert evolves from a stereotypical womanizer to a surprisingly complex character. The supporting cast, including Katherine Parkinson as an author of risqué fiction and Danny Dyer as a tech entrepreneur, adds warmth and humor to the sprawling narrative.

And for those of us who remember the 1980s, the show's production design will bring

it all flooding back, juxtaposing stately manor houses with tacky period fashions and an evocative pop soundtrack that enhances the nostalgic atmosphere.

### pop bangers

*Rivals* was very much a book of its time – and the show takes us right back to that time, from the attitudes and behaviour to the fashion and music. There is copious blue eyeshadow, an abundance of handlebar moustaches, mountains of vol-au-vents and a soundtrack heavy on 1980s pop bangers.

*Rivals* won't change the world – but it might be the most fun you have watching a TV show this year.

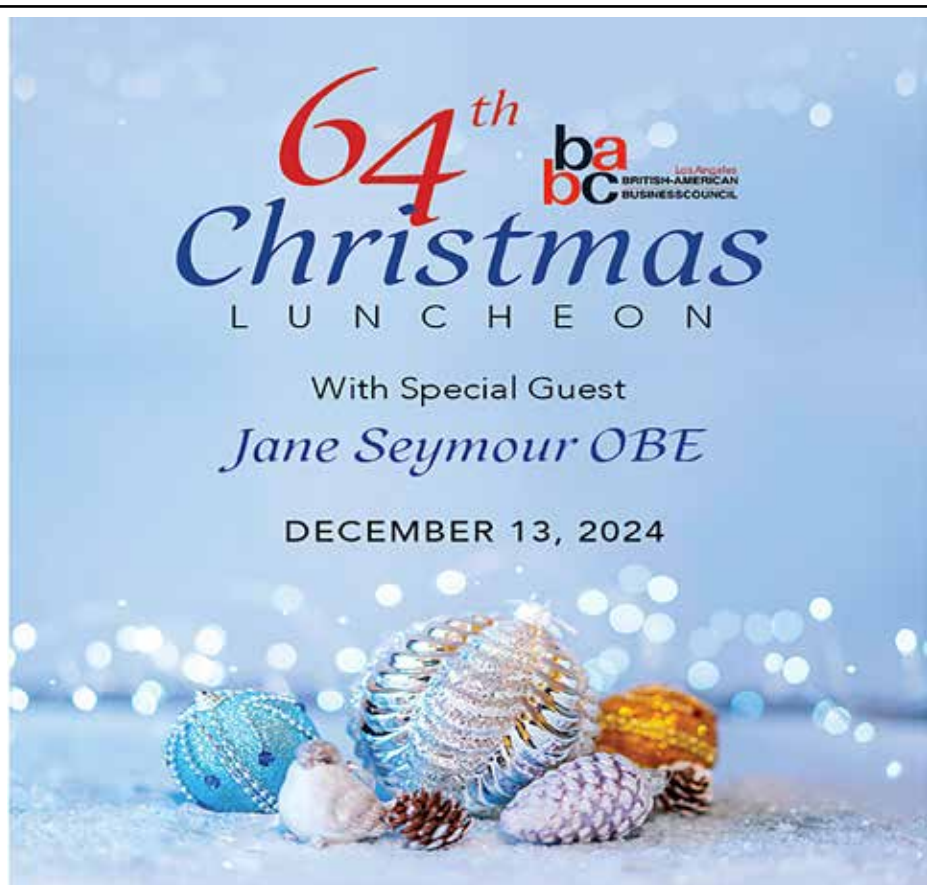

# Ever upward for Blues

**Jadon Sancho scored his first goal for Chelsea as they ruthlessly capitalized on a series of Southampton errors to run out comfortable 5-1 winners on Wednesday night.**

Sancho wrapped up the scoring for the Blues after goals from Axel Disasi, Christopher Nkunku, Noni Madueke and Cole Palmer had put them in control.

Saints briefly levelled at 1-1 through Joe Aribo but their capacity to self-destruct was underlined when, after falling 3-1 down, captain Jack Stephens was sent off by referee Tony Harrington for pulling Marc Cucurella's hair.

With Chelsea flying high - victory took them second above Arsenal - and their hosts bottom of the table, there was no

doubting who the favourites were going into the match.

And when goalkeeper Joe Lumley failed to clear Enzo Fernandez's near-post corner, Disasi headed home from two yards out to put the visitors in front.

The lead lasted just four minutes, though, as Aribo made up for squandering an earlier chance by turning home an excellent cross from full-back Kyle Walker-Peters for a deserved equaliser.

But another Lumley mistake - this time while playing out from the back - allowed Nkunku to score in an empty net and restore Chelsea's lead.

They doubled that advantage just after the half-hour as Madueke's tricky dribbling took him past Ryan Manning be-

fore stroking the ball into the far corner.

And what already looked an uphill battle became even harder for Saints when Stephens was dismissed for pulling Cucurella's hair as the hosts prepared to take a corner.

Palmer and Tosin Adarabioyo hit the woodwork as Chelsea continued to dominate - and the second half brought further trouble for Russell Martin's struggling side.

Joao Felix headed a simple chance wide immediately after the break, Tosin again hit the woodwork in the 53rd minute and Palmer, Madueke and Nkunku all had chances to extend the lead.

It was Palmer who finally did so, scoring his ninth of the season after

Nkunku's initial effort had been blocked.

Substitute Sancho then opened his Chelsea account by finishing in a one-on-one situation from Malo Gusto's through ball.

Chelsea boss Enzo Maresca opted to make seven changes to his side - only one of which was

enforced as Wesley Fofana recovers from a hamstring injury.

And the manner of the victory meant he was able to take off both Palmer and Moises Caicedo as he looks ahead to Sunday's London derby against Tottenham.

What is clear is that Maresca has flipped the

mood among the Blues faithful, with chants of "we've got our Chelsea back" ringing out of a raucous away end.

With Liverpool only drawing 3-3 at St James' Park the same night, it is also clear Chelsea fans now believe they can compete with Arne Slot's side.

## Fan fury deepens Ange misery

**THINGS are going from bad to worse for Tottenham manager Ange Postecoglou, after a confrontation with fans following their dismal 1-0 midweek loss to Bournemouth.**

The coach says he "didn't like what was being said" by some Spurs supporters after their defeat - but that "you've got to cop it".

In the immediate aftermath of defeat at the Vitality Stadium, Postecoglou pointed at a group of Tottenham fans who were voicing their anger and marched across the pitch towards the away end to confront them.

Words were exchanged before a steward attempted to defuse the situation by waving the 59-year-old Australian away.

"They're disappointed and rightly so," said Postecoglou in his post-match news conference. "They gave me some direct feedback, which I've taken on board.

"I didn't like what was being said because I'm a human being but you've got to cop it.

"I've been around long

enough to know that when things don't go well you've got to understand the frustration and disappointment. And they're rightly disappointed because we let a game of football get away from us. But that's OK. I'm OK with all that.

"All I can say is I'm really disappointed and I'm determined to get it right and will keep fighting until we do."

Tottenham's defeat by Bournemouth leaves them 10th in the Premier League table, one place below the Cherries.

It was Spurs' sixth league defeat this season, with only five sides in the top flight having lost more games than them.

"It comes down to us as a collective being a lot more determined to control a game of football and not let the opposition take control," added Postecoglou.

Tottenham have only won one of their past six matches, a 4-0 victory at Manchester City - which now feels like an outlier.

"I now know what people mean when they say Tottenham are like Jekyll

and Hyde," said former Stoke boss Tony Pulis on BBC Radio 5 Live. "They have been really poor tonight."

Spurs managed 12 shots, four on target - about half the total of Bournemouth - but their expected goals was only 0.58, compared to Bournemouth's 3.31.

Former England striker Les Ferdinand, who played for Spurs between 1997 and 2003, said on Amazon Prime: "Tottenham didn't look like they could score today.

"I thought Spurs could only be better in the second half and they were slightly better, but there was no urgency. We didn't know what Spurs was going to turn up tonight - and that wasn't the Spurs we wanted."

Former England striker Alan Shearer called it "a terrible performance" from Spurs.

"I was really surprised they came out with the same team after half-time because they needed some energy and freshening up," he said. "I never felt they were ever going to score tonight."

# Gunners end Amorim's run

Arsenal scored twice from corners to comfortably beat Manchester United as Ruben Amorim suffered his first defeat in English football. Defenders Jurrien Timber and William Saliba did the damage on Wednesday night as Arsenal took advantage of Liverpool dropping points to trim their lead at the top of the Premier League table. Saliba made sure of the win when Thomas Partey headed Bukayo Saka's corner against the French defender's back and the ball went past Andre Onana in the United goal. Arsenal have become a force to be reckoned with from set-pieces under manager Mikel Arteta. Timber and Saliba's goals

means they have scored 22 goals from corners since the start of last season, more than any other Premier League side. Amorim's United did threaten the Arsenal goal when Diogo Dalot flashed a shot past David Raya's post in the first half, and

the Arsenal keeper made an excellent save to deny Matthijs de Ligt in the second half. Substitute Mikel Merino headed wide from another excellent Arsenal set-piece and Kai Havertz had an effort saved by Onana as the Gunners dominated the closing period of the match.

It meant that Amorim, who warned that a "storm will come" for United before this game, saw his three-game unbeaten start come to an end in north London. Since losing back-to-back games to Inter Milan and Newcastle at the start of November, Arsenal have hit on a hot streak. The return of Martin Odegaard has coincided with a five-match unbeaten run and Arteta's side are back to looking like title contenders.

# Magpies and Reds serve up a thriller

Premier League leaders Liverpool drew 3-3 with Newcastle in an enthralling match at St James' Park which was described as one of the best games of the season.

The Reds twice trailed in Wednesday night's encounter and then led thanks to a double from the ever-reliable Mohamed Salah, and looked set to extend their winning run in the league to five games.

But Fabian Schar's 90th-minute equaliser

earned Newcastle a deserved point at the end of an exhausting encounter.

"One of the best [games] I've seen this season," said former Chelsea winger Pat Nev-in on BBC Radio 5 Live at full-time.

"We have seen it ebb and flow. Both sides will be happy with the point in the end."

But they will not be the only sides happy with the draw, with Chelsea, Arsenal and Manchester City - second, third and fourth respectively - all picking up wins on Wednesday. Fifth-placed Brighton, meanwhile, play Fulham on Thursday.

It means Liverpool's lead is cut from nine points to seven at the start of a busy December that could see things change dramatically at the top of the table

Historically, Liverpool were already in a

title-winning position before a ball was kicked on Wednesday.

After beating Manchester City on Sunday they were nine points clear of second place after 13 league games.

Only two teams in Premier League history have had a lead of at least nine points after the same number of matches - Manchester United in 1993-94 and Chelsea in 2005-06 - and both went on to win the title.

Despite that, many were still urging caution in the battle at the top - including Reds boss Arne Slot.

The Dutchman said before the Newcastle game that 19 matches would be a better barometer of how the title battle is shaping up, an opinion that will have only been galvanised after the 3-3 draw.

City's loss to Liverpool left them 11 points adrift of the Reds but

that has been cut to nine, and history suggests they are more than capable of overturning such a deficit.

In 2018-19, they trailed Liverpool by 10

points after a poor run of form in December but then won 18 of their 19 matches from the 30th of that month to go on and clinch the title.

"I think we know

Man City are not out of the title race - they are going to have a say," former Manchester City player and manager Stuart Pearce said on Amazon Prime.

## City to face Juve in Club World Cup

Defending champions Manchester City will face Juventus in the group stage of the Fifa Club World Cup next summer, while Chelsea meet Brazilian side Flamengo.

Pep Guardiola's City, who beat Brazilian side Fluminense to win the tournament for the first time in 2023, begin their title defence against Morocco's Wydad and also play Al Ain of the United Arab Emirates in Group G.

Chelsea, winners of the 2021 final, were also drawn alongside Mexico's Club Leon and Tunisian side Esperance Sportive de Tunisie in Group D.

The revamped Fifa Club World Cup, which has been expanded to 32 teams, will take place in the United States between 15 June and 13

A complex and lengthy draw ceremony was held across two separate Miami locations and lasted more than 90 minutes, during which a new Club World Cup trophy was revealed.

Lionel Messi's Inter Miami will take on Egyptian side Al Ahly at the Hard Rock Stadium in the opening match, staged in Miami.

Elsewhere, Paris St-Germain were drawn against Atletico Madrid

in Group B, while Bayern Munich meet Benfica in another all-European group-stage match-up.

Teams will play each other once in the group phase and the top two will progress to the knockout stage.

Teams from each of the six international football confederations will be represented at next summer's tournament, including 12 European clubs - the highest quota of any confederation.
