



L.A. IN FLAMES: If you need help, here's where to find it

AS LOS ANGELES residents begin to emerge from the ashes of the city's worst-ever wildfires, a myriad of emergency services and aid organizations have sprung up to aid those left homeless or without resources by this horrendous inferno.

The local British consulate has set up an emergency hotline for British nationals in the Los Angeles area in need of assistance at 310-789-0031. Those needing temporary emergency accommodation can also take advantage of the 211 non-emergency line, which has teamed up with VRBO to offer free temporary shelter for people displaced from their homes by fire. Start by visiting care211cs.org

In addition, the YMCA of Metropolitan Los Angeles has opened its locations not affected by the fires for temporary shelter, showers, basic amenities, and mental health support. They are also providing childcare services (5 years and up) for first responders and families affected by the fires.

Musk: Farage should step down as Reform UK leader

■ Tycoon turns hostile after Nigel breaks ranks over Tommy Robinson

NIGEL Farage has hit back at Elon Musk after the billionaire suggested that Reform UK needs a new leader.

The world's richest man sensationally turned on his supposed ally, saying he should leave the top job.

Mr Musk, a friend and aide to incoming US president Donald Trump, wrote on his social media platform X: "The Reform Party needs a new leader. Farage doesn't have what it takes."

The bombshell came after the tech tycoon had spent the past week wading into British politics over sex-abuse gangs, backing jailed far-Right activist Tommy Robinson.

Mr Farage quickly reposted Mr Musk's post, stating: "Well, this is a surprise! Elon is a remarkable individual but on this I am afraid I disagree."

"My view remains that Tommy Robinson is not right for Reform and I never sell out my principles."

The stunning blow comes after Mr Farage and party treasurer Nick

Candy met Mr Musk last month at Mr Trump's Mar-a-Lago estate in Florida.

The pair are said to have discussed the Tesla motor boss donating large sums to Reform.

Later Mr Farage said that Mr Musk – worth around £400billion – was giving "serious thought" to it.

"Money was discussed. We are in negotiations about whether he can help," Mr Farage said.

"He is fully behind this. He is motivated enough by what's going on in Britain to give serious thought to giving mon-

ey." However, tensions appeared last week after the billionaire called for the release of Robinson.

The co-founder of the now-defunct English Defence League and whose real name is Stephen Yaxley-Lennon, is currently on an 18-month prison sentence for contempt of court.

He was found guilty of breaching a court order after screening a documentary that included false claims about a Syrian refugee schoolboy. Mr Musk shared the documentary on X, describing it as "worth watching"

and calling for Robinson's release.

Speaking ahead of Reform's East Midlands Conference on Friday, party leader Mr Farage said the billionaire "has a whole range of opinions, some of which I agree with very strongly, and others of which I'm more reticent about."

He went on to say that having Mr Musk's support is "very helpful to our cause", describing him as "an absolute hero figure, particularly to young people in this country".

Mr Farage also hinted at disagreements with the tycoon, saying: "The fact that Musk supports me and supports Reform doesn't mean as two grown-ups we have to agree with everything the other says."

Pushed on whether he agreed with everything Mr Musk has said about the Government, Mr Farage said: "The point is, the fact that he supports me politically and supports Reform doesn't mean I have to agree with every single statement he makes on X."

But Mr Farage also referred to the SpaceX tycoon as his "American friend" and refused to criticize him"



Andrew McIntyre: seven year sentence

Stiff sentence for Southport stirrer

A taxi driver whose social media posts were a "catalyst" for riots that broke out after three girls were stabbed to death in Southport has been jailed seven and a half years.

Andrew McIntyre, 39, set up a Telegram channel called "Southport Wake Up" in the immediate aftermath of the knife attack at a children's dance class in the Merseyside town on 29 July.

Liverpool Crown Court heard the case involved a "sinister aspect" of violence which took place in parts of the UK last summer.

McIntyre, of Rufford, near Ormskirk, Lancashire, had admitted encouraging violent disorder and possession of a knife in an earlier hearing.

The Telegram channel was identified by the group Hope Not Hate as a "catalyst for and origin of a series of posts" concerning incidents of violence, prosecutor Arthur Gibson said.

The court heard McIntyre shared content from a site called Tommy Robinson/Britain First/For Britain about a protest in Southport on 30 July.

He also posted a map after adding: "Mosque at the top of Hart St."

In a later post he wrote: "Rise Up English Lads. 8pm tomorrow St Luke's Rd Southport."

Hours before violence broke out in Southport on 30 July he posted a "clear threat to police", writing:

"Message to All...Stand in our way, even if you're just doing your job...prepare to fall."

The day after the disorder, McIntyre posted: "Well done last night lads, to all you heavy hitters."

"Are you ready for Round 2???... Liverpool Mosque, West Derby Road, Friday 8pm."

McIntyre was also originally charged with encouraging murder after posting a link to a YouTube video of Home Secretary Yvette Cooper with the caption: "We're going to hang this woman and her associates."

Mr Gibson said the decision was taken by the Crown Prosecution Service not to pursue the charge to trial because of "evidential issues" over whether McIntyre believed the act would be carried out.

The count was left to lie on the file.

McIntyre was working as a taxi driver when he was intercepted and arrested by police in Liverpool on 8 August.

Tate wants to be PM: Not everyone digs it, BRUV

■ Controversial influencer sets his sights on No. 10; promises to 'restore underlying values'

ANDREW TATE, the controversial influencer, kickboxer, world class misogynist and alleged human trafficker, is keen to add a new job title to his repertoire: UK Prime Minister.

Despite languishing under house arrest in Romania Tate found time to launch a new political party this week - The BRUV Party, which stands for Britain Restoring Underlying Values.

Among the policies mooted by the party's bald and bearded leader

are a "24/7 live broadcast of knife crime offenders serving solitary confinement and forcing the BBC get all its topics from Elon Musk's social media platform X.

In terms of economic policies, Tate - who is awaiting trial on rape and human trafficking charges in Romania, and is wanted in the UK to face allegations of sexual assault - says the BRUV Party will purchase a "national Bitcoin reserve" for Britain.

"In an unpredictable

global economy, traditional financial systems are vulnerable to manipulation and collapse. A national Bitcoin reserve will future-proof Britain's economy, giving us a decentralised, nation-resistant asset that ensures stability and shields us from economic coercion by foreign powers," the party's charter, which is rigged with spelling errors, reads.

Following the announcement Tate was roundly ridiculed, with one commenter on X commenting that the party's charter, which includes calls for more wrestling, more guns and more patriotic signage on streets, was an "interesting mix of North Korea and homo-eroticism."

Someone else said the BRUV party was the "very worst idea in the history of British politics," with another labelling Tate the "biggest

loser on the planet."

Meanwhile, others pointed out that it is not possible to 'run for

prime minister' because of the UK's parliamentary system.

One person wrote:

"There's literally dozens of reasons why this won't happen, not least of them being that you don't 'run for Prime Minister' in the UK."

Tate also said on social media he would introduce "weekly referendums" to get more people involved in politics.

In response, Labour MP Emily Darlington said: "Britain has struggled with division over the last few years. But despite what it looks like online, British values are still intact - Tate will discover that we will not vote for a misogynist charged with sex trafficking and rape in this country."

The announcement comes after Andrew Tate asked his X followers whether he should run for prime minister.

"Ultra serious post. Should I enter politics and run for Prime Minister of the UK?", he asked.

Fans cry foul amid reports linking Musk to LFC bid

Liverpudlians have sent a clear message to Elon Musk amid rumours that he is interested in buying Liverpool FC.

The world's richest man is rumoured to be mulling a potential bid for the Reds, who currently sit at the top of both the Premier League and Champions League.

Asked about a potential purchase on Times Radio, Musk's father, Errol, refused to comment on whether he is interested in purchasing the club, saying they'll "raise the price".

When pushed for an answer, he added: "Oh, yes. But that doesn't mean he's buying it.

"He would like to yes, obviously. Anybody would want to - so would I."

Last May, Forbes rated Liverpool the fourth most valuable club, with an estimated value of £4.3 billion.

However, that amounts to just over one per cent of Musk's total net worth, which is believed to be around £340 billion.

His father went on to speak about Musk's family links to the city of Liverpool, which could explain the rumored interest.

He said: "His grandmother was born in Liverpool, and we have relatives in Liverpool, and we were fortunate to know quite a lot of the Beatles because they grew up with some of my family.

"So, we are attached to Liverpool, you know."

But as soon as the news broke, Liverpool fans took to social media to show the feelings weren't mutual.

'Anybody that's in favour of Elon Musk buying Liverpool can do one,' one Liverpool fan wrote on X.

'Any Liverpool fan wanting Elon Musk to buy isn't a Liverpool fan,' another added.

A third wrote: 'I don't believe there is a single genuine Liverpool fan that wants Elon Musk anywhere near the club.'

One fan express concerns that Musk would quickly strip away the club's identity, should he ultimately succeed in a bid to take over the club.

'Elon Musk ownership of Liverpool will be 100% worse than FSG's.

At the start, he'd sign a ton of players. Within 2-3 years, he'd wipe away the club's identity, worse than INEOS at United,' a

fan concluded.

'He'd still sign and spend money though, he likes to win. Pick your poison.'

Another simply wrote: 'Keep Elon Musk far away from Liverpool Football Club.'

The 53-year-old billionaire is already the owner of Tesla, SpaceX and X (formerly Twitter) and reportedly is keen to expand his business empire further.

Musk has previously described his grandmother, who was born in 1923 and died in 2011 aged 87, as 'an important part' of his childhood, which included time spent on Merseyside as young child on holiday.

'My Nana was one of the poor working-class girls with no one to protect her who might have been abducted in present day Britain', he said on X.

'She was very strict, but also kind and I could always count on her. She grew up very poor in England during the Great Depression only to be bombed in WW2', he said.

The South African-born Tesla tycoon once proudly declared he was 'from a British/English not an Afrikaner background'.

When Margaret Thatcher died in 2013, the entrepreneur paid tribute on Twitter - which he now owns and has rebranded as X - saying the late Prime Minister was 'tough but sensible and fair like my English Nana'.

His grandmother, Cora Amelia Robinson, was one of five siblings born in the family's modest terraced house in Mossley Hill, Liverpool in August 1923.

She grew up in pre-war poverty as part of a 'proud, hard-working family' before leaving the UK to settle in South Africa where she married Walter Musk in 1944.

Jail for prison guard who had sex with inmate

■ Uproar after video of OnlyFans star's sex acts at Wandsworth Prison goes viral

A porno-producing prison guard who filmed one of her sex romps with a convict in his cell has been jailed for 15 months.

Linda De Sousa Abreu's torrid tryst with career criminal Linton Weirich was filmed by another jailbird who was smoking marijuana as the action unfolded.

The 30-year-old married OnlyFans star had been a guard at Wandsworth Prison when she had sex with Weirich three times over several days. The raunchy footage soon hit the internet and Abreu tried to flee the country.

'boost of power'

Judge Martin Edmunds sentenced the sobbing Abreu to 15 months in prison on Tuesday, saying she was an "enthusiastic participant" in the wild sexual encounter.

He told her: "(You) undermined discipline in the prison and put fellow officers at risk. You knew that conduct was forbidden, and forbidden for good reason. Whether you intended it or not, the fact is the video went viral and caused great harm."

Before becoming a guard, Abreu moonlighted as an OnlyFans model.

The judge said that not only did Abreu bring the

prison system into disrepute, she has made the job more dangerous for other female guards.

At the time, Abreu claimed she "felt like a gangster" during sex with the jailbird and that she "loved" him. Her role as prison guard gave her a boost of "power" she said.

Abreu's amorous antics came to light when her sex video went viral and her bosses saw it.

Prosecutor Eloise Marshall said the video begins with Abreu performing oral sex on Weirich while the other prisoner provides commentary and puffs on a joint.

The auteur chimes in as the pair romped: "Guys, we made history."

At one point during the sex session, the trio feared they would be caught and Abreu hid on a bunk bed. The footage was shot by a smuggled phone and forwarded by the convict to a pal on the outside.

When Abreu was confronted she at first claimed the sex occurred "under duress." Then she said she was lured into the cell and blocked from leaving. Then she said she was fearful she would be raped or beaten if she did not go along.

She later pleaded guilty to misconduct in public office and backpedalled from her fibs.

"She has taken full responsibility for her actions," her lawyer Rajiv Menon said, adding his client now admits to the jailhouse sex romps and allowing them to be filmed.

In asking for a lenient sentence, Menon described his client as suffering from a slew of psychiatric problems.

He added: "She deeply regrets the breach of trust. (She is a) highly impulsive and reckless person who tends to act without considering the consequences."

"She was almost intoxicated by the high-risk behaviour in which she engaged, and she didn't consider the consequences of her actions."

As for her co-star, Weirich had been serving a sentence of more than four years for a \$120,000 heist at a posh Kensington address.

Frigid start to New Year for shivering Brits

HEAVY snow, freezing rain and ice brought travel chaos to Britain this week, closing airport runways, roads and rail and cutting power to thousands of homes.

An amber weather warning was in place for much of the country on Monday and Tuesday as up to 12in of snow fell in some areas, the Met Office said.

A less severe yellow warning for Wales, southern and northern England and the Midlands was also issued as rain and milder temperatures brought a rapid thaw and risk of flooding as the week progressed.

Southern Scotland and northern England were hit hardest by the weather with higher ground, especially the southern Pennines, Cumbria and Wales, seeing between six and 12 inches of snow.

Seven inches was recorded in Yorkshire,

while temperatures plunged to -11C in Loch Glascarnoch in the Scottish Highlands. The National Grid said it had been working to restore power after outages across in Birmingham, Bristol and Cardiff.

The severe weather is the biggest test of Labour's decision to scrap the winter fuel allowance.

About 10 million pensioners are going without the grant worth up to £300 this winter after Chancellor Rachel Reeves shelved it for anyone not on Pension Credit.

Health Secretary Wes Streeting was branded "cruel" by Conservative Party chairman Nigel Huddleston after he told pensioners to "turn the heating on" and wear layers over the weekend. Asked whether his advice was "tactful", Mr Streeting said: "It is part of the advice the NHS is

giving to people during this cold snap to make sure that people are doing whatever they can to keep warm, to make sure, as we've been doing in the run-up to winter, that people get vaccinated and so on.

"In terms of protecting

the poorest pensioners this winter, the Government is taking action. Of course, that doesn't mean that getting rid of the winter fuel allowance for others has been a popular decision."

National Highways expected up to 10in of snow

in northern England and closed Woodhead Pass connecting Manchester and South Yorkshire through the Peak District.

The A66 which cuts through the North Pennines and Yorkshire Dales between Cumbria and Durham was also closed.

Nick's nick proves nice little earner

■ London man suffered 'trauma' and bleeds Wilkinson Sword for £5k after shaving accident

A London man has carved out a £5k windfall - after cutting himself shaving.

Nick Silverthorn, 48, bought a Sainsbury's own brand razor from his local store. But when he got home and used it for the first time he says it cut both cheeks.

He says he discovered one of the blades was detached and believed it was faulty. So he decided to sue the manufacturer.

And he was awarded an out-of-court settlement against one of the world's biggest razor firms - Wilkinson Sword.

Londoner Nick said: "This was no ordinary shaving cut. It sliced my skin. My cuts bled for over 20 minutes. I took action to protect others as they may not be as lucky as me.

"This was a serious fault. It was a matter of principle to take the big boys on and I did and won."

Nick wanted to look fresh while visiting his relatives over the festive period after a few days of overindulgence.

So he visited a Sainsbury's in Richmond, south-west London, and bought an own brand £2.50 Men Advance 3 razor. But when he unwrapped it and started shaving on Boxing Day 2023 he cut his face.

Nick added: "I put on the hot tap and my shaving lotion and I was on autopilot. I started shaving on one side with one stroke and then another stroke on the other side.

"I noticed after a few seconds that I had started bleeding badly on my left cheek and then on my right hand side as

well and before I knew, it was streaming down my face."

Unlike previous times when he had cut his face shaving he says this felt completely different.

Nick added: "It just kept coming. Due to the wounds being on my face it took me nearly half an hour dabbing with tissues before the blood finally stopped pumping out of the cuts." He said he inspected the razor and saw that one of the blades was detached in the head.

The part-time landscape gardener added: "When I saw the blade hanging out I thought that could have done some real damage.

"It wasn't just an everyday nick or cut I had been given. It had sliced into my skin. I had been shaving for 30 years and

never had cuts like this."

Nick got relatives to take pictures of the cuts on his face and also preserved the razor, box and receipt as evidence. His wounds took weeks to heal leaving him with scars on his cheek.

And he said the trauma of being cut led to him having recurring nightmares for months.

He added: "I'd had a bad experience with operations and blood in the past and it took me straight back. I kept see-

ing blood on my face in my dreams. It was a bad time for me."

Brand bosses then sent the razor for tests and a month later offered to settle his claim for £5,000 with no admission of liability.

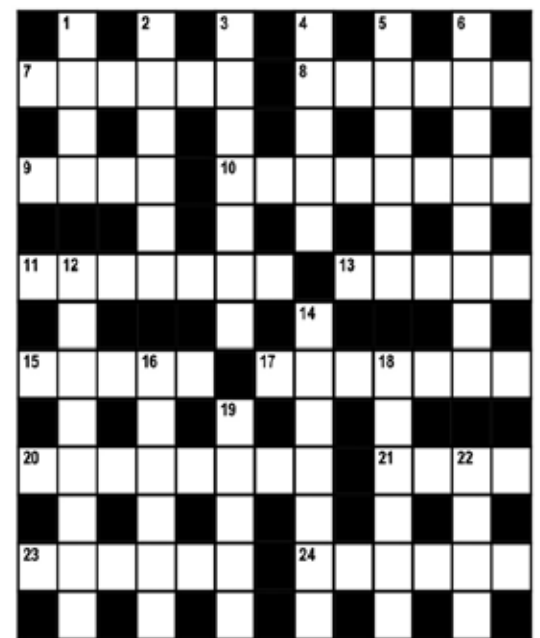

Isak on target again as Toon deliver textbook away performance

Alexander Isak's rich goalscoring form continued as Newcastle United took control of their Carabao Cup semi-final with a superb first-leg win against Arsenal at Emirates Stadium.

Newcastle have never won the competition but will make their second final in three seasons if they avoid defeat, or lose by a one-goal margin, in the second leg at St

James' Park on 5 February.

Arsenal, second in the Premier League, started the tie as favourites, but have it all to do in the return fixture.

Isak scored his 14th goal in 15 games to set Newcastle on the way to their seventh successive win.

Goalkeeper Martin Dubravka's free-kick was launched forward,

Sven Botman headed the ball on and Jacob Murphy played it into Isak's path with the Swede lifting a composed finish past David Raya.

Anthony Gordon doubled the visitors' lead in the 51st minute, converting the rebound after Raya could only parry Isak's shot.

Gabriel Martinelli had hit the post for the Gunners when the game was

only their second defeat under Slot.

Liverpool came closest when substitute Trent Alexander-Arnold's shot was cleared off the line by Radu Dragusin, but this was a very disappointing display by the Premier League leaders.

And the victory for Postecoglou's side, who were already without 10 players through injury and illness, came after they lost Rodrigo Bentancur amid worrying scenes early on. He went down in the penalty area and was taken off on a stretcher wearing a neck brace after 10 minutes of treatment.

It was later confirmed he was conscious, talking and would undergo further checks in hospital.

Spurs manager Ange Postecoglou showed faith in his youthful stars in the hothouse of an EFL Cup semi-final first leg against Liverpool, and was fully vindicated as they delivered in style.

Bergvall was the name on everyone's lips at the final whistle, not just because the 18-year-old Swede played with great maturity in midfield, but because Liverpool will feel he should have been shown a second yellow card, with the video assistant referee (VAR) unable to intervene once play was allowed to car-

In the wider context, however, Bergvall has shown amid Spurs' struggles exactly why they were so keen to acquire his services in the summer, the £8.5m paid to Djurgarden already looking like a bargain.

And sharing top billing was 21-year-old goalkeeper Antonin Kinsky, barely through the door after a £12.5m move from Slavia Prague but thrown straight into this crucial game by Postecoglou.

He showed great confidence with the ball at his feet and when commanding his area, his biggest contribution coming late on when he reacted superbly to turn away Darwin Nunez's header.

Spurs have a slender advantage to take to Anfield, but they will be well satisfied with that, having been thrashed 6-3 at home by Liverpool recently in the Premier League.

Liverpool will take a burning sense of injustice into the EFL Cup semi-fi-

Isak, a striker long linked with a move to Arsenal, showed the Gunners what they were missing with an excellent performance which got him a goal and an assist as he provided constant problems for Gabriel and Saliba.

Jacob Murphy and Gordon also played their part again in Newcastle's resurgence, but everyone contributed in handing Arsenal their first home loss of the season.

Dubravka made an excellent save to deny Gabriel, with Newcastle's defending typified by last-ditch blocks from Dan Burn and Botman as they battled to deal with Arsenal's constant threat from inswinging corners.

Since a 4-2 loss at Brentford a month ago,

the Magpies have beaten Leicester, Brentford, Ipswich, Aston Villa, Manchester United, Tottenham and now the Gunners.

That run has lifted Newcastle to fifth in the Premier League, in contention for a return to Champions League football after playing in that tournament last season, though they have no European football this campaign.

They now have an FA Cup tie and four league matches before they must focus on the second leg.

Newcastle fans will already be looking forward to 5 February, which promises to be a raucous evening at St James' Park, with them hoping to finish the job off and return to Wembley.

Hammers chasing Rashford

West Ham have expressed interest Manchester United forward Marcus Rashford but any deal remains unlikely.

The 26-year-old forward's wages, which are believed to be in excess of £300,000-a-week, and the number of clubs interested make any move difficult deal for West Ham to complete.

The competition includes Borussia Dortmund, who are also reluctant to pay Rashford's wages, while AC Milan, Juventus and

Napoli have also been linked with a move.

United are open to allowing Rashford to leave the club in the January transfer window.

Although the club would prefer a permanent sale for £40million-rated Rashford, they accept that is unlikely to happen in this month's transfer window, with the summer the best option.

It follows his non-selection in the last five matches under new manager Ruben Amorim, albeit with illness

cited as the reason for him missing the 2-2 draw with Liverpool on Sunday.

West Ham, meanwhile, are keen to improve their squad after announcing Graham Potter as their new manager to replace Julen Lopetegui.

The club are eyeing several attacking targets from the top flight, including Brighton striker Evan Ferguson, after striker Michail Antonio was hospitalised after a car crash in early December.

Potter: will he prove magic at Hammers?

Graham Potter says he is looking forward to a "big challenge" after being confirmed as the new West Ham manager.

The 49-year-old has signed a two-and-a-half-year contract with the London club, who sacked Julen Lopetegui on

Wednesday after six months in charge.

"It's a proud day to be head coach of this amazing club, big tradition, big

history, big expectations, big challenge," Potter said.

"I'm really excited, it's a bit like Christmas - Christmas for the adults.

"I'm looking forward to meeting the players

today, meeting our supporters and getting going."

Potter takes over with the Hammers 14th in the Premier League - seven points above the relegation zone - with just six league wins to their name.

It is his first managerial position since being dismissed by Chelsea in April 2023.

"It's been 20 months of a good rest, a good break and you can imagine in

that time you speak to lots of people. Lots of conversations with different owners and different directors," he added.

"But it was important that I chose the right option for me at the right time and as soon as I spoke to this club, it just felt right for me.

"It's an amazing club with a tremendous, loyal fanbase that is passionate, knowledgeable, knows their football and what they want. I think it's a good fit.

"My experience is that if you can build a team that is recognizable on the pitch, that the supporters identify with, are proud of and enjoy watching and you get that trust and connection between the players and the supporters, with everybody aligned, that's the key."

Potter was Chelsea's first managerial appointment following Todd Boehly's takeover, but dismissed after less than seven months in charge.

The Blues paid more than £21m in compensation to Brighton, where Potter had impressed after leading the Seagulls to Premier League finishes of 15th, 16th and ninth in a three-year spell.

Potter, who has also managed at Ostersunds FK and Swansea City, oversaw a record £323m outlay at Stamford Bridge in the 2023 January transfer window, but success did not materialise and he was sacked following an 11th defeat in 31 games.

Dyche gets his marching orders

■ **New owners dispense with Everton manager, Moyes among the favorites to replace him**

Sean Dyche has been sacked as Everton manager after less than two years in charge at Goodison Park.

The 53-year-old's departure was announced just hours before Everton were due to host League One side Peterborough in the third round of the FA Cup on Thursday.

Everton announced their under-18s head coach Leighton Baines and club captain Seamus Coleman had been put in charge of the team for that game.

Right-back Coleman and former left-back Baines have made more than 800 Everton appearances between them.

Four members of Dyche's coaching staff - Ian Woan, Steve Stone, Mark Howard and Billy Mercer - have also departed.

The Toffees were beaten 1-0 by Bournemouth on Saturday and sit 16th in the Premier League

and just one point clear of the relegation zone.

They failed to register a shot on target at Vitality Stadium and have won just three of 19 games in the league this season.

A source close to the Friedkin Group - which completed a £400m takeover of the club last month - said the new owners had been in talks with Dyche over a couple of days this week, with both sides feeling they had reached the end of the road. Difficult negotiations took place over an exit package for Dyche and his staff before a settlement was reached.

The source added that the timing of Dyche's departure, just hours before a game, was not ideal.

Club sources say they want Dyche's replacement to have Premier League experience and former Everton manager David Moyes is among the names to have been

linked.

However, sources close to Jose Mourinho have ruled the Fenerbahce manager out of contention.

The former Chelsea, Manchester United and Tottenham boss previously worked under the Friedkin Group at Roma, but he was sacked by them in January 2024.

Moyes, 61, managed Everton from 2002 to 2013 and recently said he was not ready to retire from football management but did not want to be in a job "fighting relegation".

Speaking on Tuesday, Dyche said that his communication with Everton's owners had been "positive" with "no indication" they were looking to bring someone else in. He said they had been "been very up front and open" about expectations.

Dyche, whose contract was due to expire

in the summer, succeeded Frank Lampard on 30 January 2023 with Everton in the relegation zone.

The team secured survival with a 1-0 win against Bournemouth on the final day of that season.

He then steered the Toffees to a 15th-place

finish in the 2023-24 campaign despite the Merseysiders being deducted eight points for two separate breaches of Premier League financial rules.

The club have looked strong defensively this season, keeping seven clean sheets.

But they have struggled for goals, netting

only 15, and are the second-lowest scorers in the league, with only bottom club Southampton having managed fewer.

Dyche is the sixth Premier League manager to be sacked this season, and the second in as many days after West Ham dismissed Julen Lopetegui on Wednesday.

Controversial late goal gives Spurs narrow edge

Tottenham edged out Liverpool 1-0 Wednesday night in a controversial finale to their Carabao Cup semi-final first leg.

Lucas Bergvall gave Spurs a narrow advantage to take to Anfield - but Liverpool were left raging that the 18-year-old was on the pitch to make the

decisive contribution four minutes from time.

Bergvall was on a yellow card when he caught Liverpool defender Kostas Tsimikas late in an incident not seen by referee Stuart Attwell.

Tsimikas was still off the pitch when Bergvall scored moments later, prompting a furious re-

action from head coach Arne Slot, who was cautioned.

Spurs deserved the win after Pedro Porro missed a great chance and Dominic Solanke saw a goal ruled out for offside, but the manner of their win will leave a bitter taste for Liverpool, who suffered
